The ornamental design for a wireless telephone handset, as shown and described.

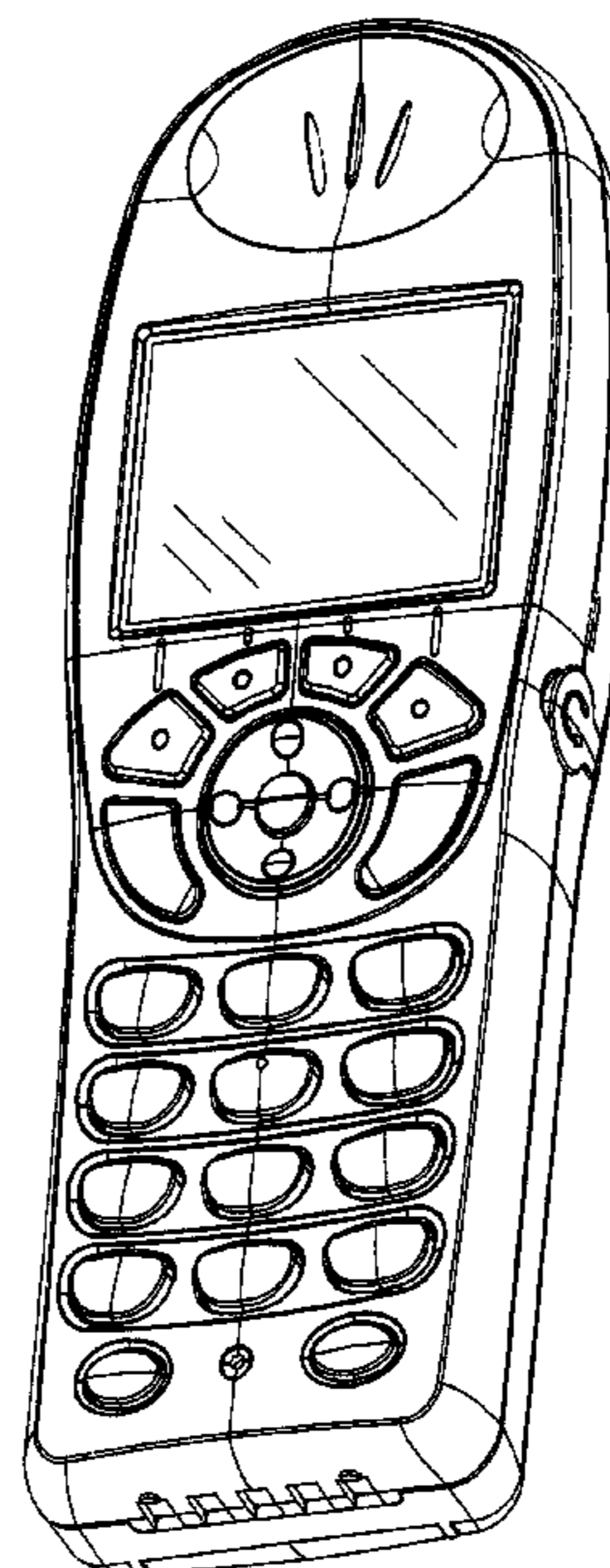
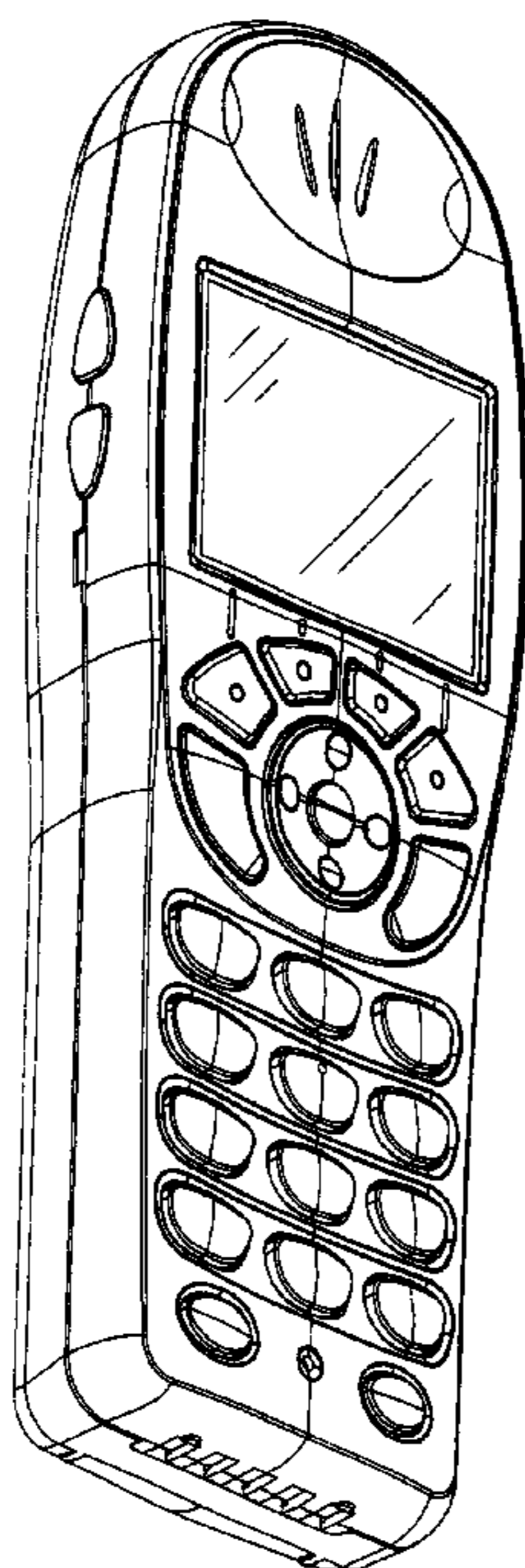
DESCRIPTION

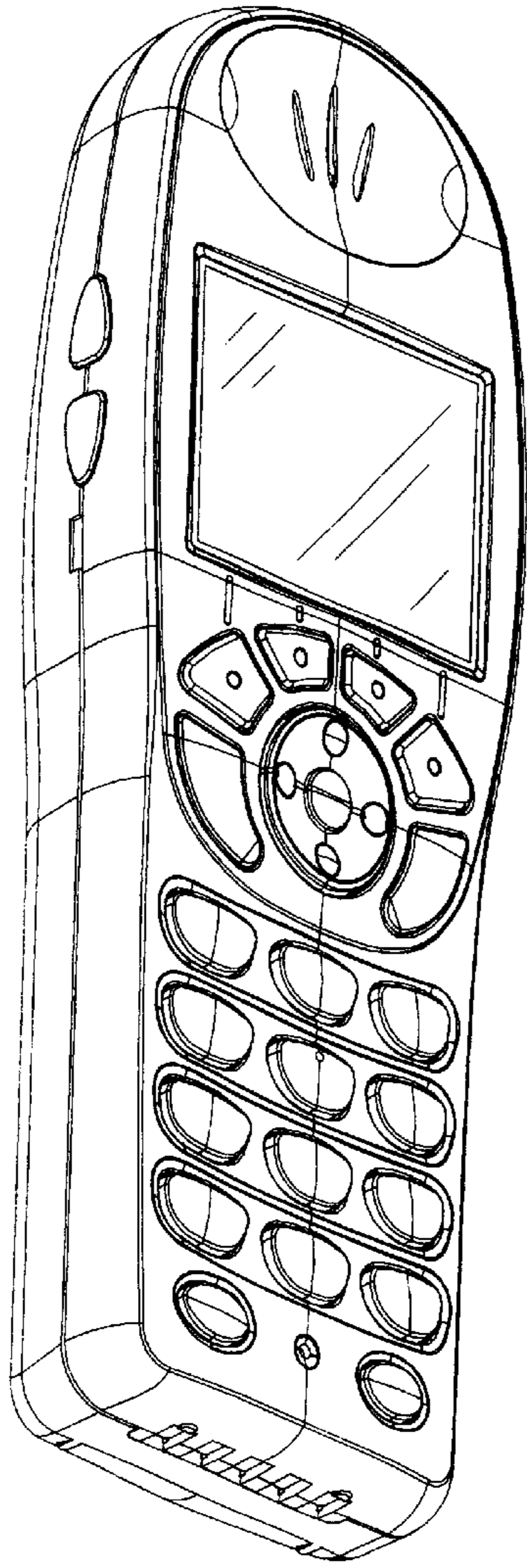

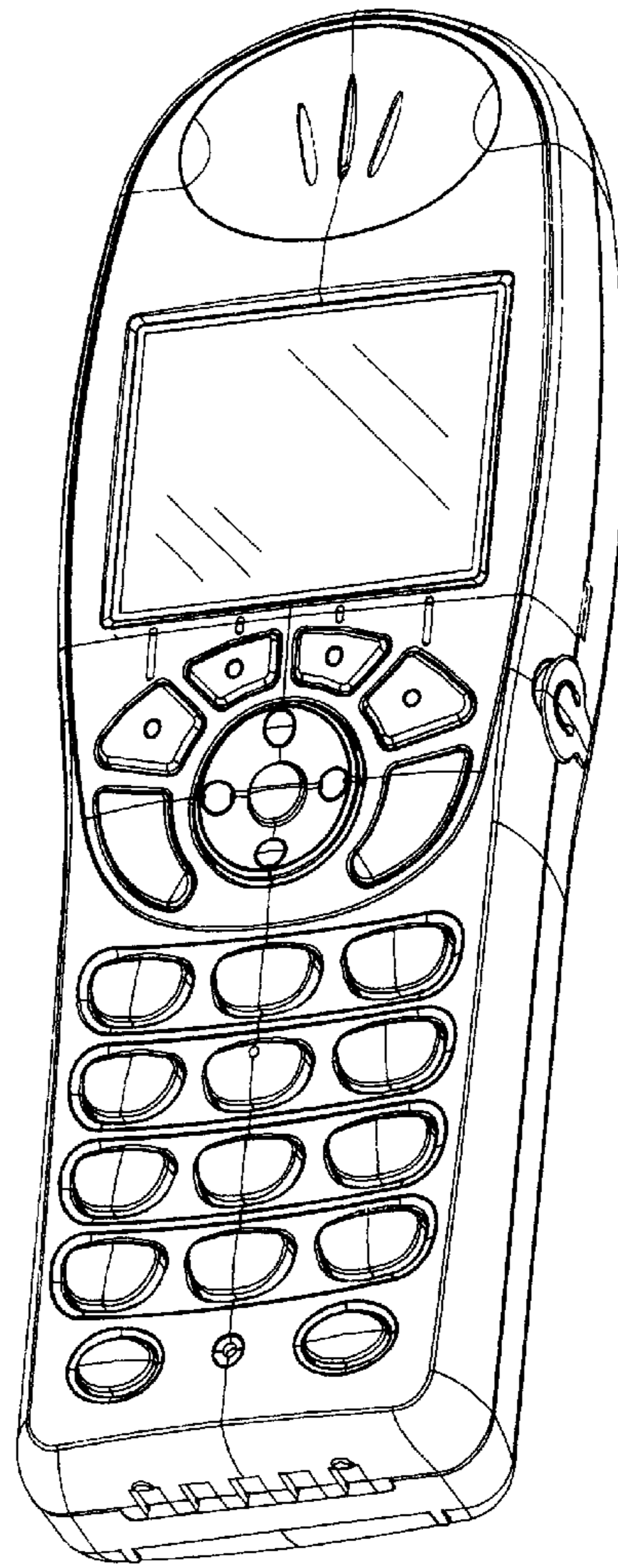
