(57) **CLAIM**

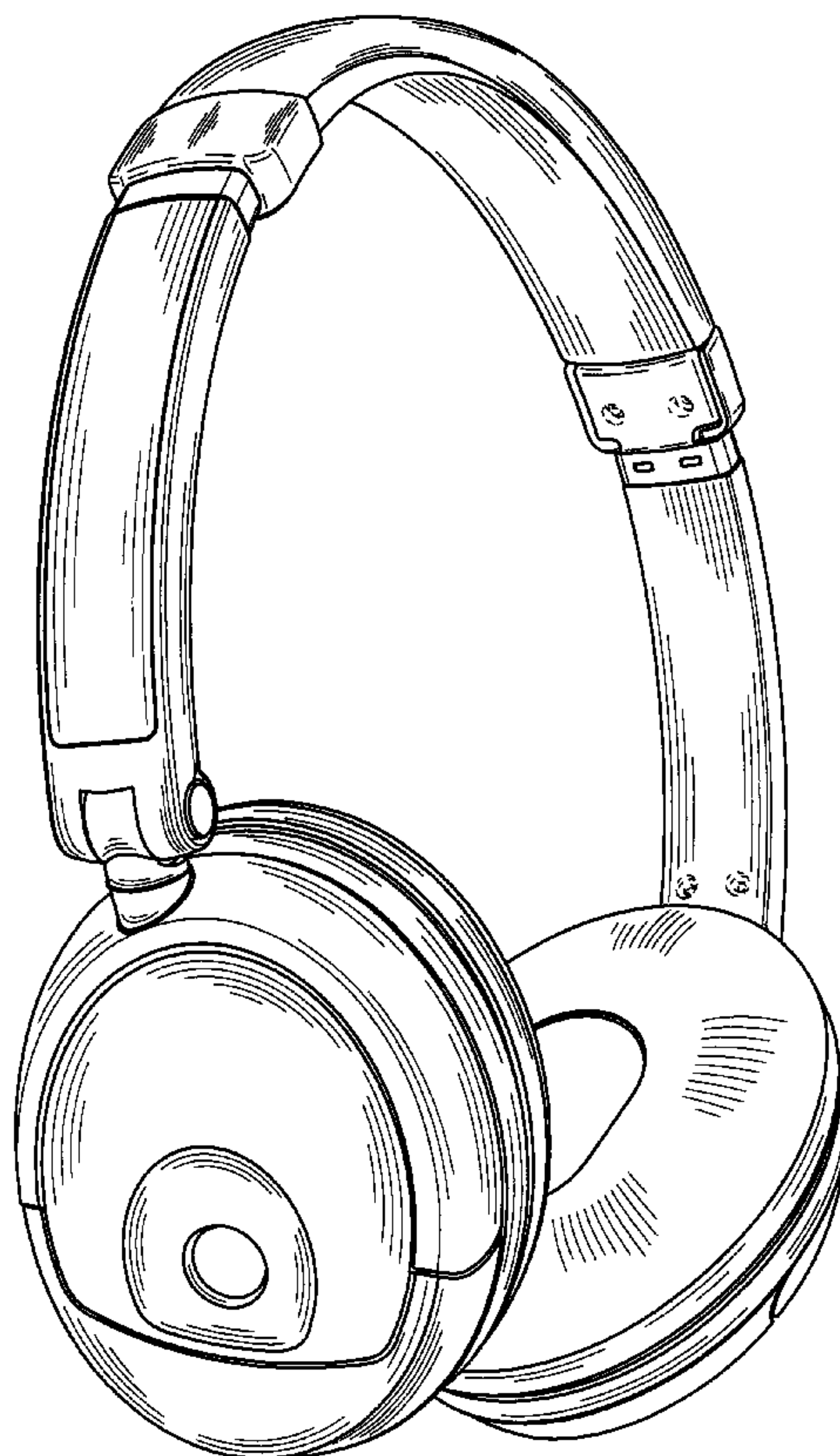
The ornamental design for a headset, substantially as shown and described.

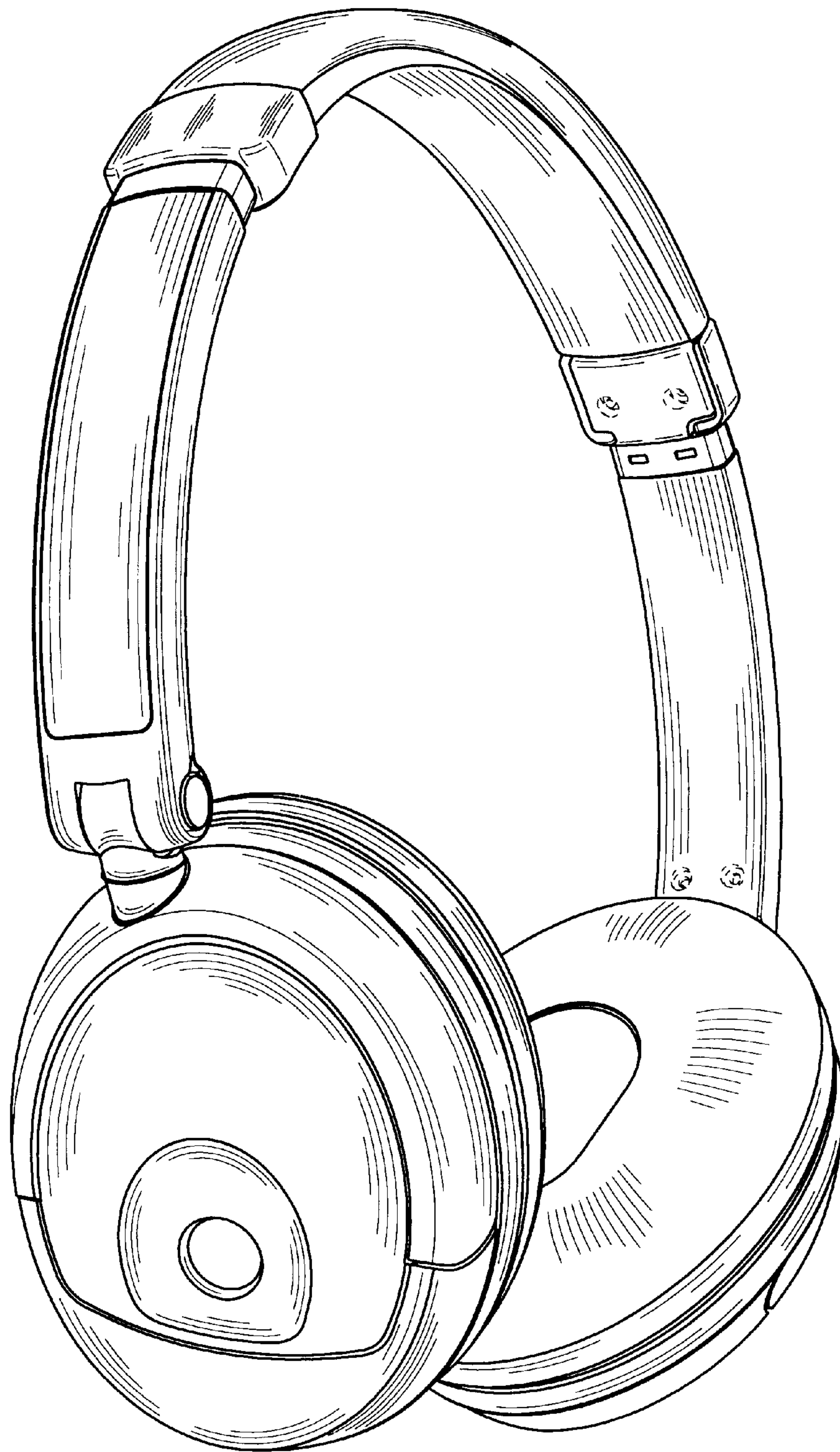

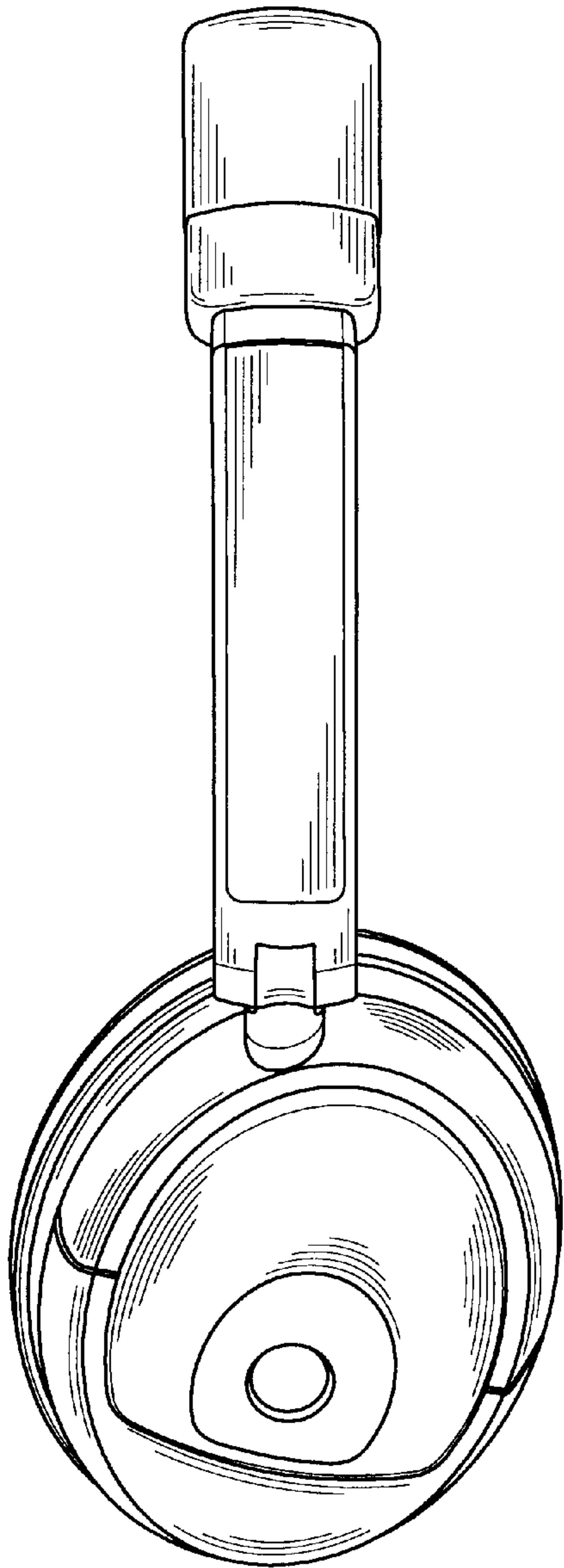

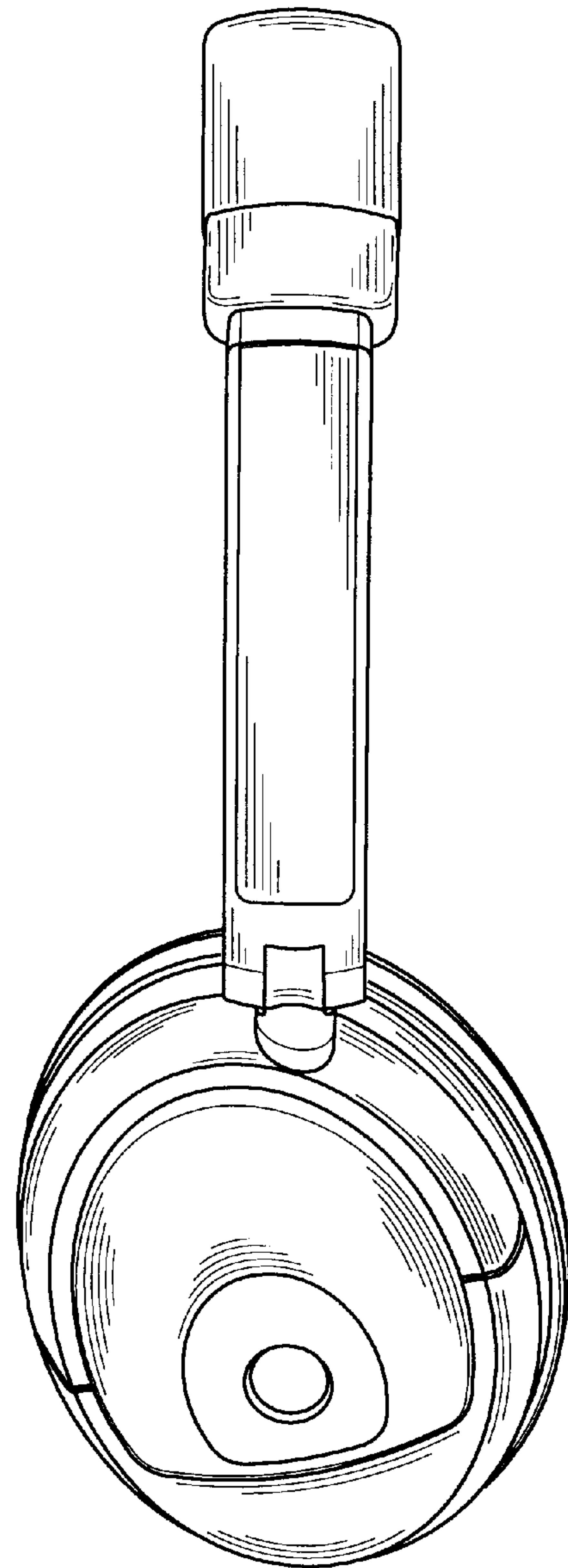

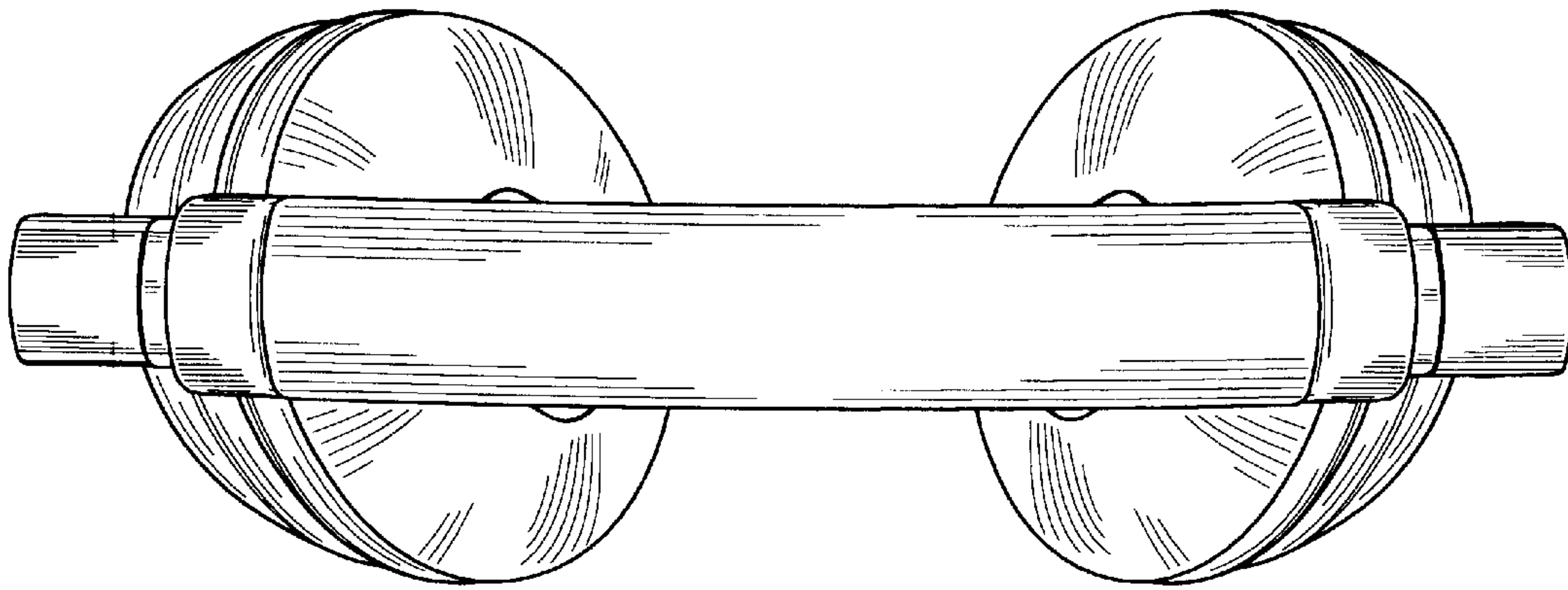

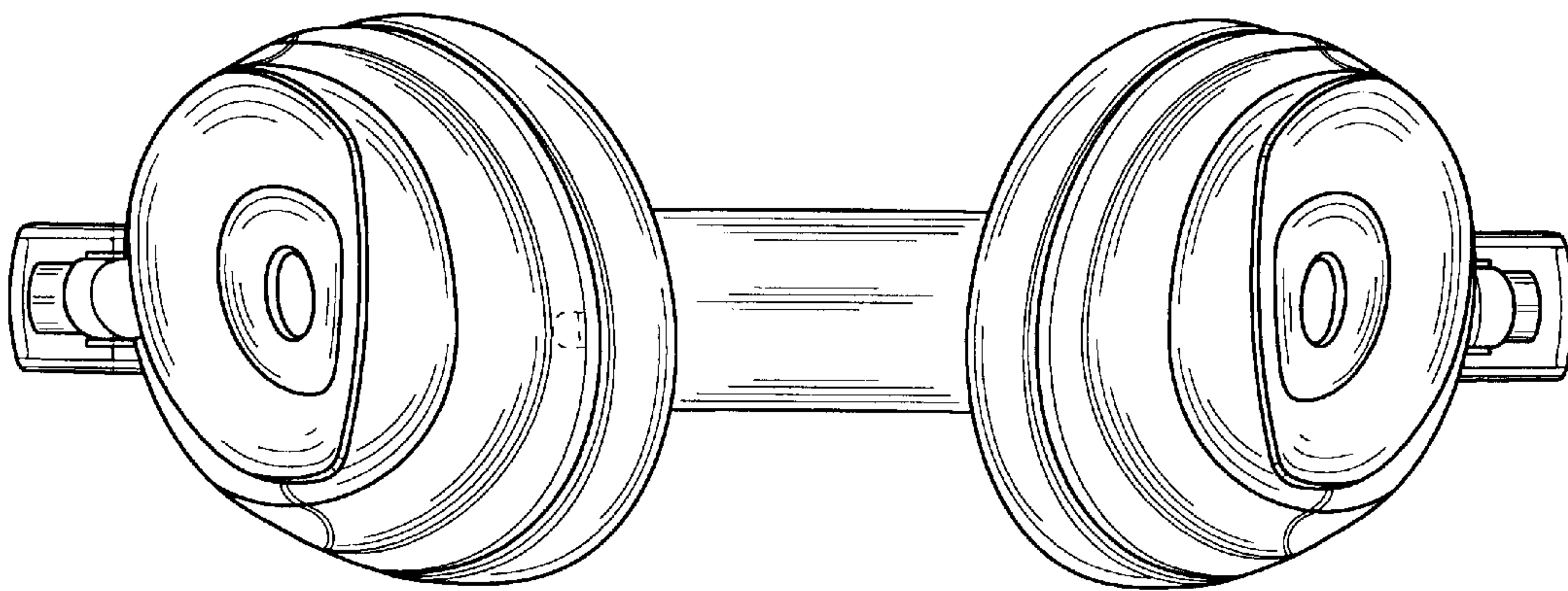
