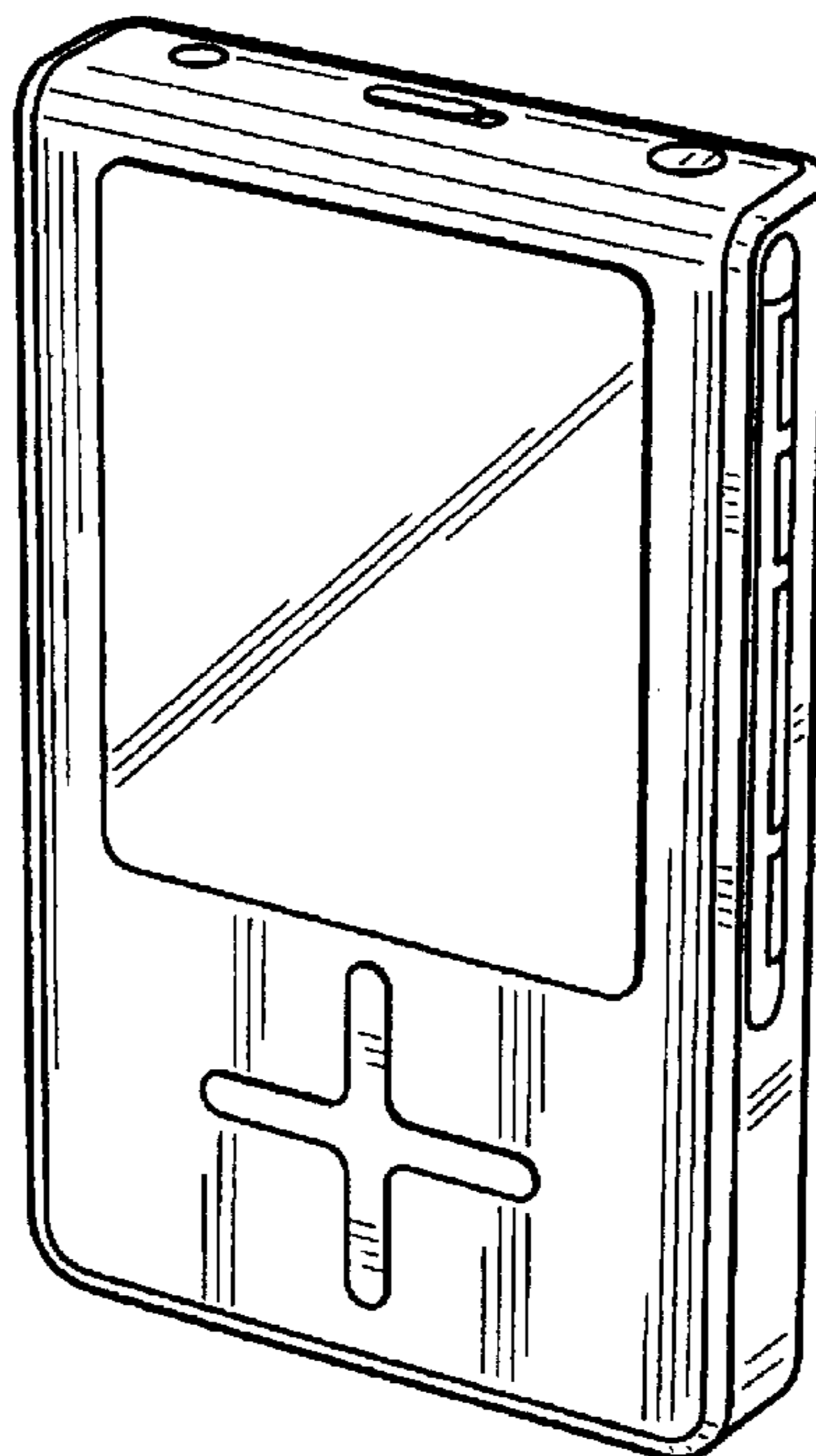
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a digital audio player, showing my new design;

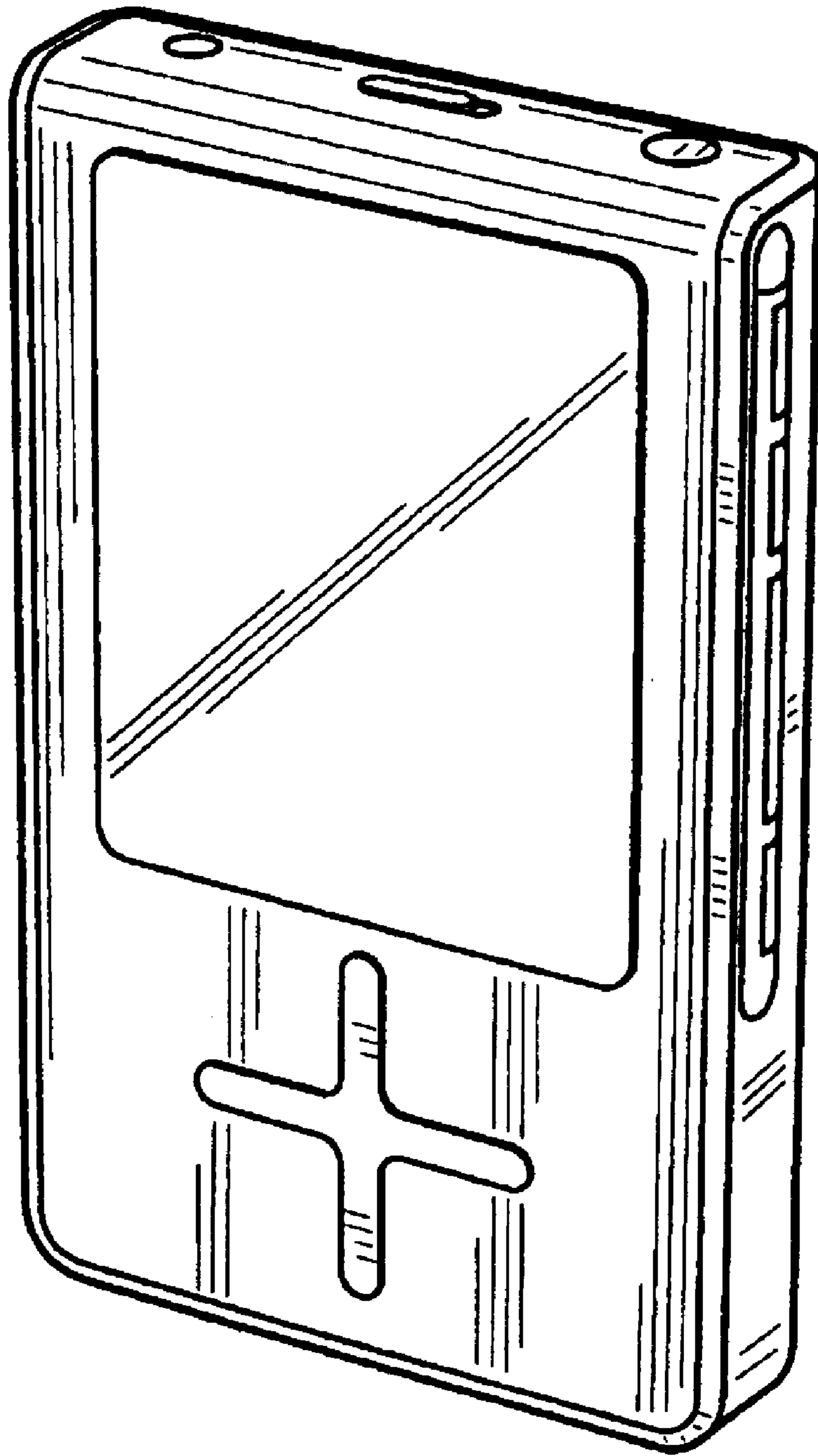

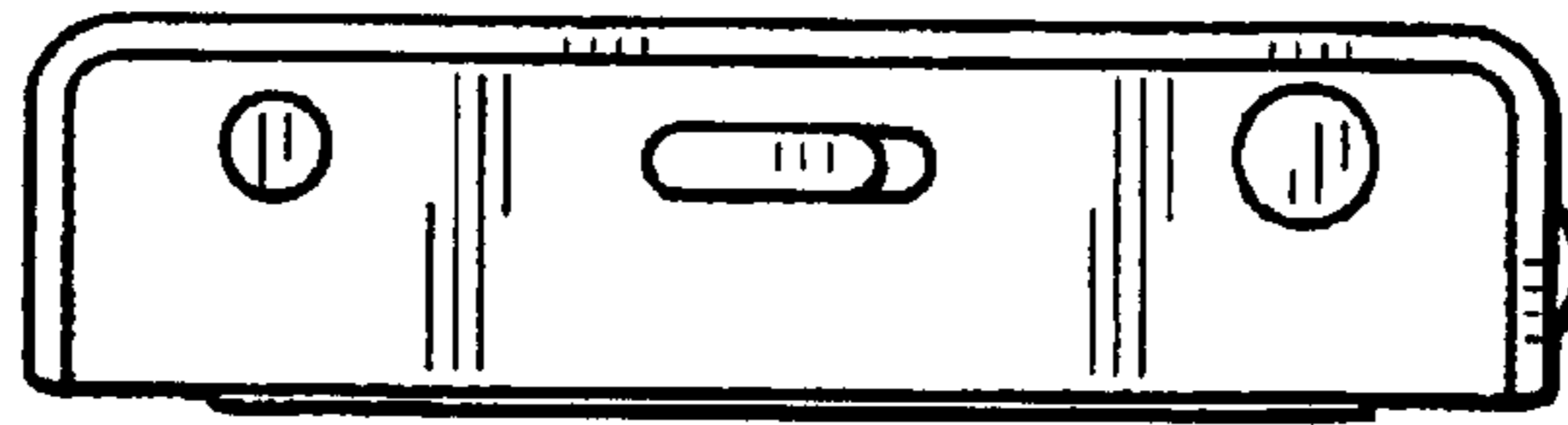

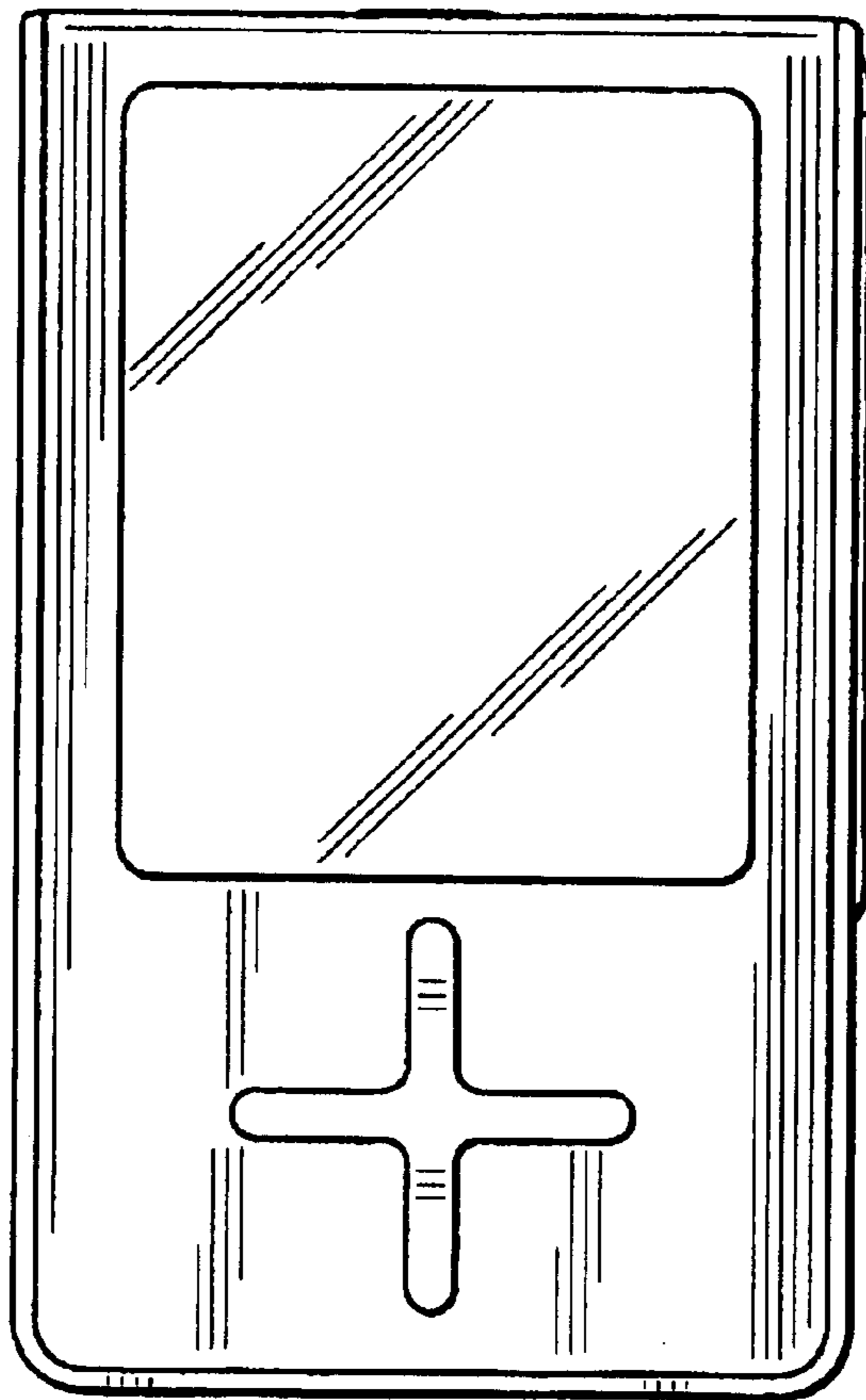

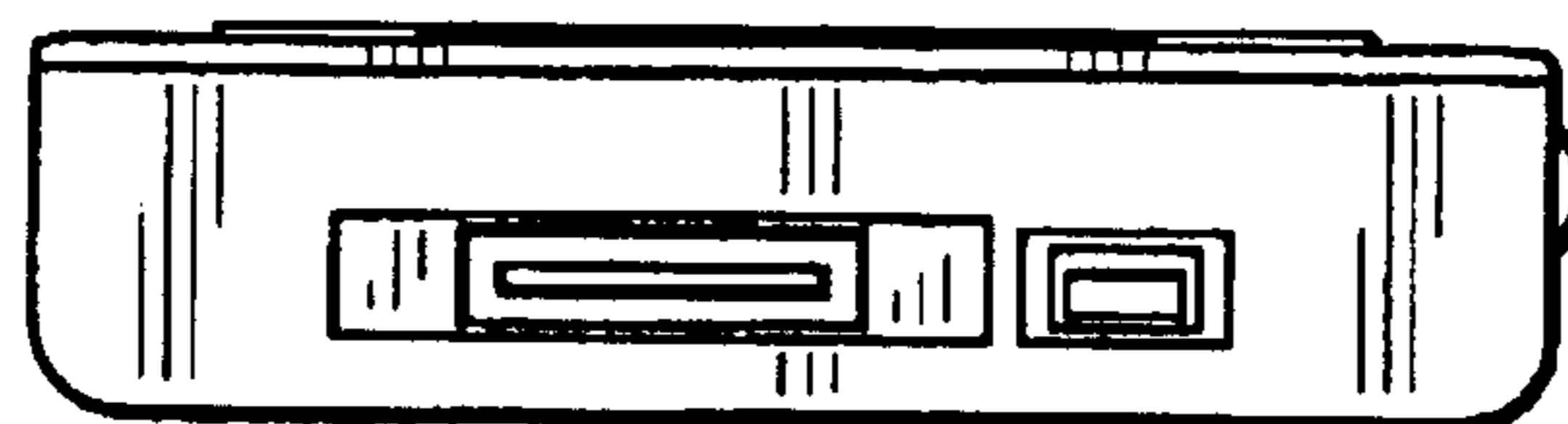

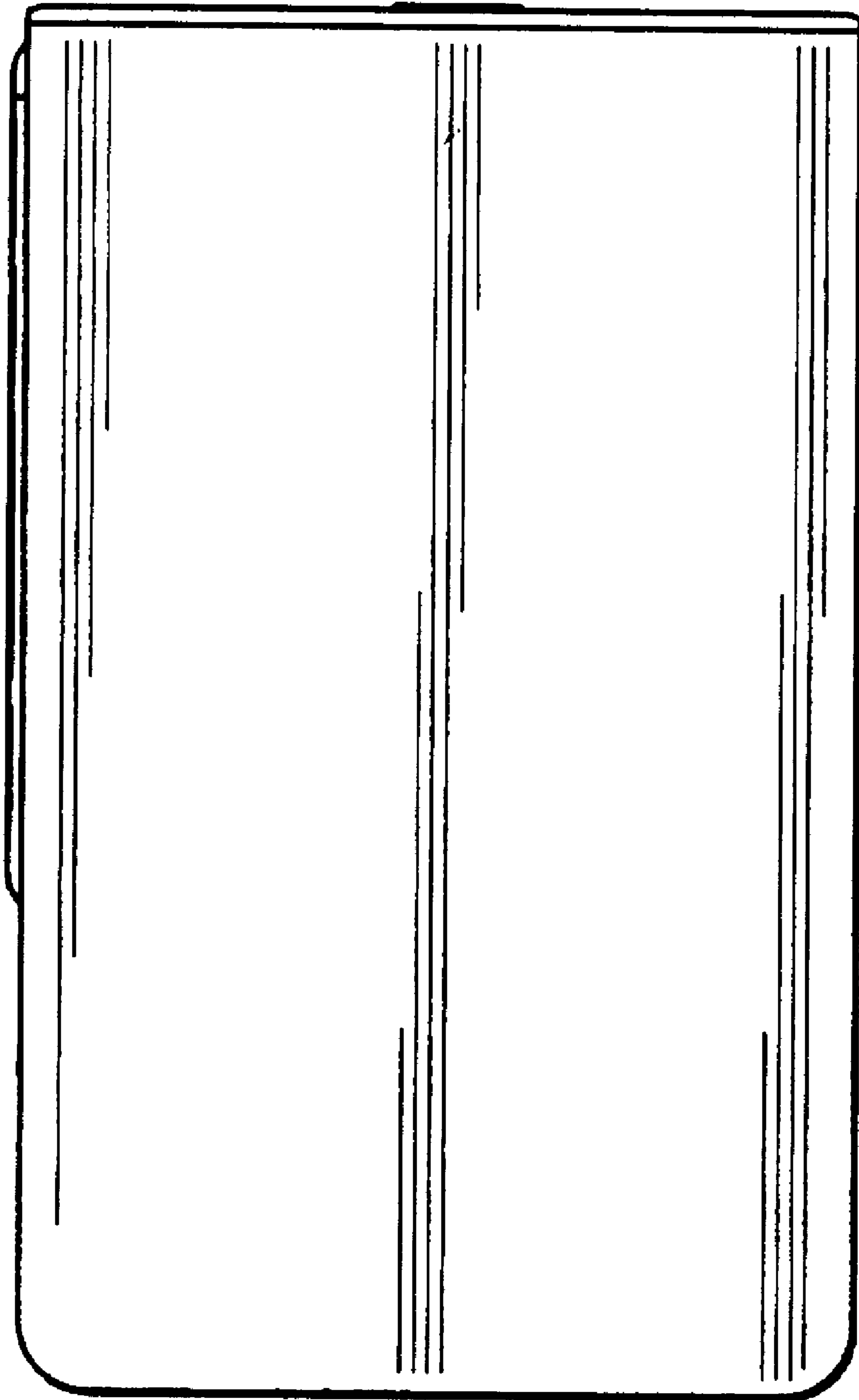

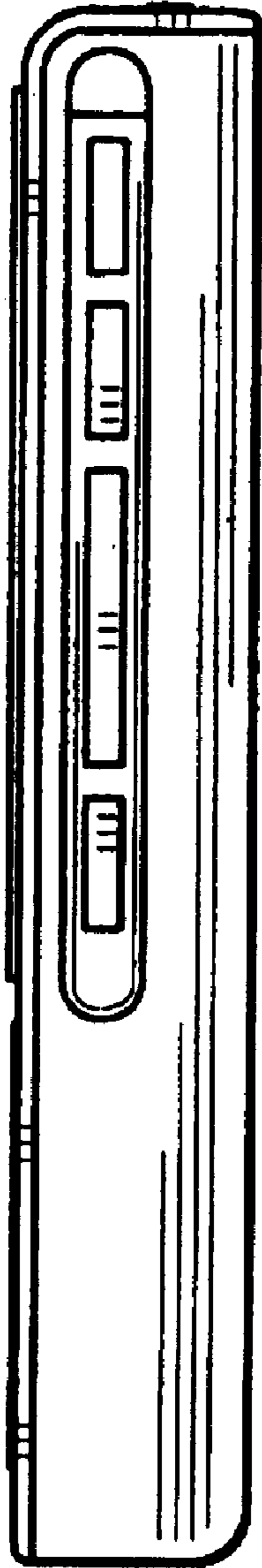
