(57) **CLAIM**

The ornamental design for a lavatory, as shown and described.

DESCRIPTION

In a preferred embodiment, the nature of this product is as a plumbing fixture primarily useful for washing various objects.

FIG. 1 is a left, top, front perspective view of a lavatory according to our new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof, the rear elevational view thereof being a mirror image of the front elevational view shown;

FIG. 4 is a left side elevational view thereof, the right side elevational view thereof being a mirror image of the left side shown;

FIG. 5 is a bottom plan view thereof; and,

FIG. 6 is a front sectional view thereof taken along line 6—6 of FIG. 2.

The broken line representations of drain structure in FIGS. 1–6 are for the purpose of illustration only, and form no part of the claimed design.

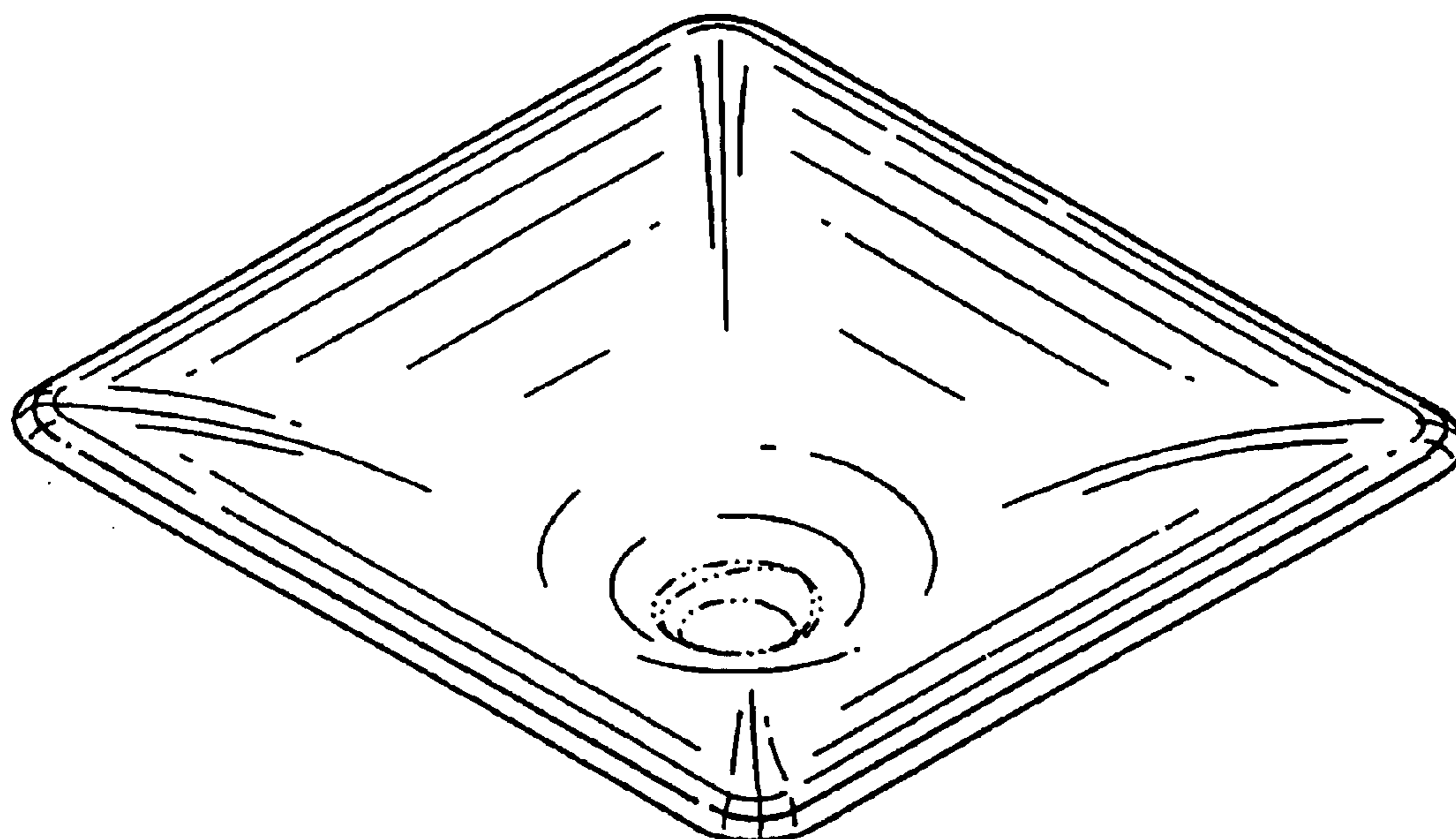

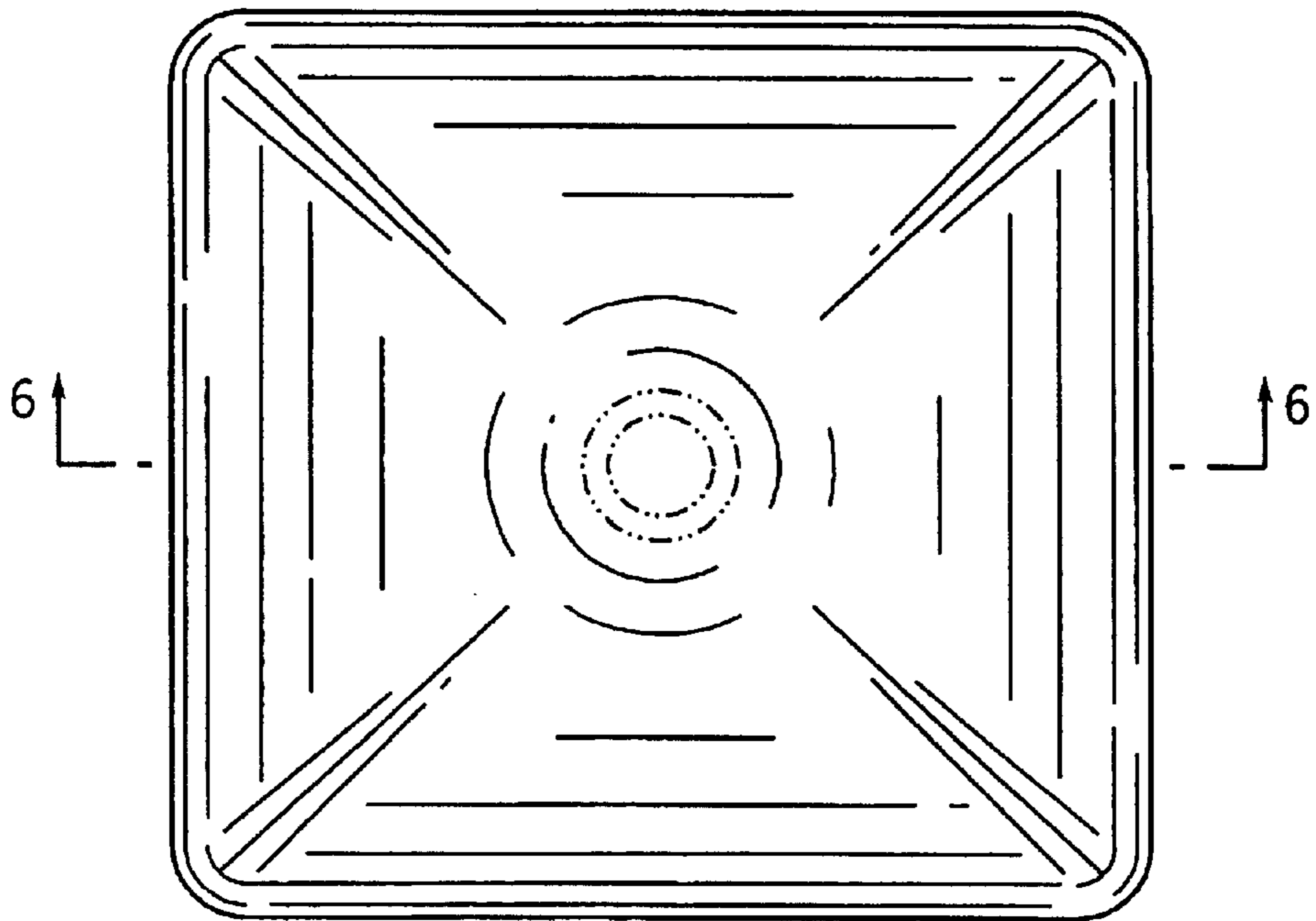
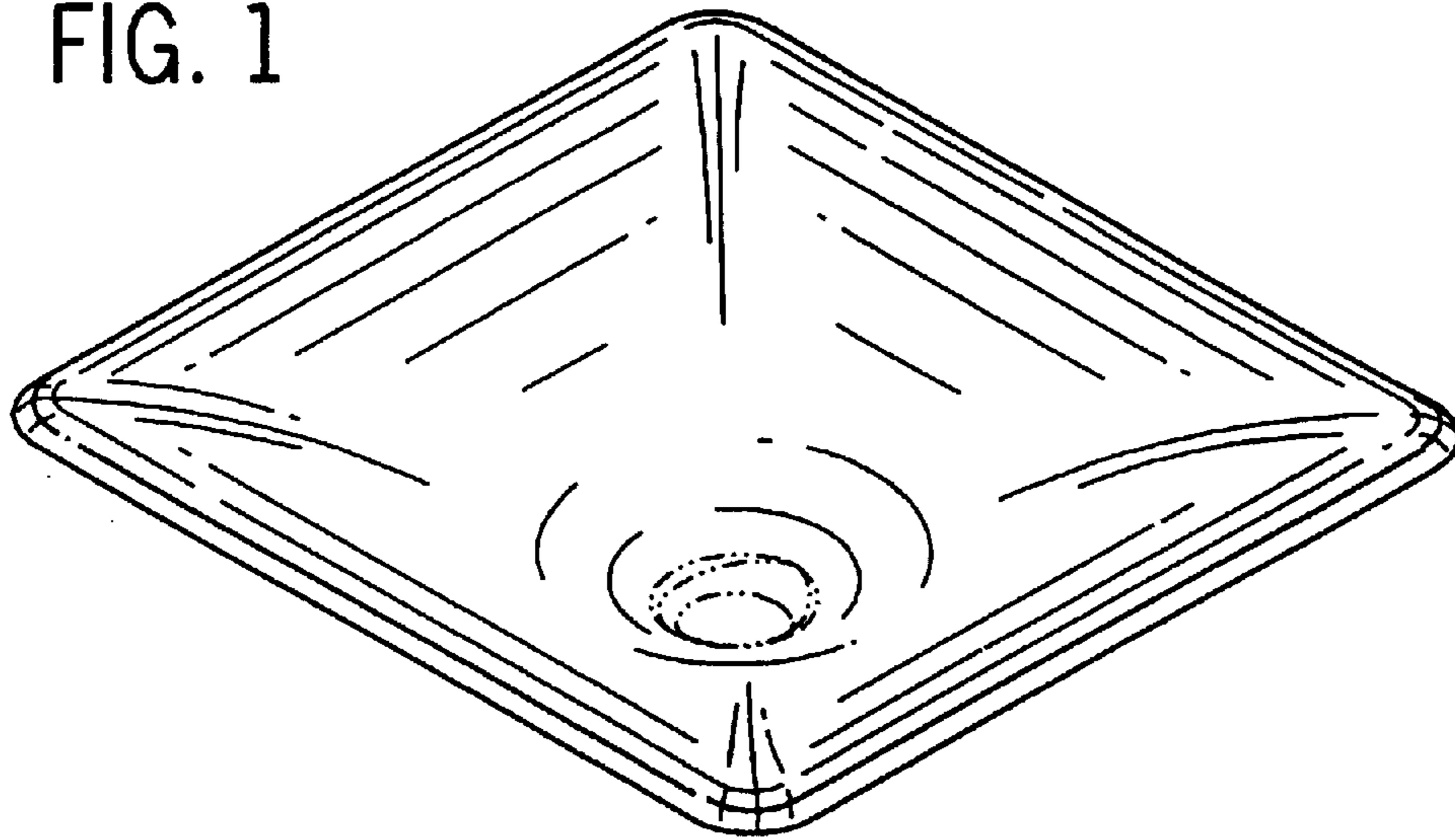

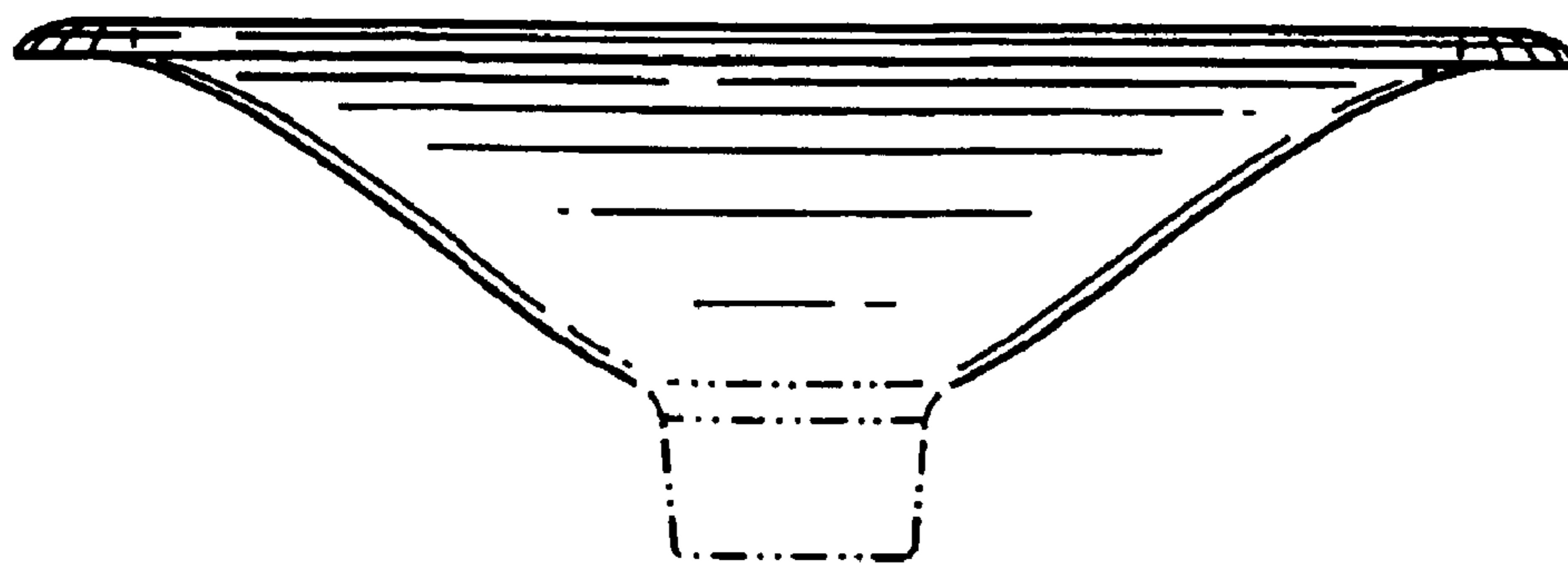

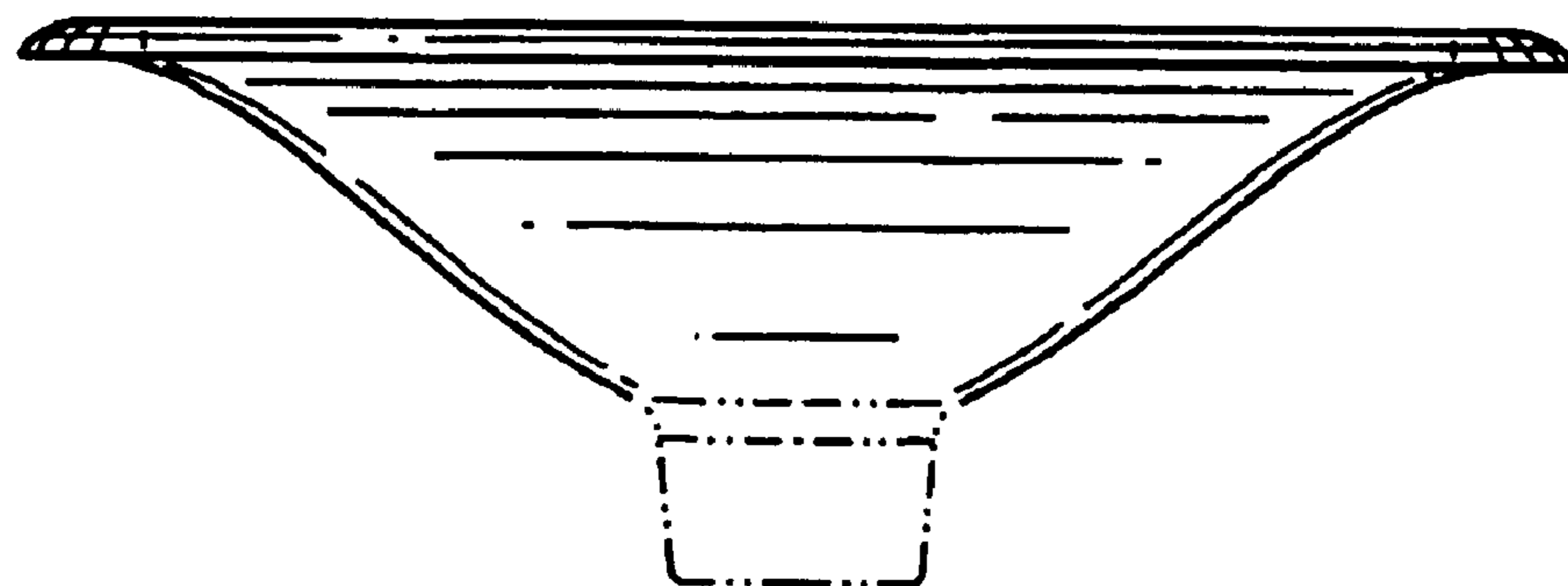

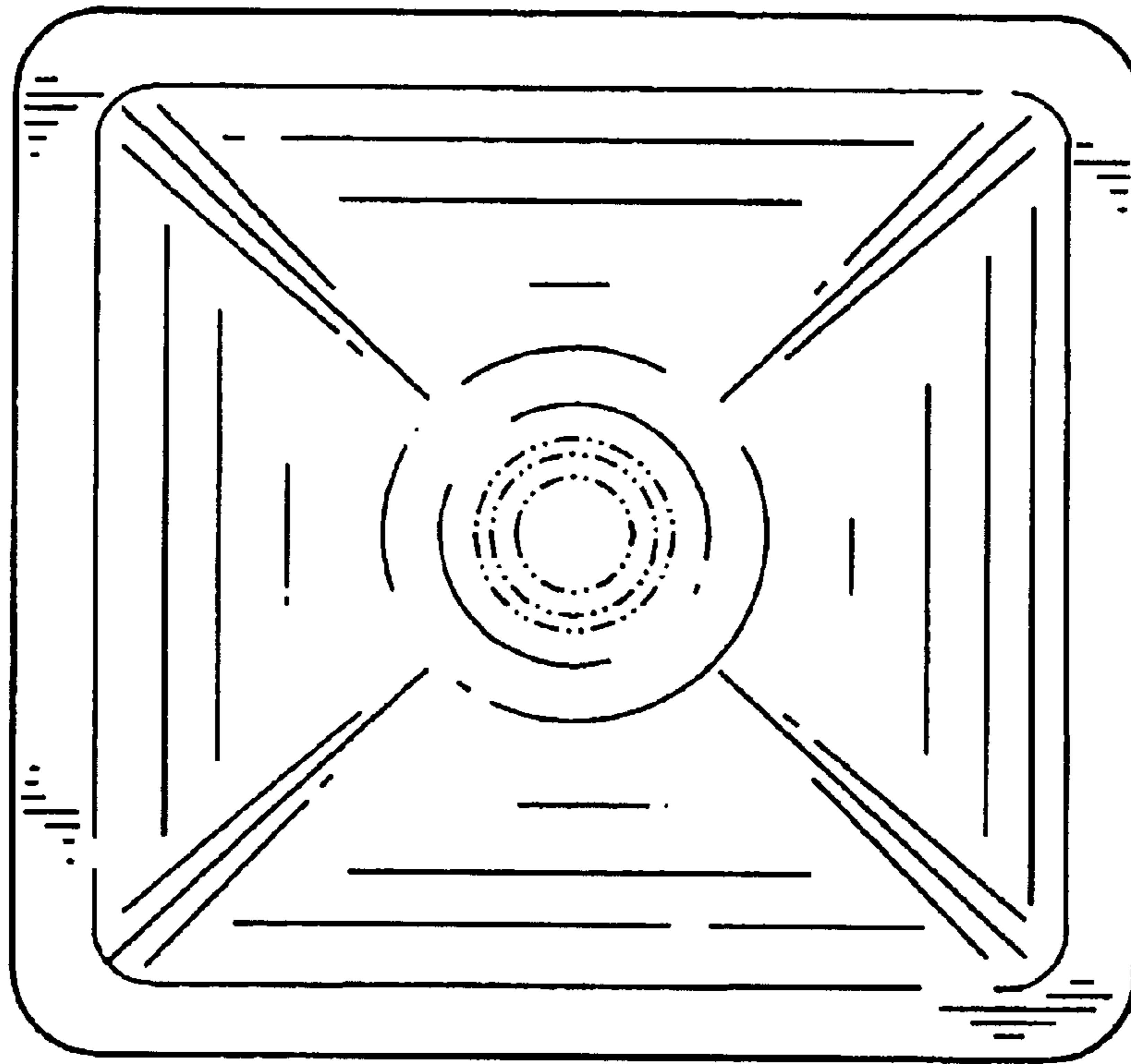

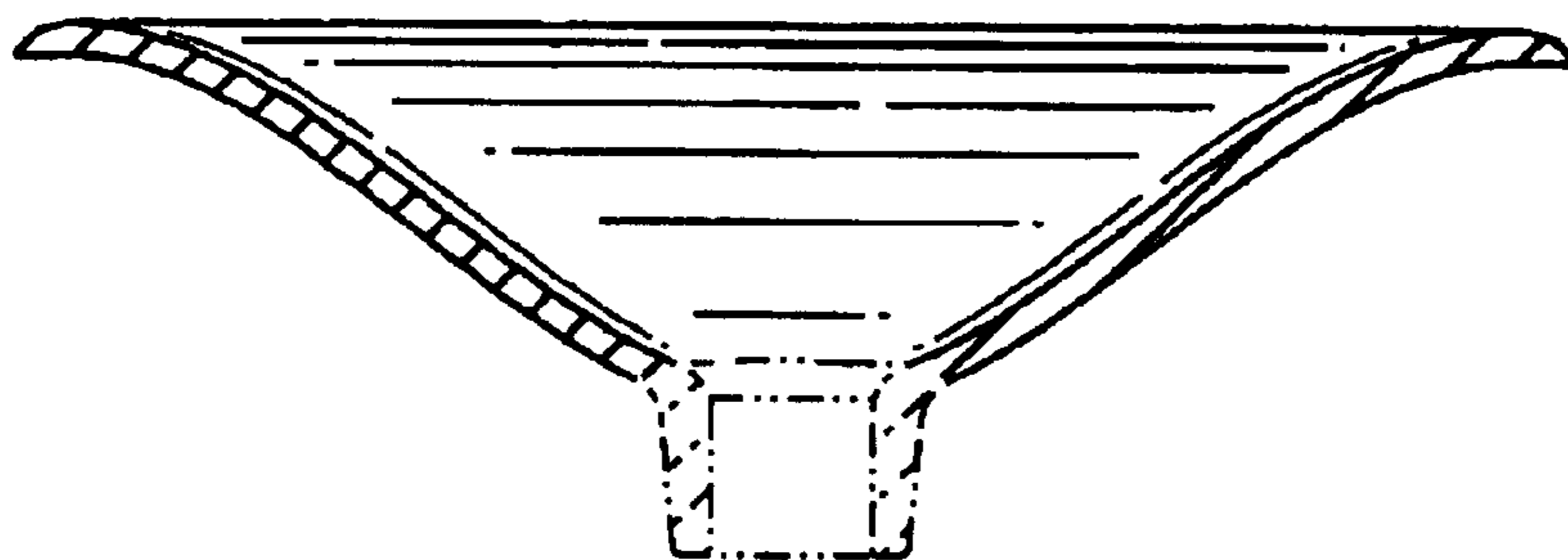
