(57) **CLAIM**

The ornamental design for a hair treatment applicator device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a hair treatment applicator device showing our new design;

FIG. 2 is a front view of the hair treatment applicator device of FIG. 1;

FIG. 3 is a back view of the hair treatment applicator device of FIG. 1;

FIG. 4 is a first side view of the hair treatment applicator device of FIG. 1;

FIG. 5 is a second side view of the hair treatment applicator device of FIG. 1;

FIG. 6 is a top view the hair treatment applicator device of FIG. 1; and,

FIG. 7 is a bottom view of the hair treatment applicator device of FIG. 1.

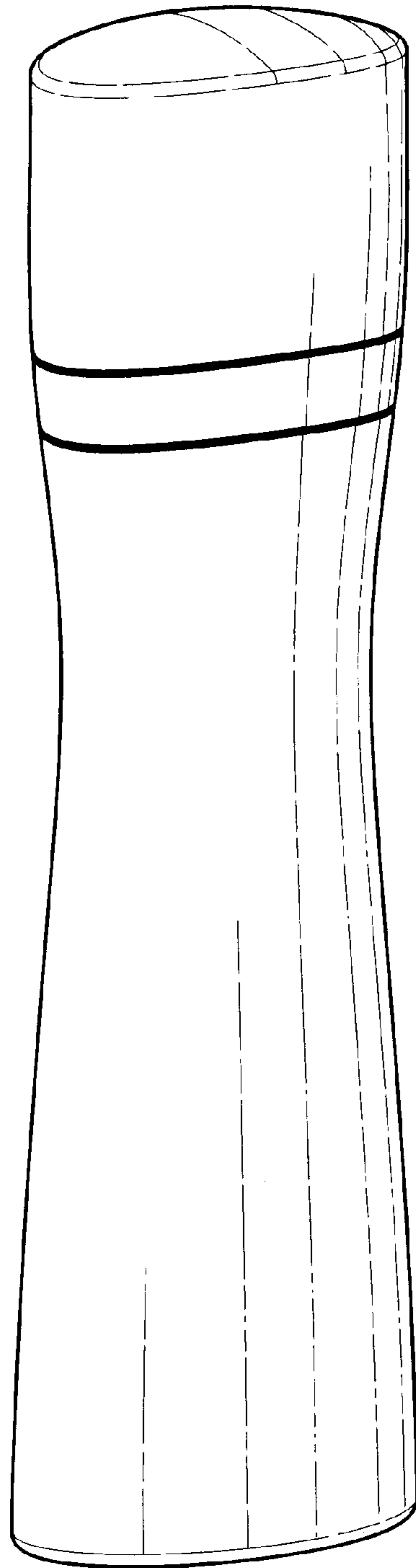

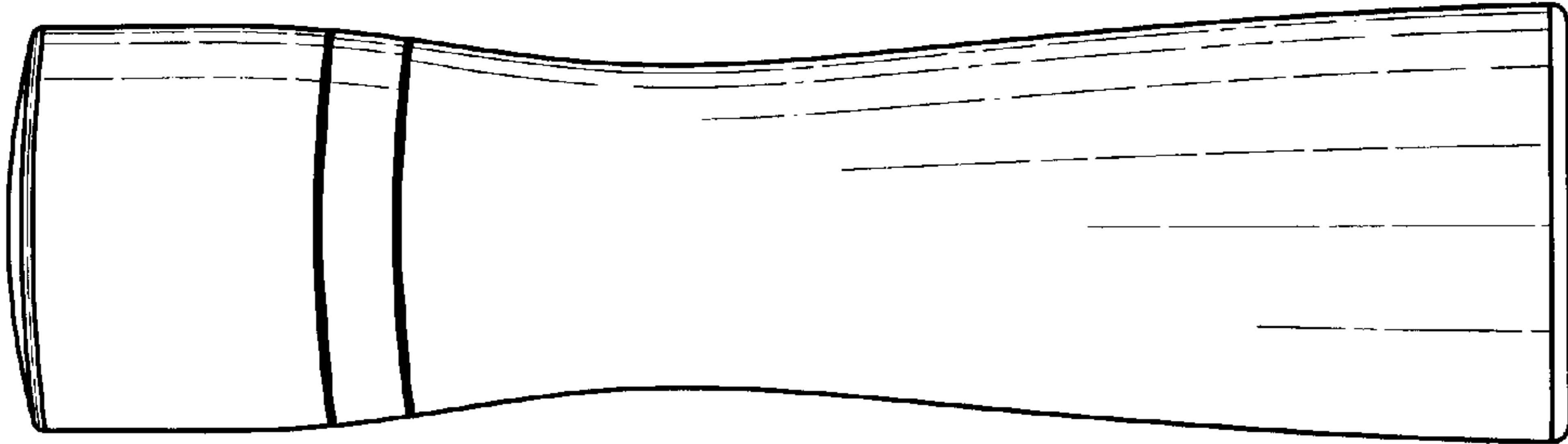

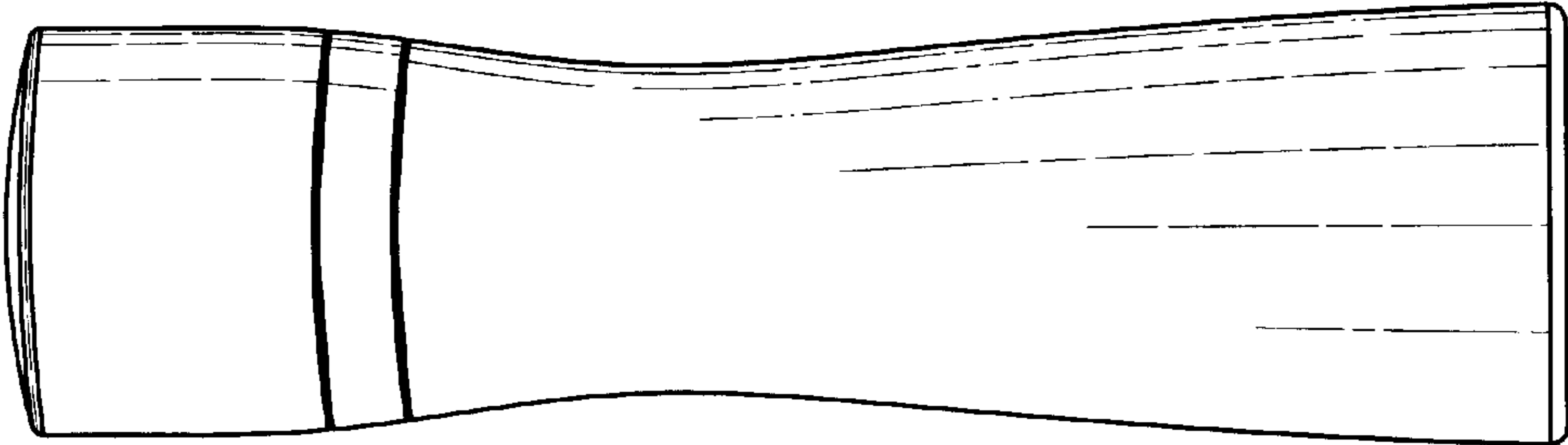

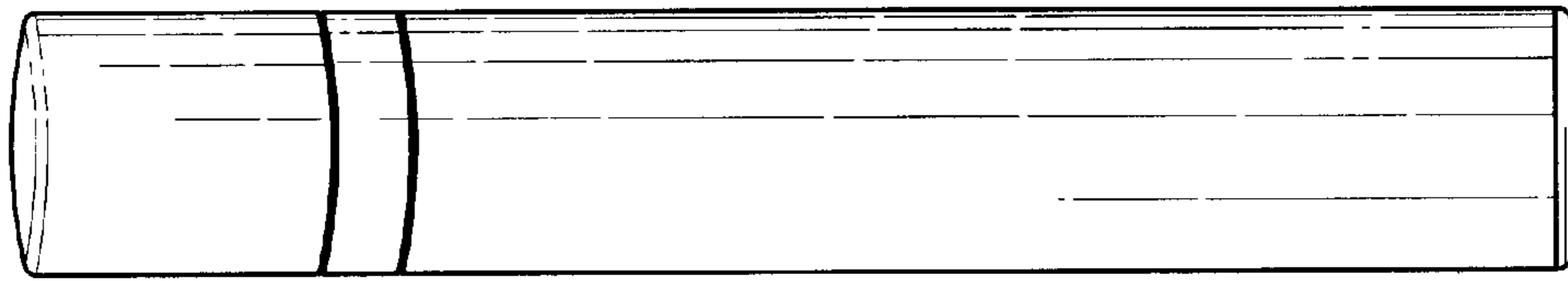

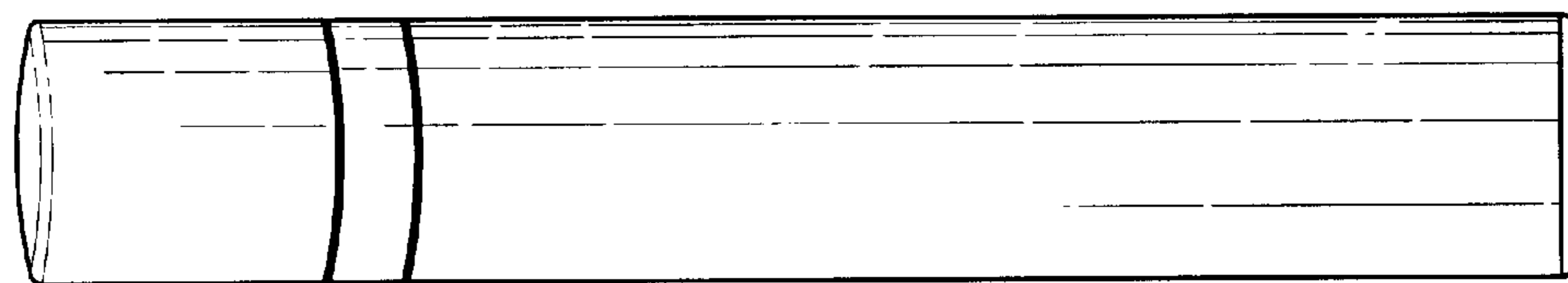

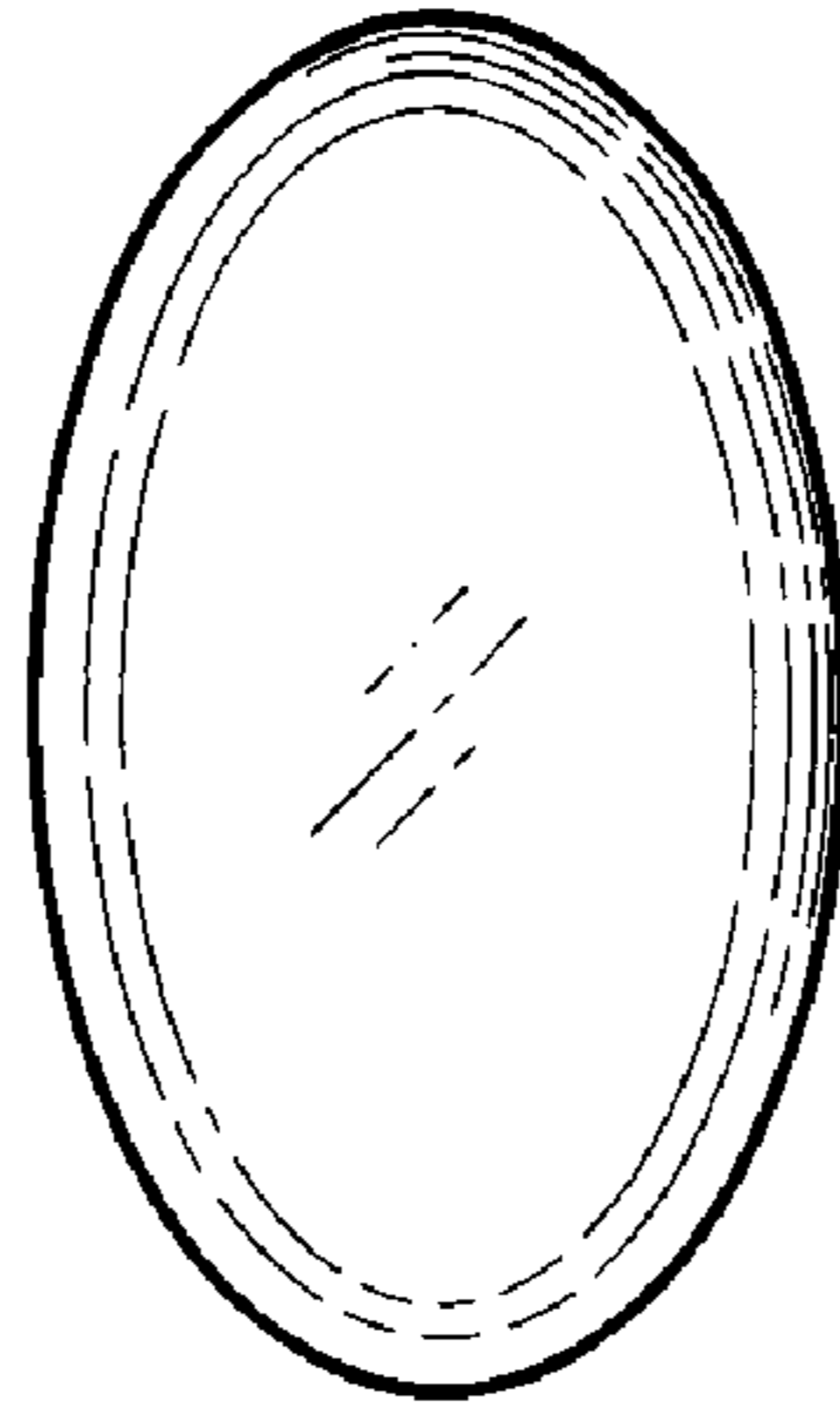

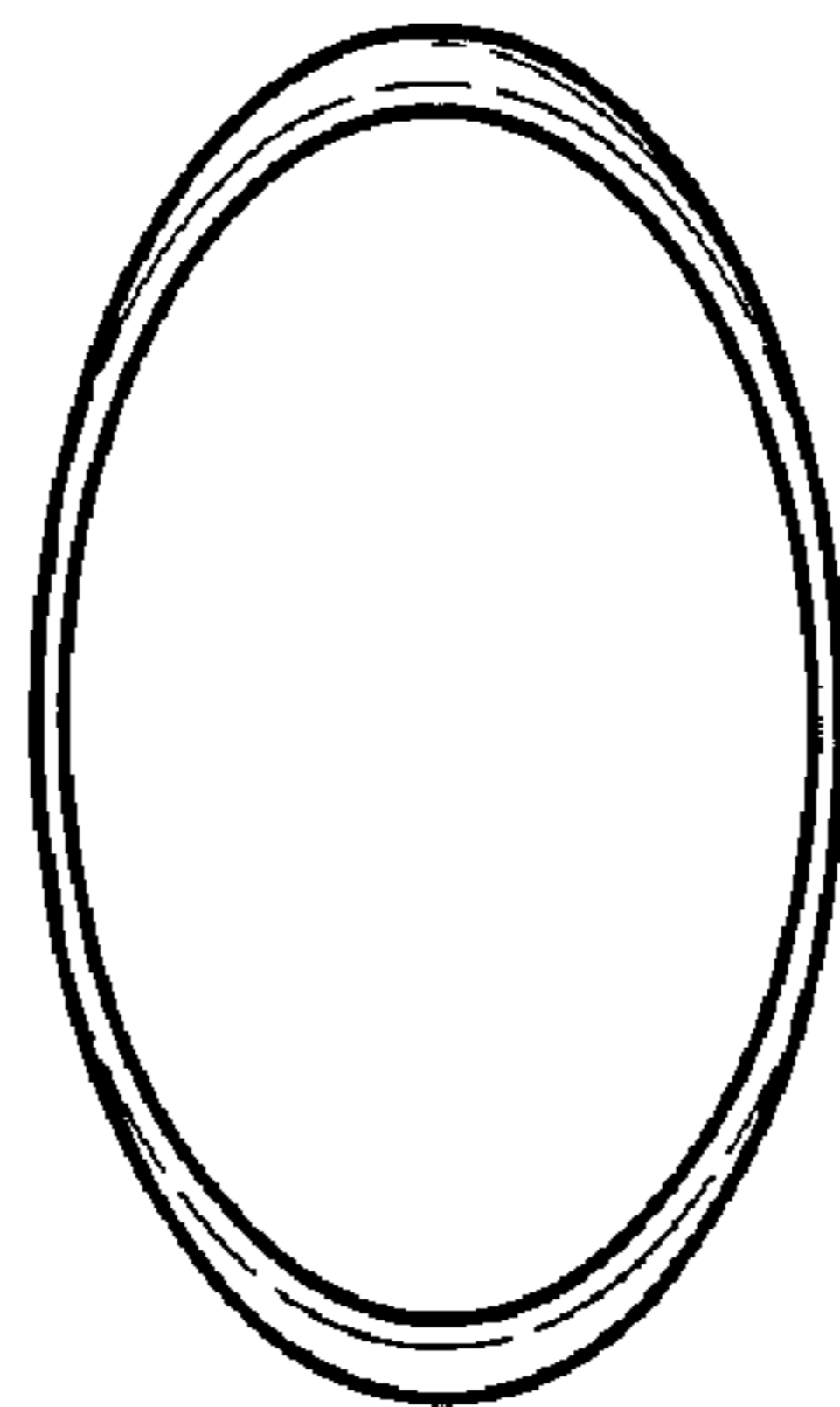
