DESCRIPTION

FIG. 1 is a front perspective view of my new design for a shopping cart.

FIG. 2 is a right side elevation view of FIG. 1, the left side being a mirror image.

FIG. 3 is a back side elevation view of FIG. 1.

FIG. 7 is a front perspective view of an alternate embodiment of my new design for a shopping cart.

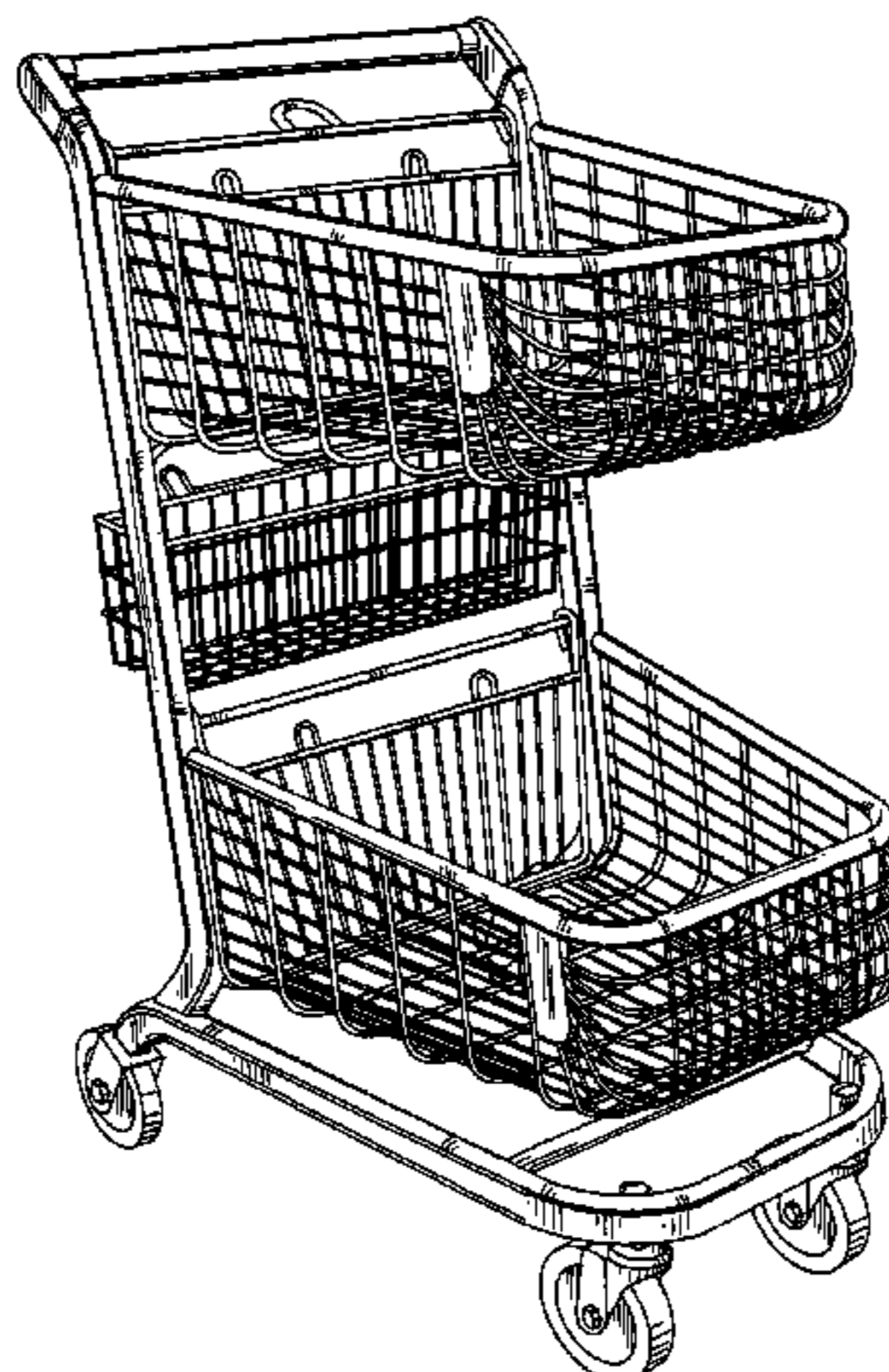
FIG. 8 is a right side elevation view of FIG. 7, the left side being a mirror image.

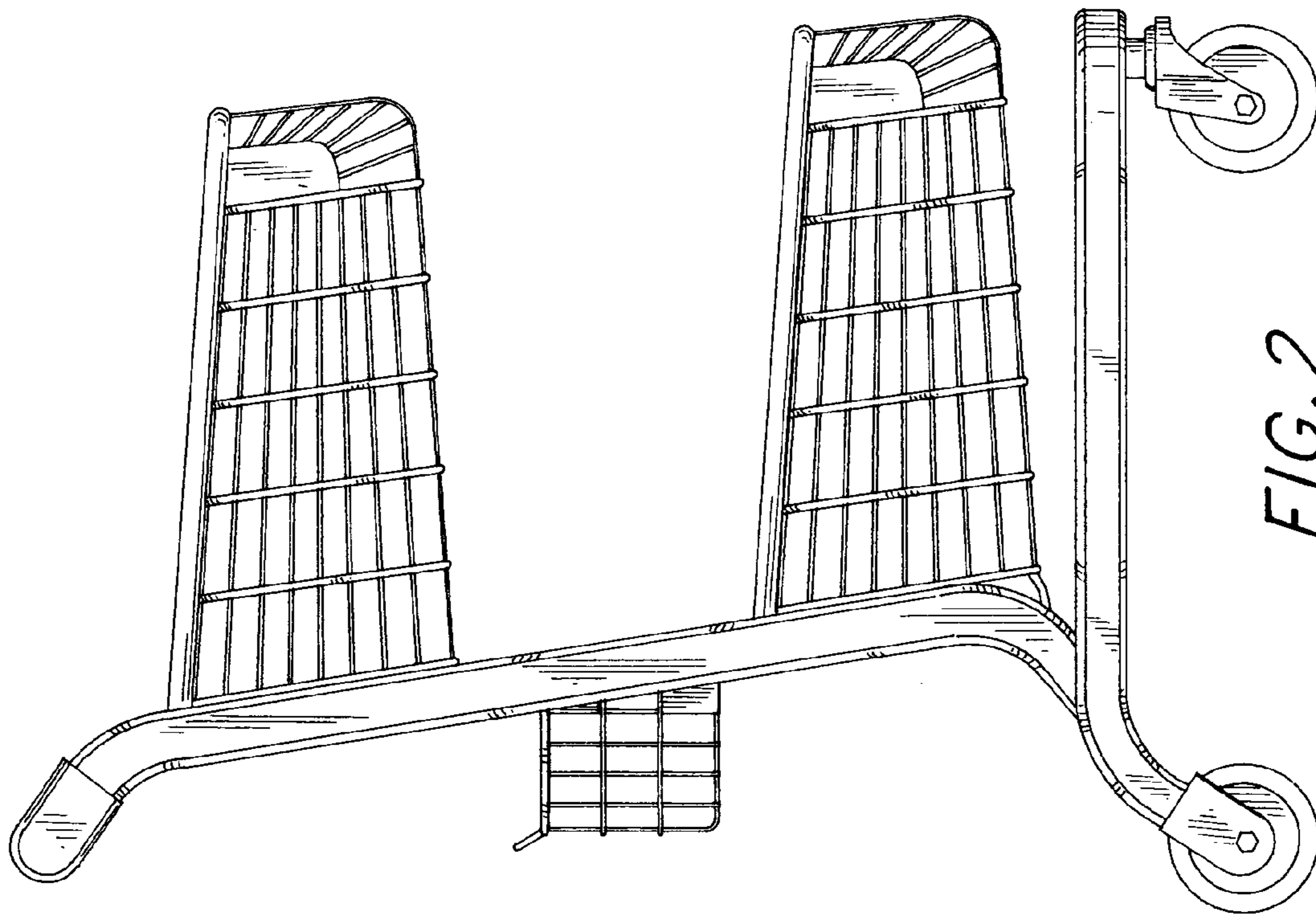

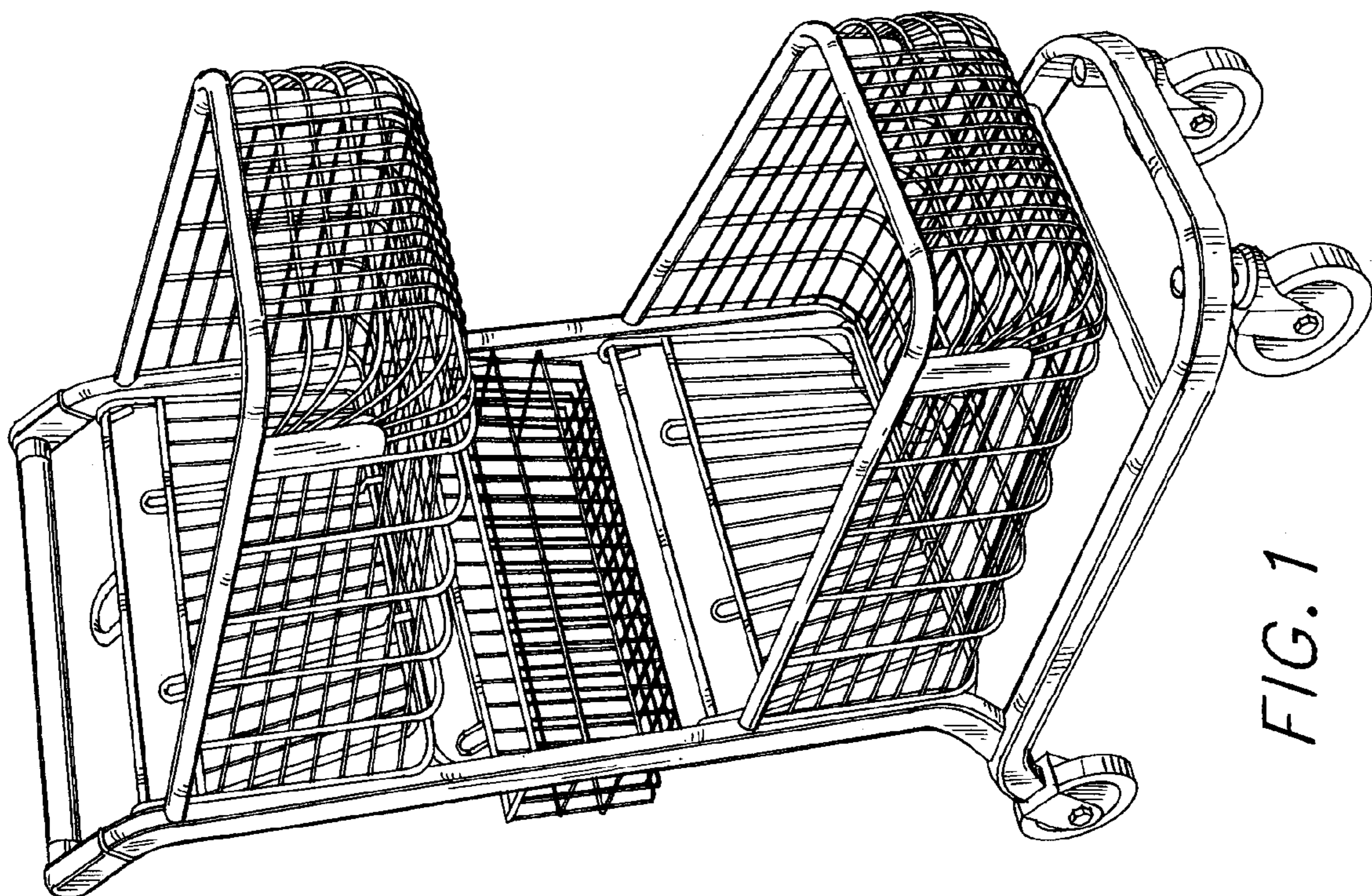

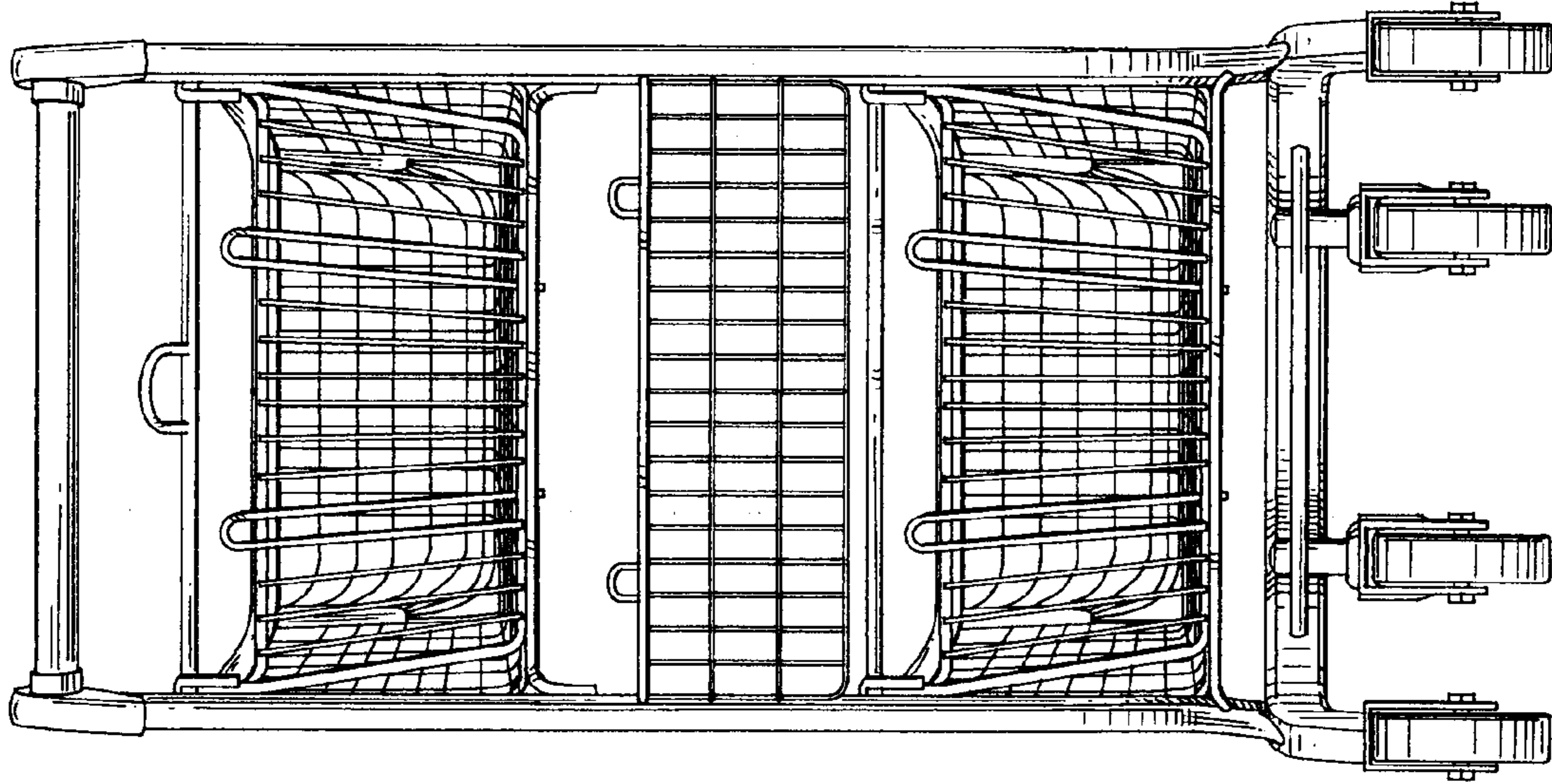

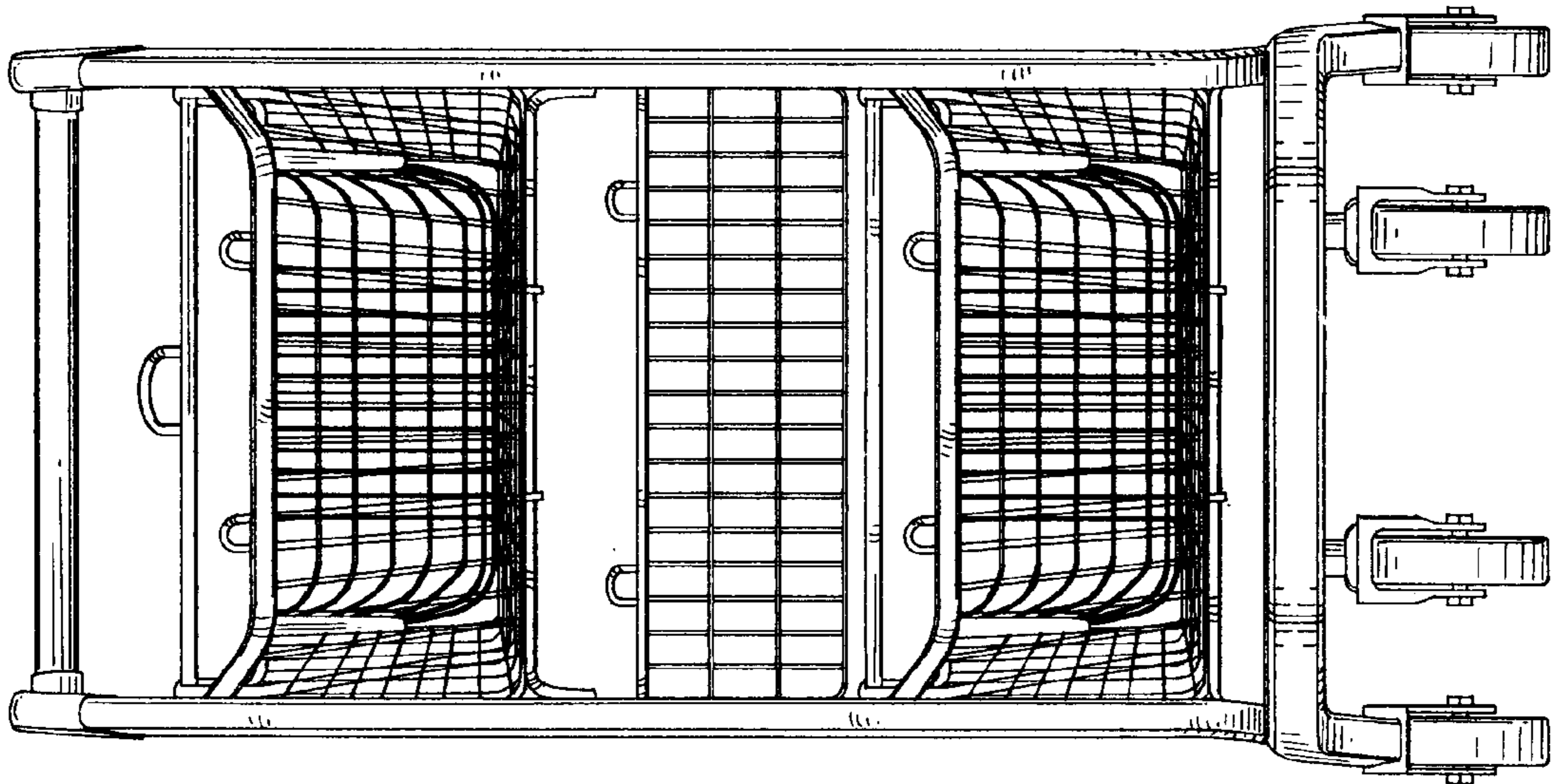

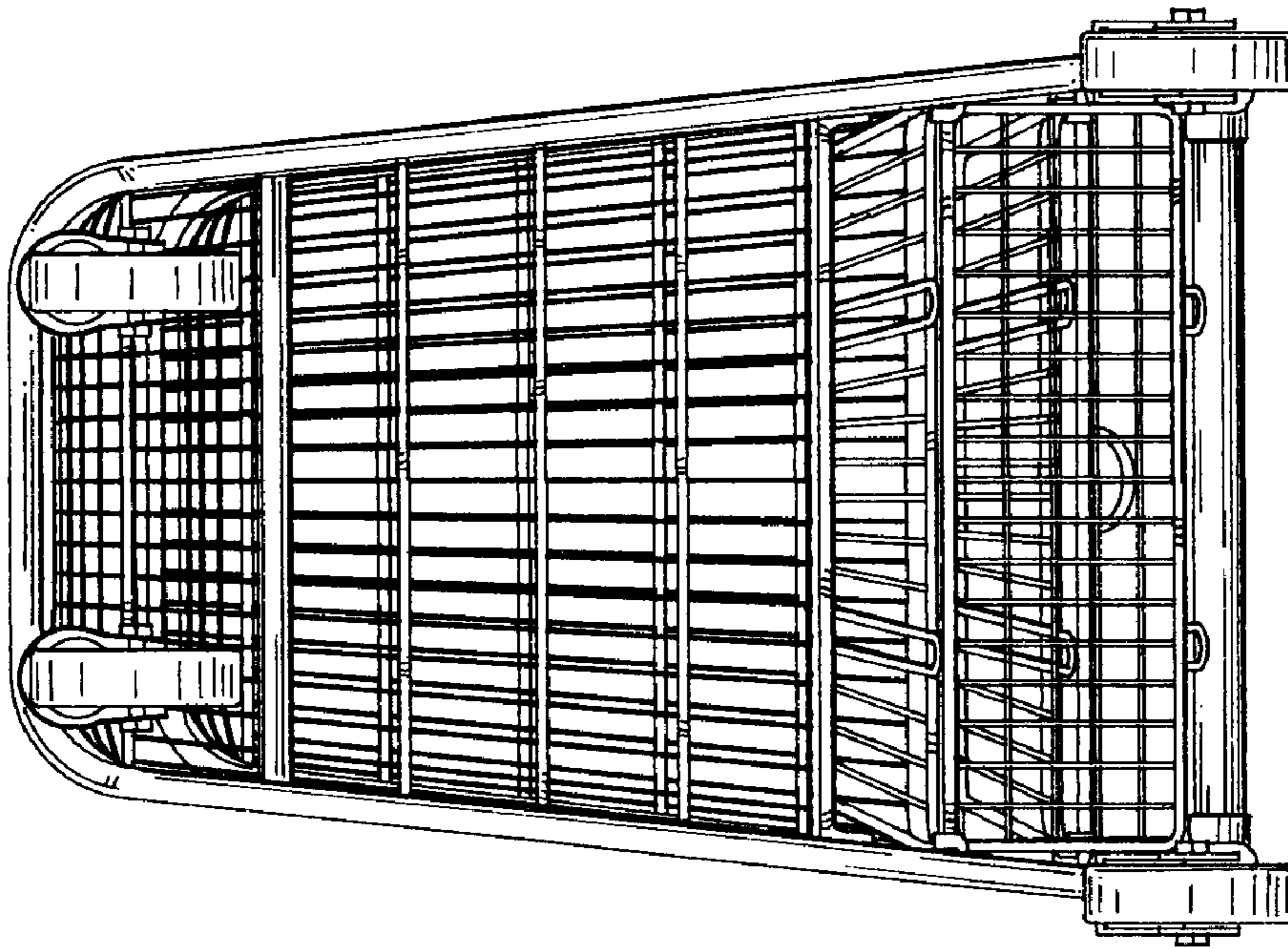

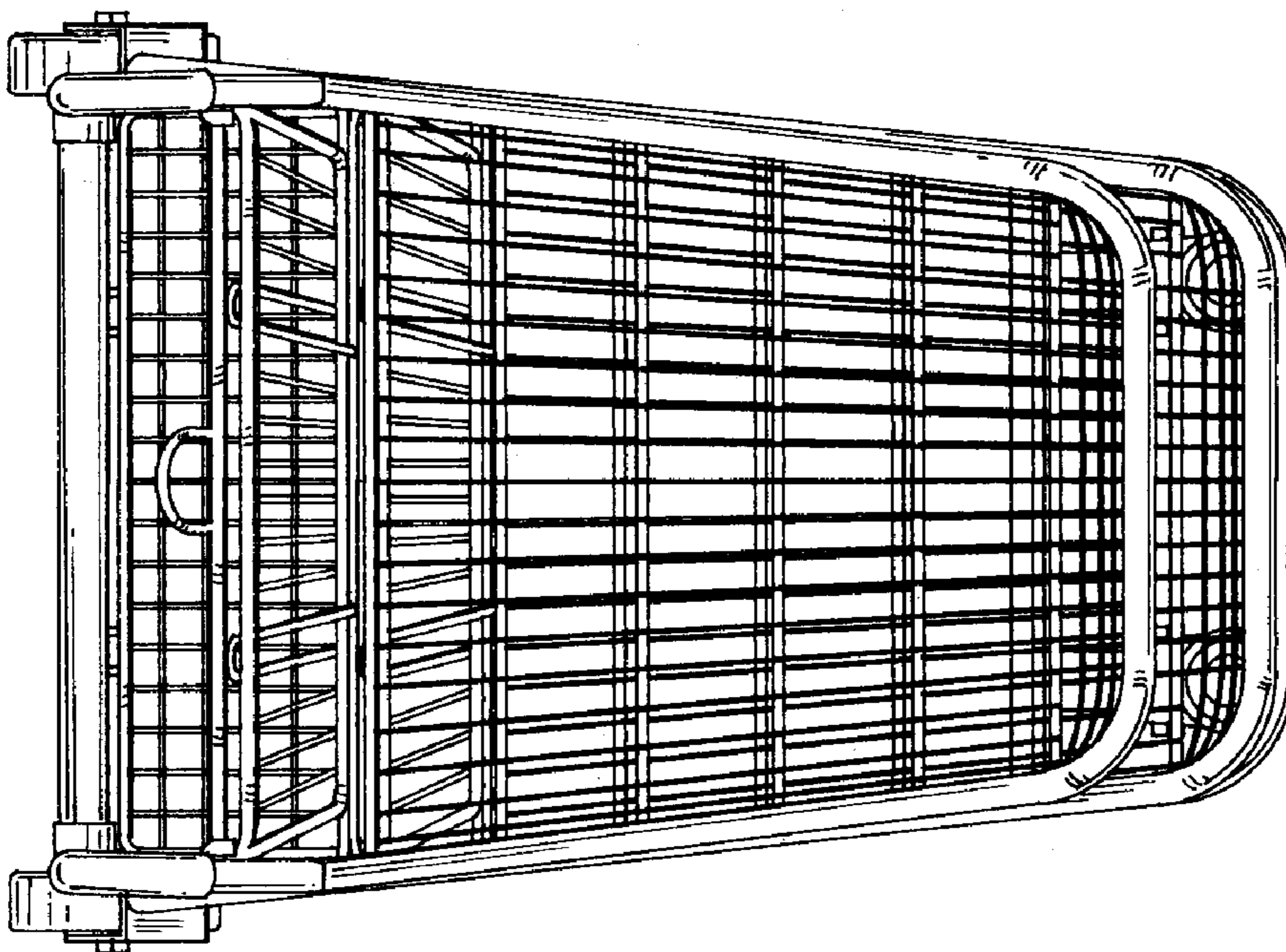

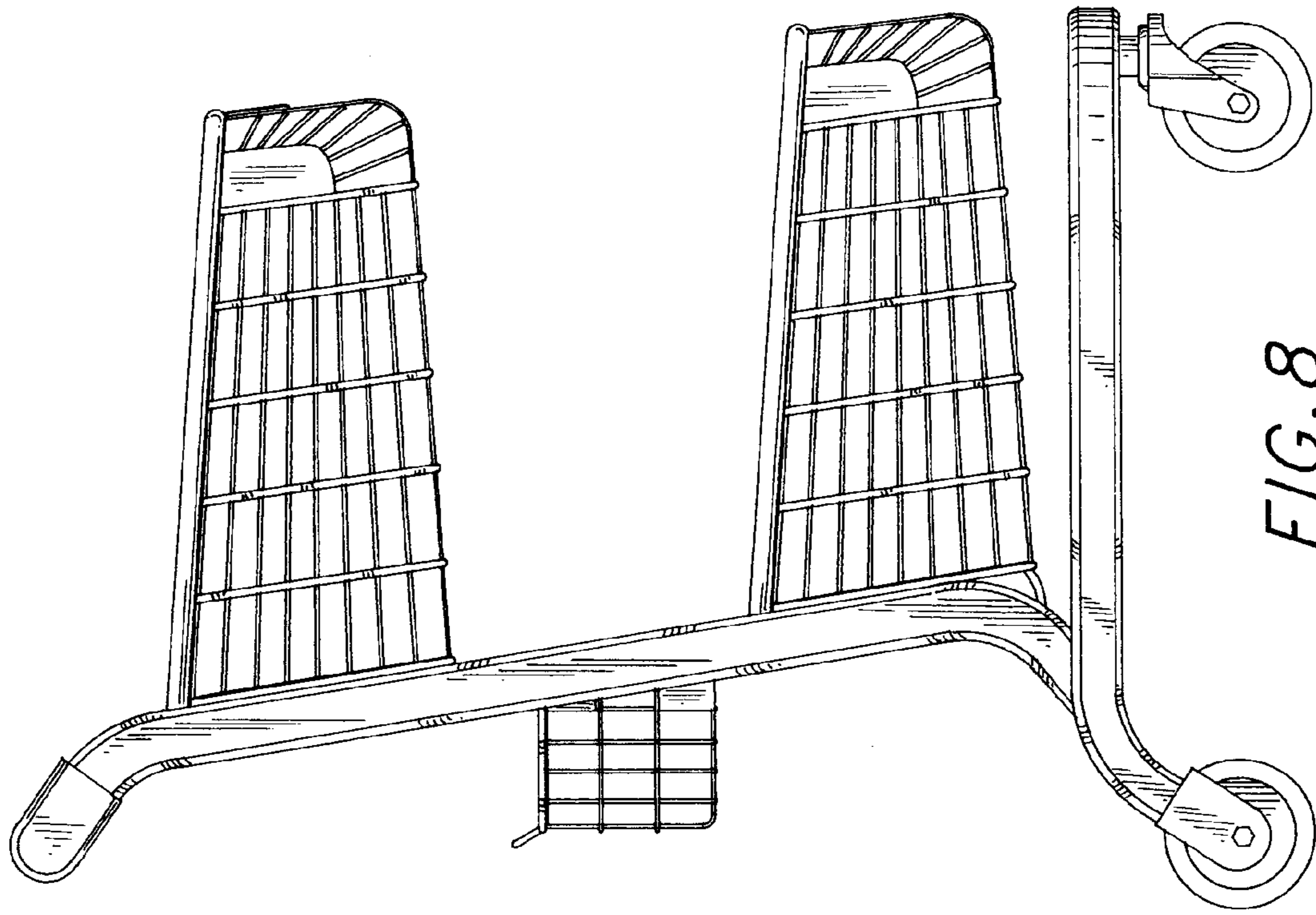

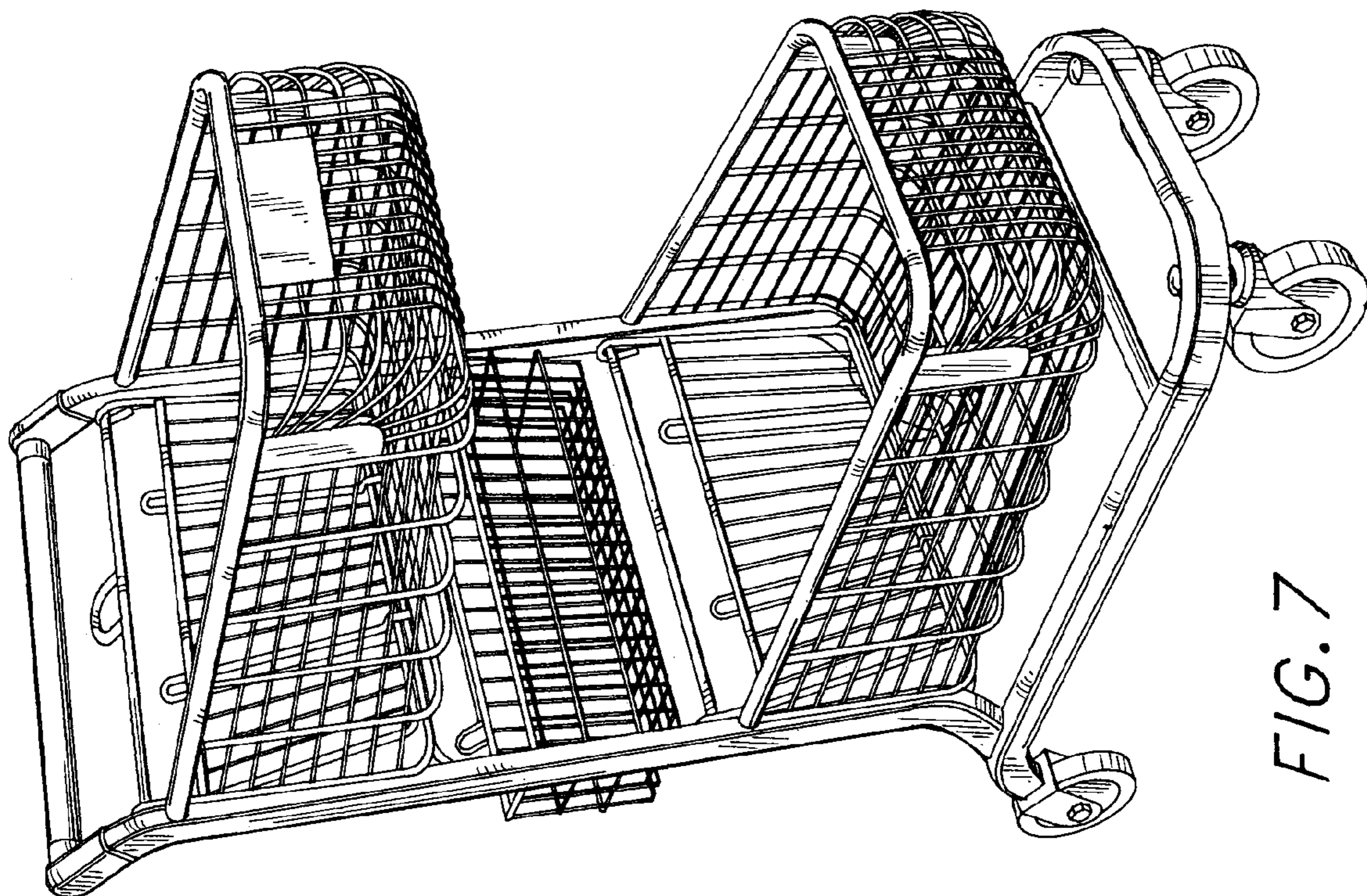

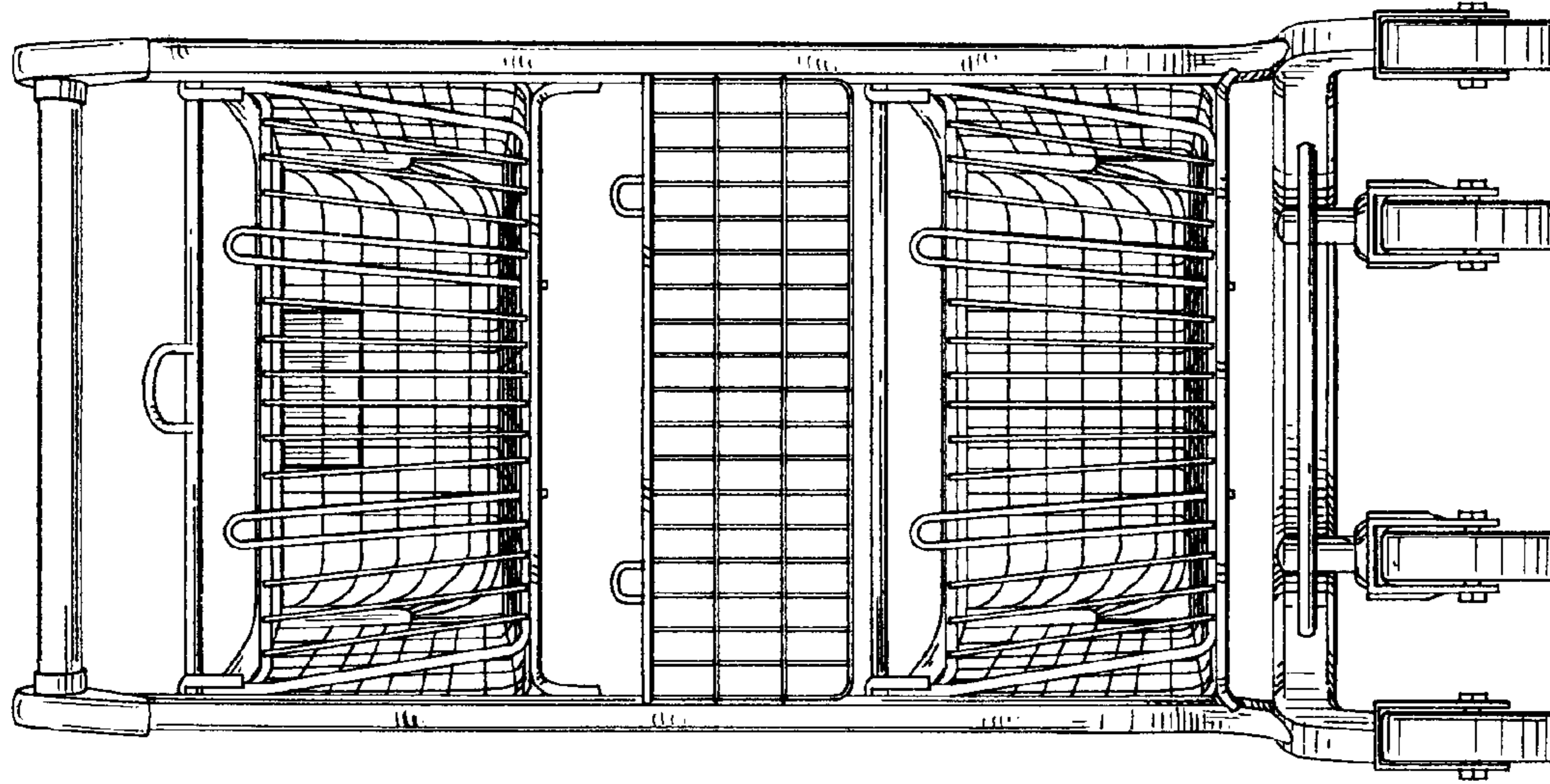

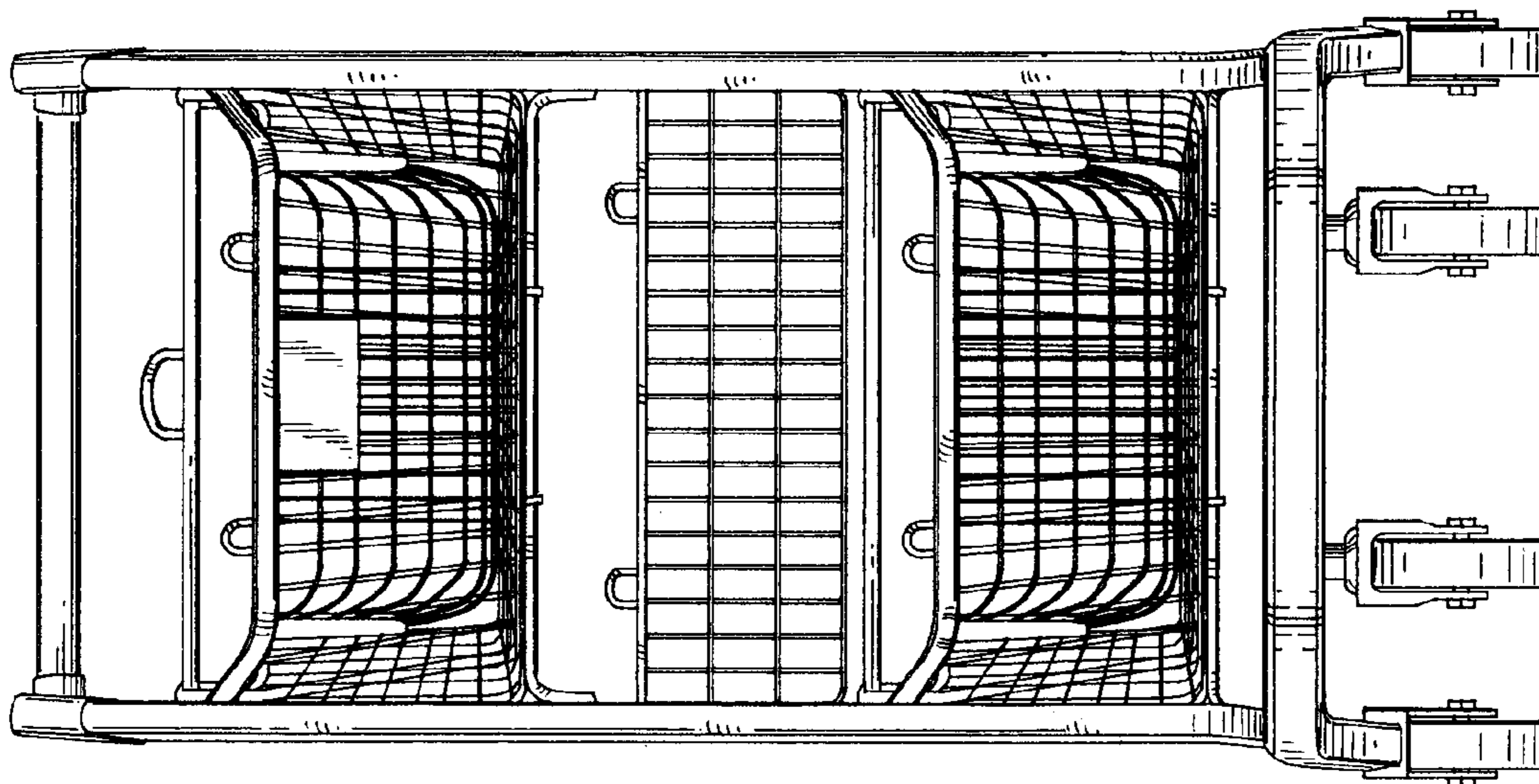

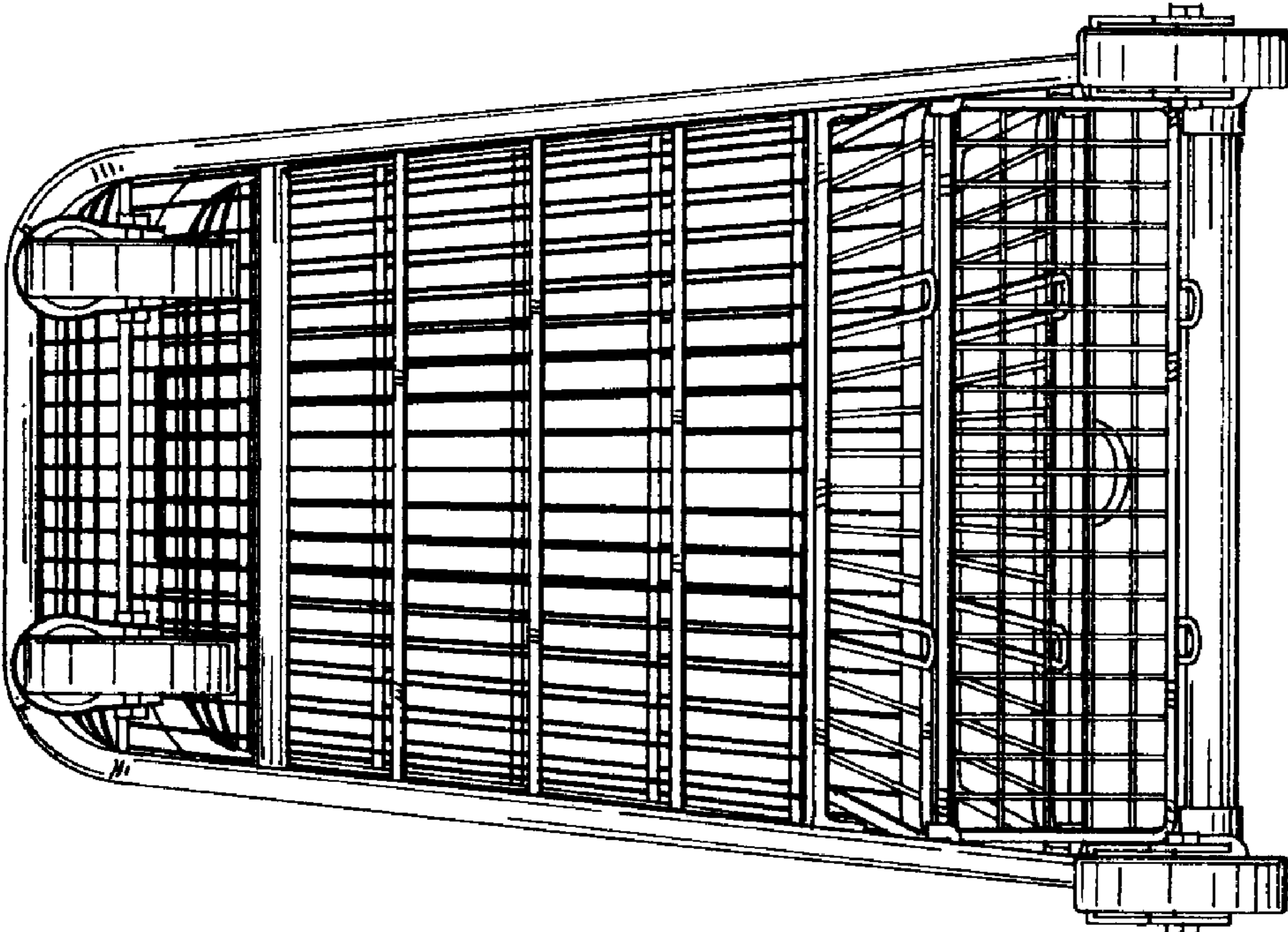
