(57) **CLAIM**

The ornamental design for a body scrubbing towel, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the body scrubbing towel showing my new design;
FIG. 2 is a left side elevational view of the body scrubbing towel;
FIG. 3 is a top plan view of the body scrubbing towel;
FIG. 4 is a cross sectional of the body scrubbing towel, taken in the direction of cut line 4—4 in FIG. 3; and,
FIG. 5 is a diagrammatic perspective view of the body scrubbing towel.

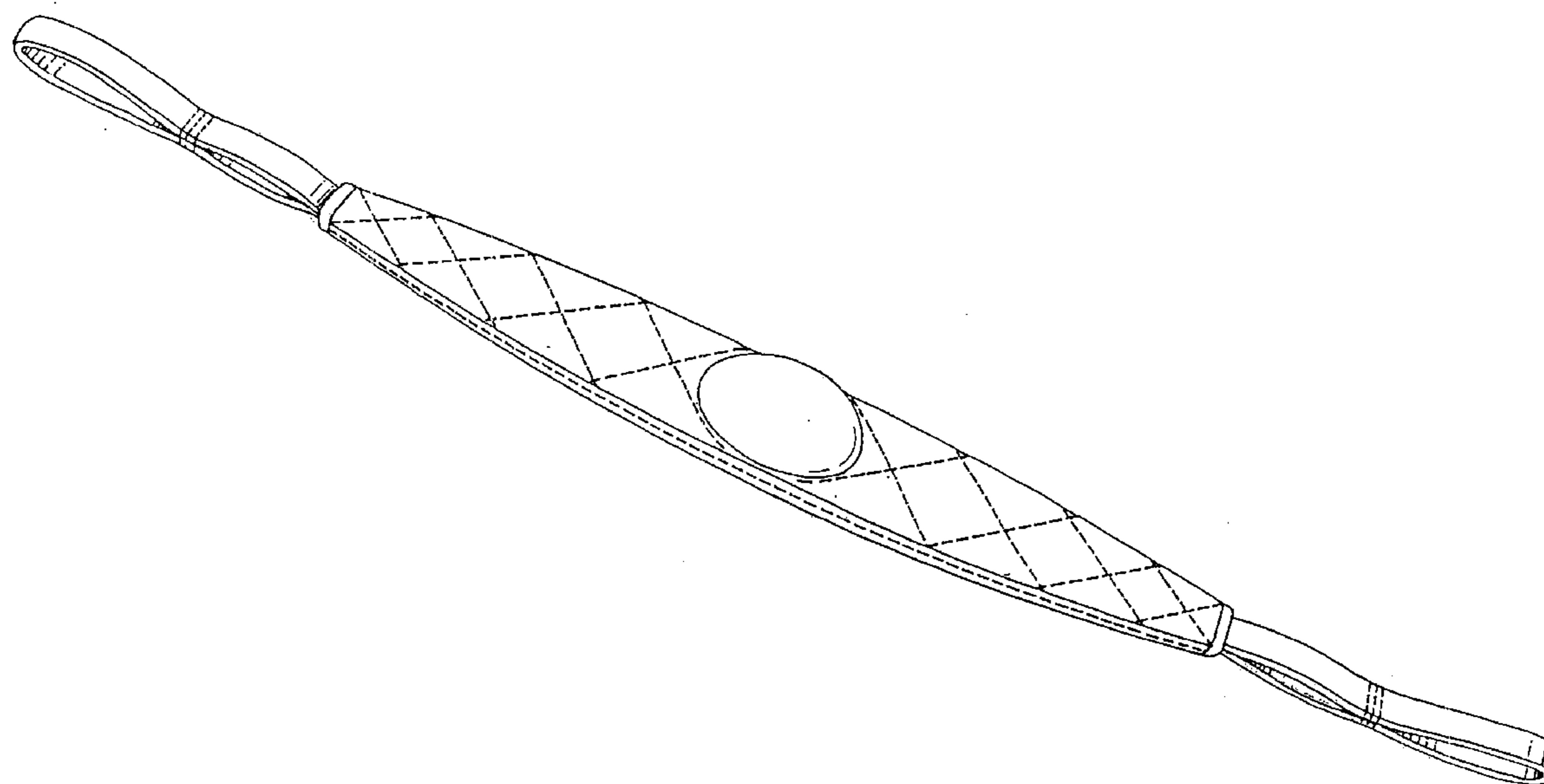

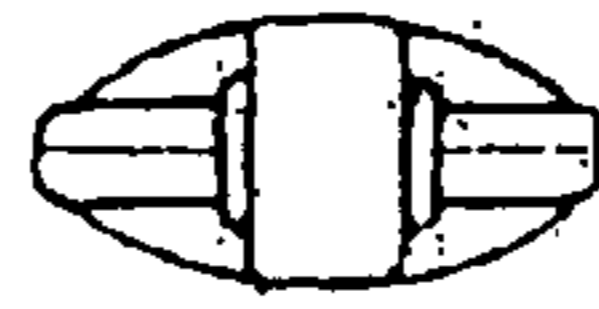

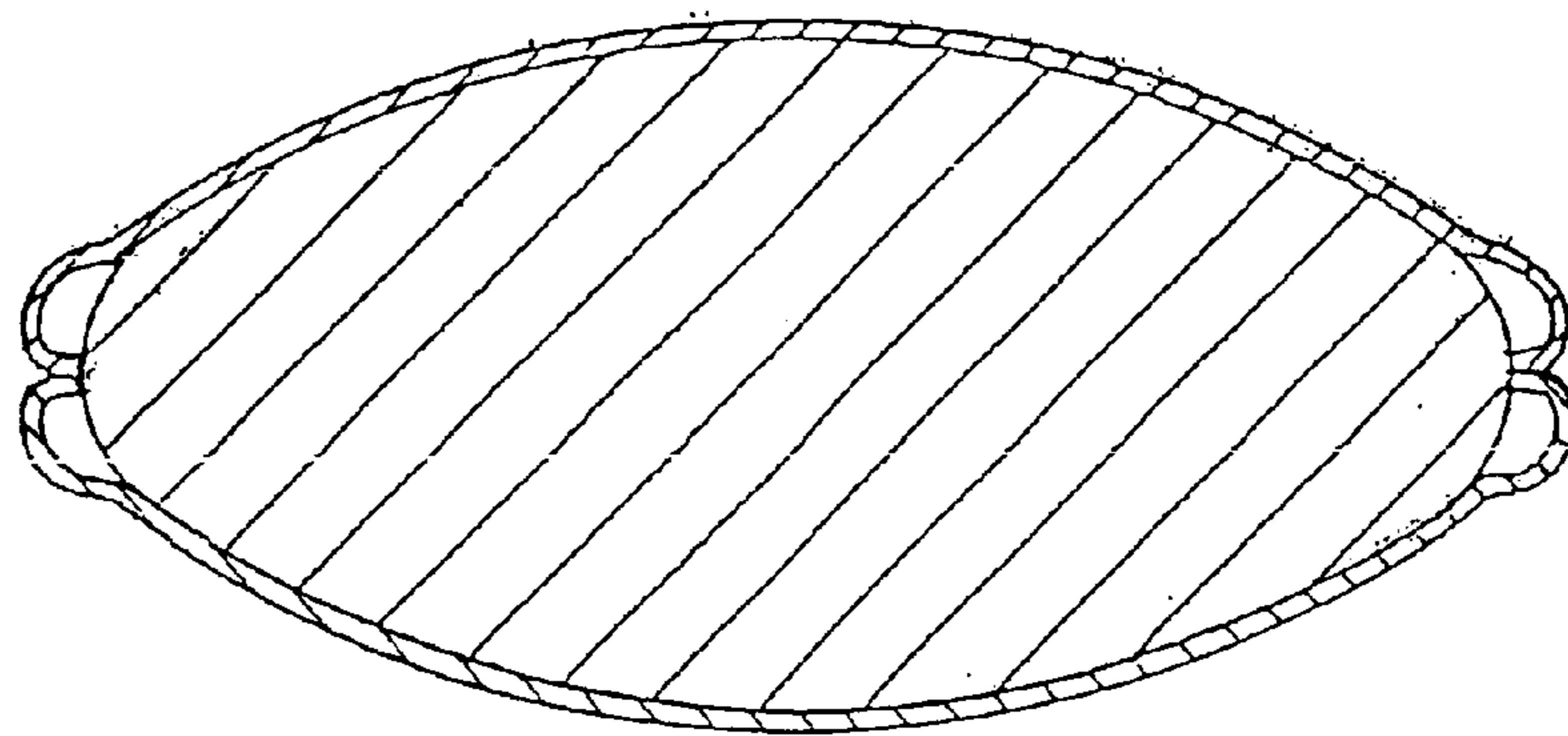

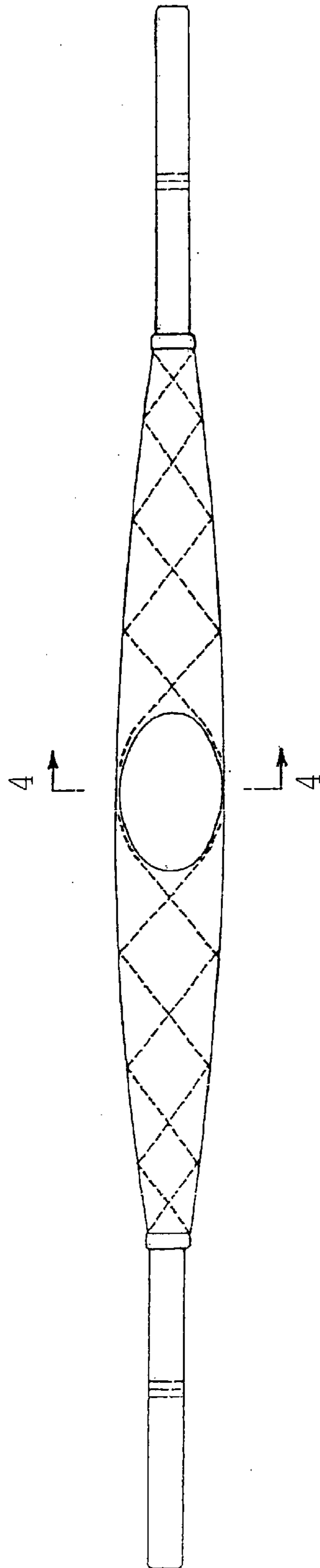
