FIG. 1 is an isometric view of a barbeque lid showing the new design;

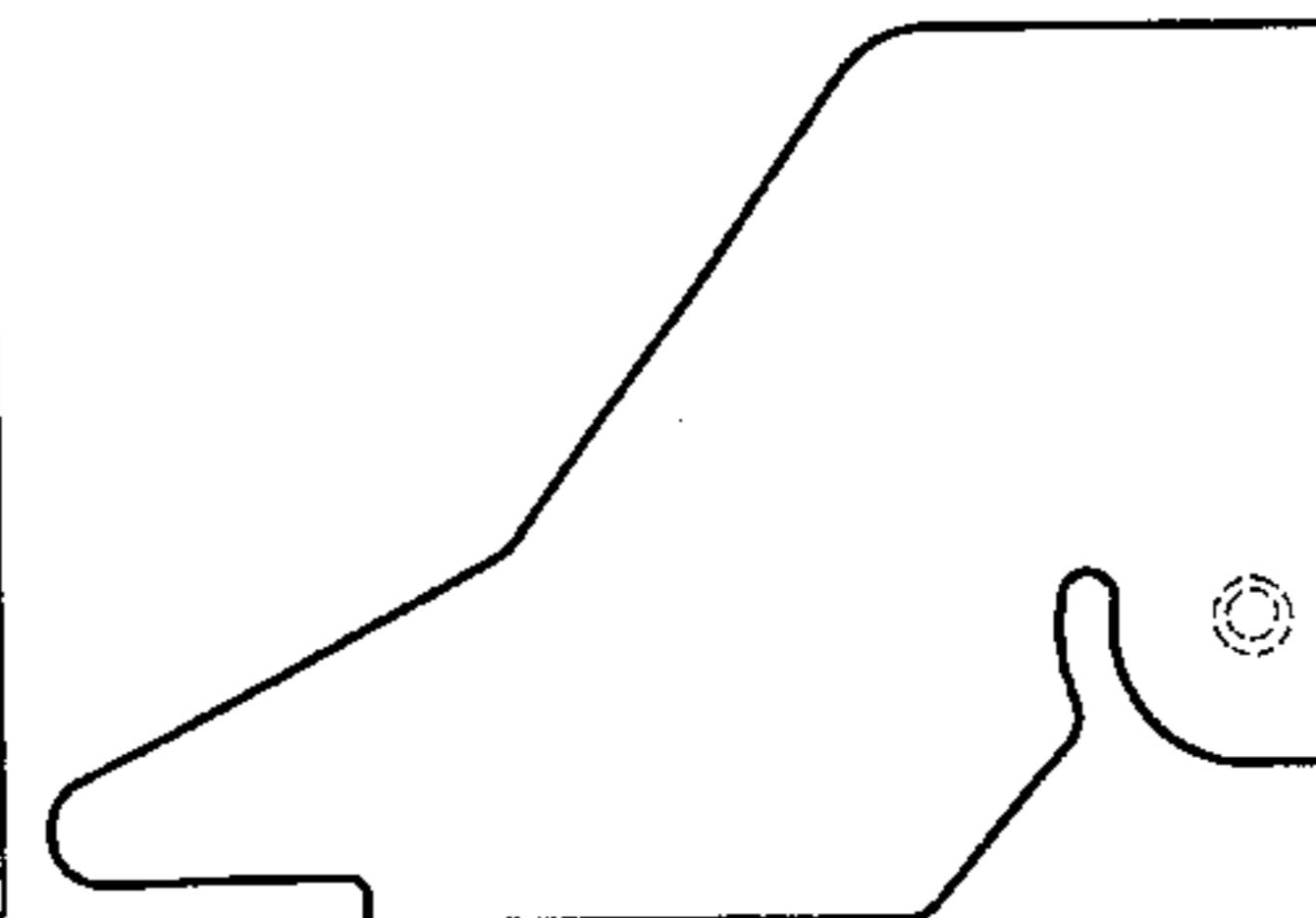
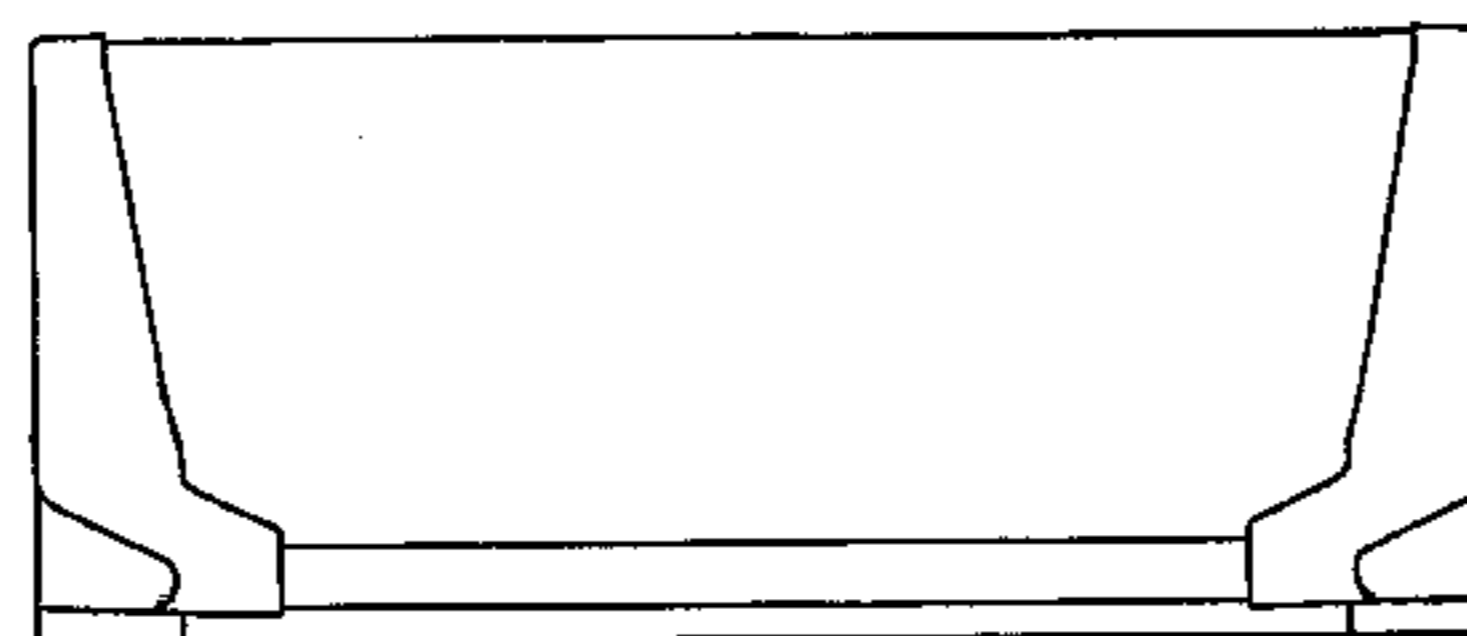
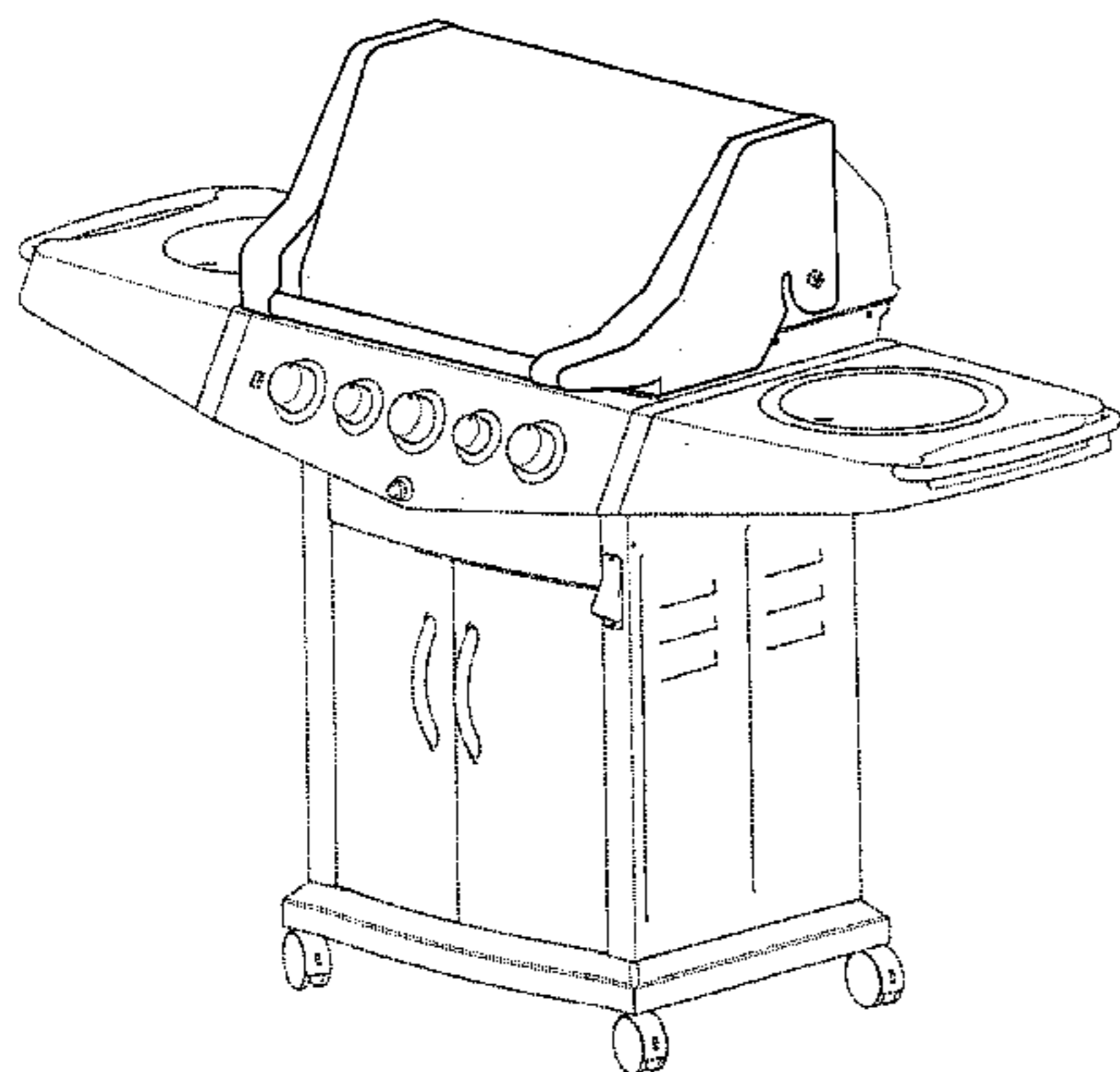
FIG. 2 is a front view of the barbeque lid of FIG. 1;

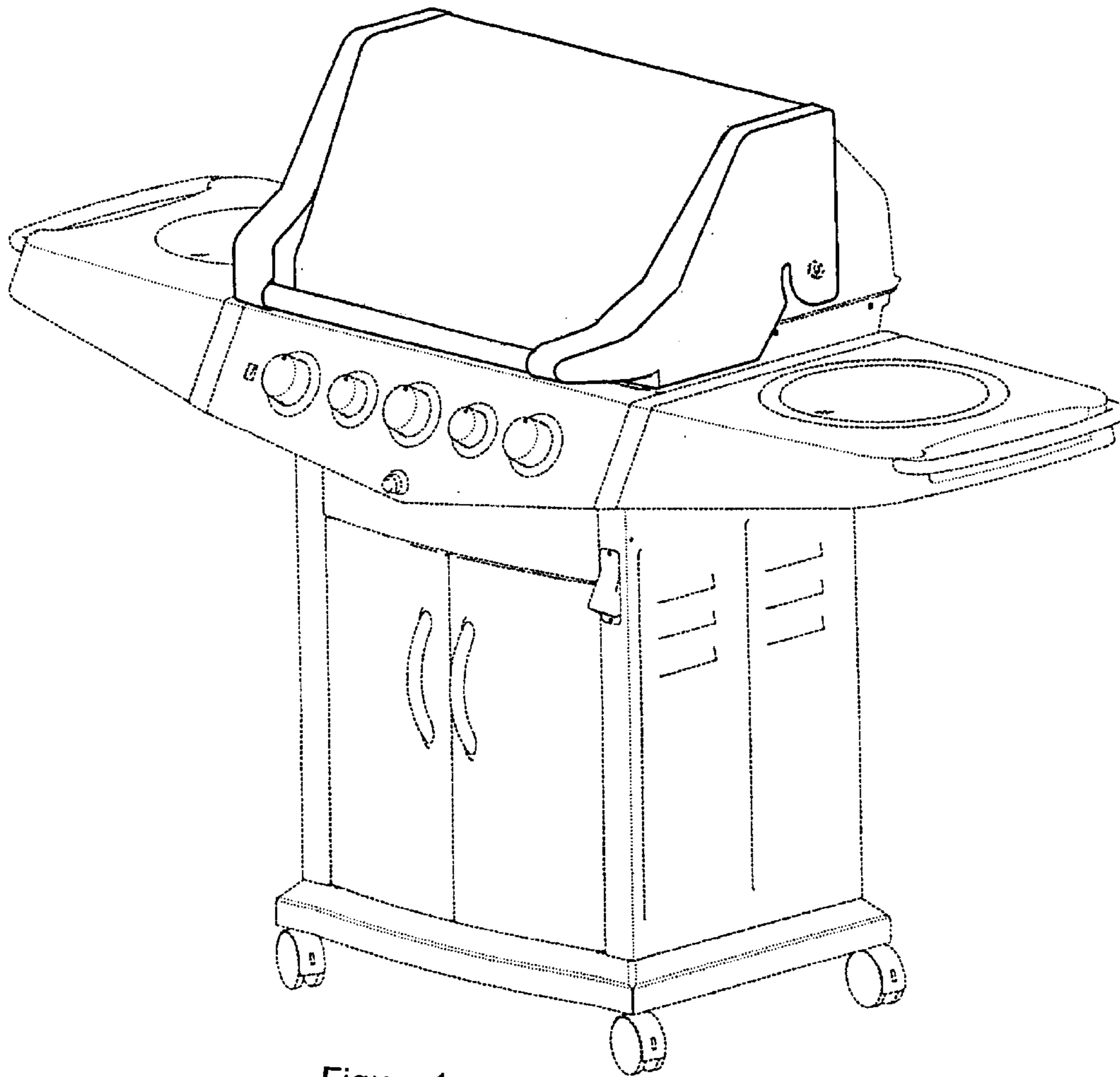

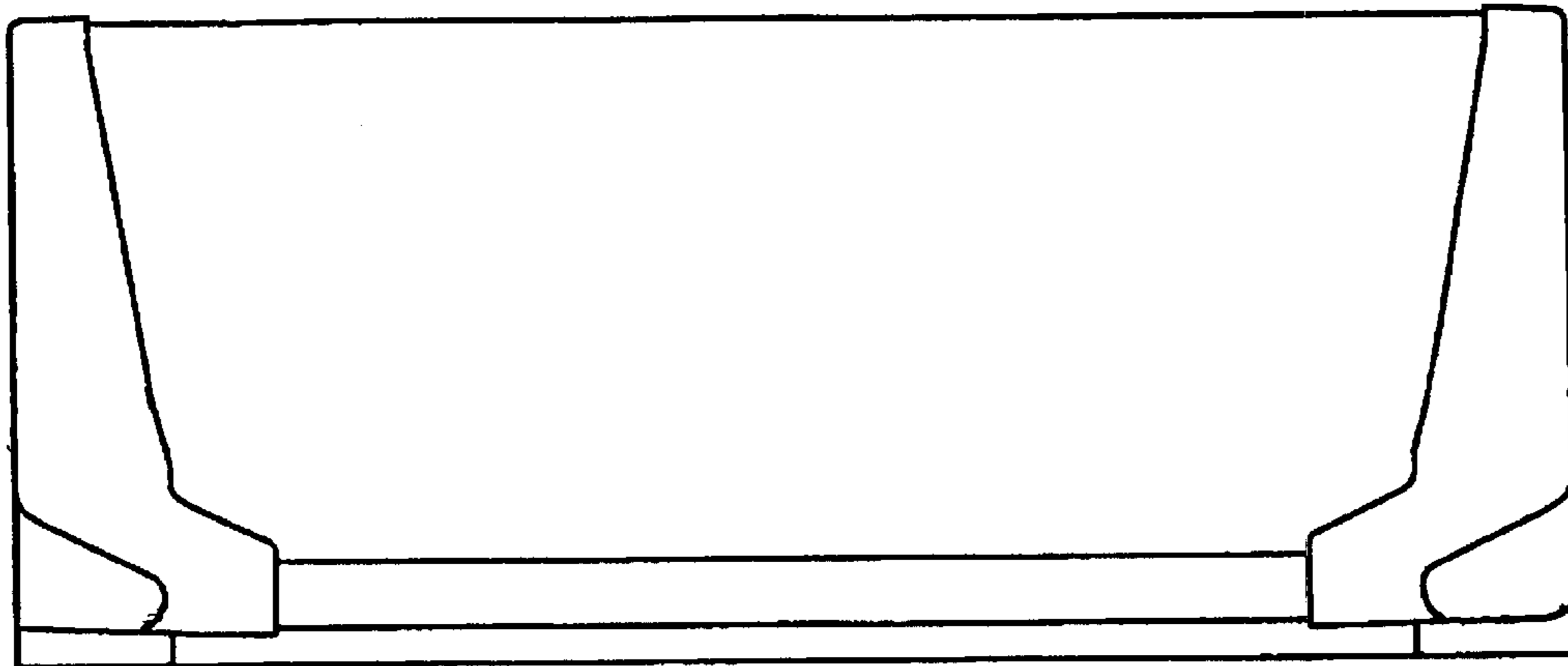

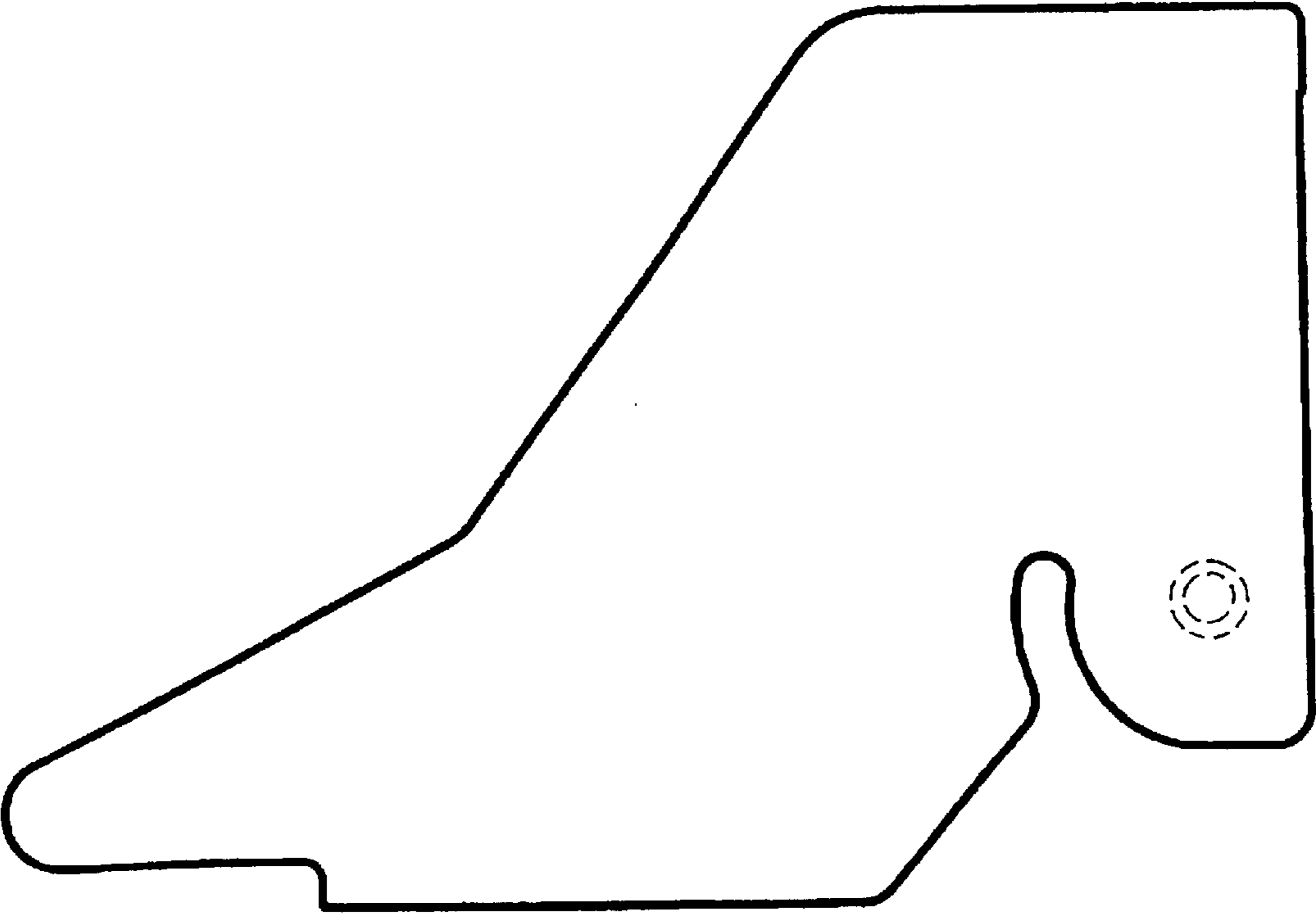

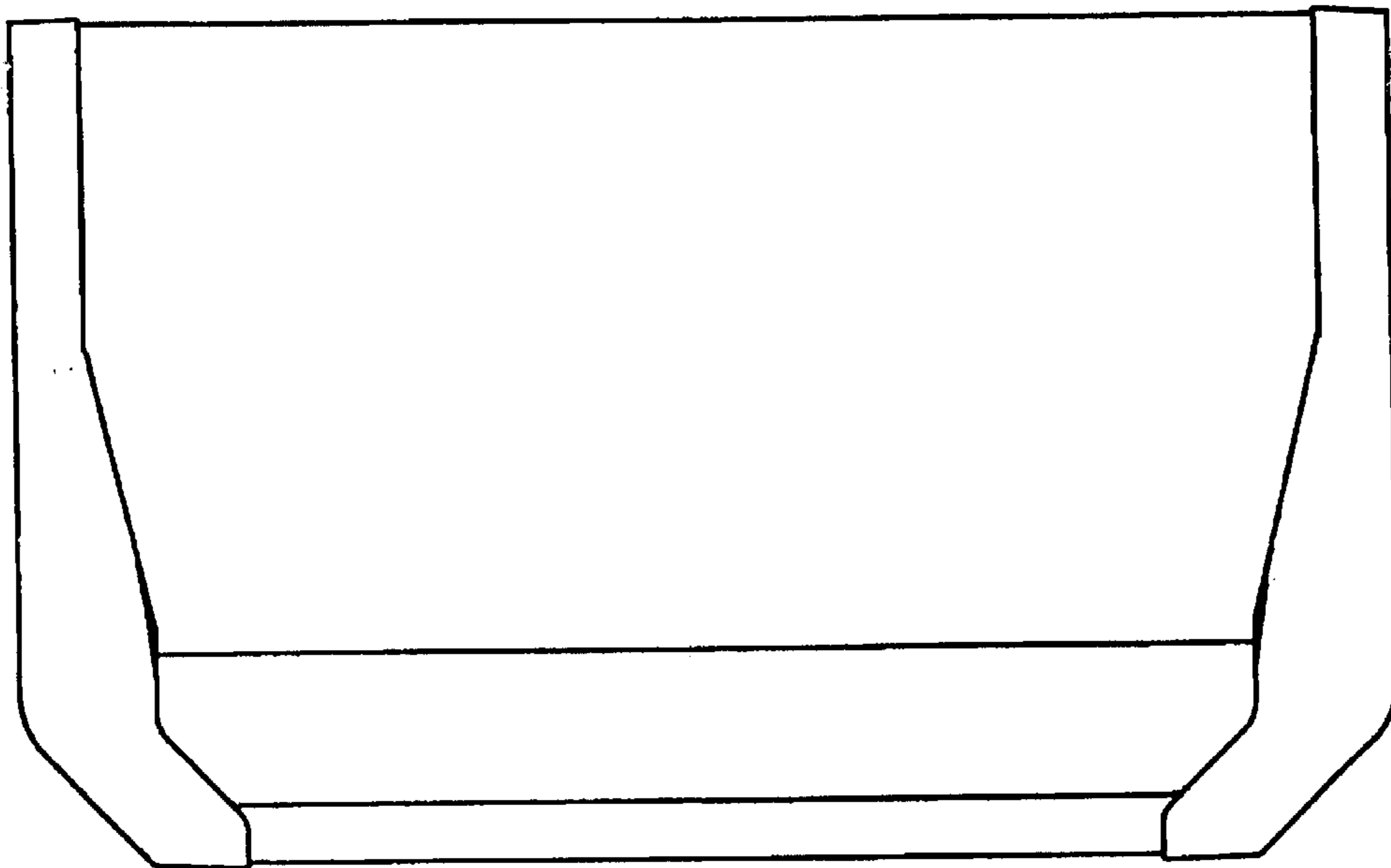
