The ornamental design for a consumable holder member, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a consumable holder member showing my new design for retaining a taco in a vertical position;

FIG. 2 is a top view of FIG. 1;

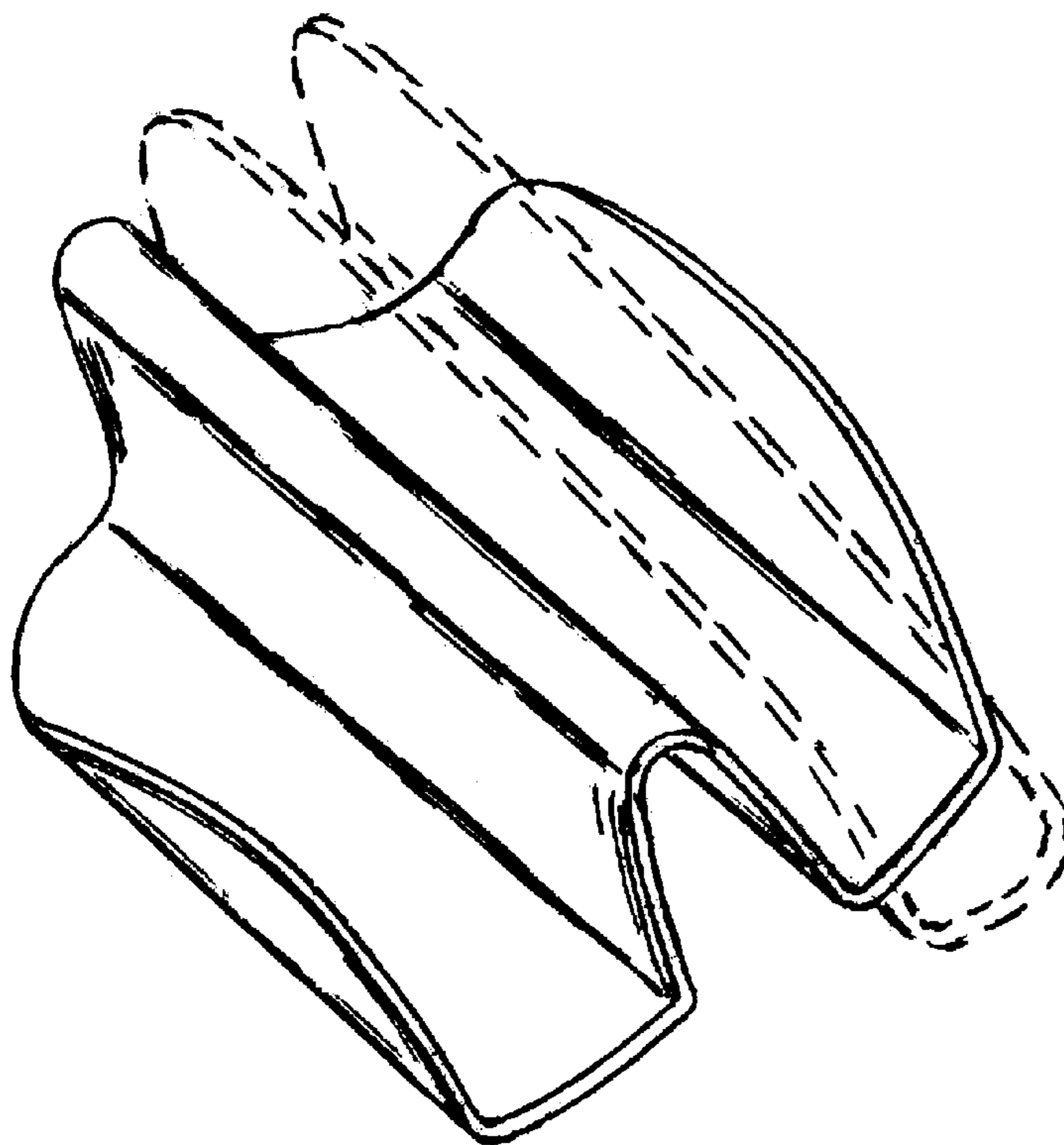
FIG. 3 is a side plan view of FIG. 1

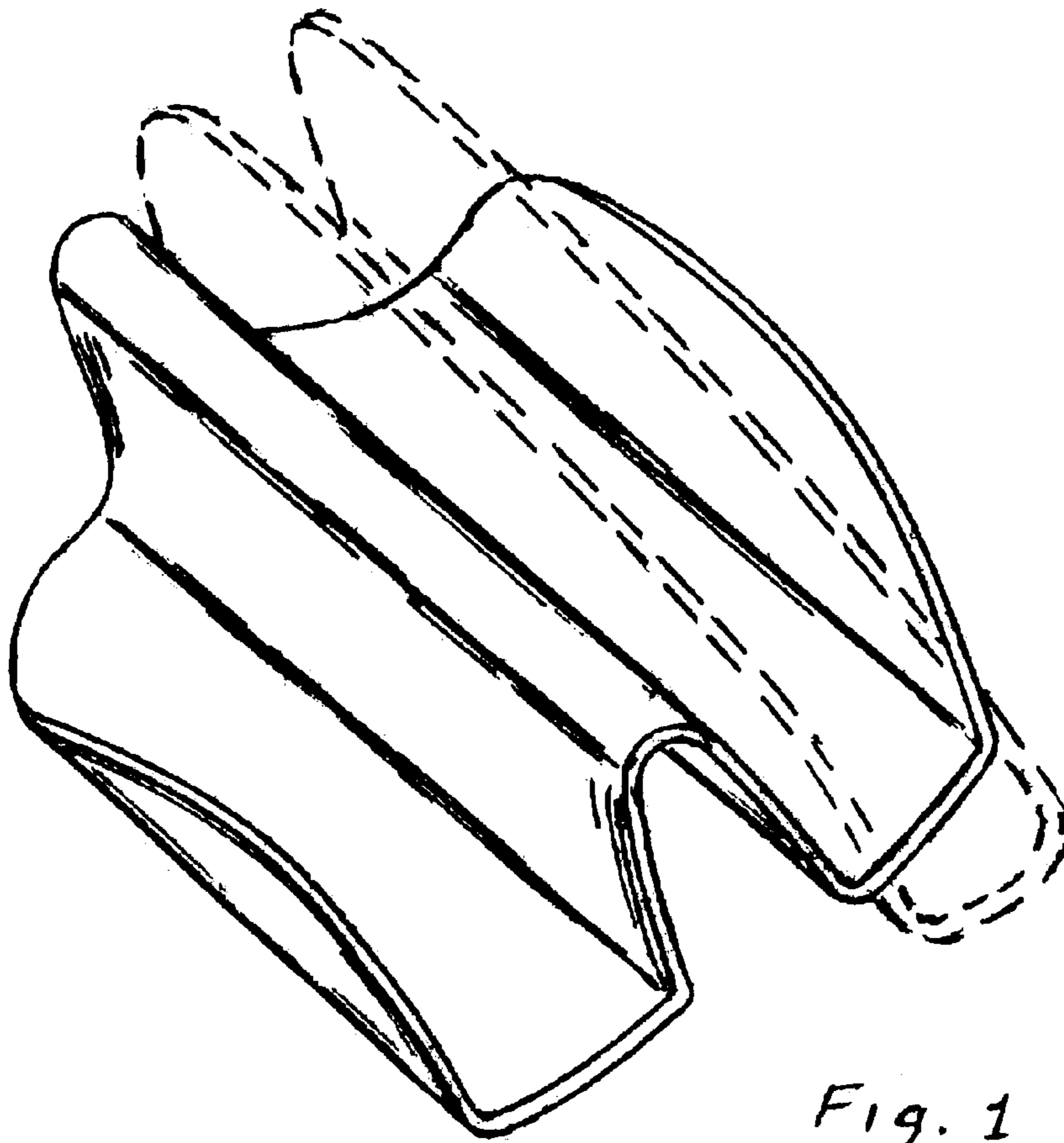

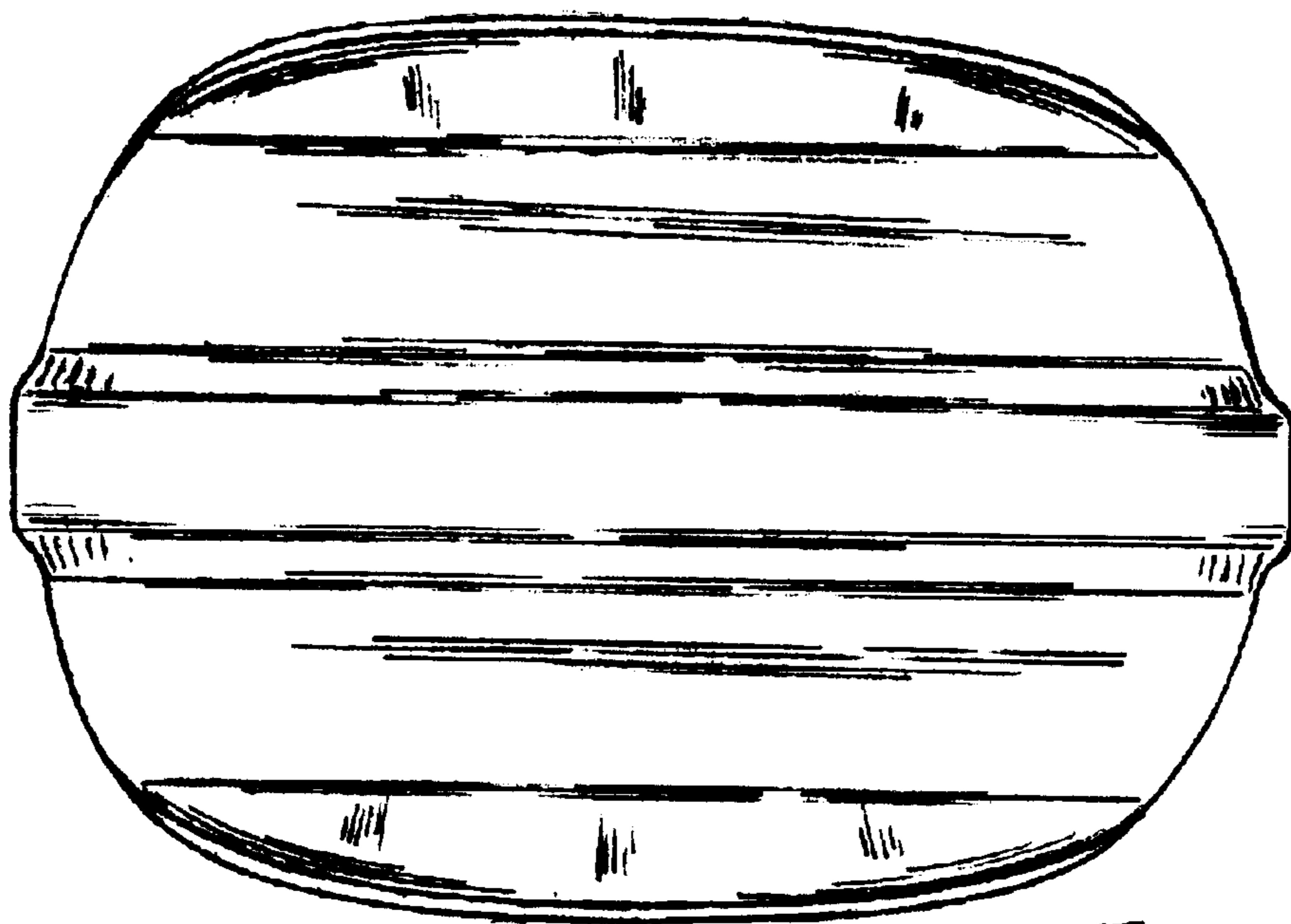

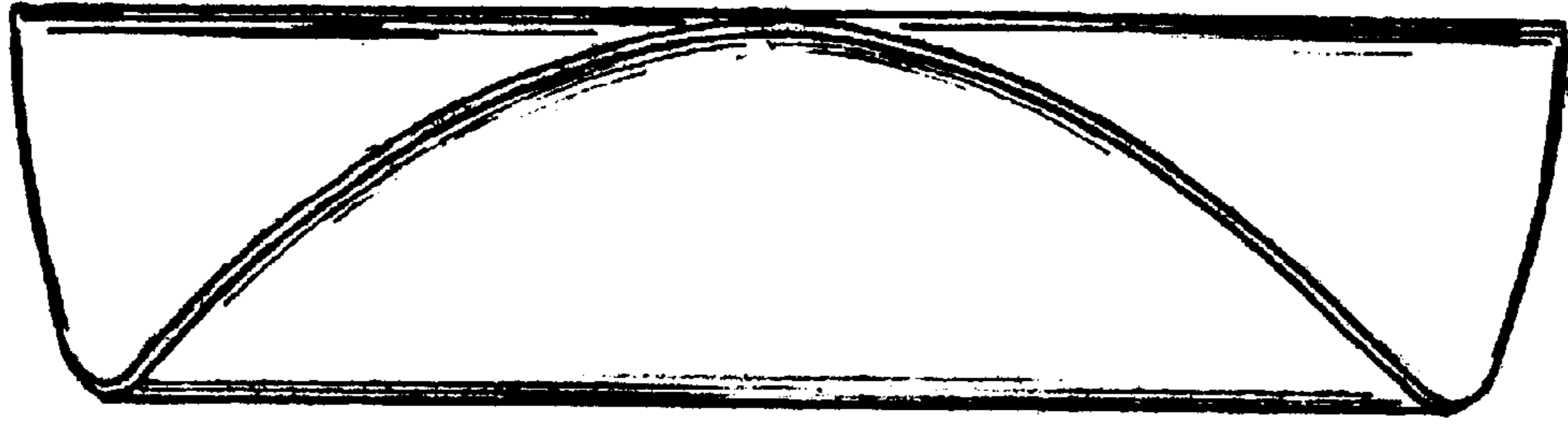

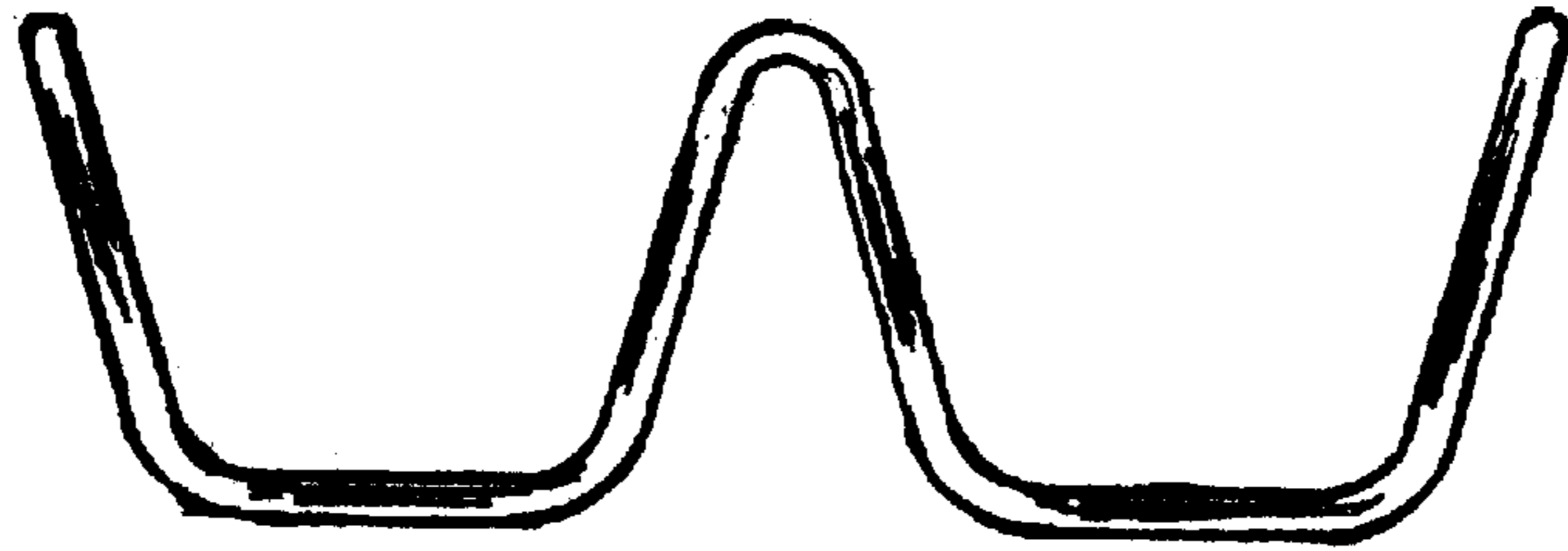

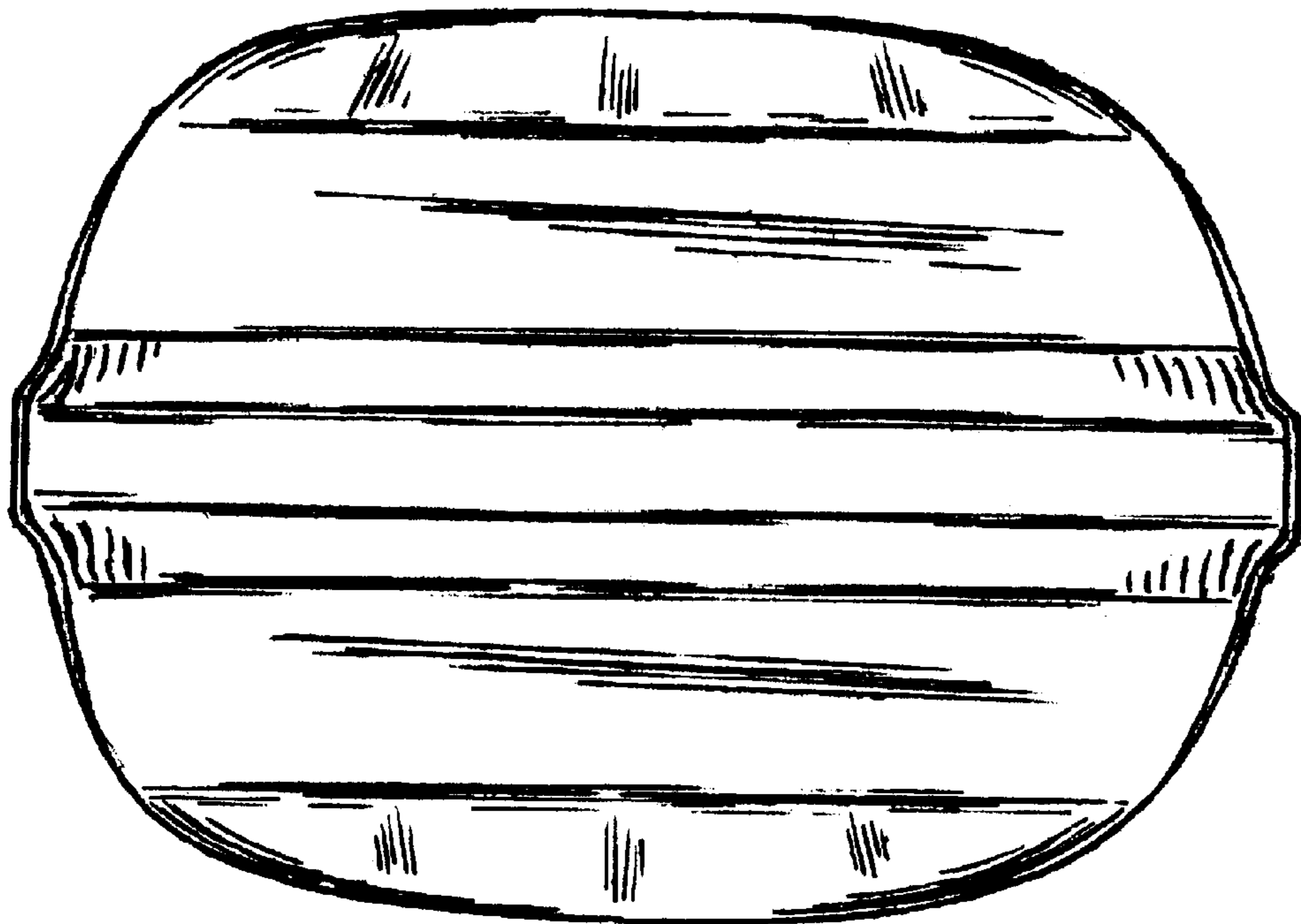
