(57) **CLAIM**

I claim the ornamental design for a cup, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cup according to the new design;
 FIG. 2 is a front view thereof, the rear view being a mirror image thereof;
 FIG. 3 is a left side elevation view of the cup shown in FIG. 1;
 FIG. 4 is a right side elevation view of the cup shown in FIG. 1;
 FIG. 5 is a top view of the cup shown in FIG. 1; and,
 FIG. 6 is a bottom view of the cup shown in FIG. 1.
 The broken lines in the drawings are for illustrative purposes only and form no part of the claimed design.

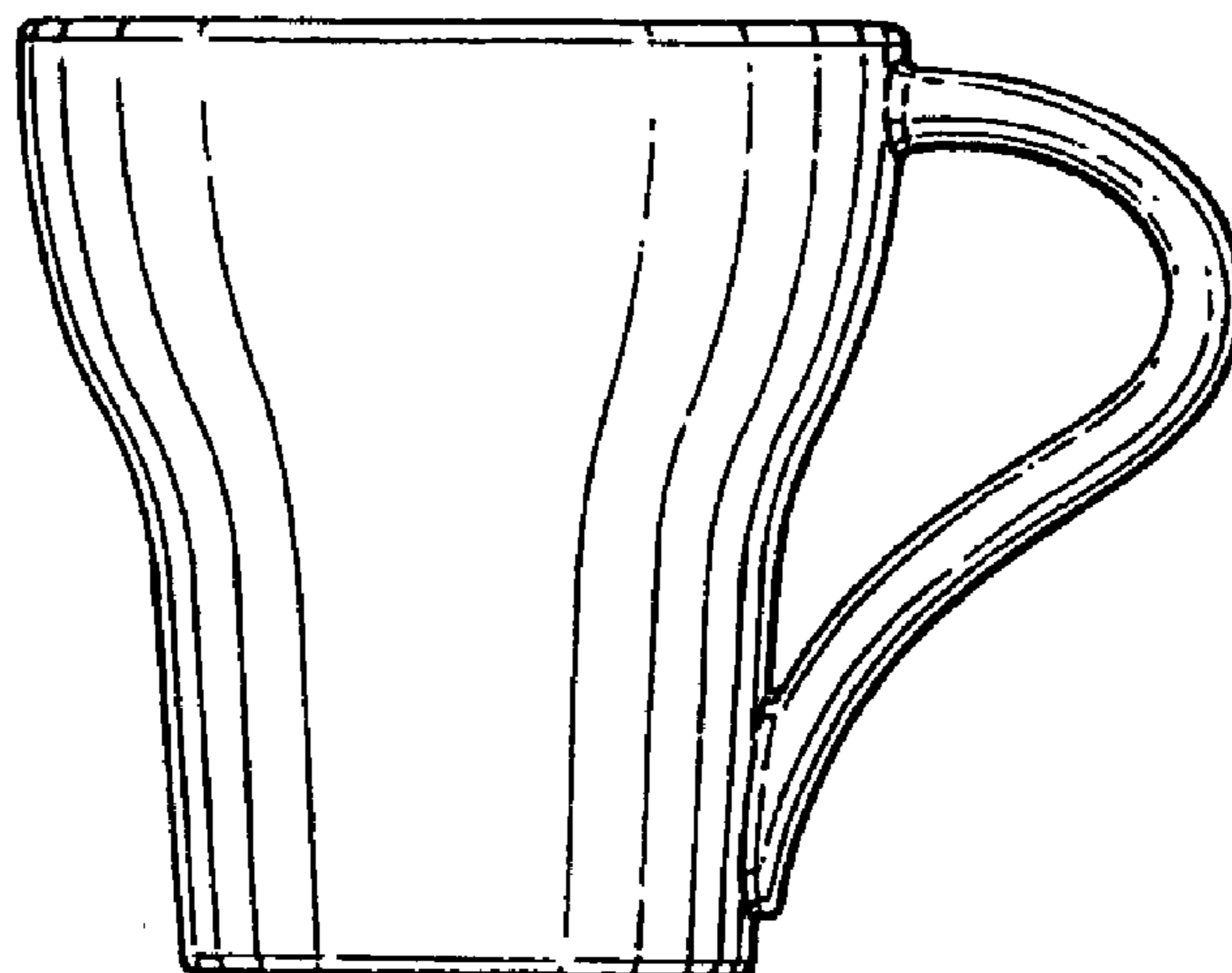

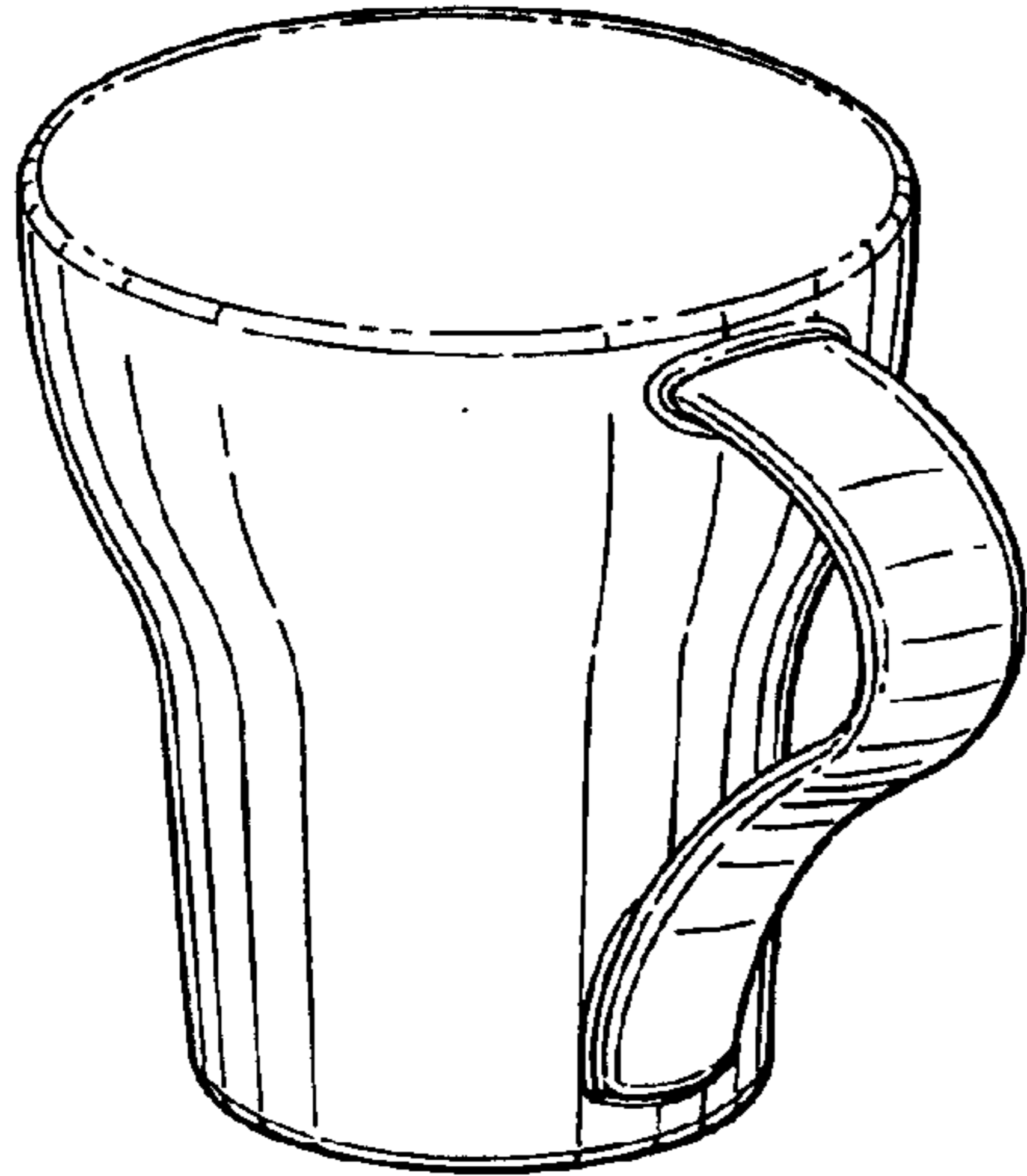

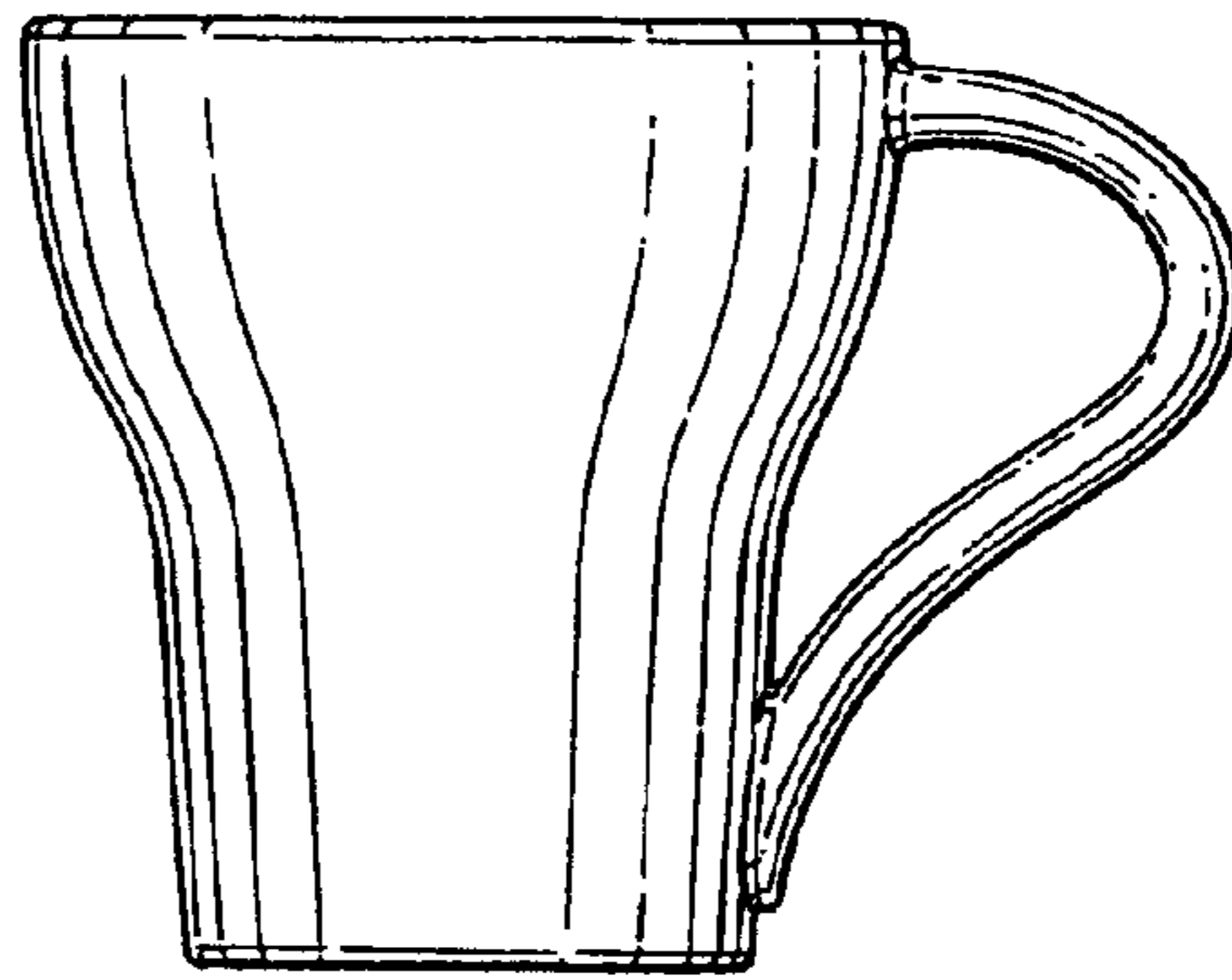

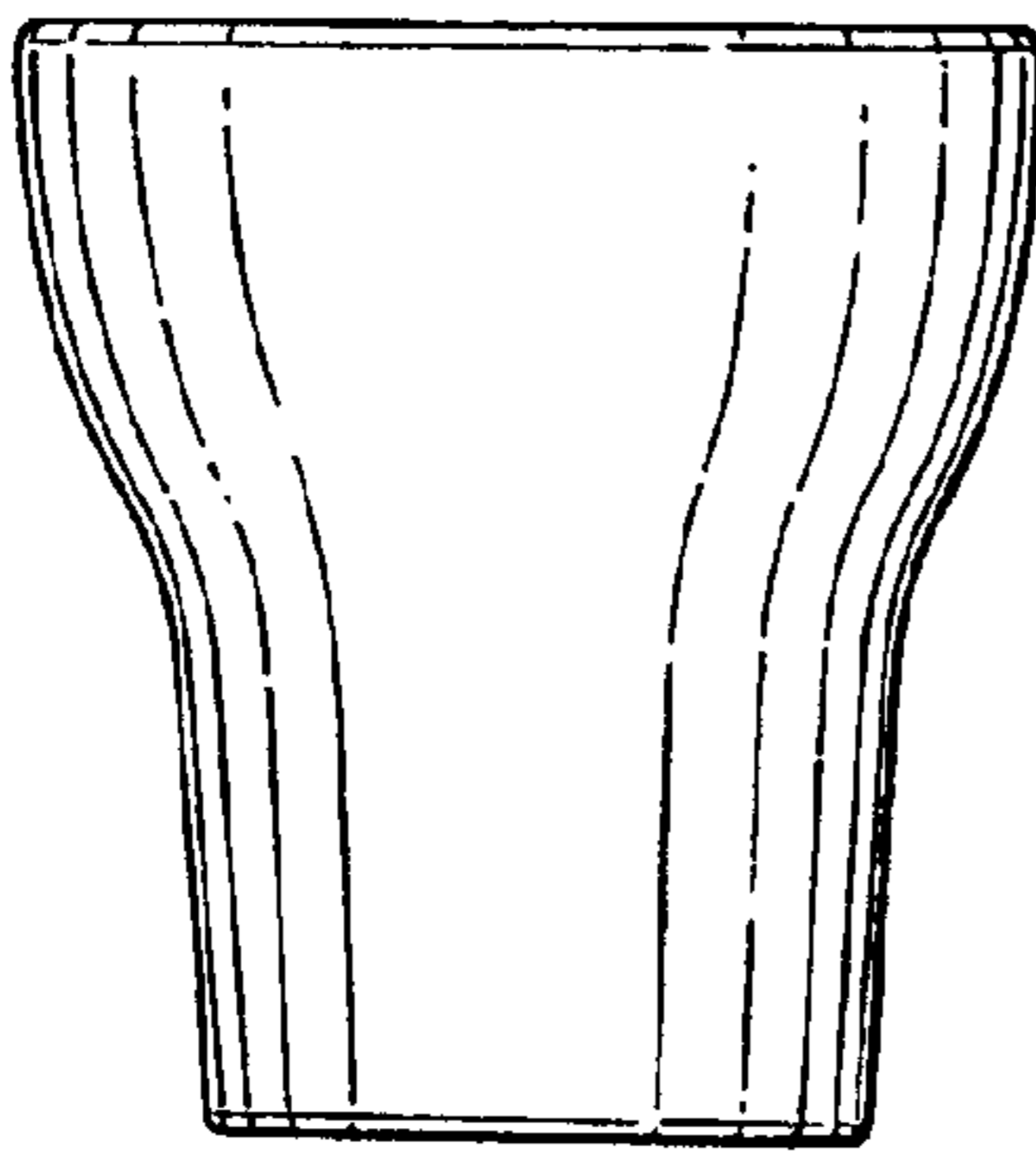

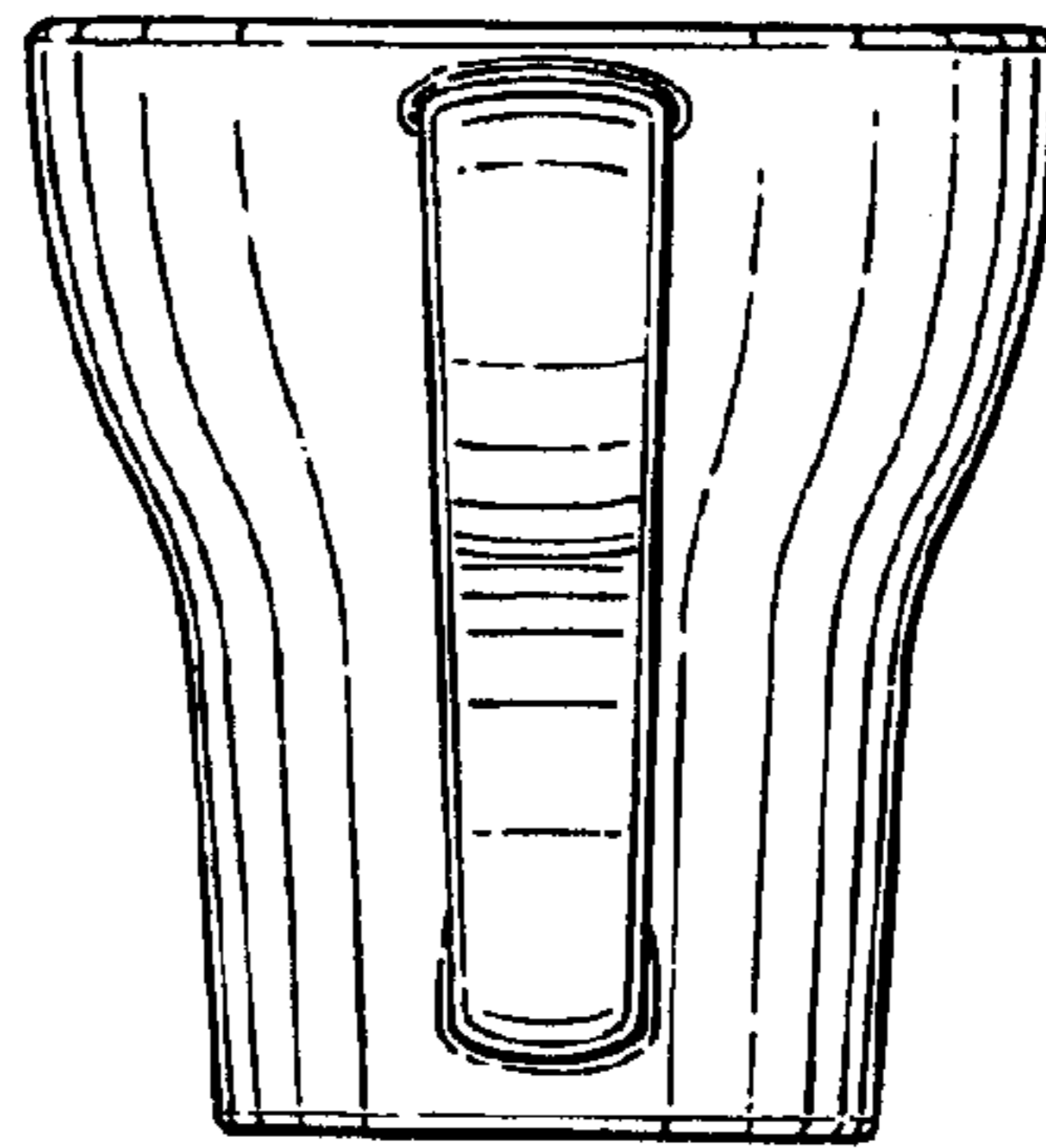

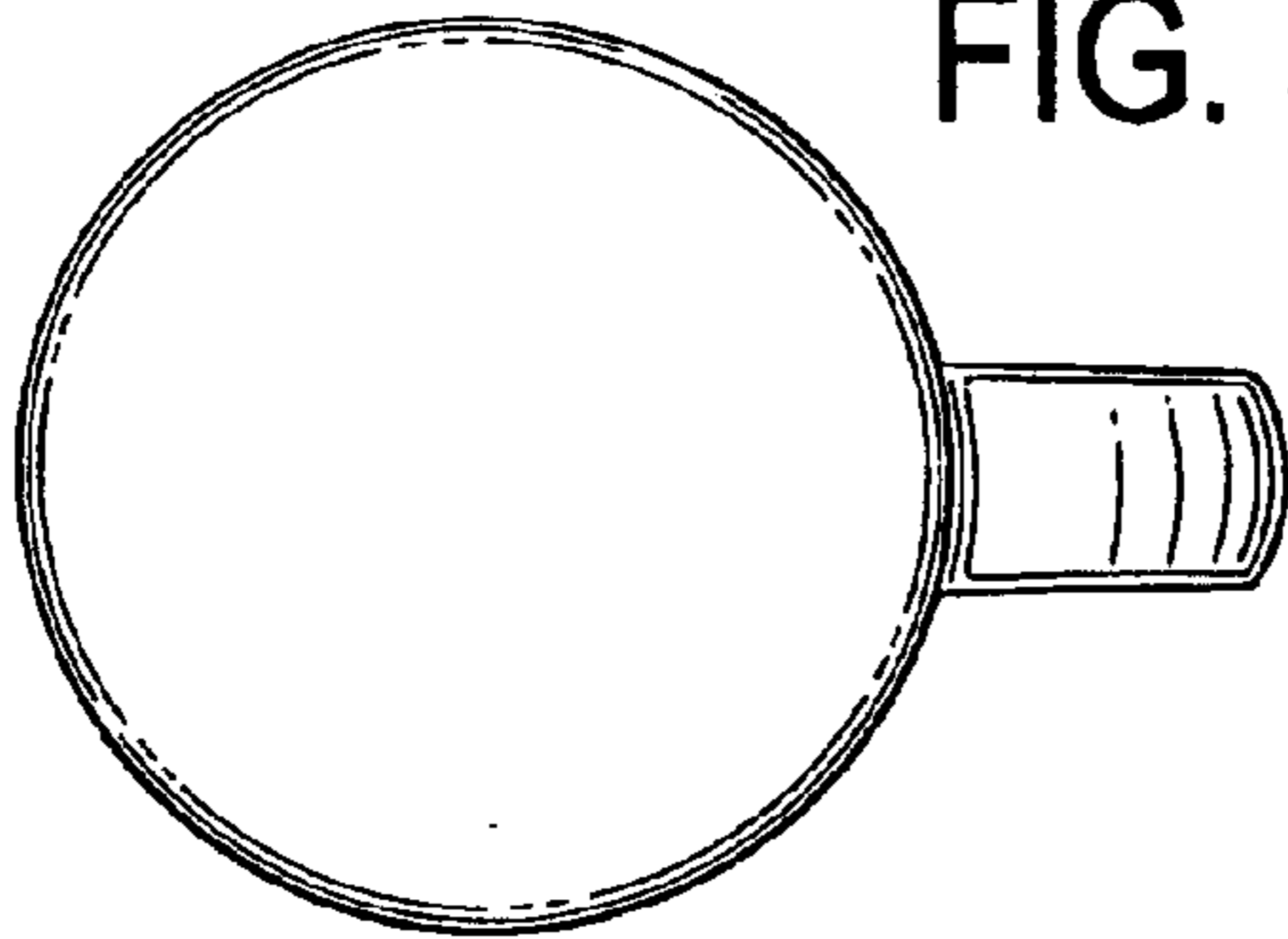
