(57) **CLAIM**

The ornamental design for a beverage ball carrier, as shown and described.

**DESCRIPTION**

FIG. 1 is a side perspective view of a beverage ball carrier showing the design.

FIG. 2 is another side perspective view of the embodiment of the invention shown in FIG. 1.

FIG. 3 is a perspective view of the embodiment shown in FIGS. 1 and 2.

FIG. 4 is a top view of the embodiment shown in FIGS. 1, 2, and 3.

FIG. 5 is a bottom view.

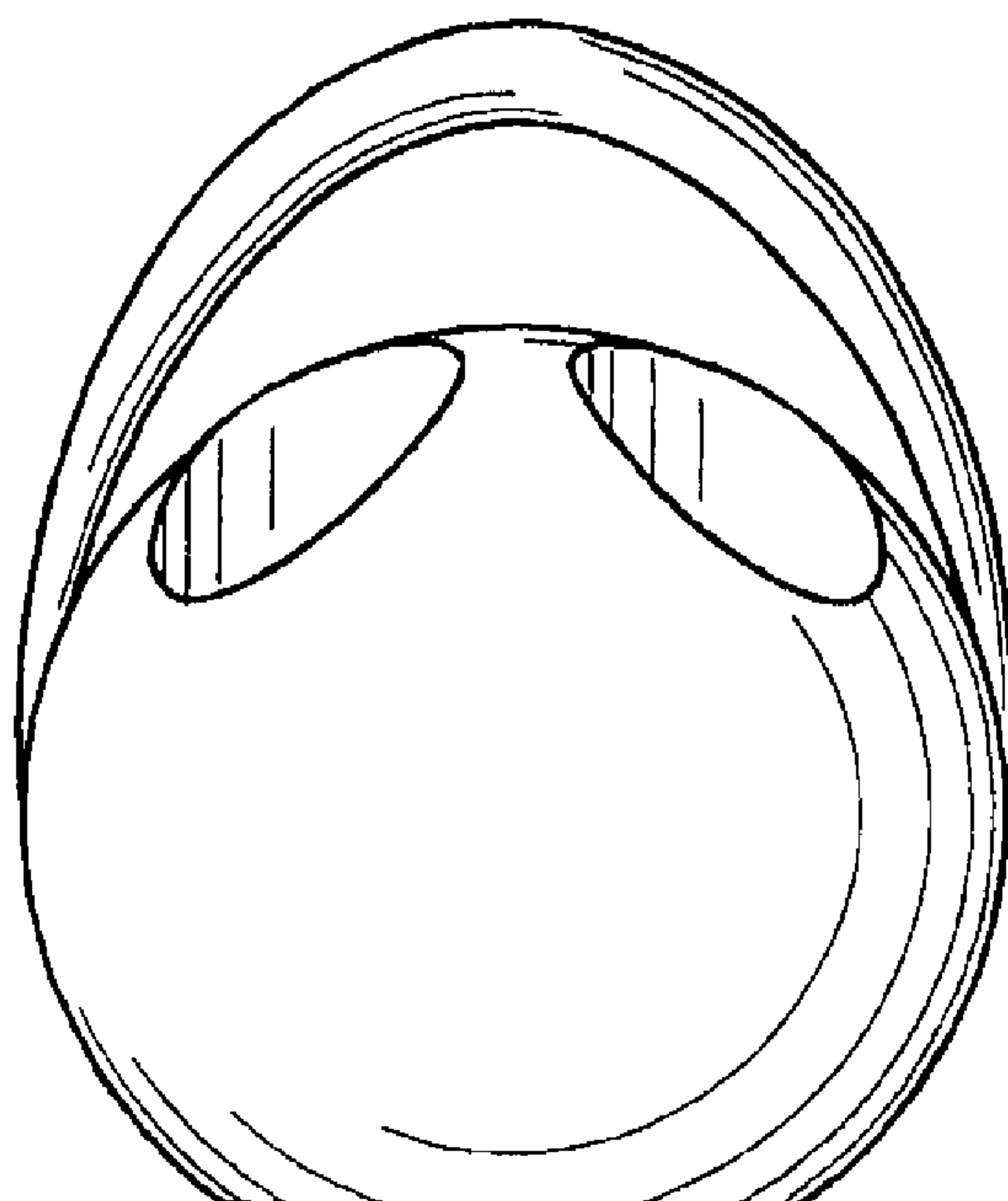
FIG. 6 is a side perspective view of a beverage ball carrier showing a second embodiment of the design, the sole difference being the addition of two additional beverage container holes.

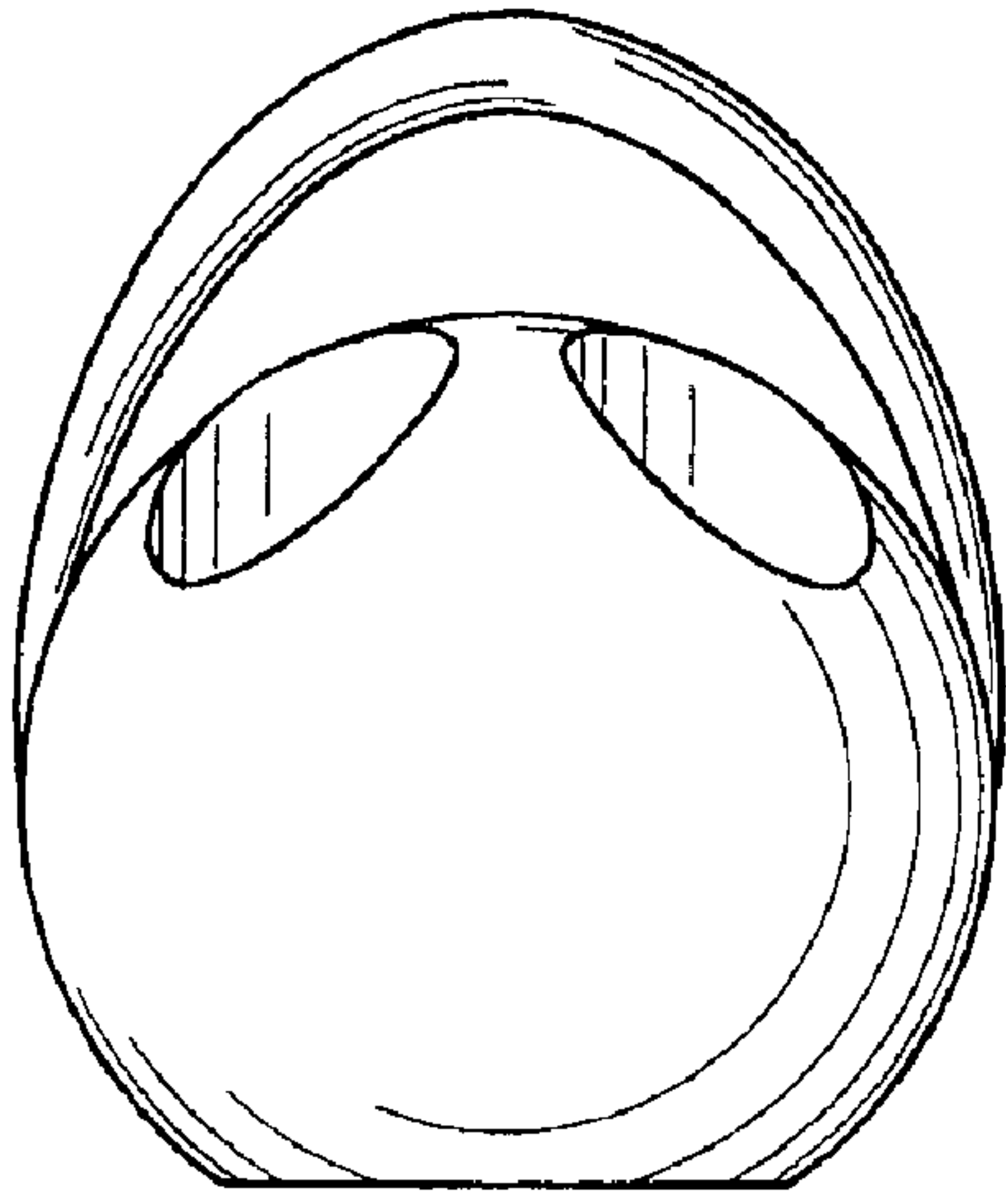
FIG. 7 is another side perspective view of the embodiment of the invention shown in FIG. 6.

FIG. 8 is a perspective view of the embodiment shown in FIGS. 6 and 7; and,

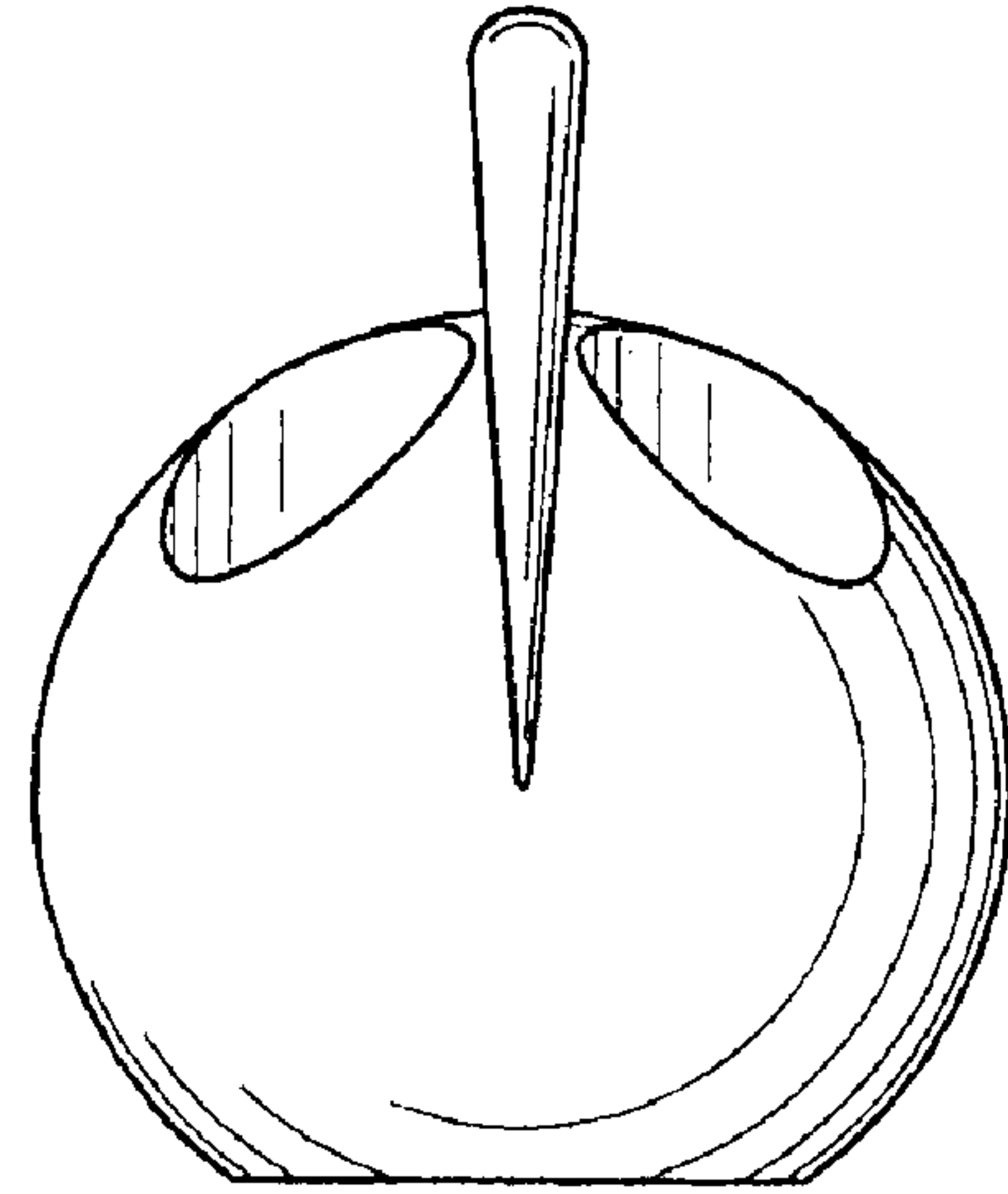
FIG. 9 is a top view of the embodiment shown in FIGS. 6, 7, and 8.

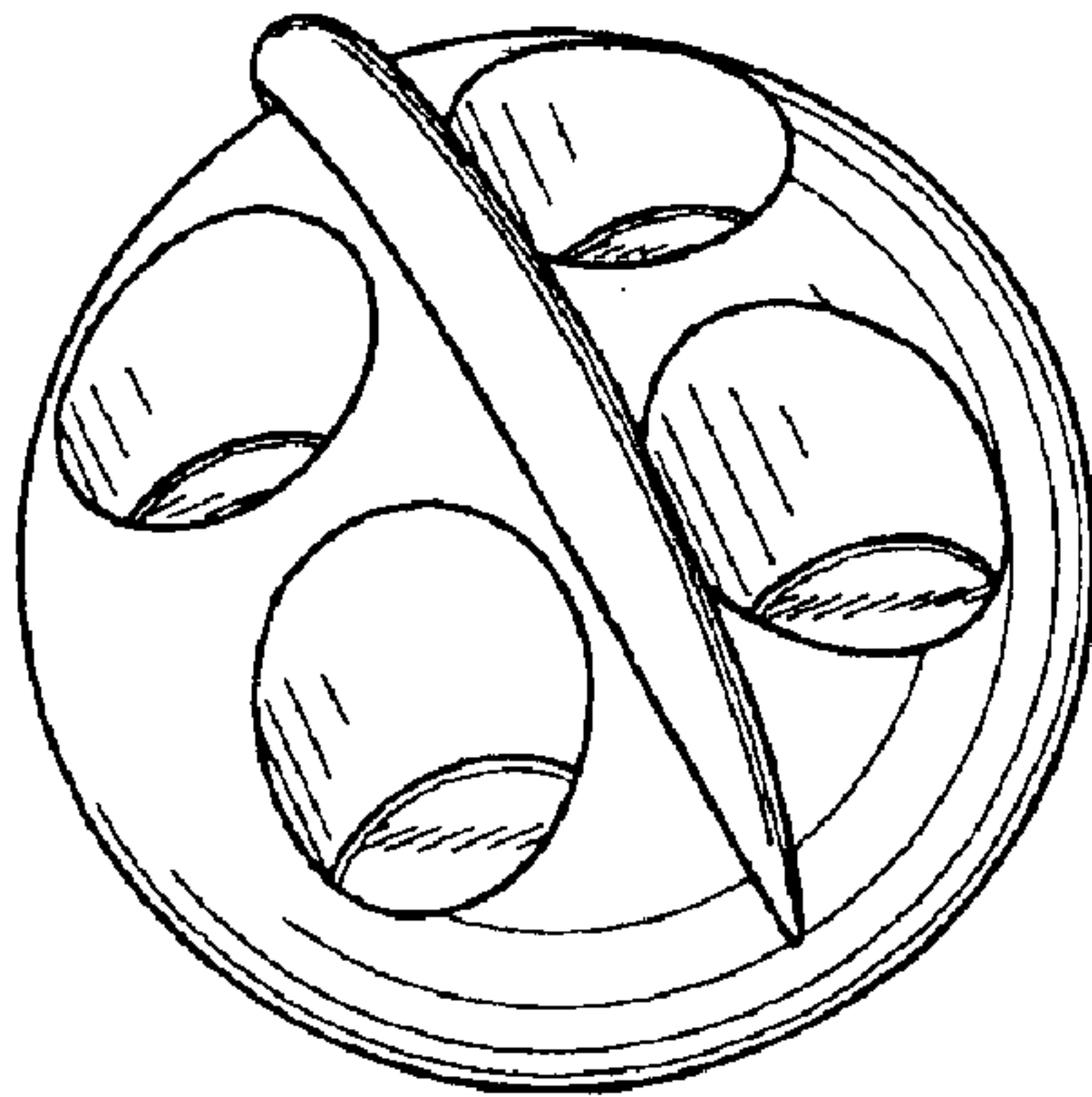




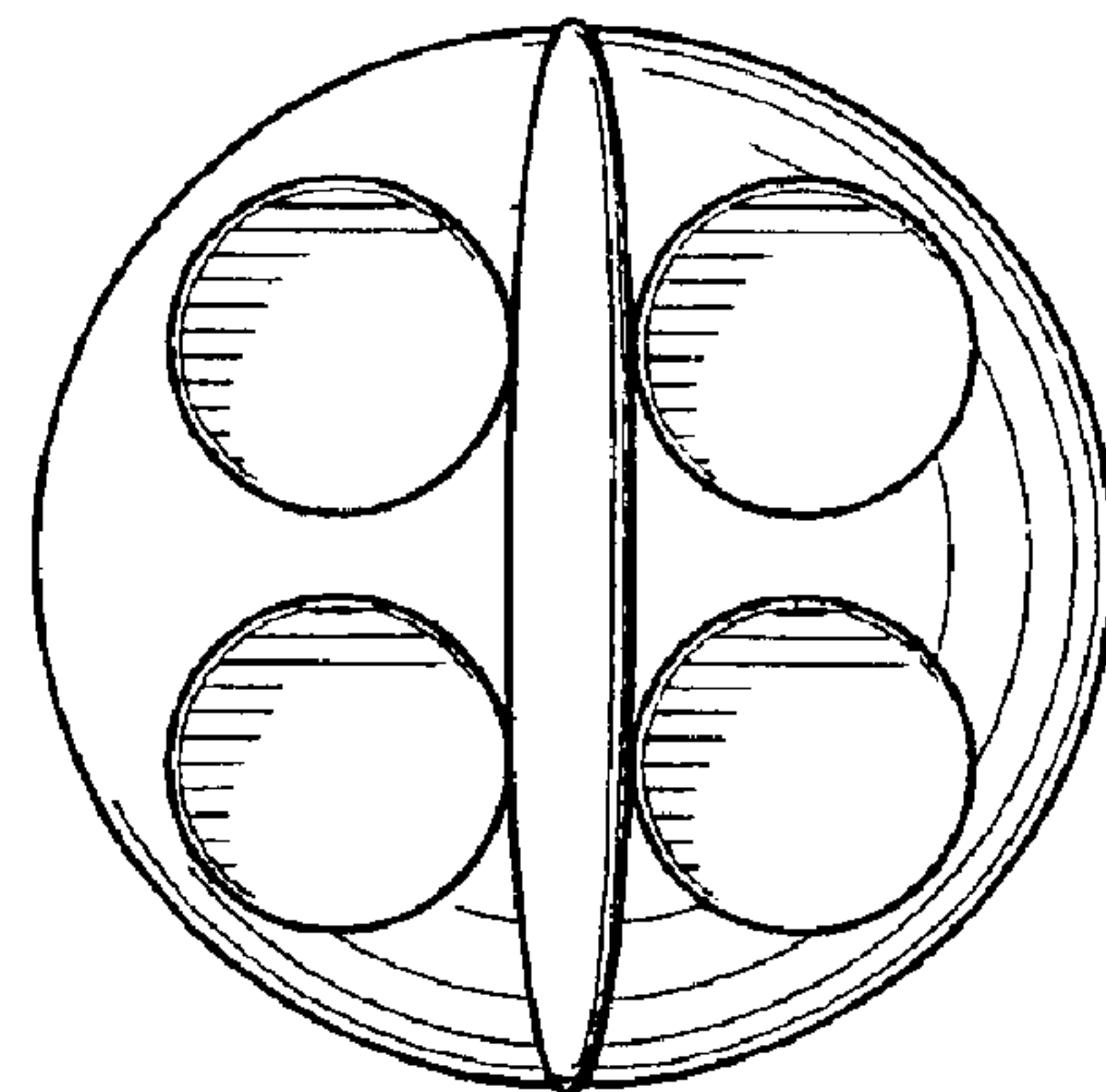

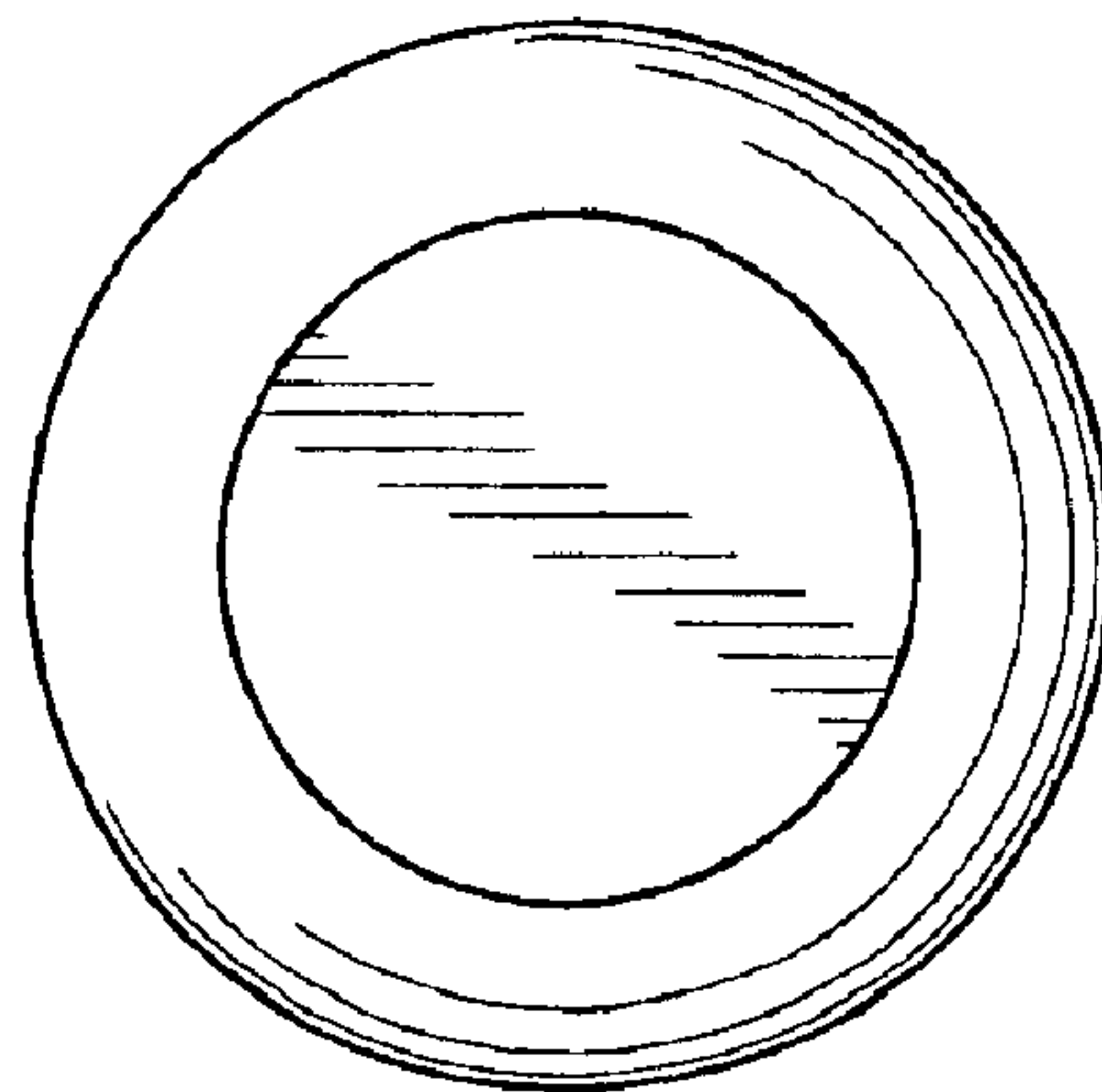

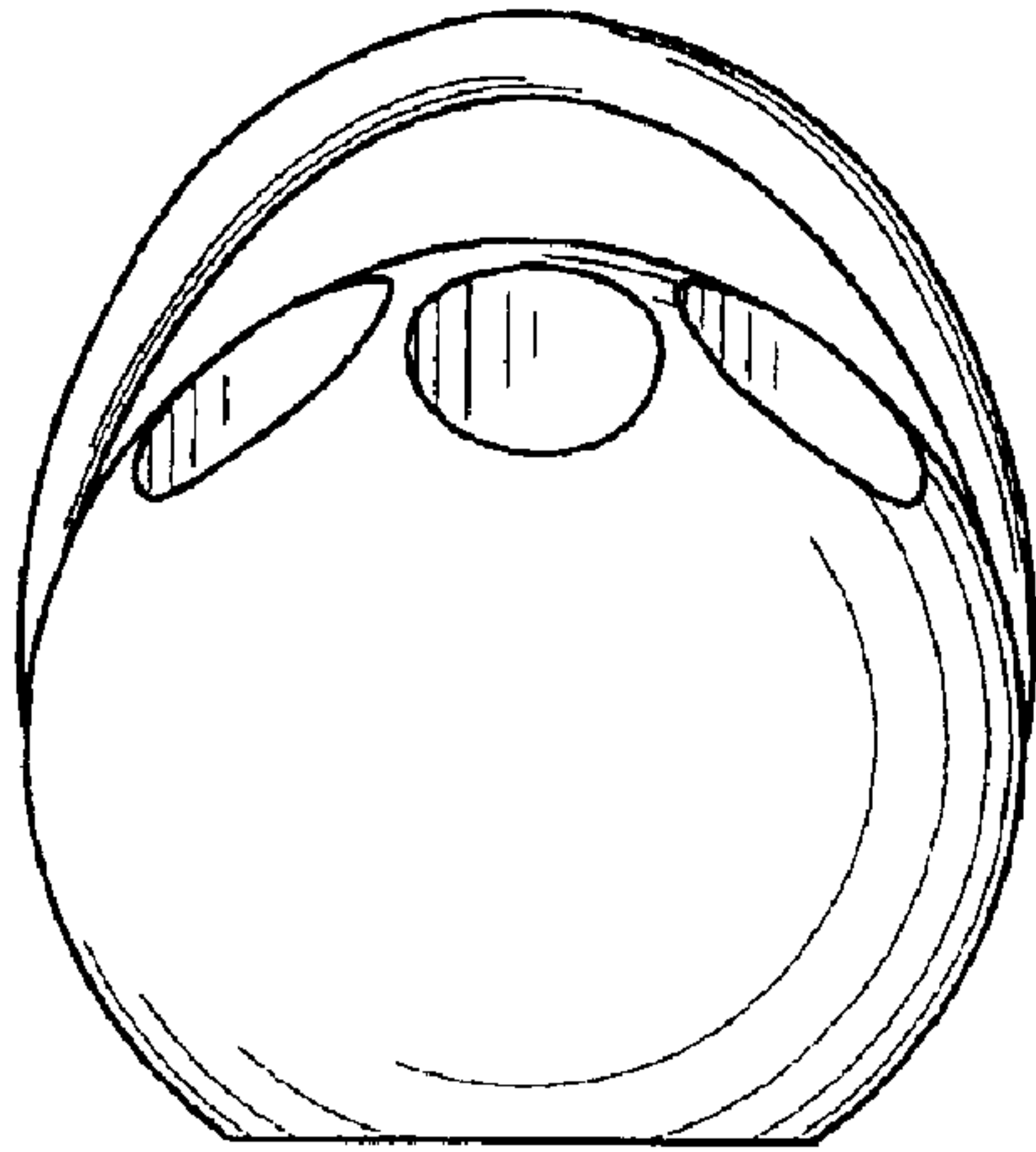

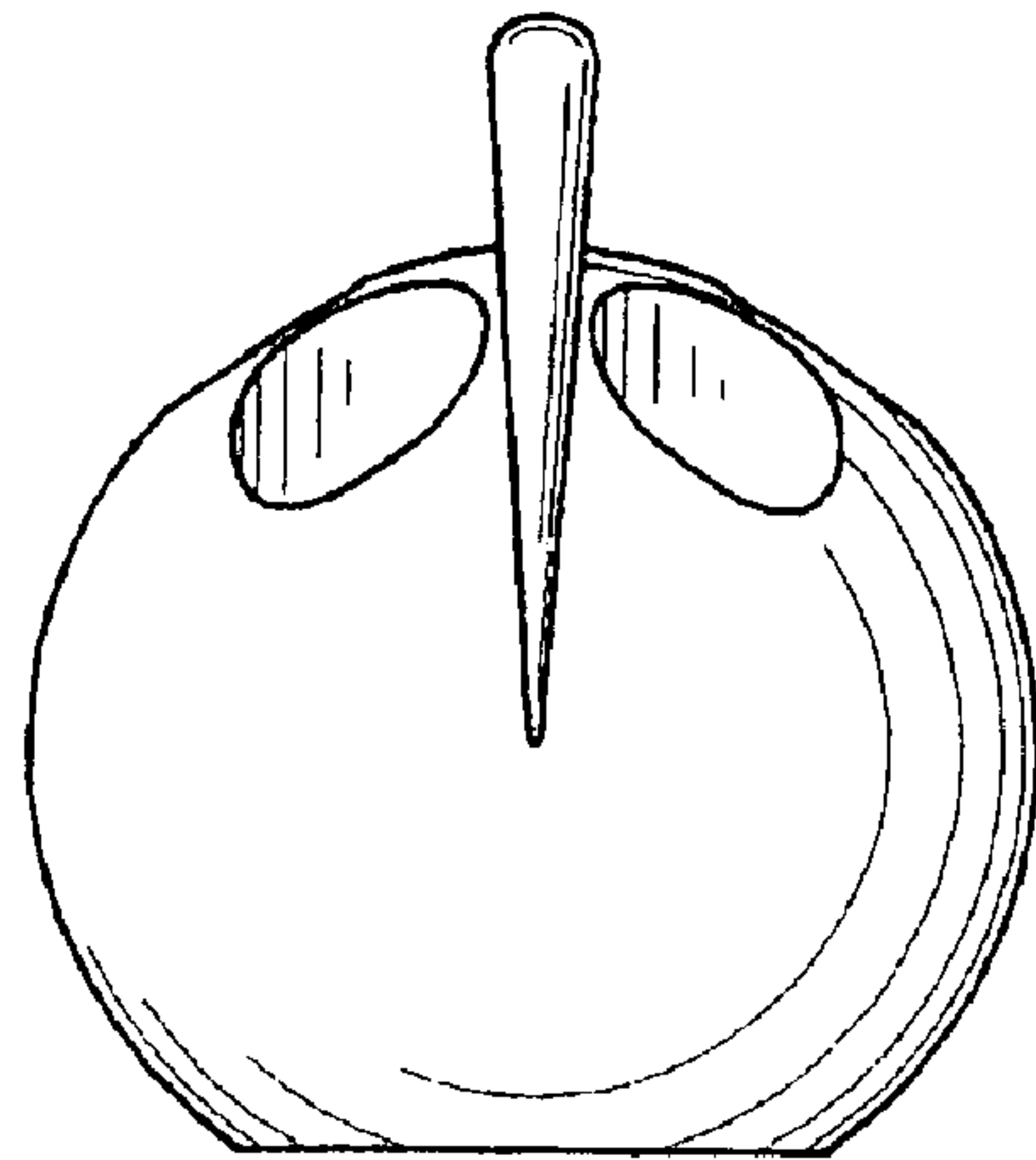

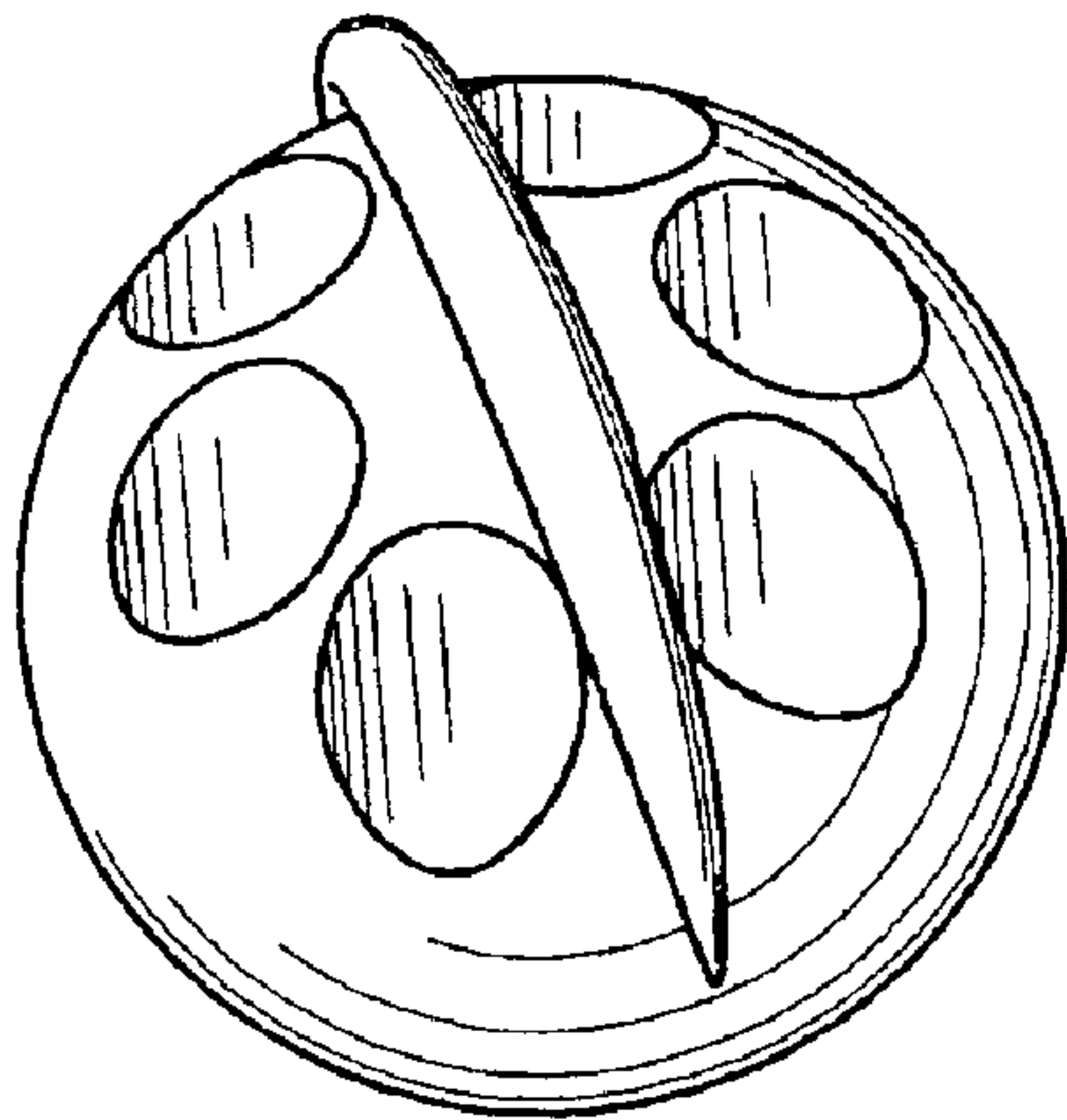

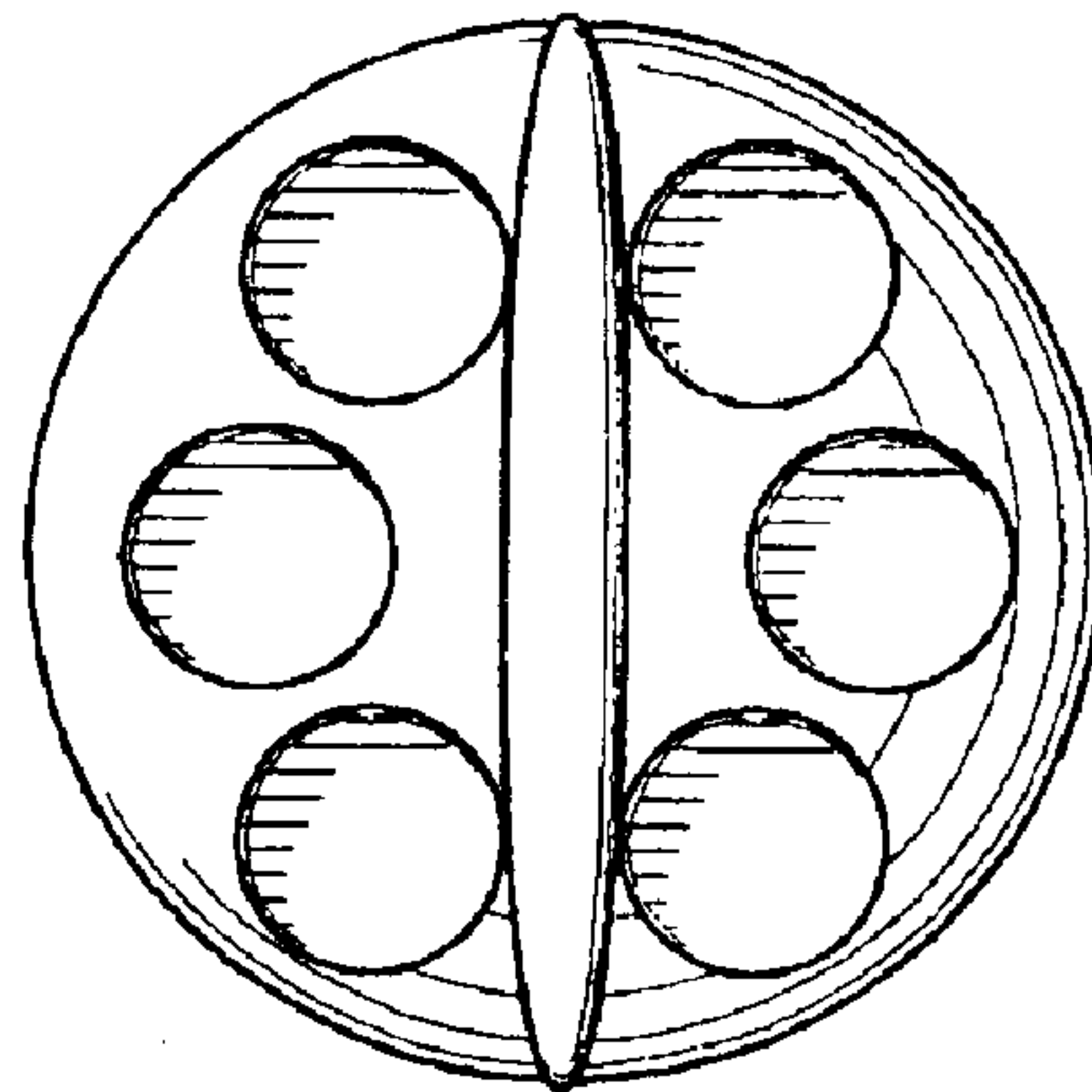
