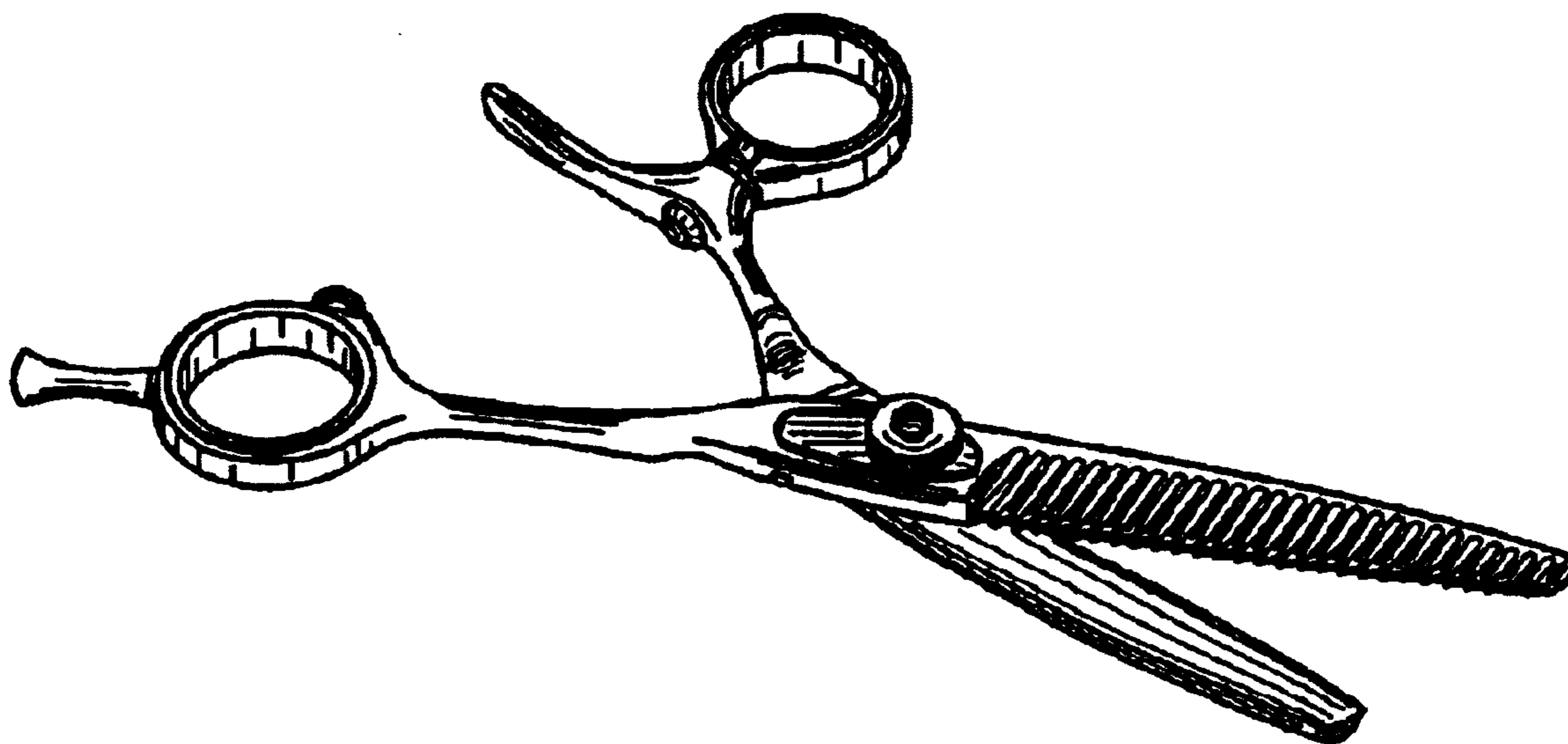
FIG. 1 is a perspective view of the design according to the present invention;

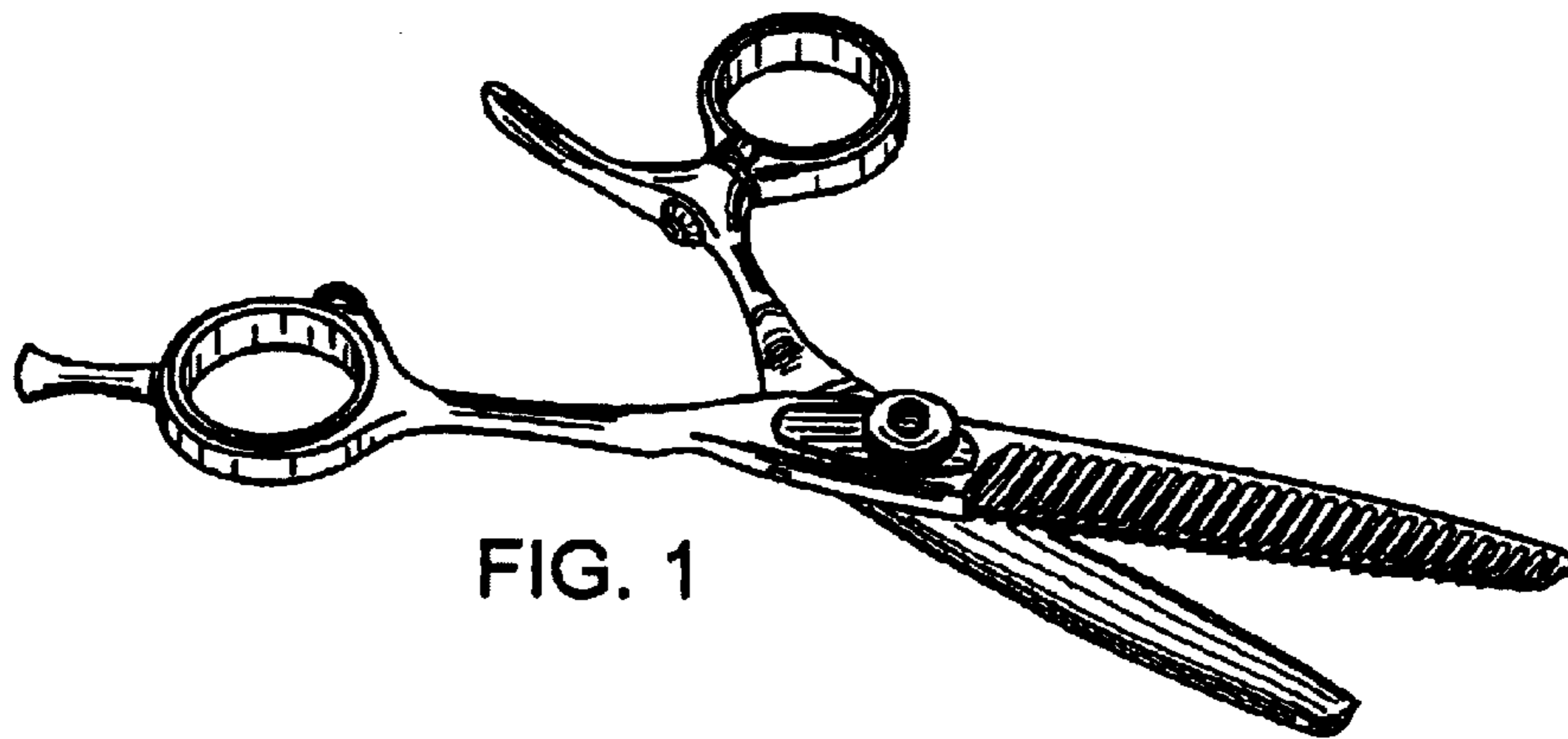

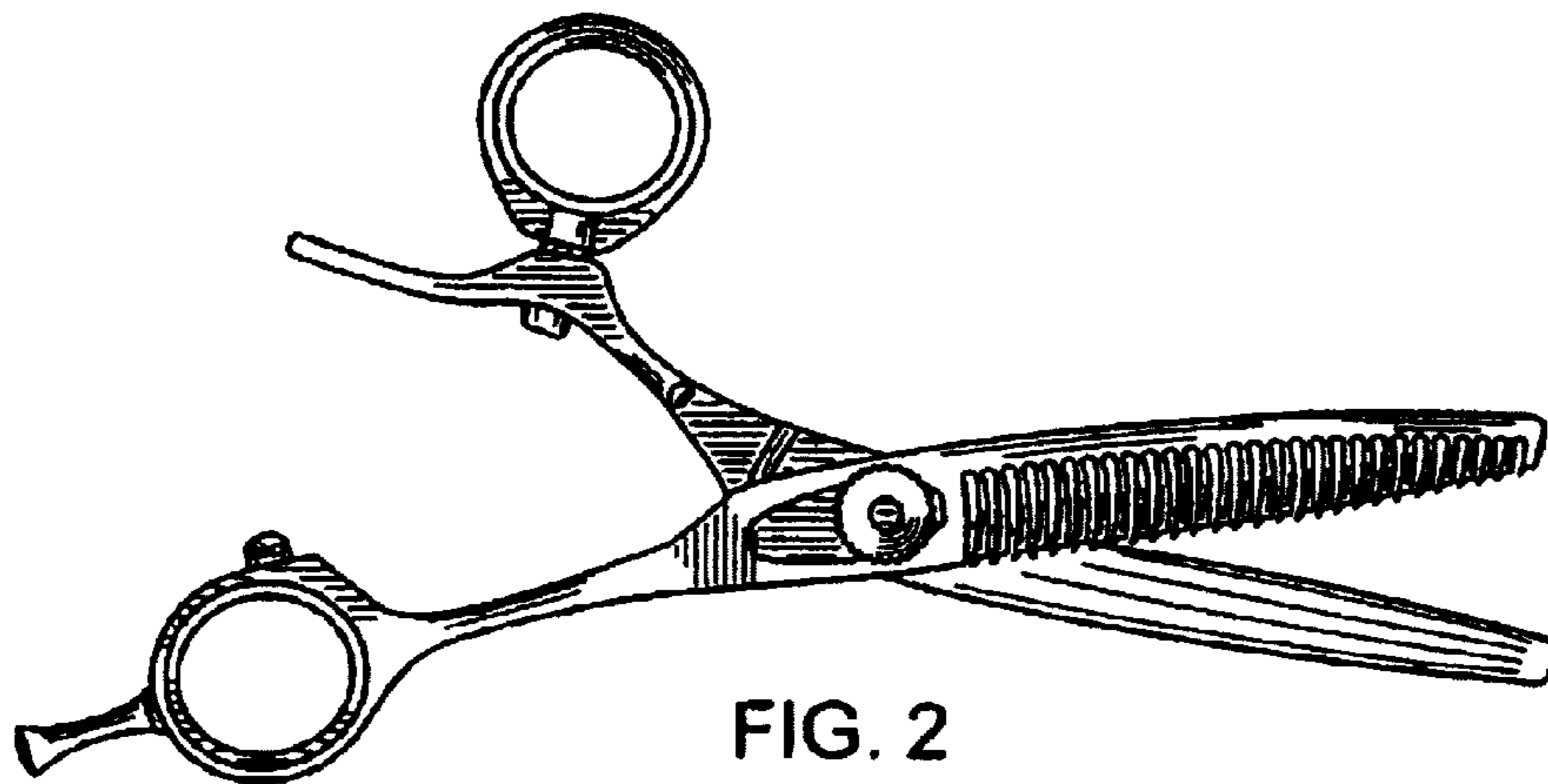

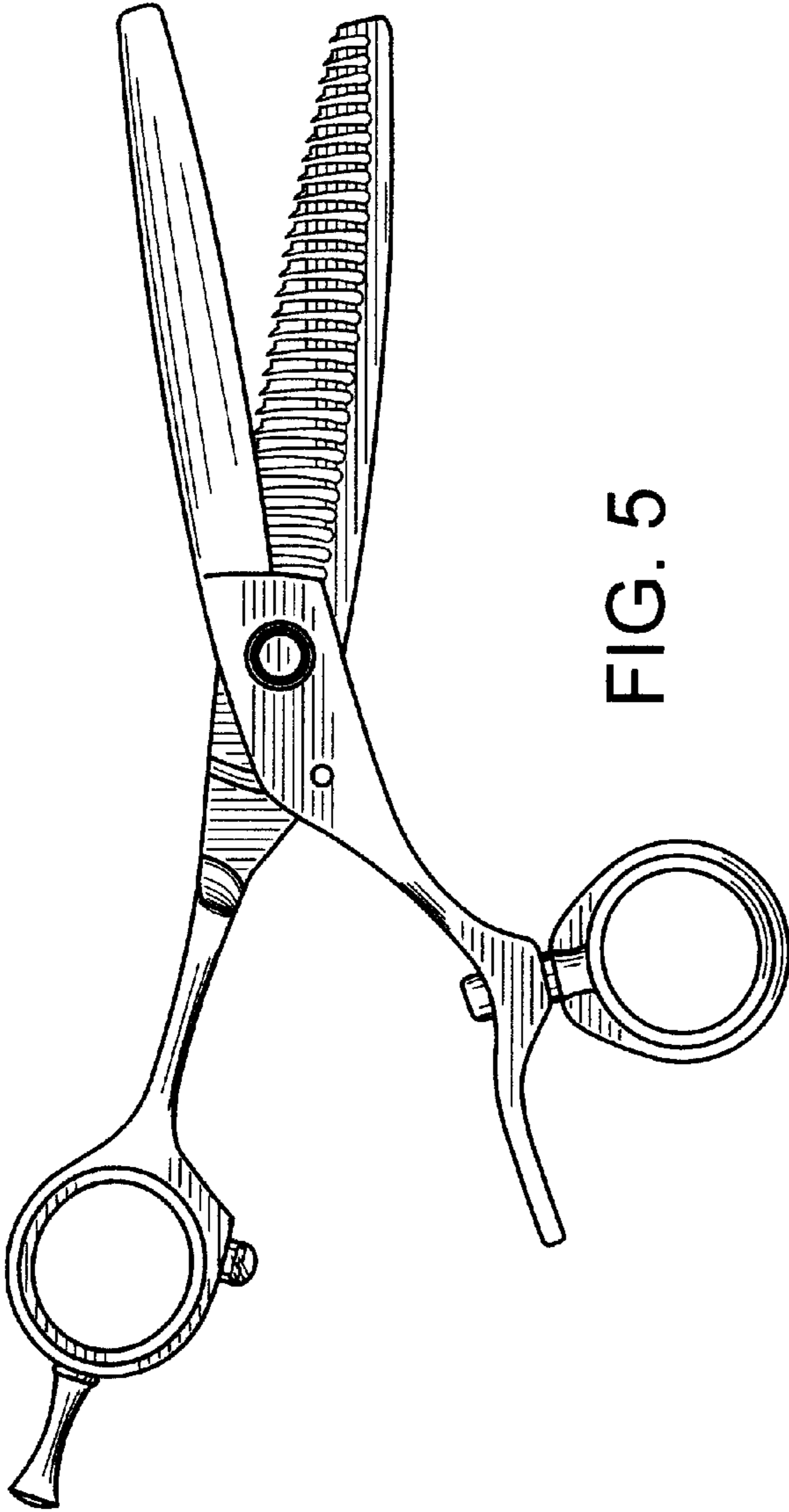

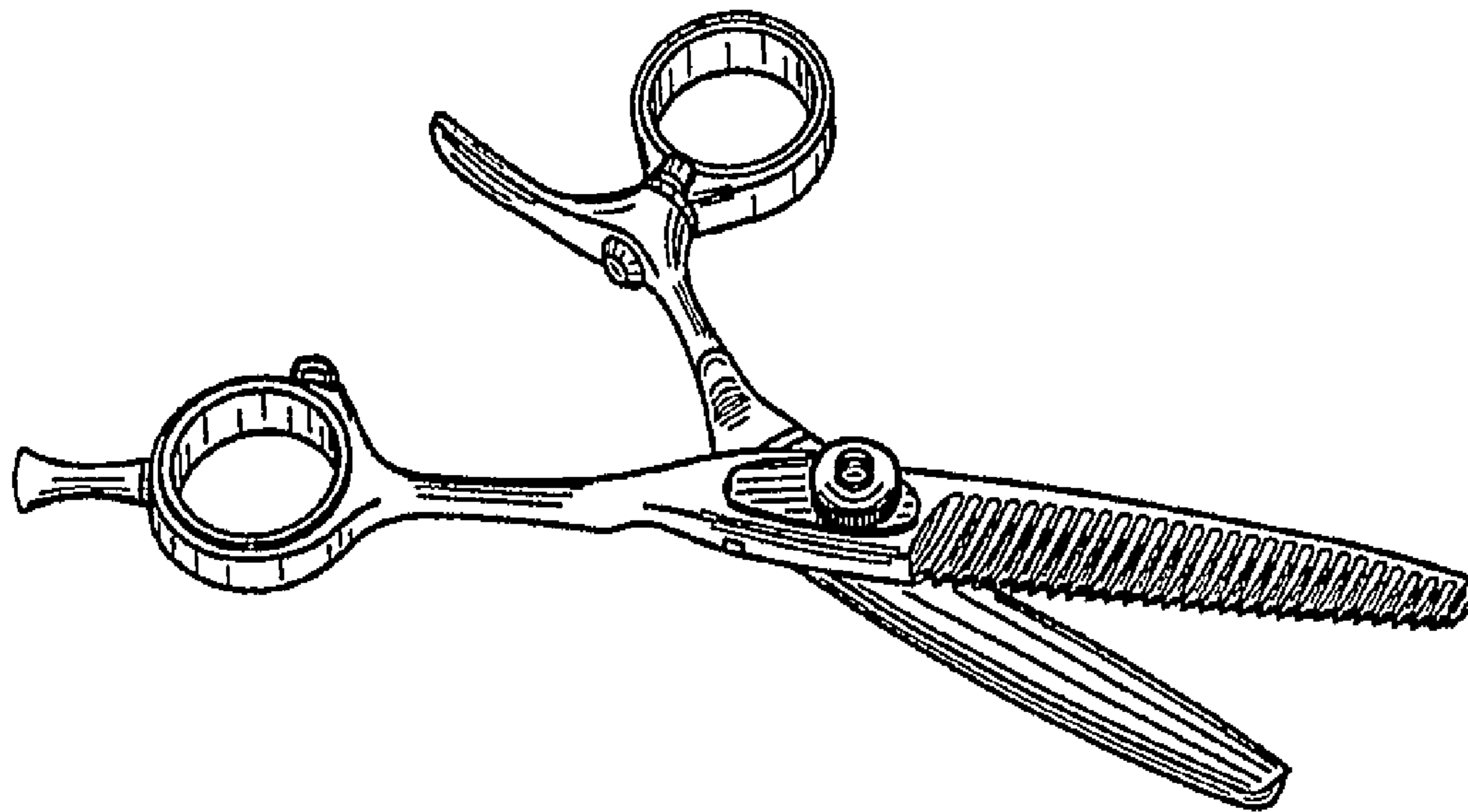

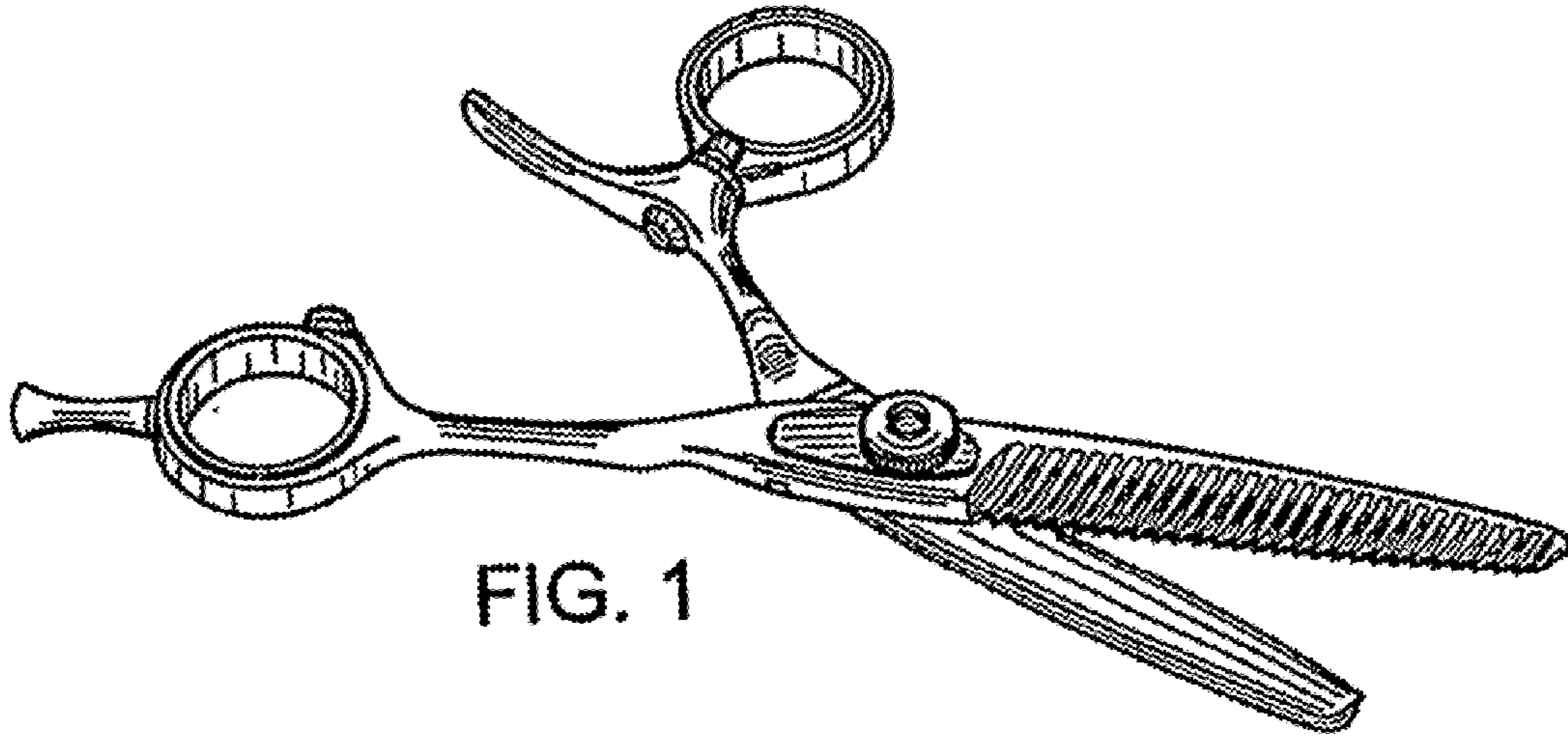

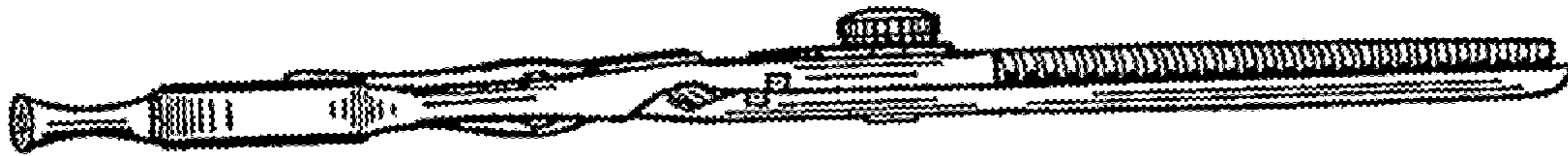

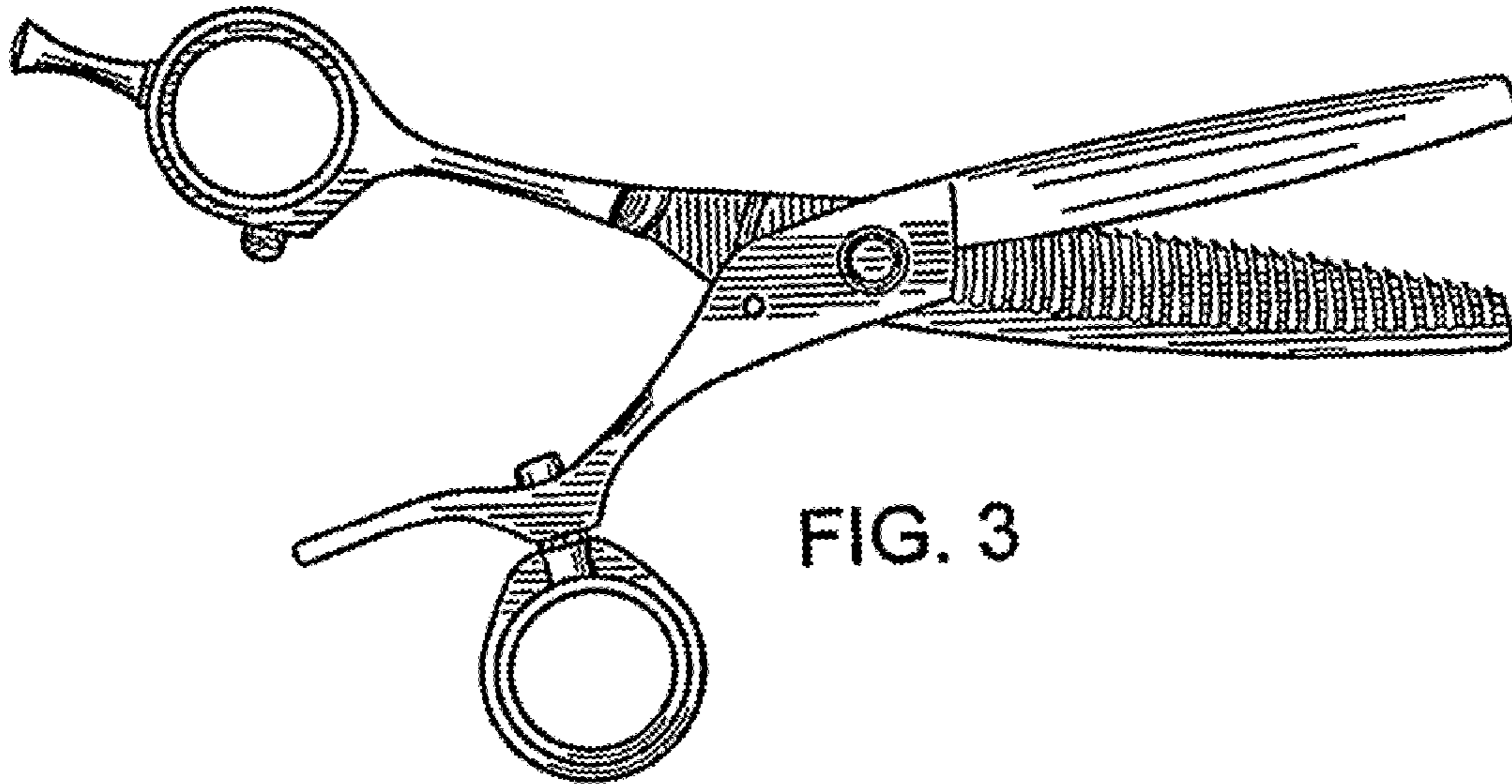

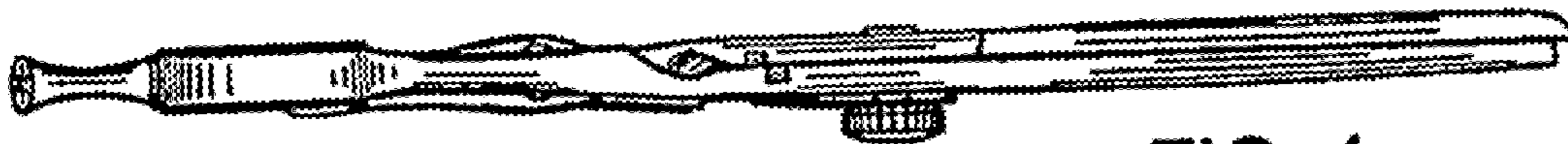

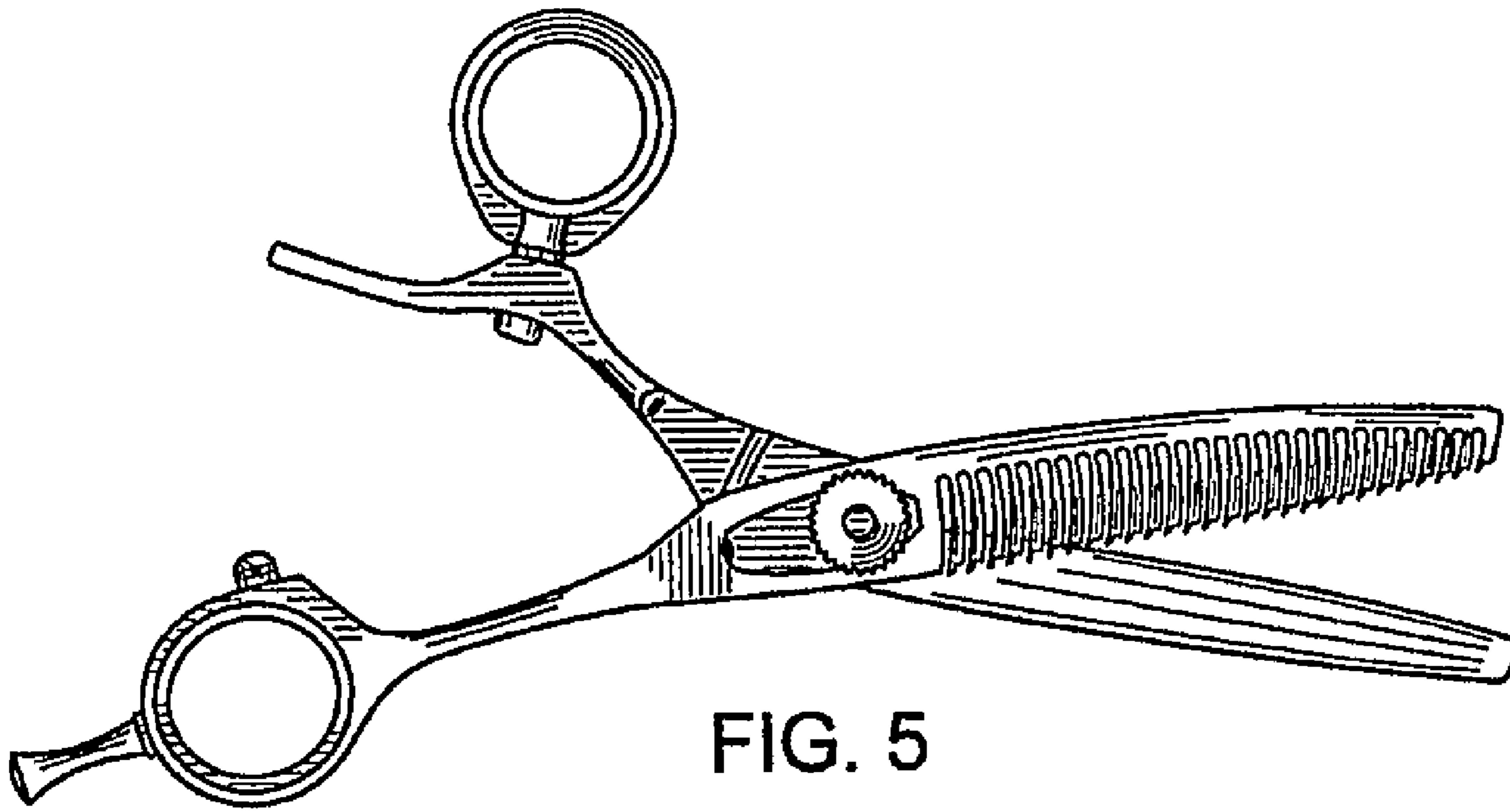
