(57) **CLAIM**

The ornamental design for a blade protector with snake skin image for chain saw, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of my new design of a blade protector with snake skin image for chain saw viewed from a first direction;

FIG. 2 is a side elevational view of a first side of the blade protector with snake skin image for chain saw;

FIG. 3 is a perspective view of a blade protector with snake skin image for chain saw viewed from a second direction; and,

FIG. 4 is a side elevational view of a second side of the blade protector with snake skin image for chain saw.

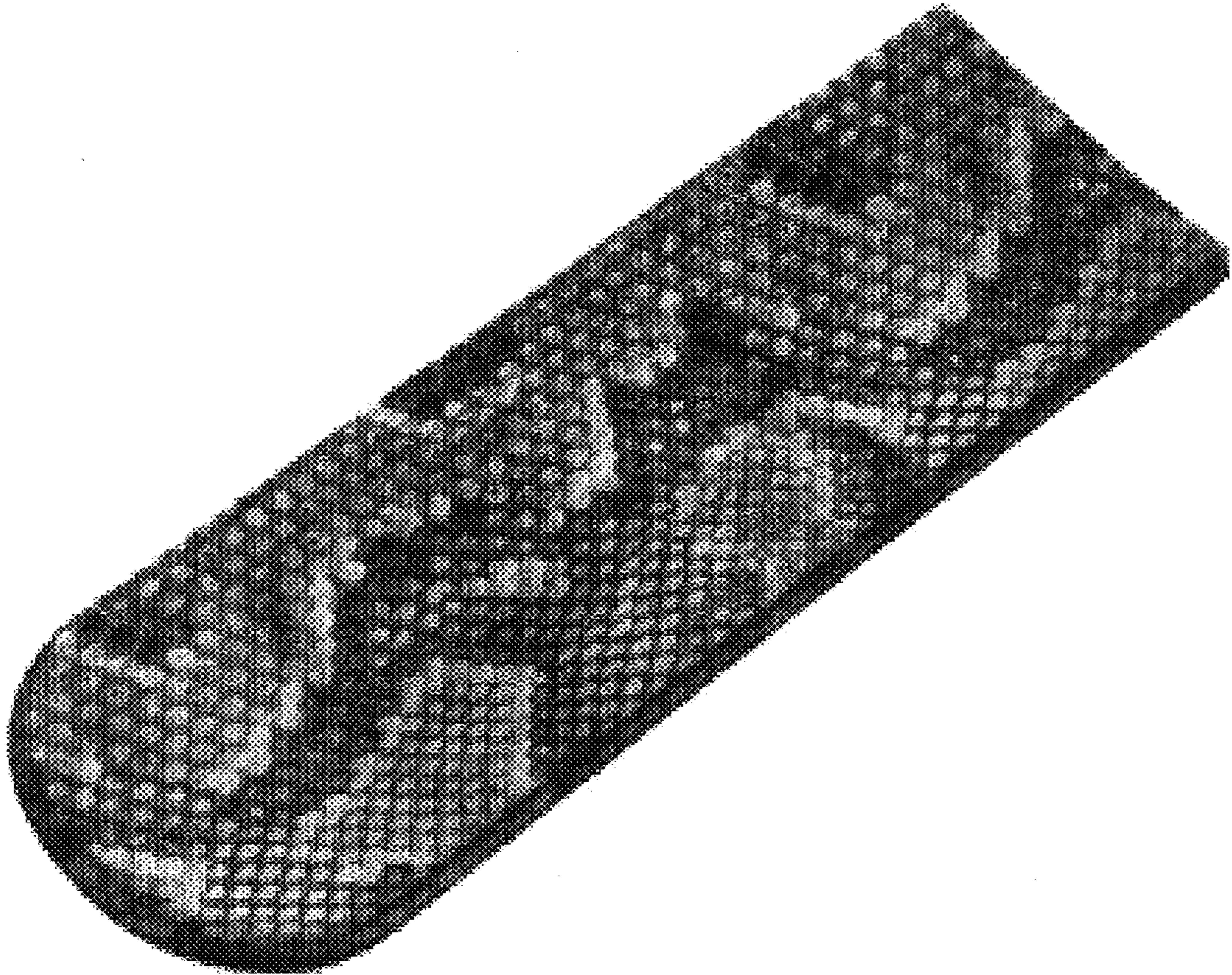

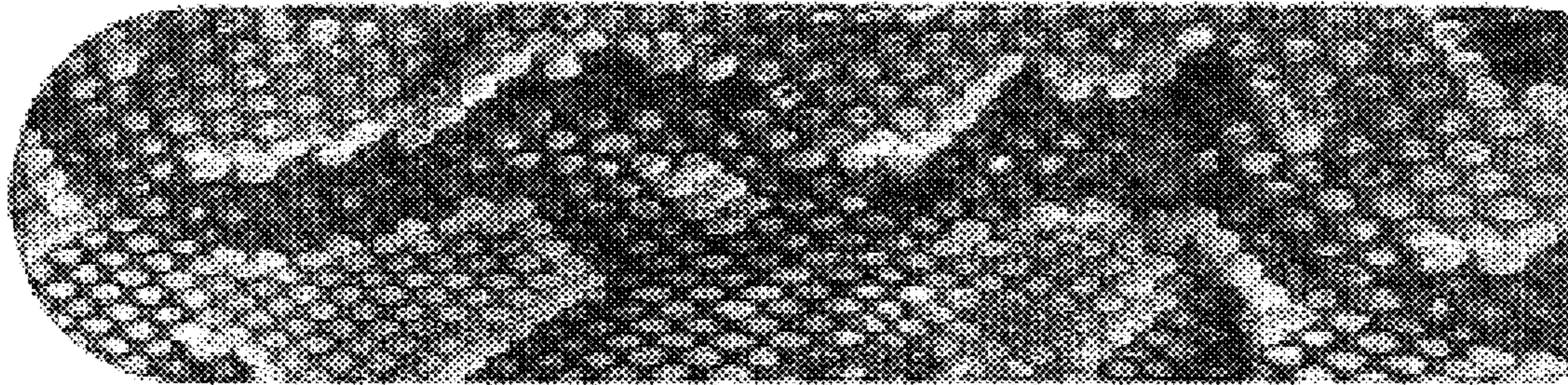

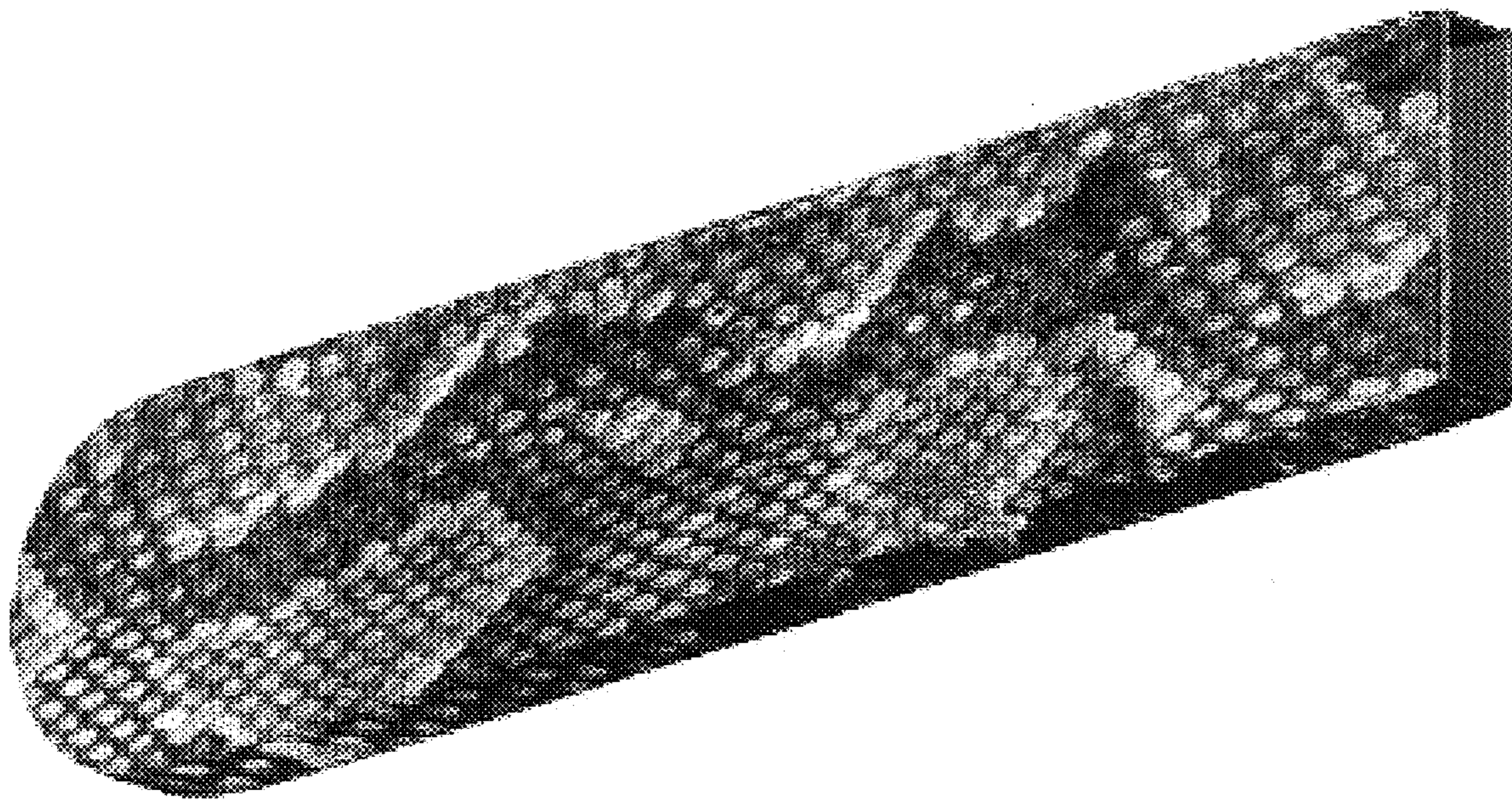

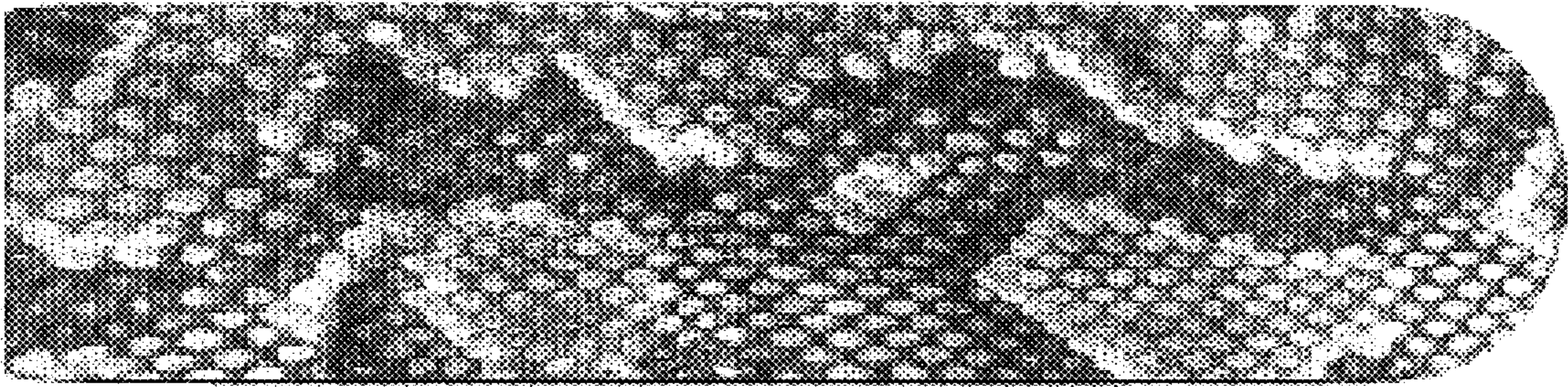
