(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a bottle according to our new design; and,
FIG. 2 is a top plan view thereof.
The bottle is symmetrical about its central vertical axis with the obvious exception of the screw threads located adjacent the top.

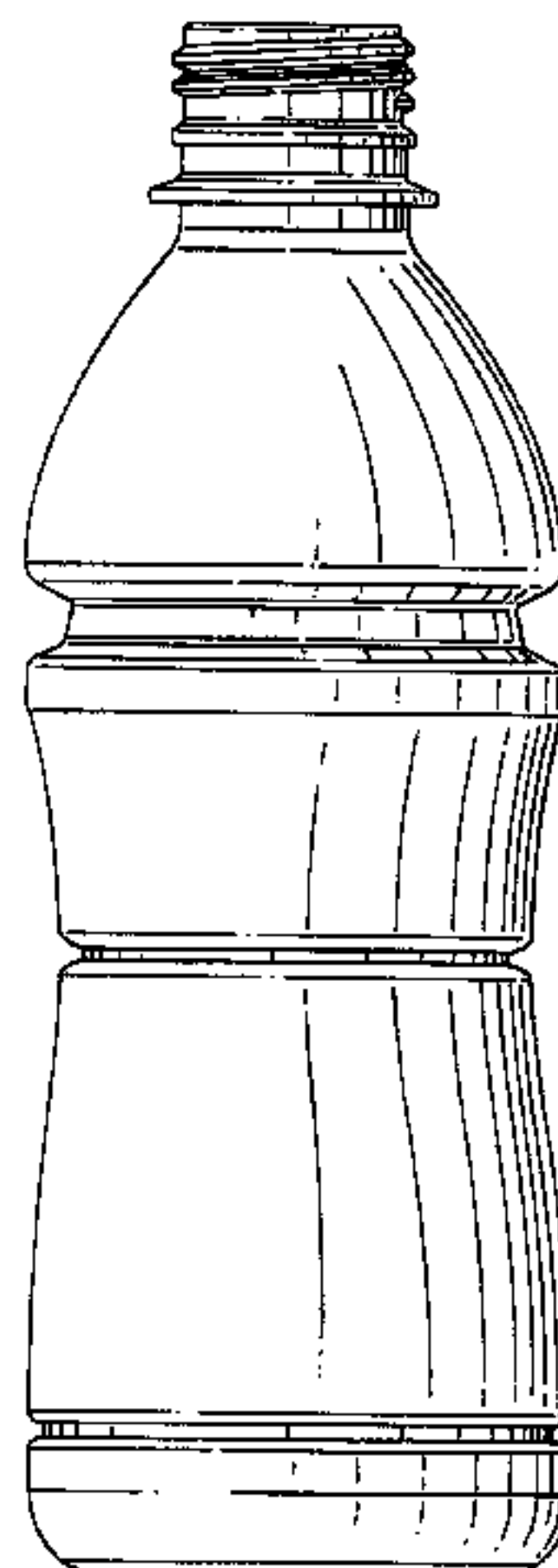

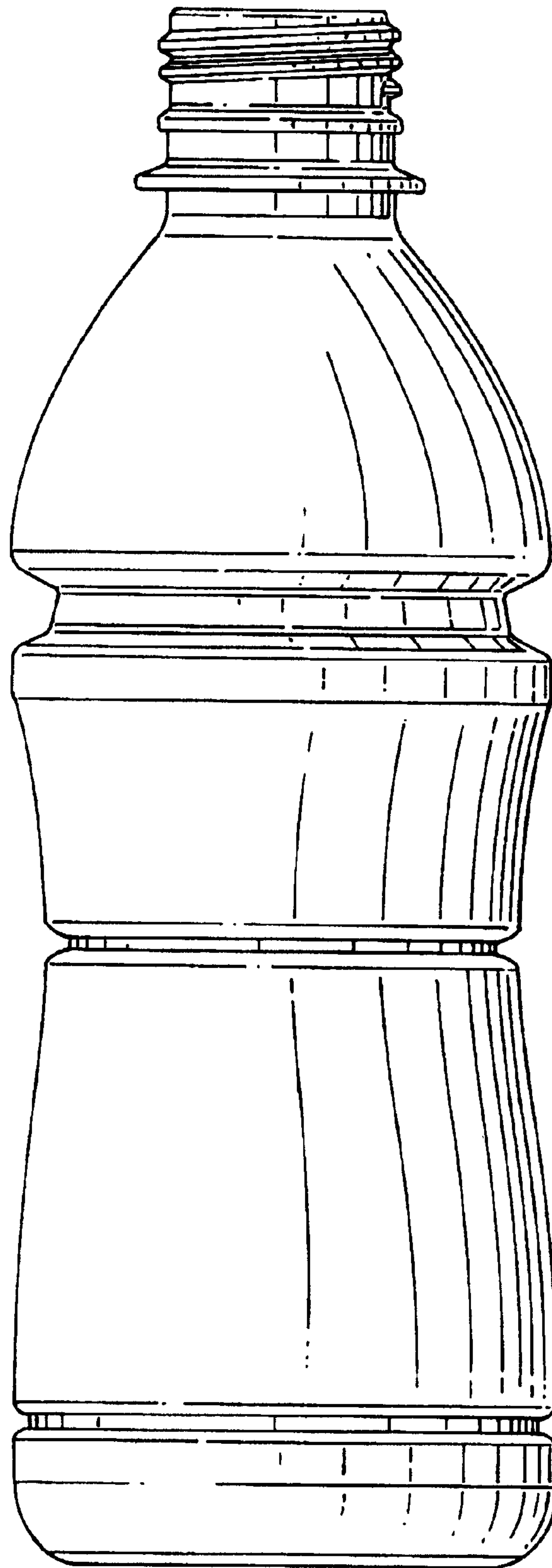
