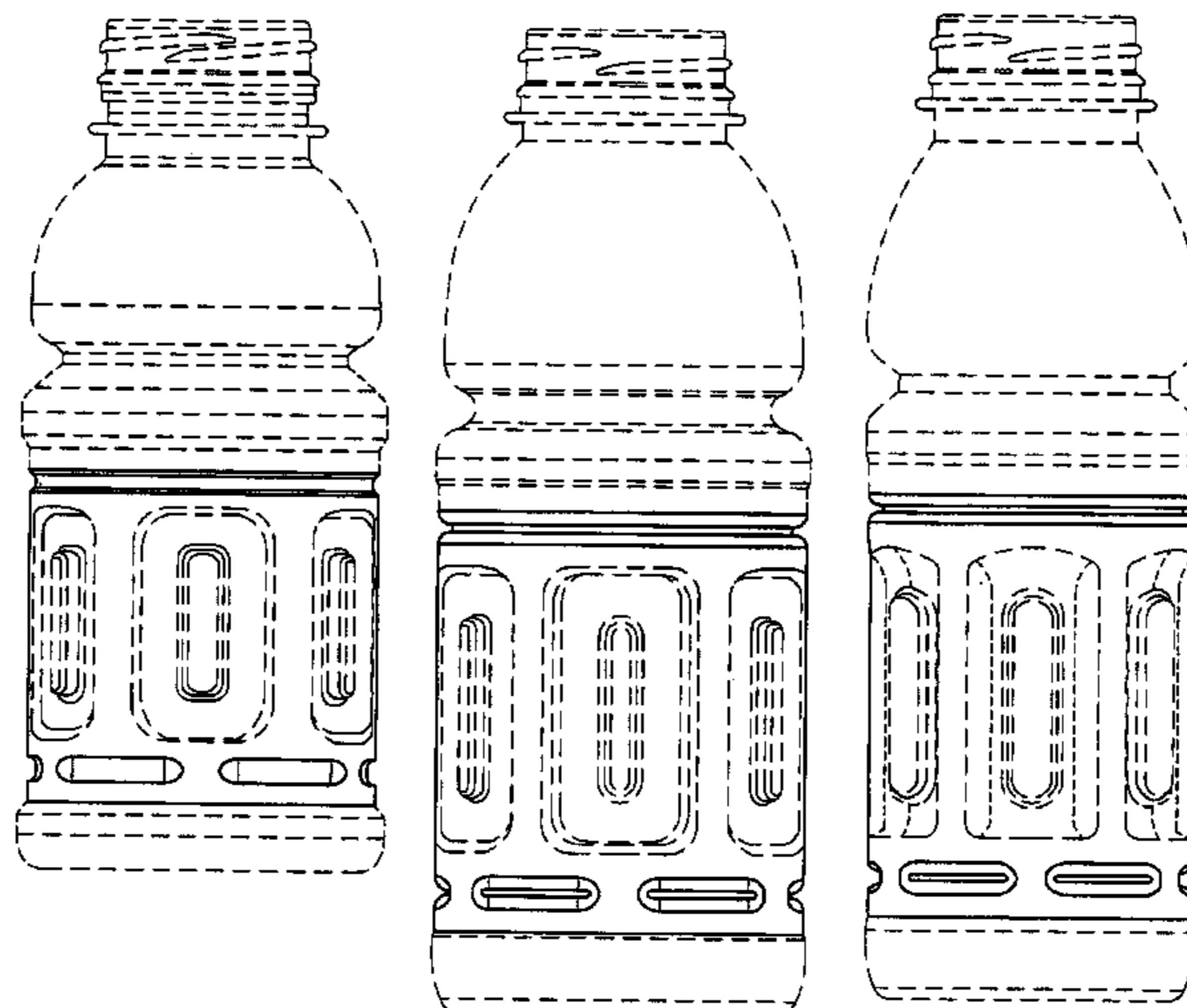
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevational view of a container, showing my new design, the rear elevational view being identical;
FIG. 2 is a perspective view thereof;
FIG. 3 is a front elevational view of a second embodiment showing my new design, the rear elevational view being identical;
FIG. 4 is a perspective view thereof;
FIG. 5 is a front elevational view of a third embodiment showing my new design, the rear elevational view being identical; and,
FIG. 6 is a perspective view thereof.

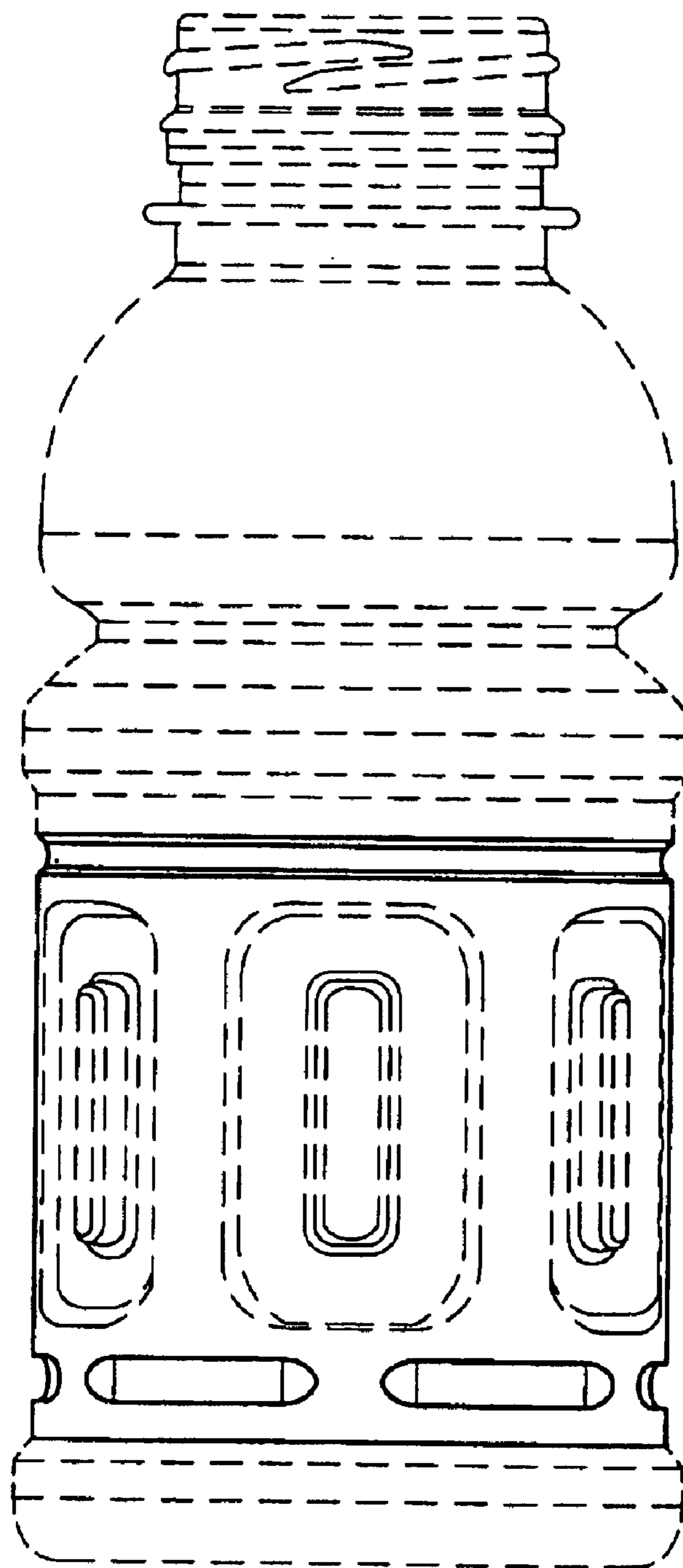

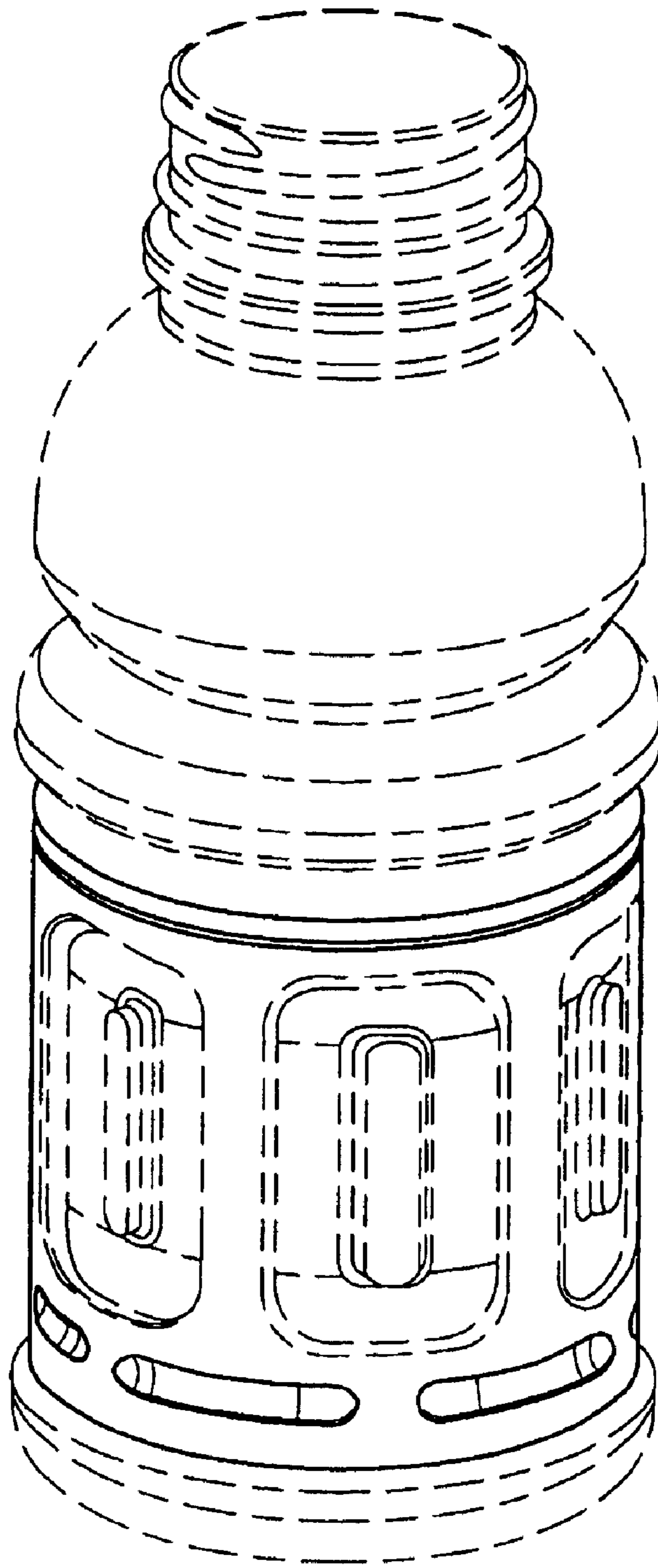

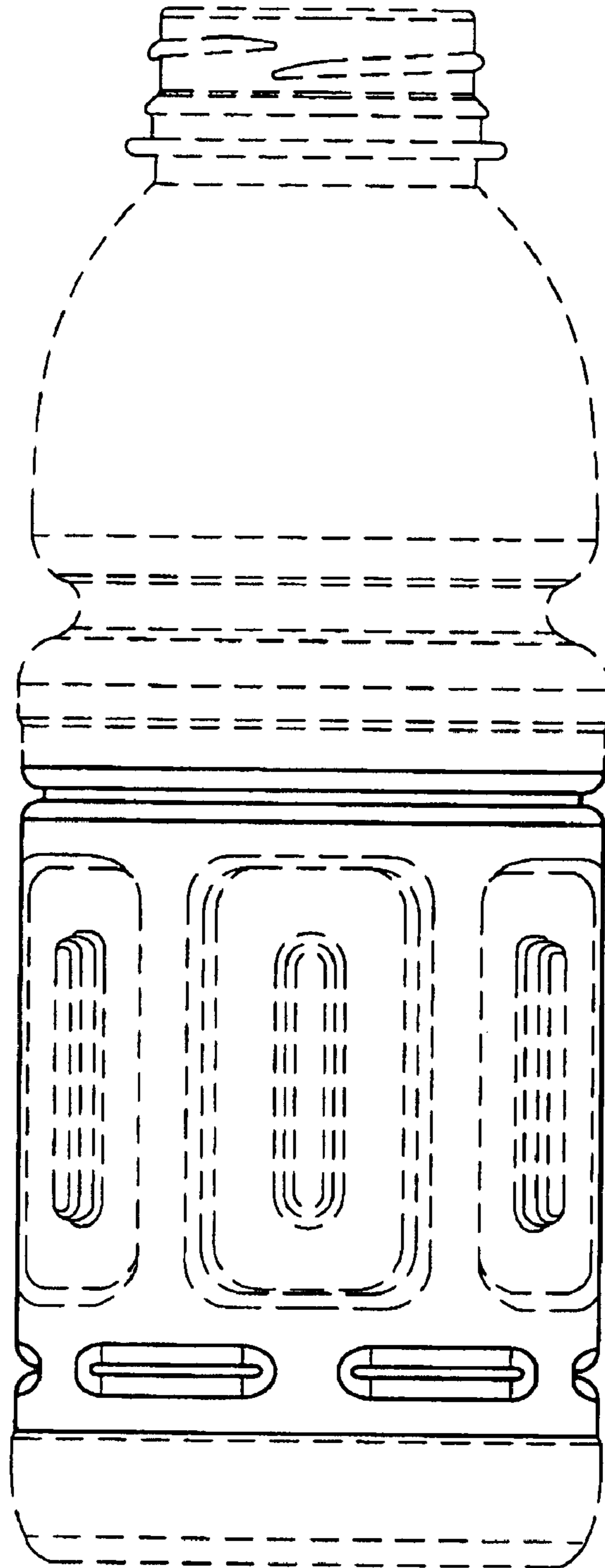

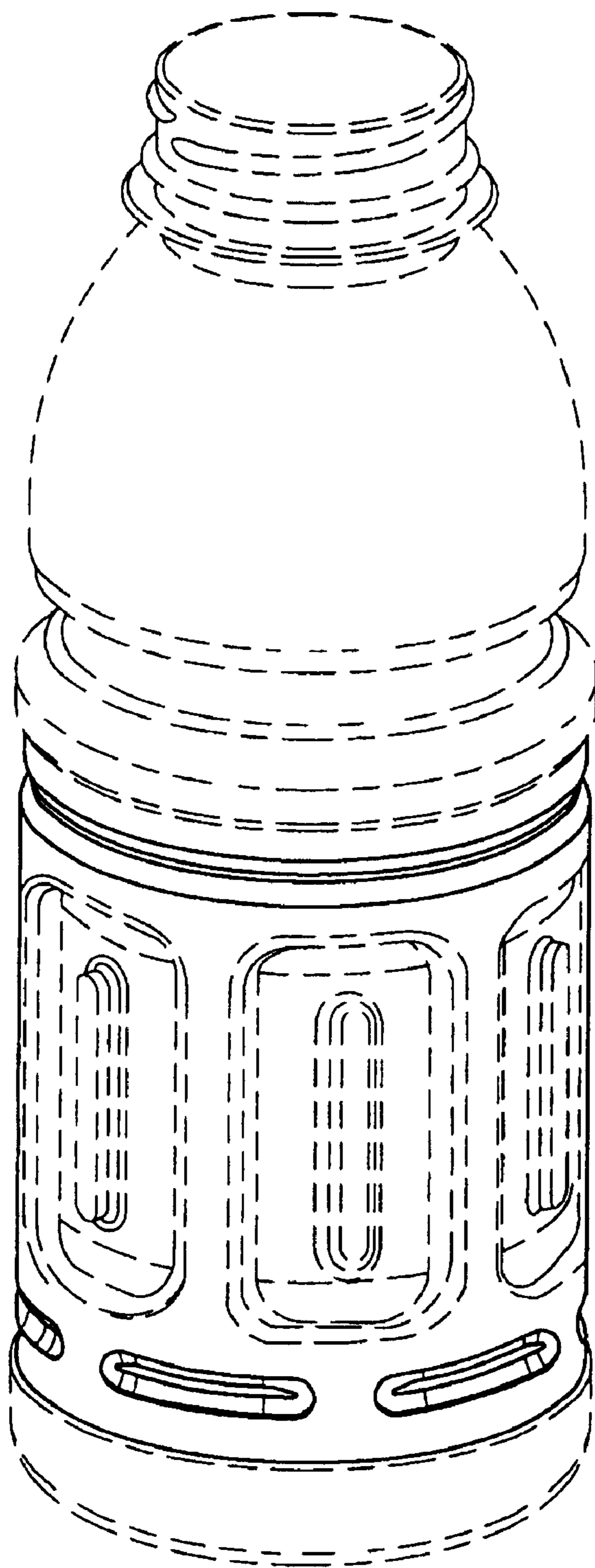

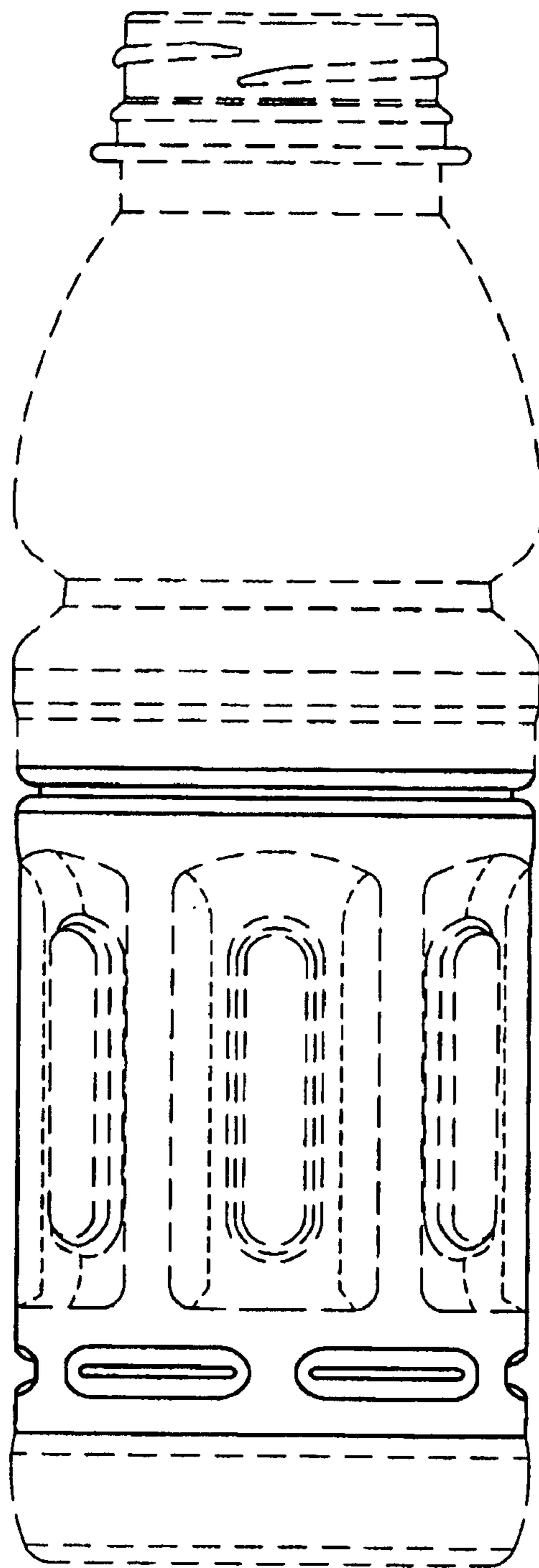

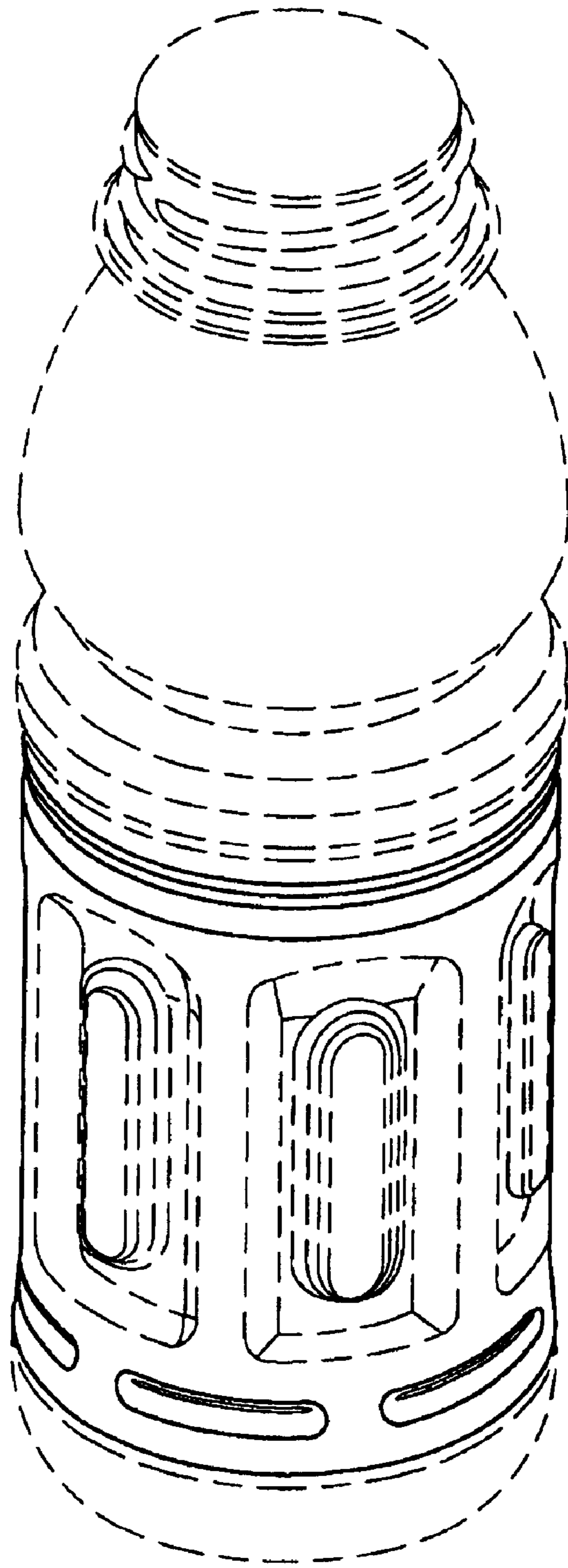
