**DESCRIPTION**

FIG. 1 is a front elevational view of a bottle, showing my design;

FIG. 2 is an enlarged, partial, front elevational view of a lower portion of the bottle;

FIG. 3 is a left side elevational view of the bottle;

FIG. 4 is an enlarged, partial, left side elevational view of the lower portion of the bottle;

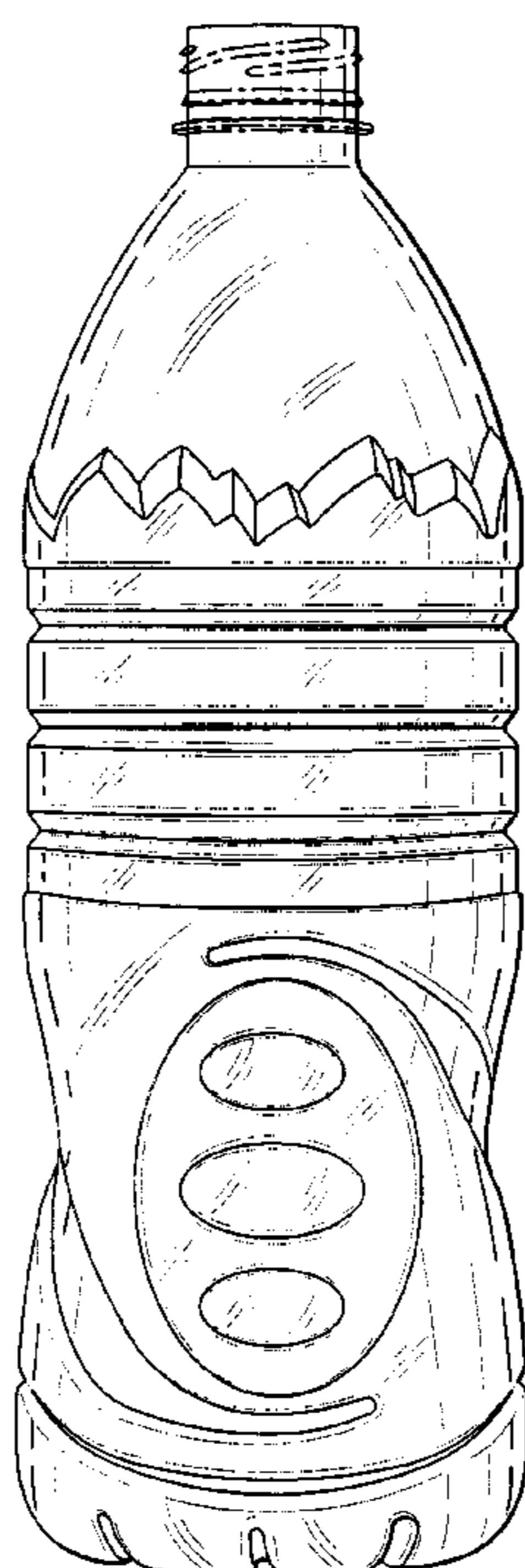
FIG. 5 is a front and left side perspective view of the bottle;

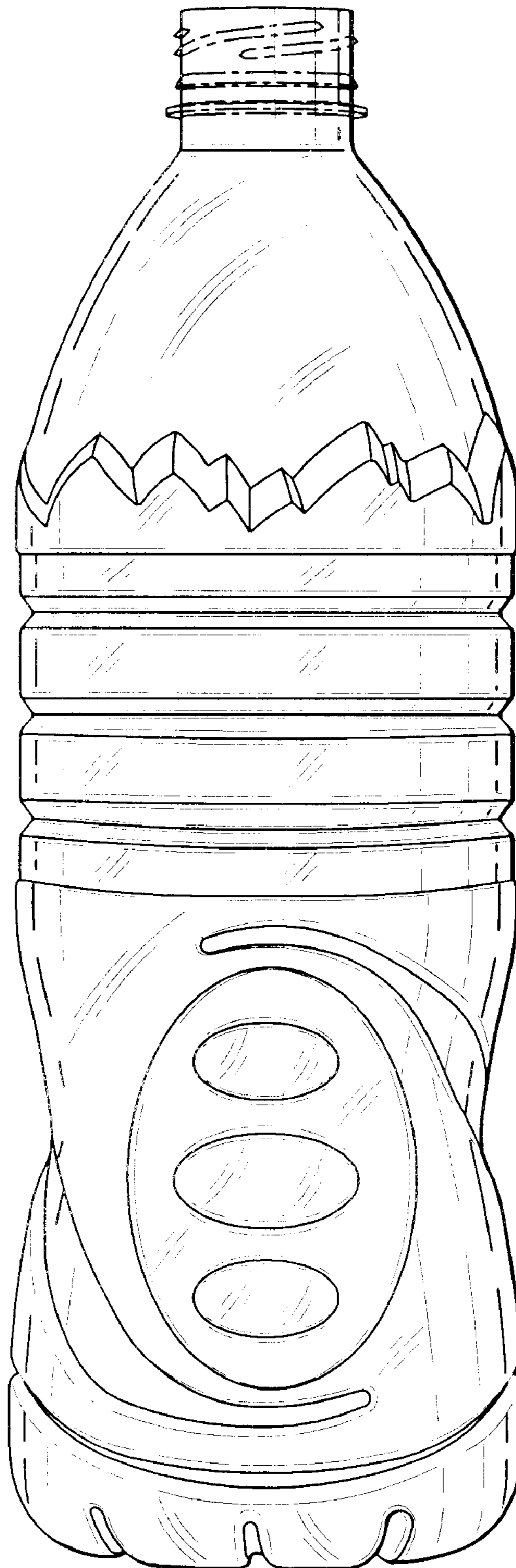
FIG. 6 is a perspective view of the bottom of the bottle; and,

FIG. 7 is a front and bottom perspective view of the bottle.

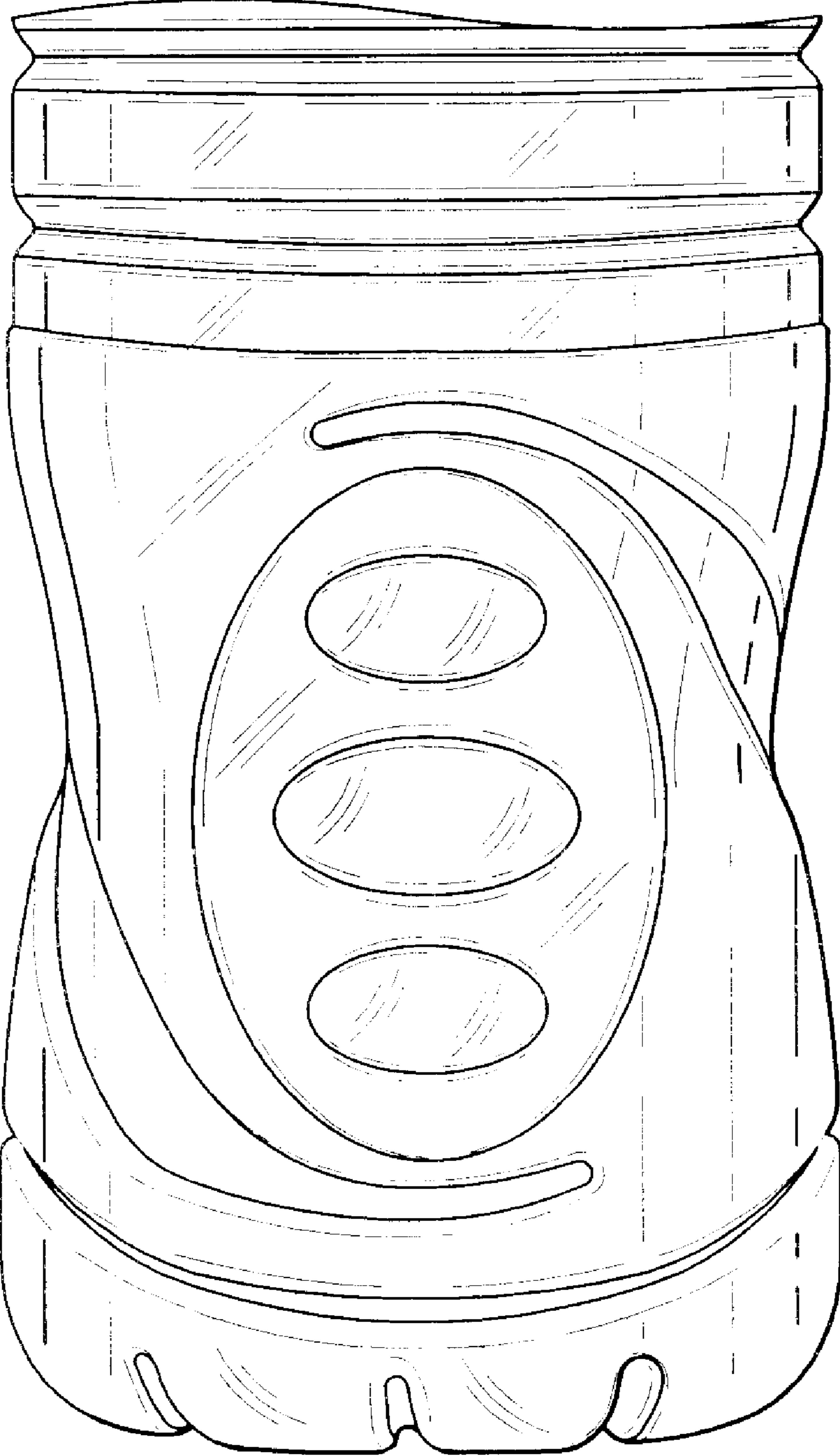
The structure shown in phantom lines in the figures is shown for illustrative purposes only and forms no part of the claim design.

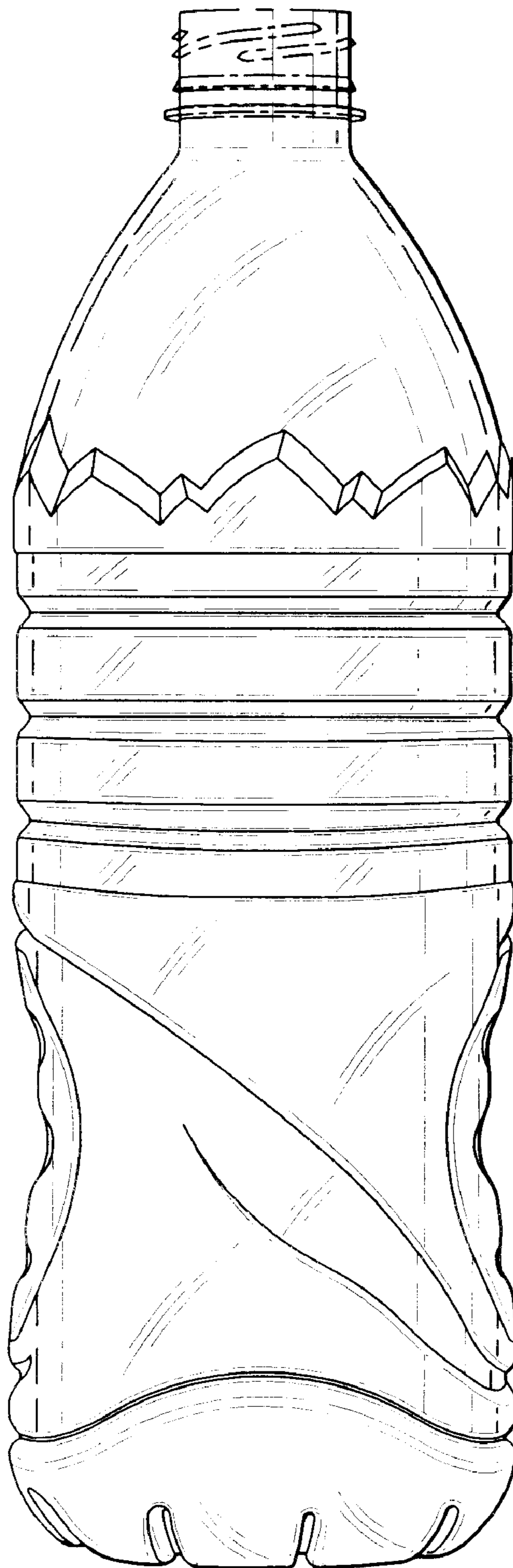




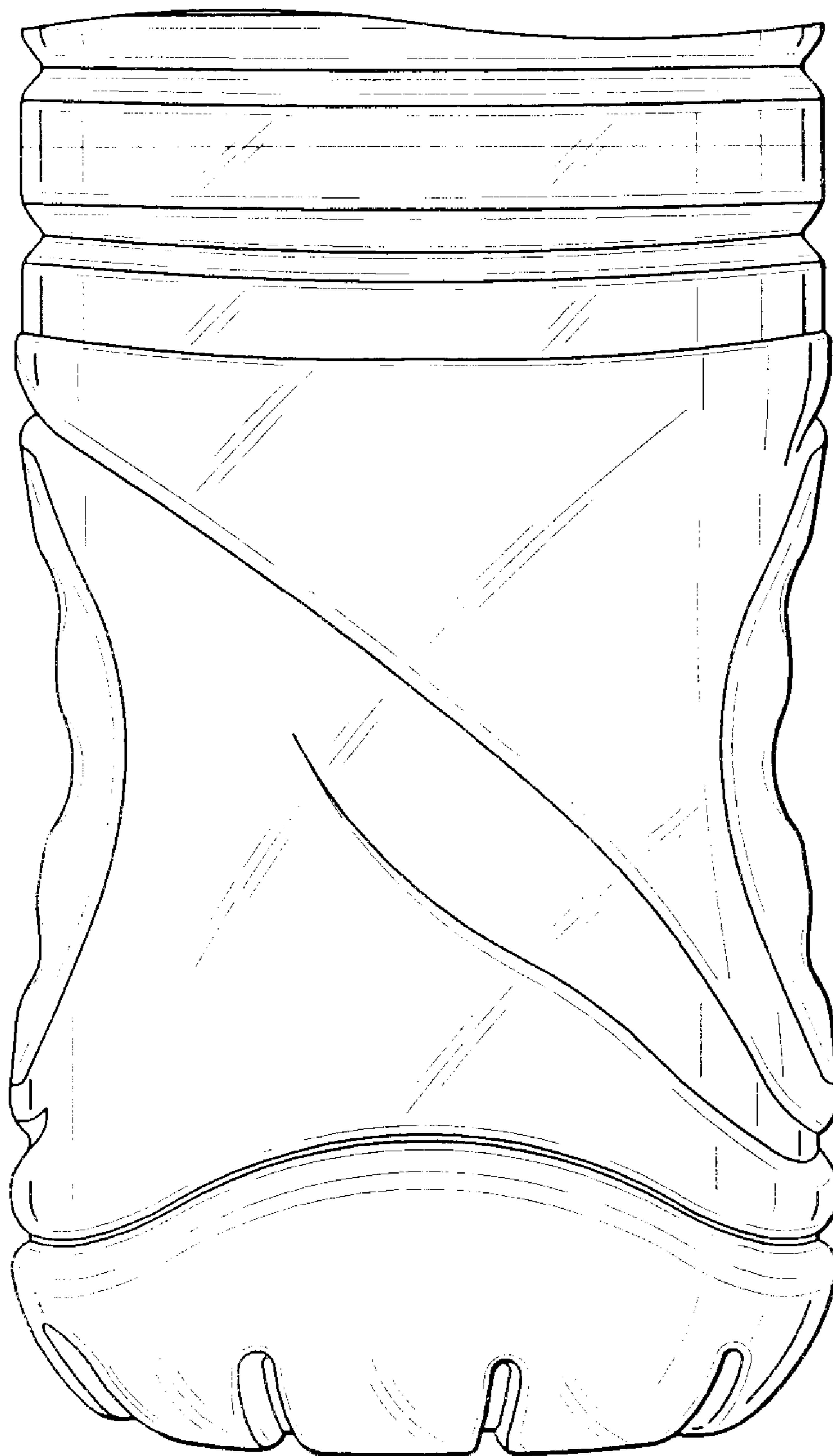

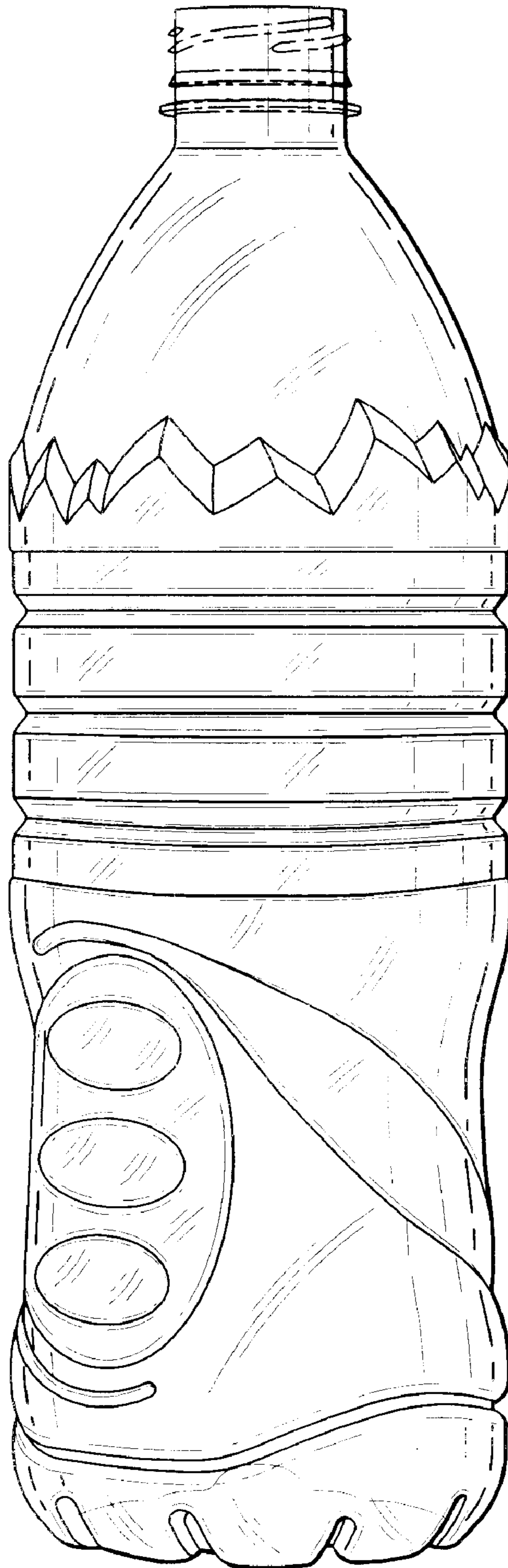

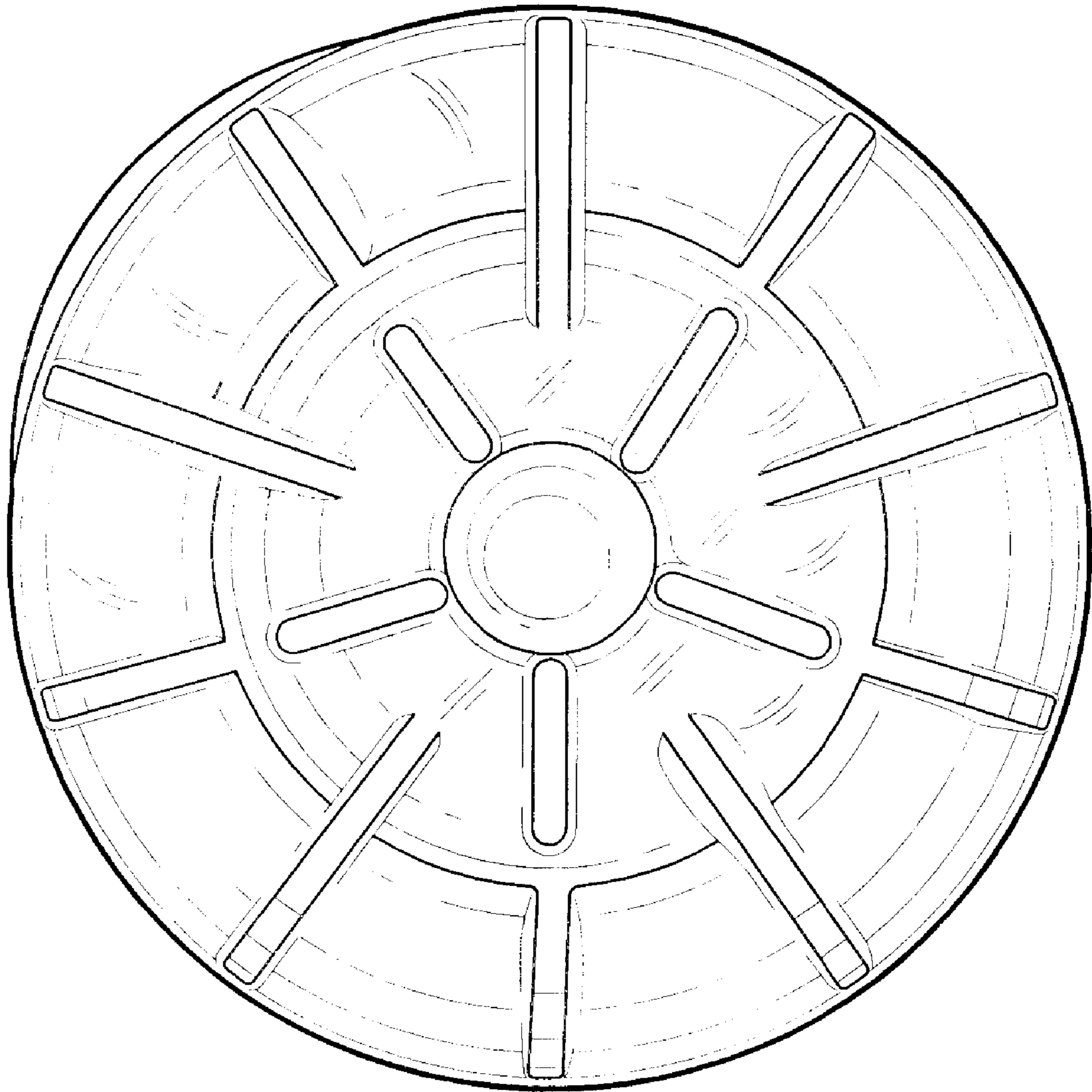
