(57) **CLAIM**

I claim the ornamental design for a perfume bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a perfume bottle showing my new design, the rear elevational view being identical;

FIG. 2 is a left side elevational view thereof, the right side elevational view being identical;

FIG. 3 is a top plan view thereof;

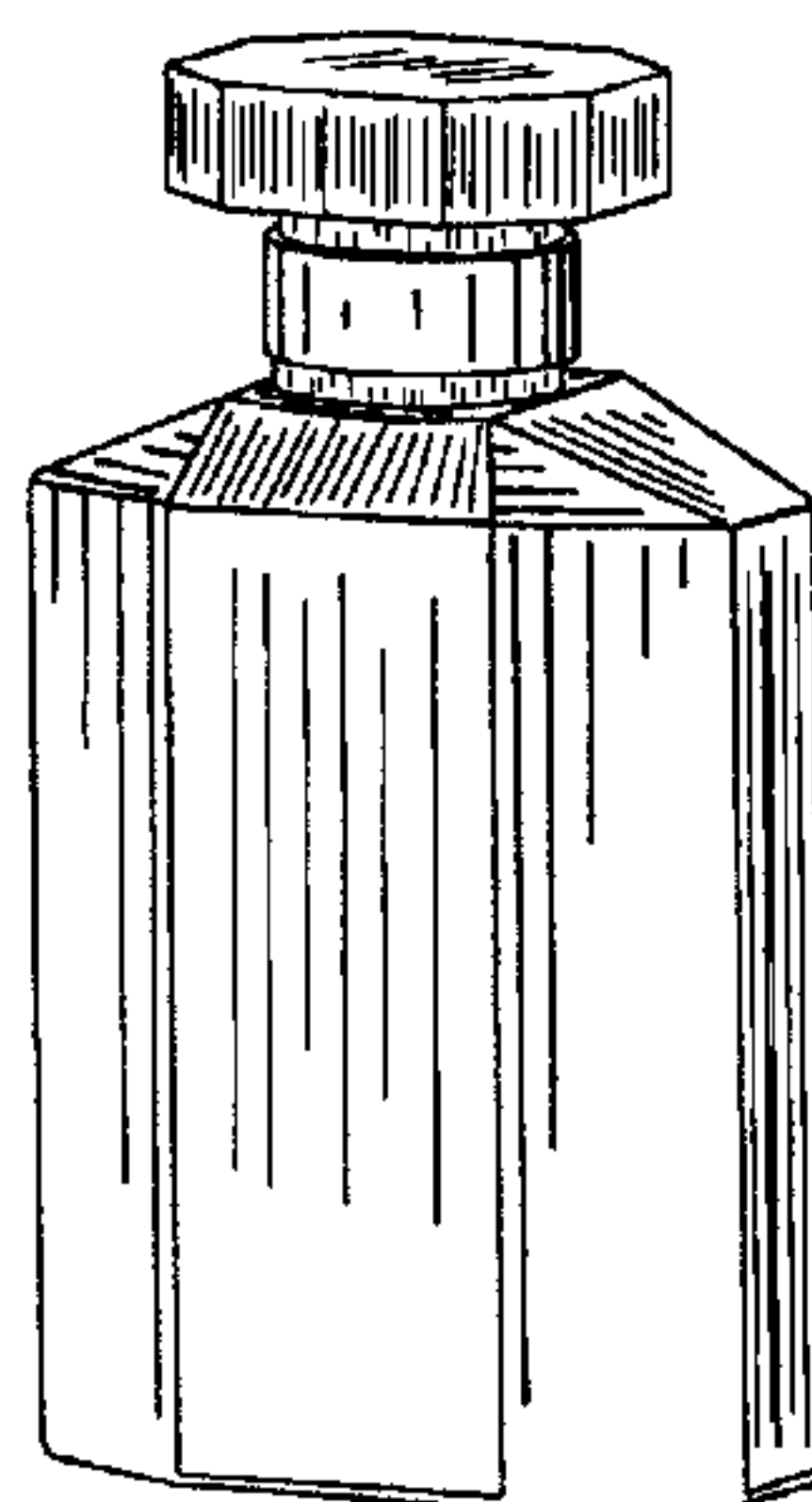
FIG. 4 is a top, front, right perspective view thereof;

FIG. 5 is a front elevational view of a second embodiment showing my new design, the rear elevational view being identical;

FIG. 6 is a left side elevational view thereof, the right side elevational view being identical; and,

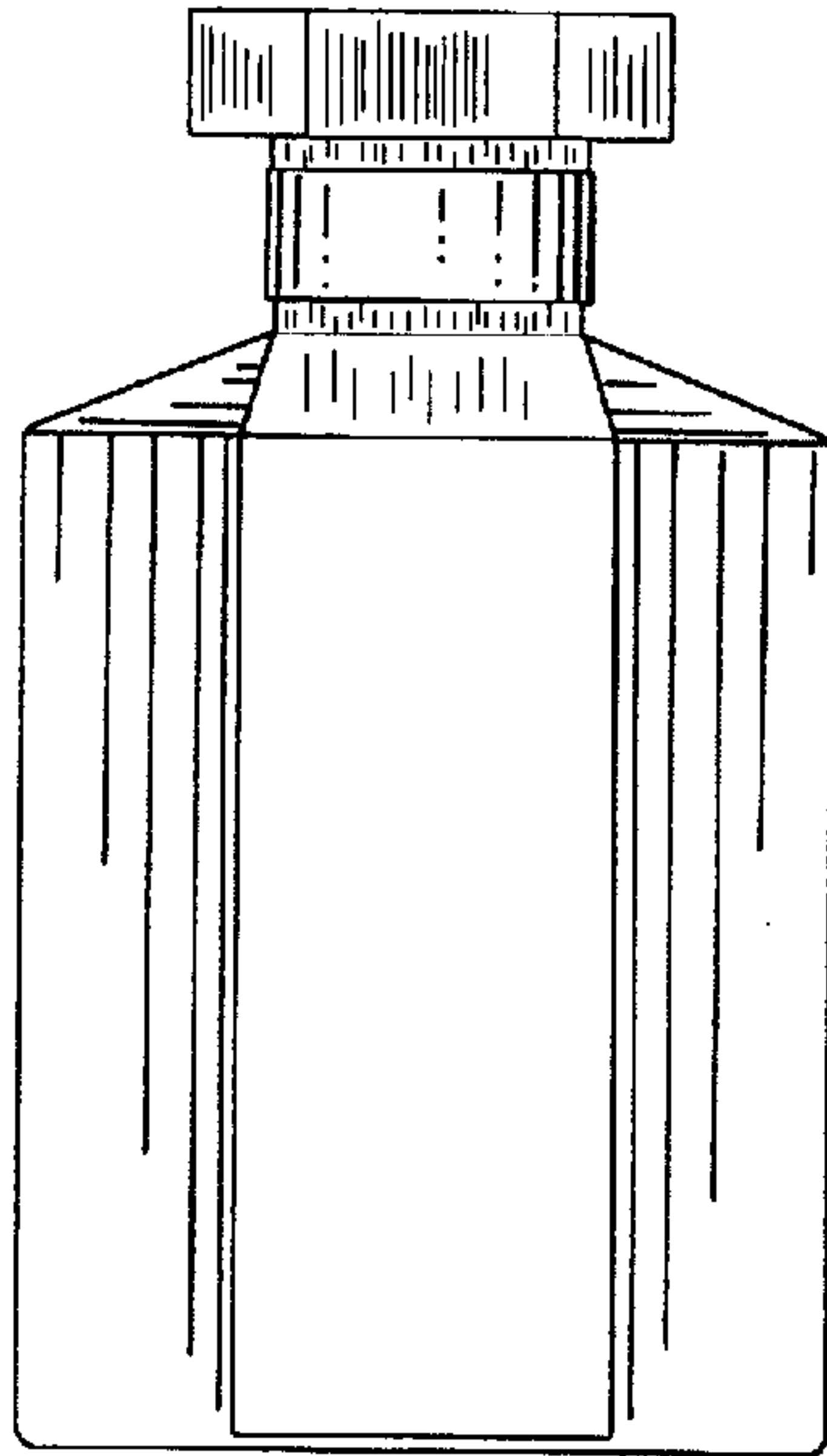

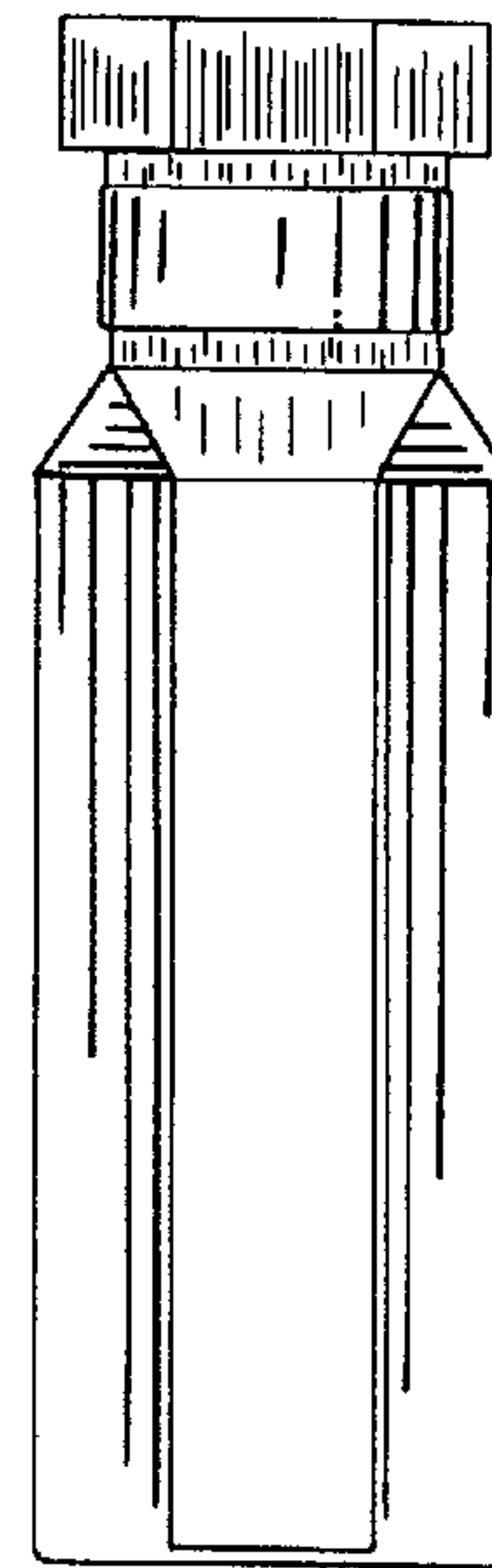

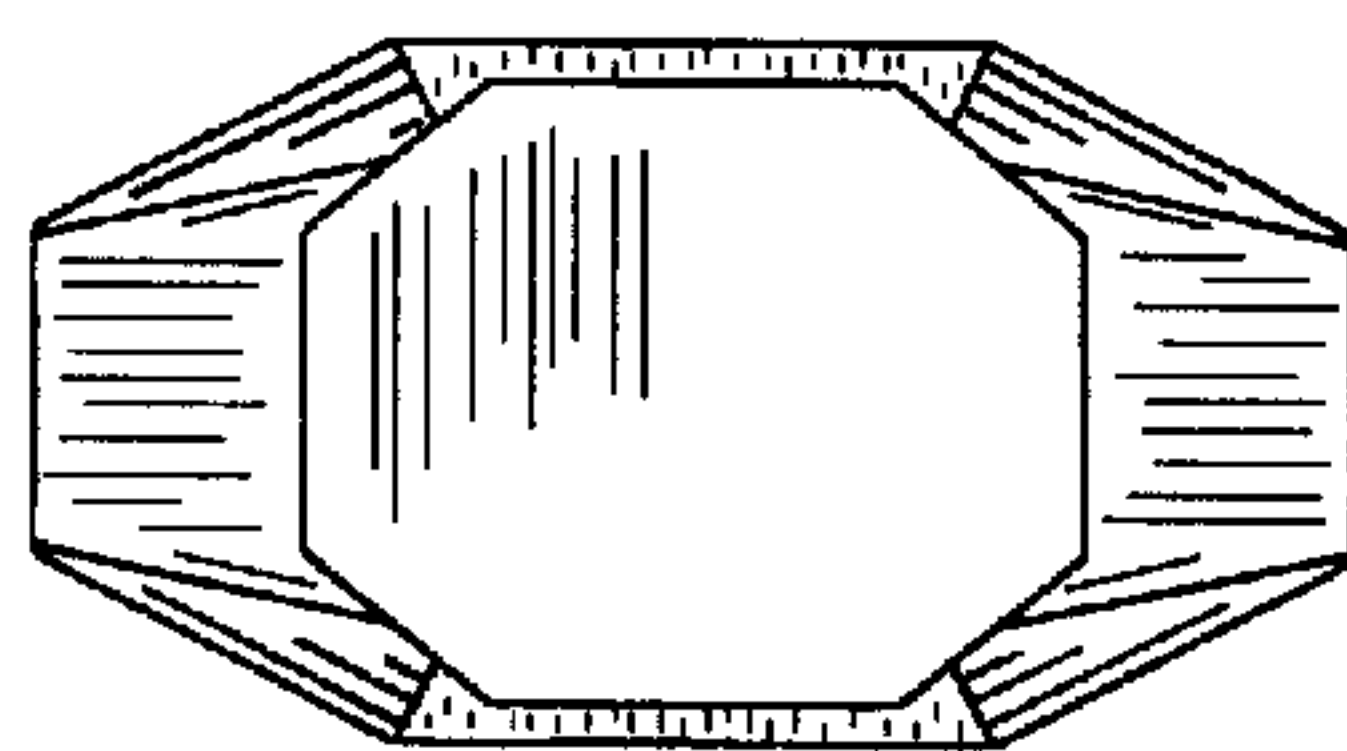

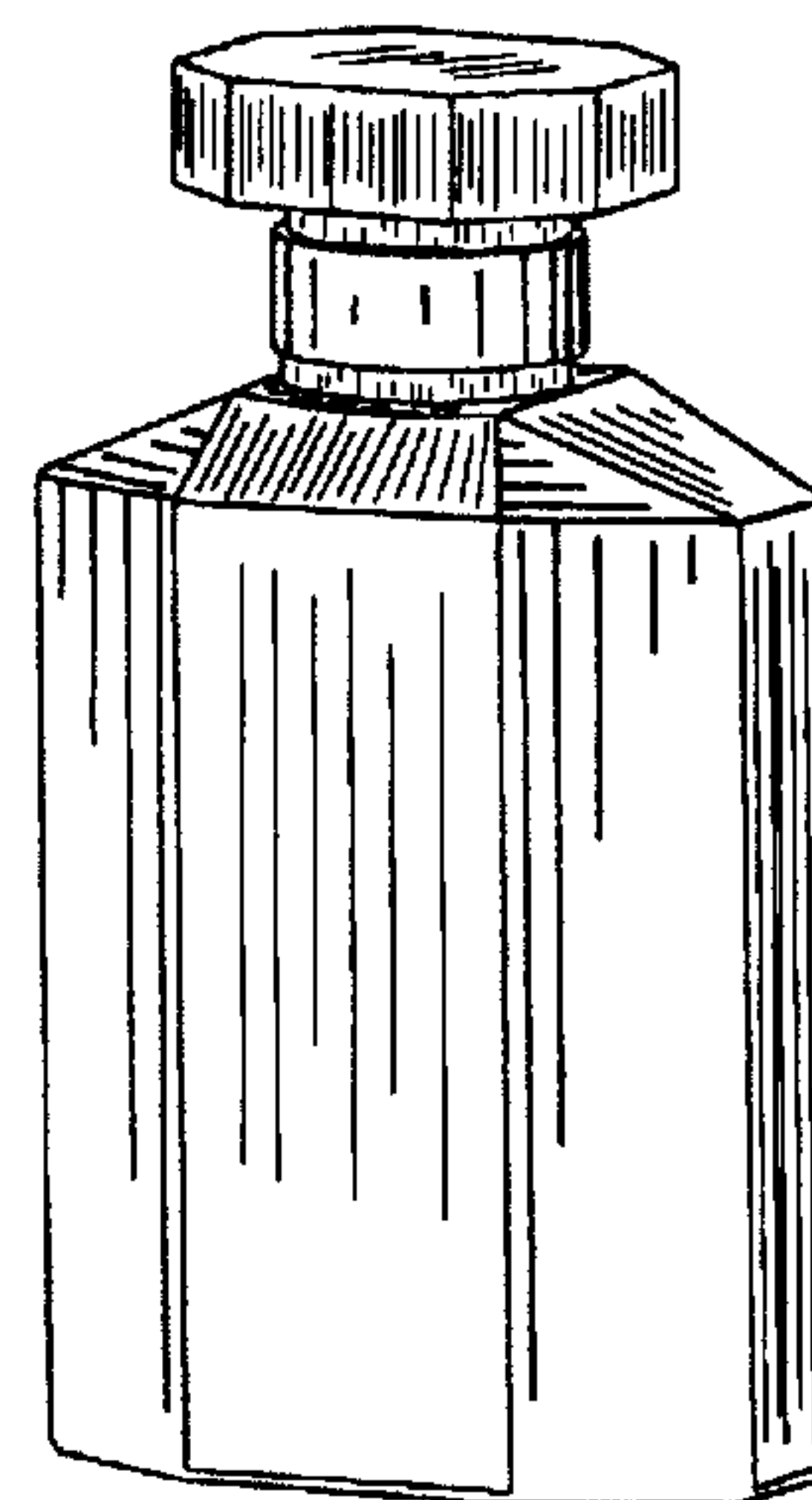

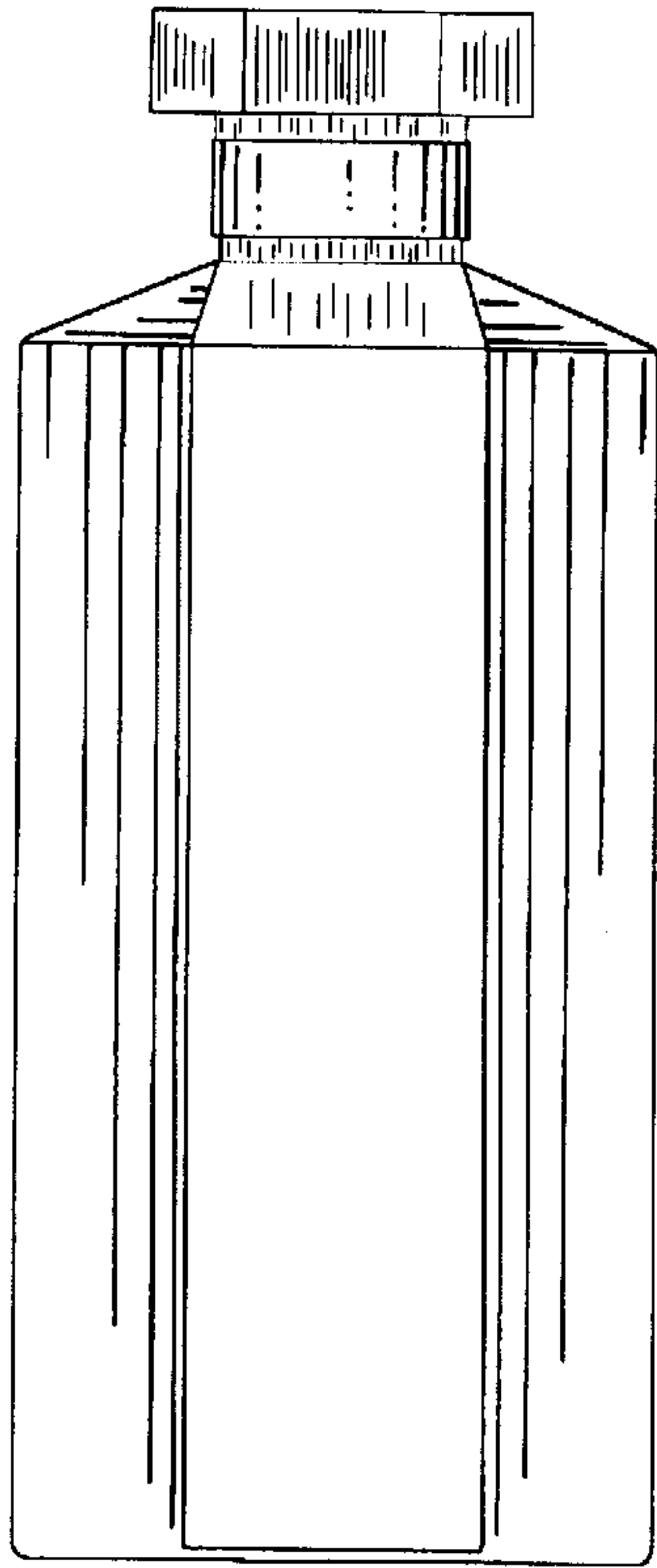

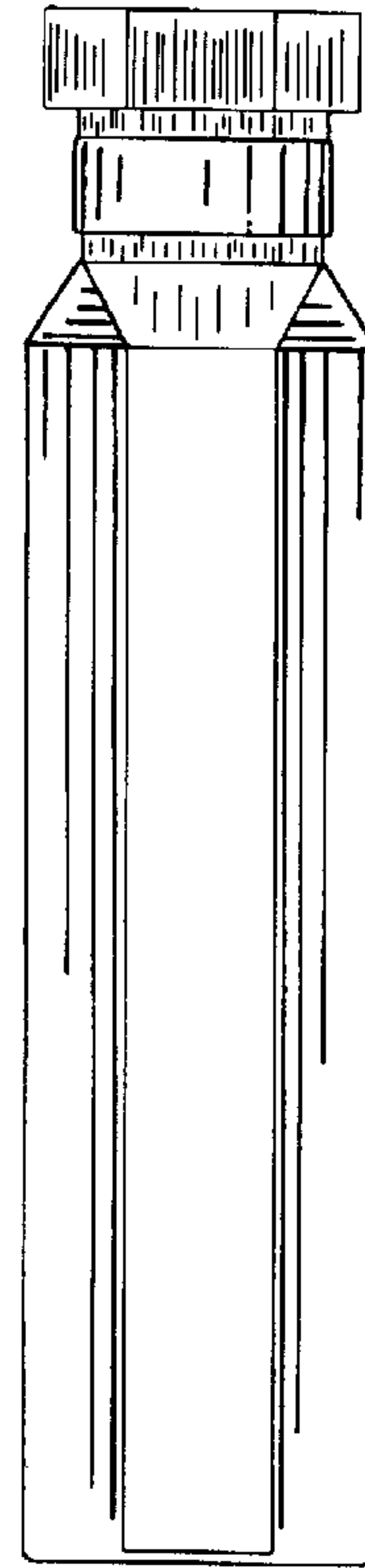

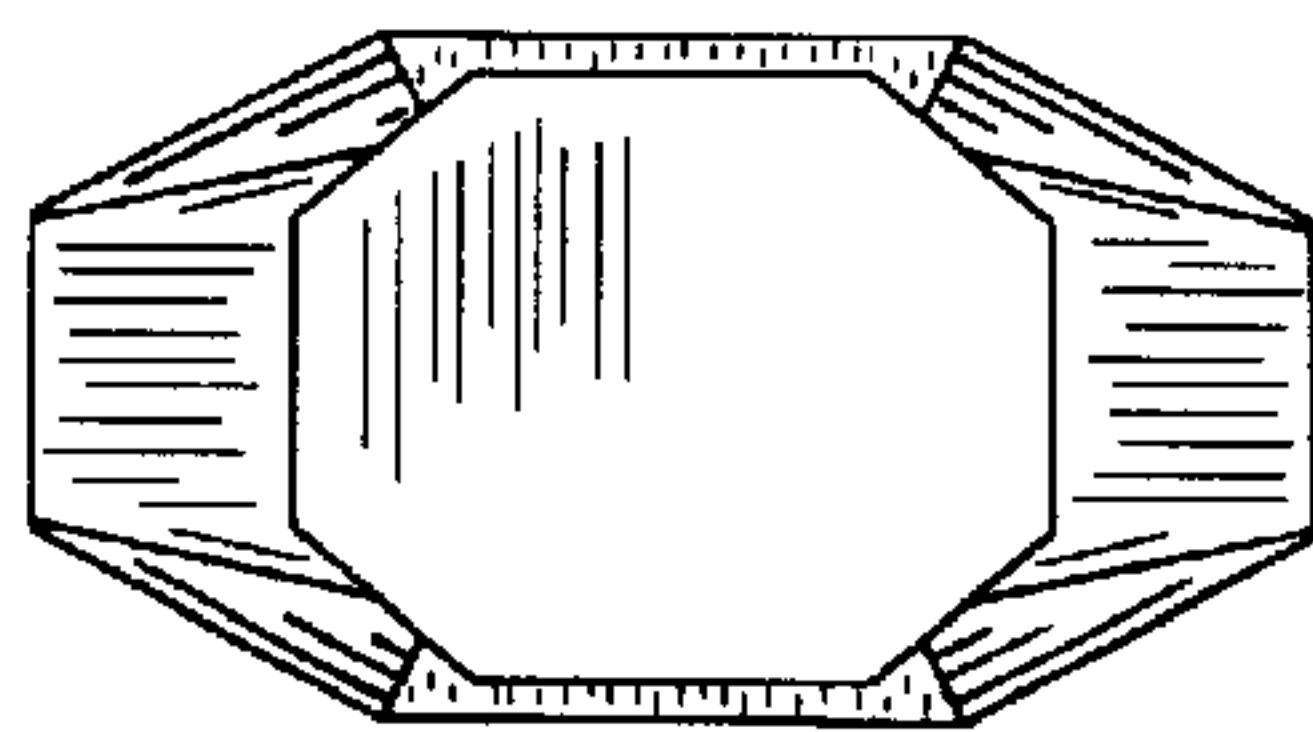
