FIG. 5 is a rear plan view thereof;

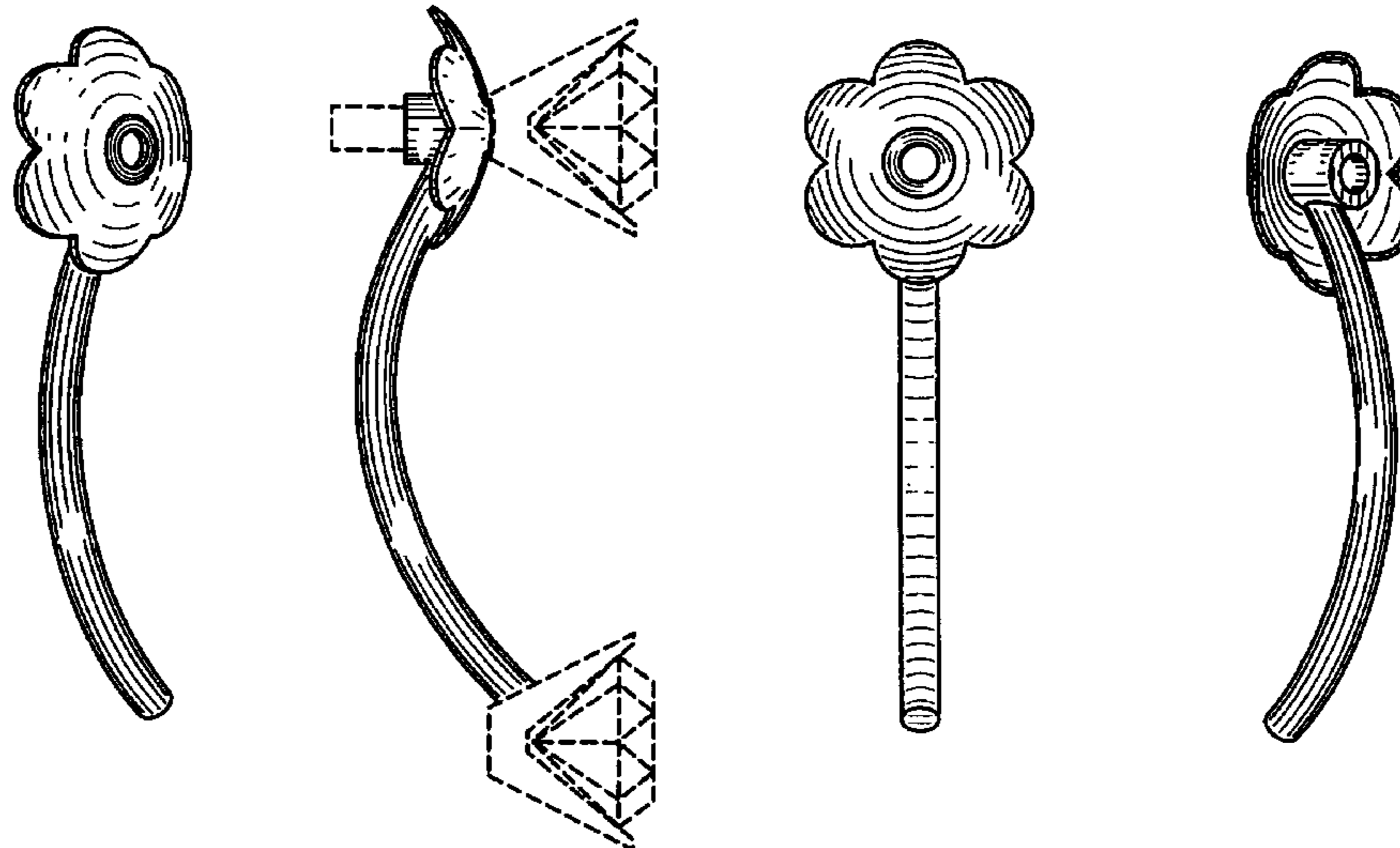
FIG. 6 is a rear perspective view thereof;

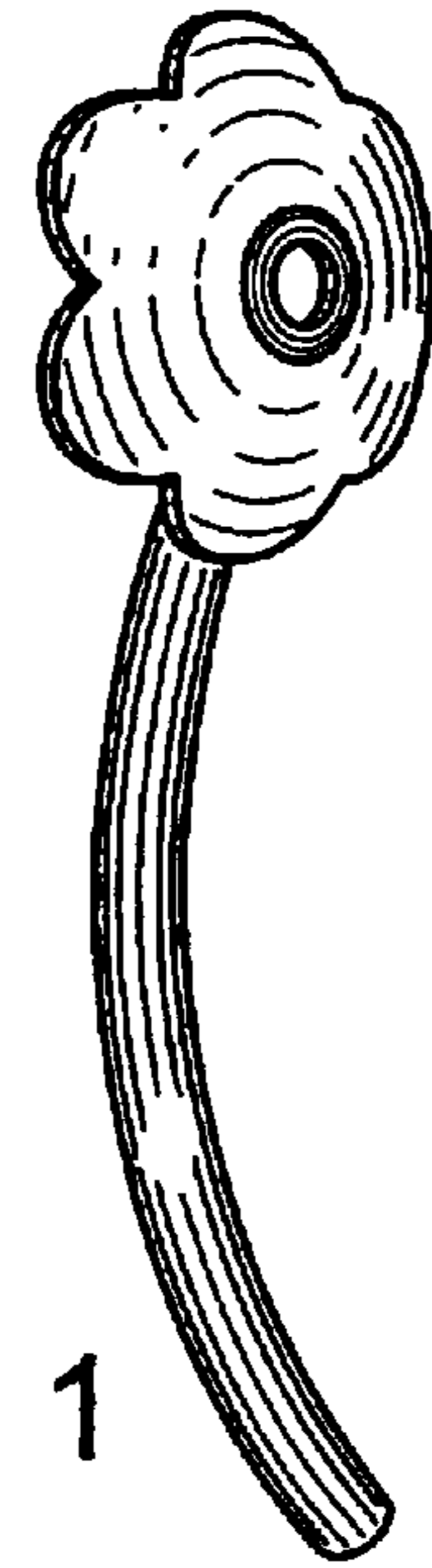

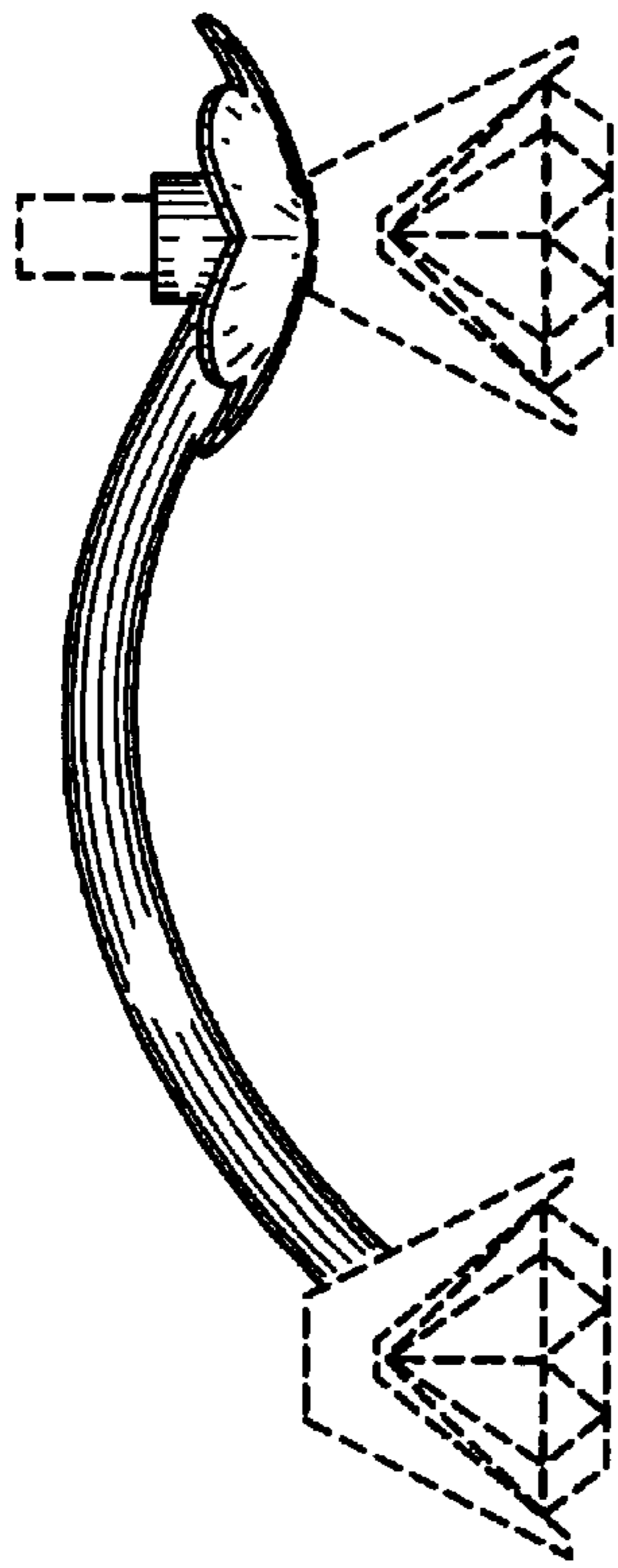

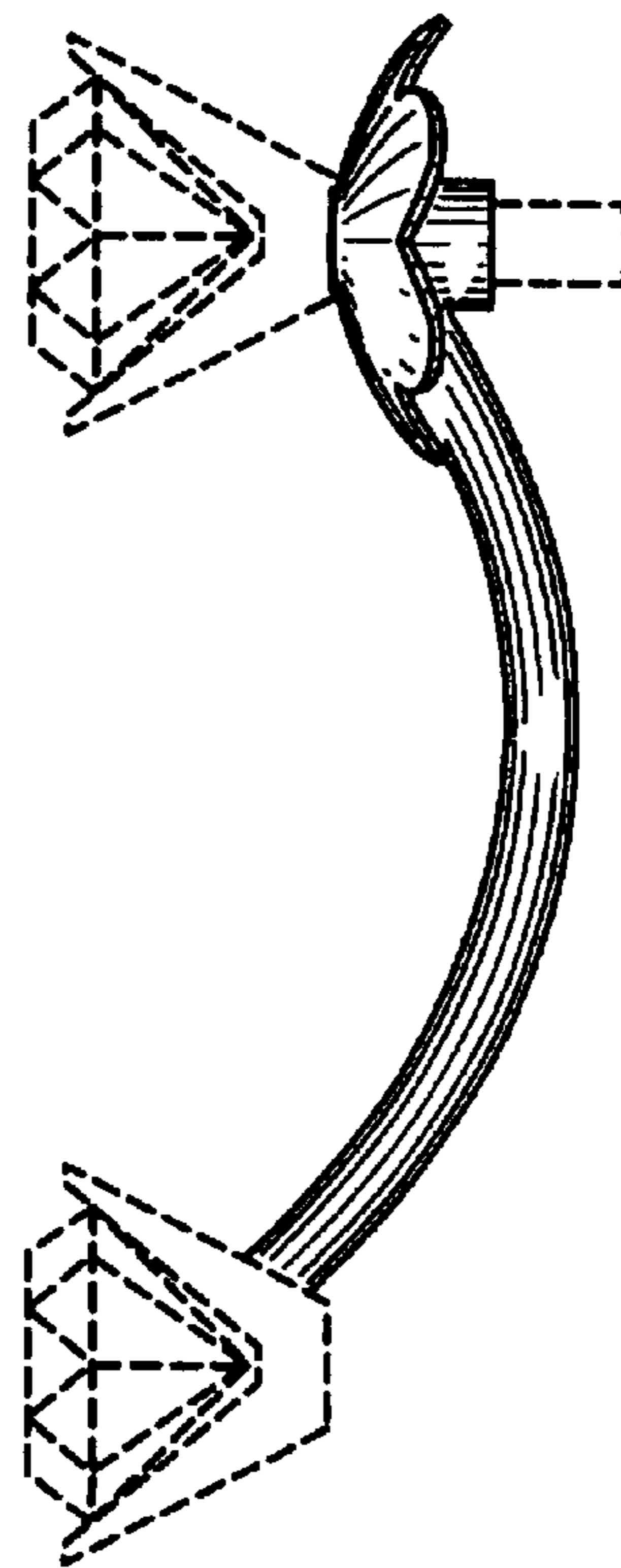

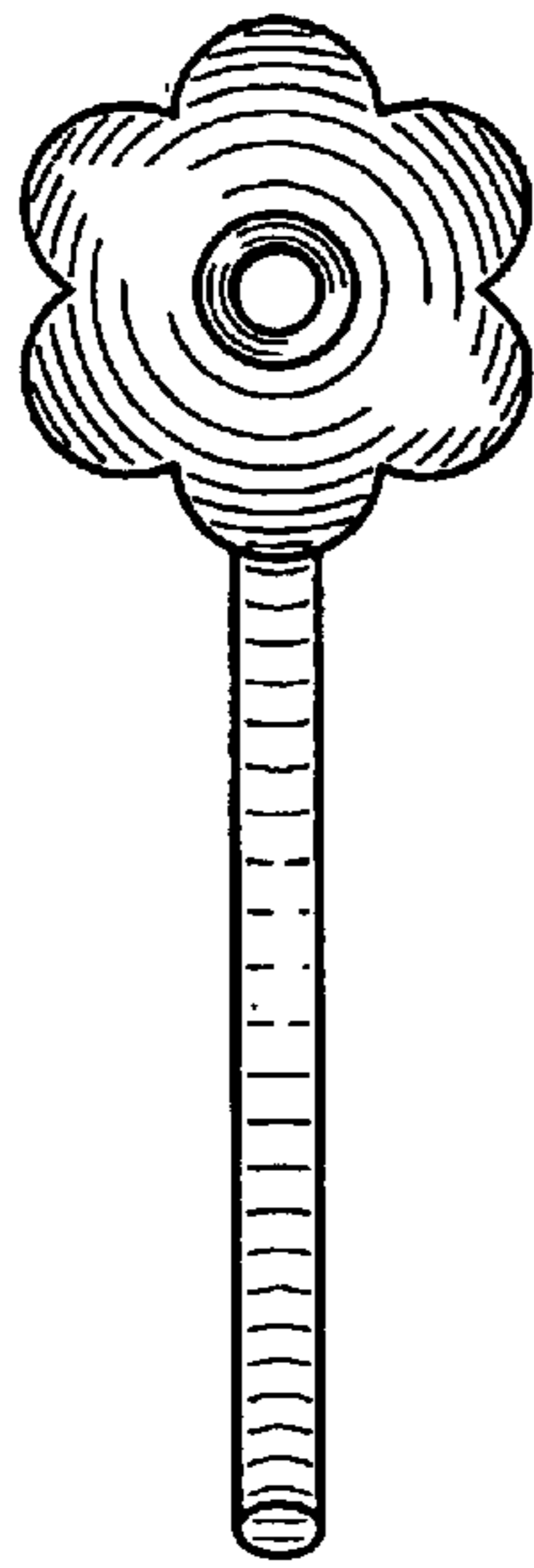

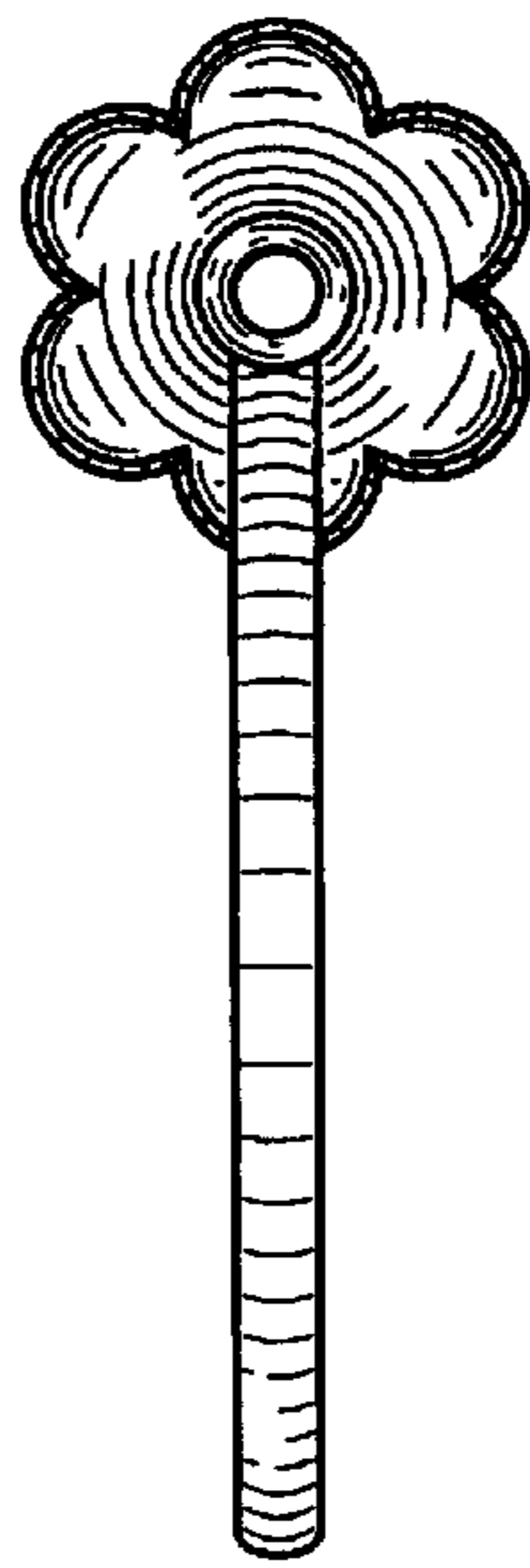

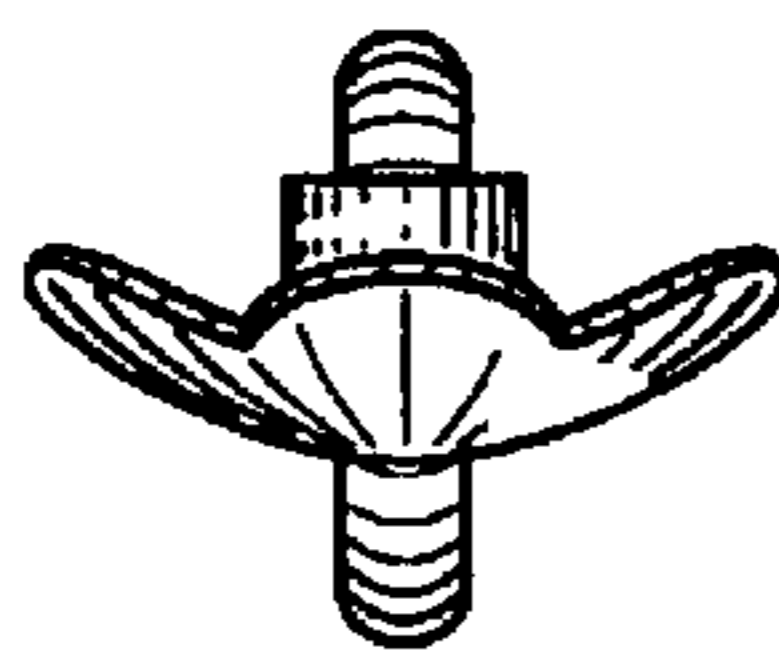

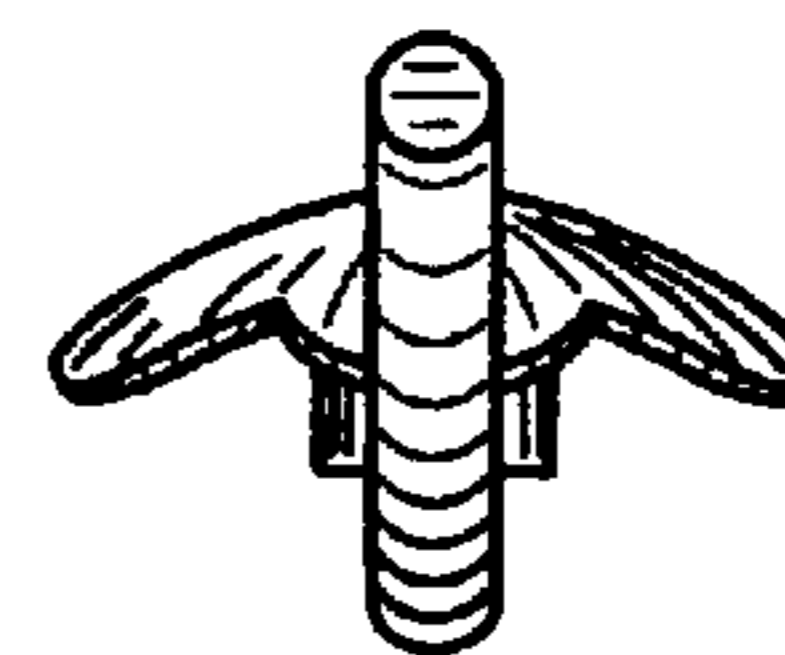
