(57) **CLAIM**

The ornamental design for a flower holder, as shown and described.

DESCRIPTION

FIG. 1 is a side perspective view of a translucent flower holder, showing our new design;

FIG. 2 is a side perspective view thereof, shown in an alternate position of use;

FIG. 3 is a top plan view of the flower holder shown in FIG. 1;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a front elevational view thereof;

FIG. 6 is a left side elevational view thereof;

FIG. 14 is a left side elevational view thereof;

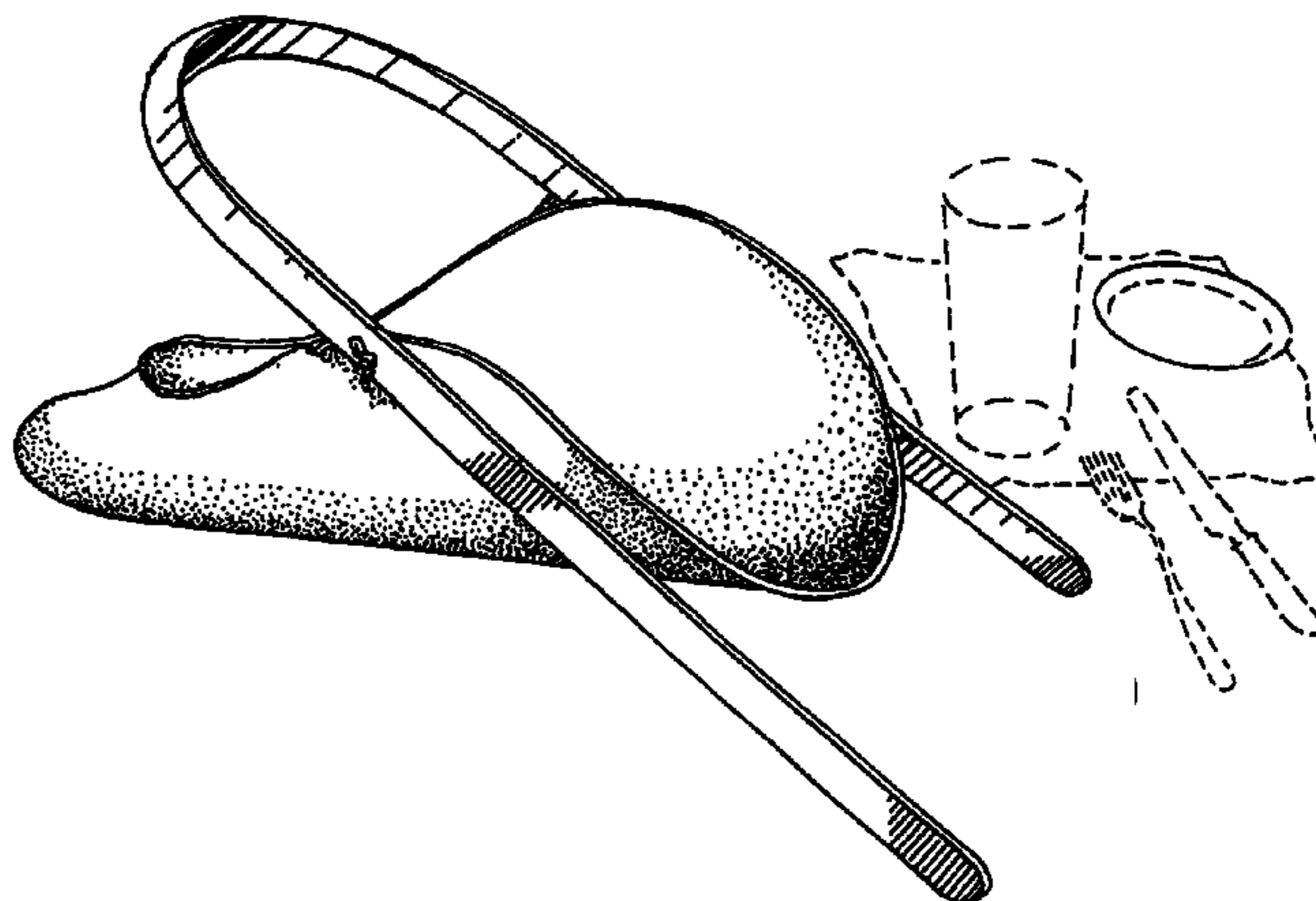
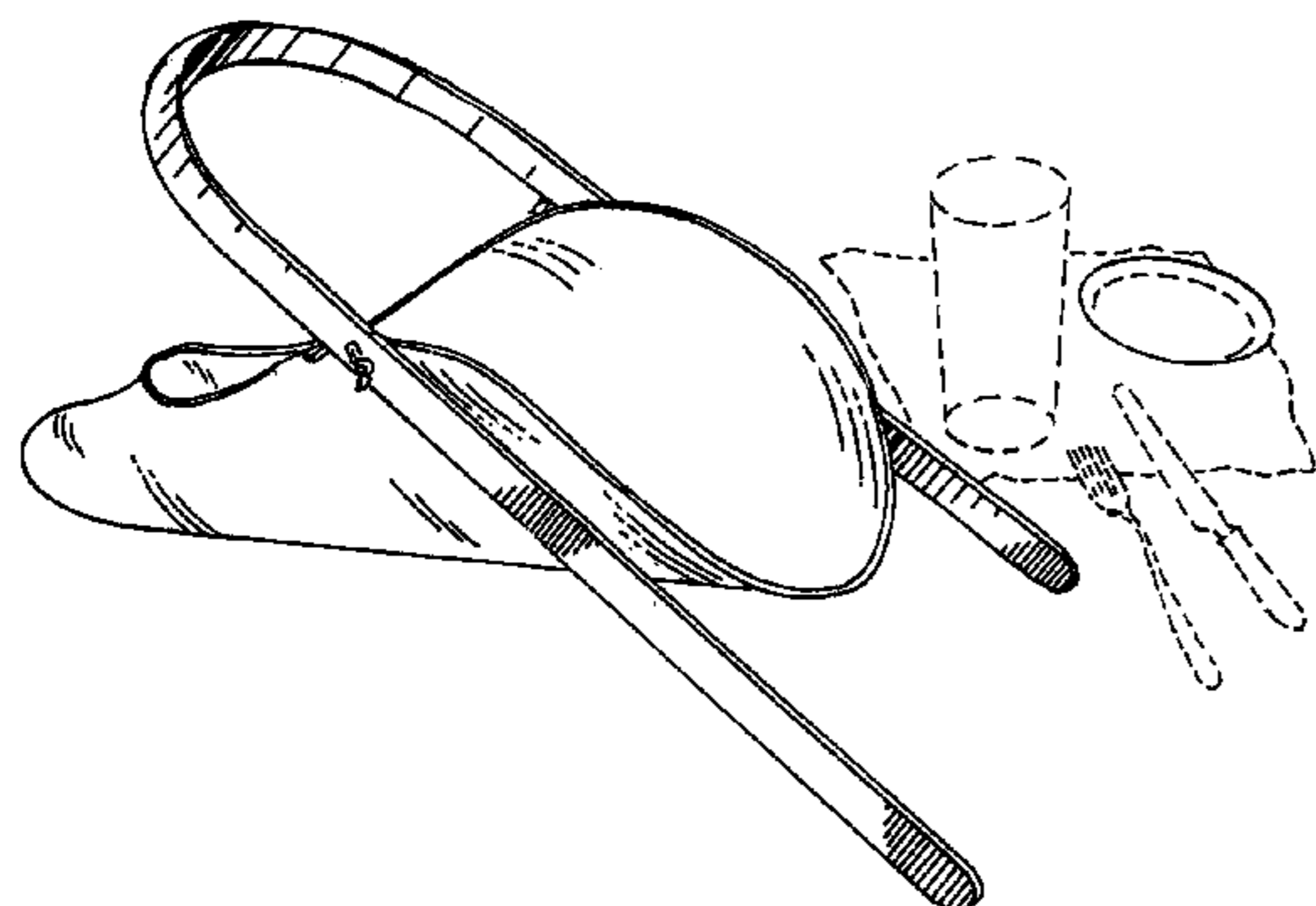
FIG. 15 is a right side elevational view thereof;

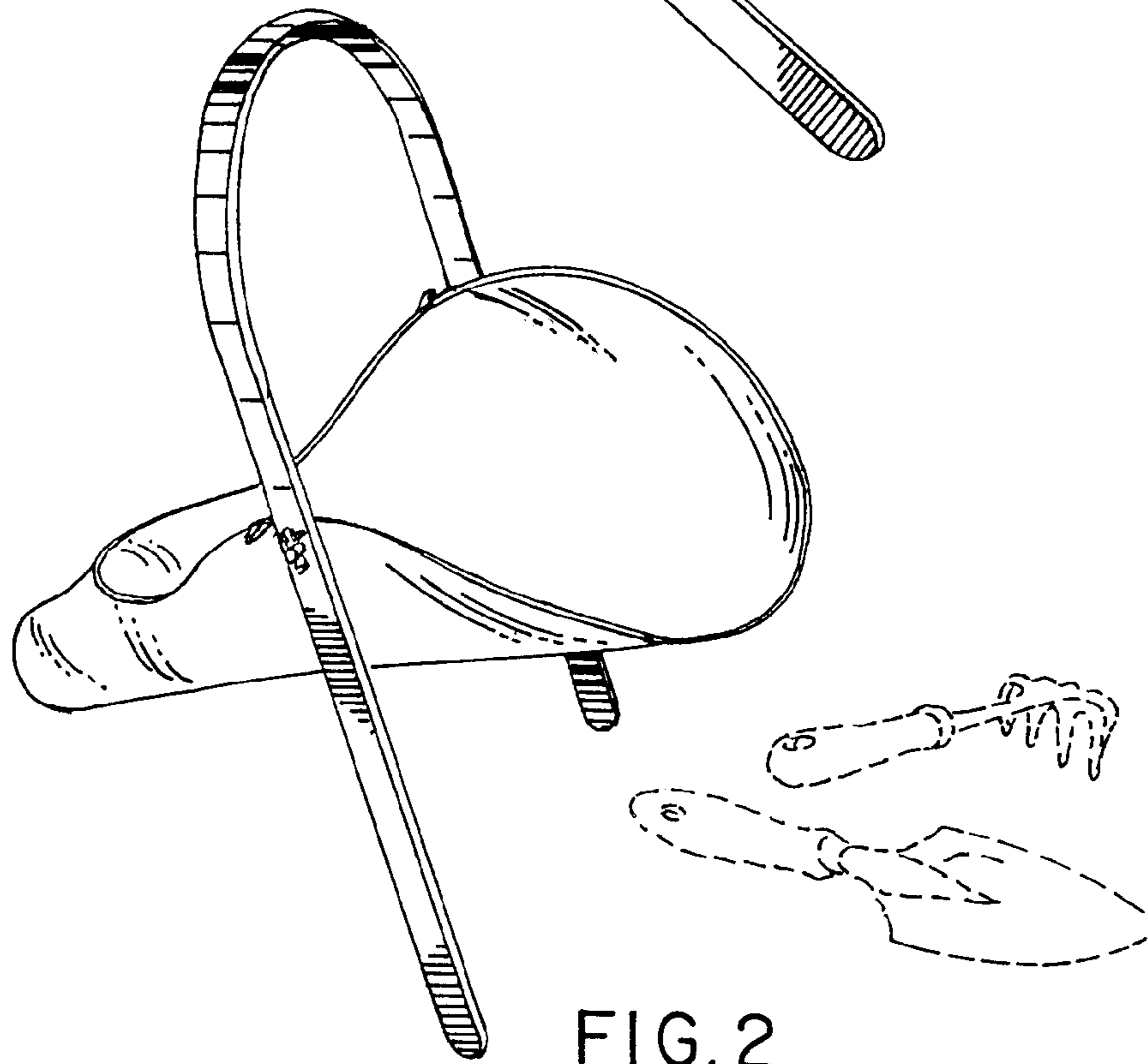
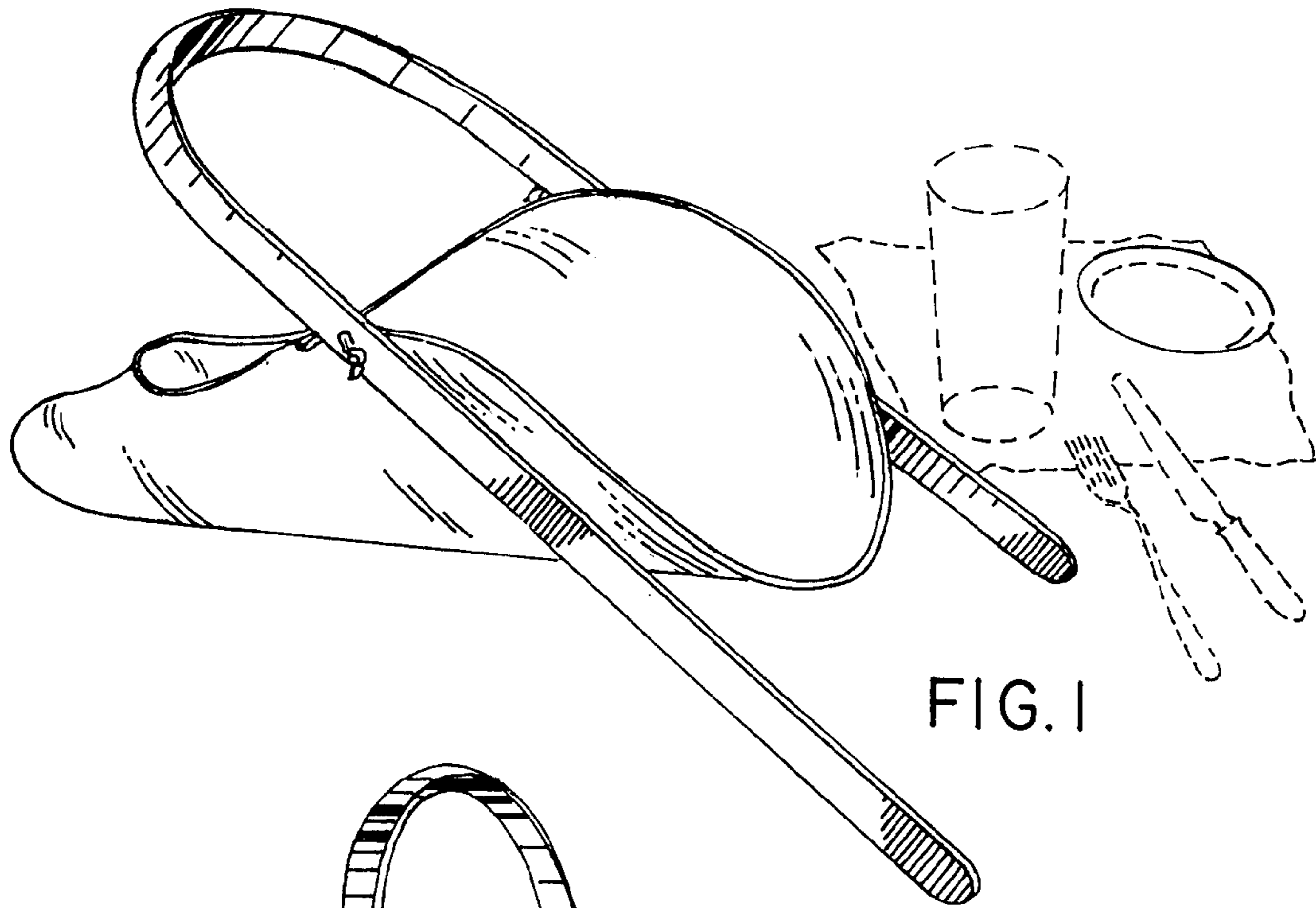
FIG. 16 is a rear elevational view thereof; and,

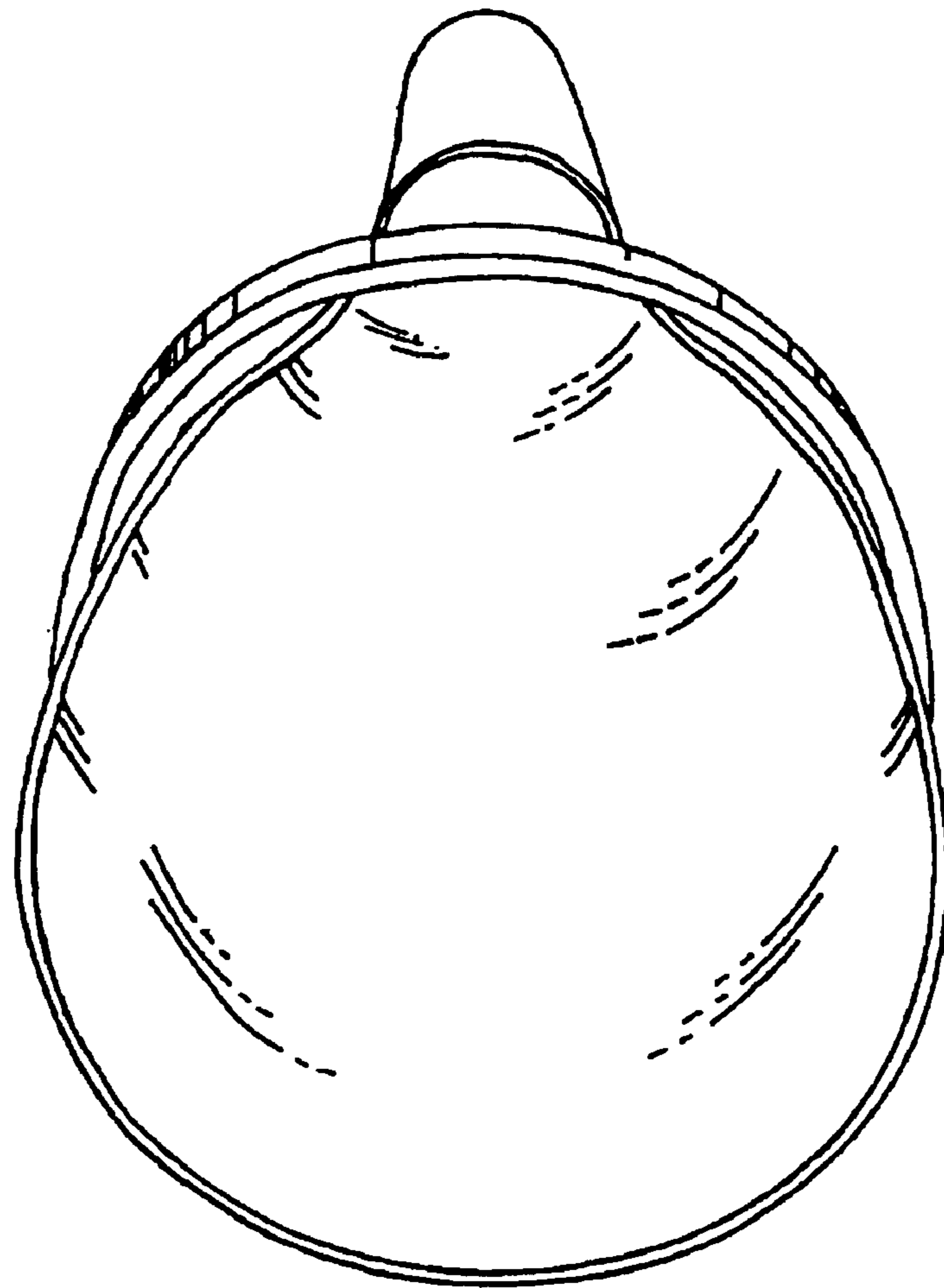

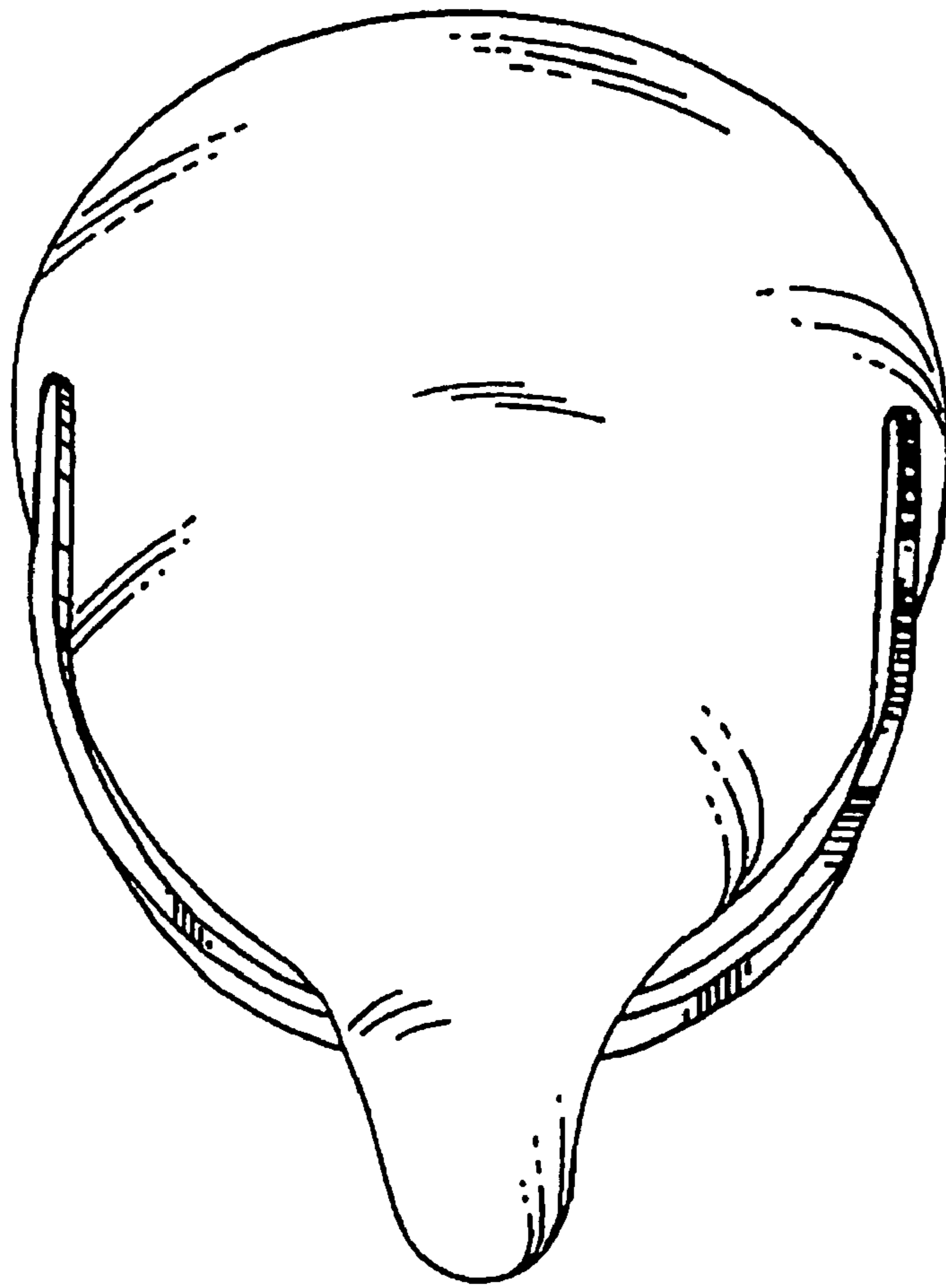

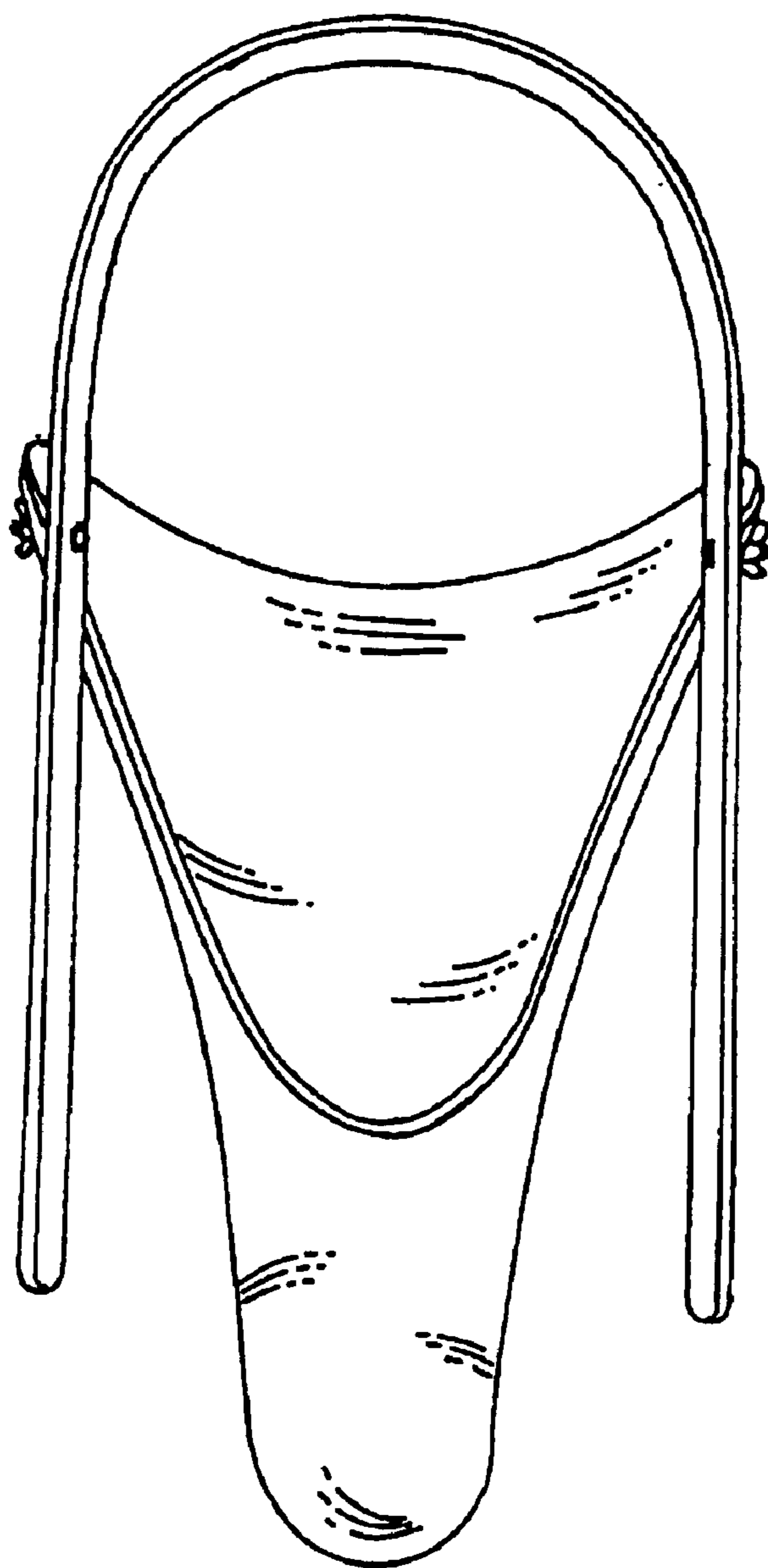

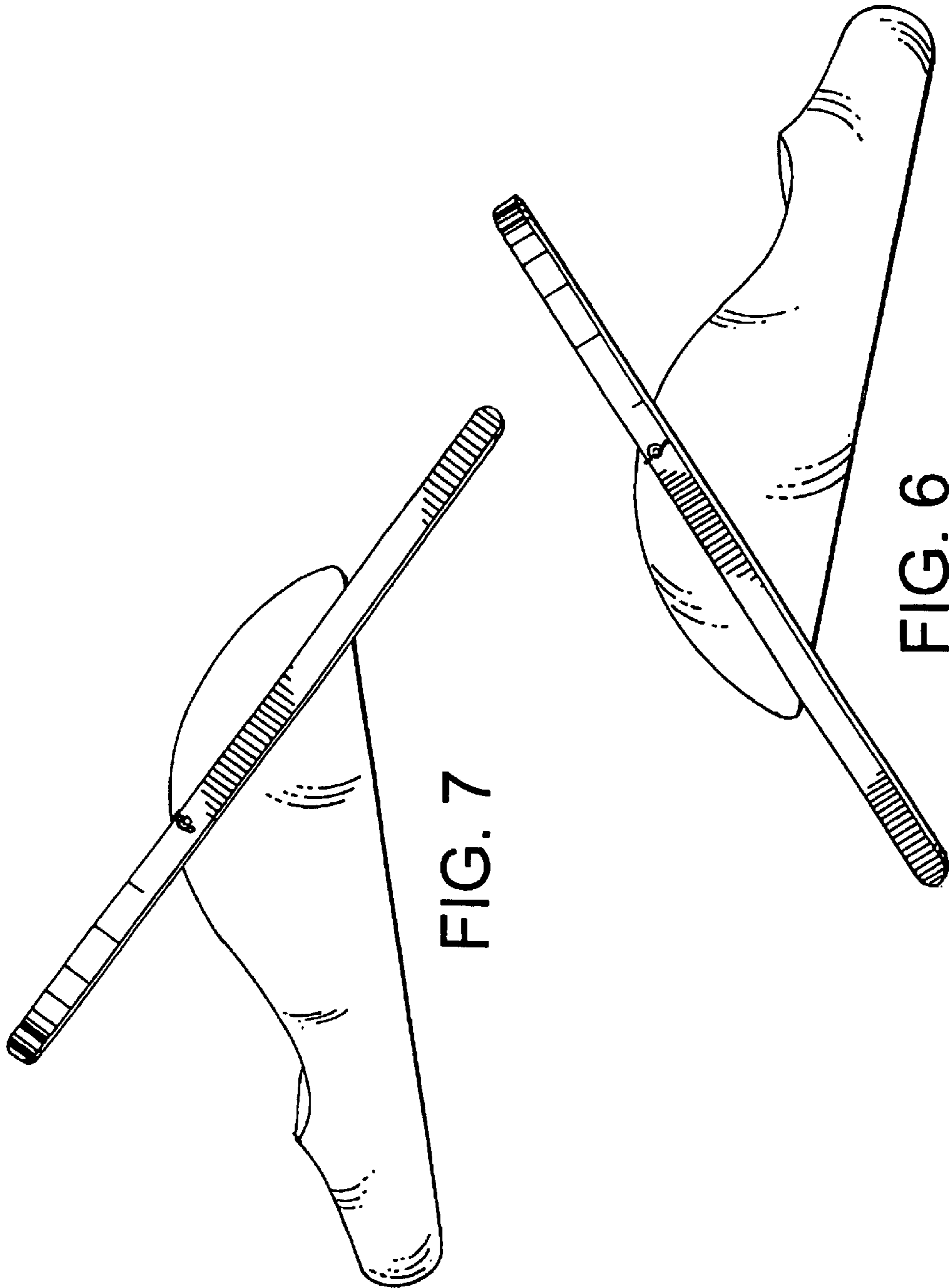

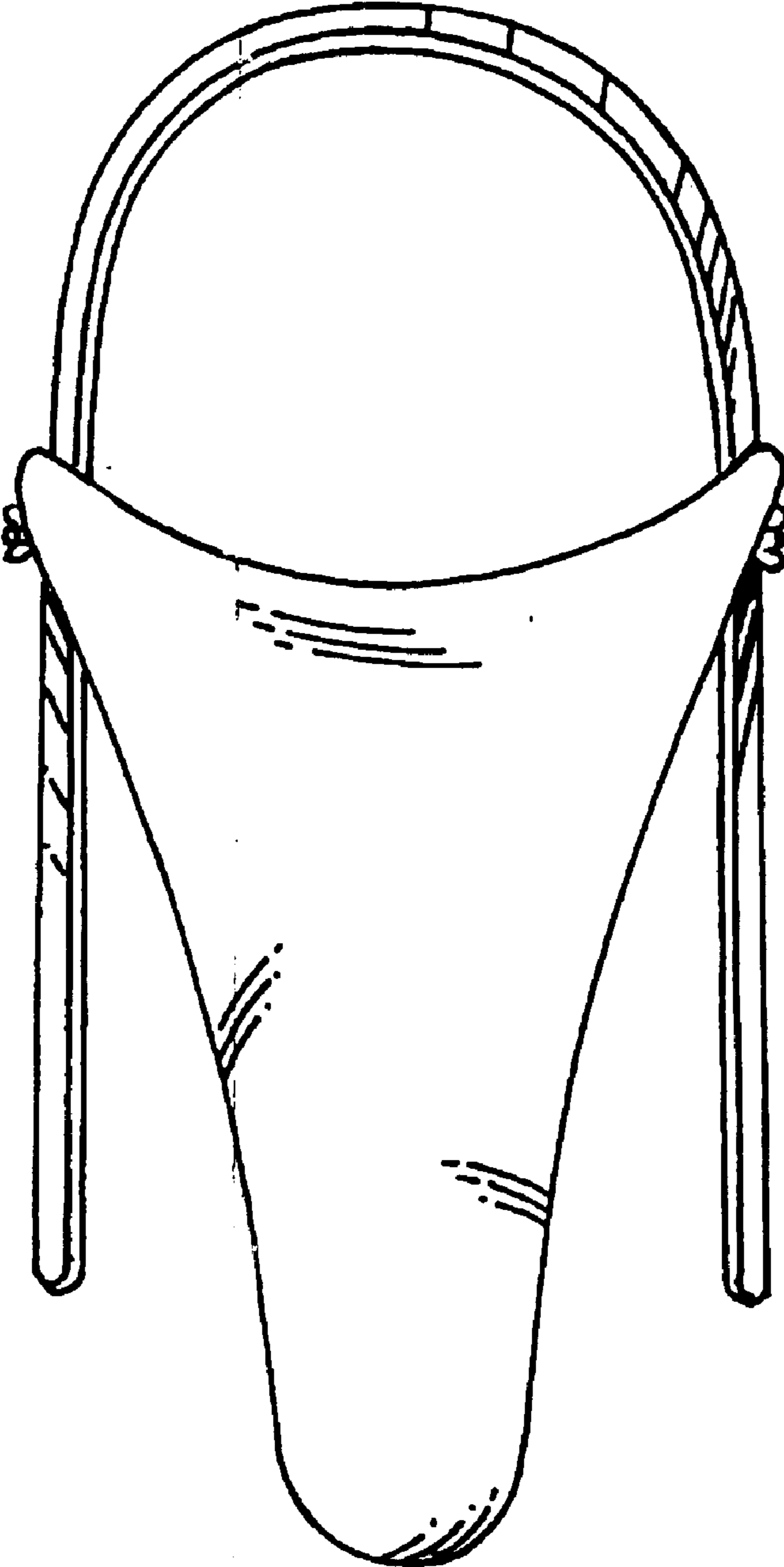

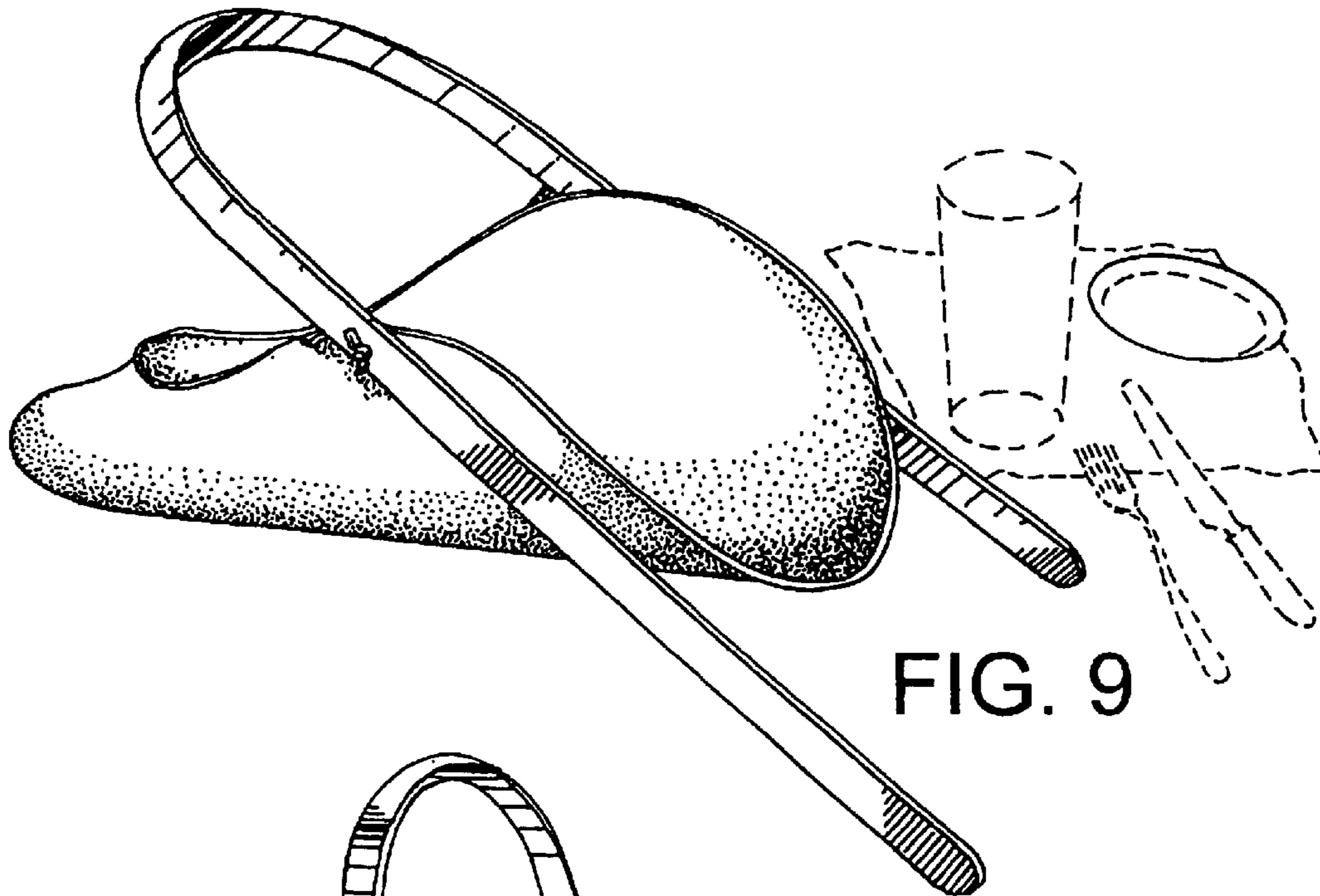

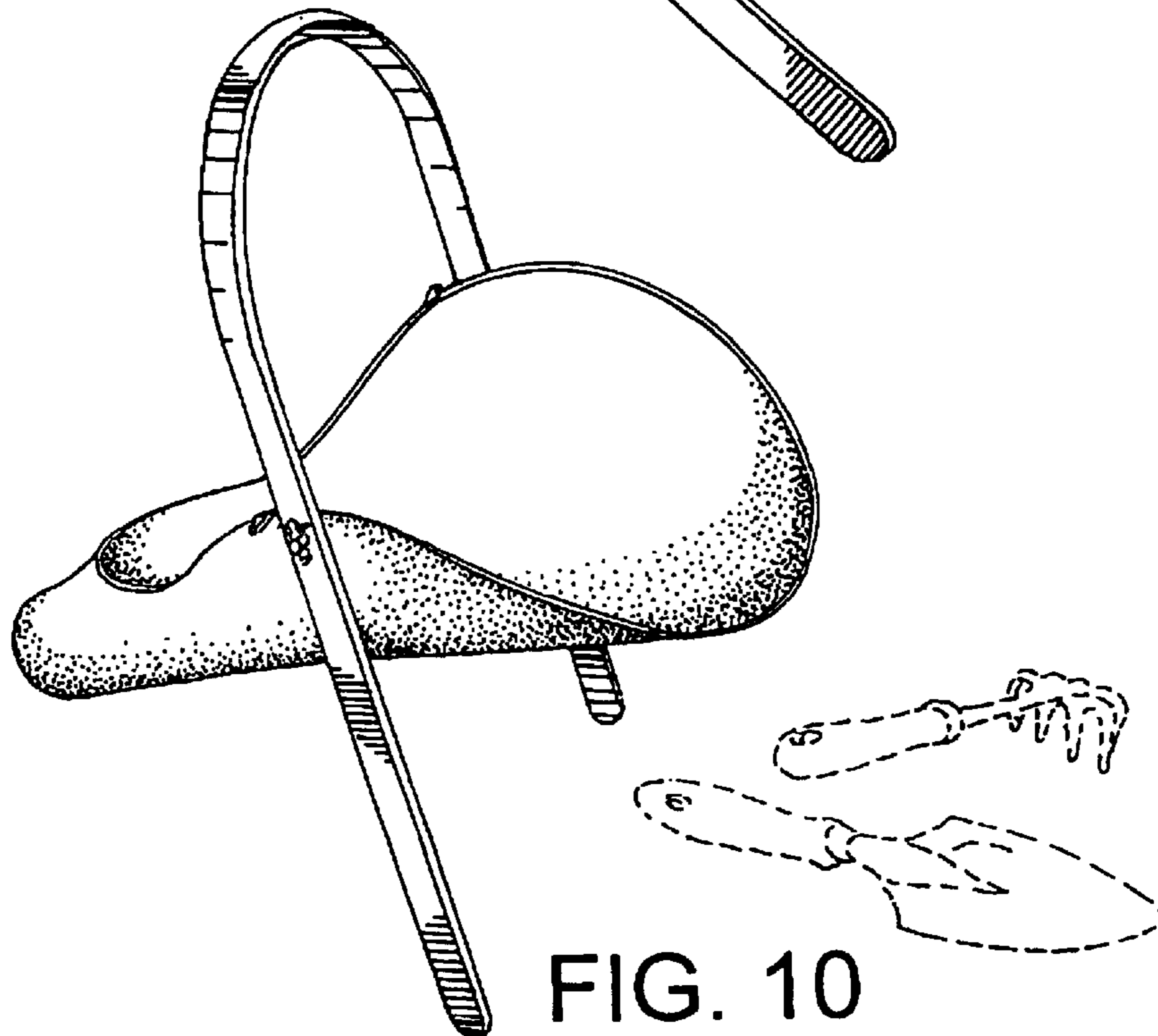

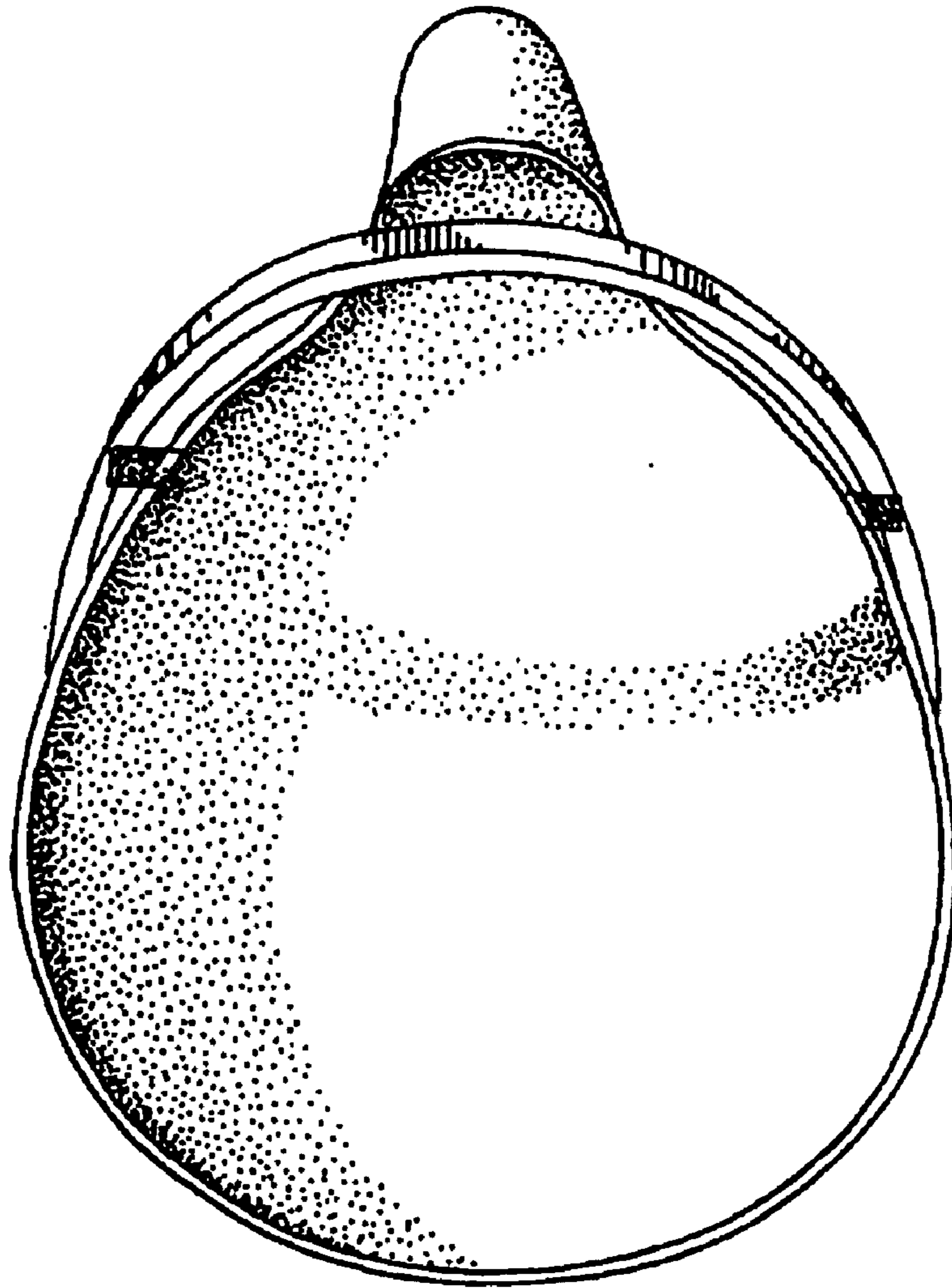

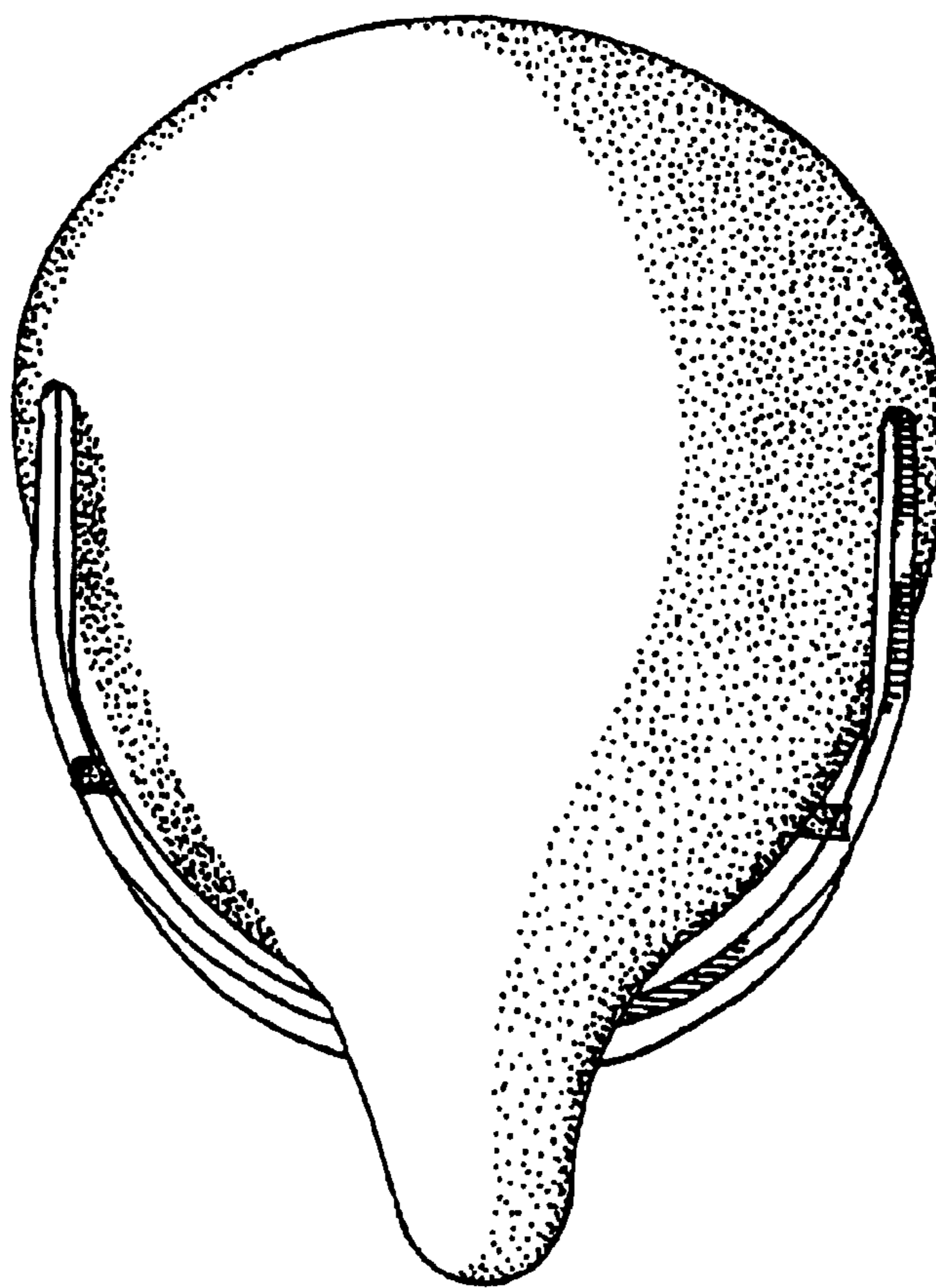

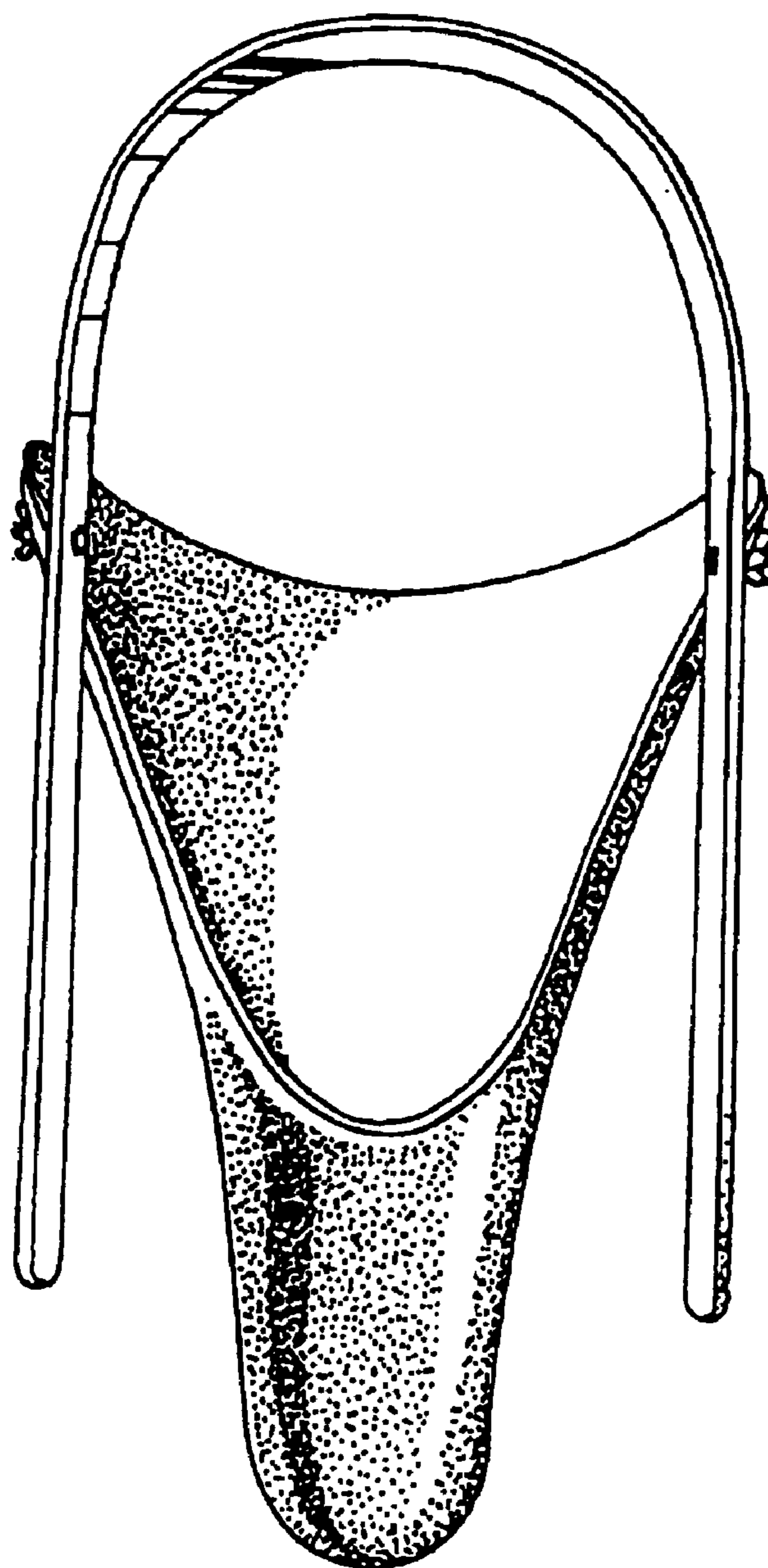

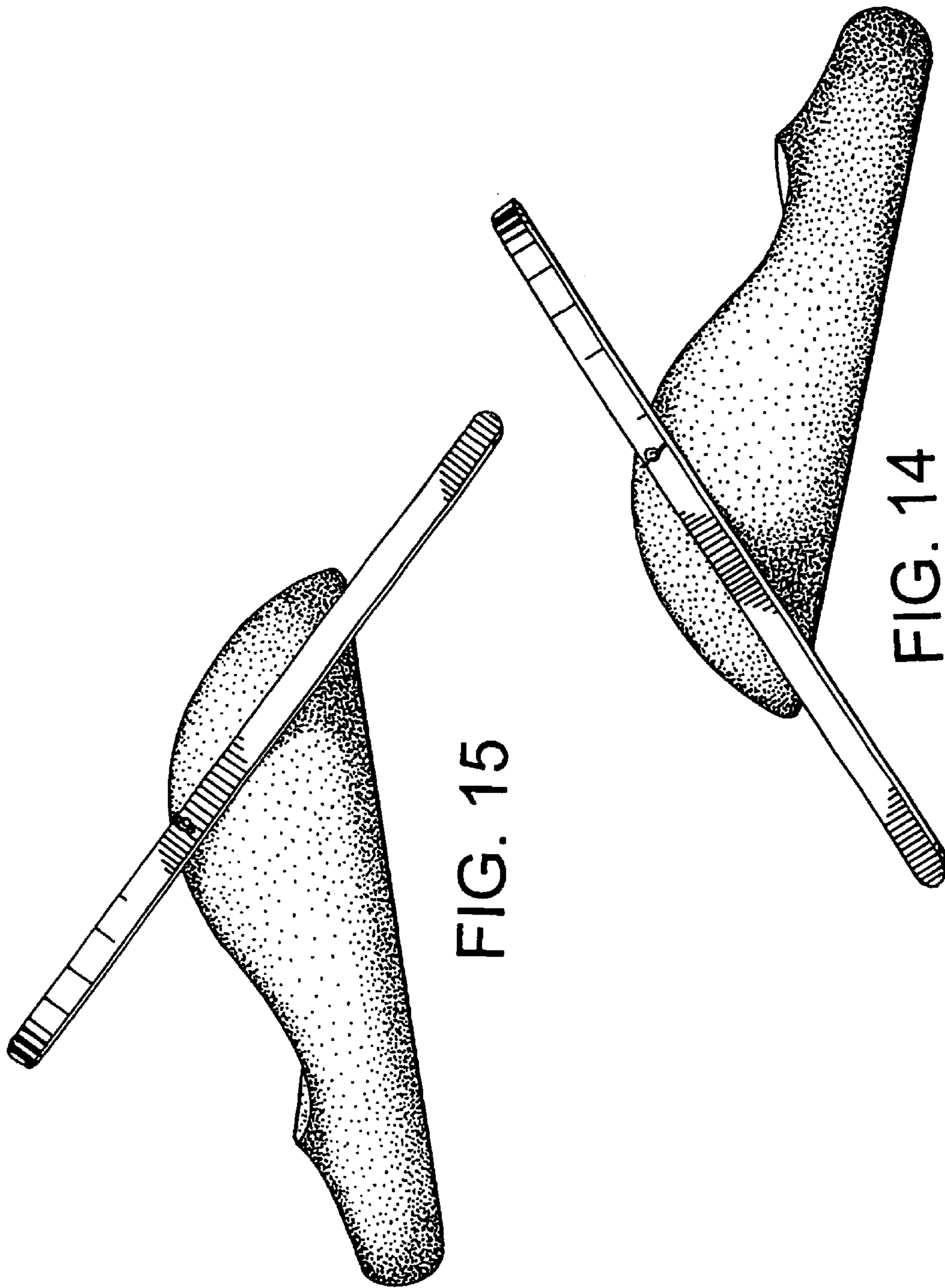

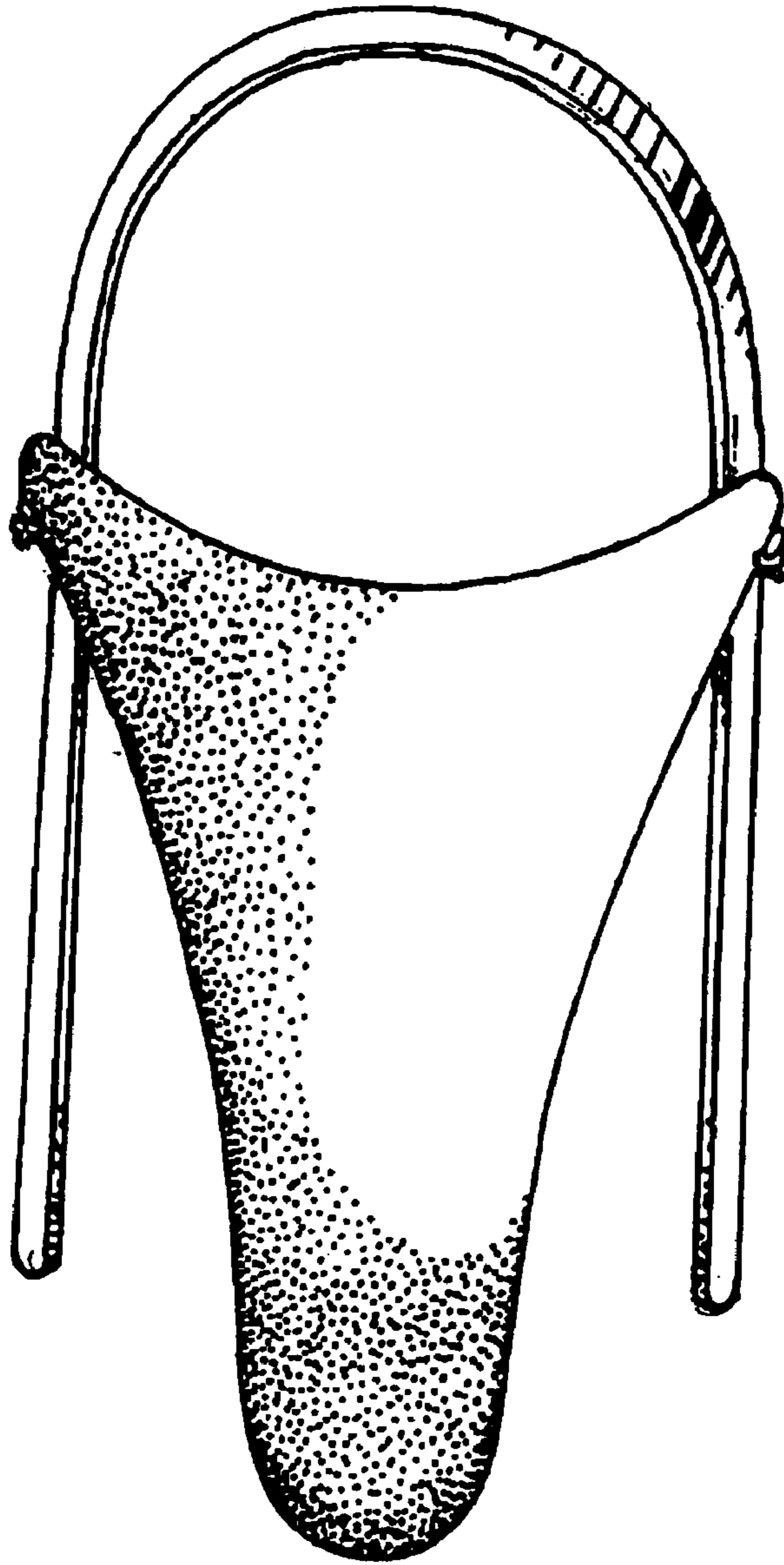

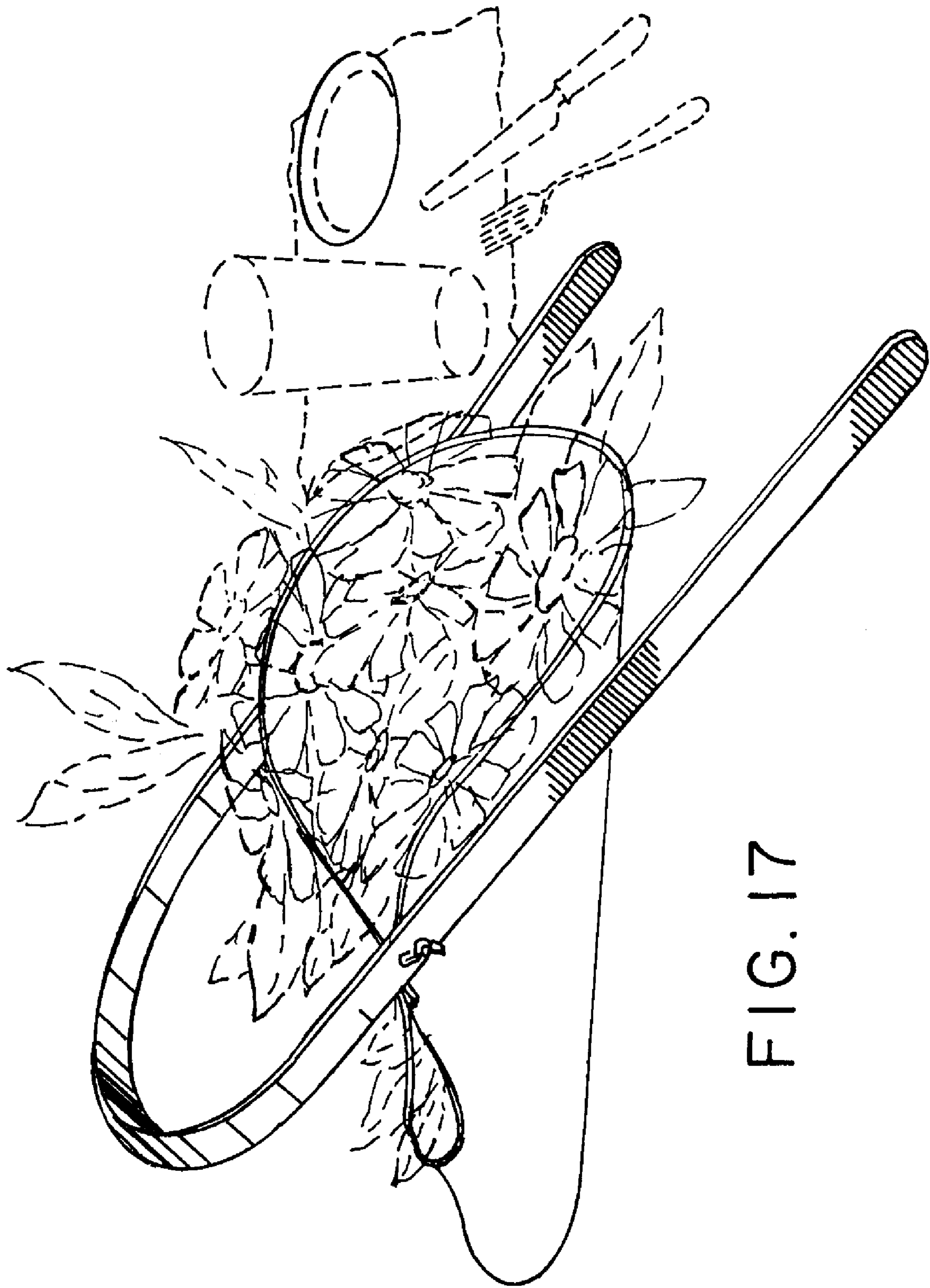
