(57) **CLAIM**

The ornamental design for a gazebo planter, as shown and described.

DESCRIPTION

FIG. 1 shows a perspective view of the gazebo planter of my claimed design;

FIG. 2 shows a front elevational view thereof, the opposite side being a mirror image thereof;

FIG. 3 shows a right side elevational view thereof, the left side being a mirror image thereof;

FIG. 4 shows a top plan view thereof; and,

FIG. 5 shows a bottom plan view thereof.

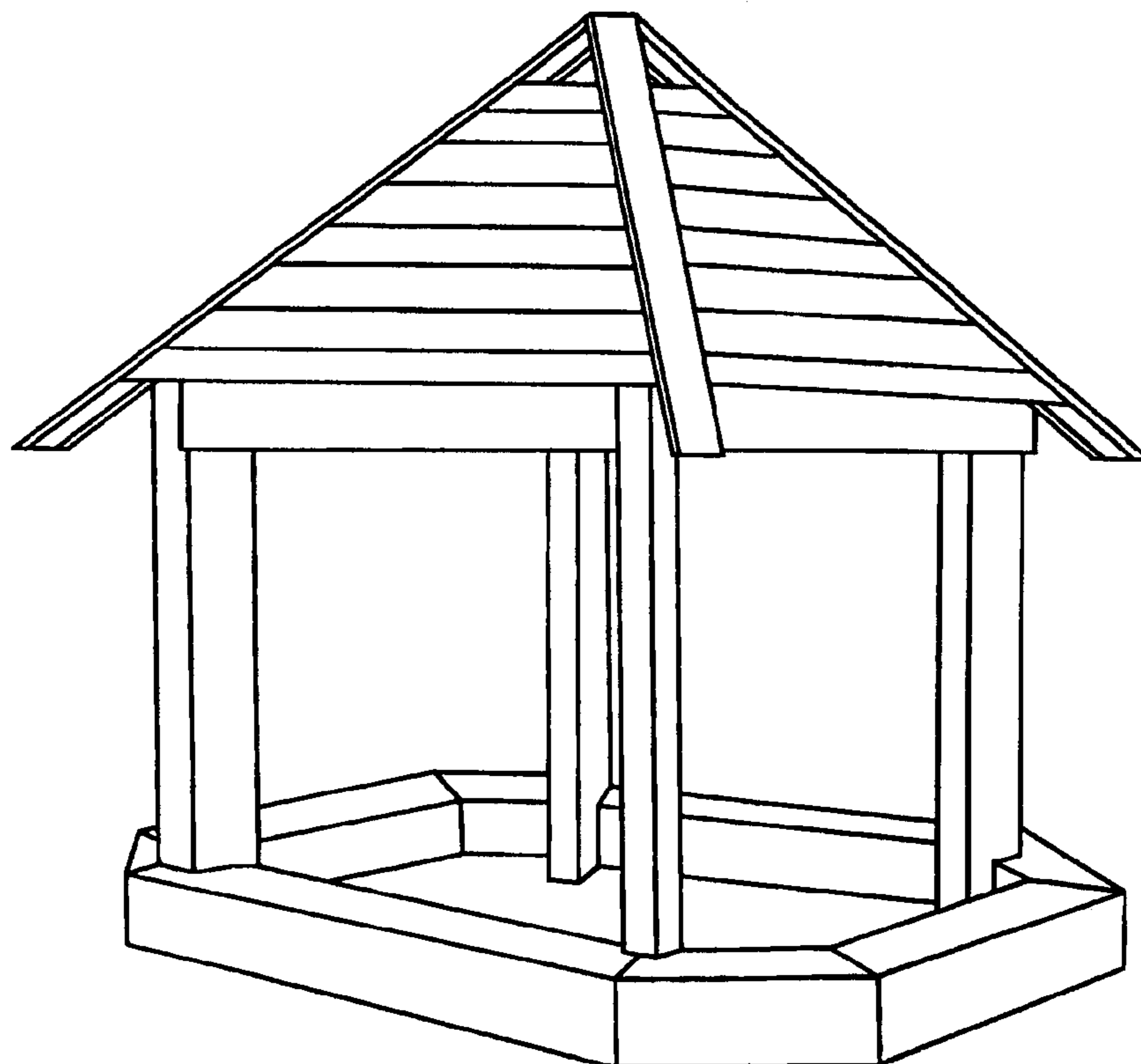

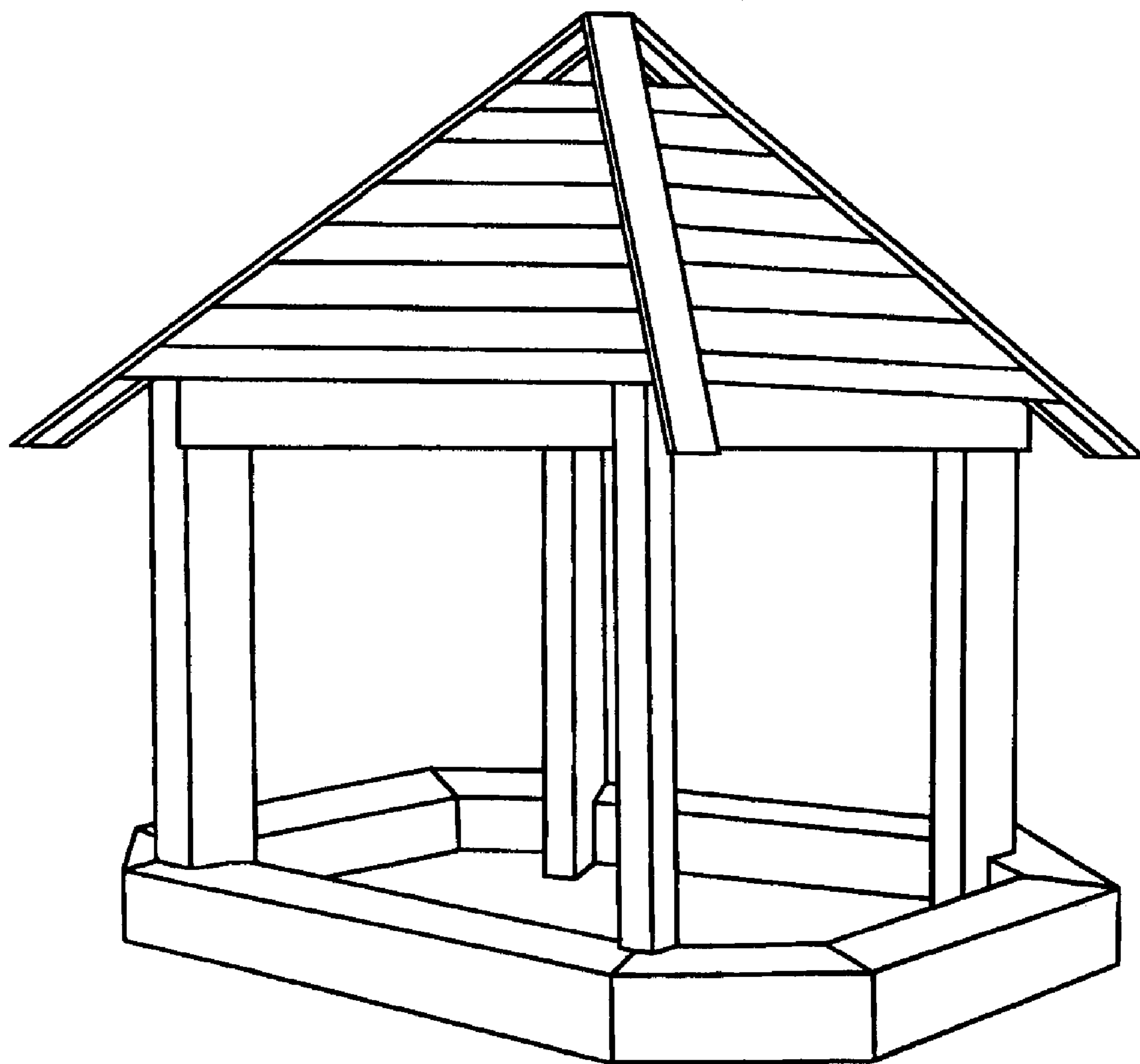

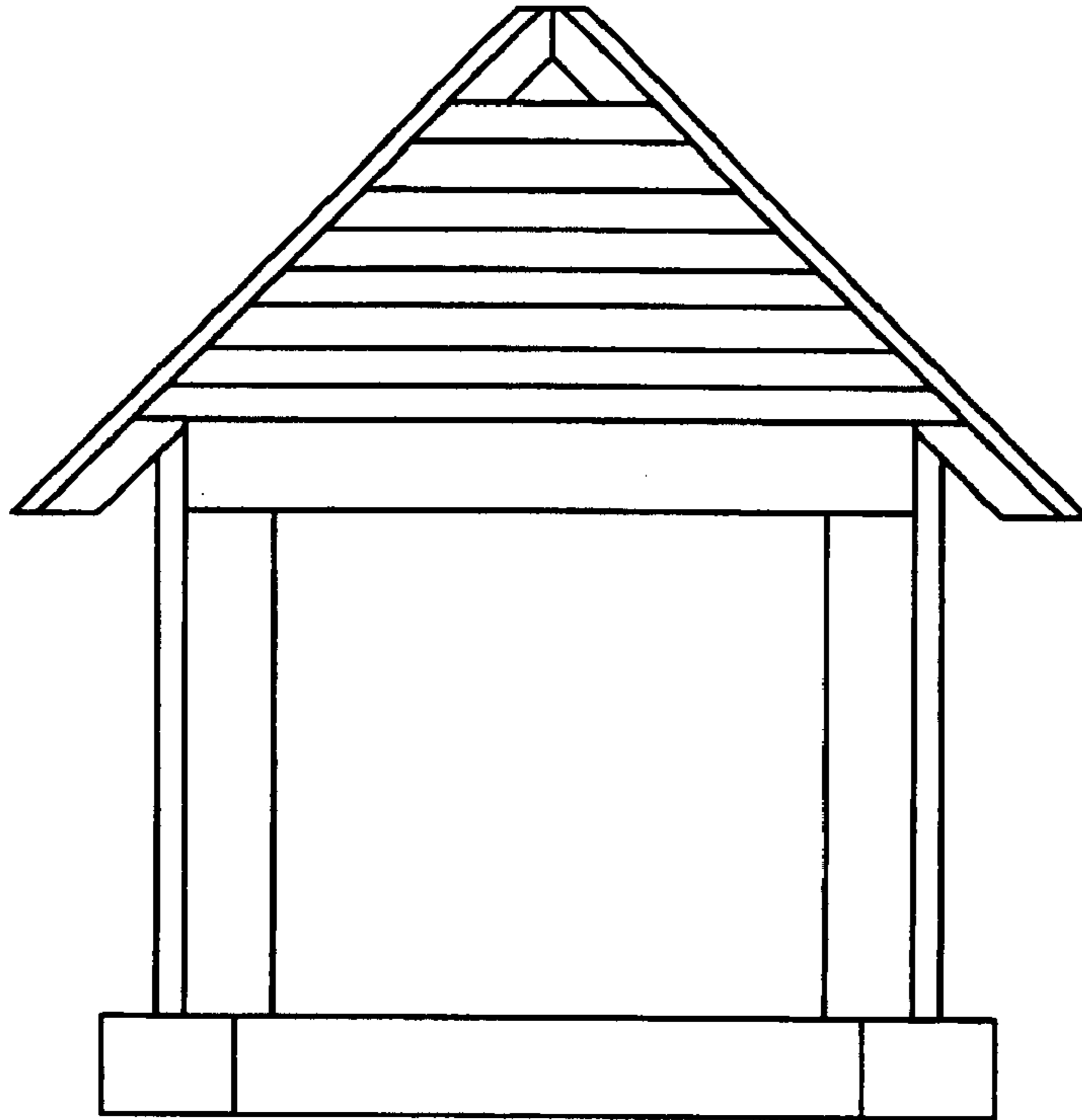

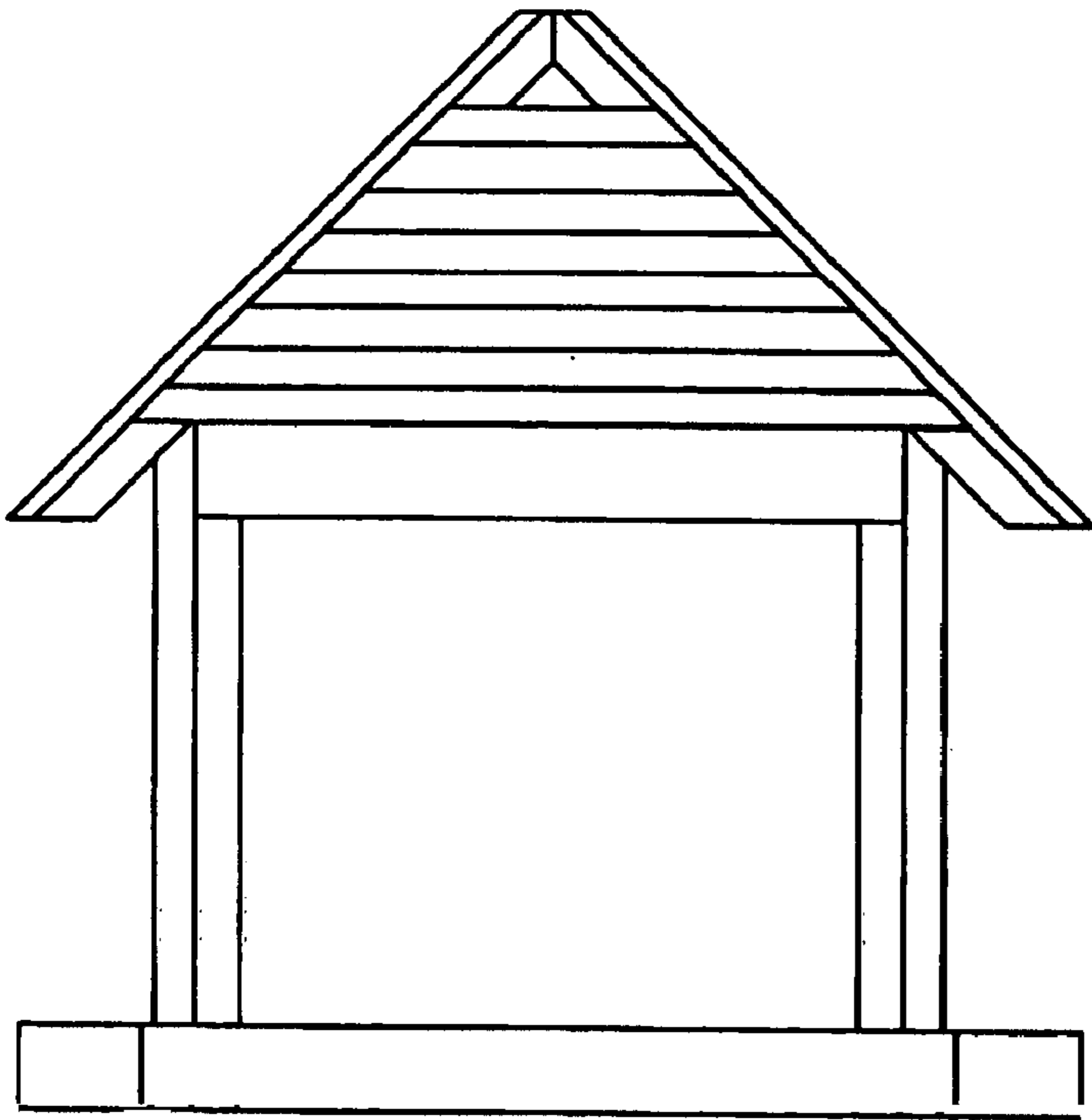

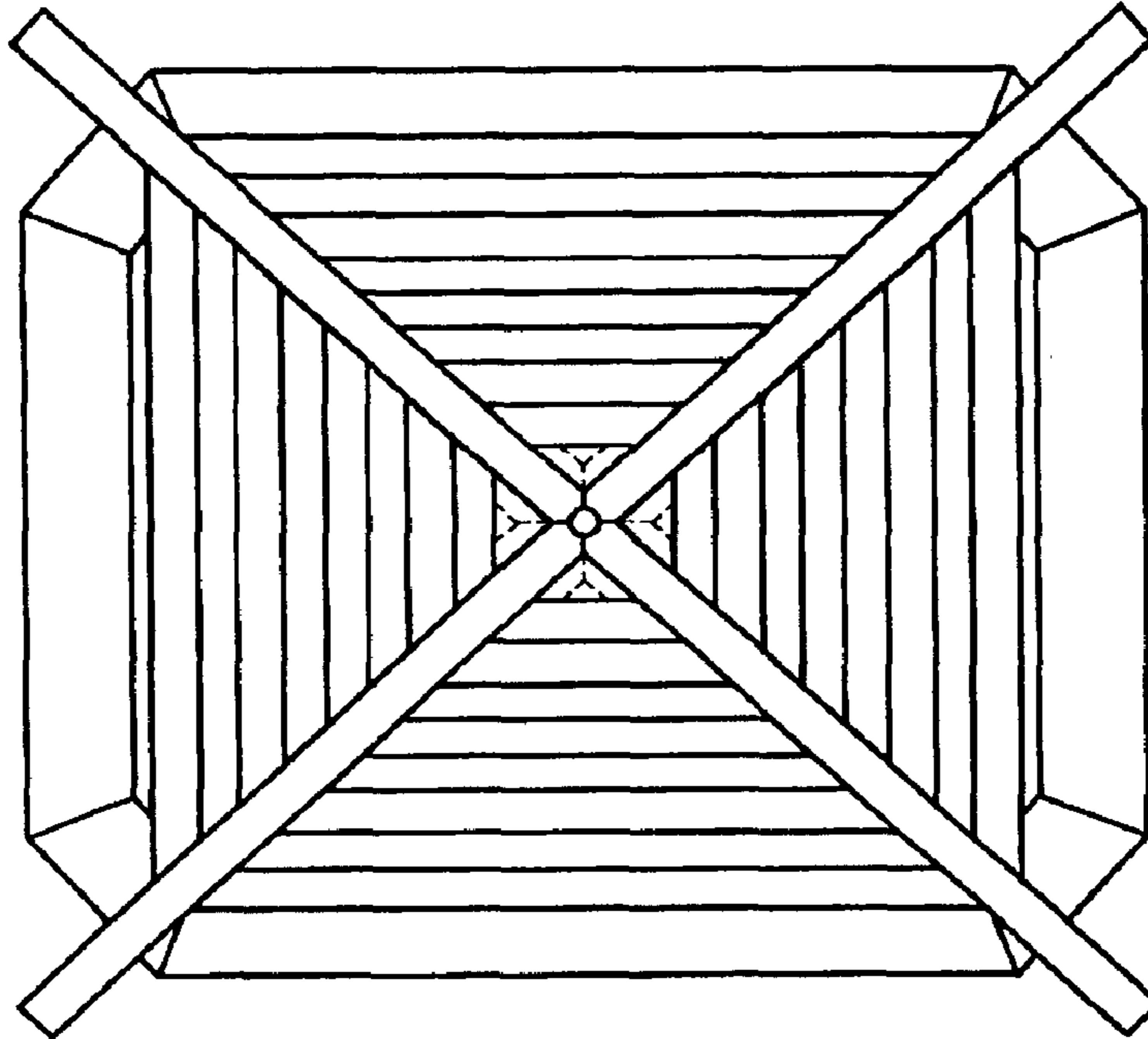
