**DESCRIPTION**

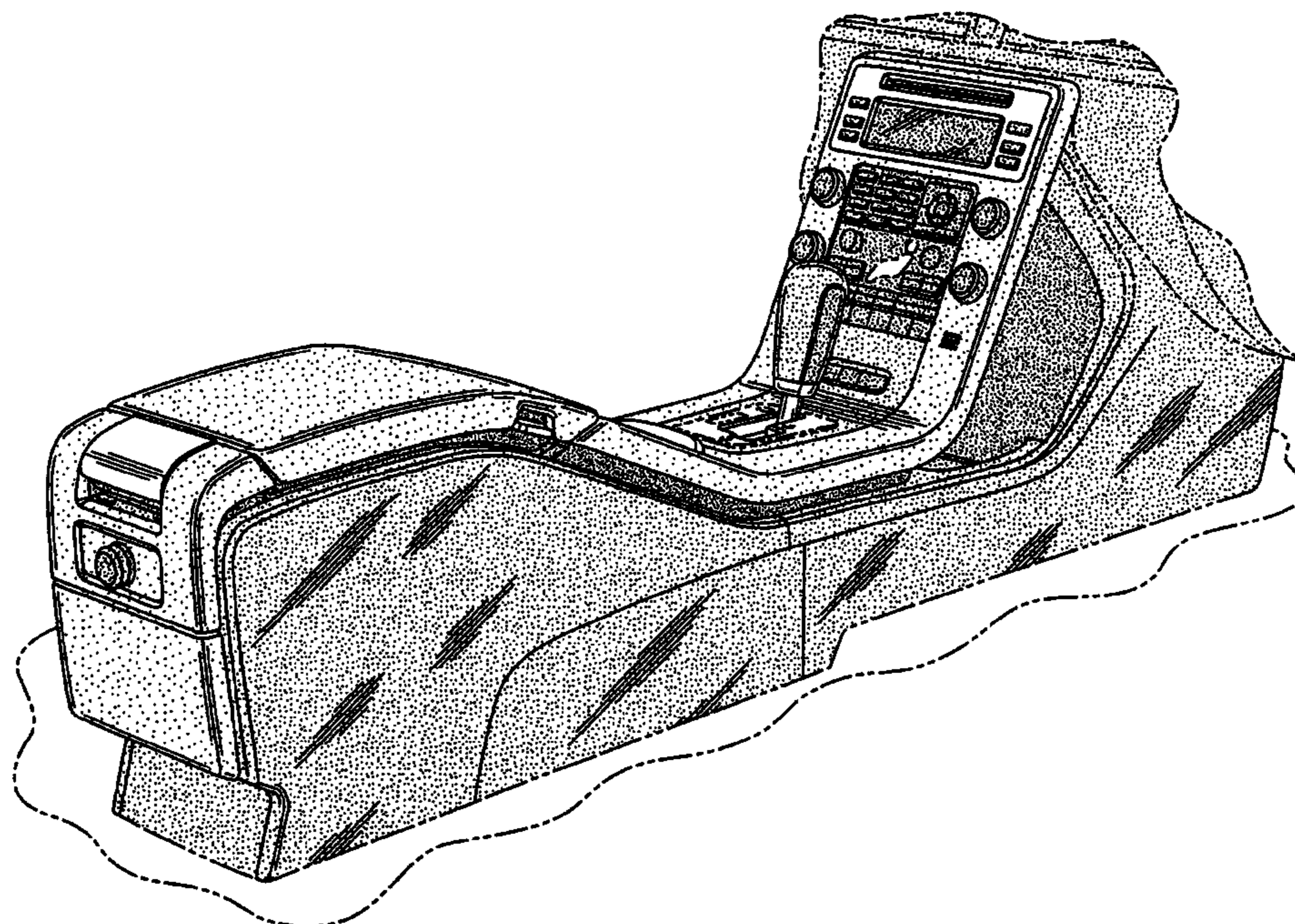
FIG. 1 is a perspective view of a center console in accordance with the present invention;

FIG. 2 is a right side perspective view of the center console of FIG. 1;

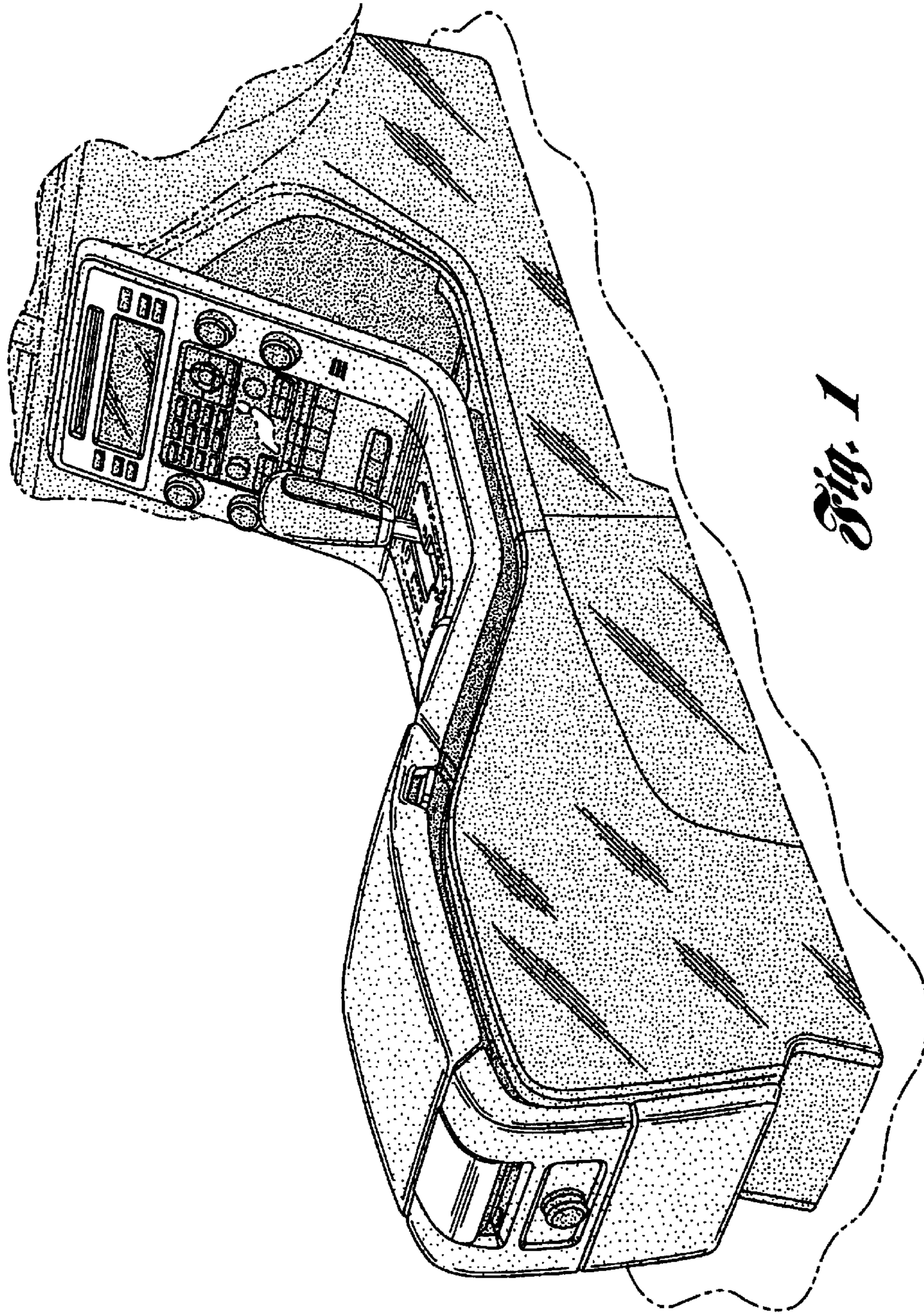
FIG. 3 is a top plan view of the center console of FIG. 1; and, FIG. 4 is a right side elevation view of the center console of FIG. 1.

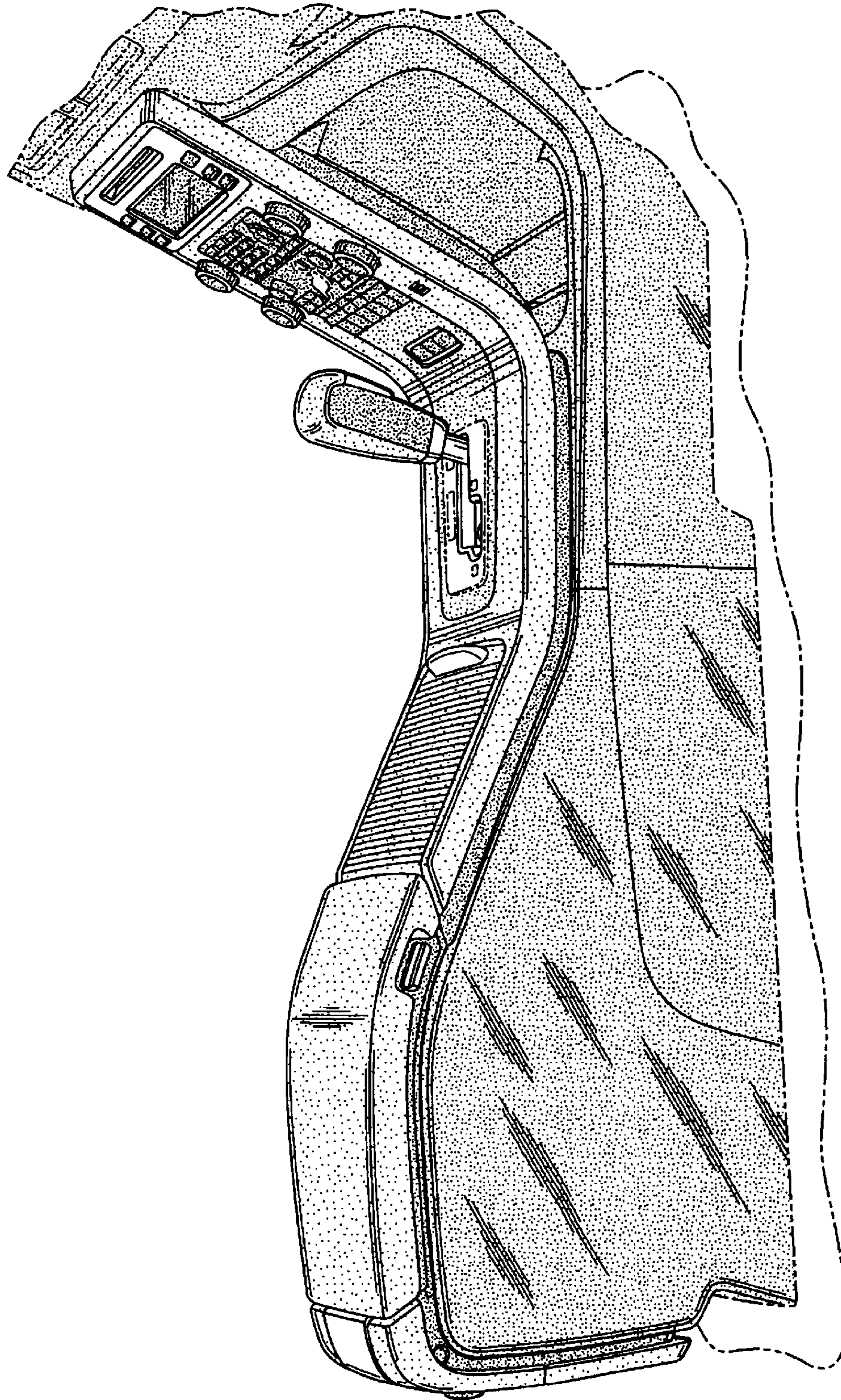




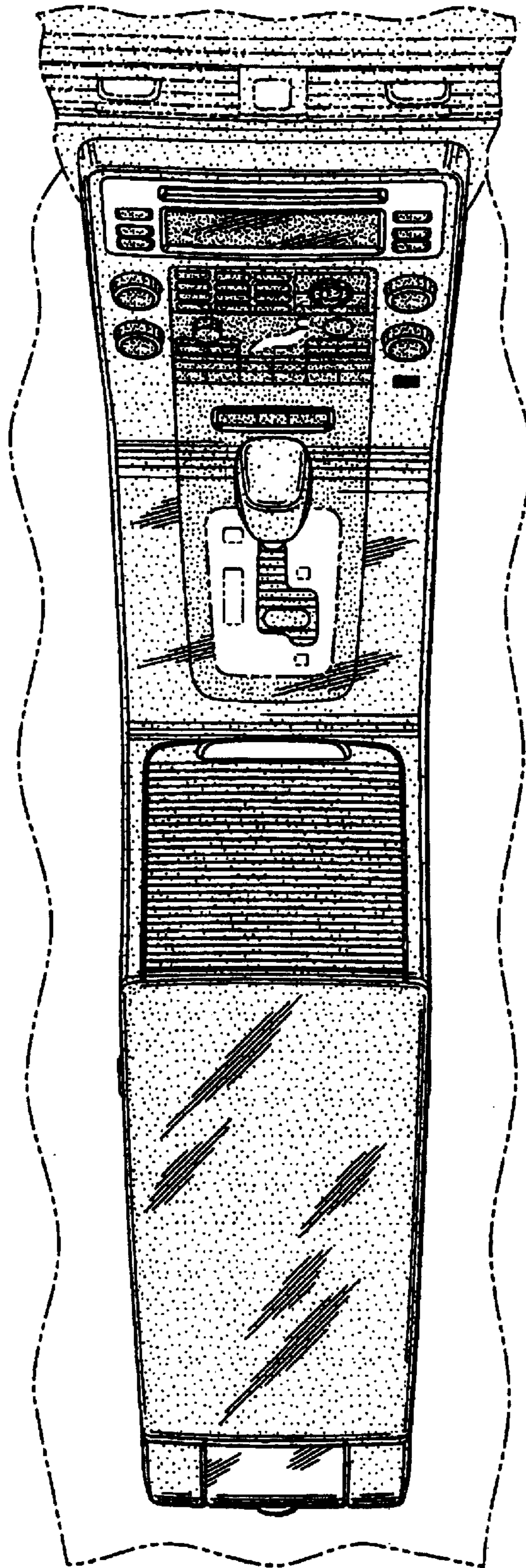

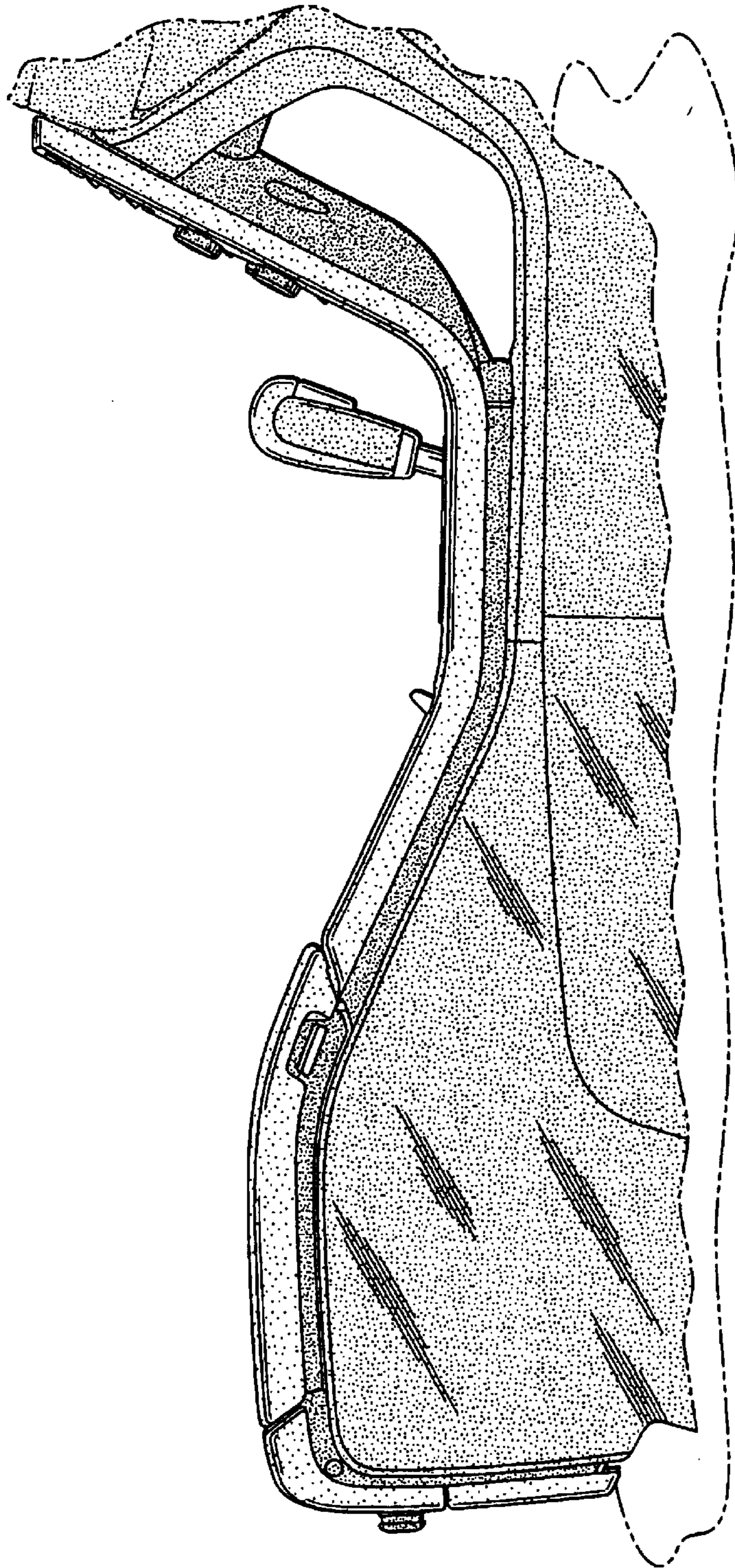
