DESCRIPTION

FIG. 1 is a front, top, right side perspective view of our new design for a small-sized motor;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a left side elevation view thereof; and,

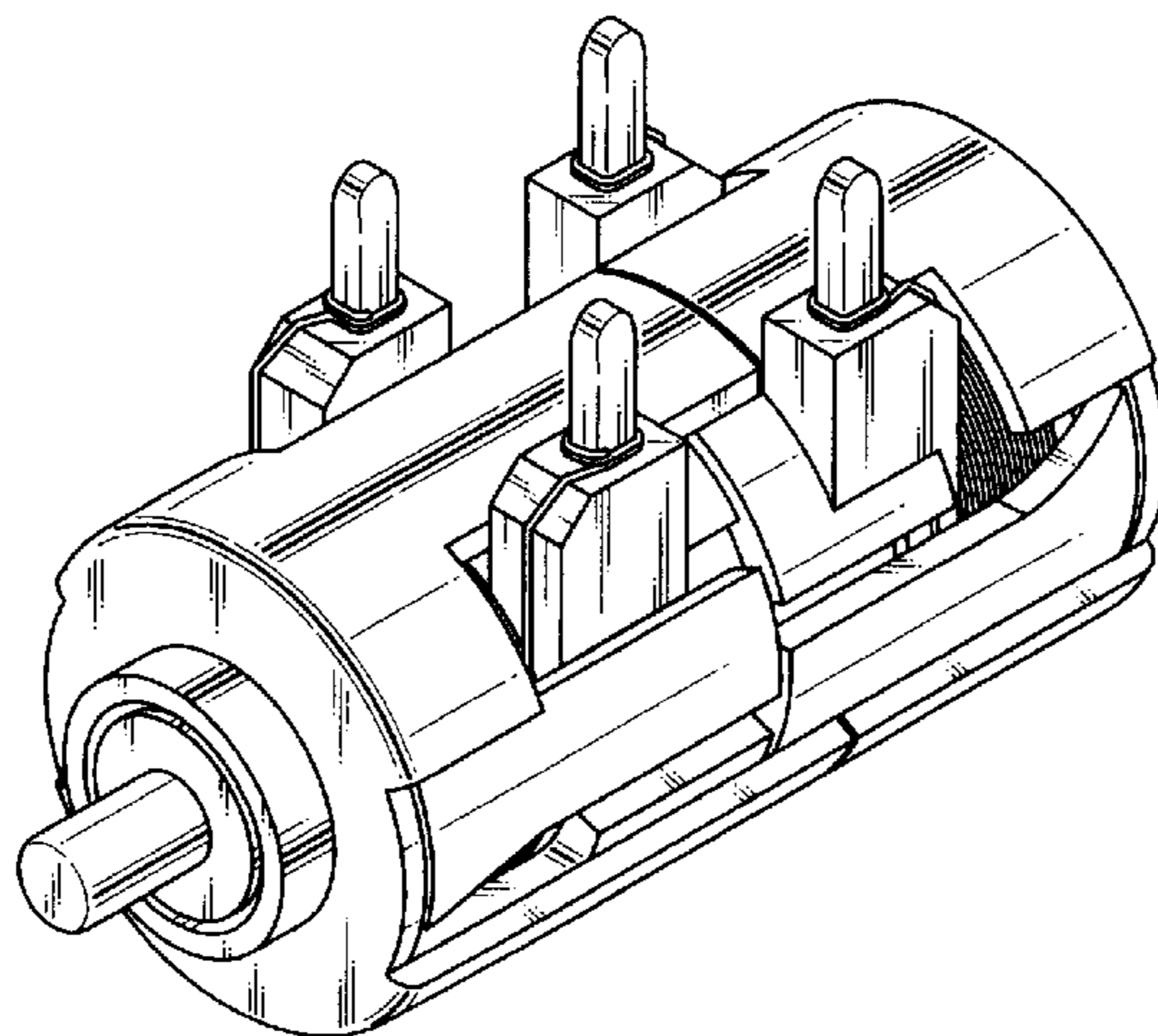

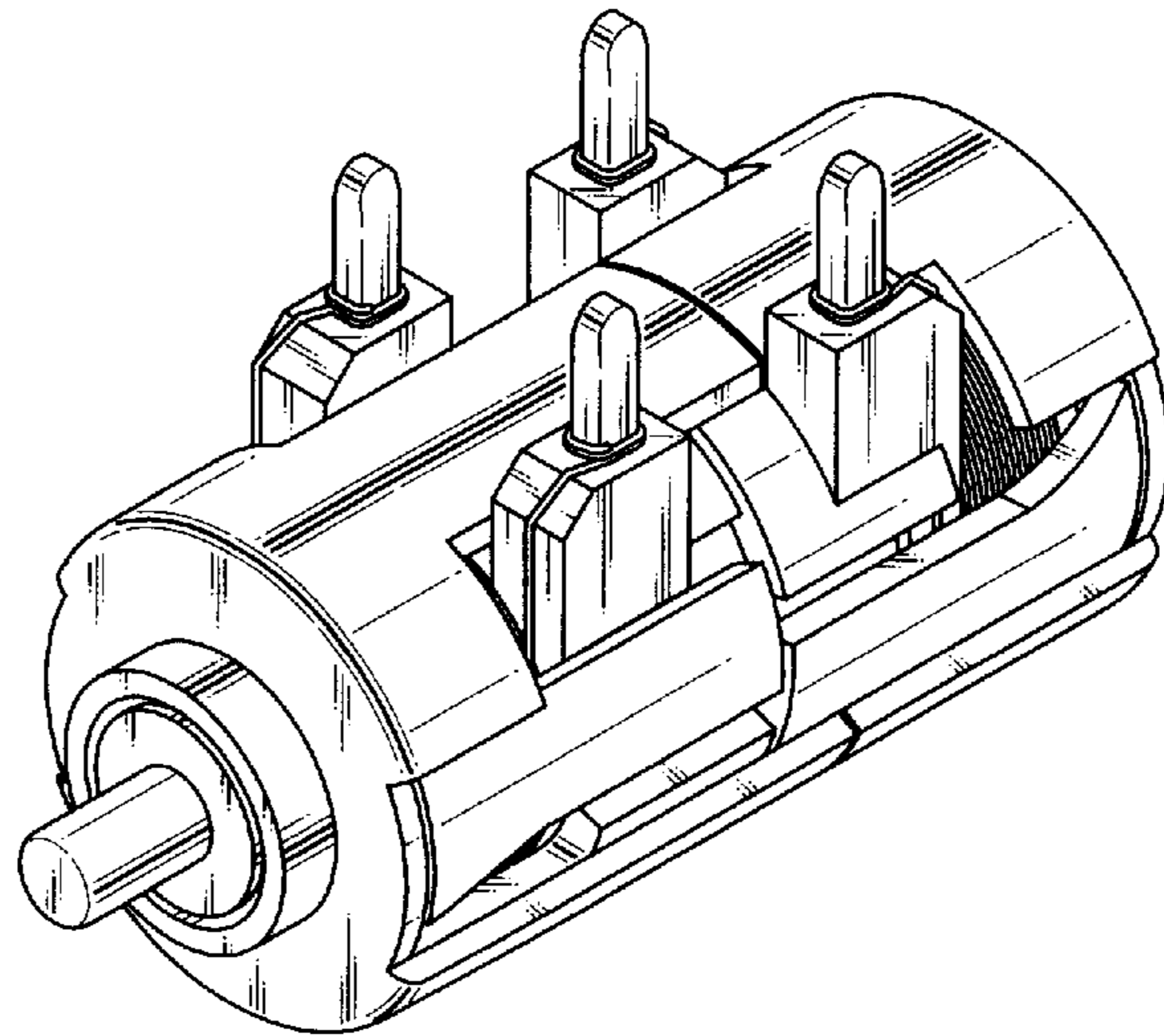

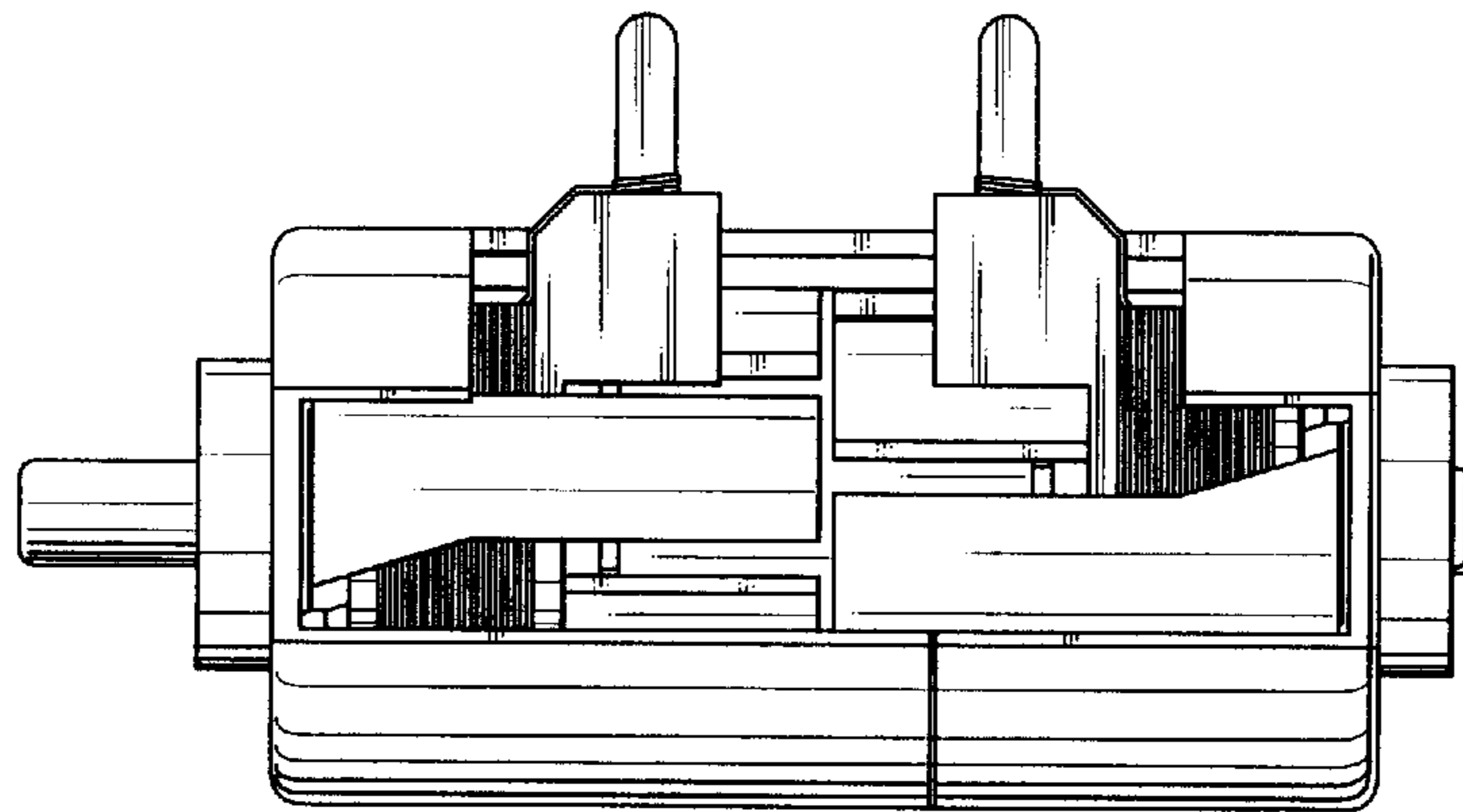

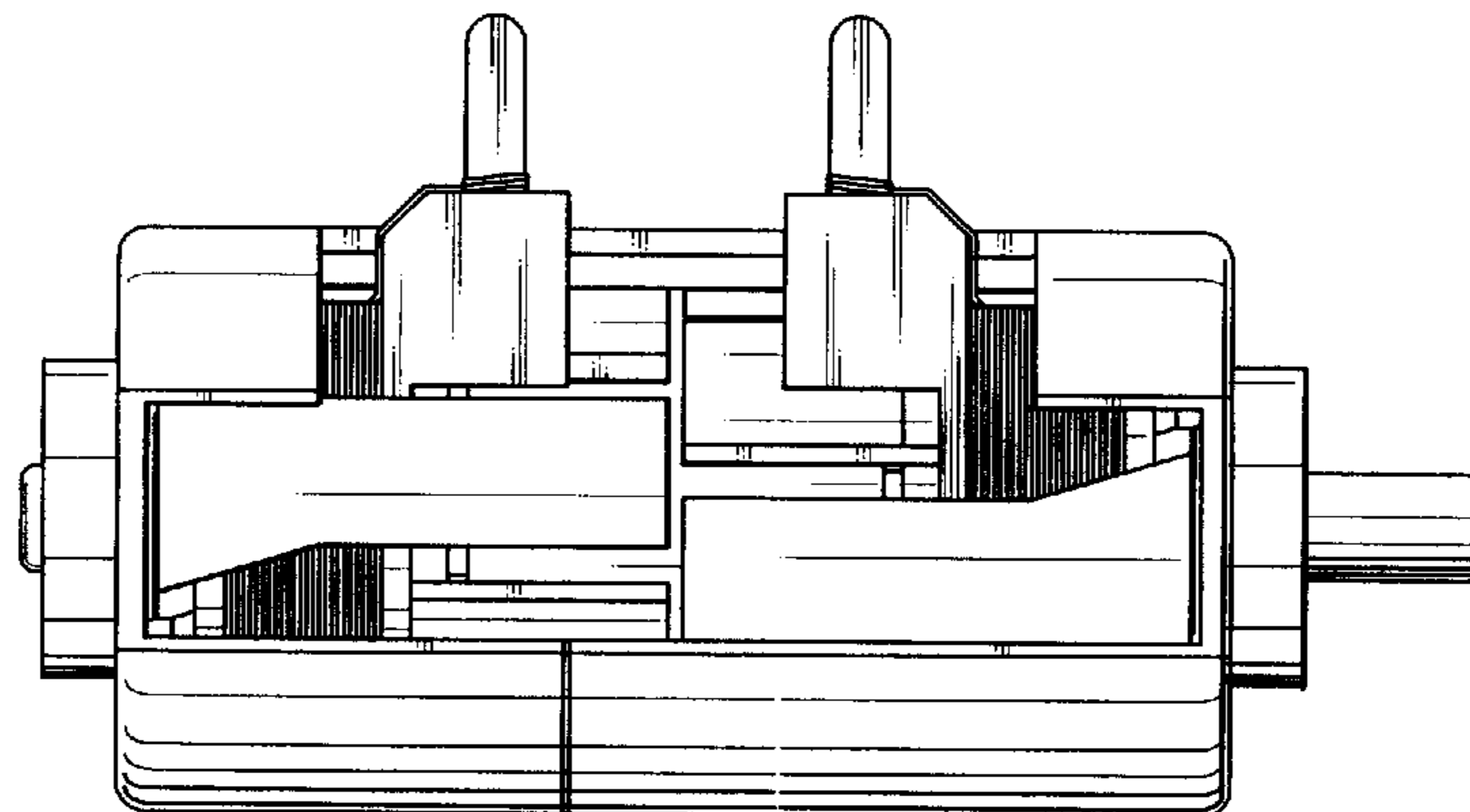

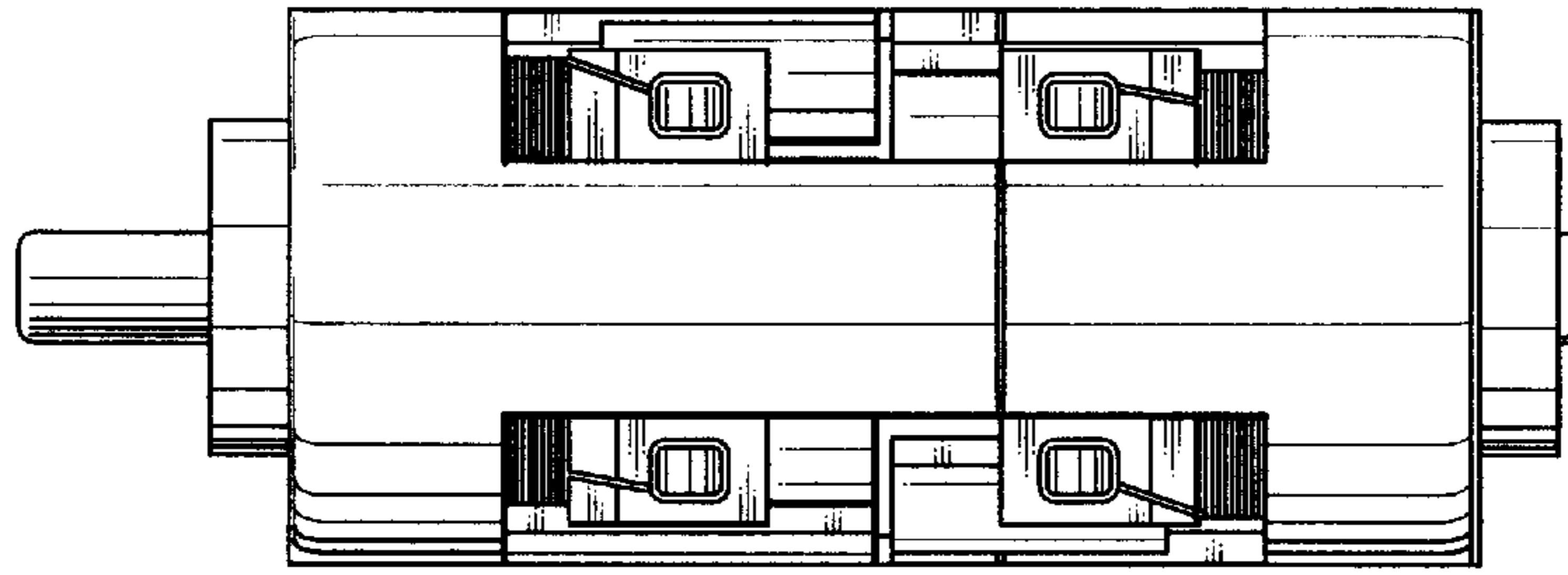

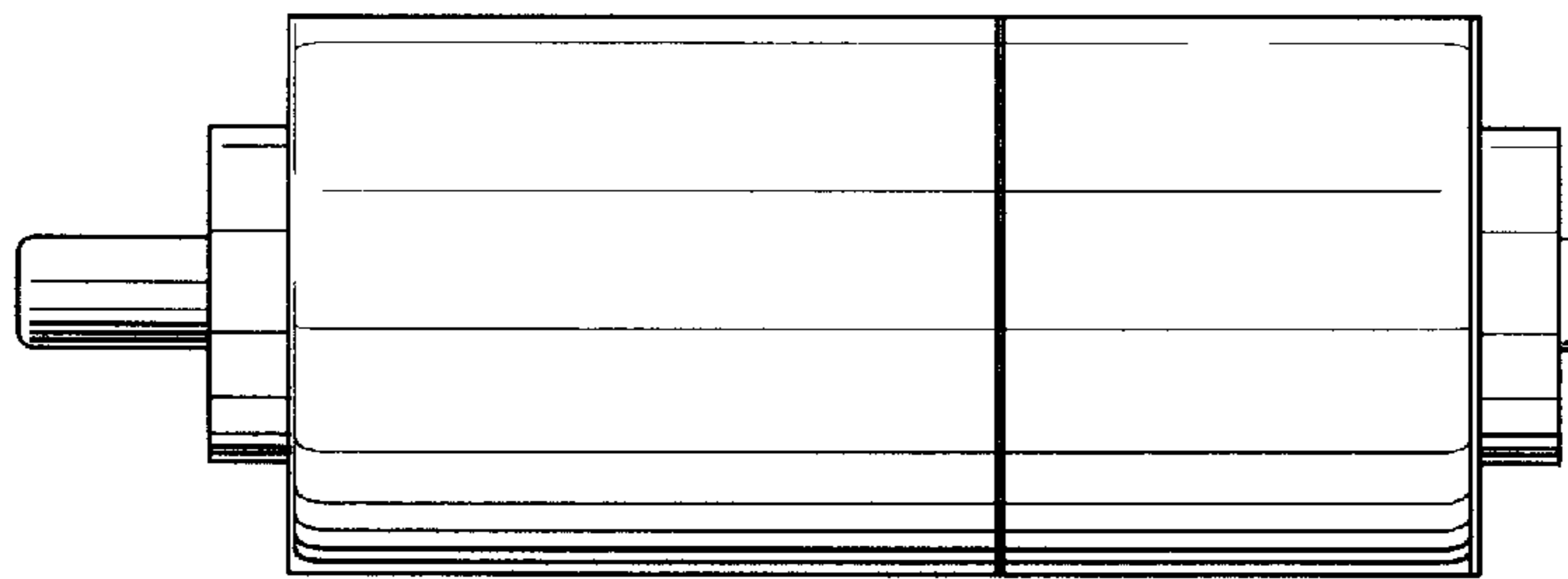

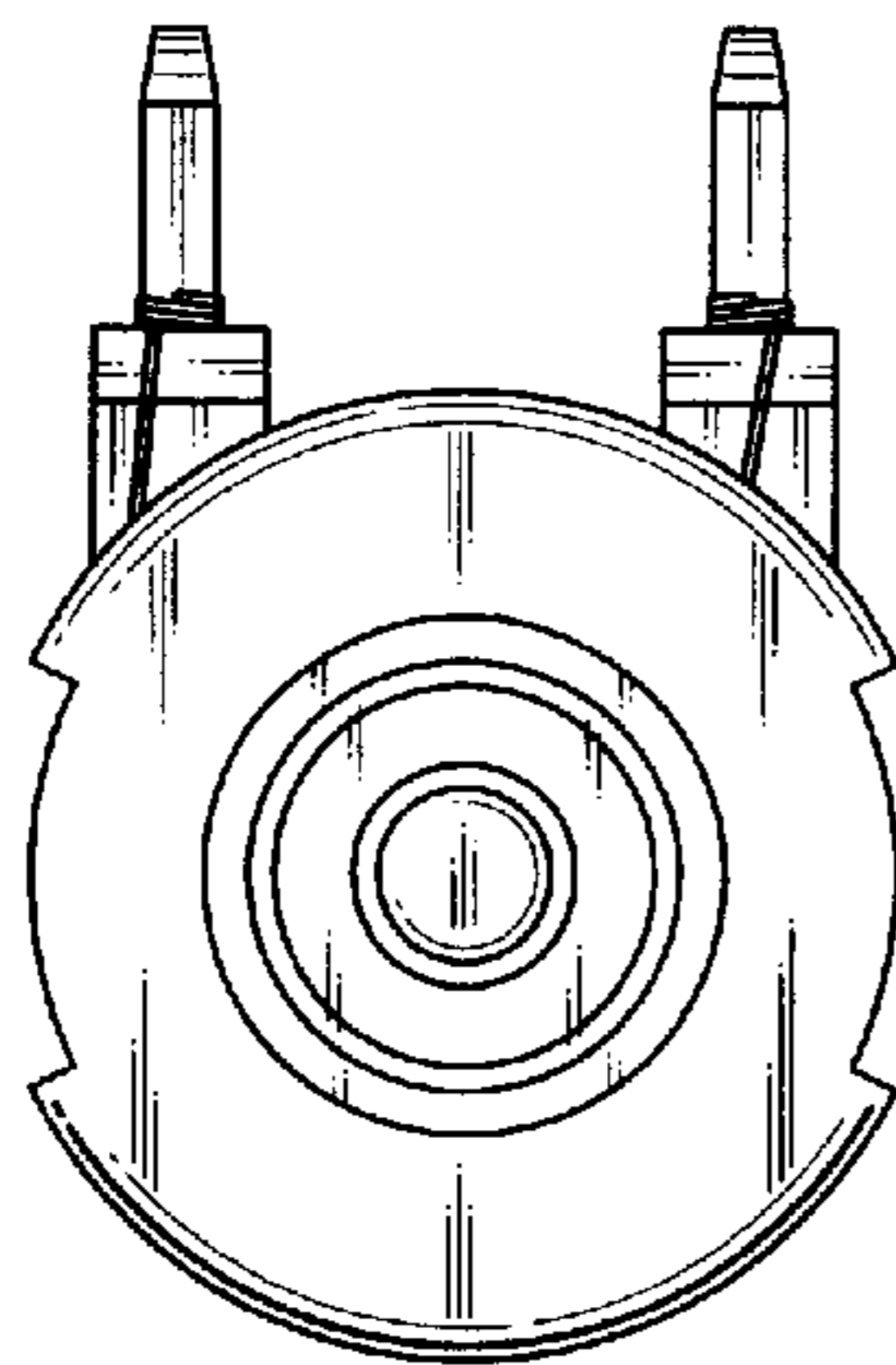
