(57) **CLAIM**

The ornamental design for a remote controller for digital audio players, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front left perspective view of a remote controller for digital audio players showing our new design; FIG. 2 is a front elevational view thereof, FIG. 3 is a rear elevational view thereof, FIG. 4 is a left side elevational view thereof, FIG. 5 is a right side elevational view thereof, FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

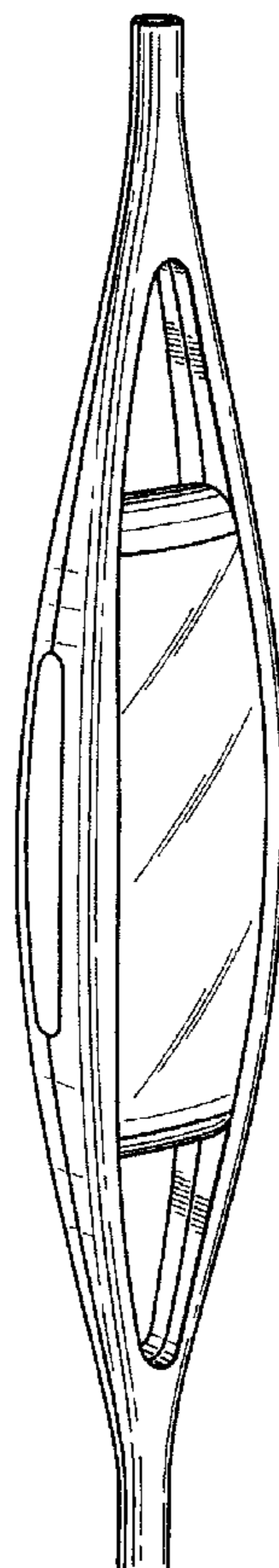

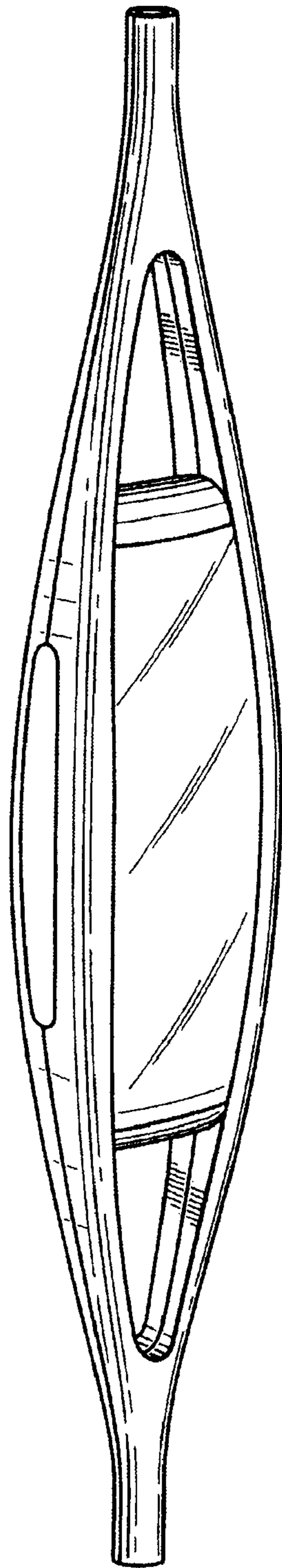

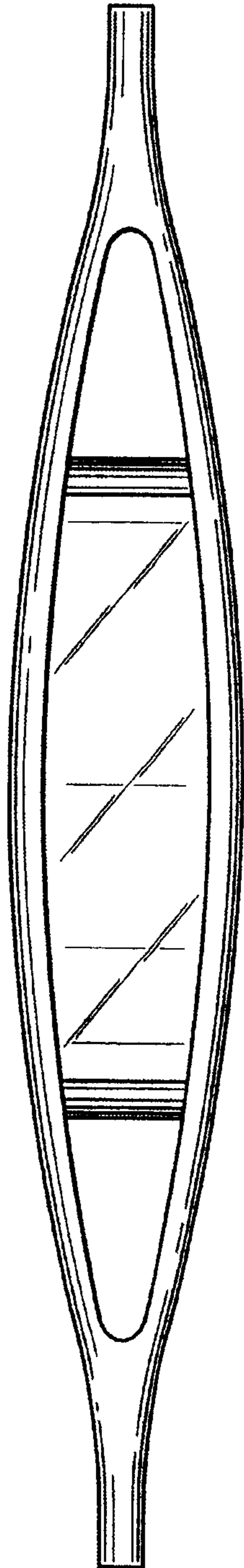

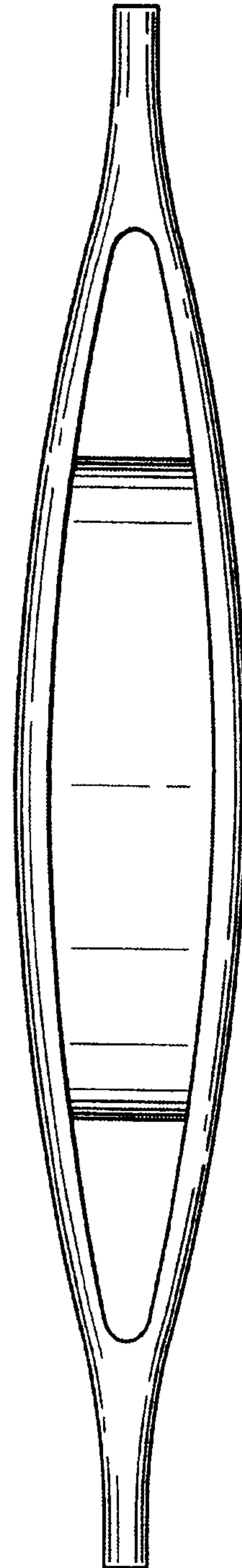

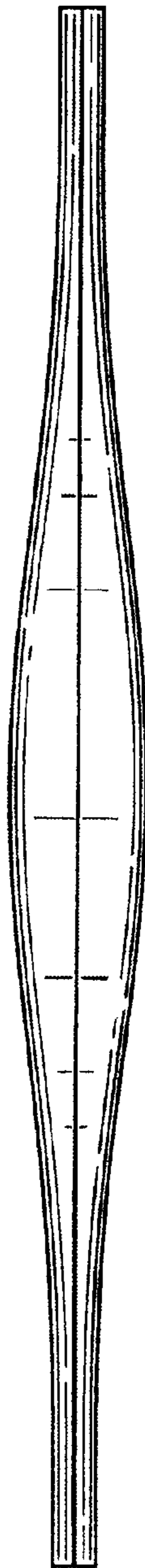

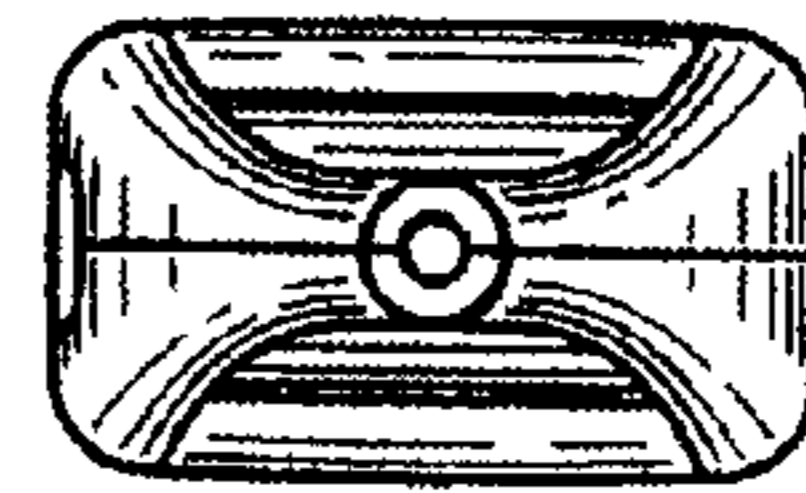
