We claim the ornamental design for a multimedia computer, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side perspective view of an embodiment of the multimedia computer with front door panels in an open position;

FIG. 2 is a front elevational view of the FIG. 1 embodiment;

FIG. 3 is a rear elevational view of the FIG. 1 embodiment;

FIG. 4 is a top plan view of the FIG. 1 embodiment;

FIG. 5 is a right side elevational view of the FIG. 1 embodiment;

FIG. 6 is a left side elevational view of the FIG. 1 embodiment;

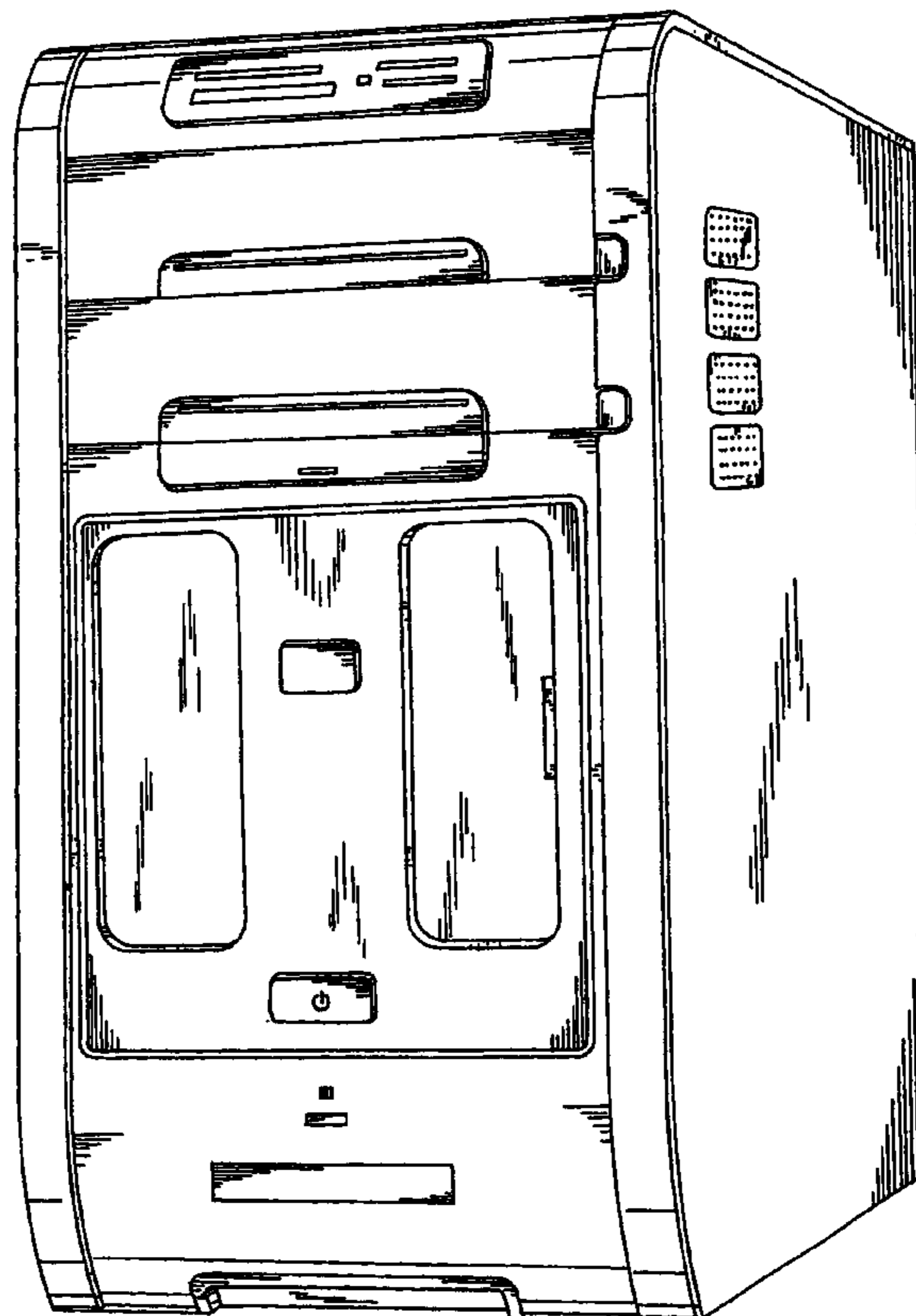
FIG. 7 a bottom plan view of the FIG. 1 embodiment;

FIG. 8 is a top plan view of the FIG. 1 embodiment with a door on the upper surface in an open position; and,

FIG. 9 is a front right side perspective view of the FIG. 1 embodiment with front door panels in a closed position.

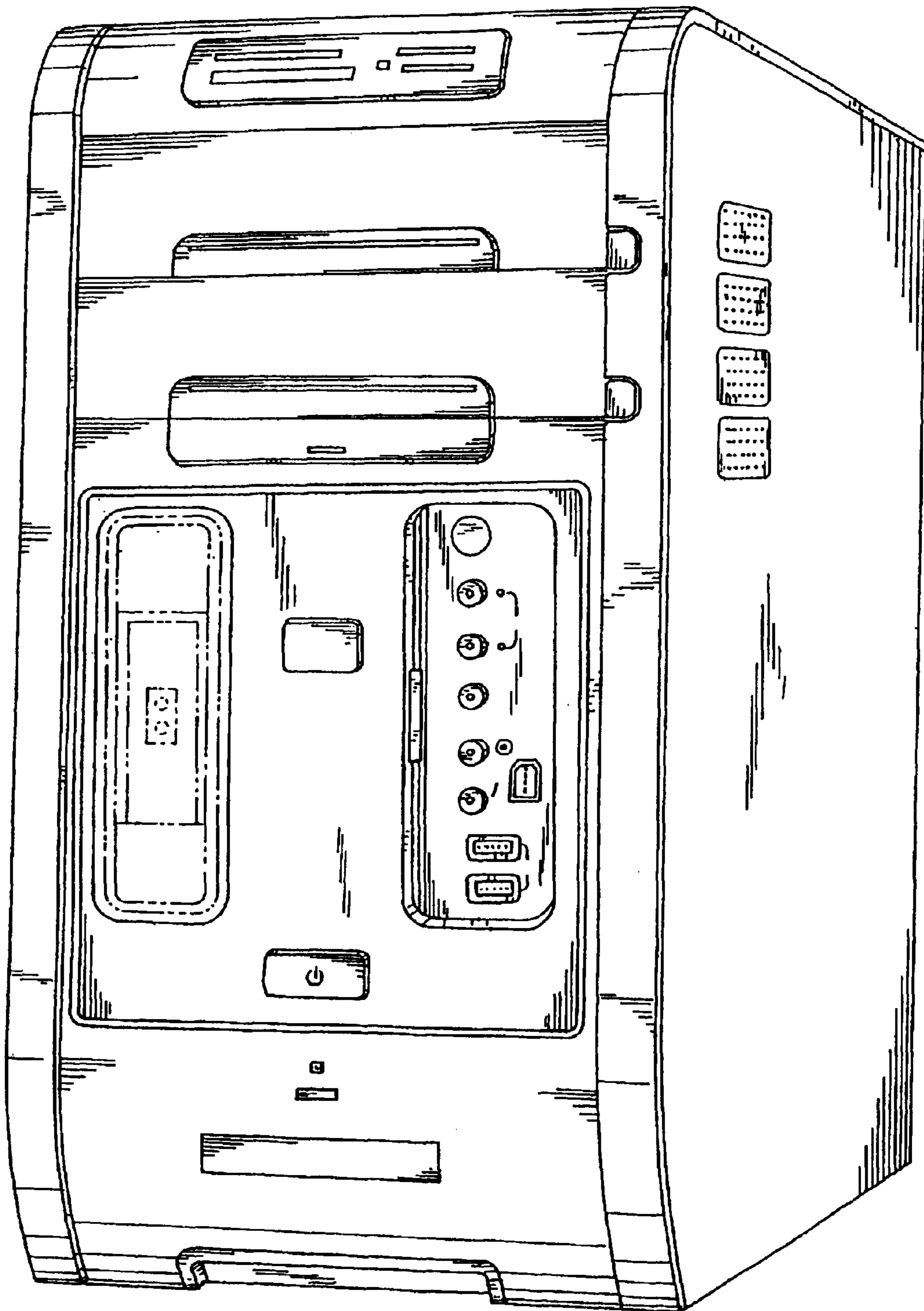

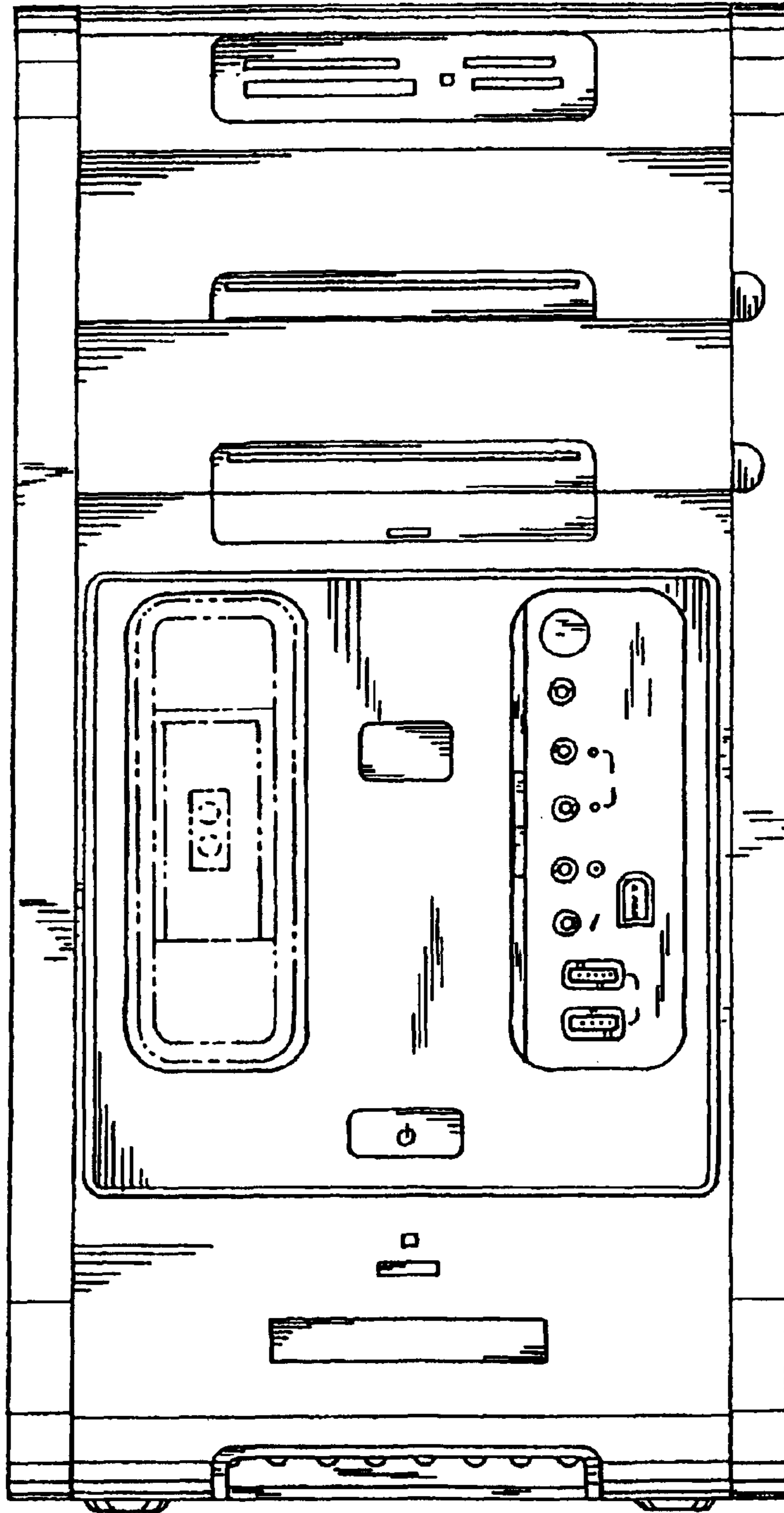

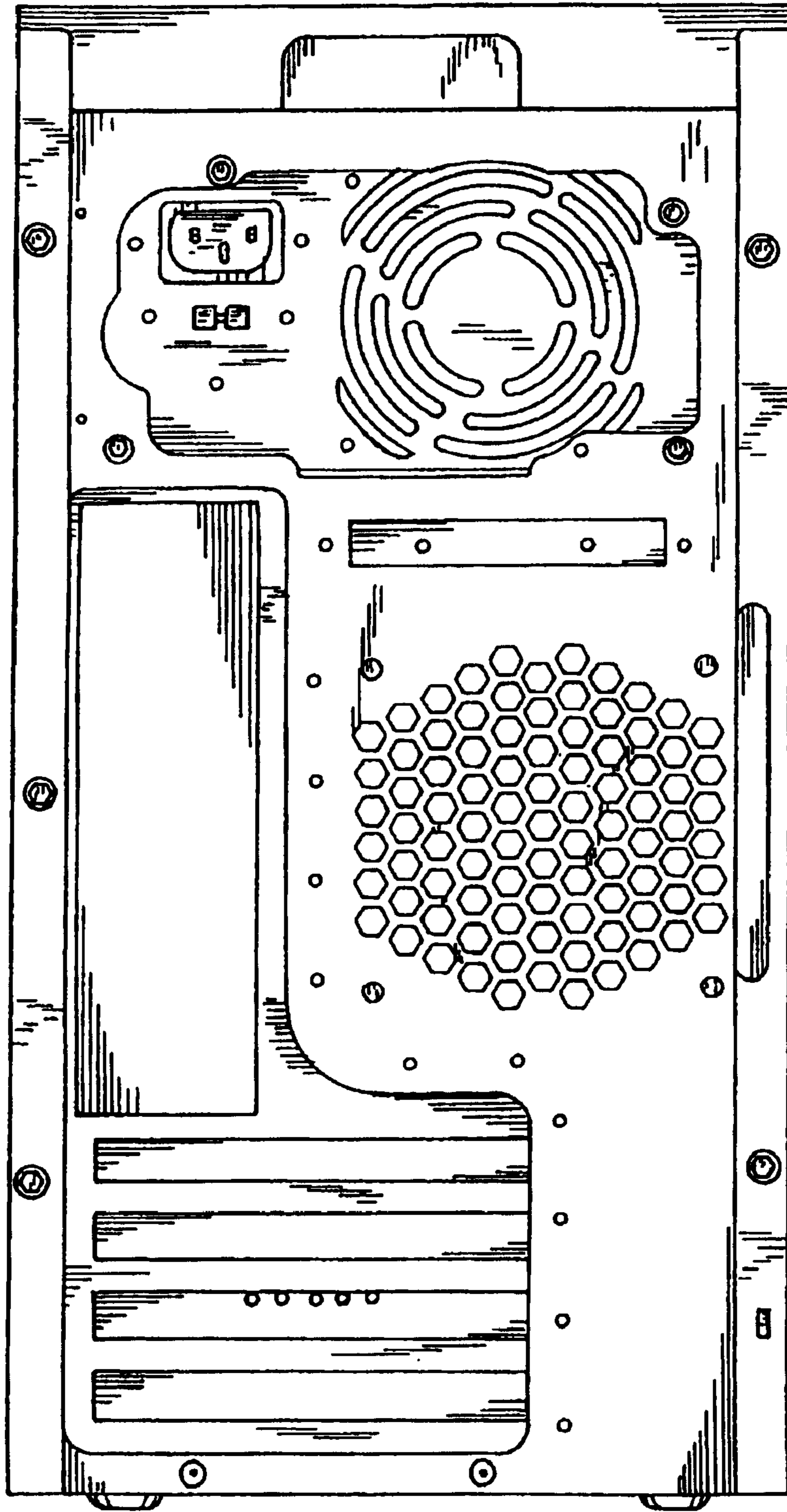

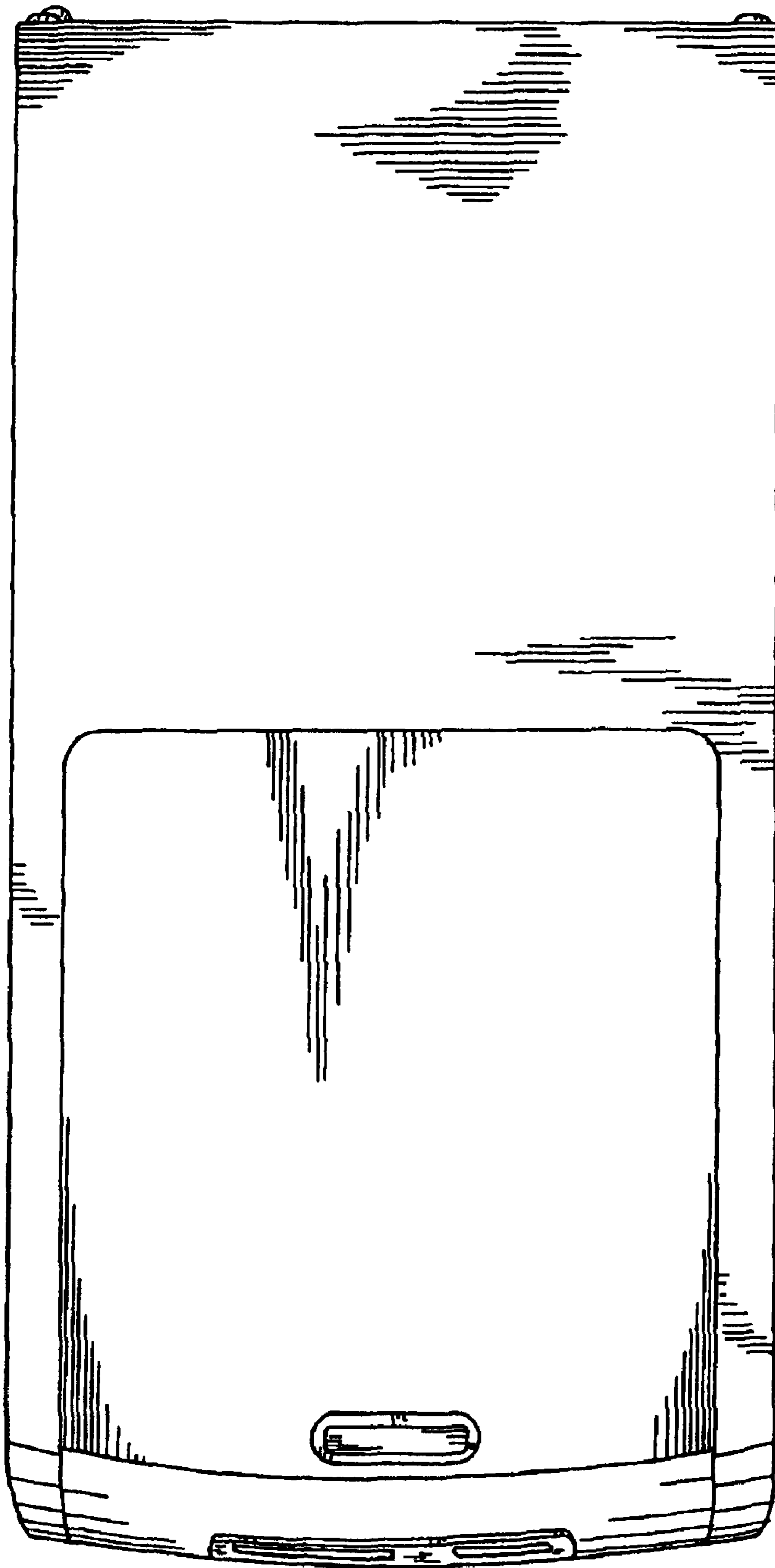

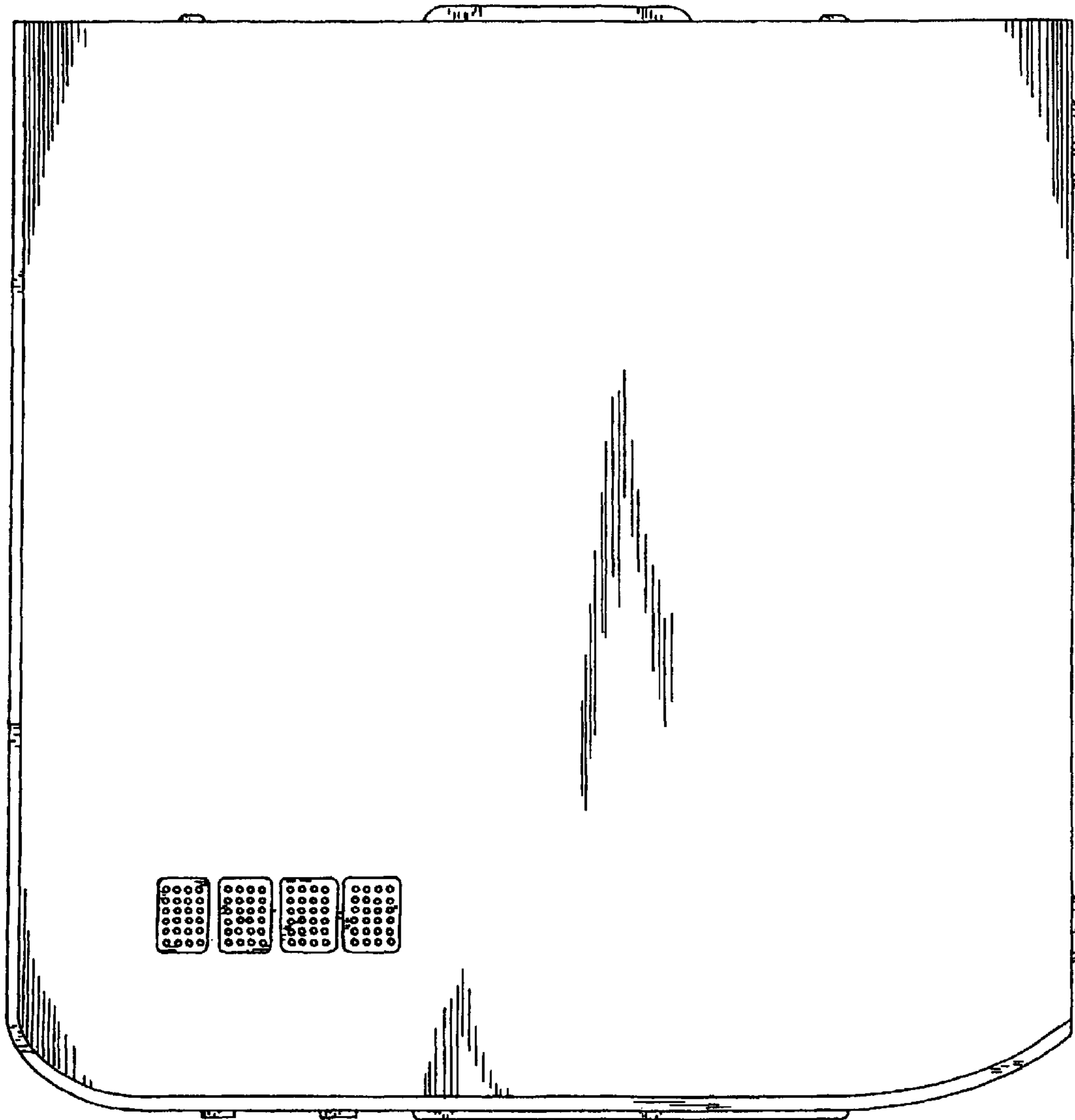

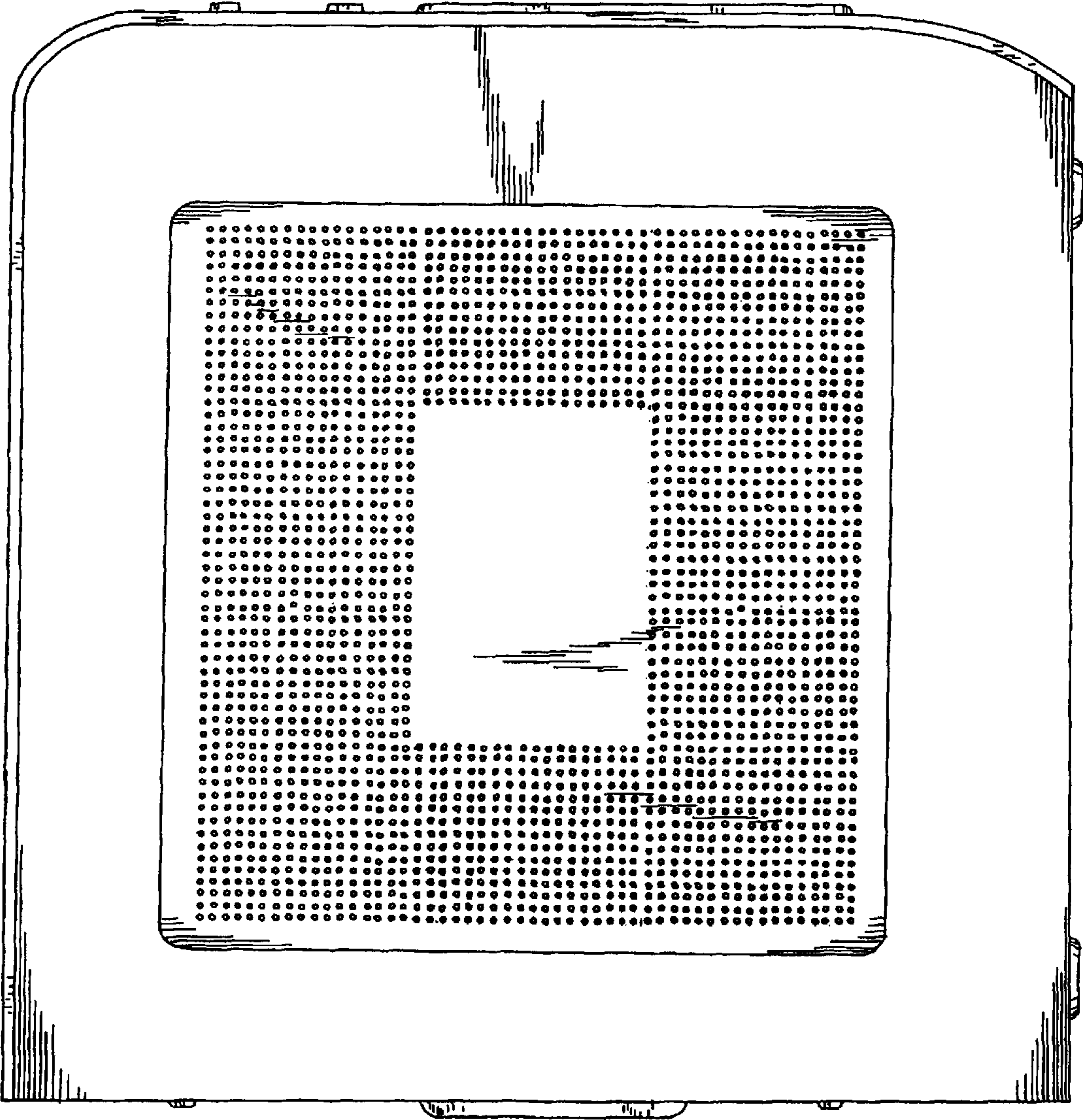

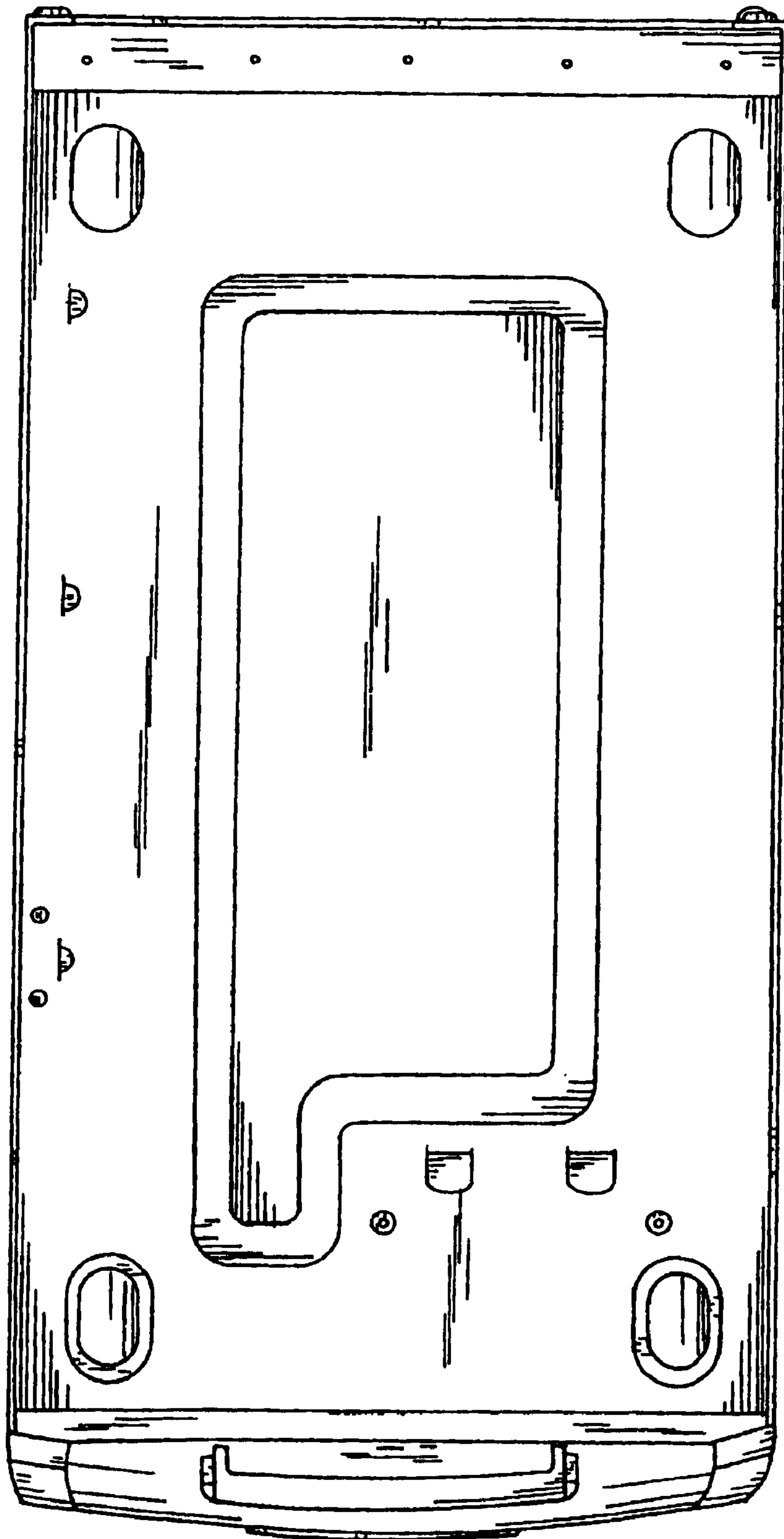

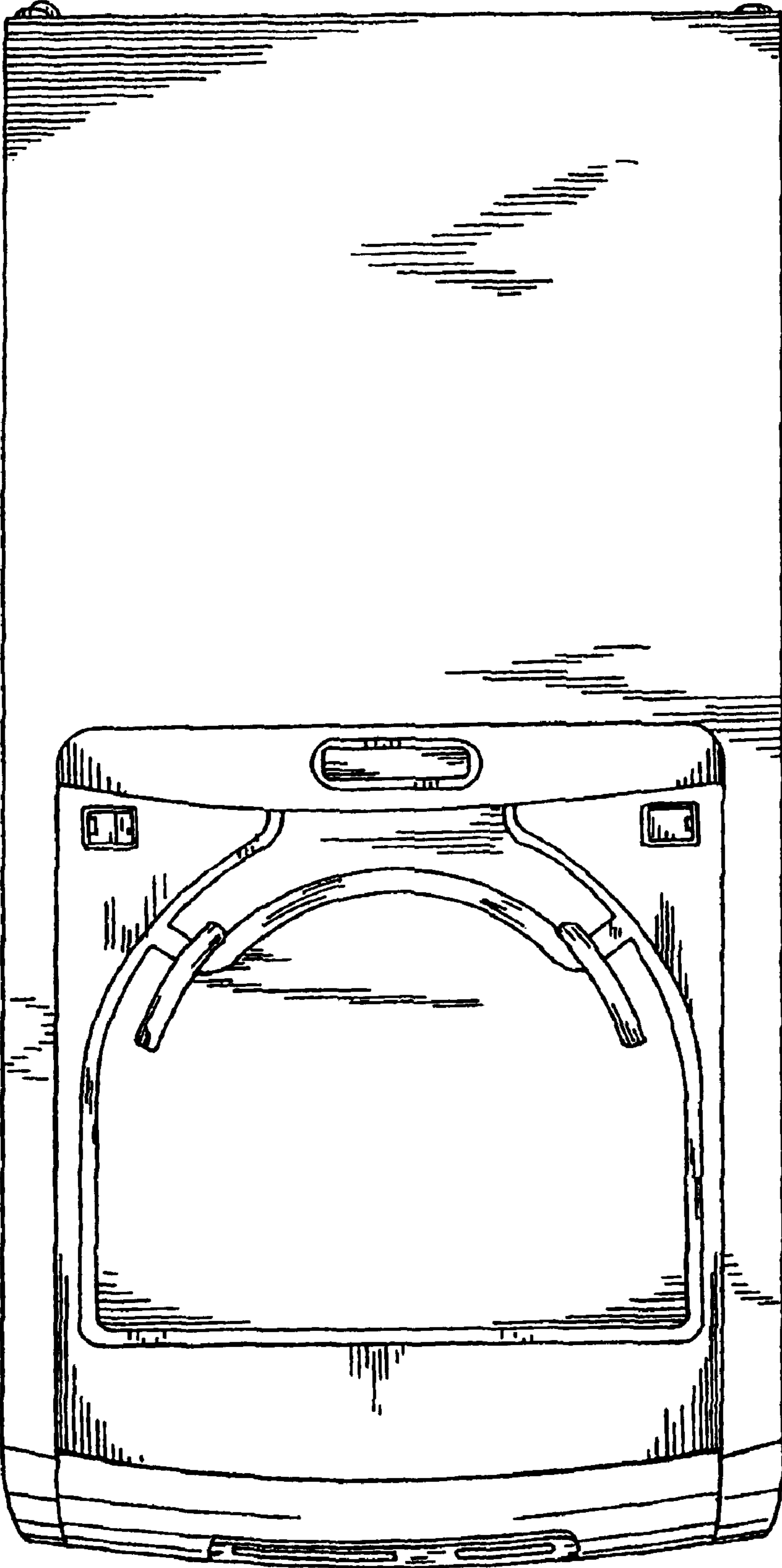

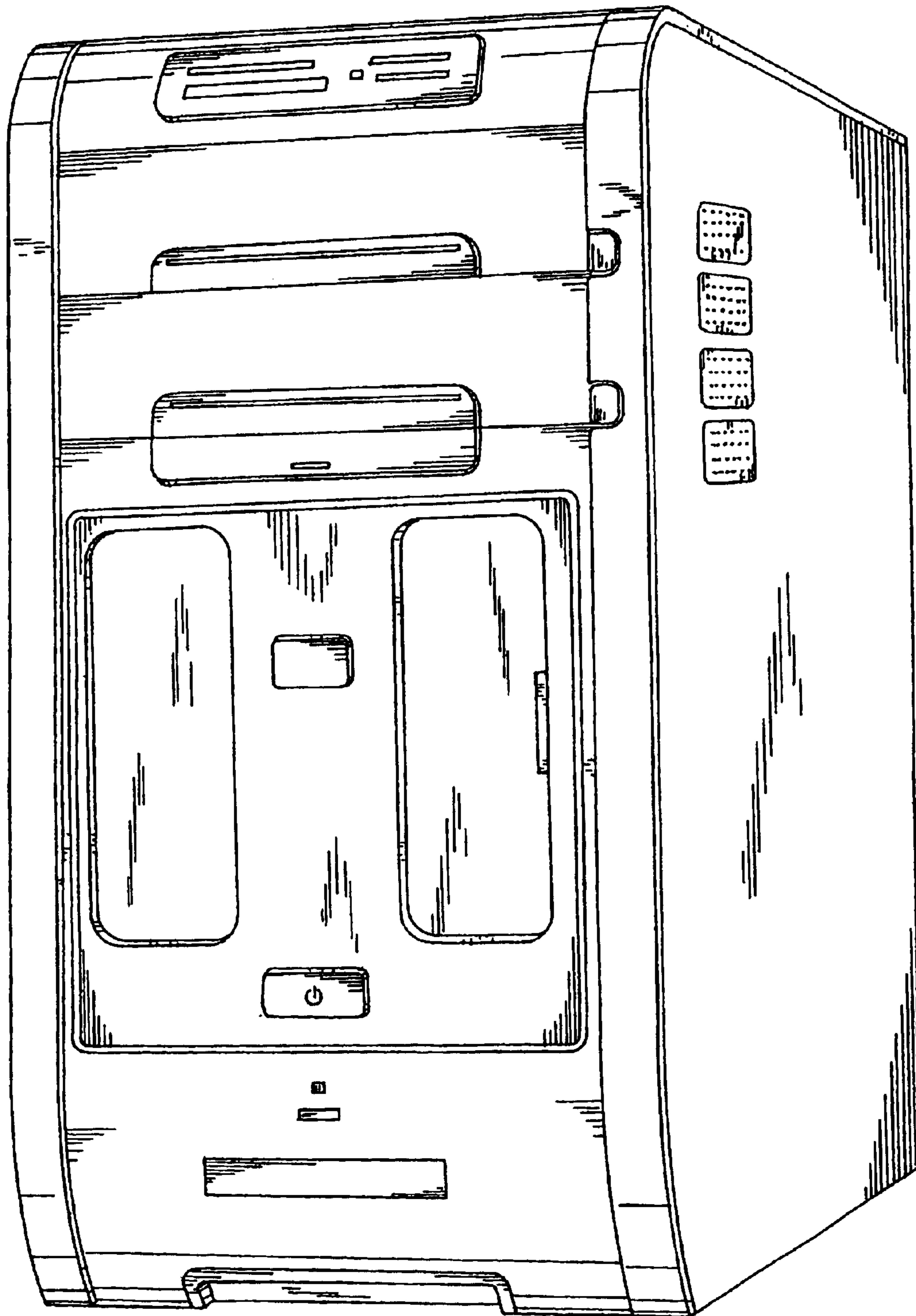
