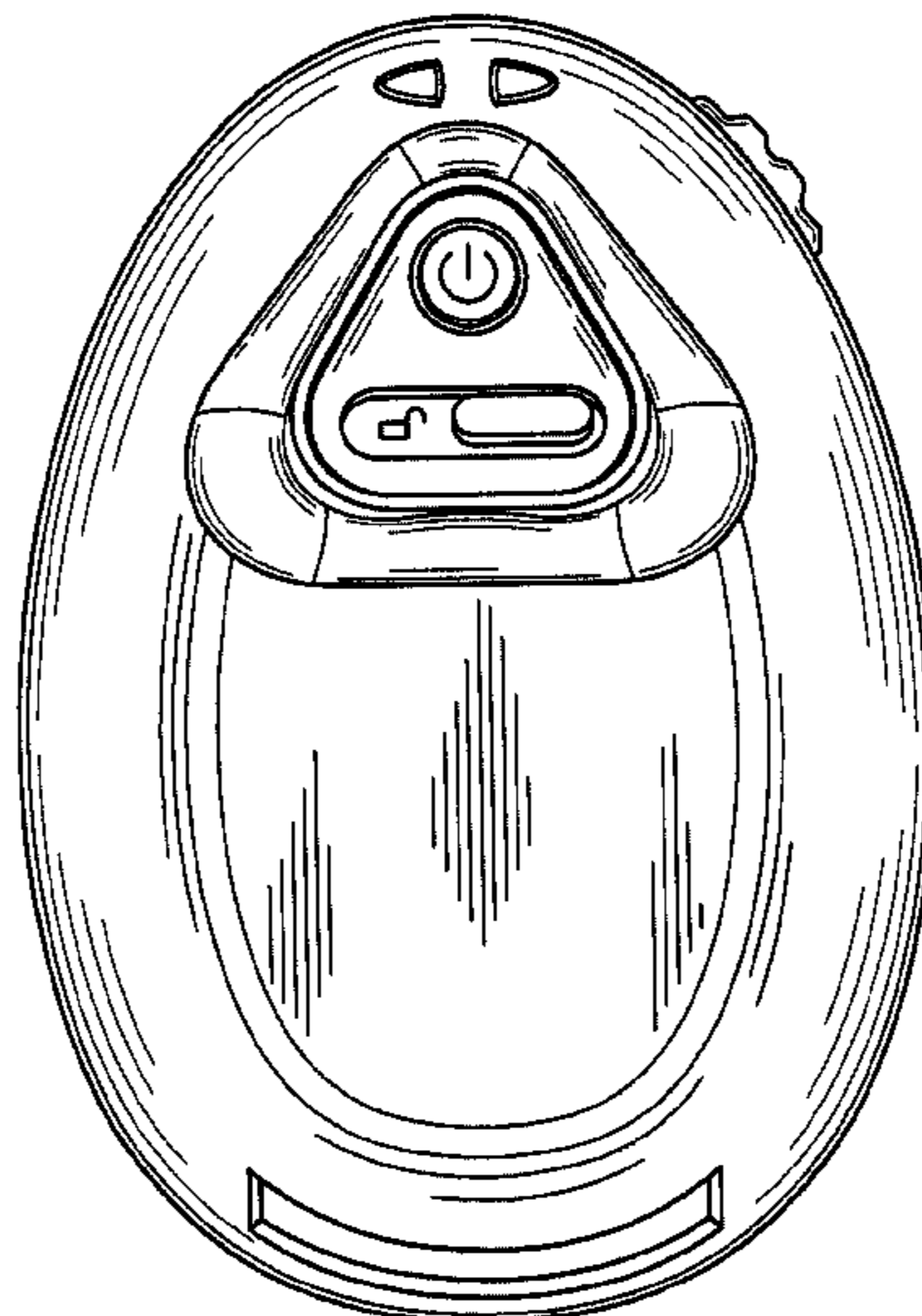
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top plan view of a digital media player, showing my new design;

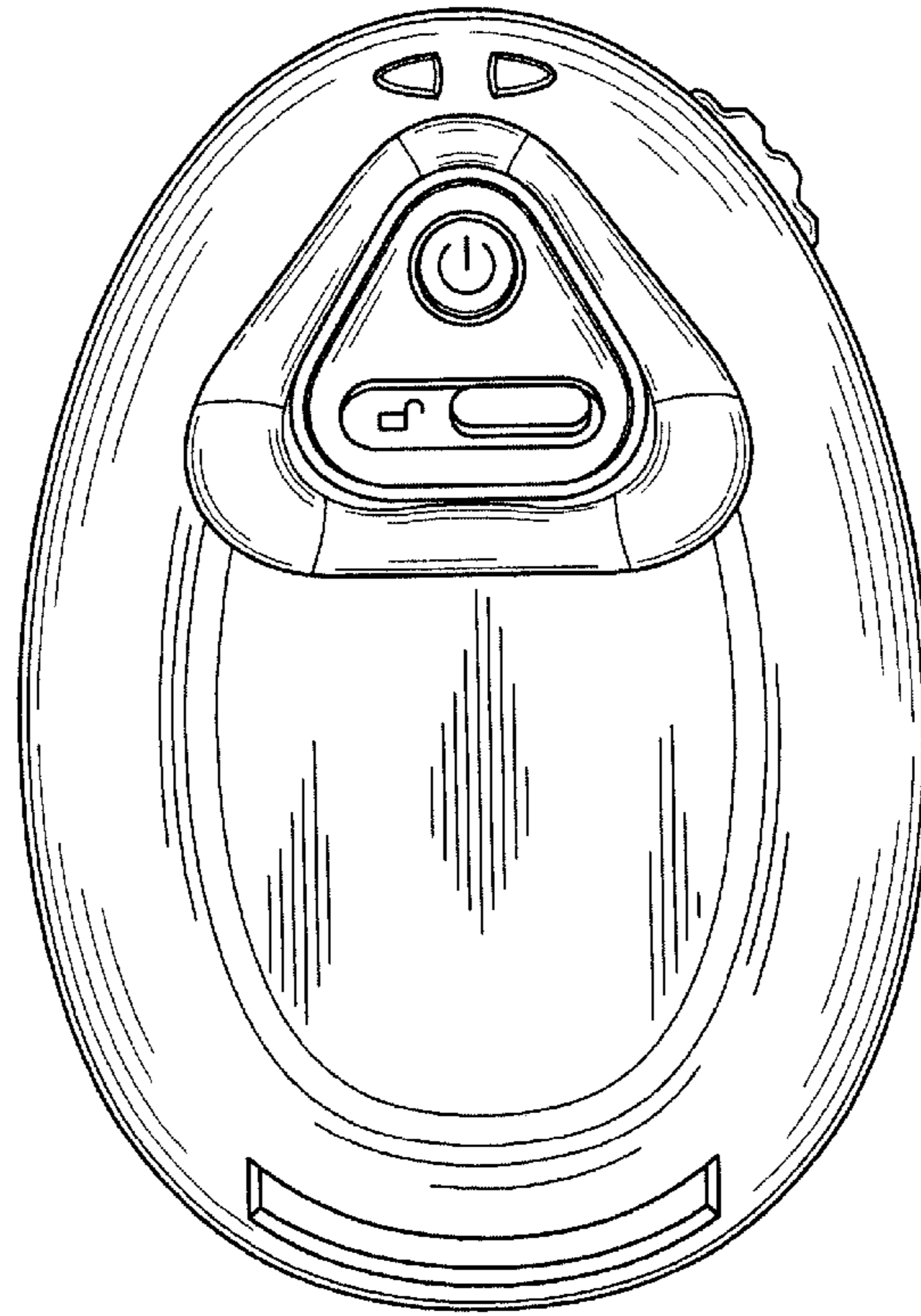

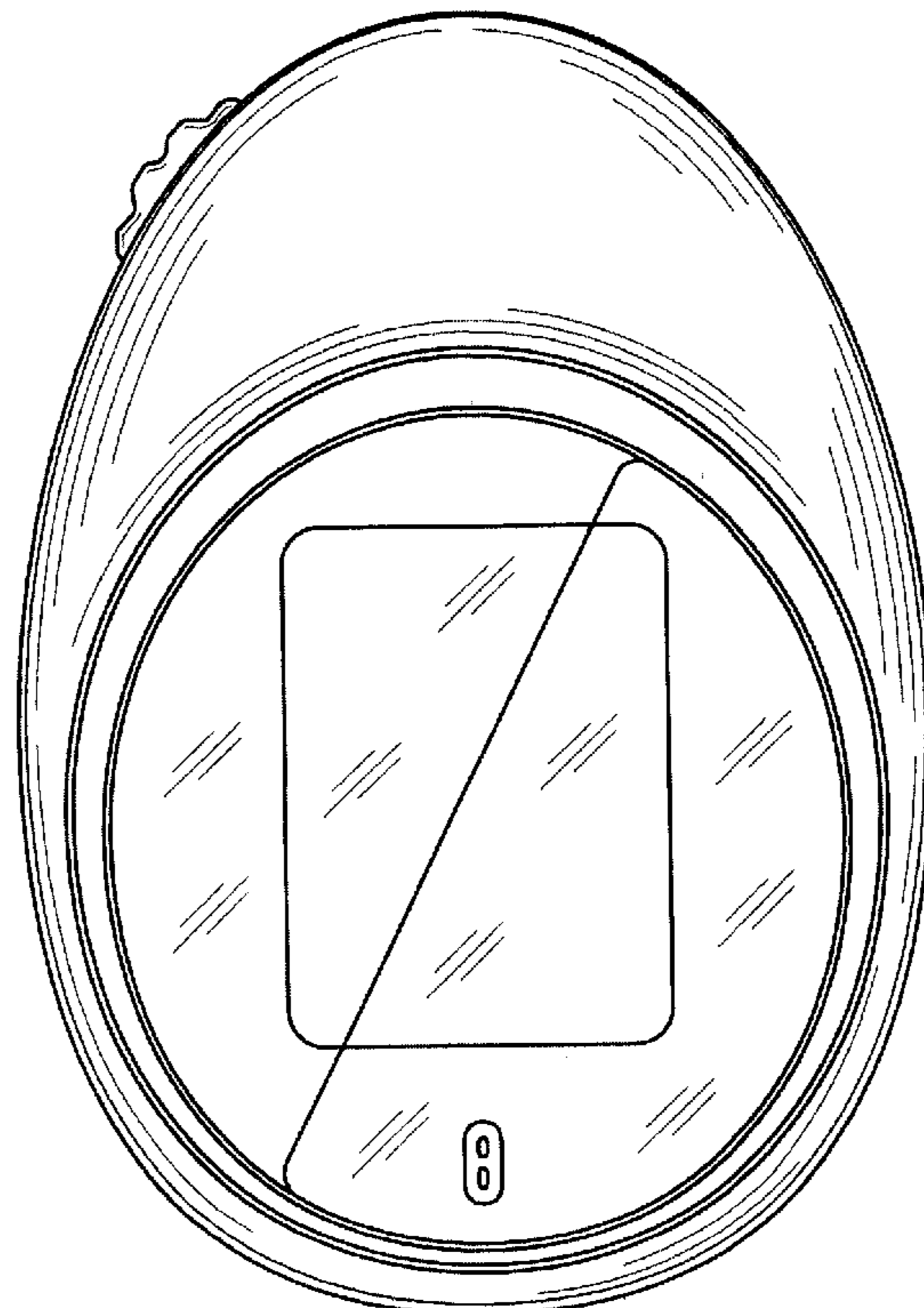

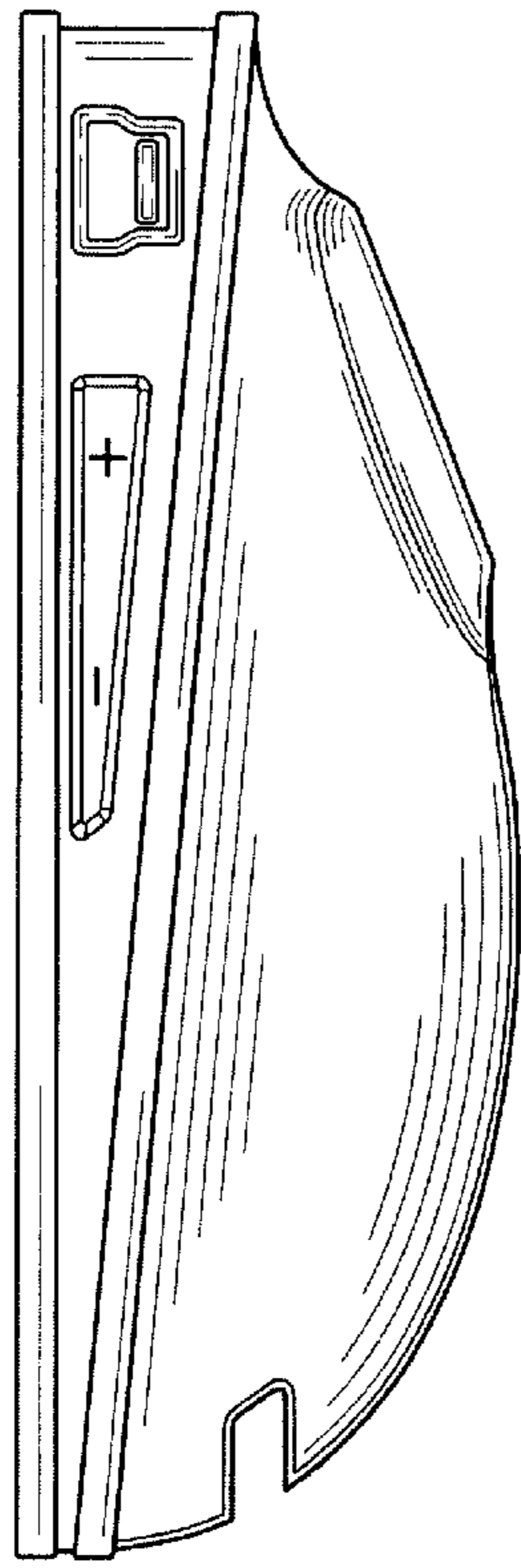

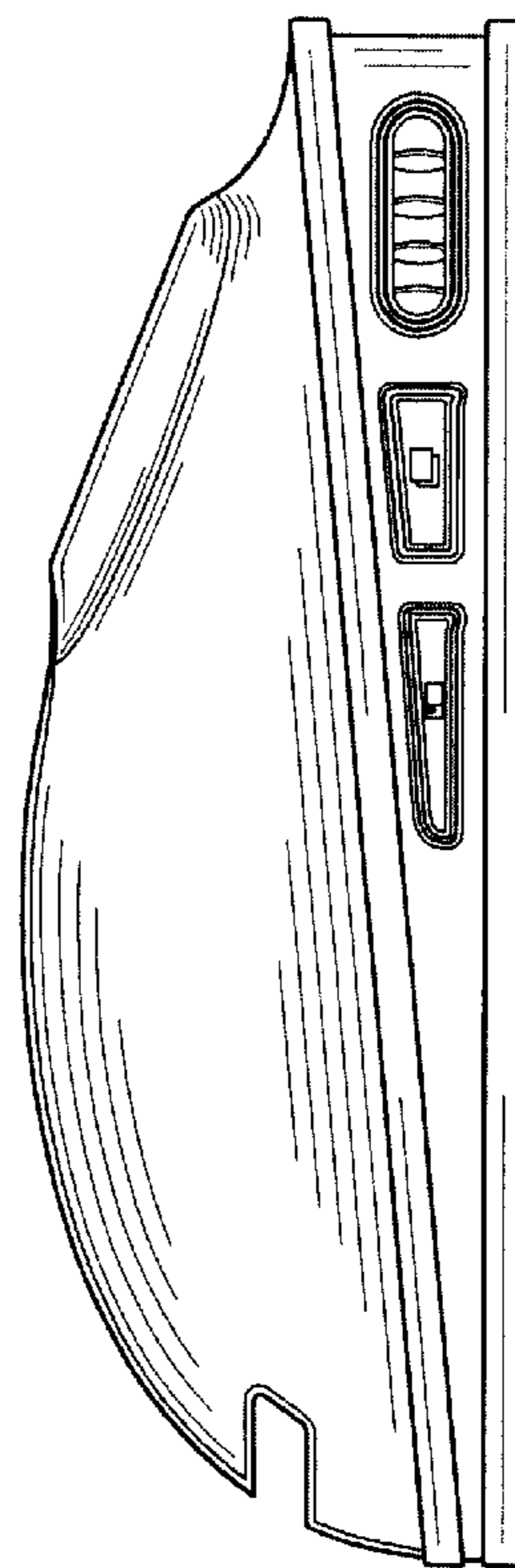

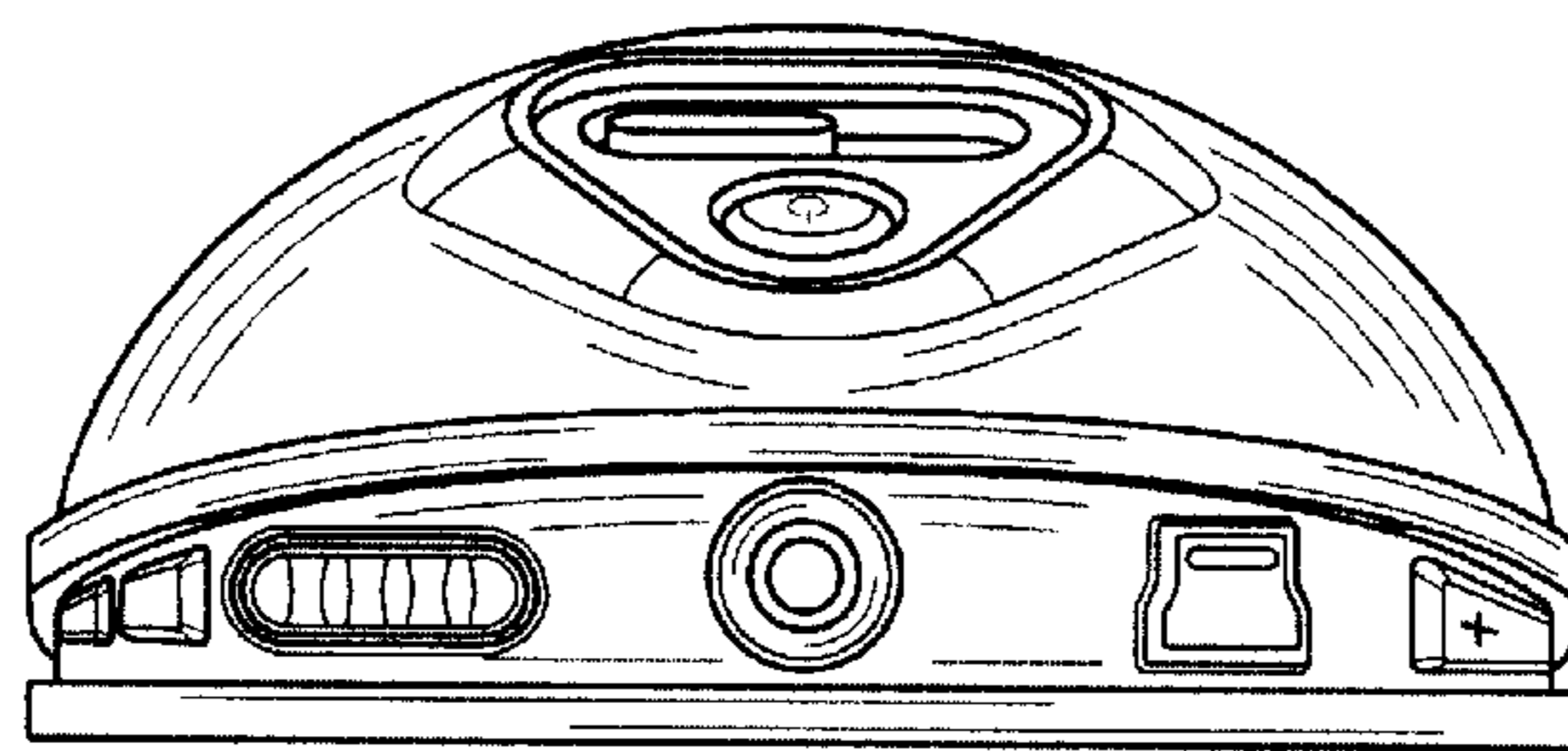

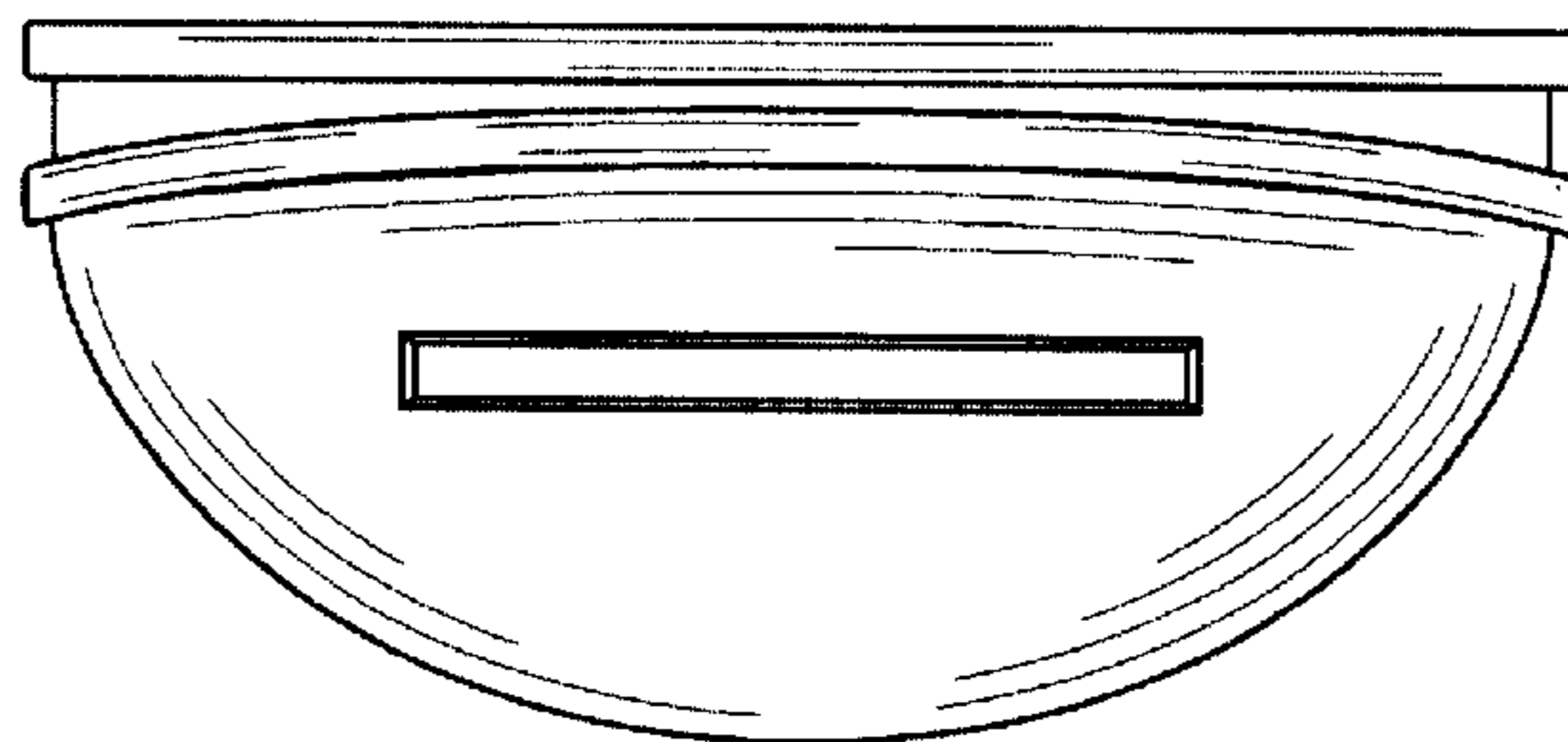
