FIG. 3 is a top view of FIG. 1;

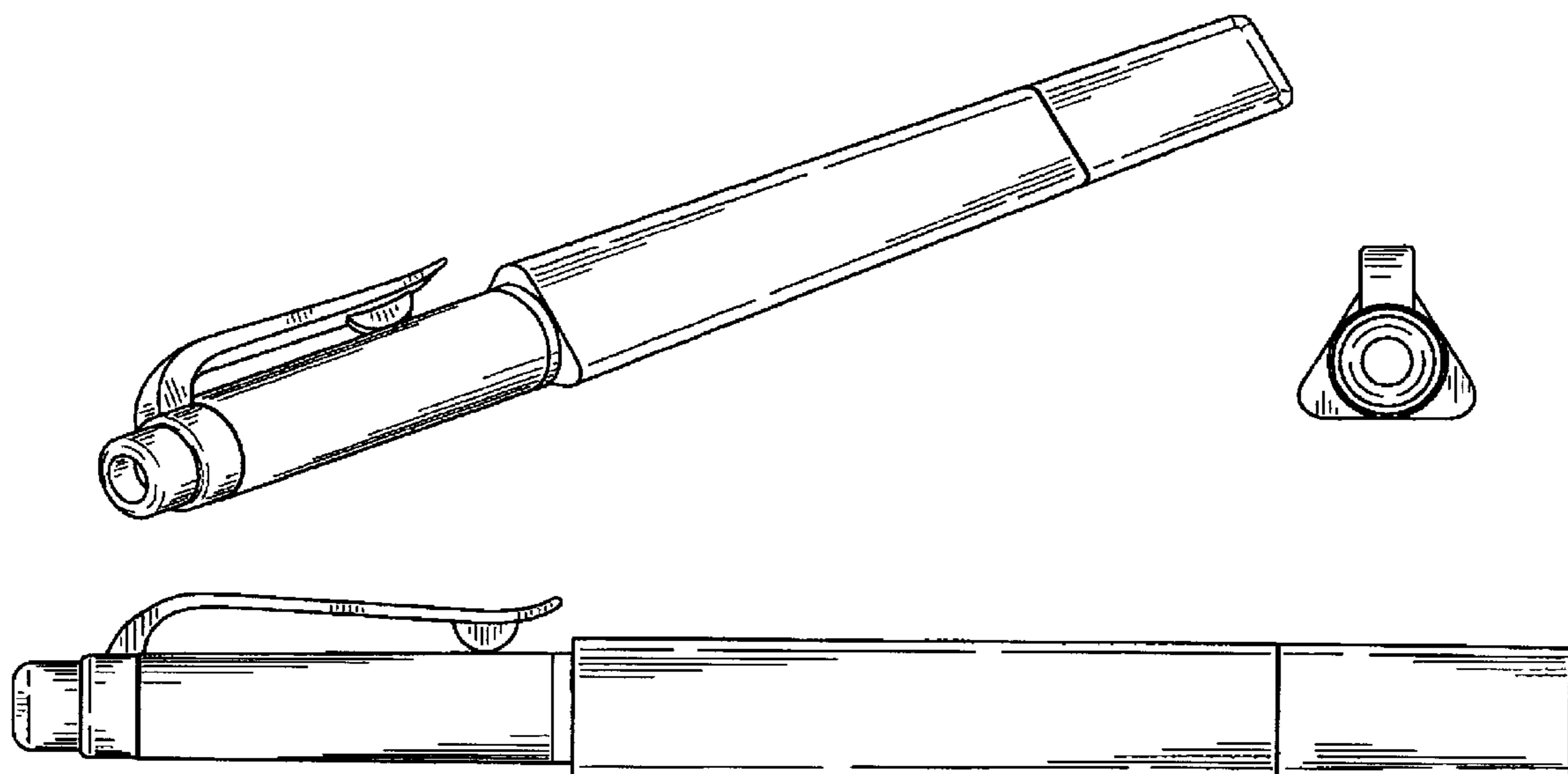
FIG. 4 is a bottom view of FIG. 1;

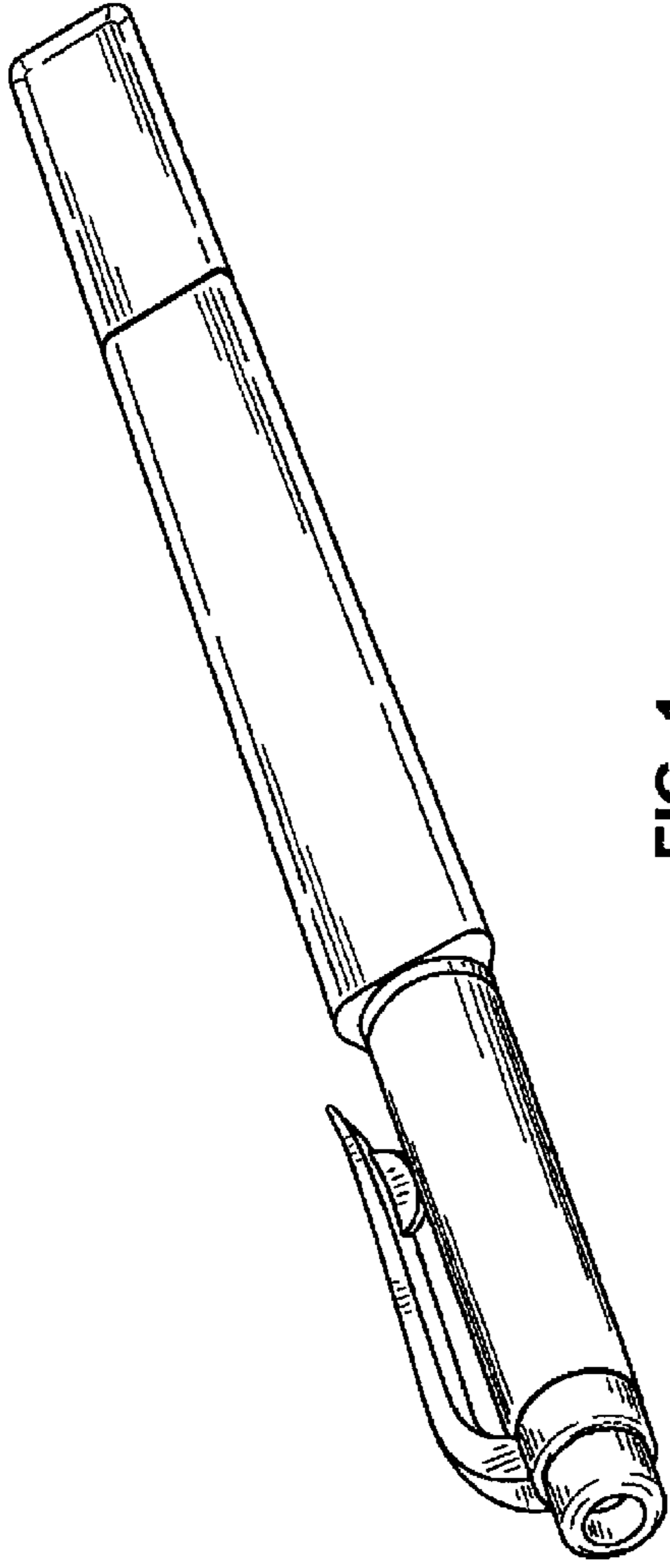

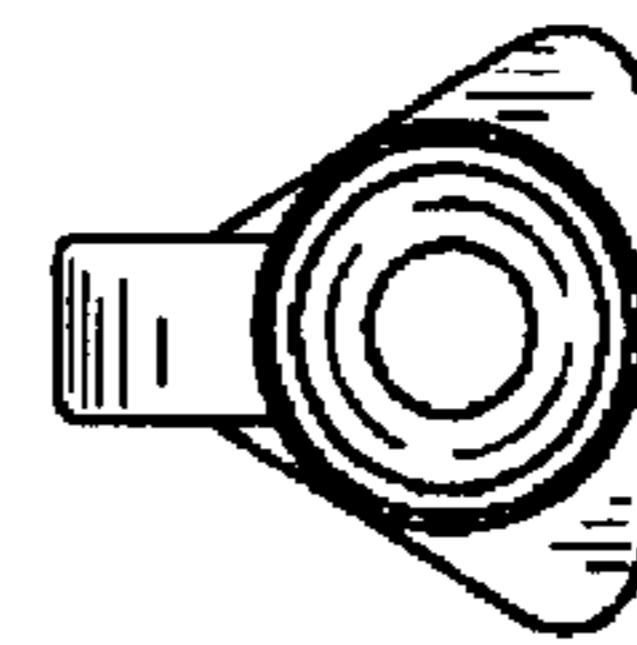

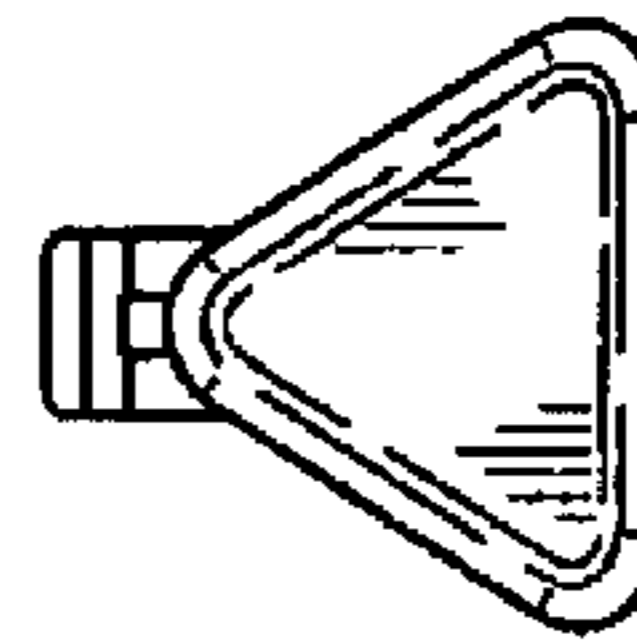

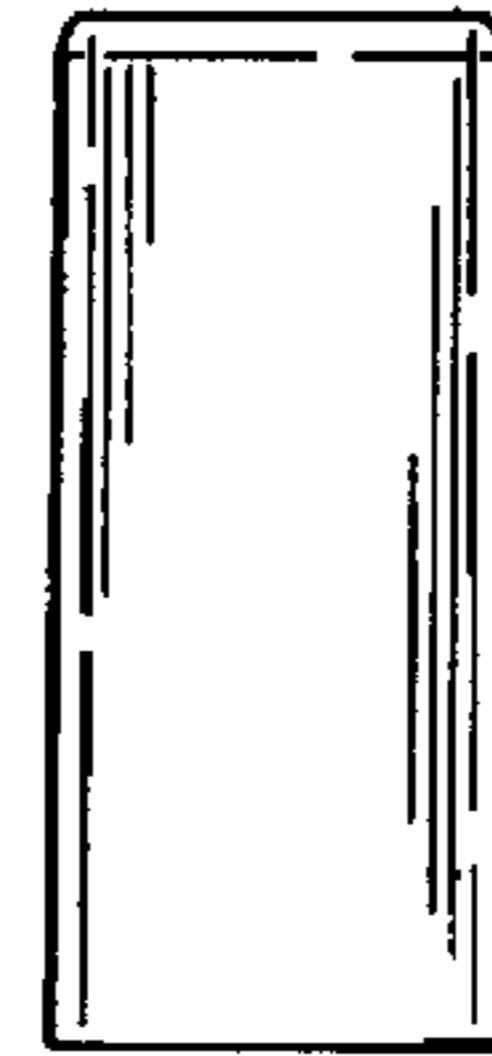

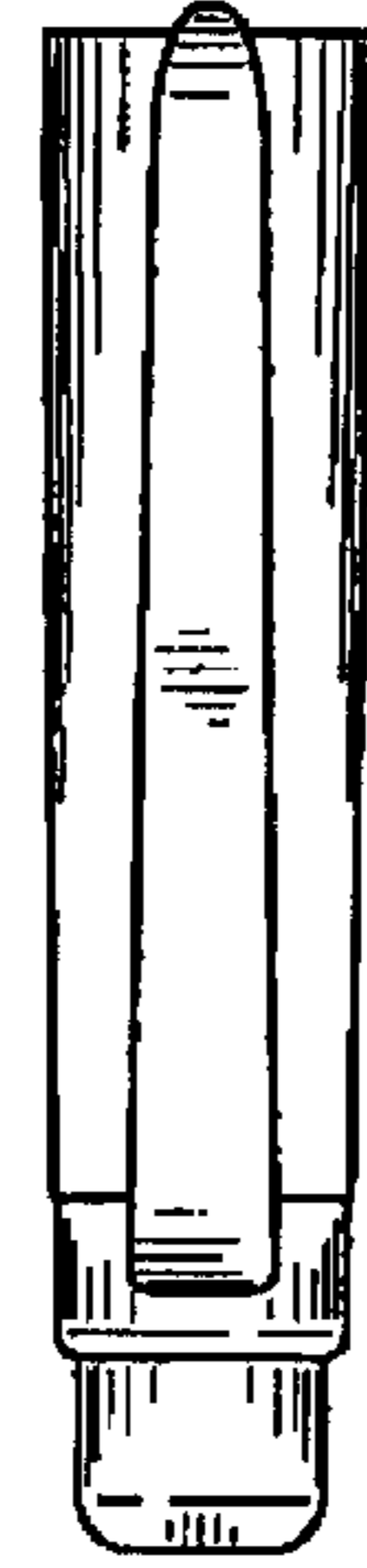
