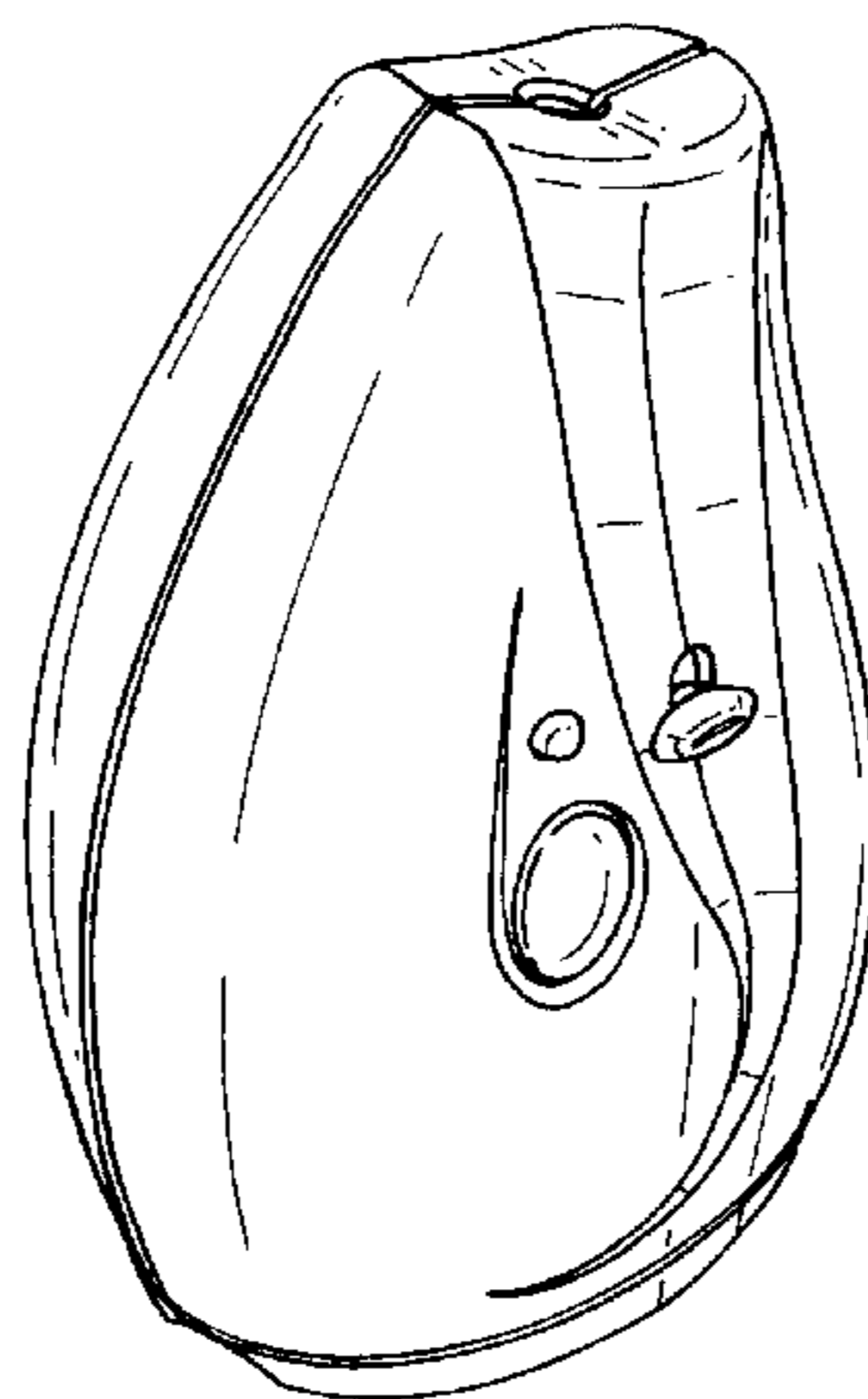
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a left, top perspective view of a complete air freshener device;  
FIG. 2 is an elevation view of the front thereof;  
FIG. 3 is an elevation view of the back thereof;  
FIG. 4 is an elevation view of the right side thereof;  
FIG. 5 is an elevation view of the left side thereof;  
FIG. 6 is a plan view of the top thereof; and,

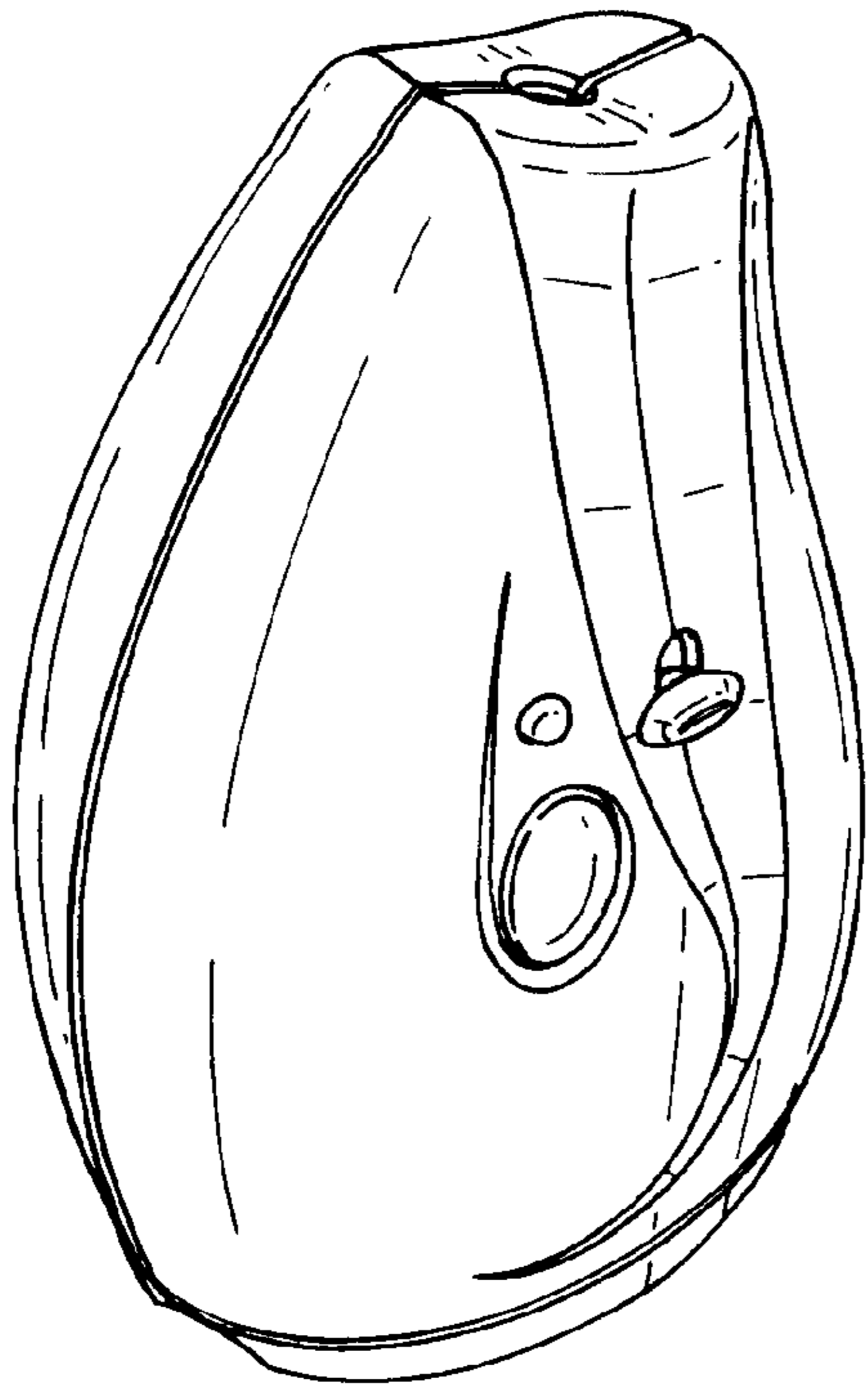

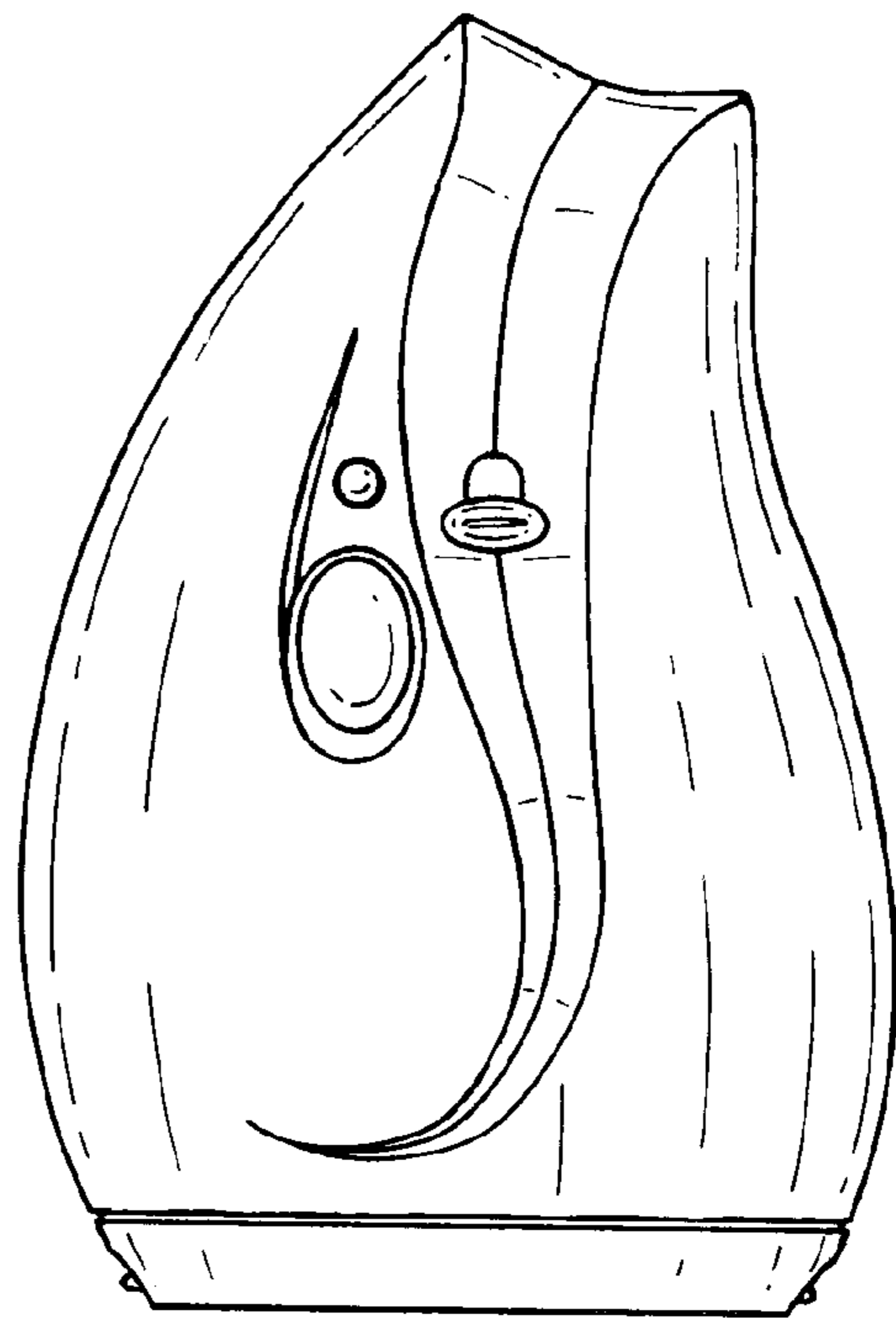

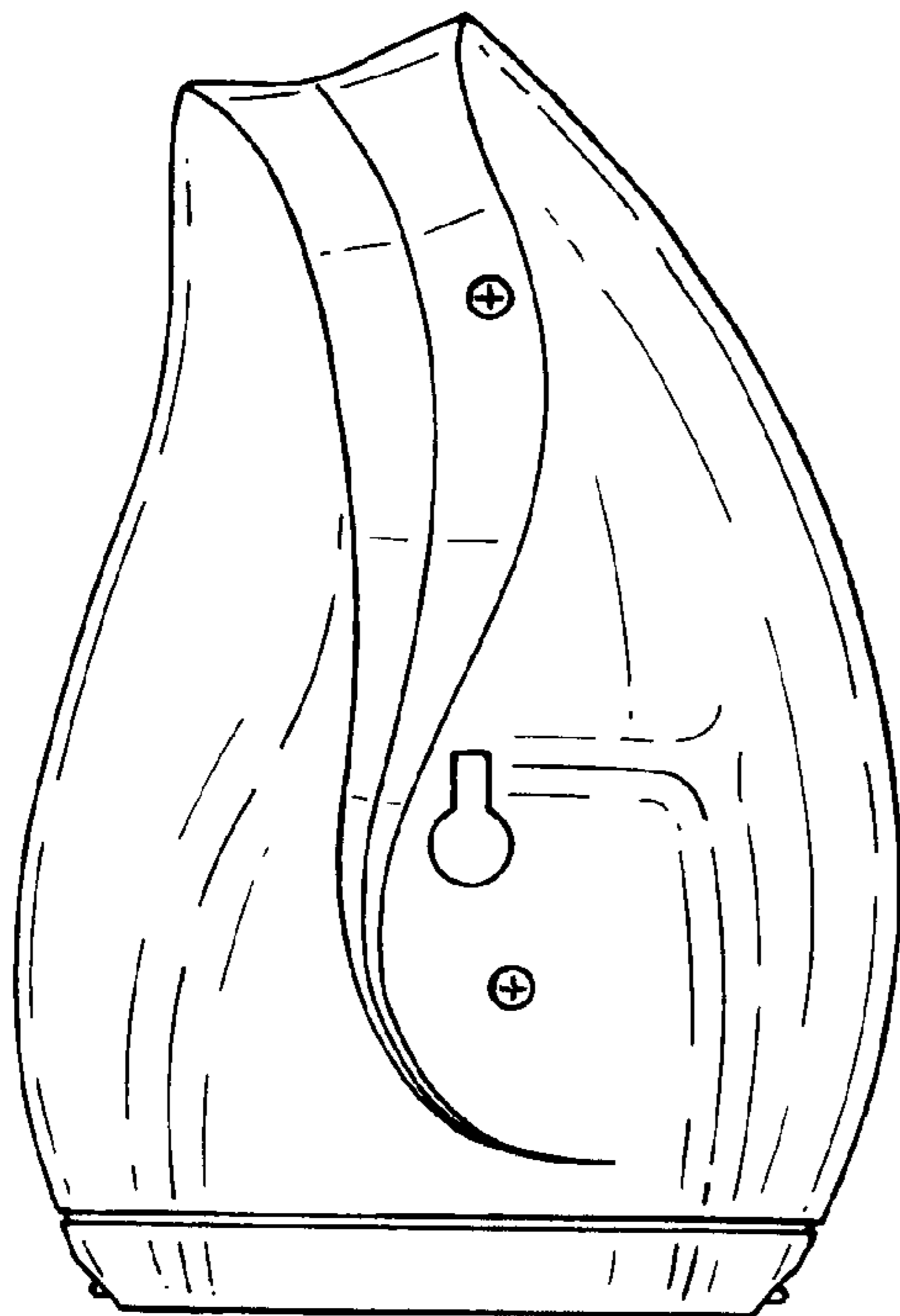

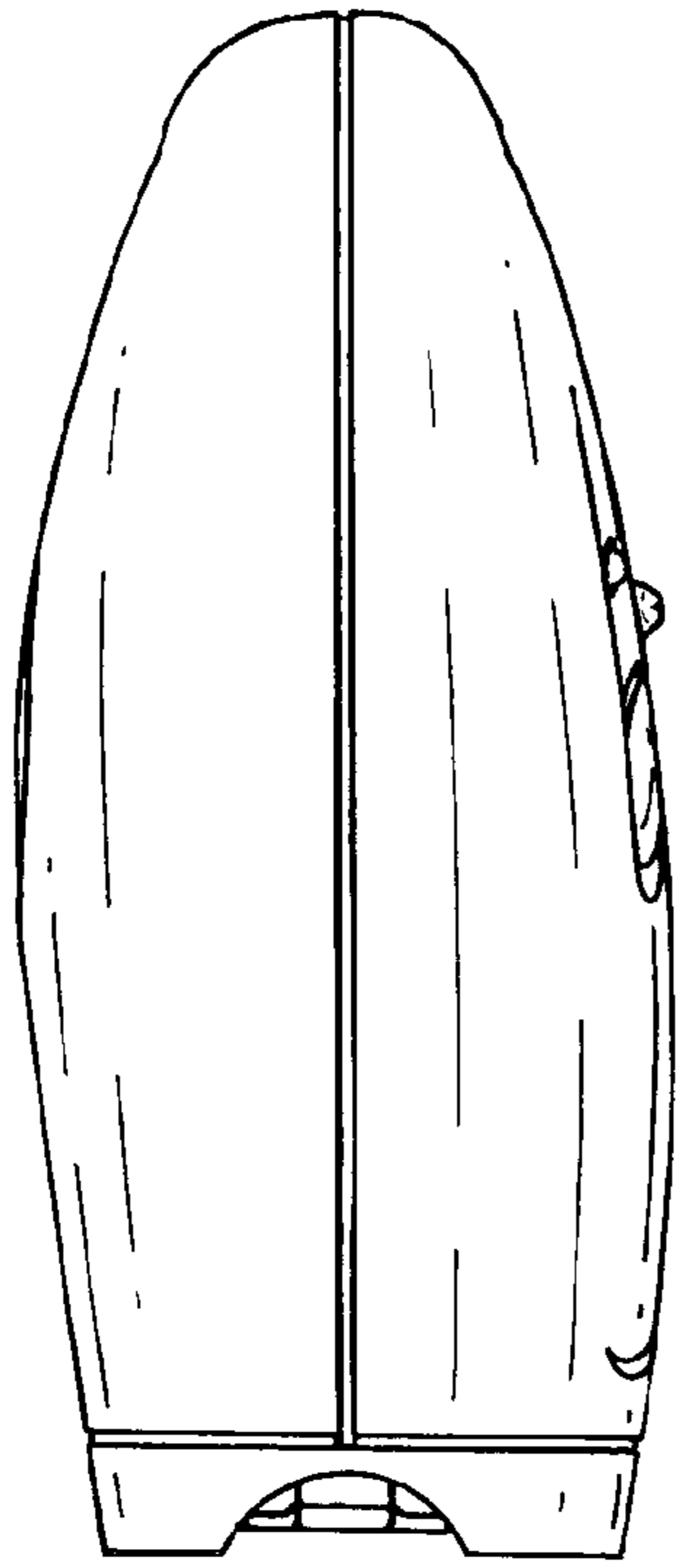

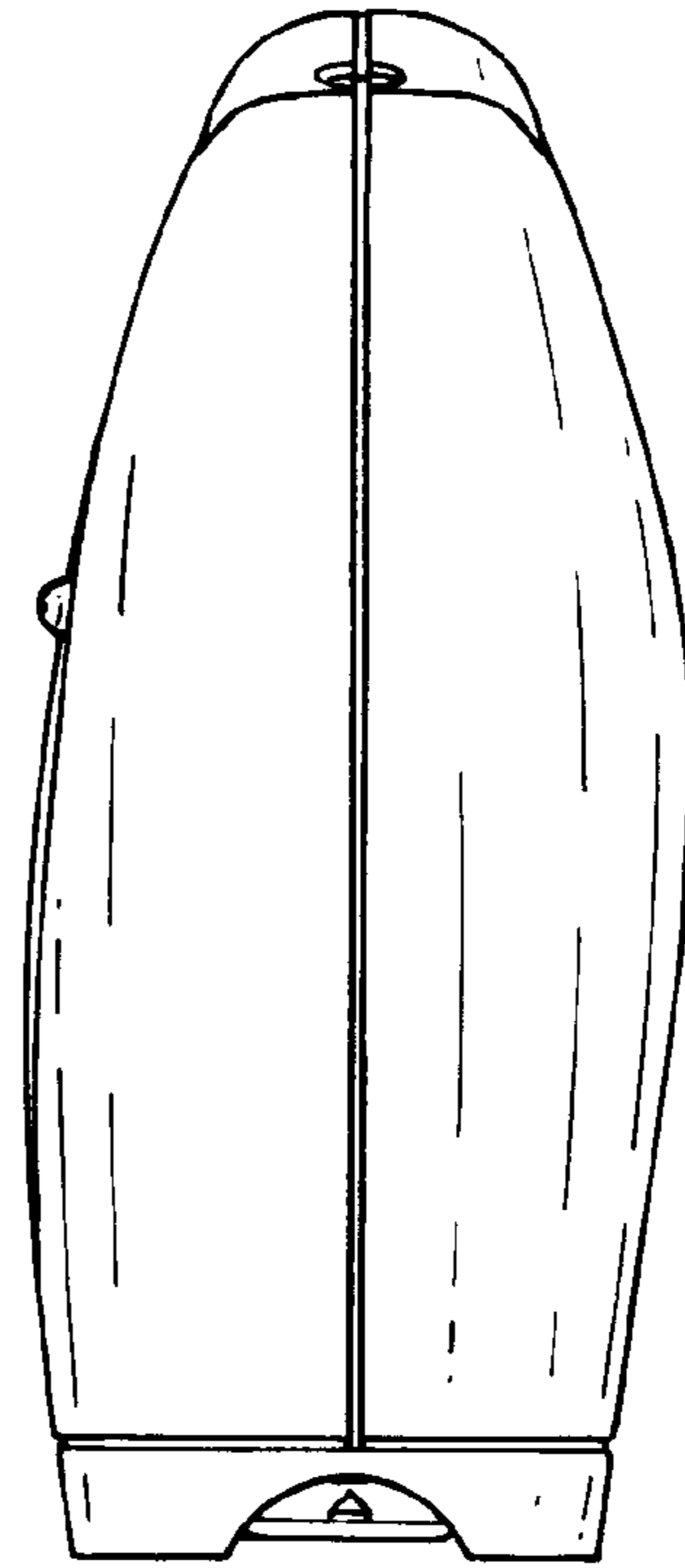

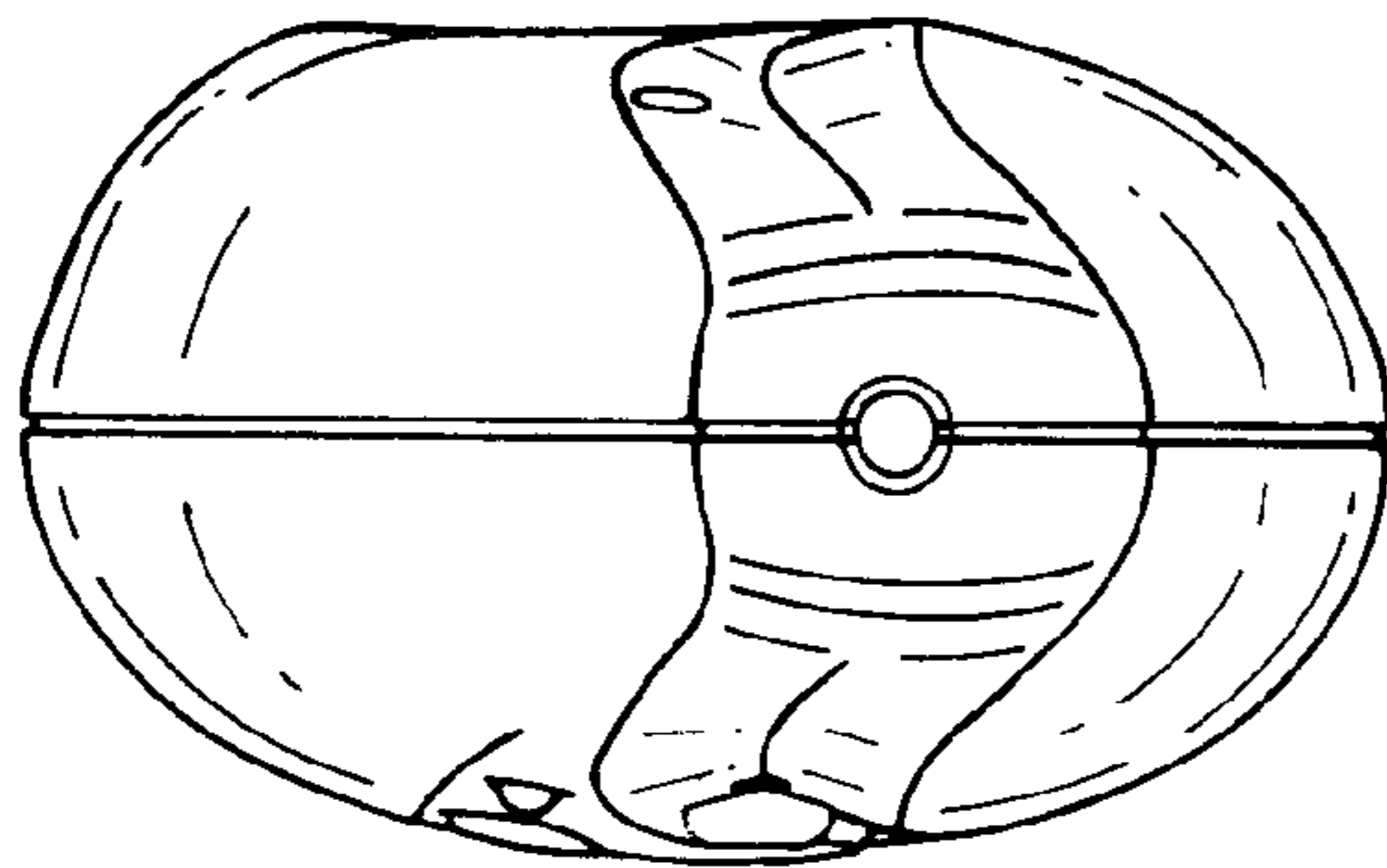

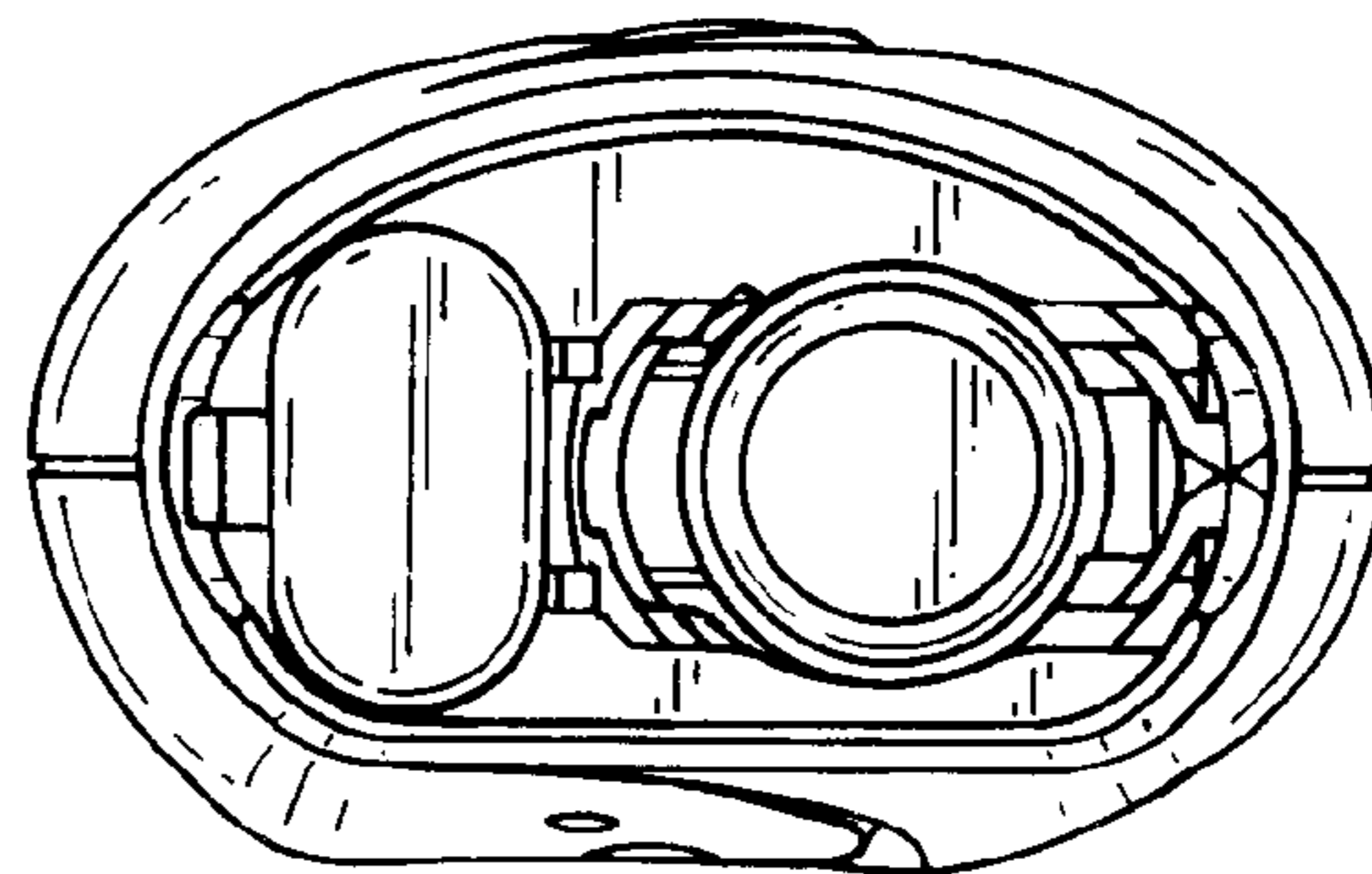
