(57) **CLAIM**

The ornamental design for a ceiling fan motor housing, as shown and described.

**DESCRIPTION**

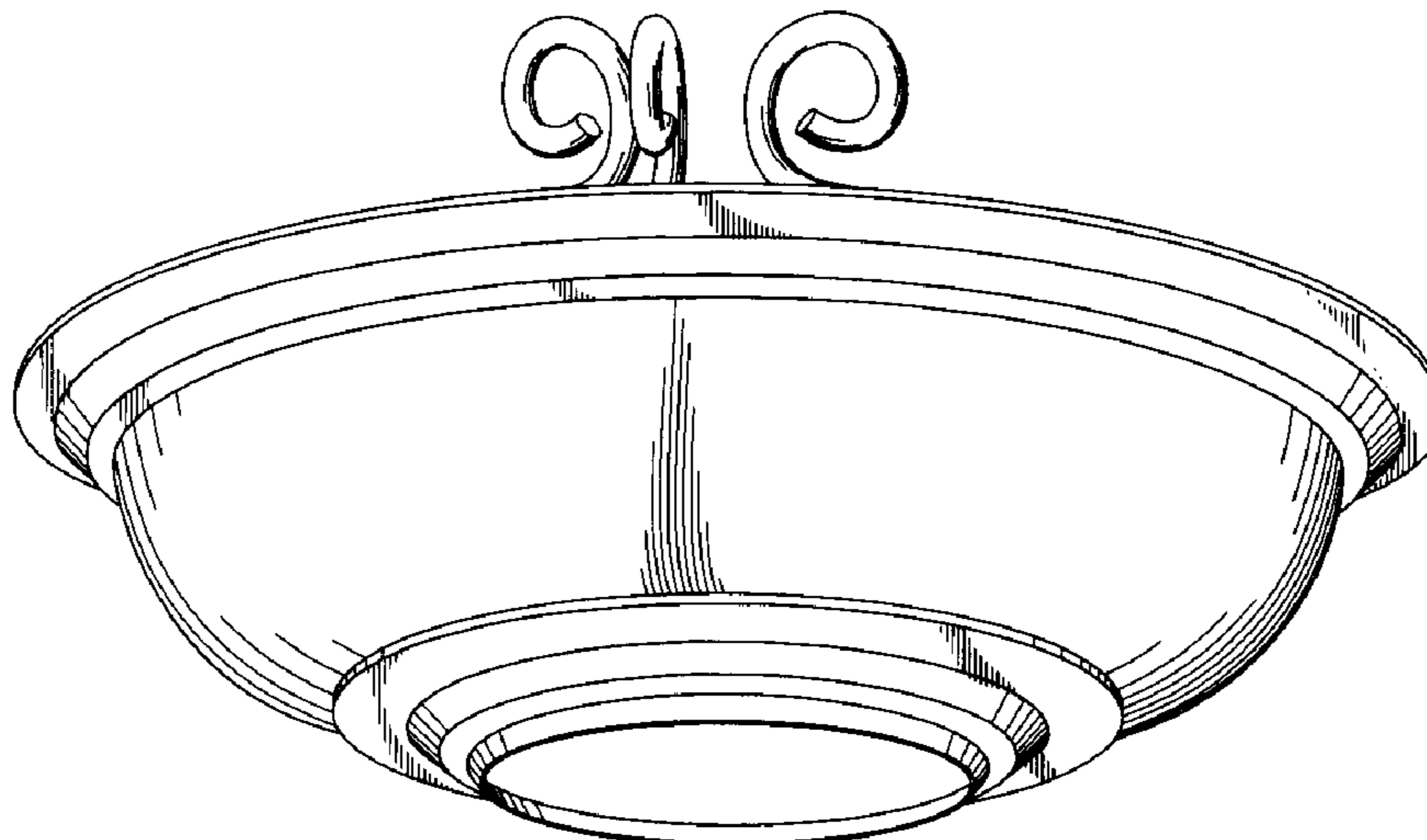

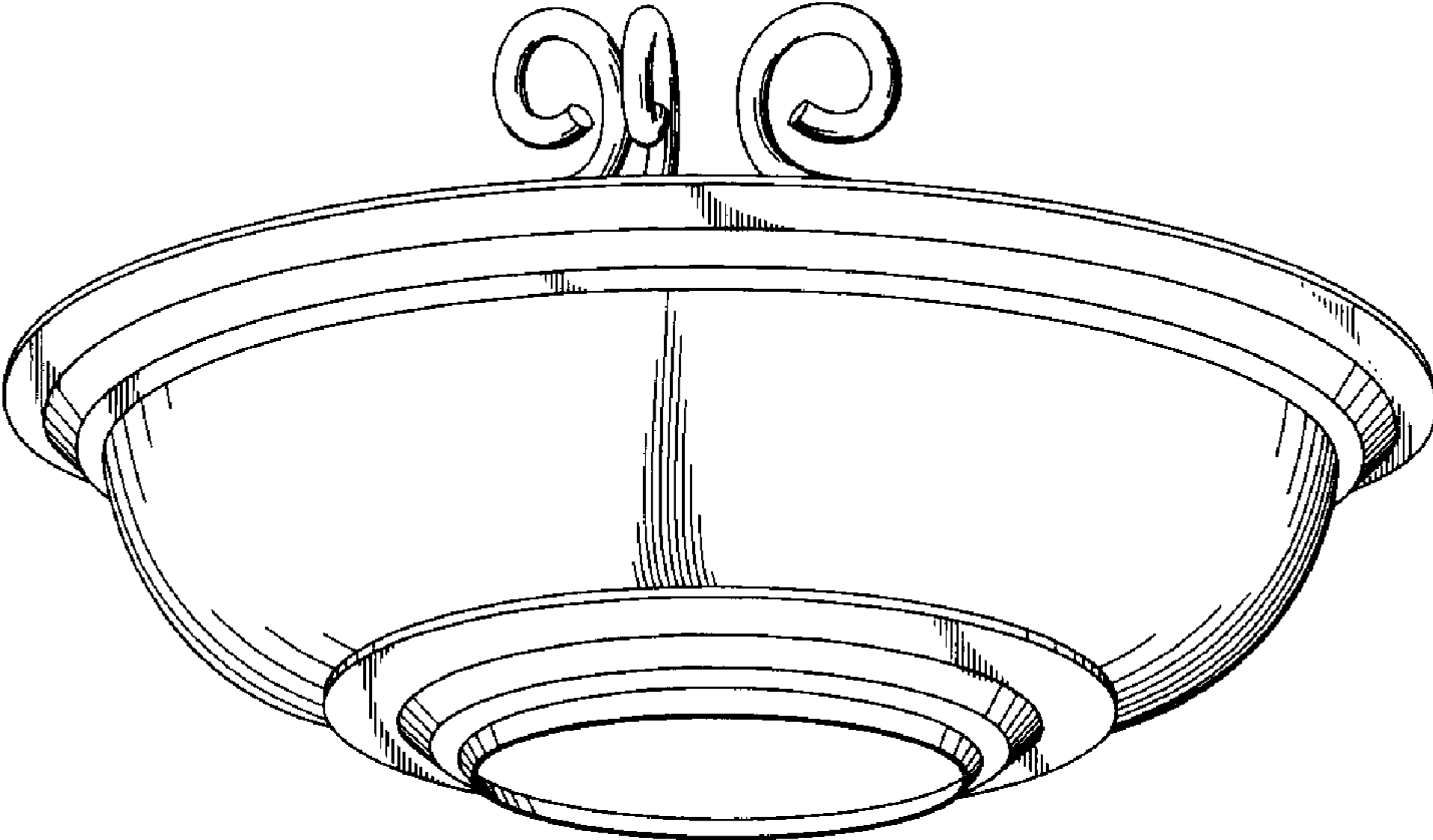

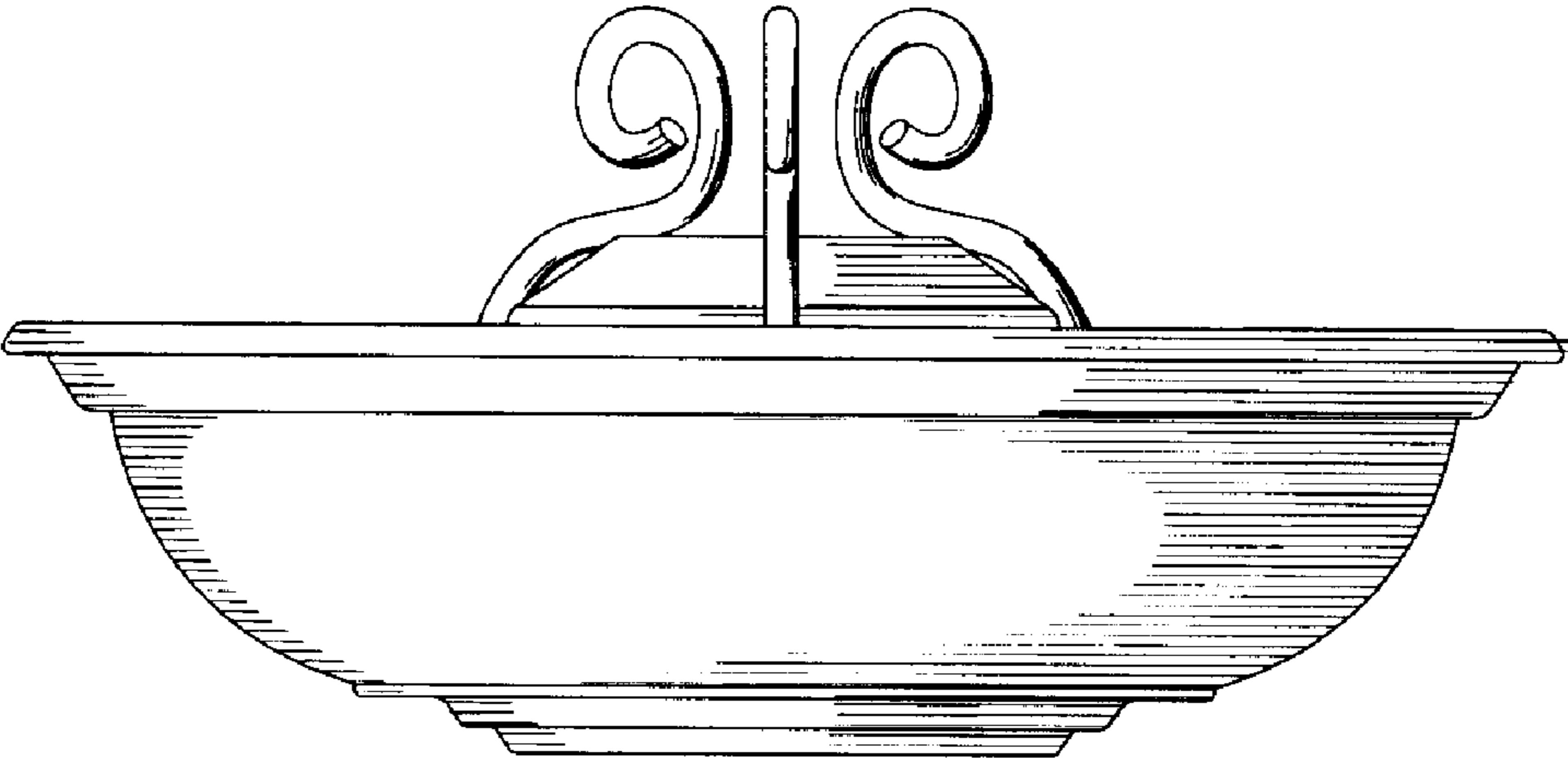

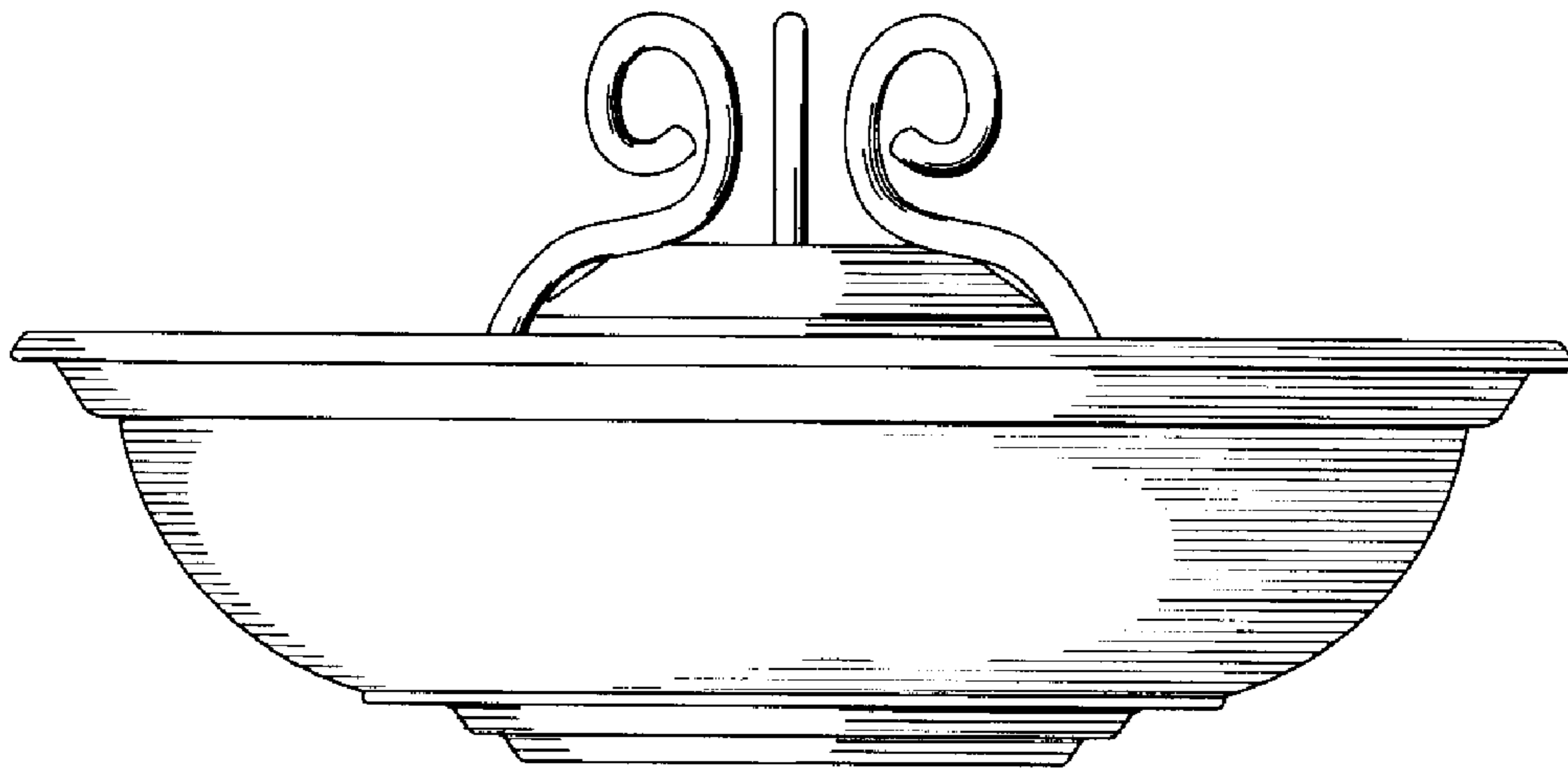

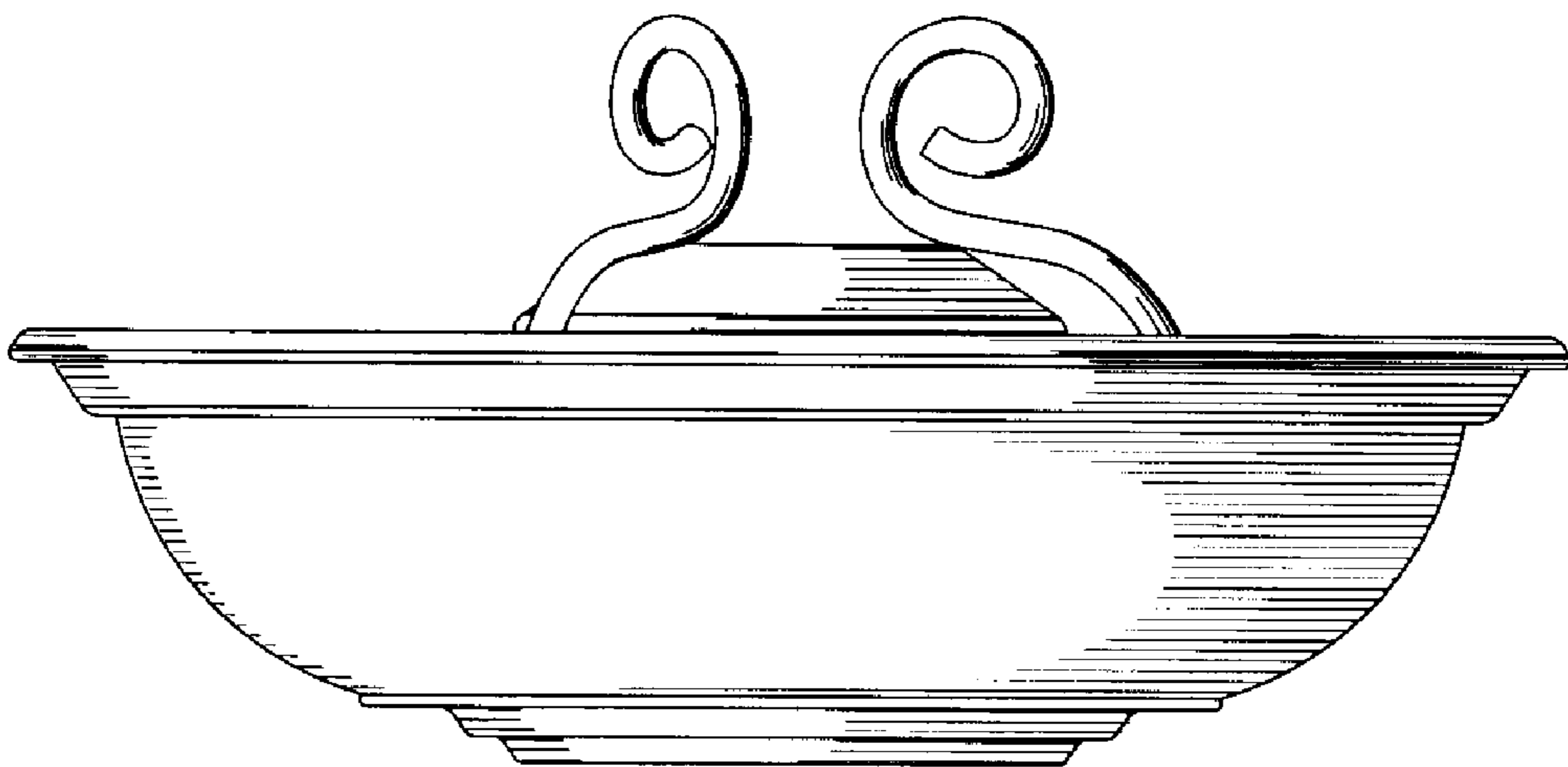

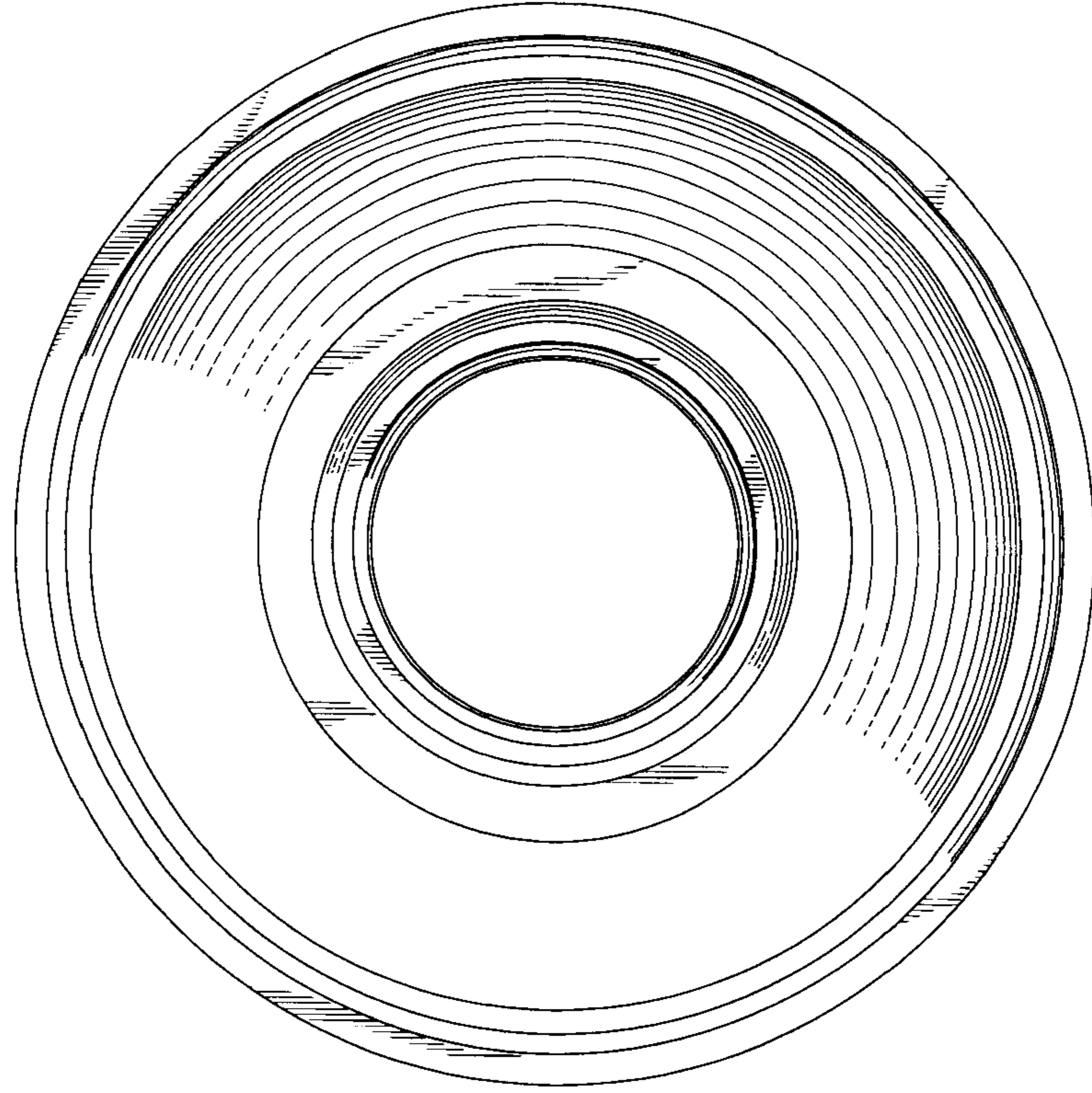
