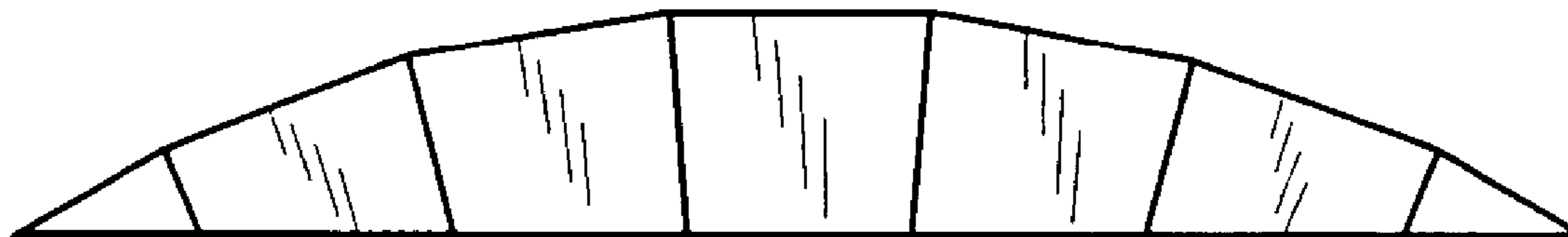
(57) **CLAIM**

The ornamental design for dental handpiece, as shown and described.

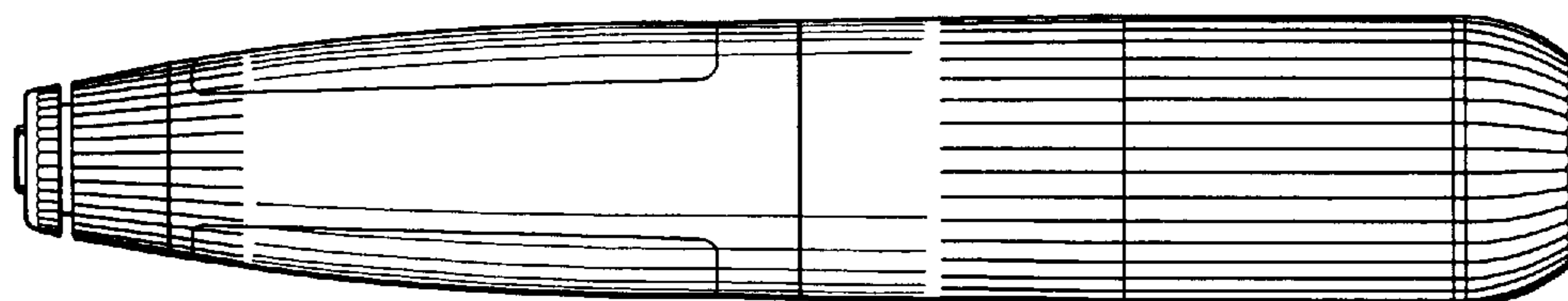
**DESCRIPTION**

FIG. 1 is a front elevation of a dental handpiece showing my new design;

 FIG. 9 is a perspective view thereof taken from the upper right side of FIG. 1.

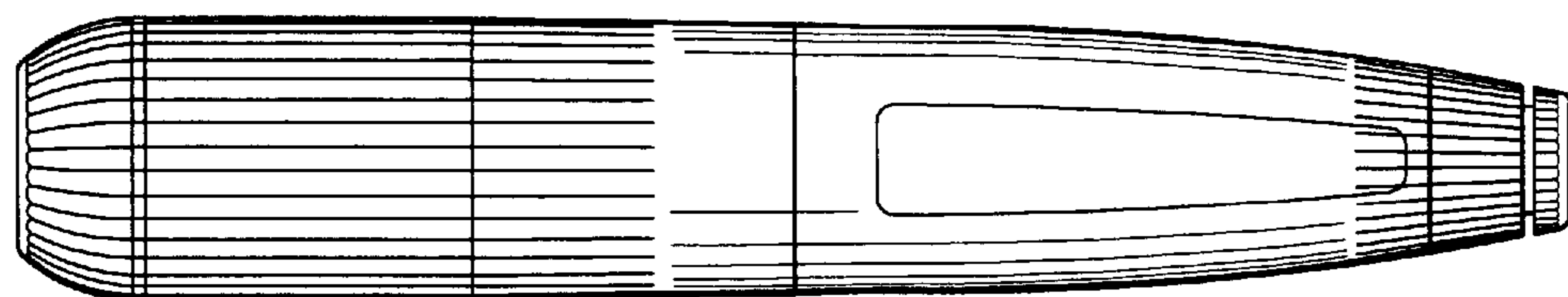

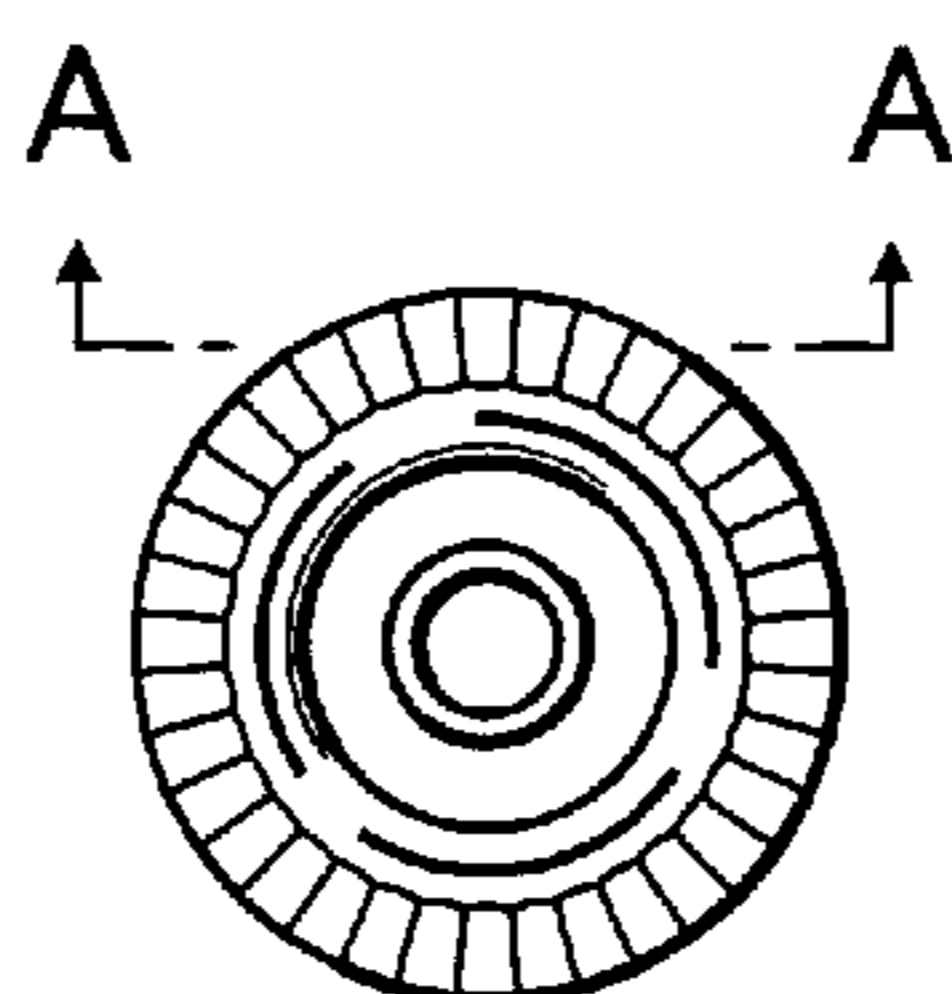

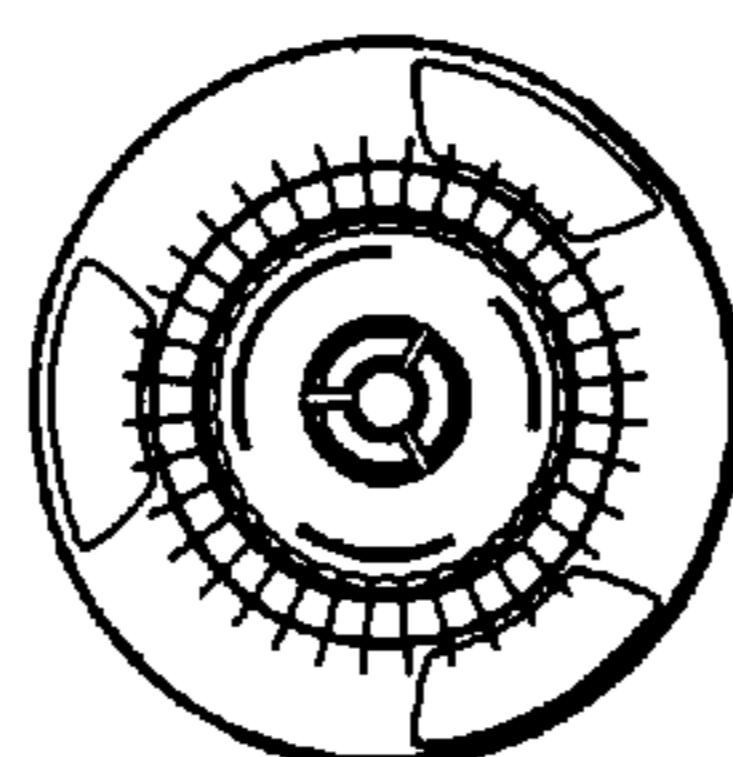

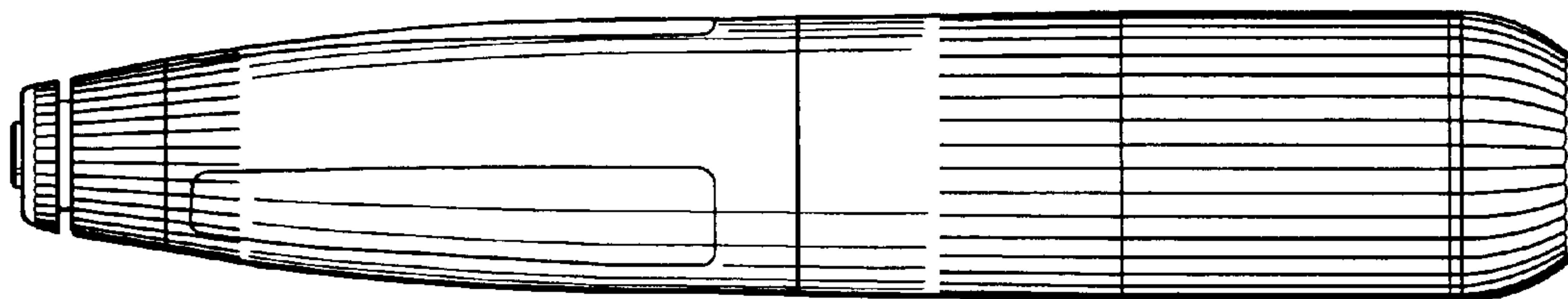

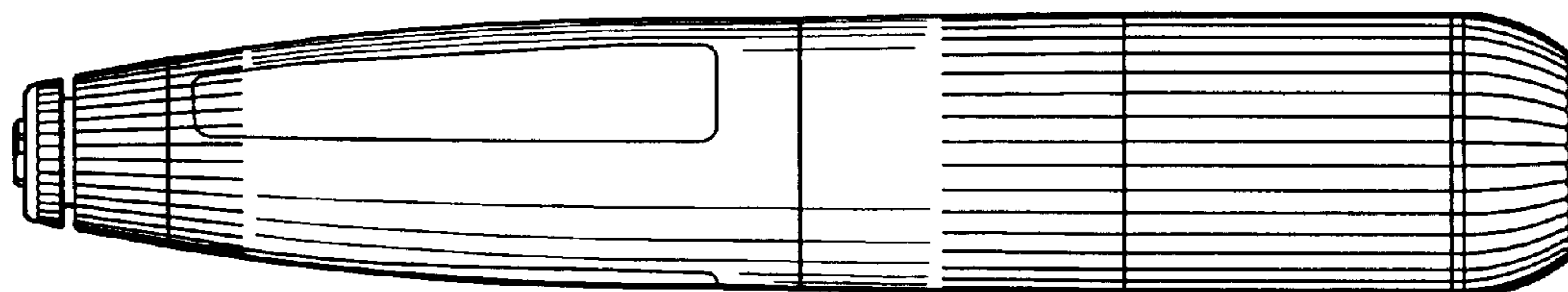

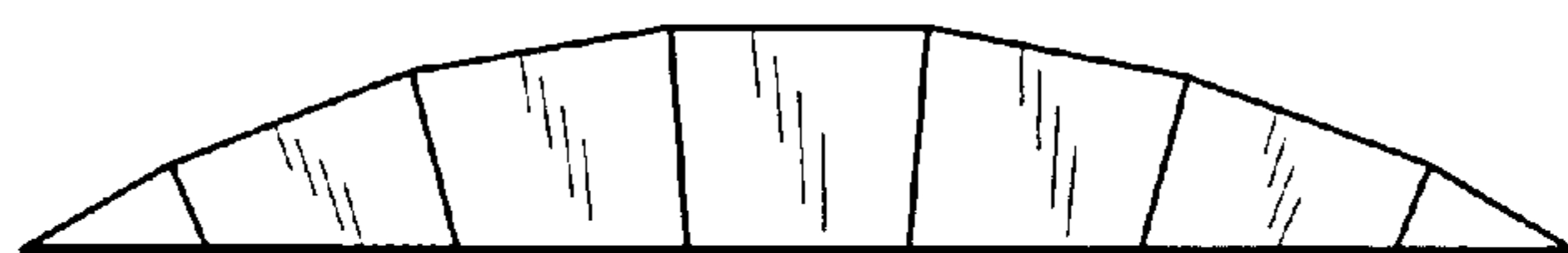

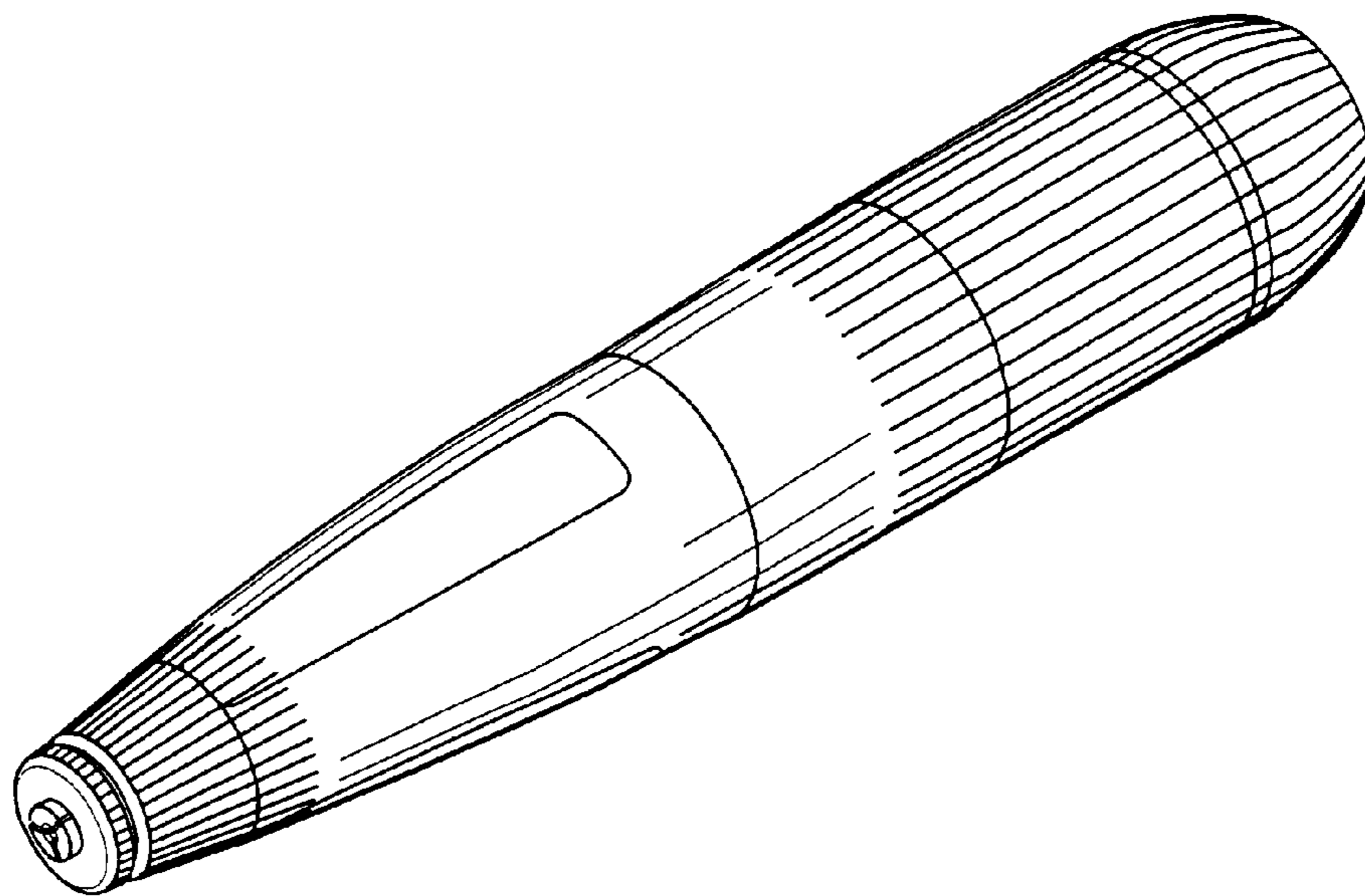
