FIG. 4 is an elevational view thereof showing a portion of my design in a partially open configuration;

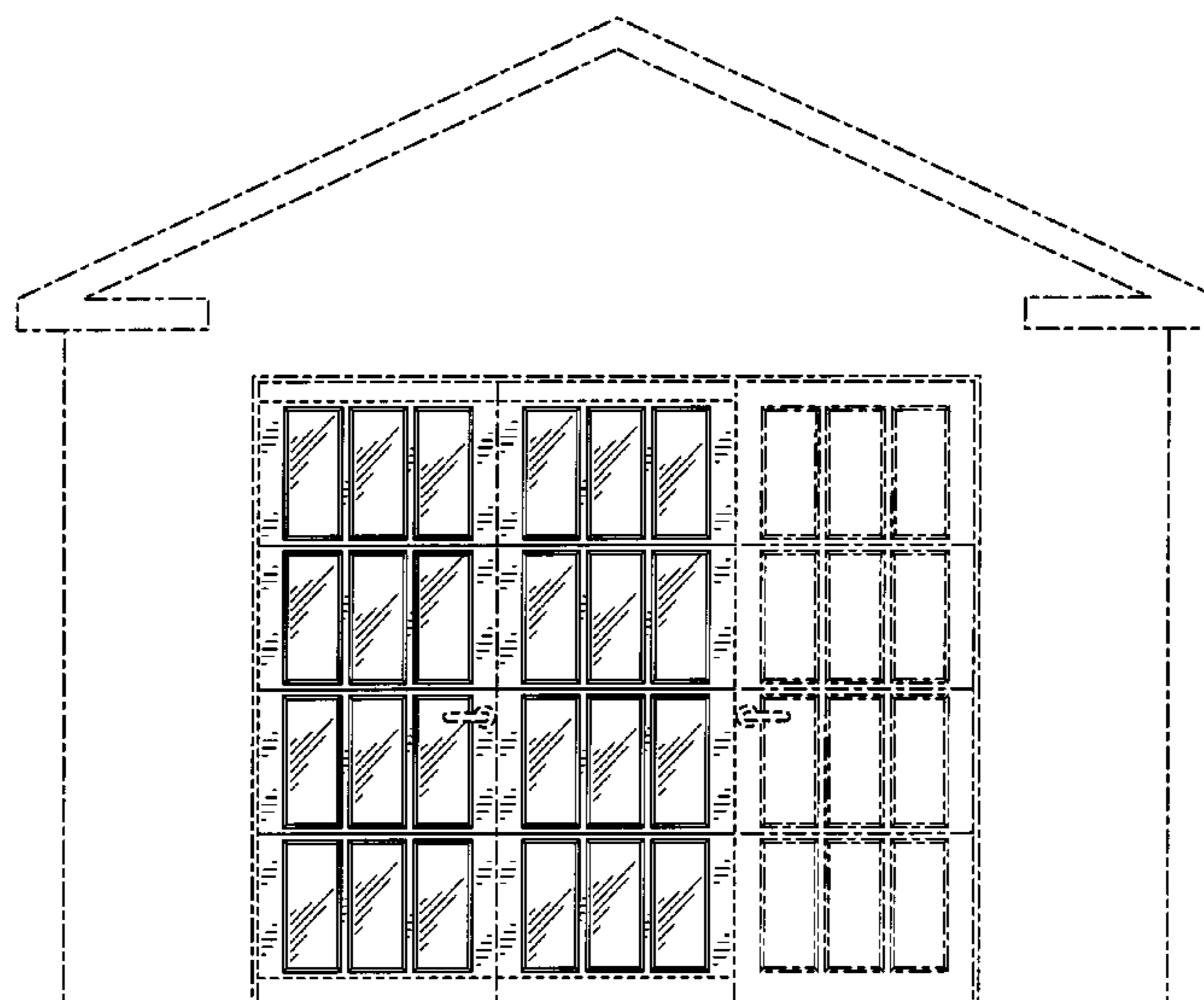
FIG. 5 is an elevational view of a portion of an overhead garage door facade showing a third embodiment of my new design in a closed configuration; and,

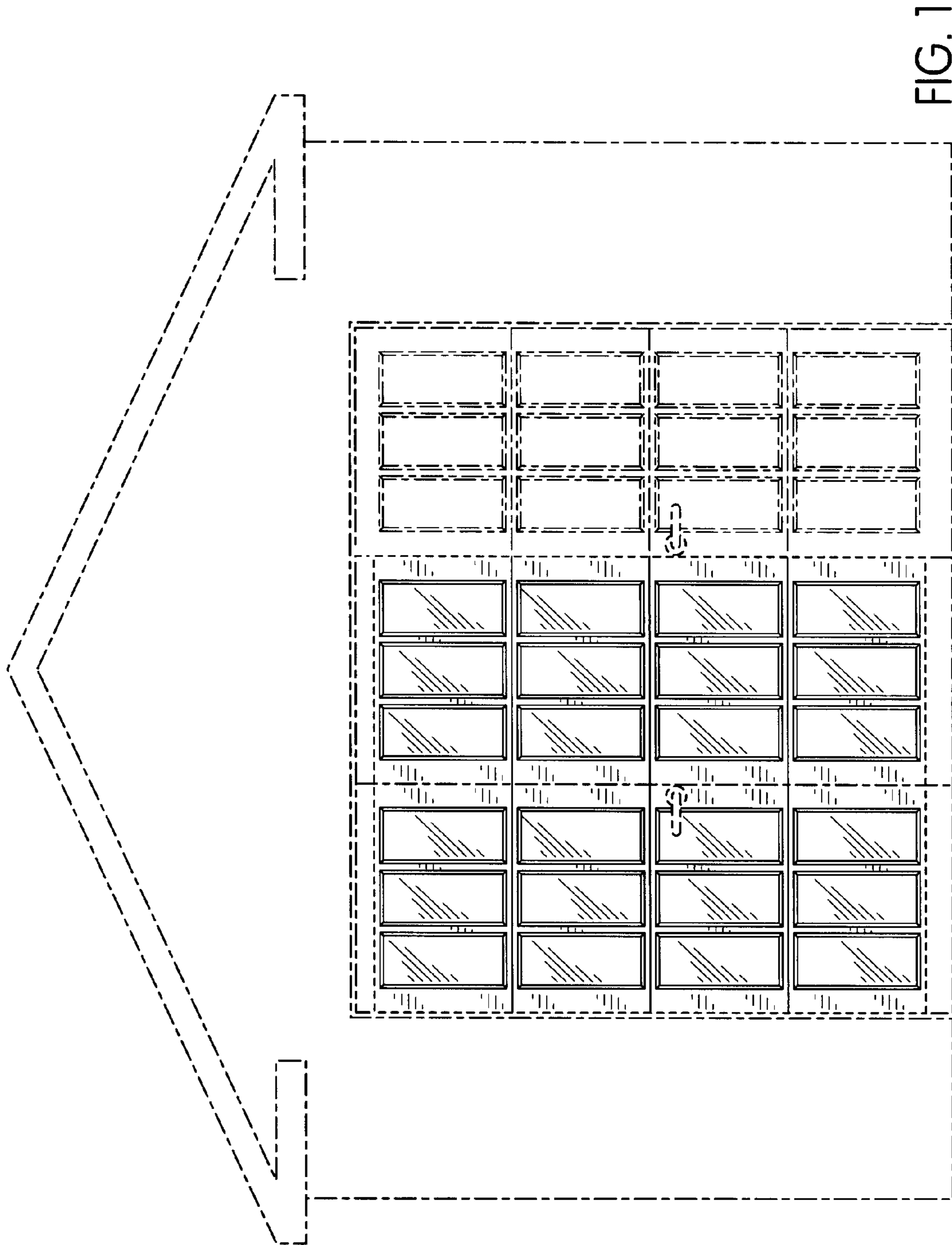

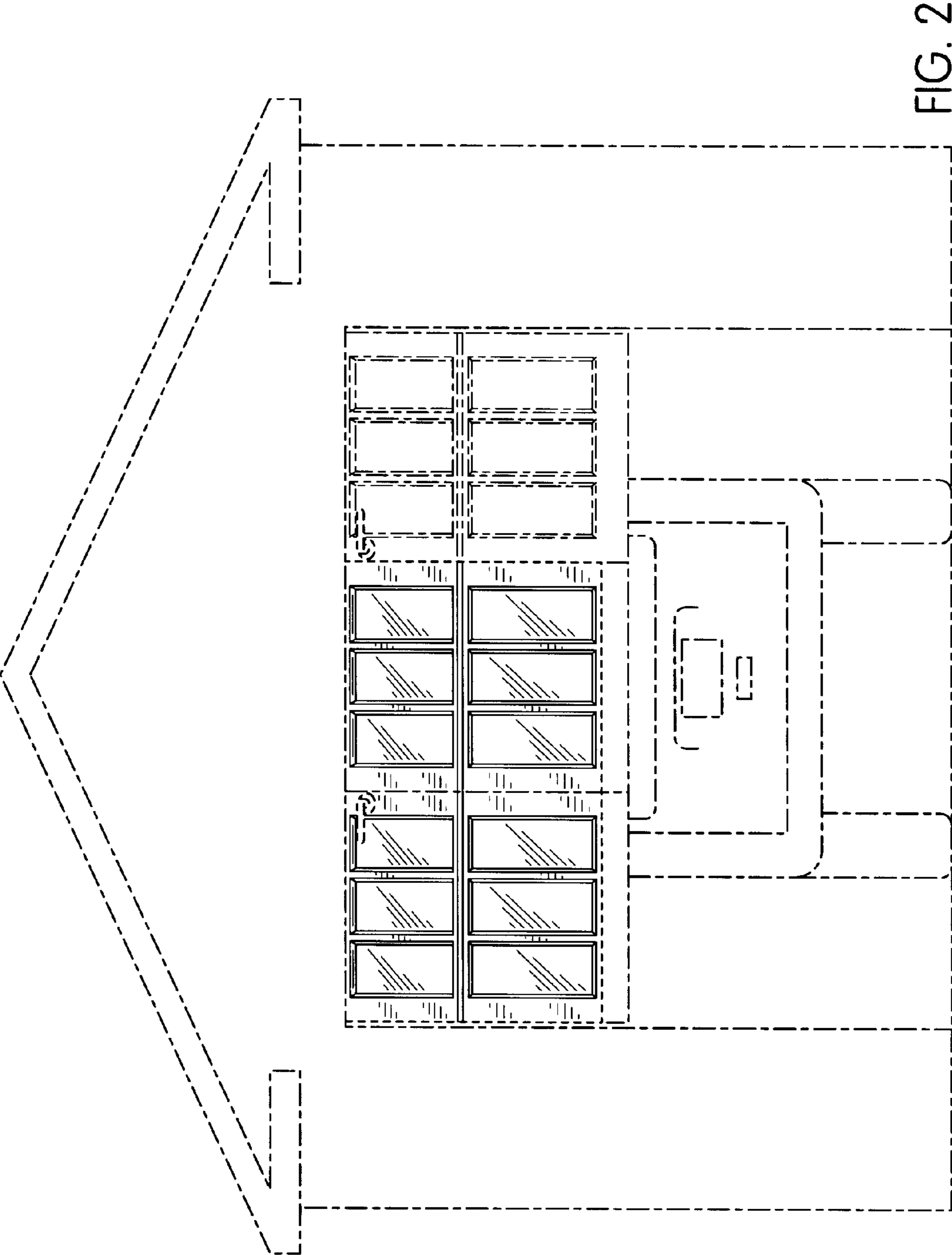
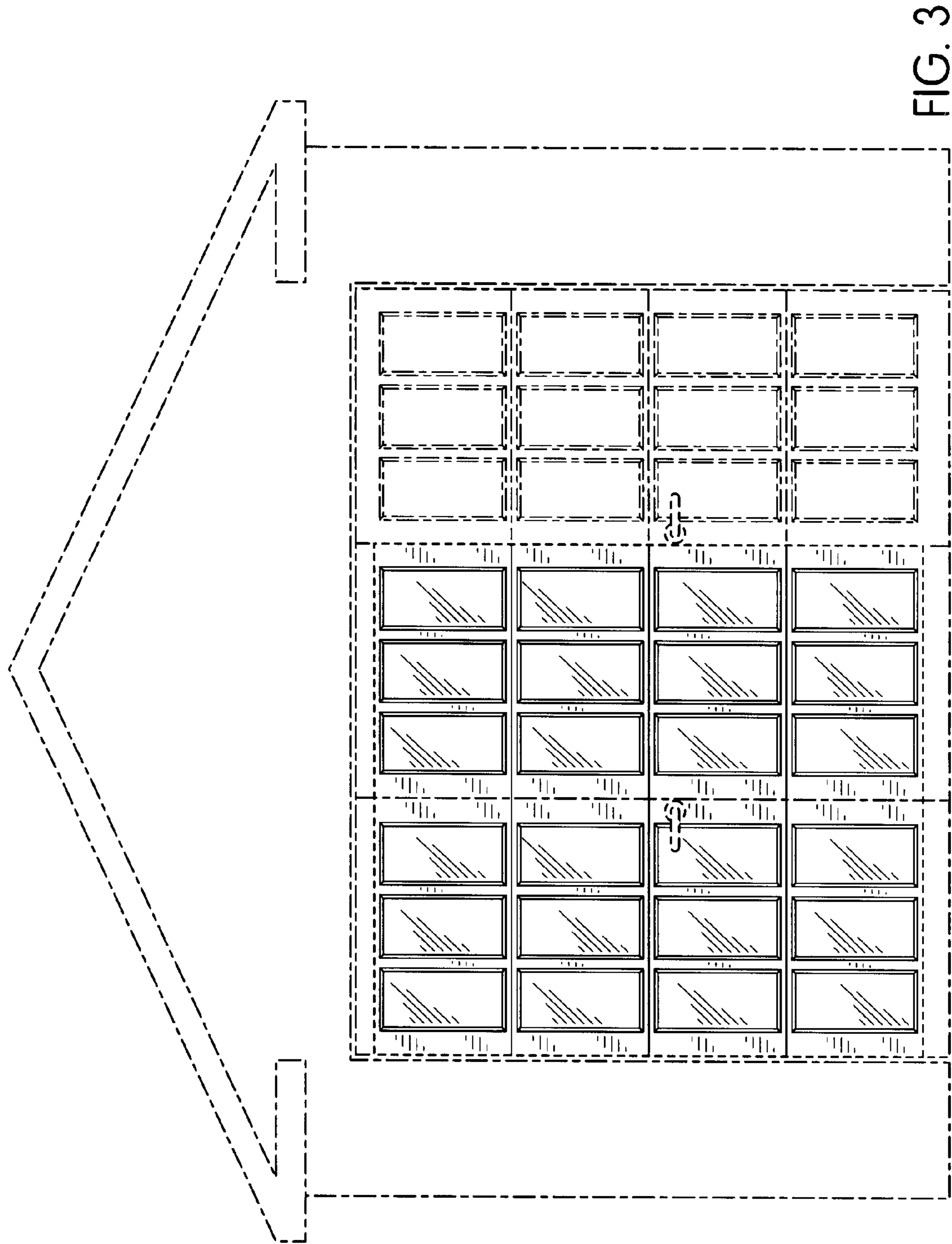

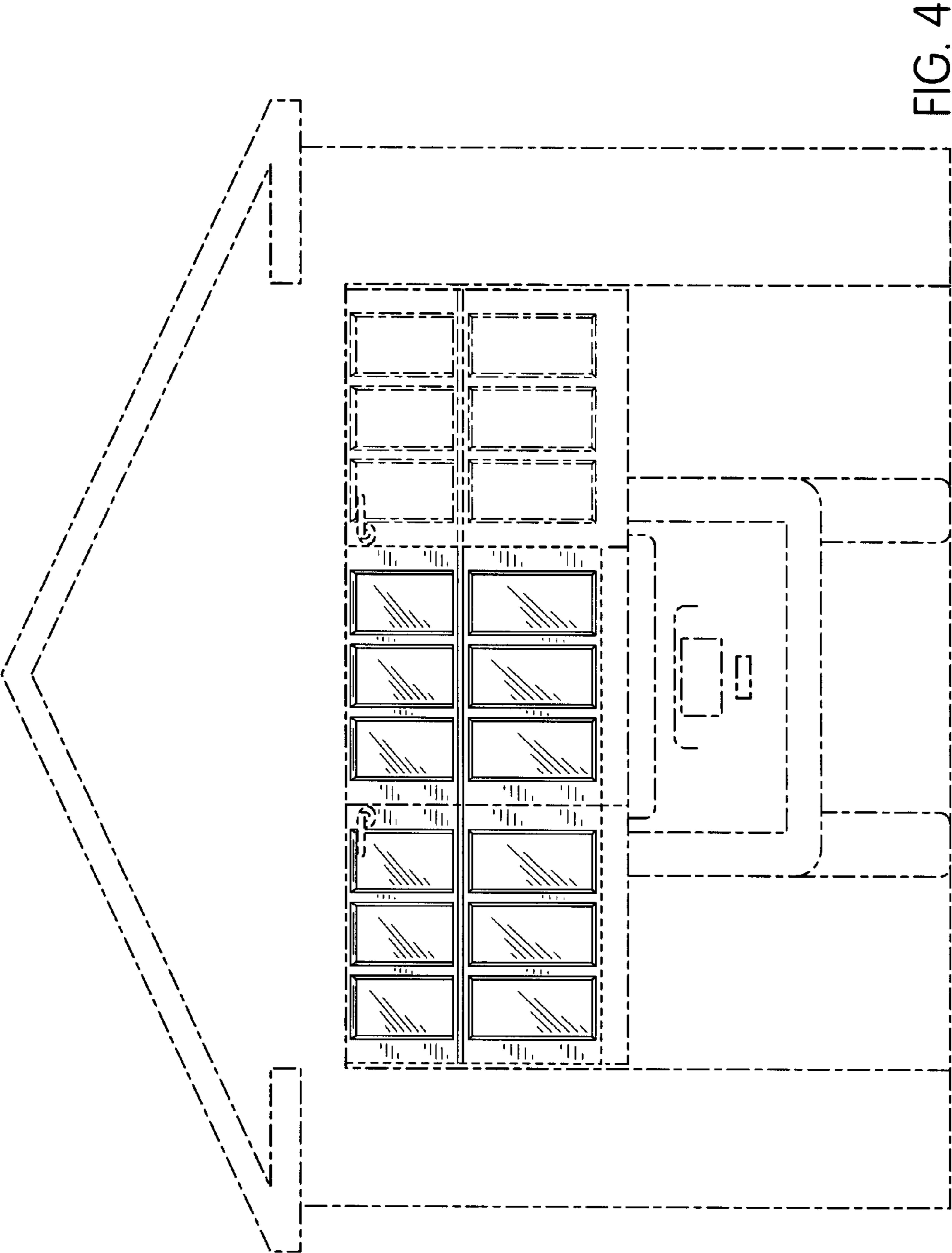

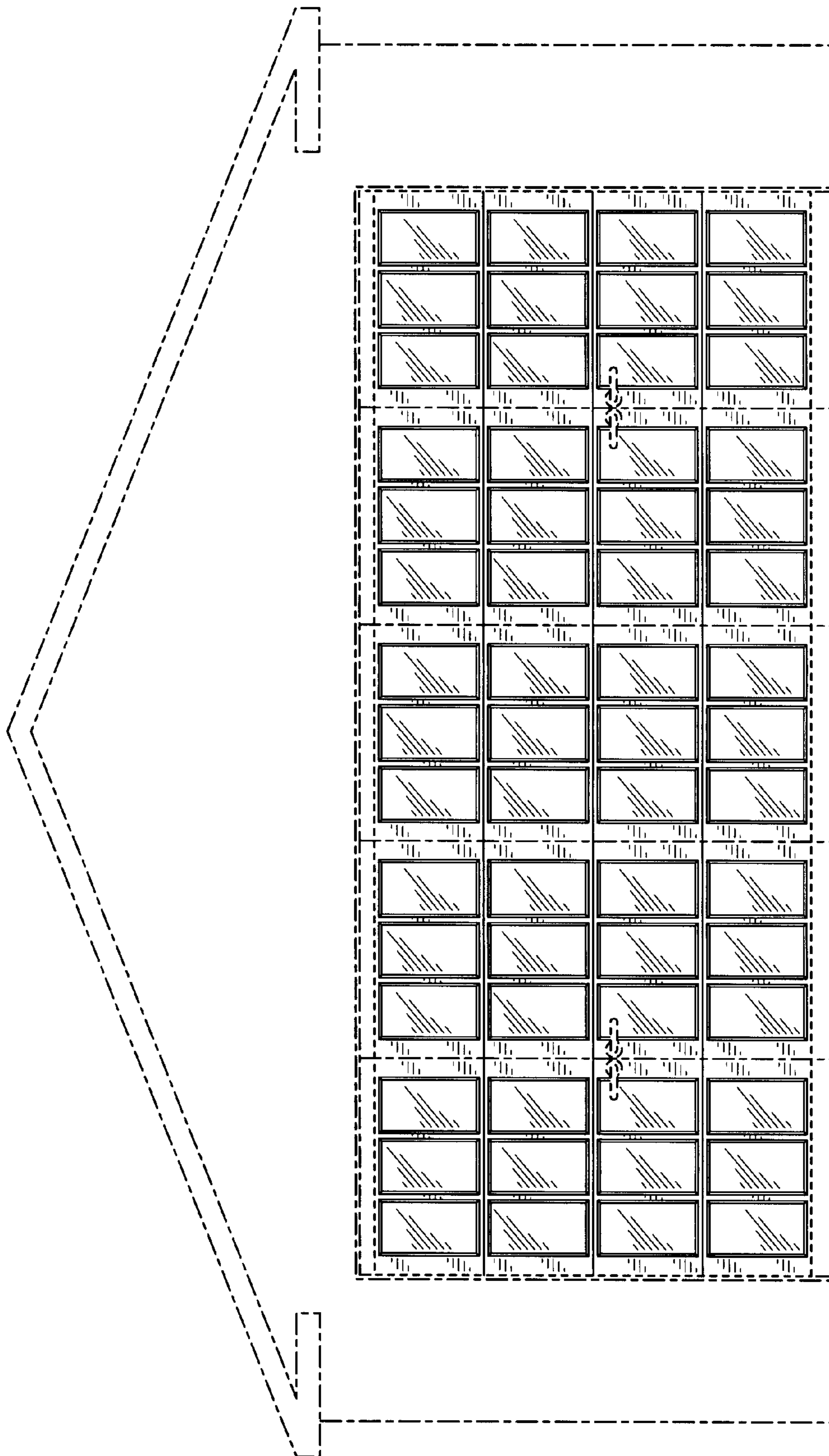

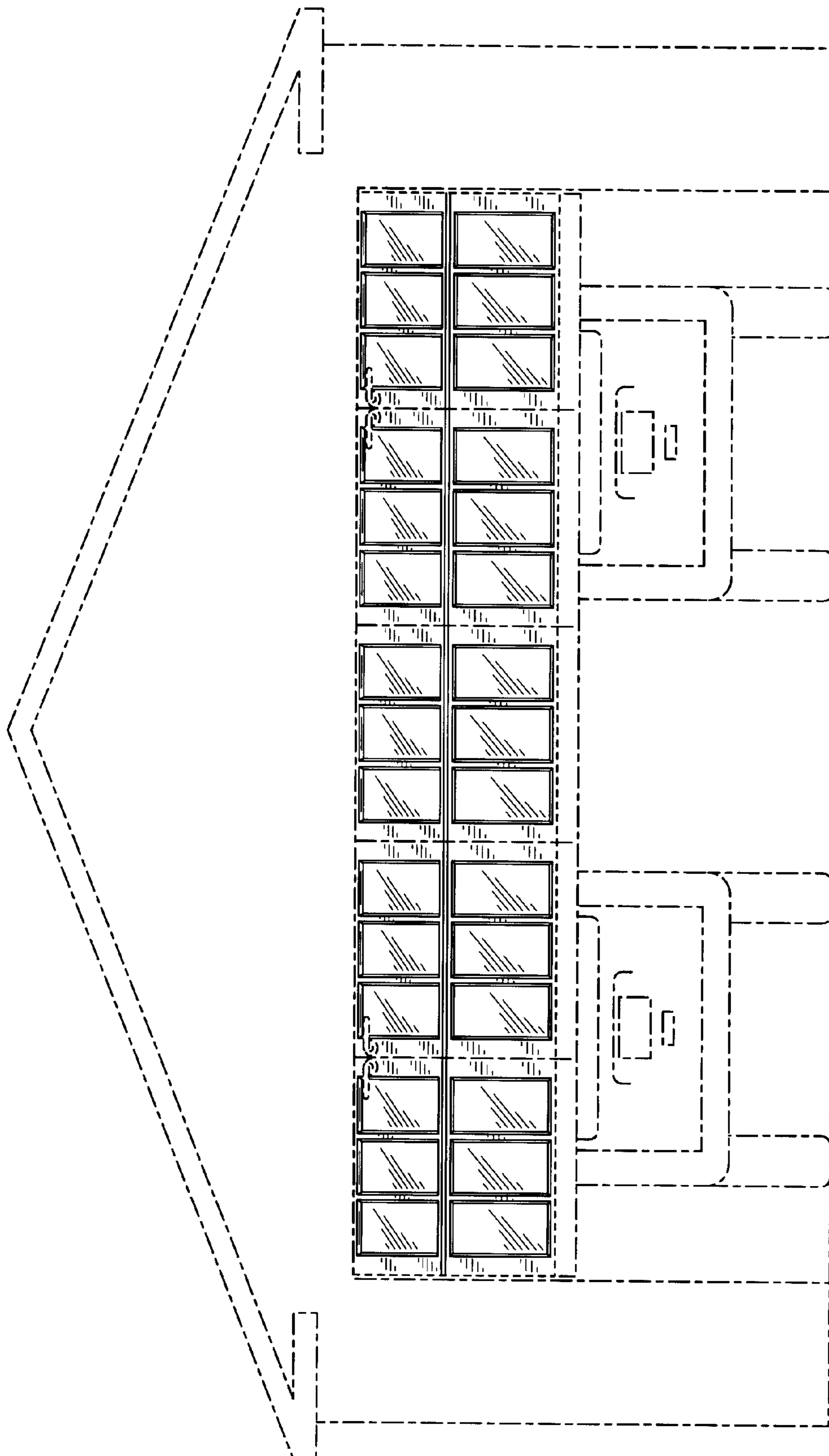
