DESCRIPTION

FIG. 1 is a perspective view of a swarf lamp with the base of the lamp abutting the ceiling, with the lamp being turned on;

FIG. 2 is another perspective view of a swarf lamp with the base of the lamp being spaced from the ceiling; and the lamp being turned on.

FIG. 3 is another perspective view of a swarf lamp with the base of the lamp being spaced from the ceiling; and the lamp being turned off.

FIGS. 4A to 4D are four elevational views of a swarf lamp with each view being taken at a different 90° angle around the circumference of the lamp along a plane horizontal to the ground, with the lamp being turned on; and,

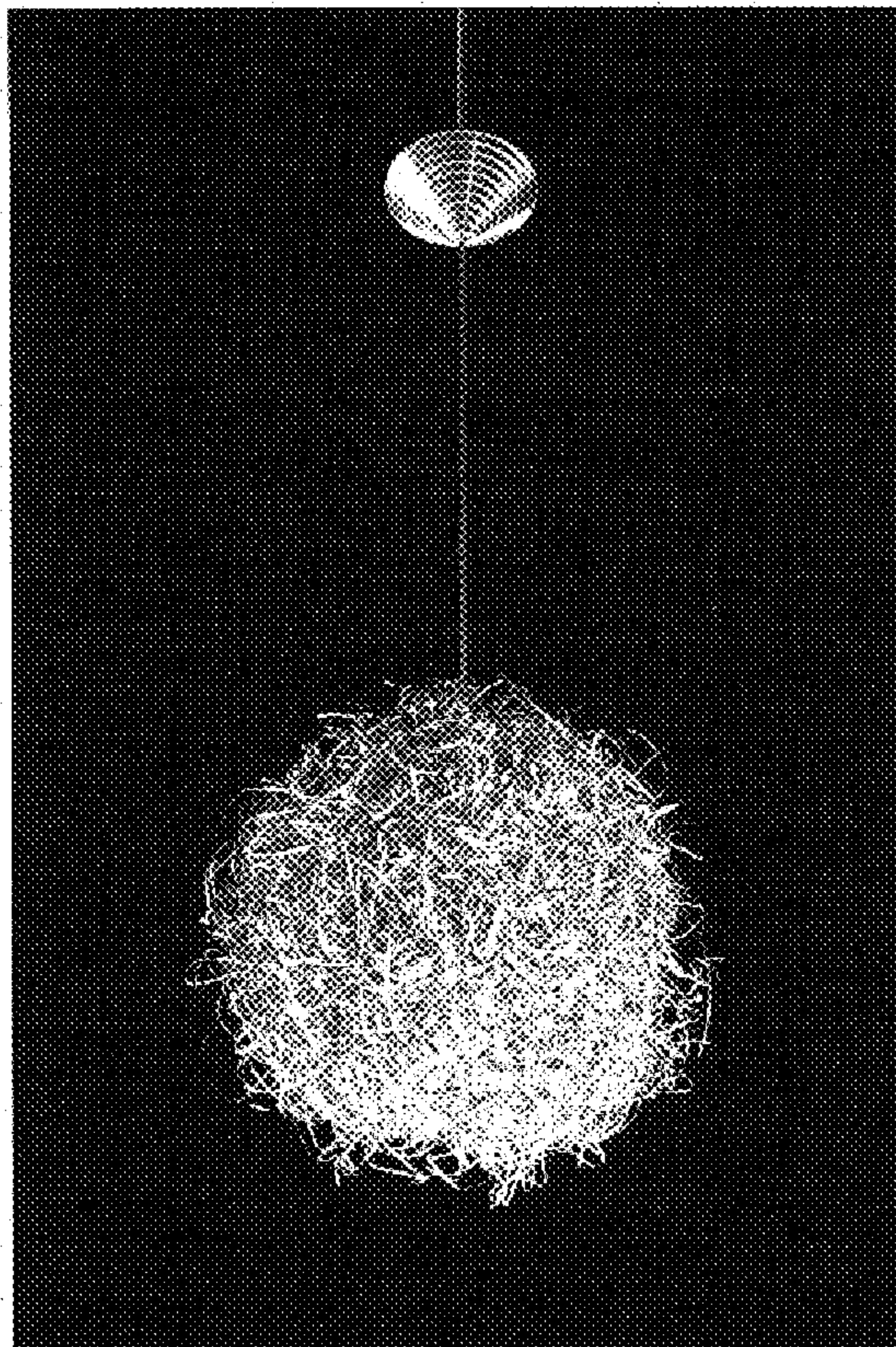
FIG. 5 is an enlarged bottom plan view of a swarf lamp hanging from a ceiling; with the lamp being turned on.

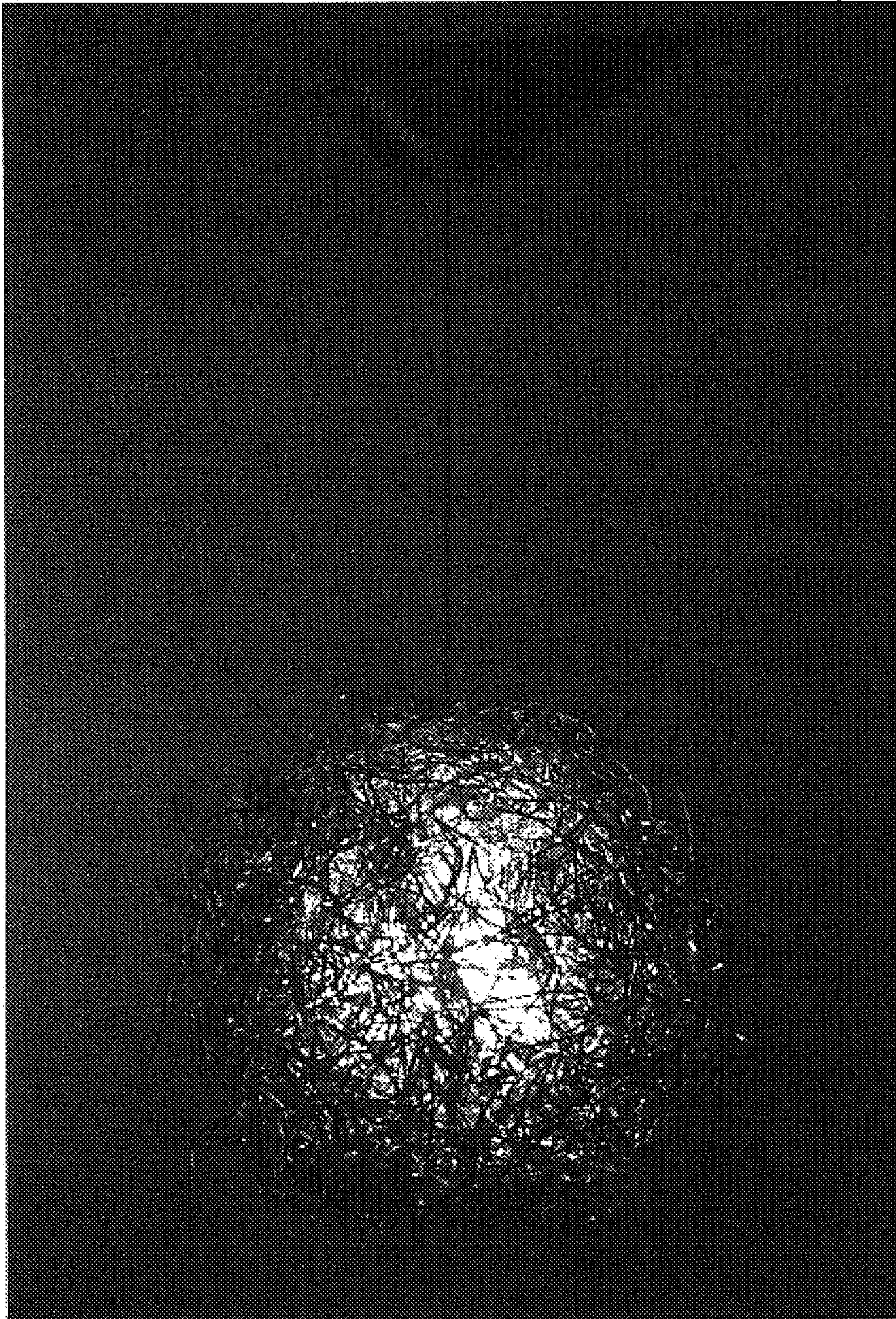

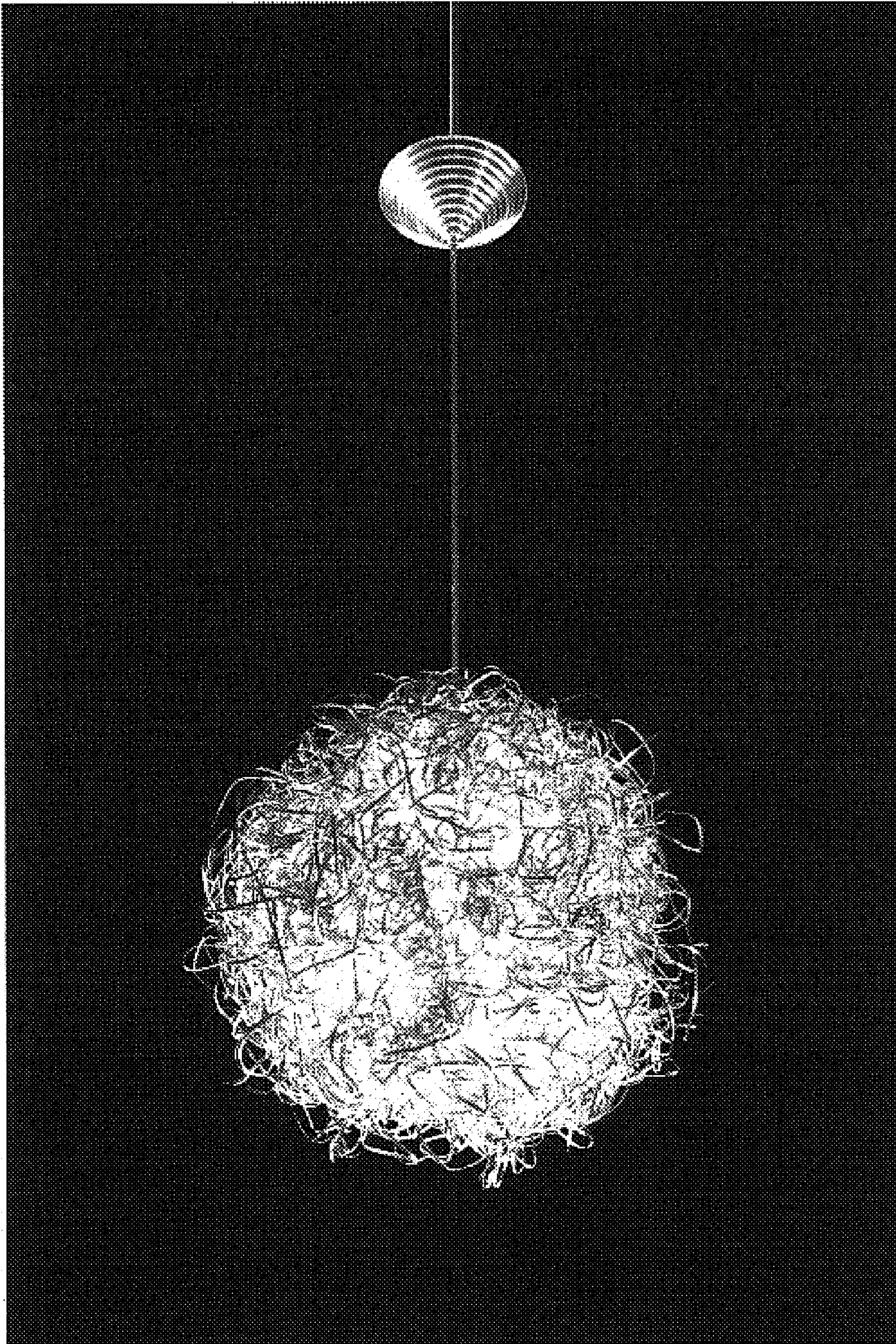

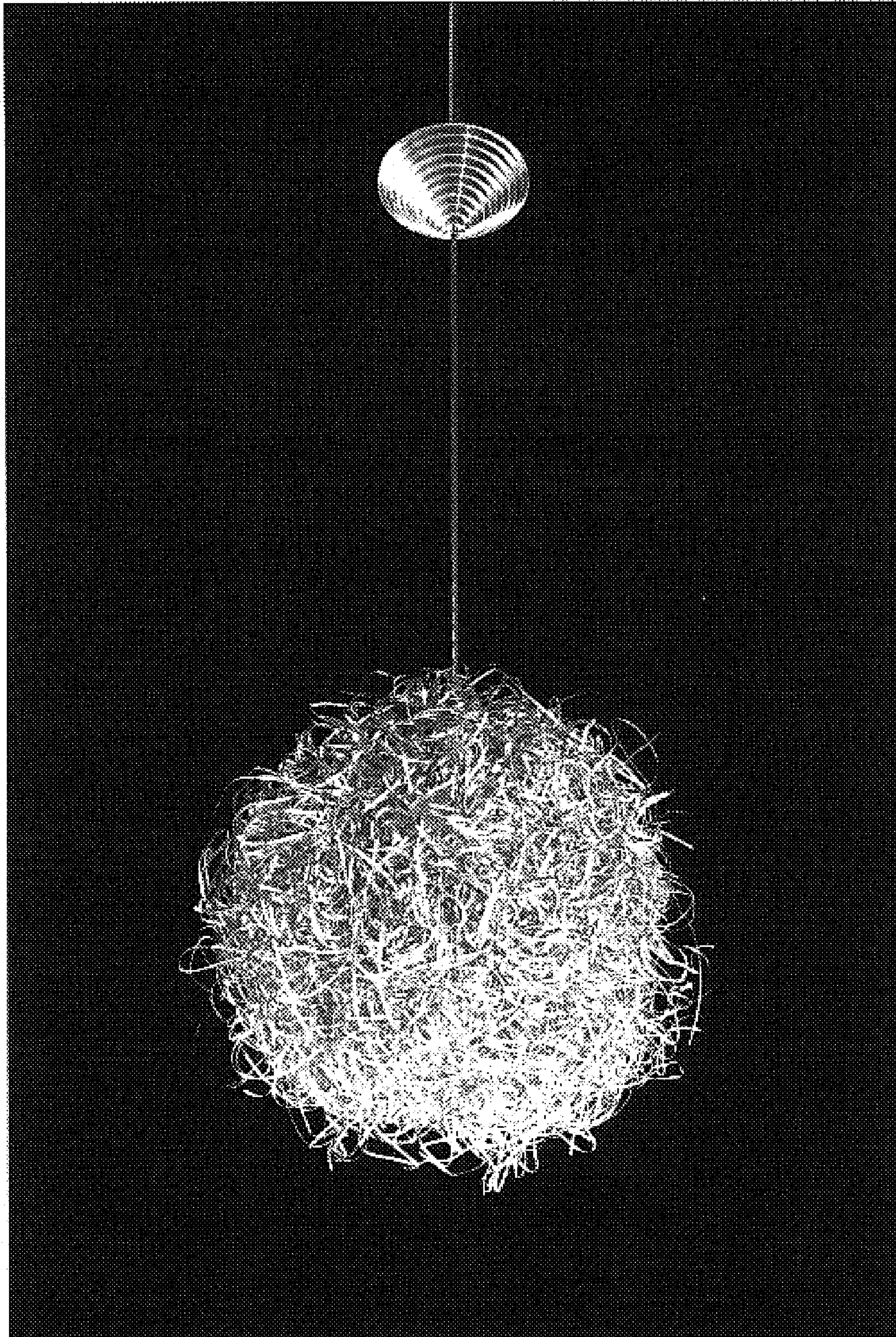

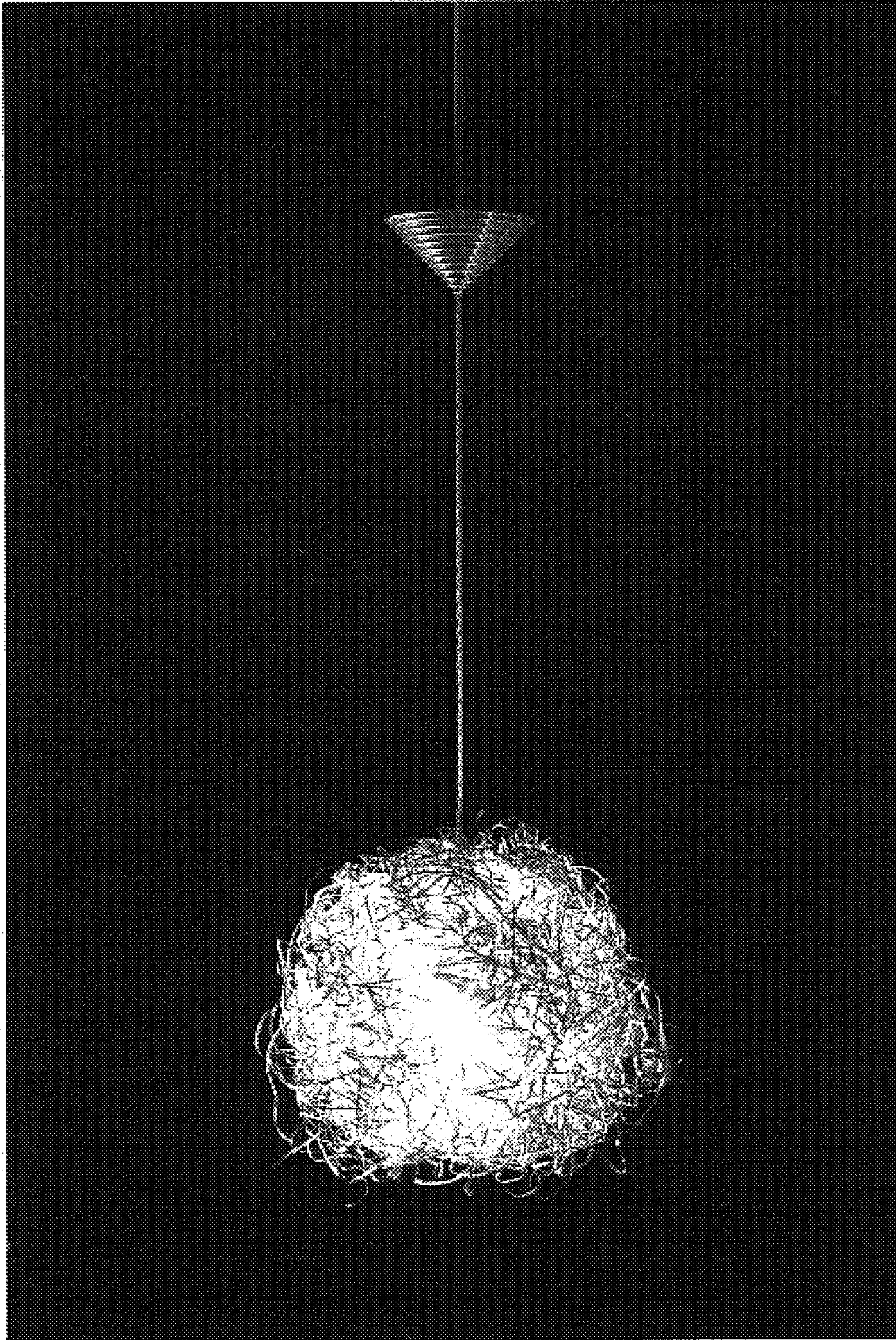

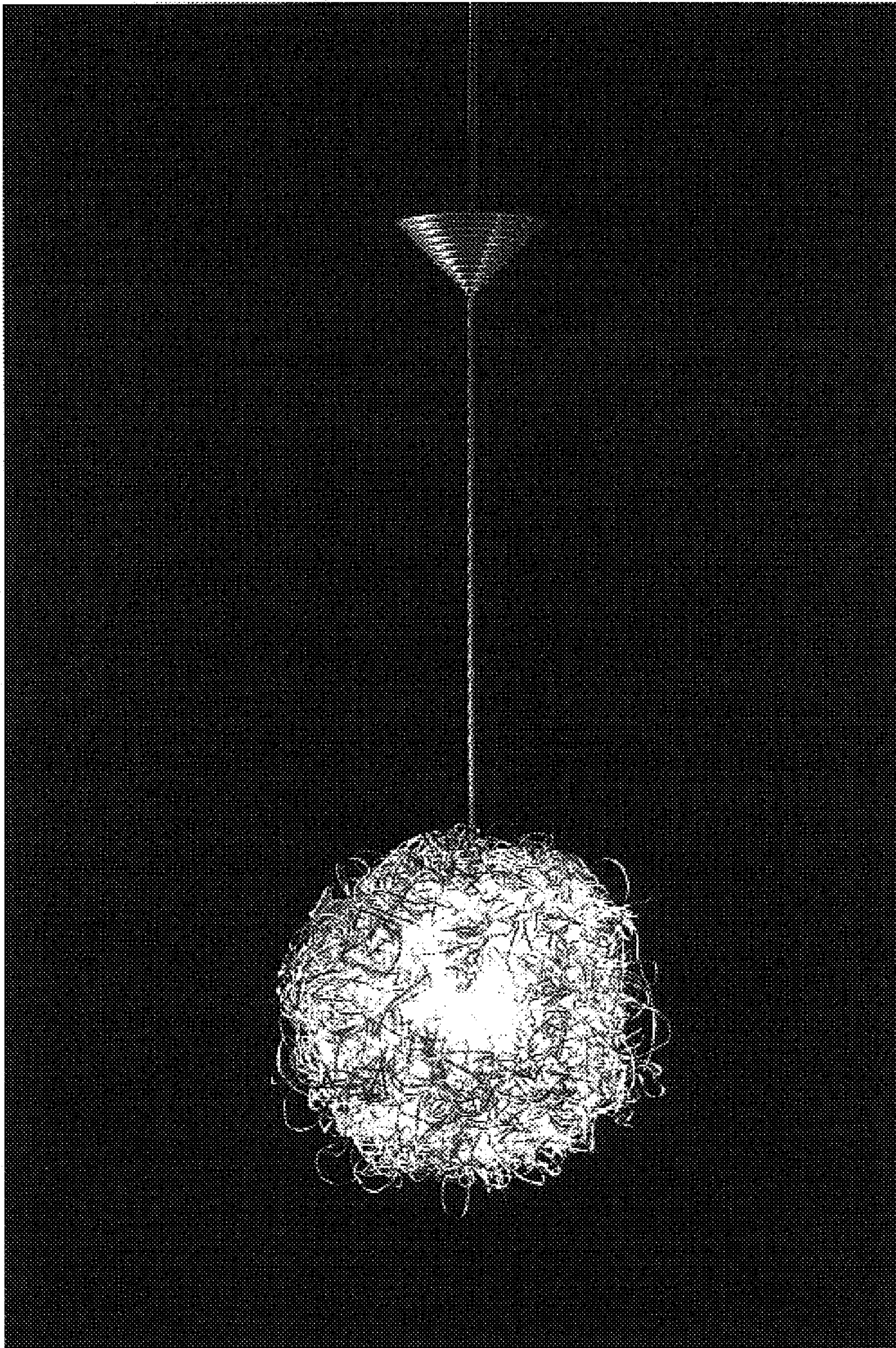

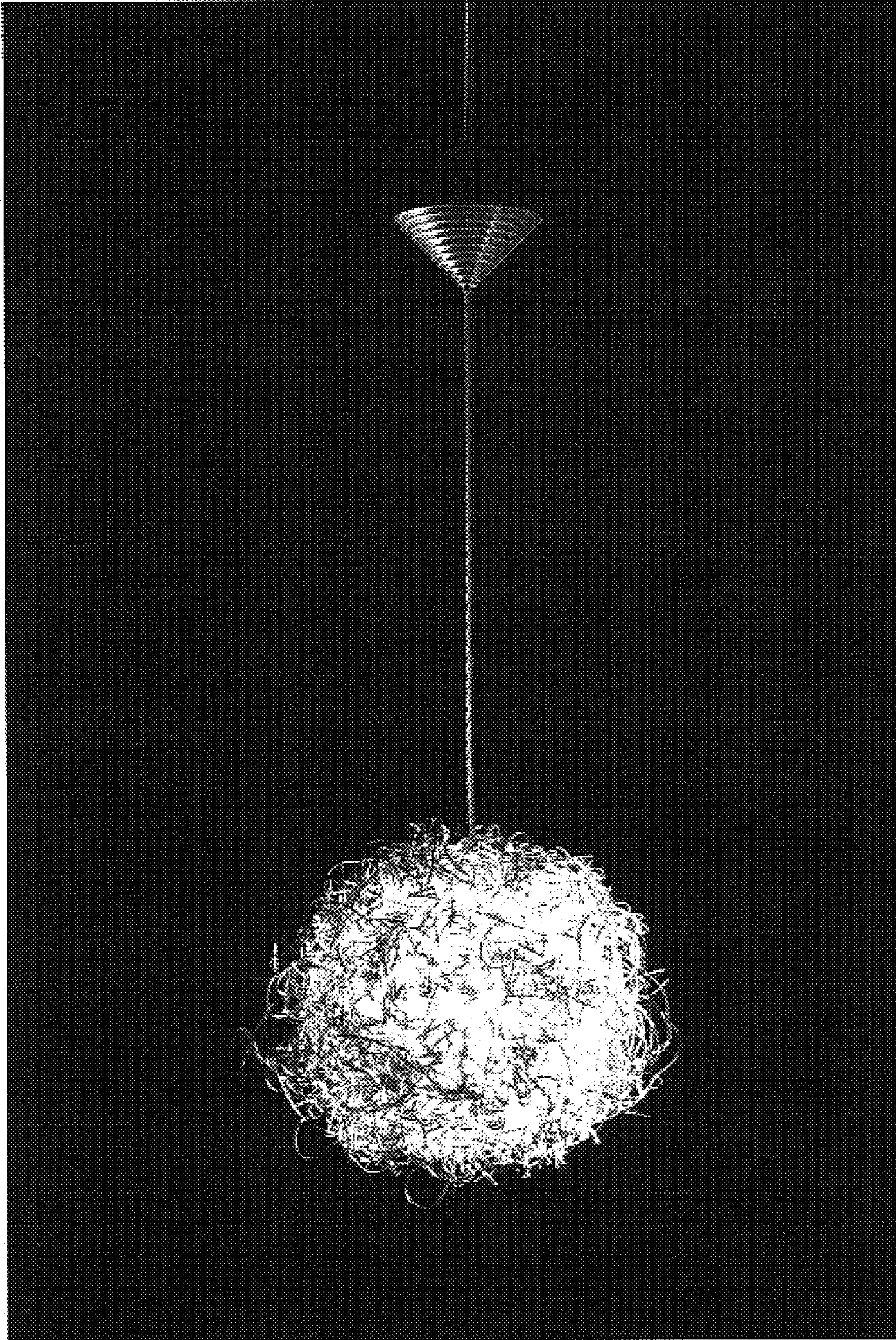

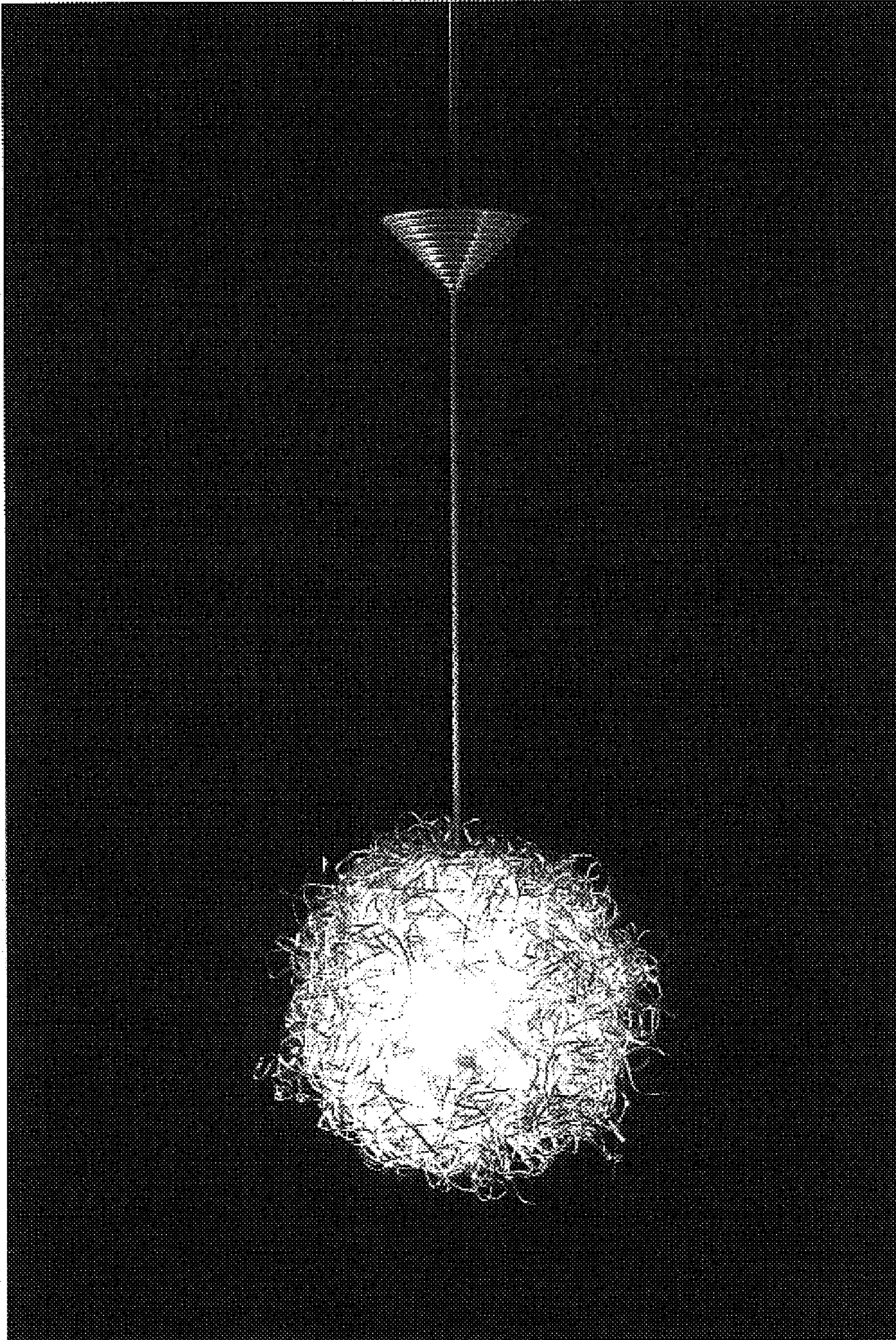

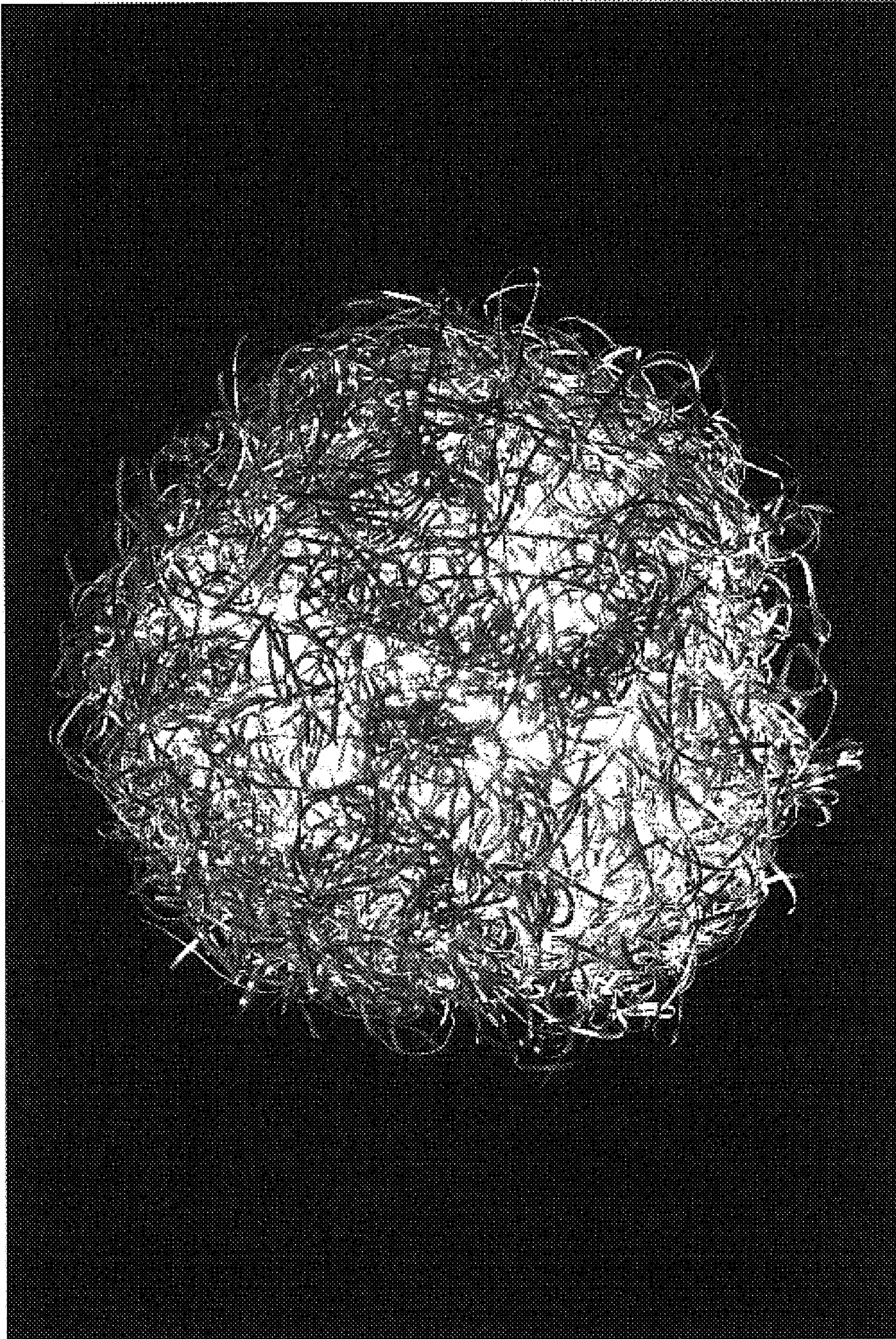
