(57) **CLAIM**

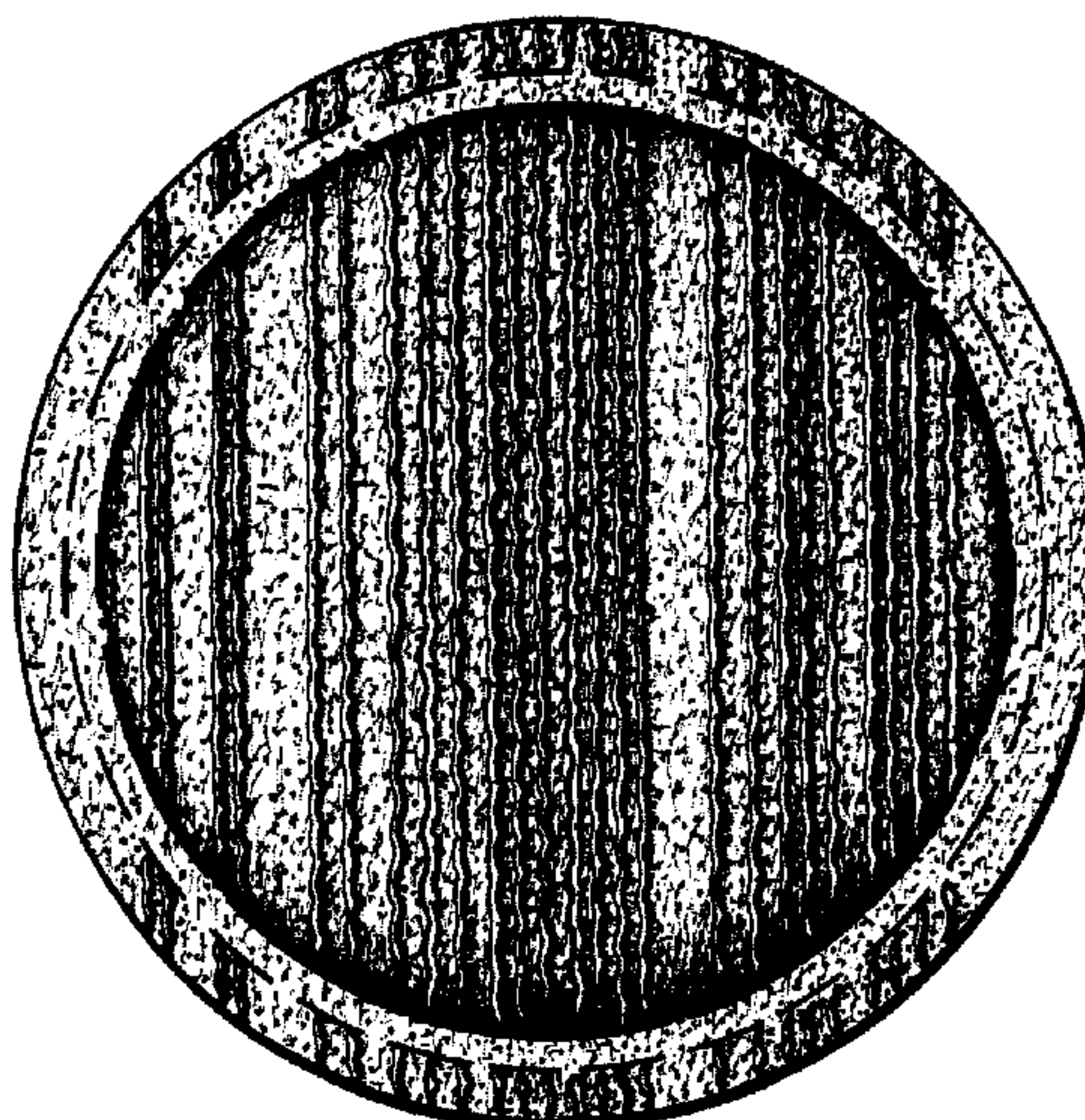
The ornamental design for a skin treatment article, as shown and described.

DESCRIPTION

FIG. 1 is a plan view of one side of the skin treatment article showing my new design;
FIG. 2 is a plan view of the opposite side thereof;
FIG. 3 is a side view thereof; and,
FIG. 4 is an enlarged fragmented view of the surface of FIG. 1.

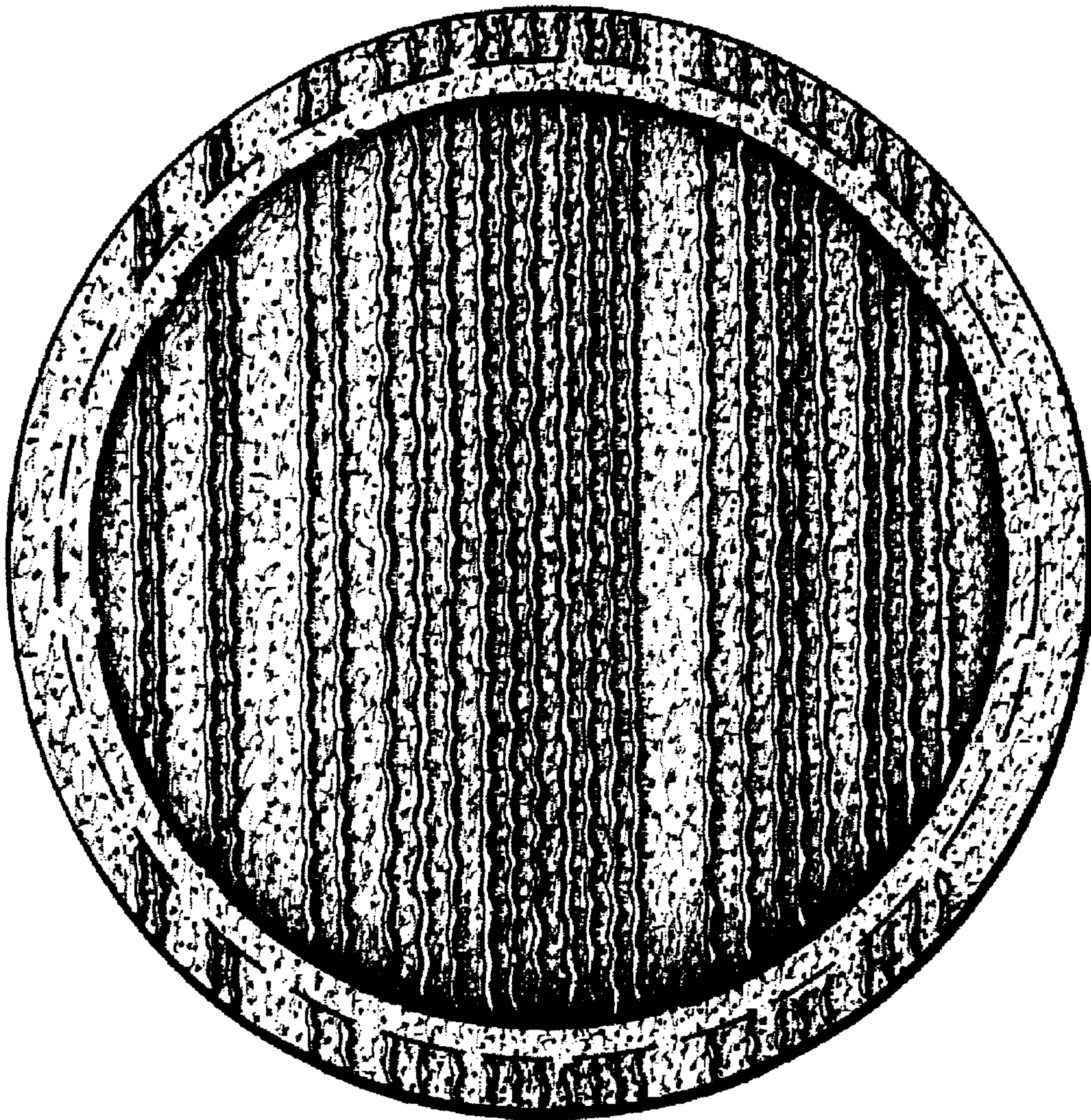

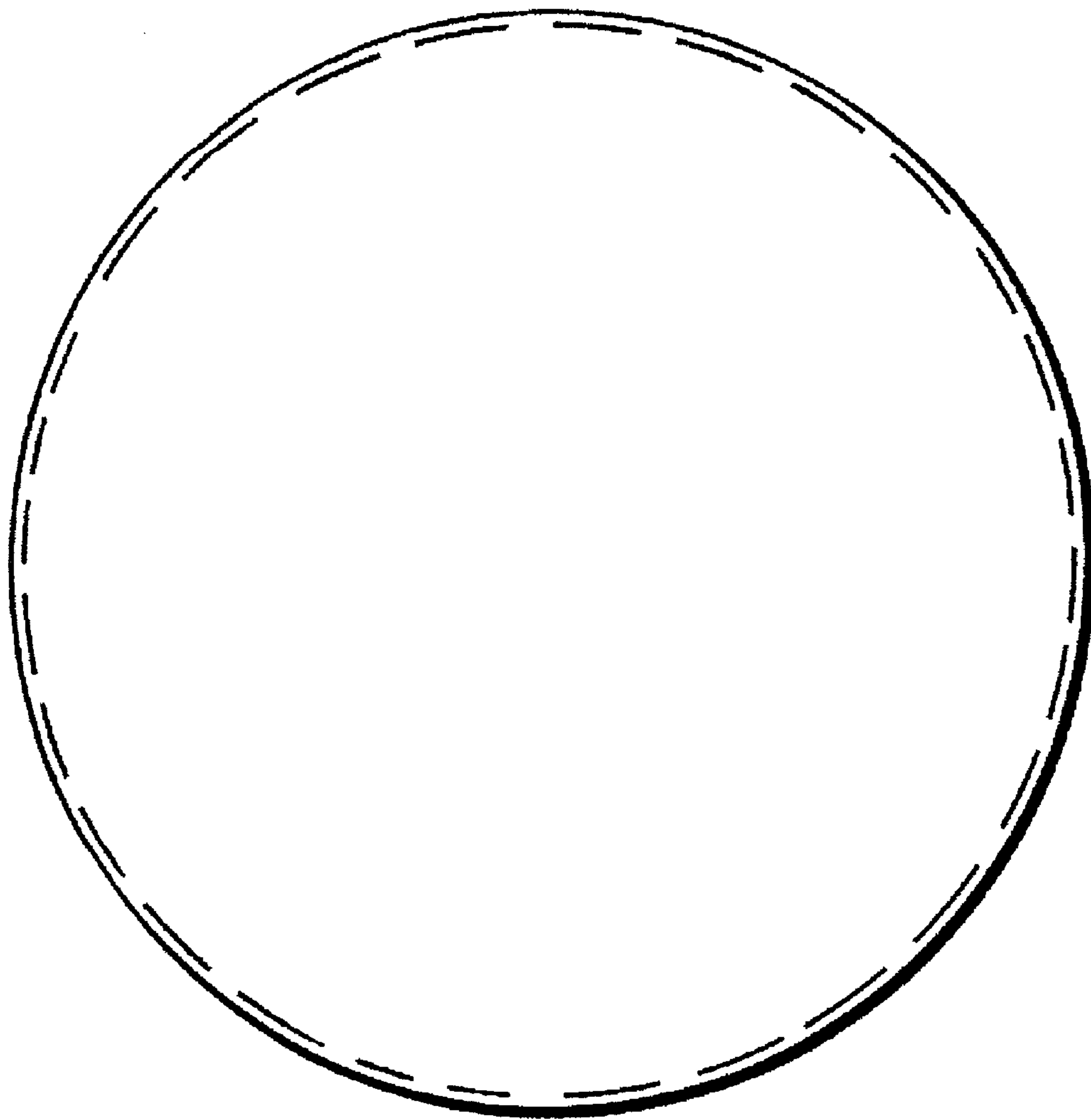

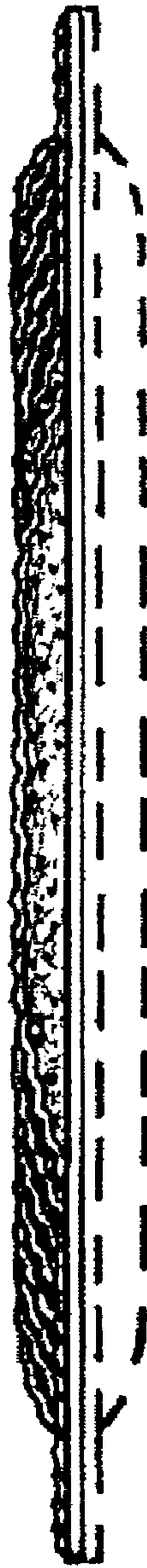
