DESCRIPTION

FIG. 3 is a front elevational view thereof, the rear view being a mirror image thereof;

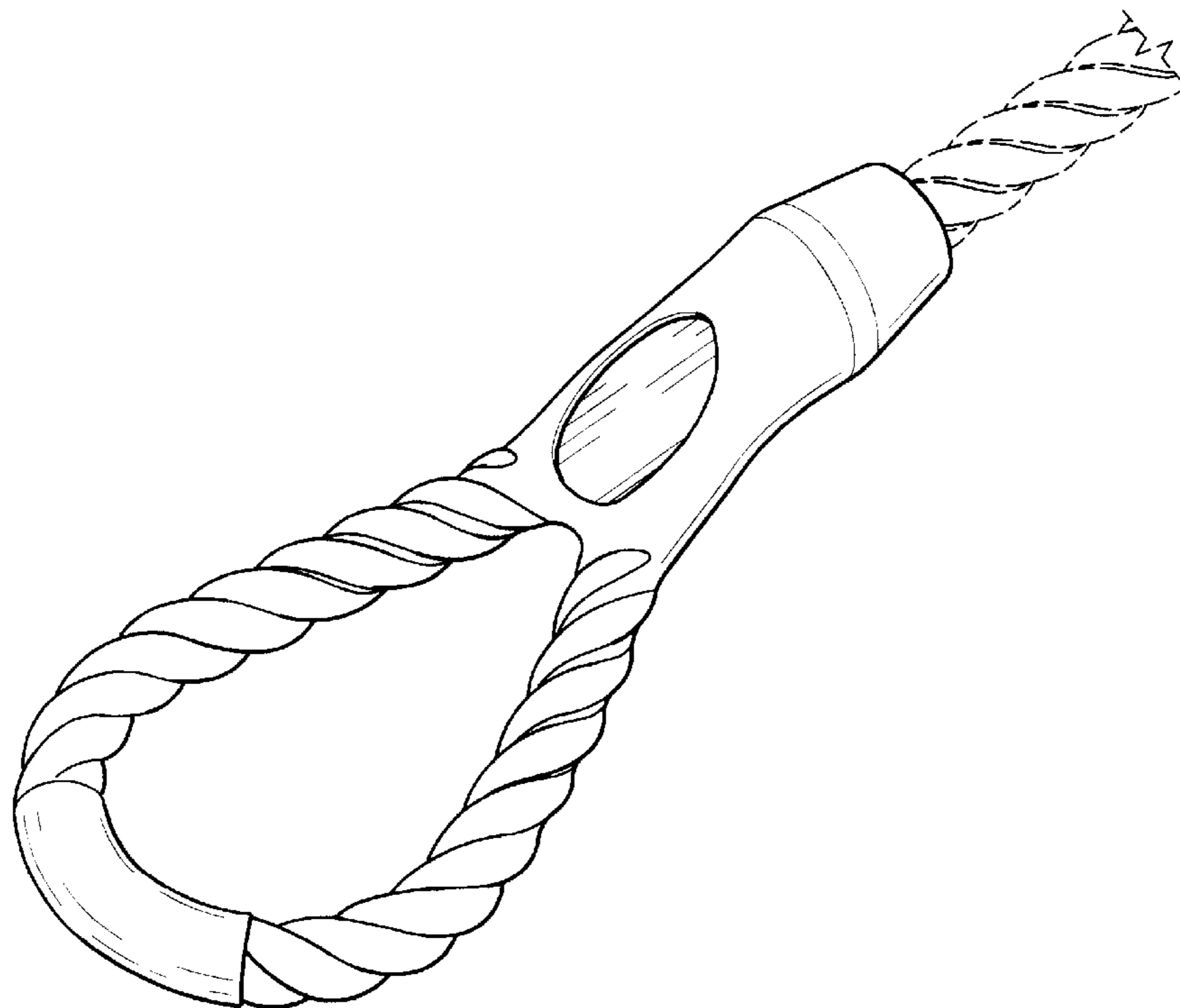
FIG. 4 is a bottom plan view thereof;

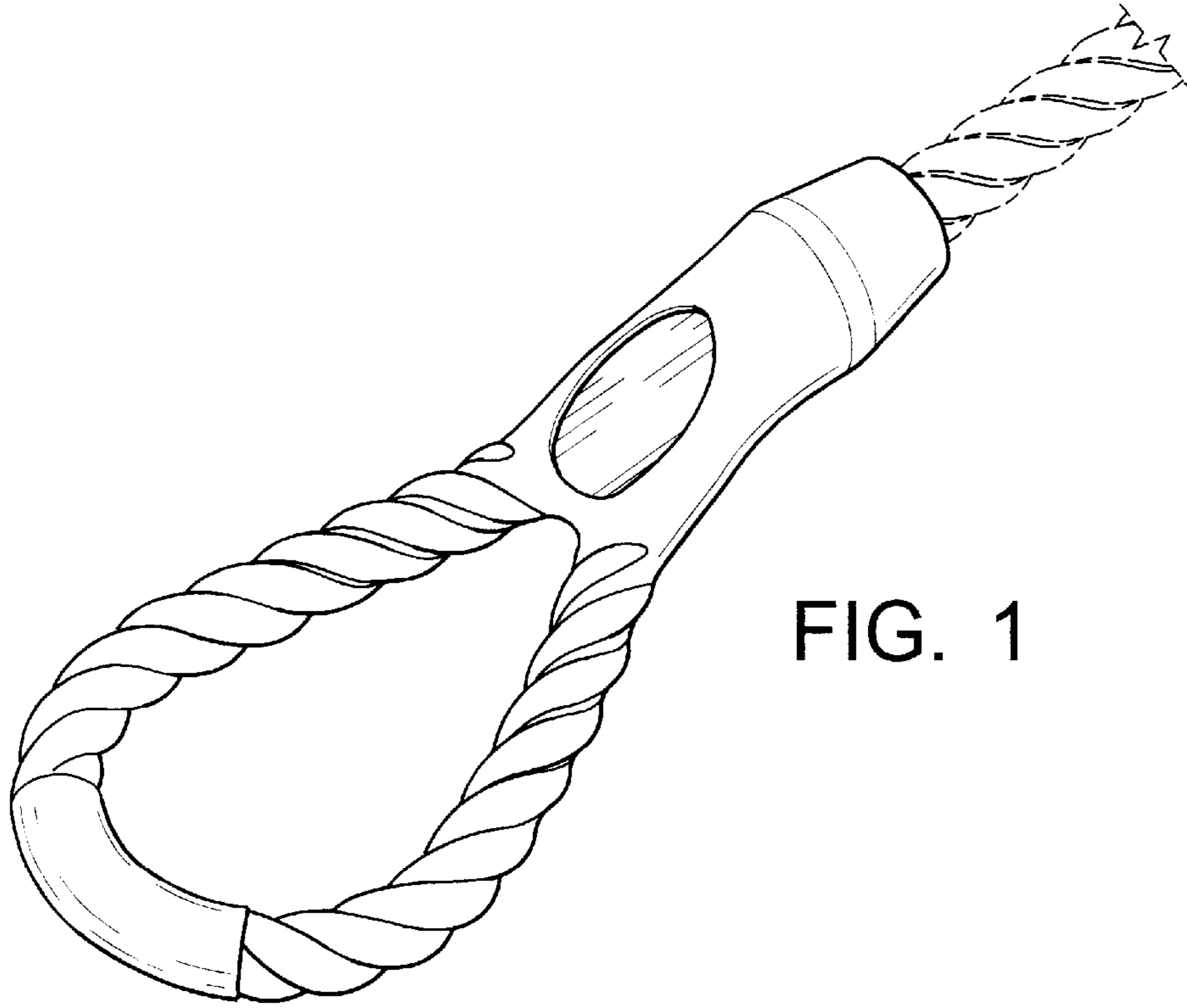

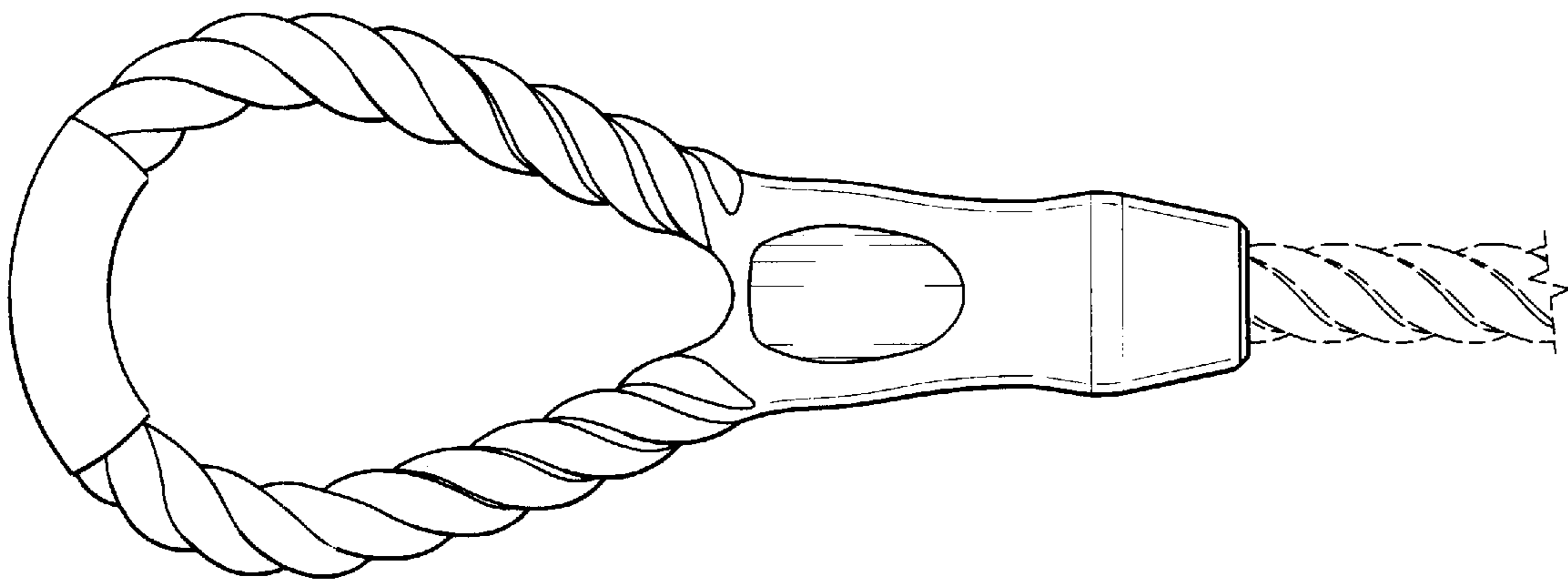

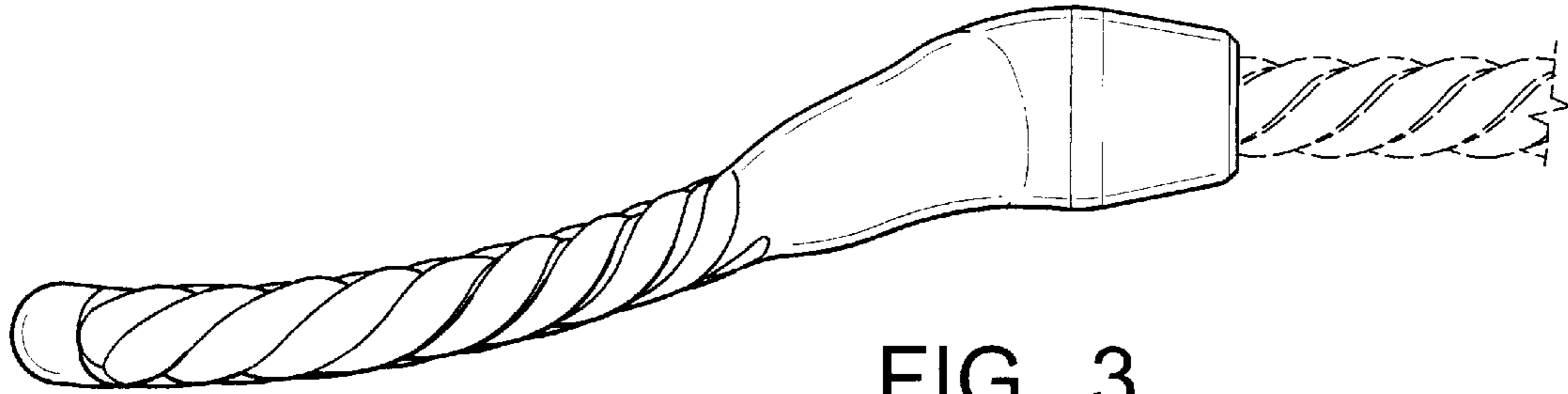

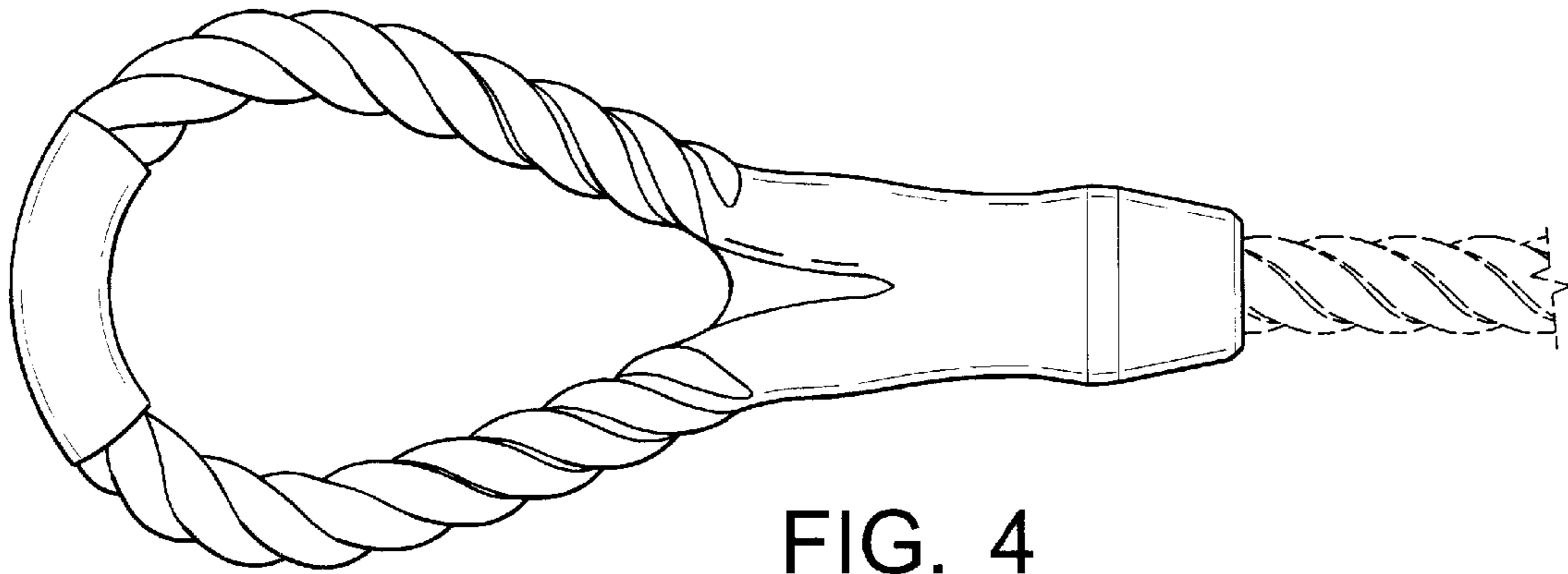

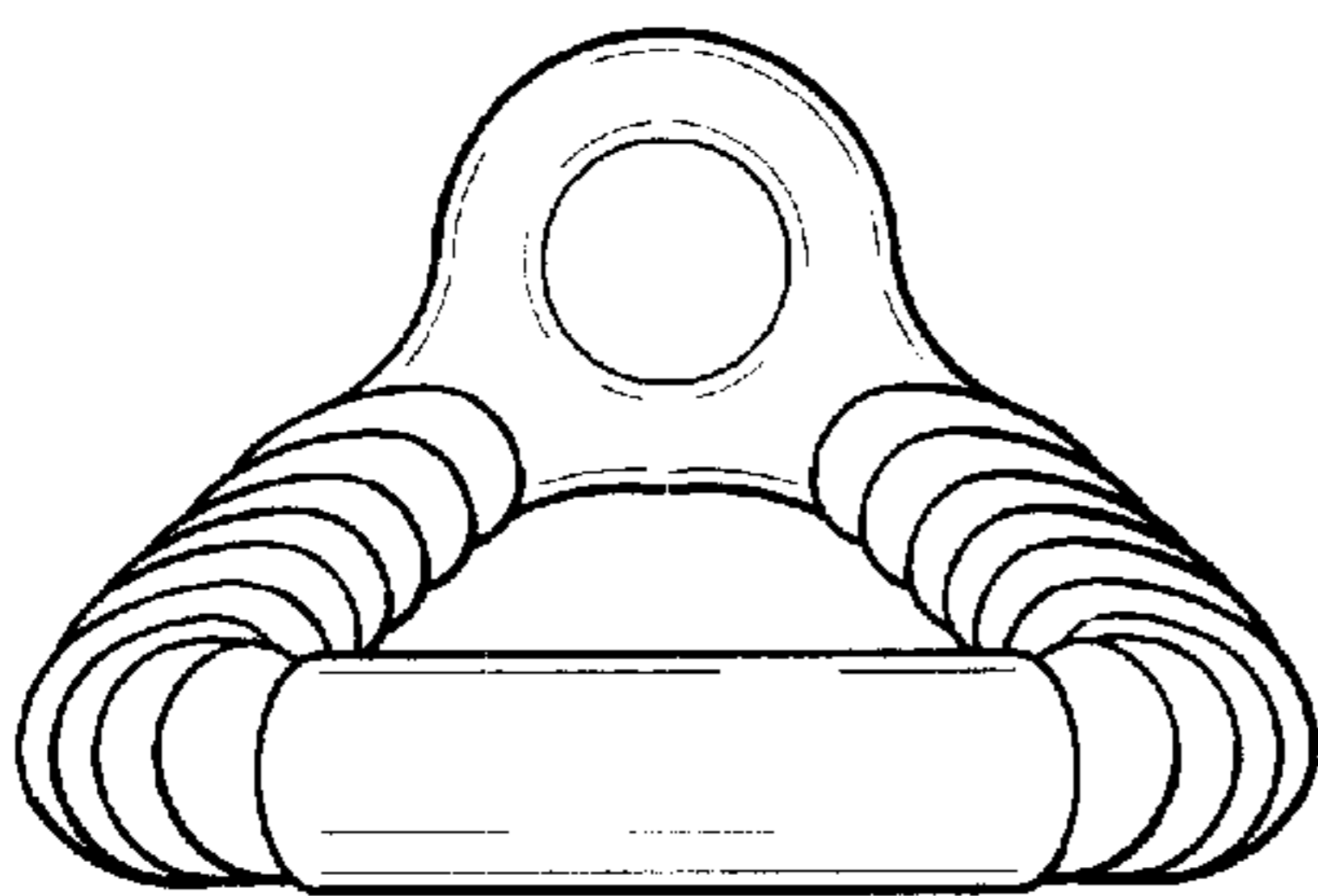

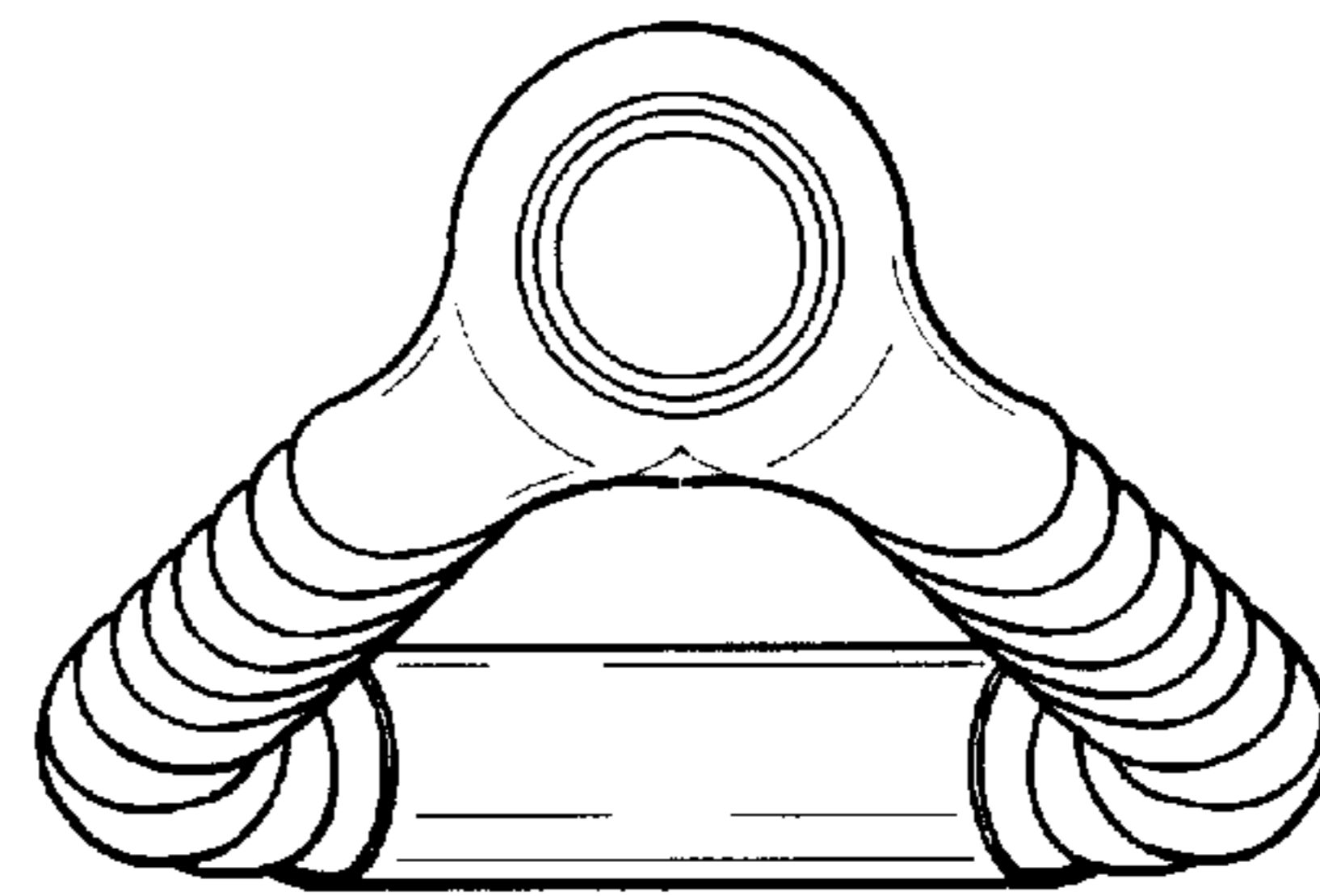
