(57) **CLAIM**

The ornamental design for an extendible pallet guard, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front view of an extendible pallet guard showing my new design;

FIG. 2 is a rear view of the design;

FIG. 4 is a front view section of the design;

FIG. 5 is a front view of the design with an extended panel;

FIG. 6 is a rear view of the design with an extended panel;

FIG. 7 is a rear view section of the design with an extended panel;

FIG. 8 is a front view section of two panels joined at 180° with each other;

FIG. 9 is a front perspective view of the panels of FIG. 8;

FIG. 10 is a side view of the panels of FIG. 8;

FIG. 11 is another side view of the panels of FIG. 8;

FIG. 12 is a rear perspective view of the panels of FIG. 8;

FIG. 13 is a rear view of the panels of FIG. 8;

FIG. 14 is a front perspective view of two panels joined at 90° with each other;

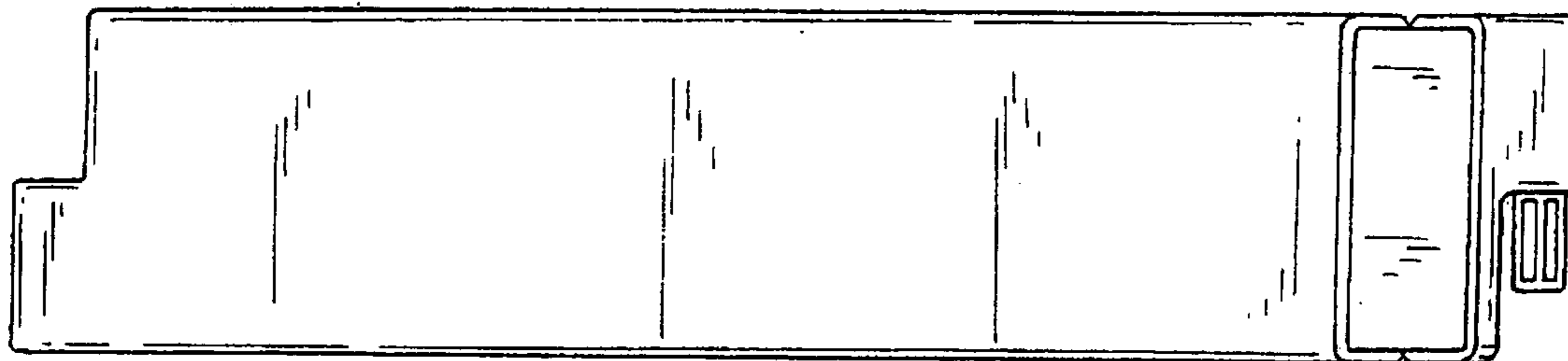
FIG. 15 is a top perspective view of the panels of FIG. 14; and,

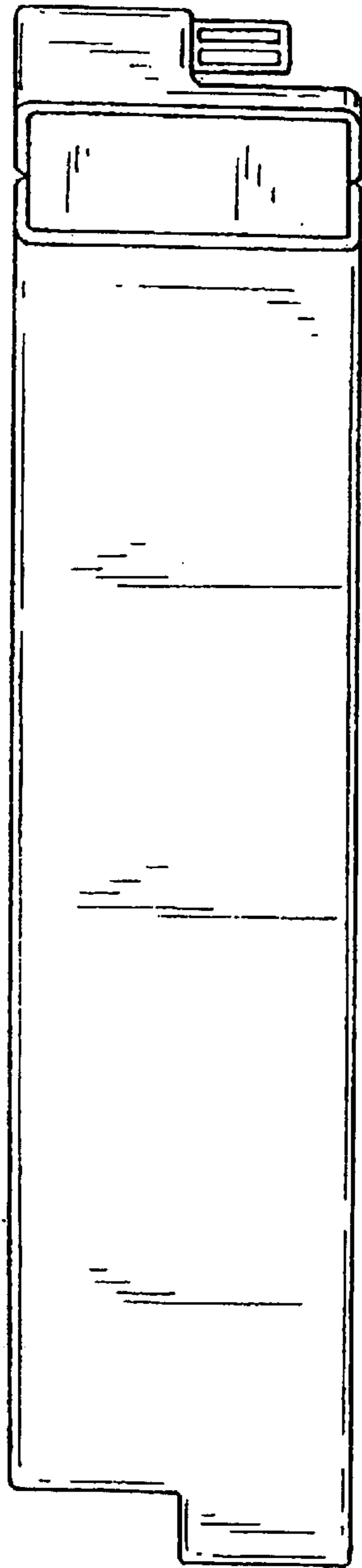

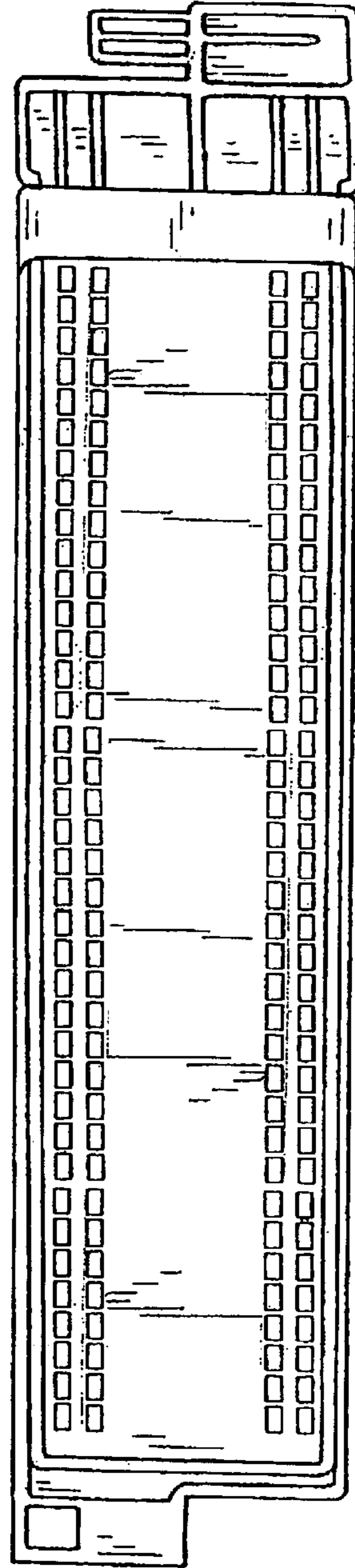

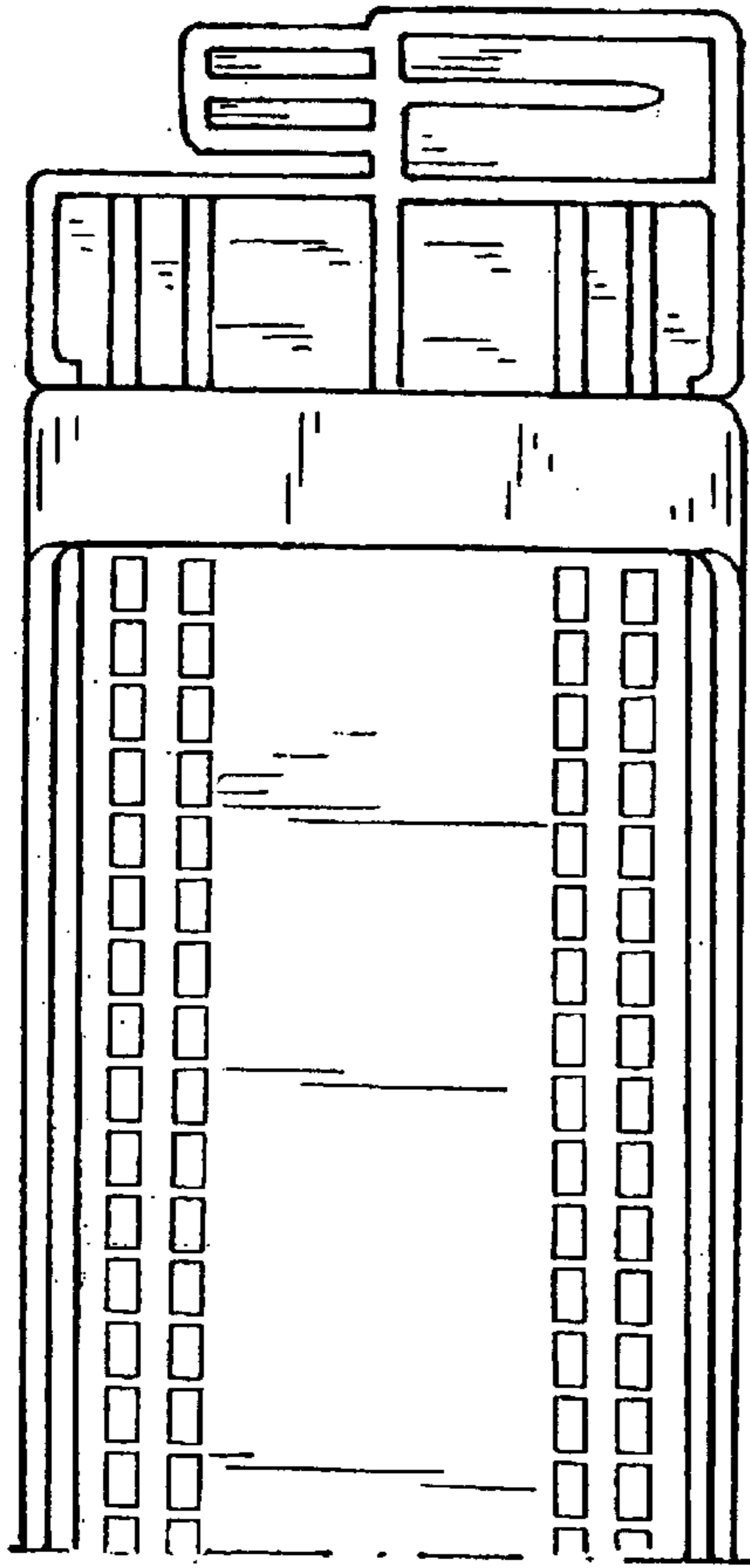

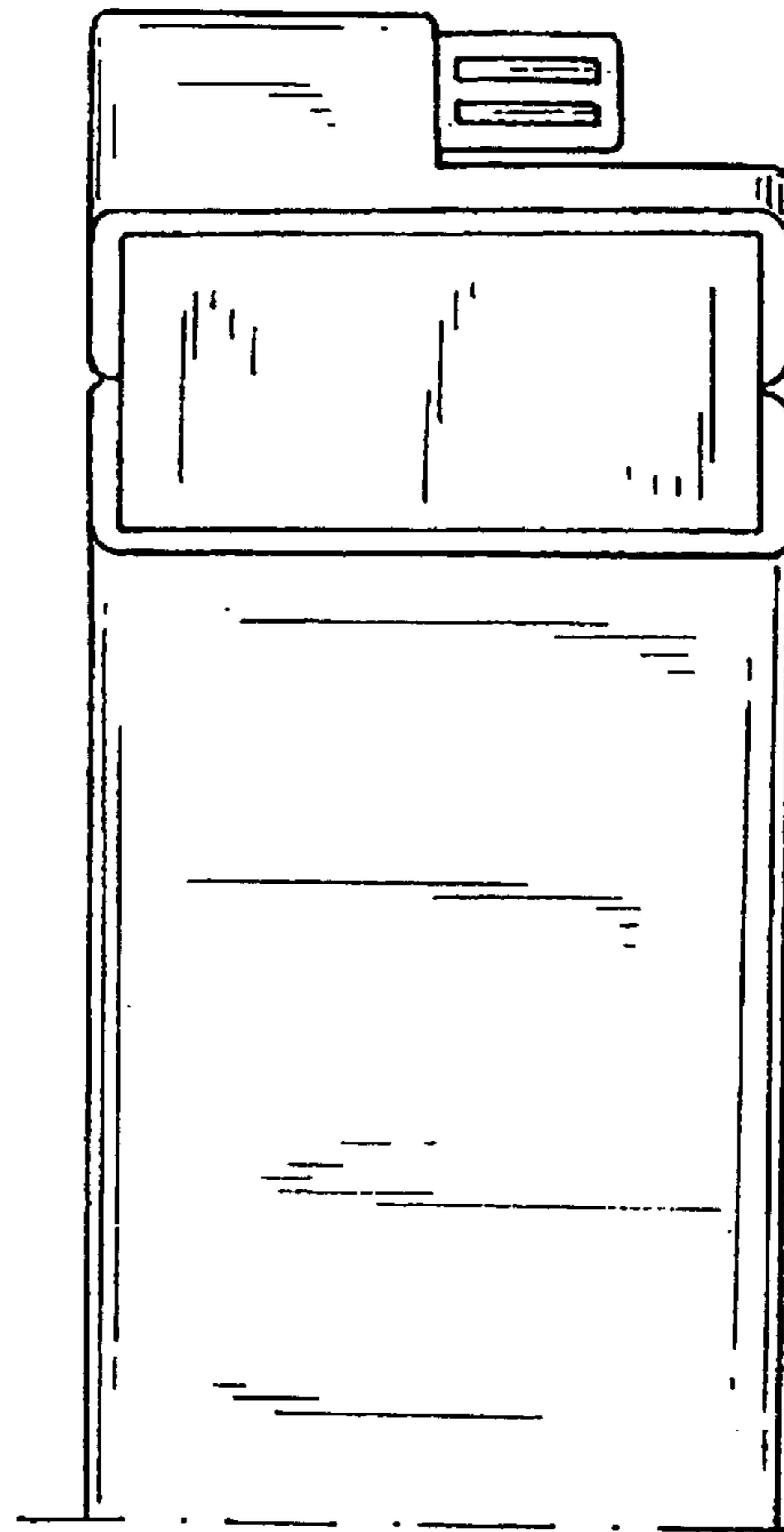

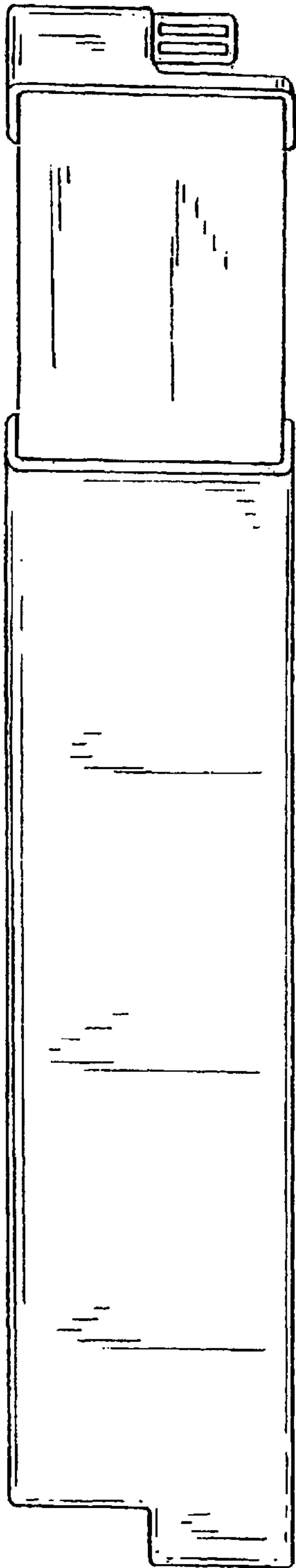

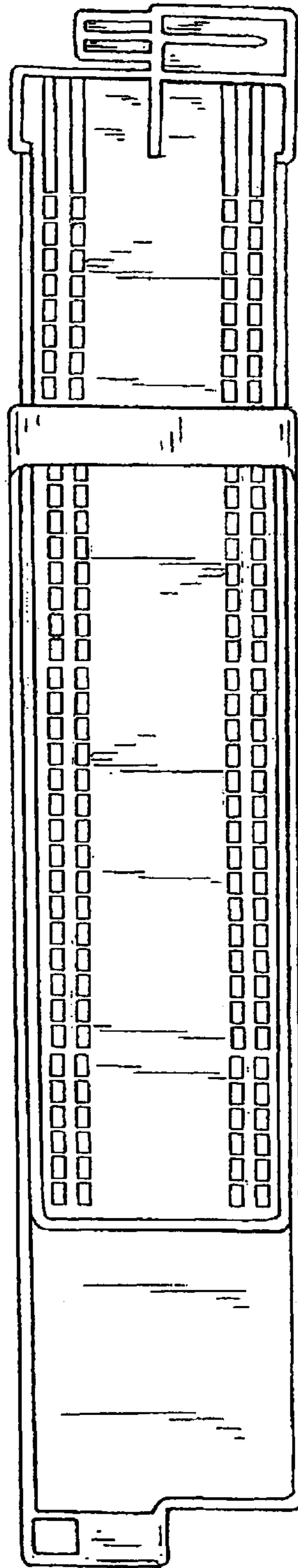

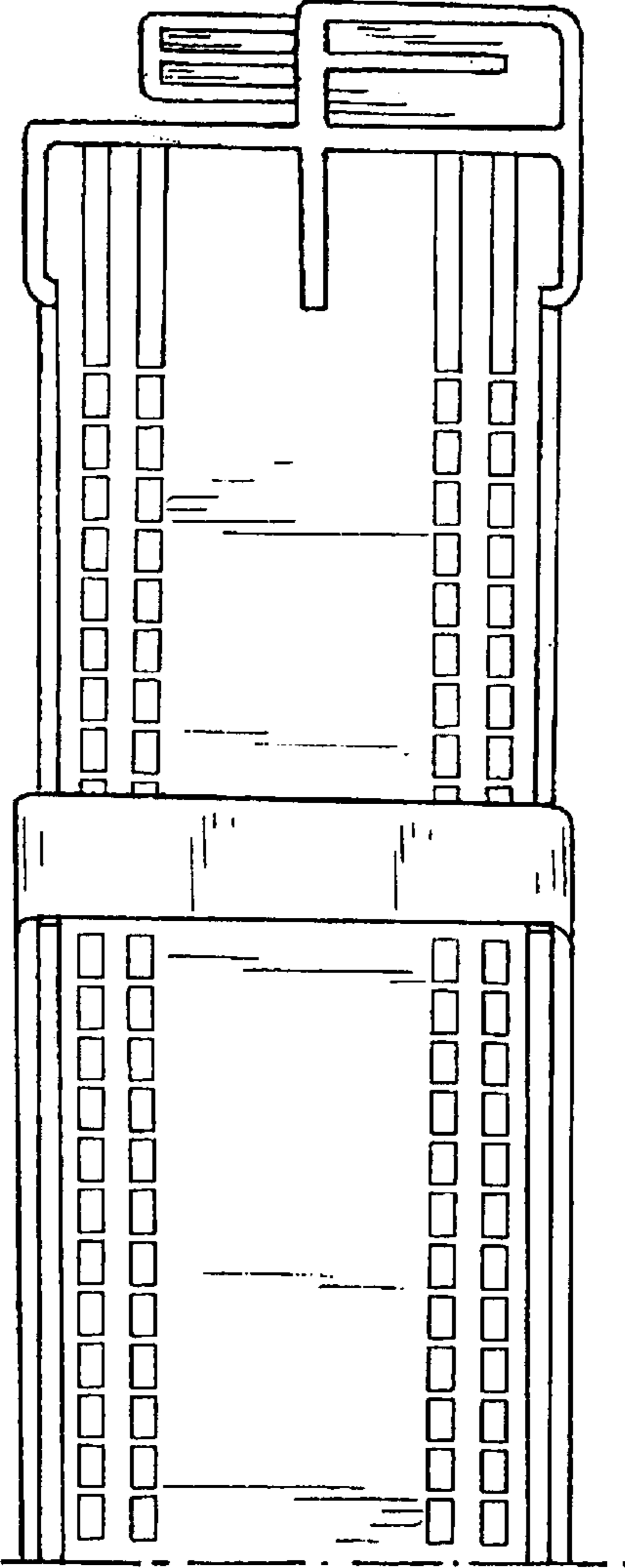

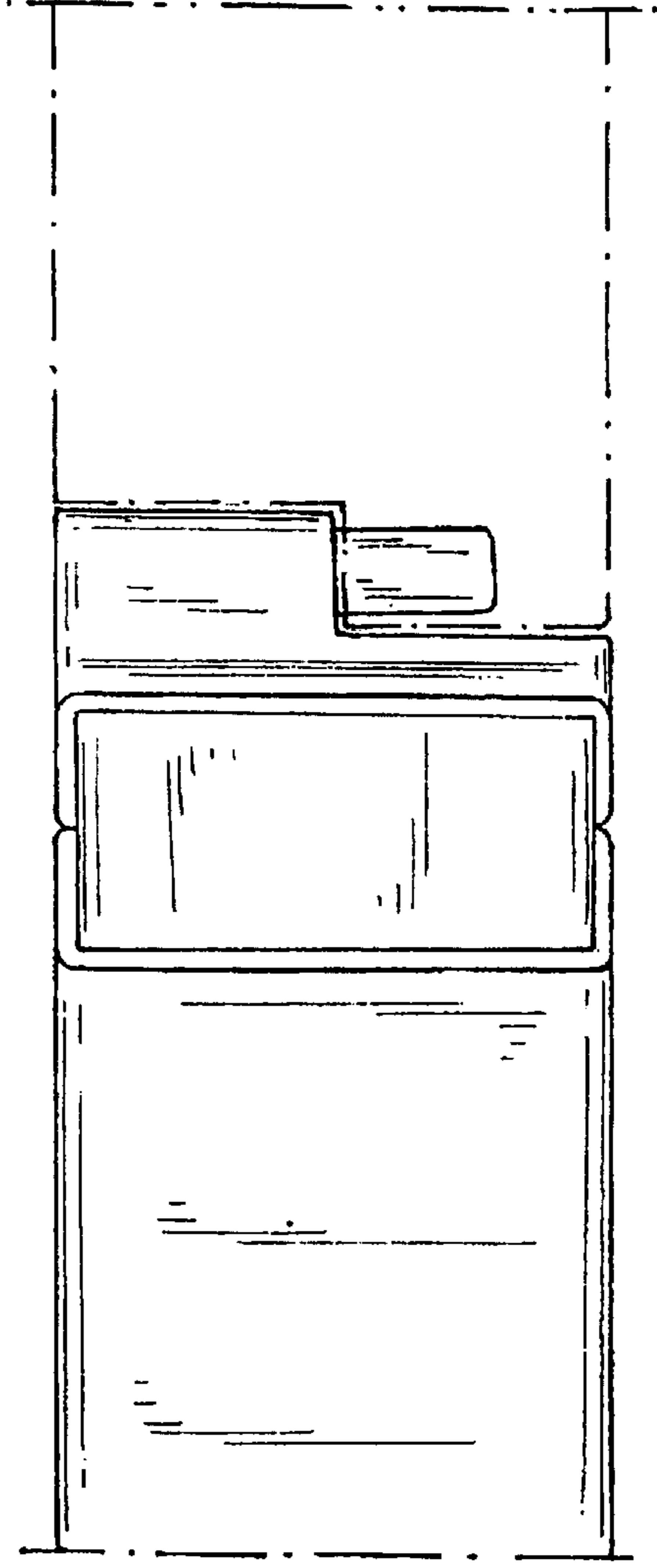

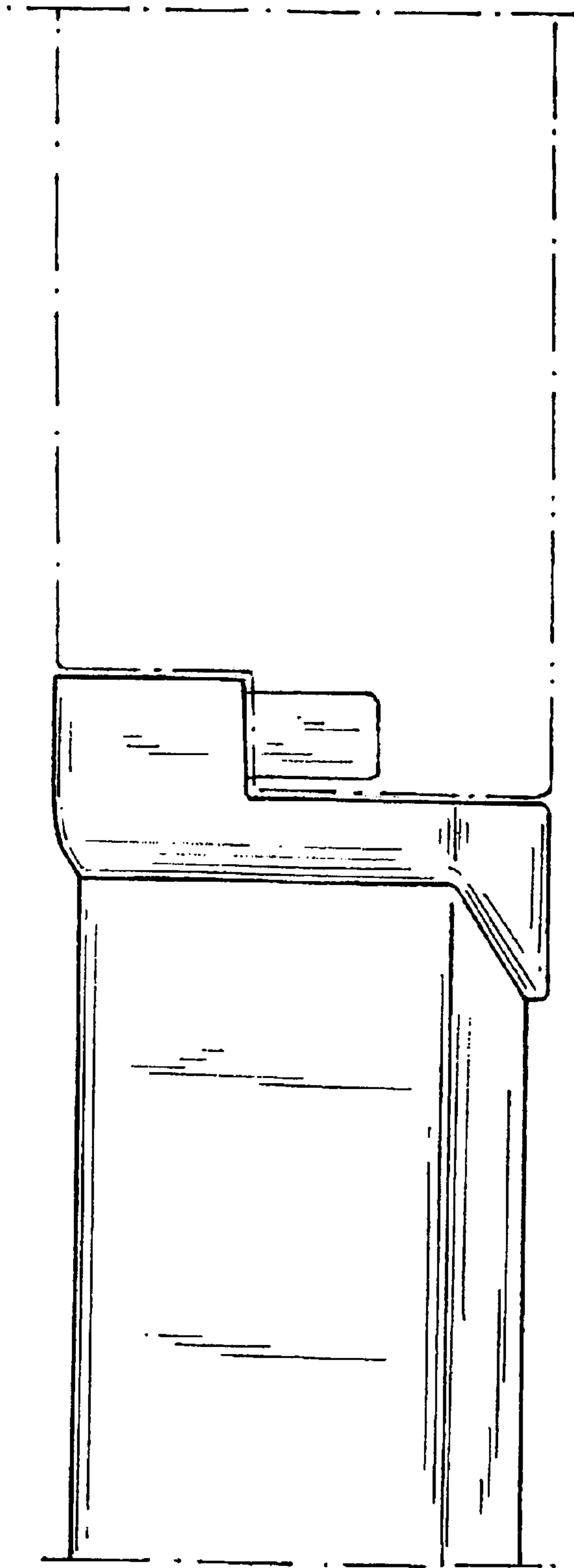

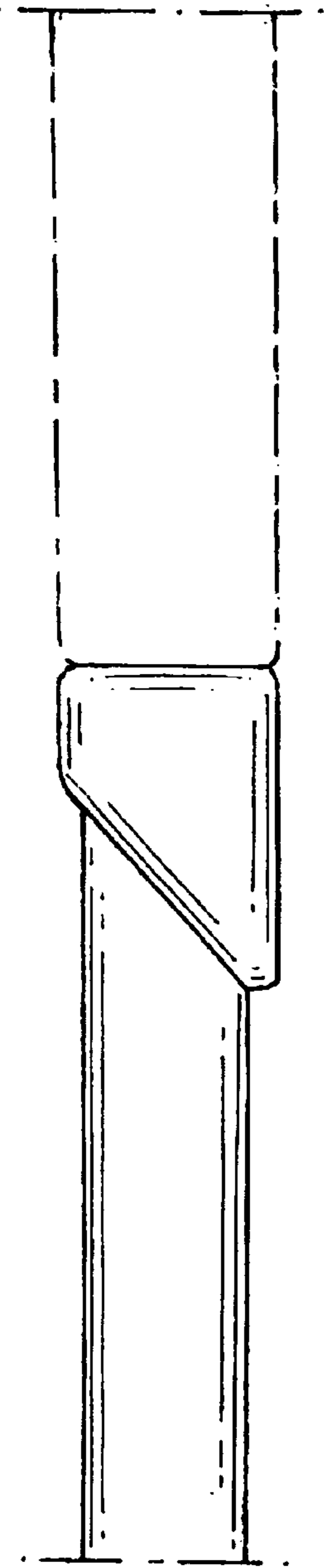

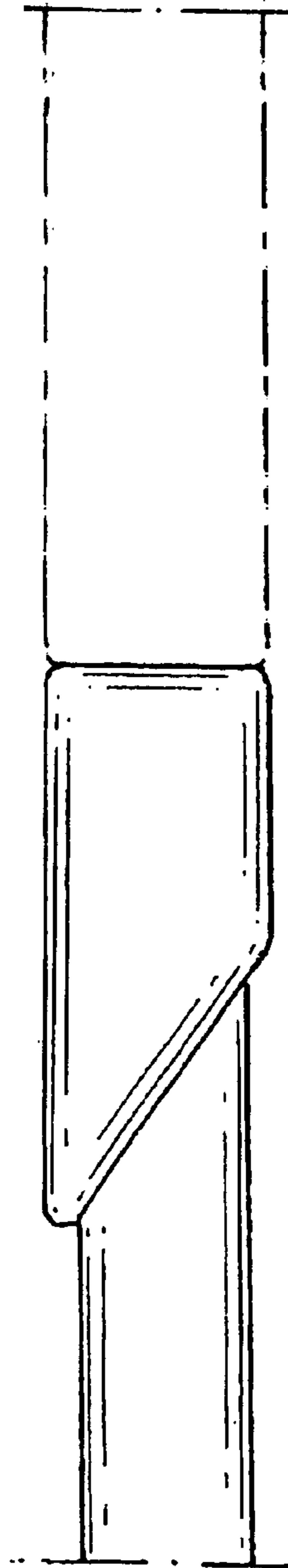

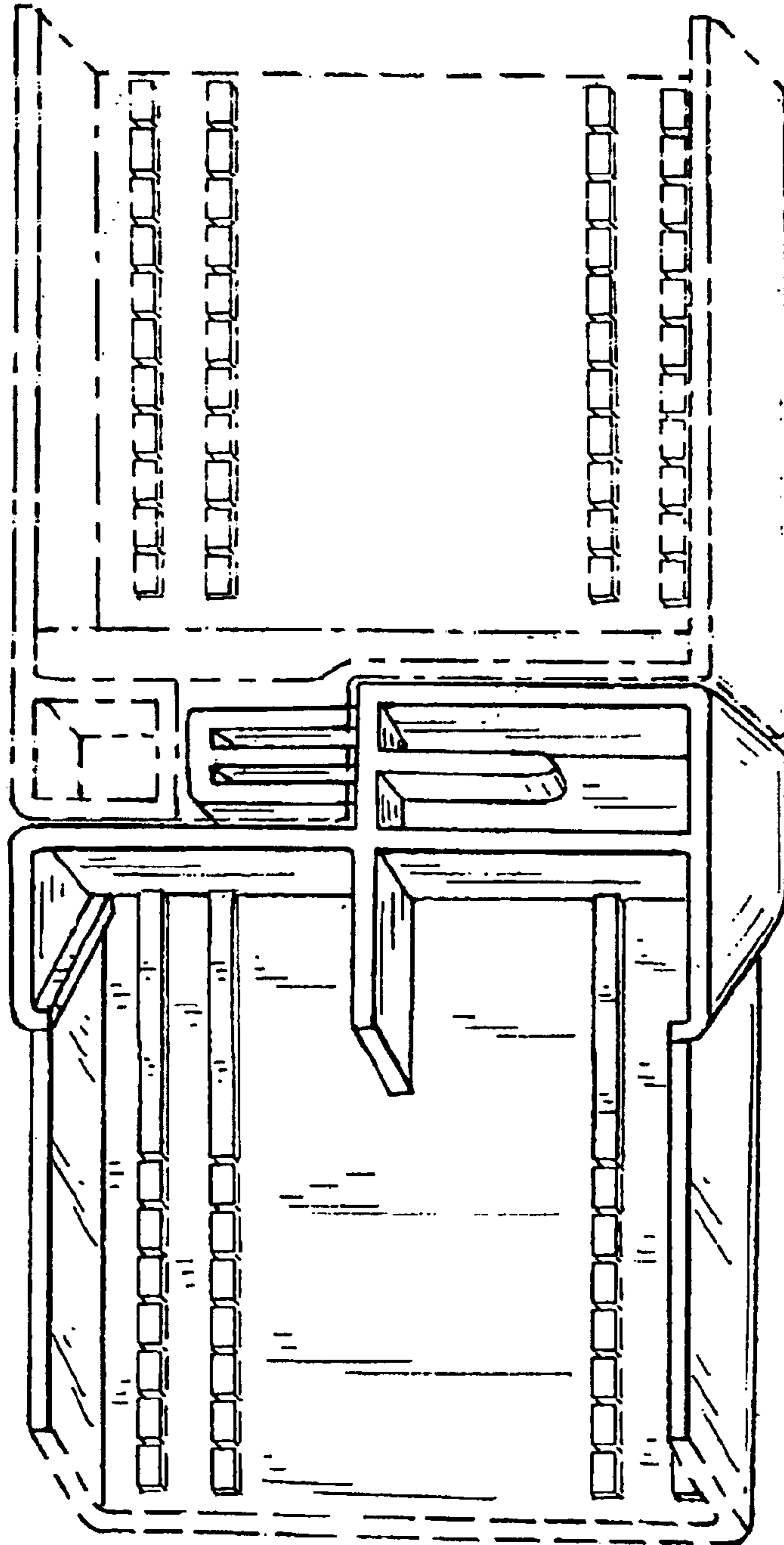

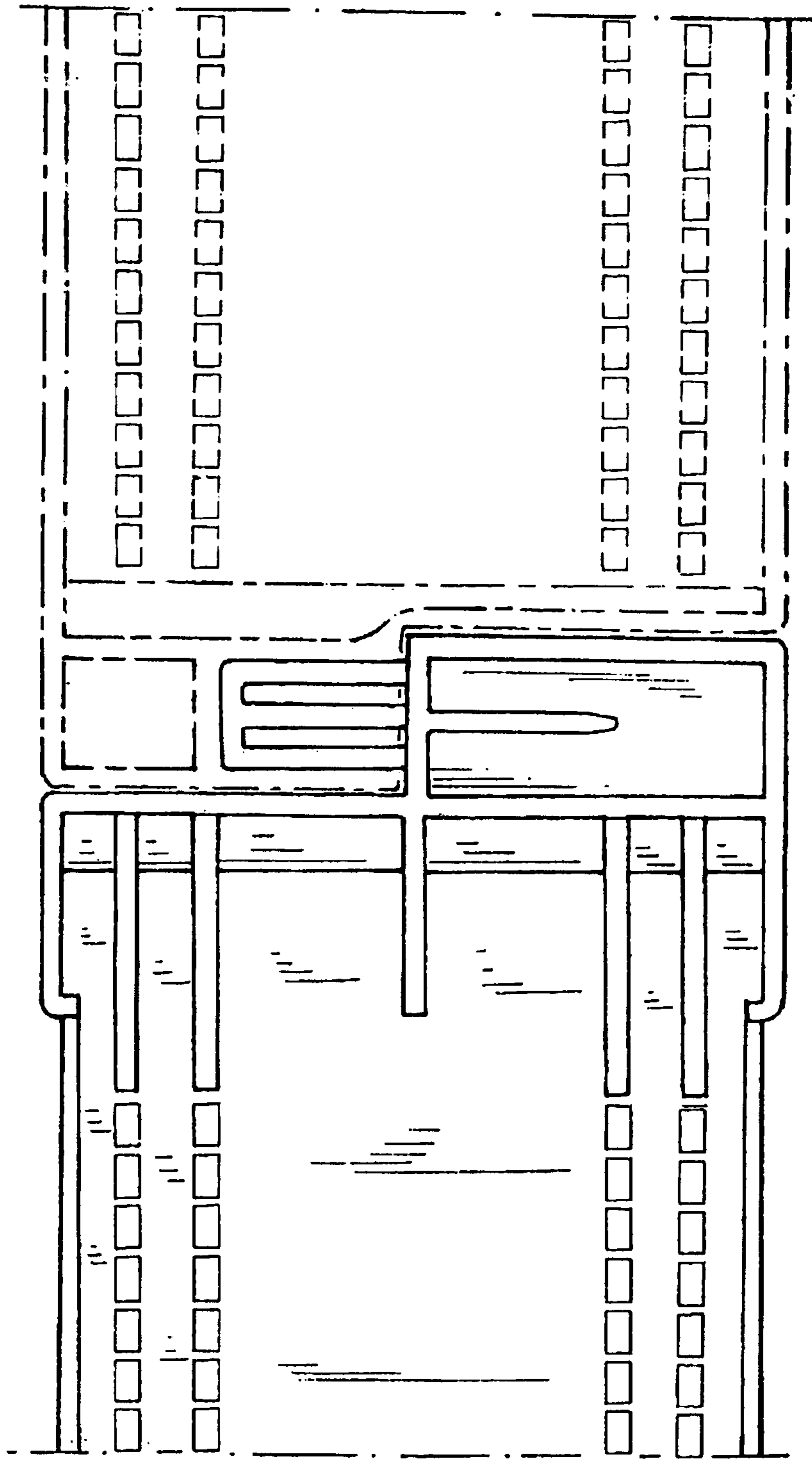

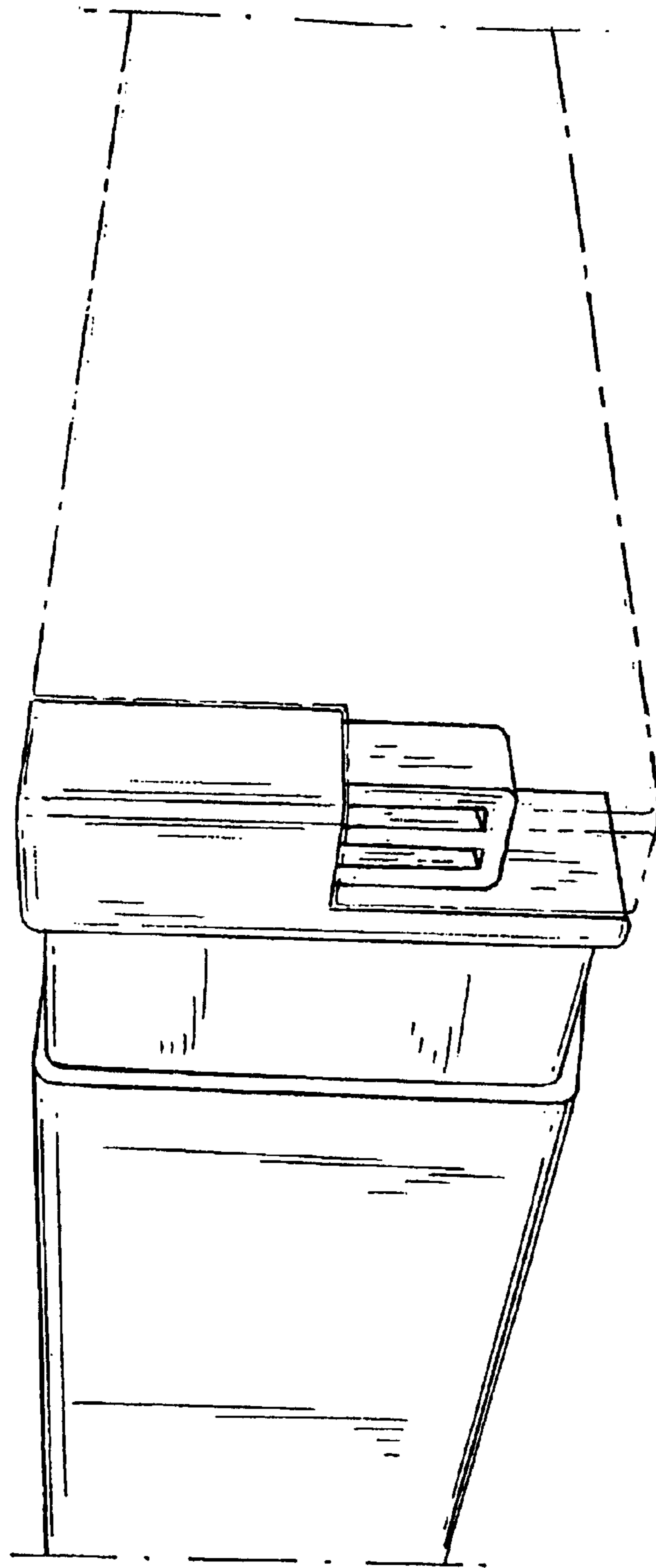

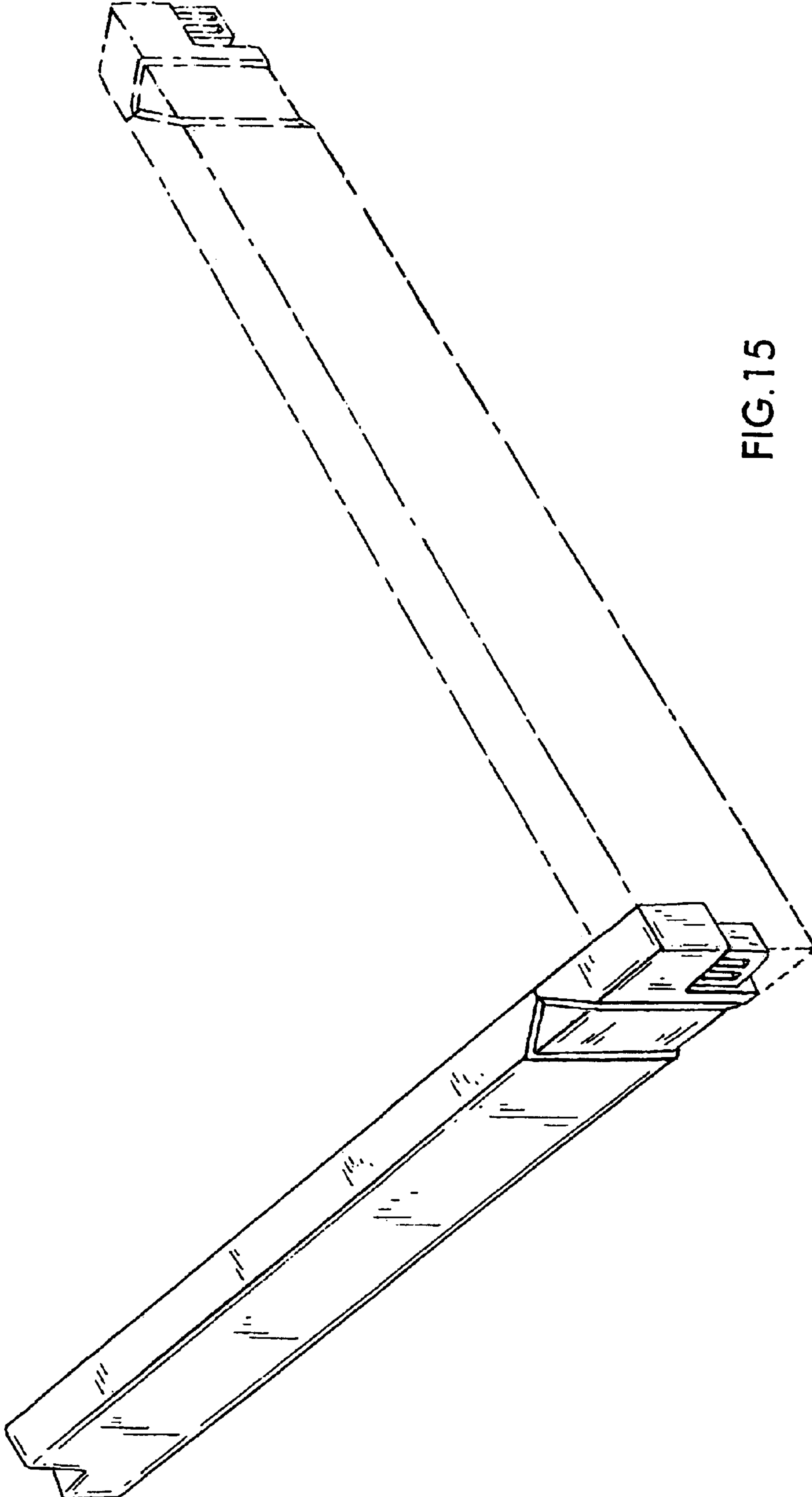

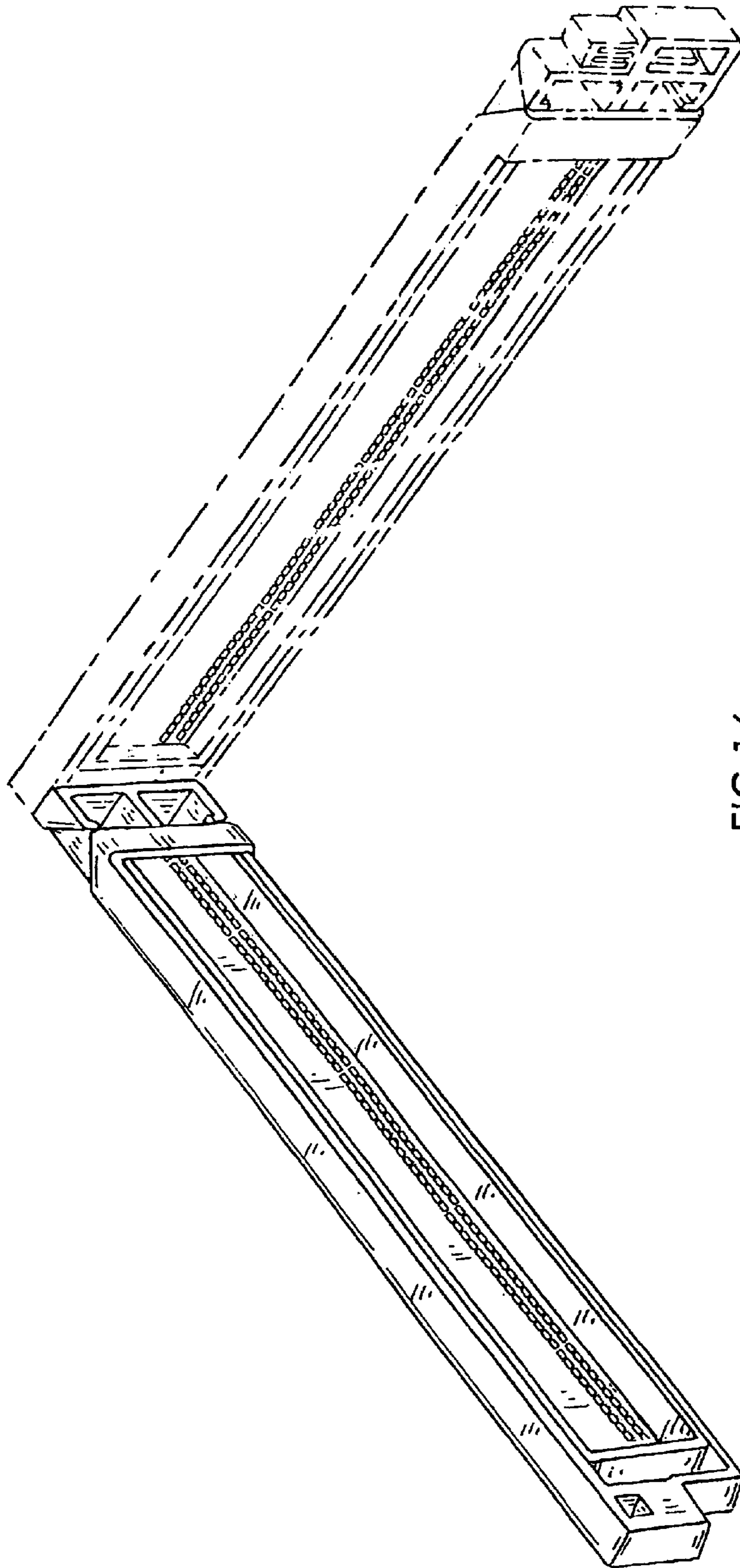
