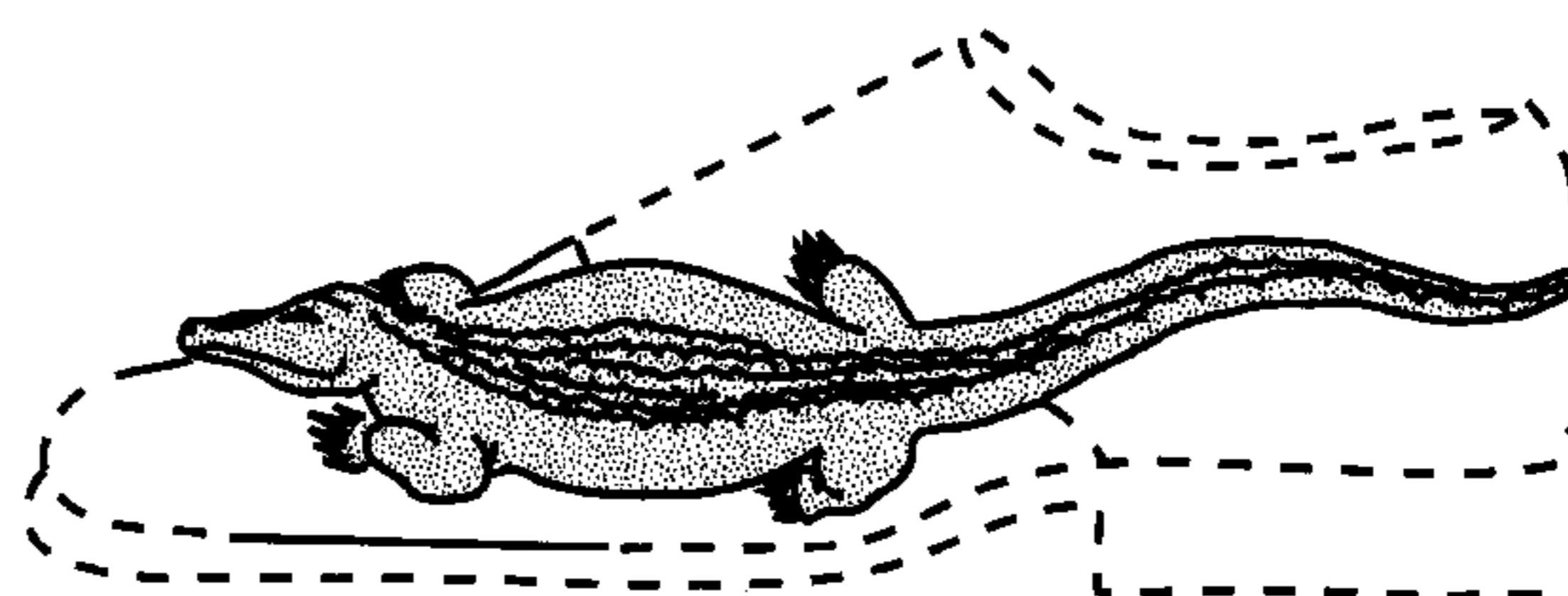
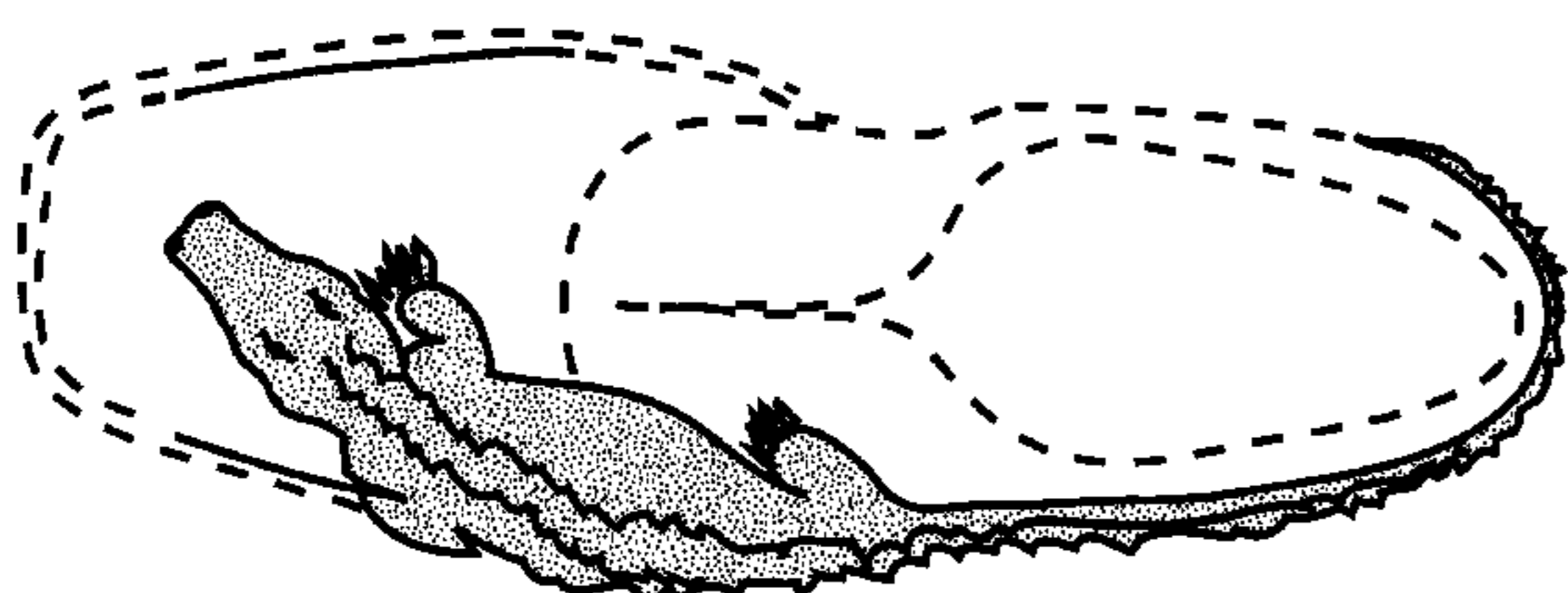
The ornamental design for a shoe with reptile, as shown and described.

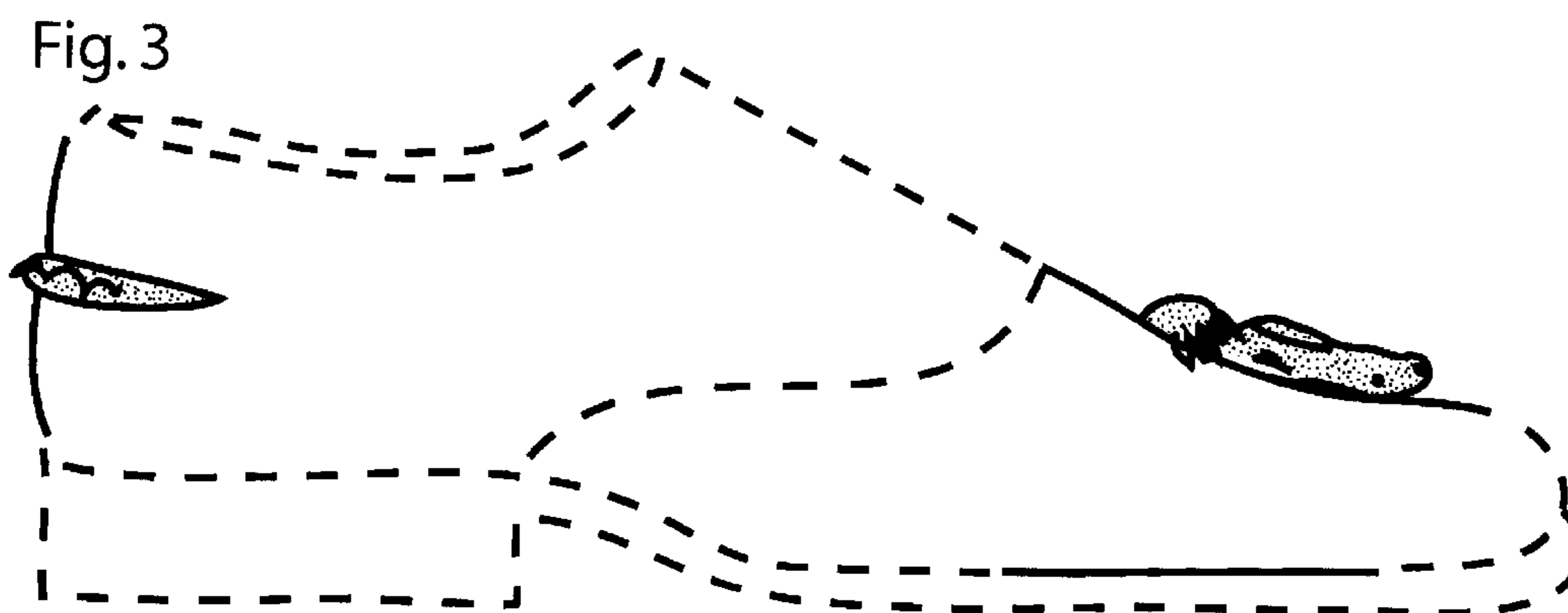
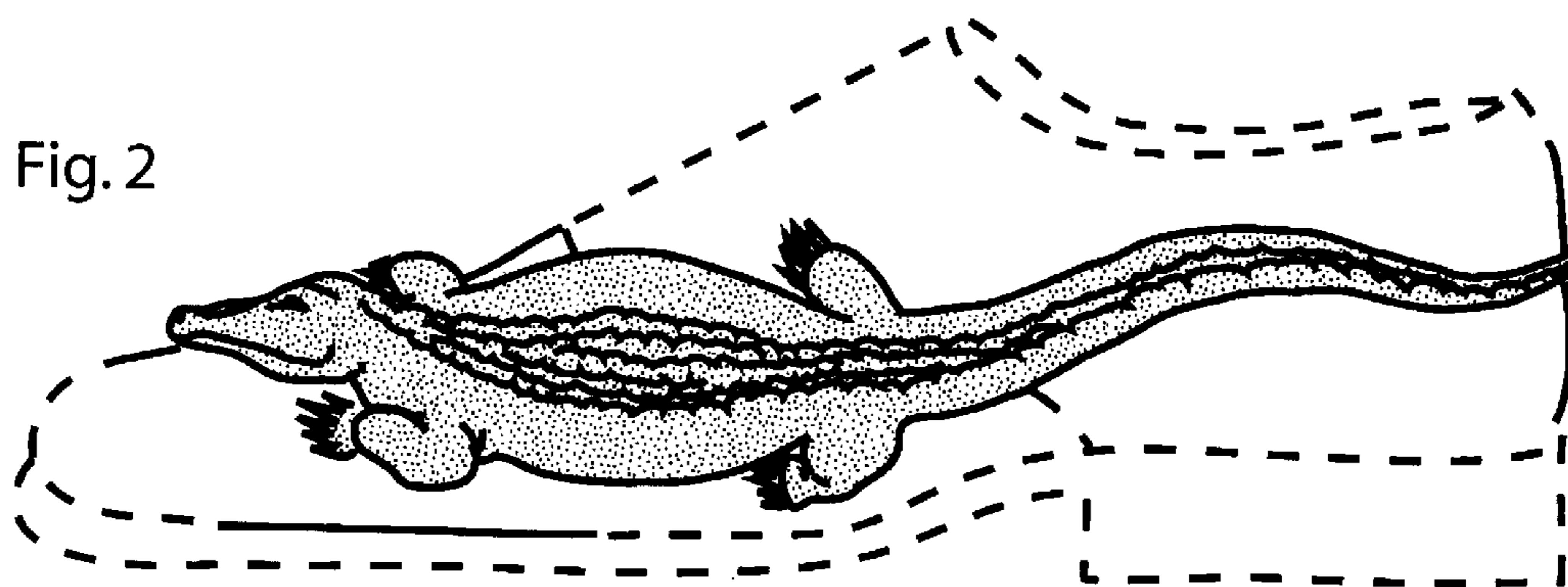
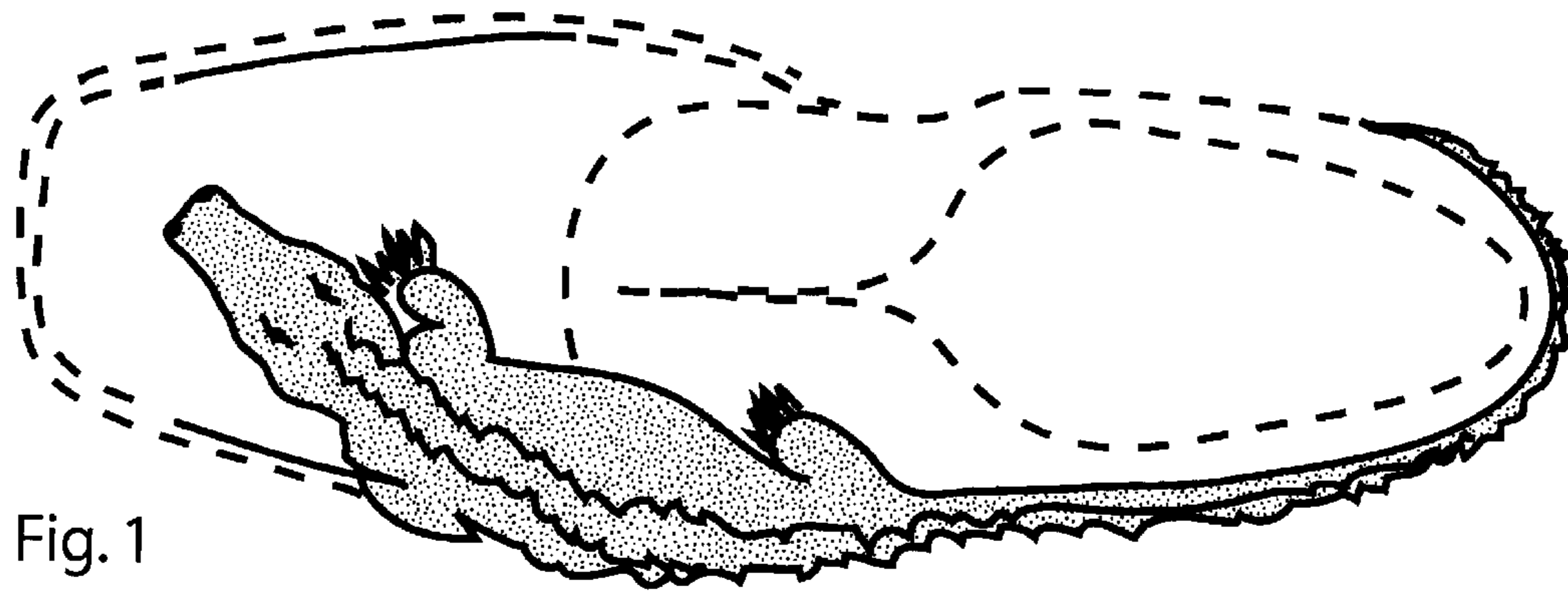
DESCRIPTION

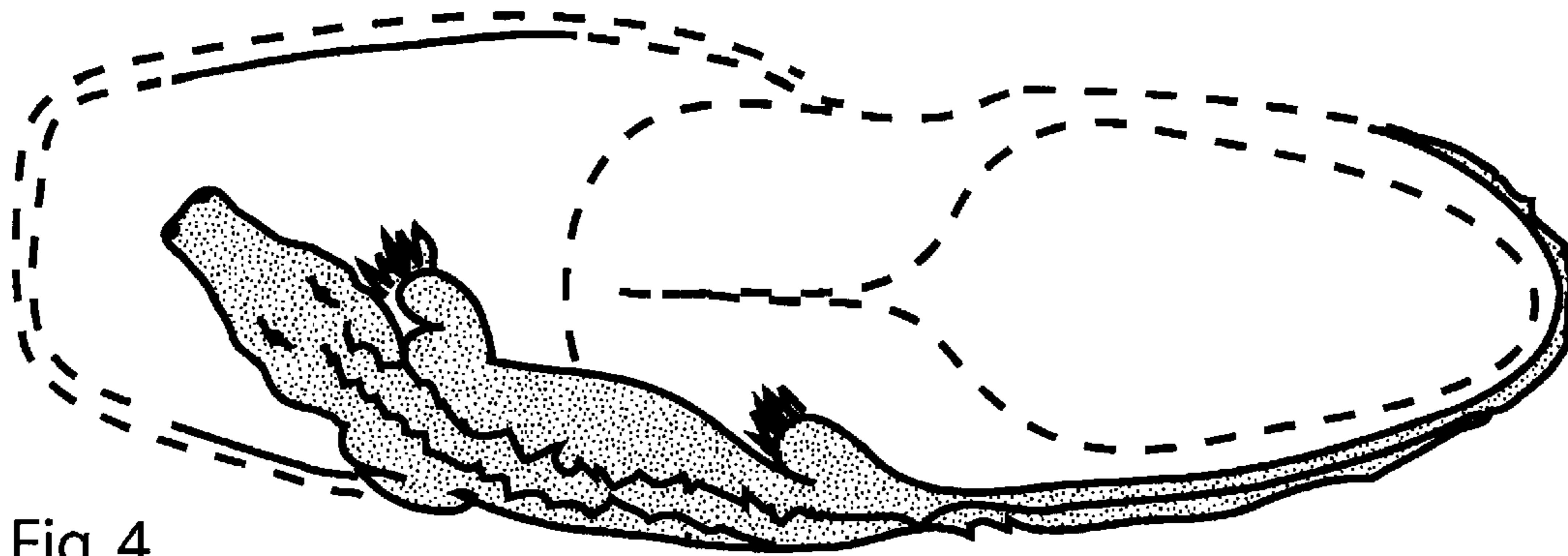

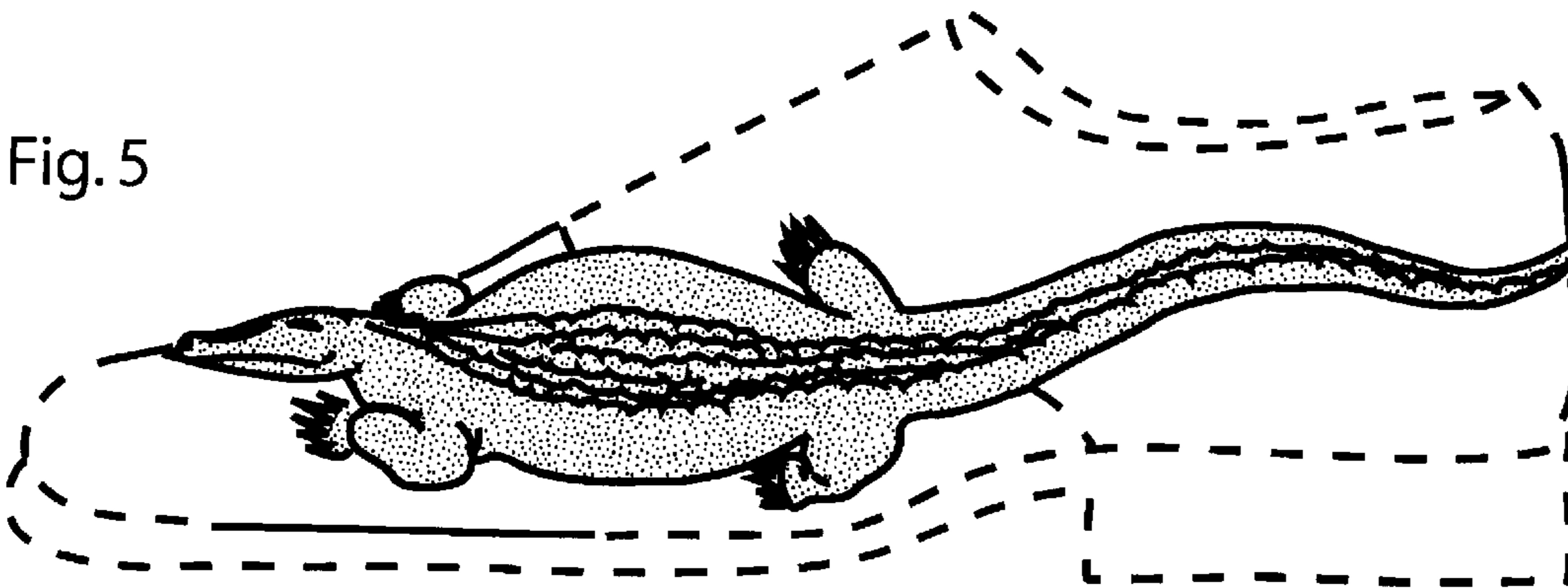

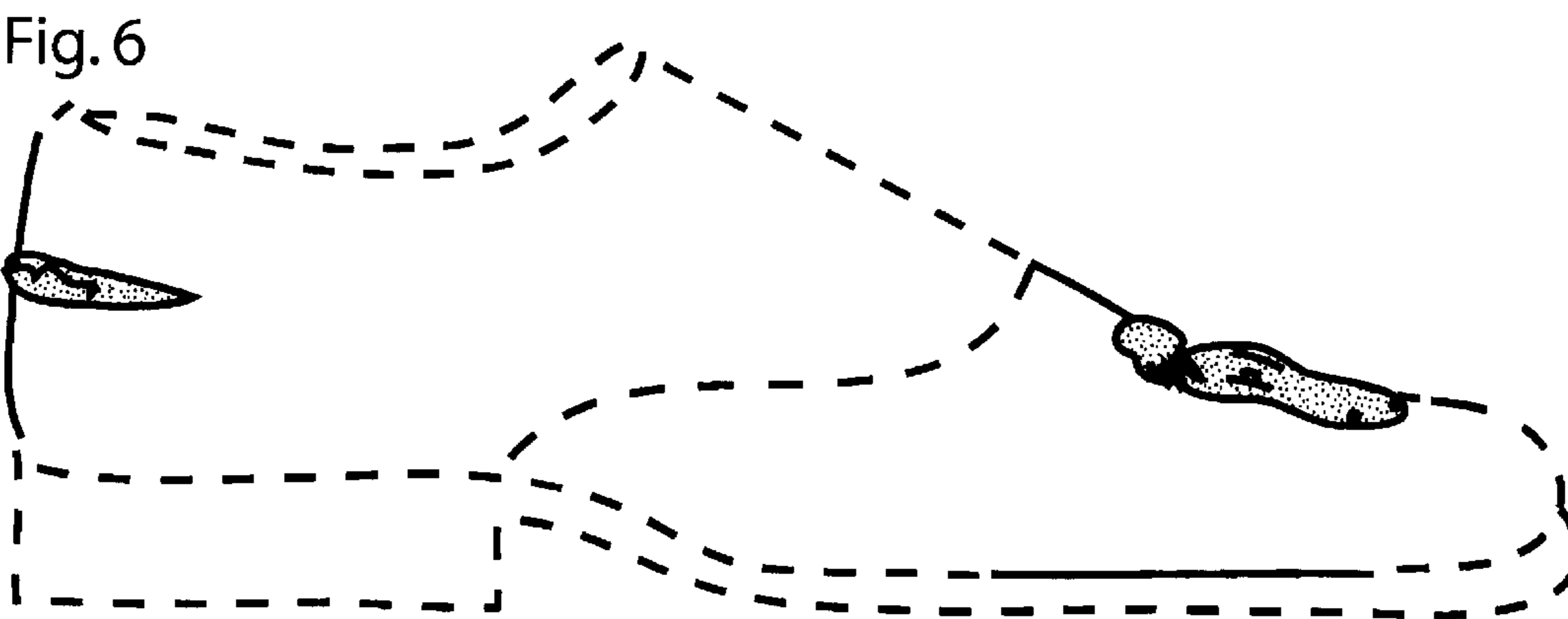
