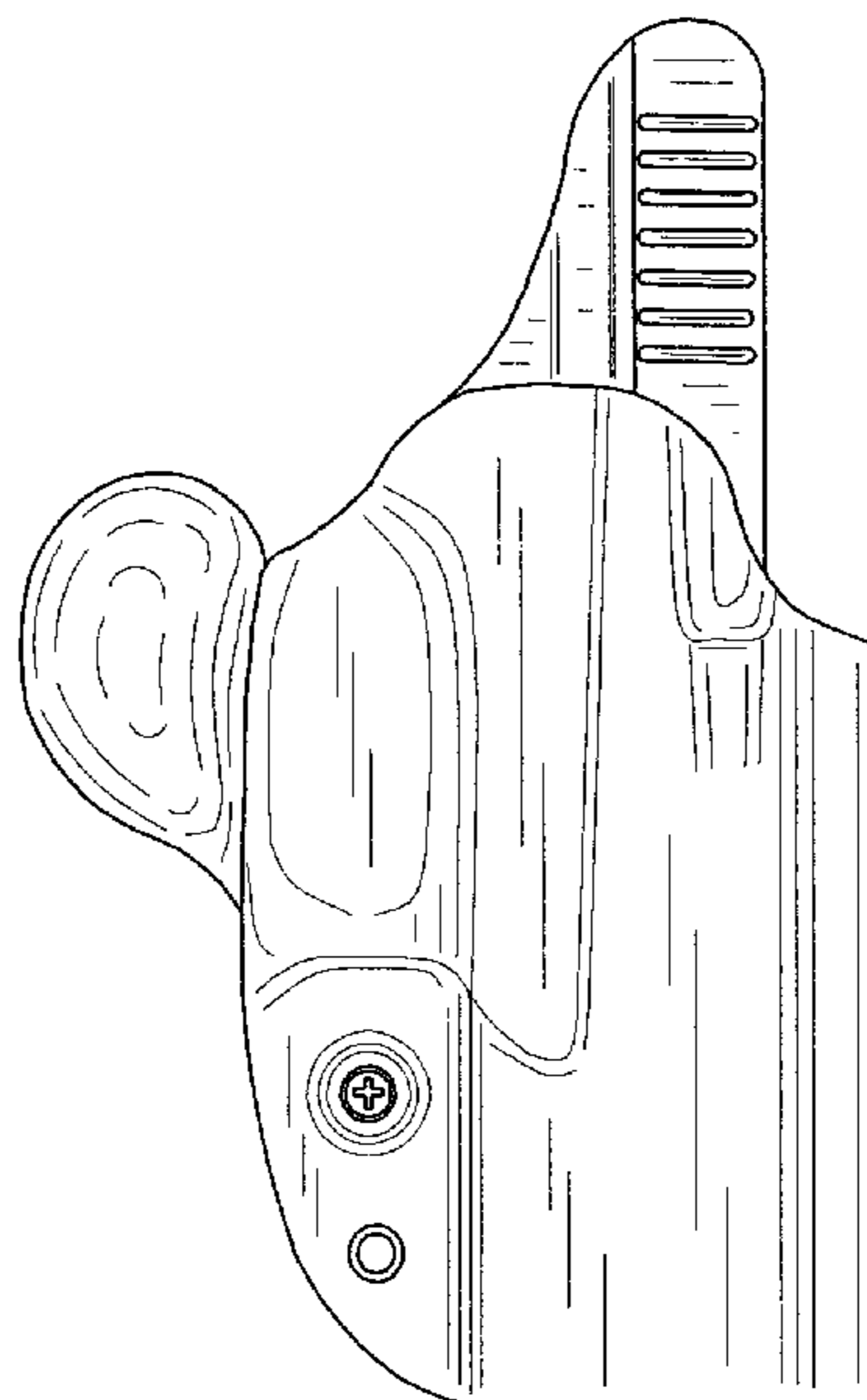
(57) **CLAIM**

The ornamental design for a modular holster with trigger guard, as shown and described.

**DESCRIPTION**

FIG. 1 is a left elevational view of a modular holster with trigger guard showing our new design. FIG. 2 is a right elevational view thereof. FIG. 3 is a rear elevational view thereof. FIG. 4 is a front elevational view thereof. FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof.

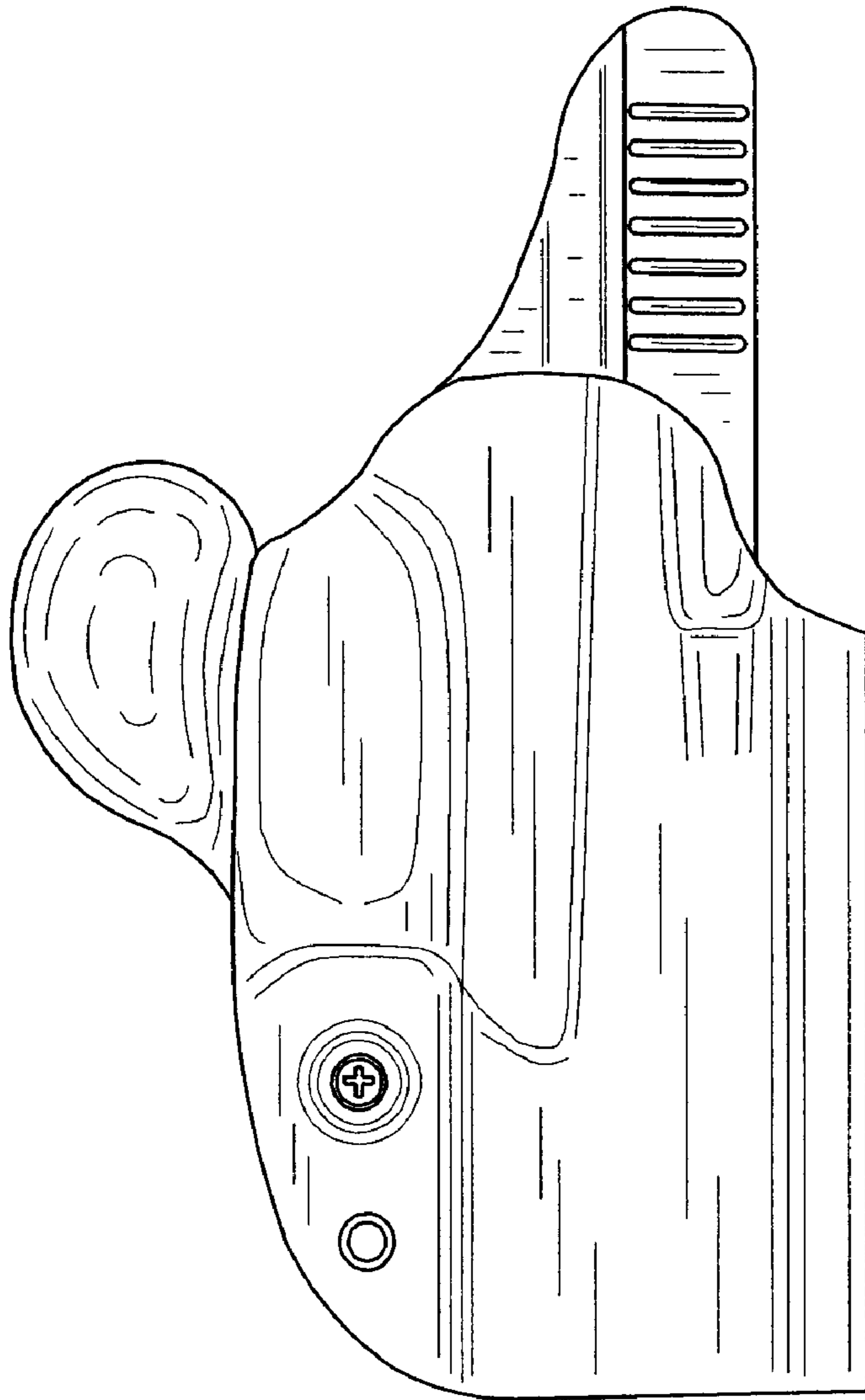

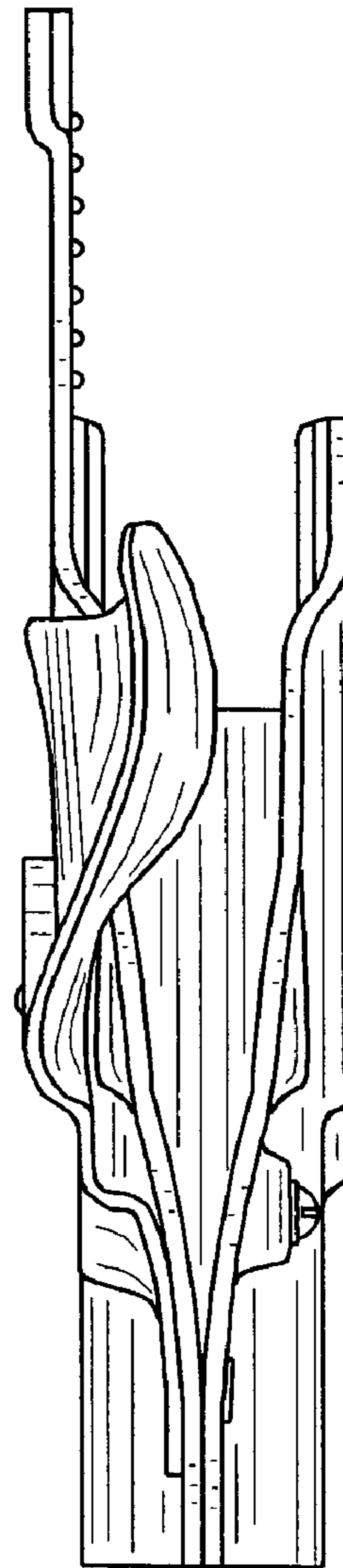

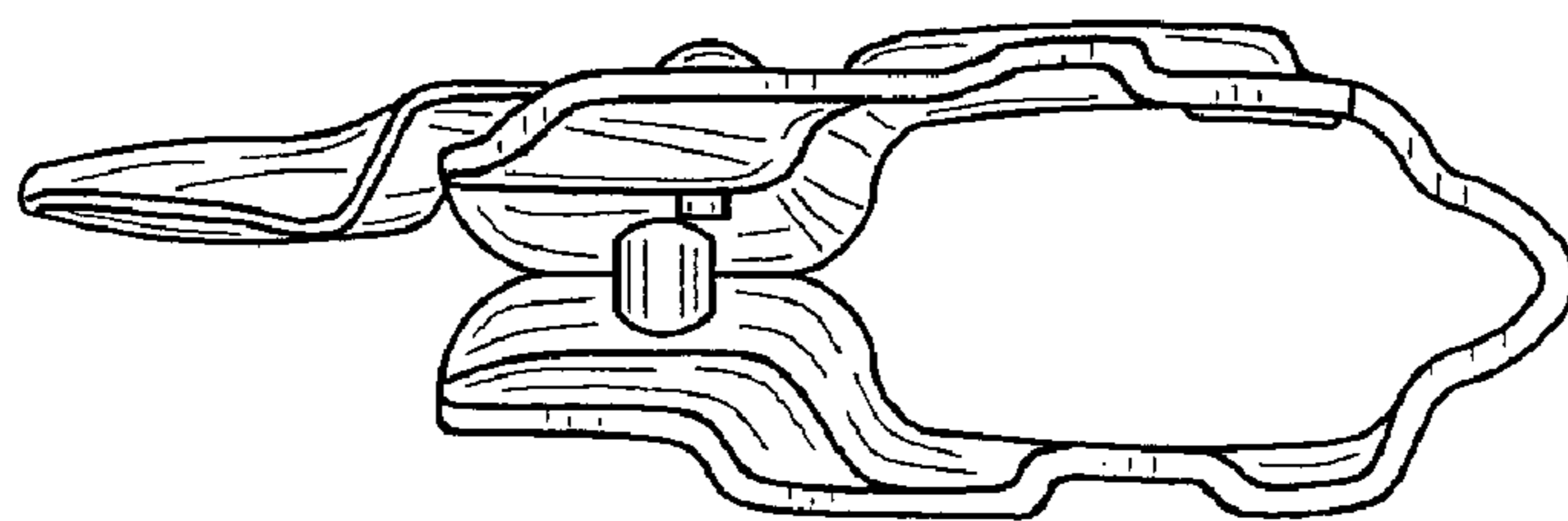

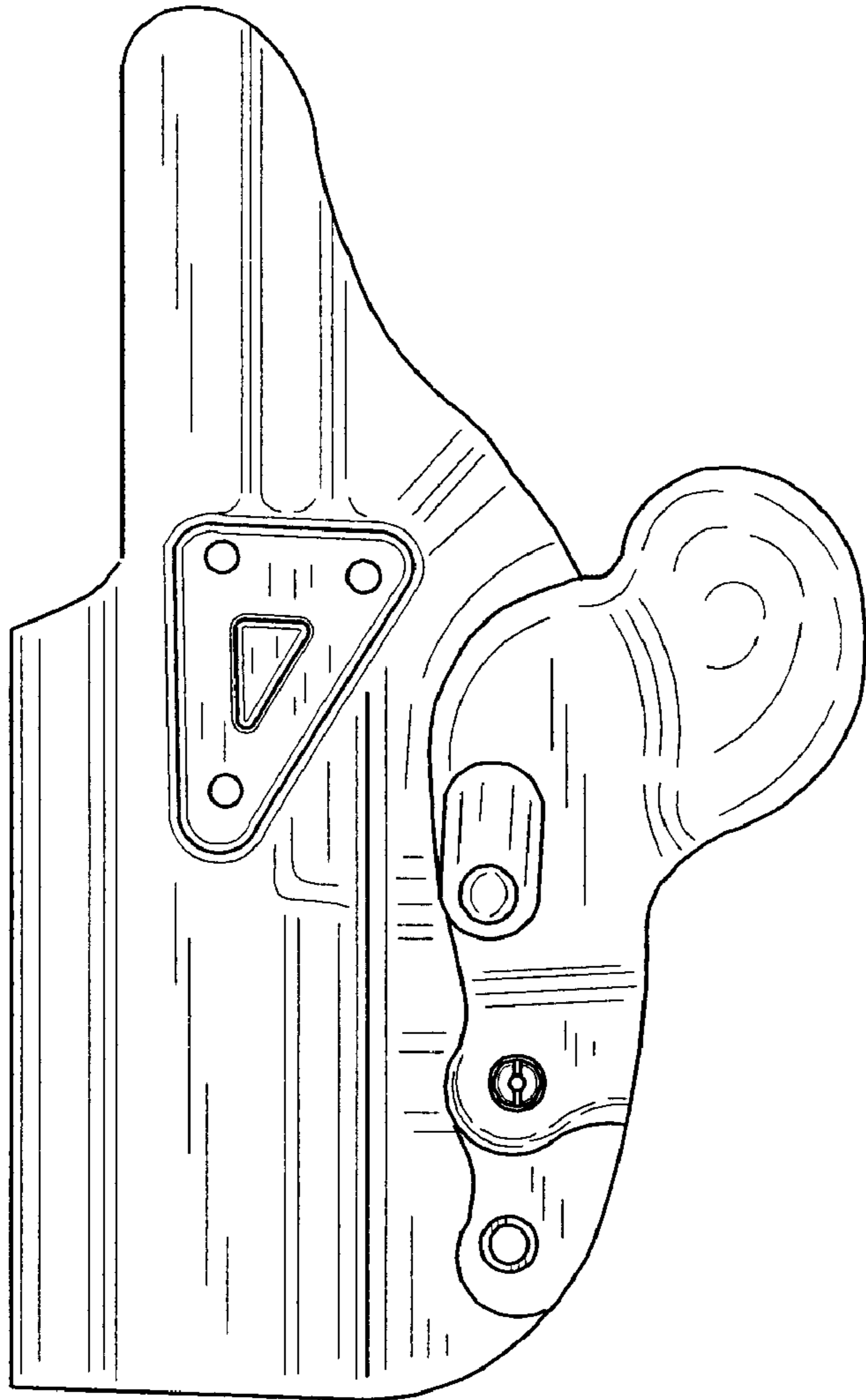

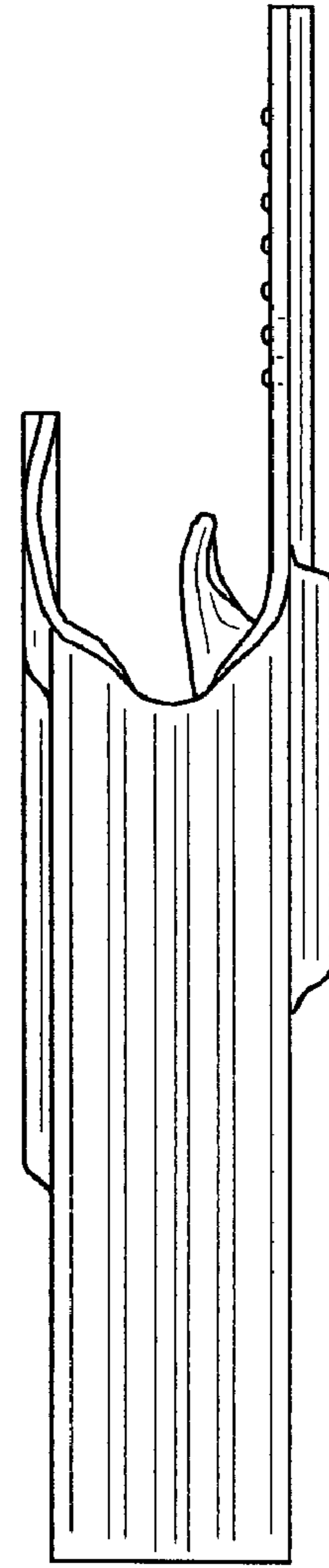

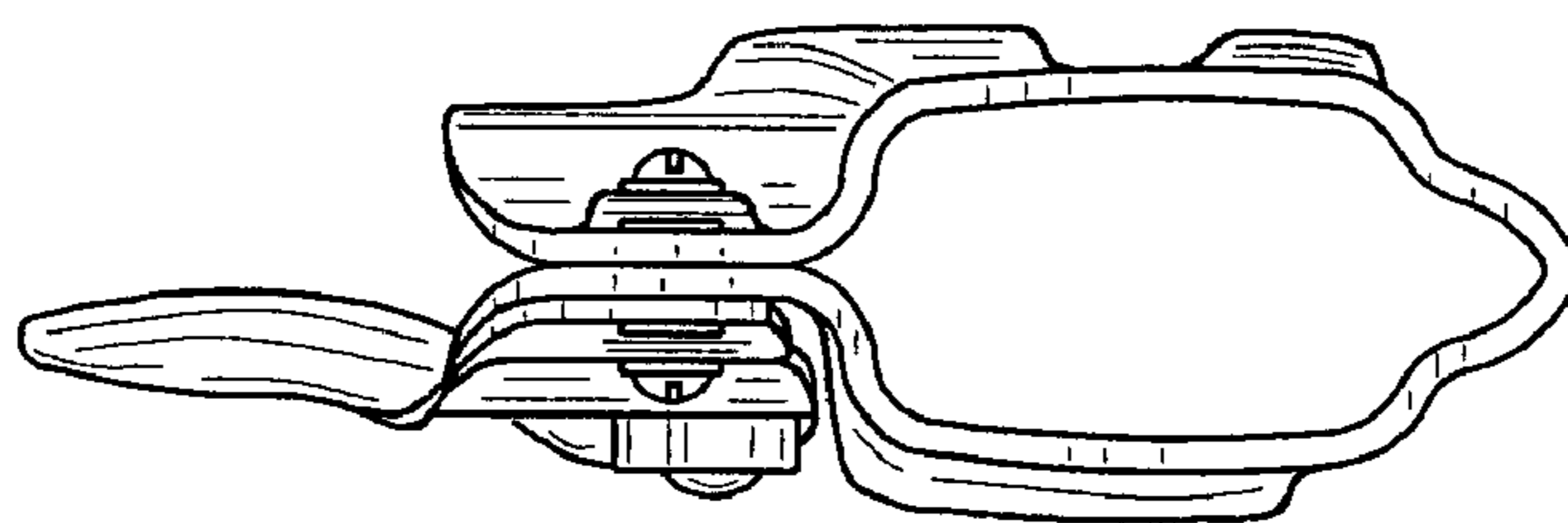
