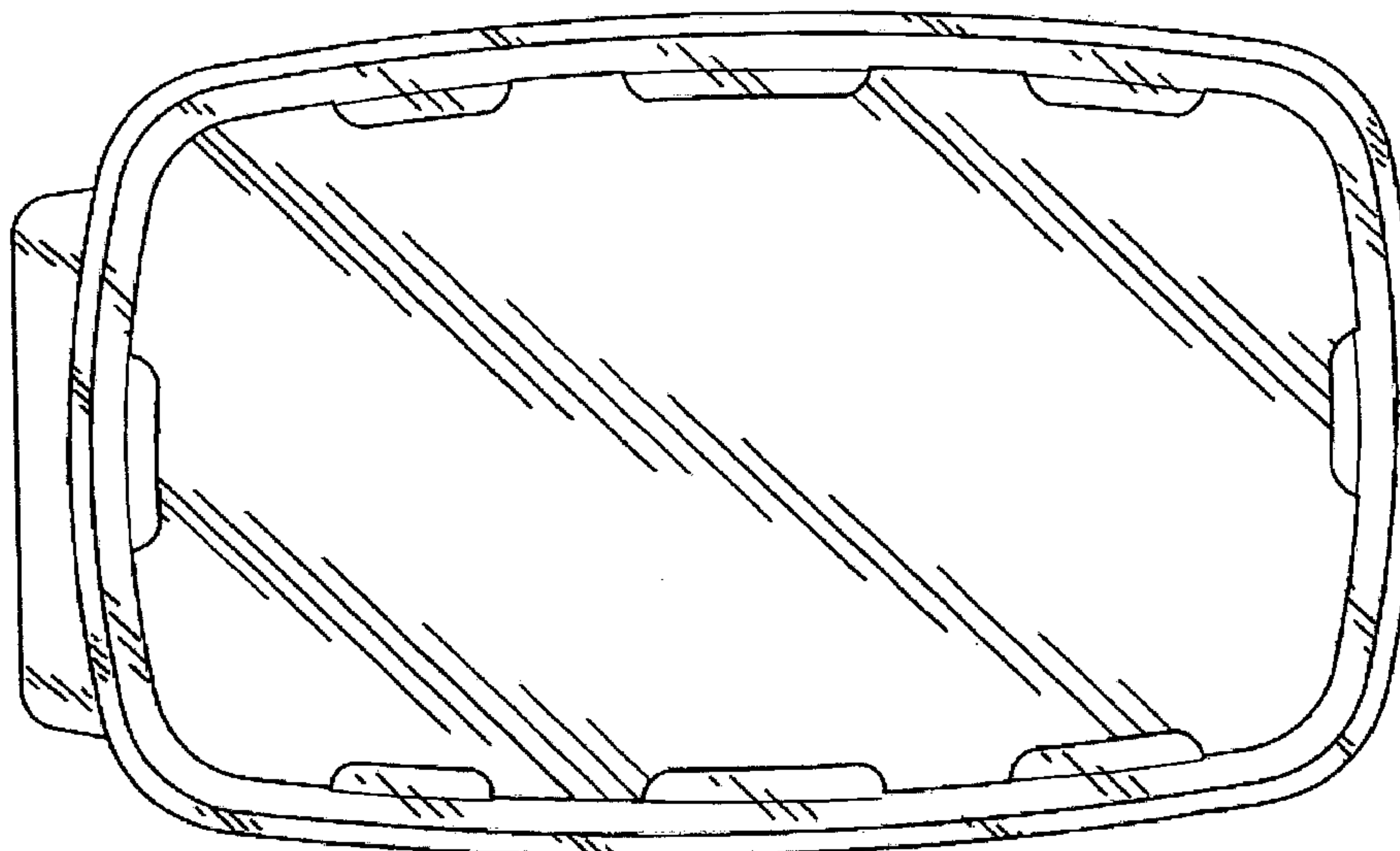
(57) **CLAIM**

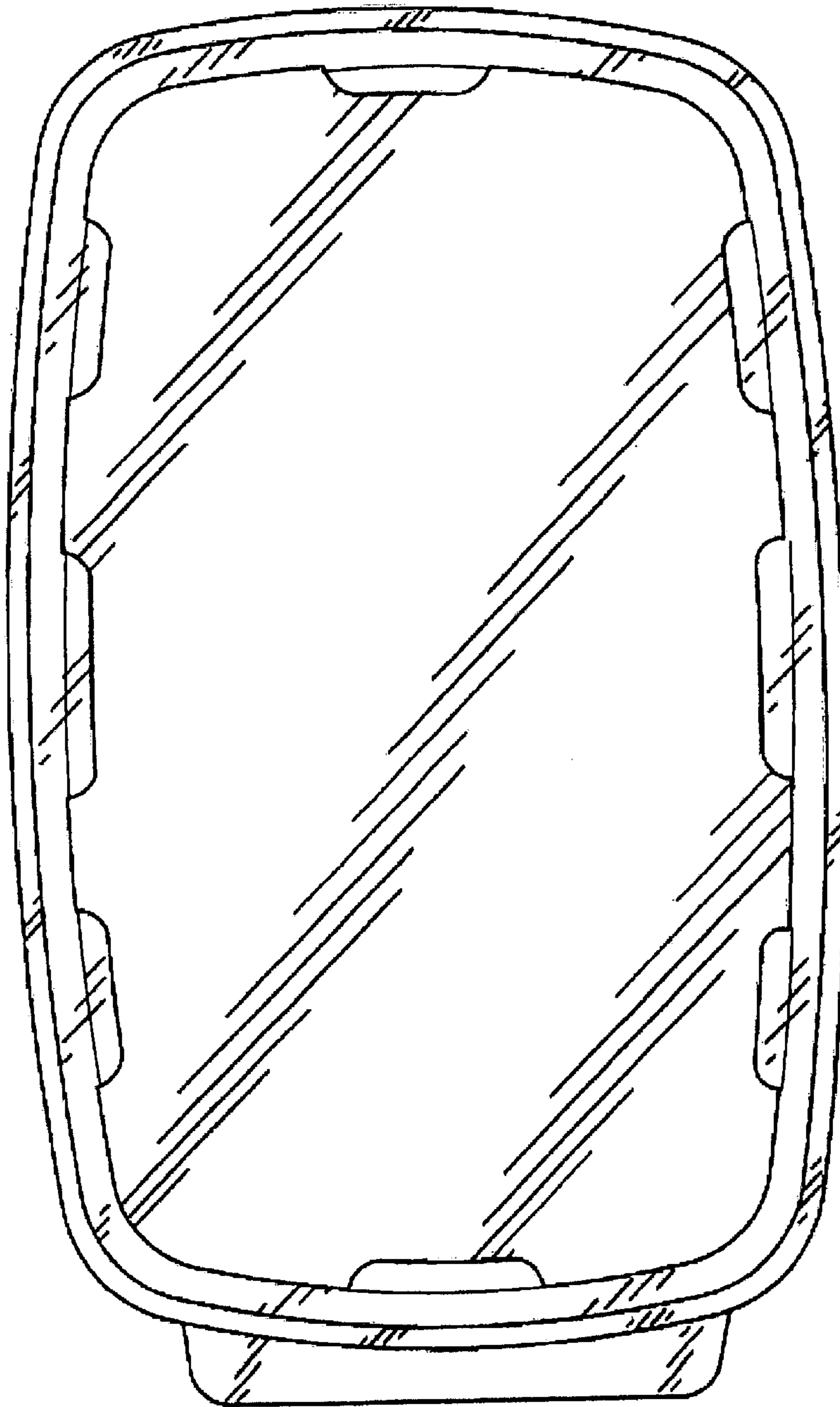
The ornamental design for a storage container cover with

**DESCRIPTION**

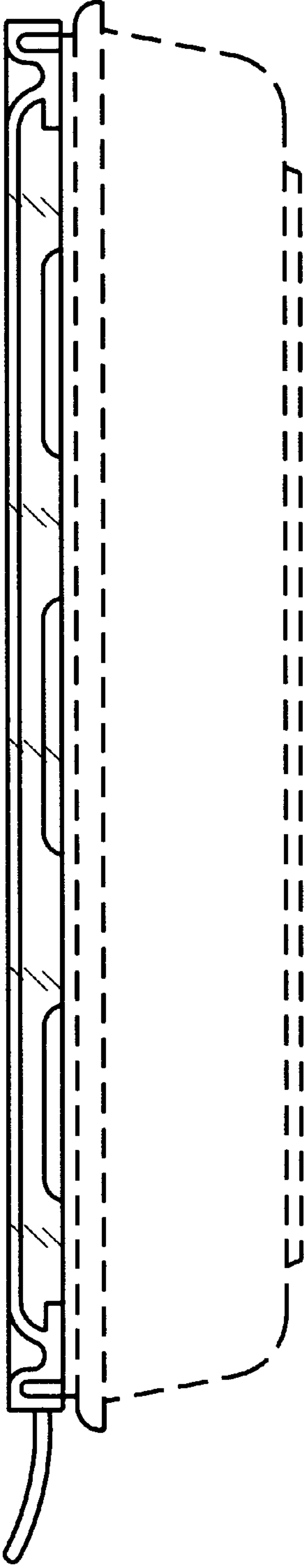
FIG. 1 is a top plan view of a storage container cover with  
removable cutting surface therein, showing my new design;  
FIG. 2 is a side elevational view thereof from one side, the  
other side elevational view thereof being a mirror image;  
FIG. 3 is an end elevational view thereof from one end;  
FIG. 4 is an end elevational view thereof from the opposite  
end; and,  
FIG. 5 is a bottom plan view thereof.  
The dashed line depiction of a storage container in FIGS. 2,  
3 and 4 indicate environment only and forms no part of the  
claimed design.

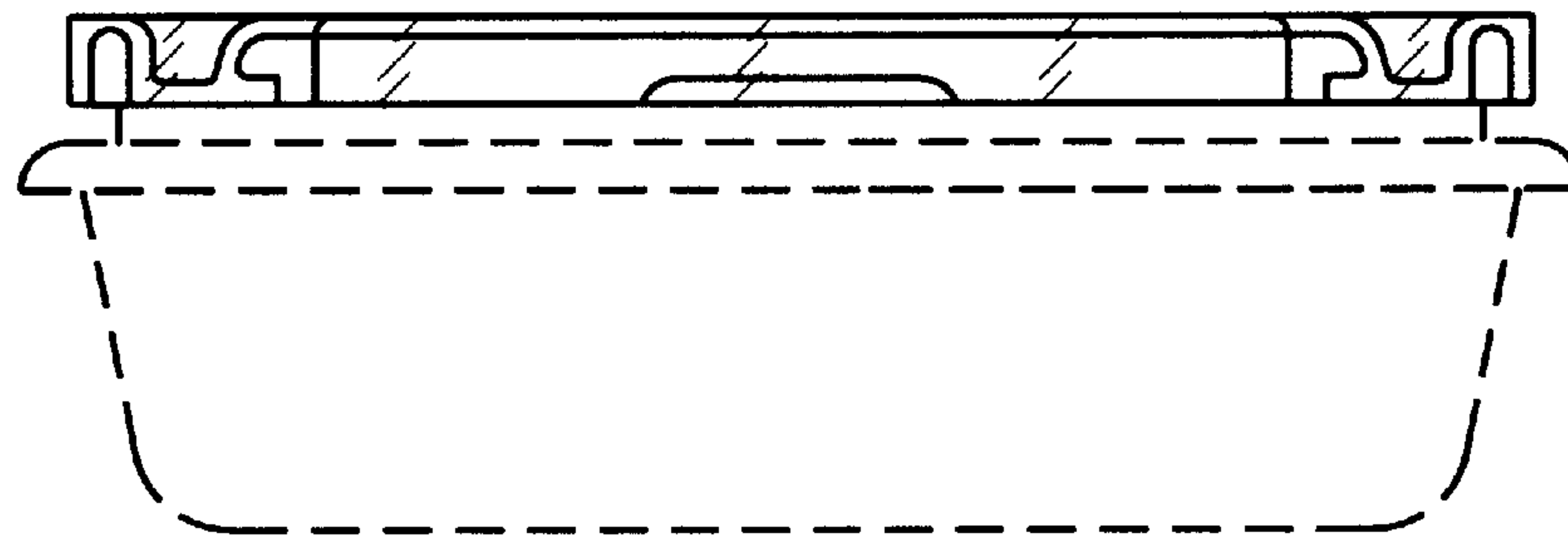




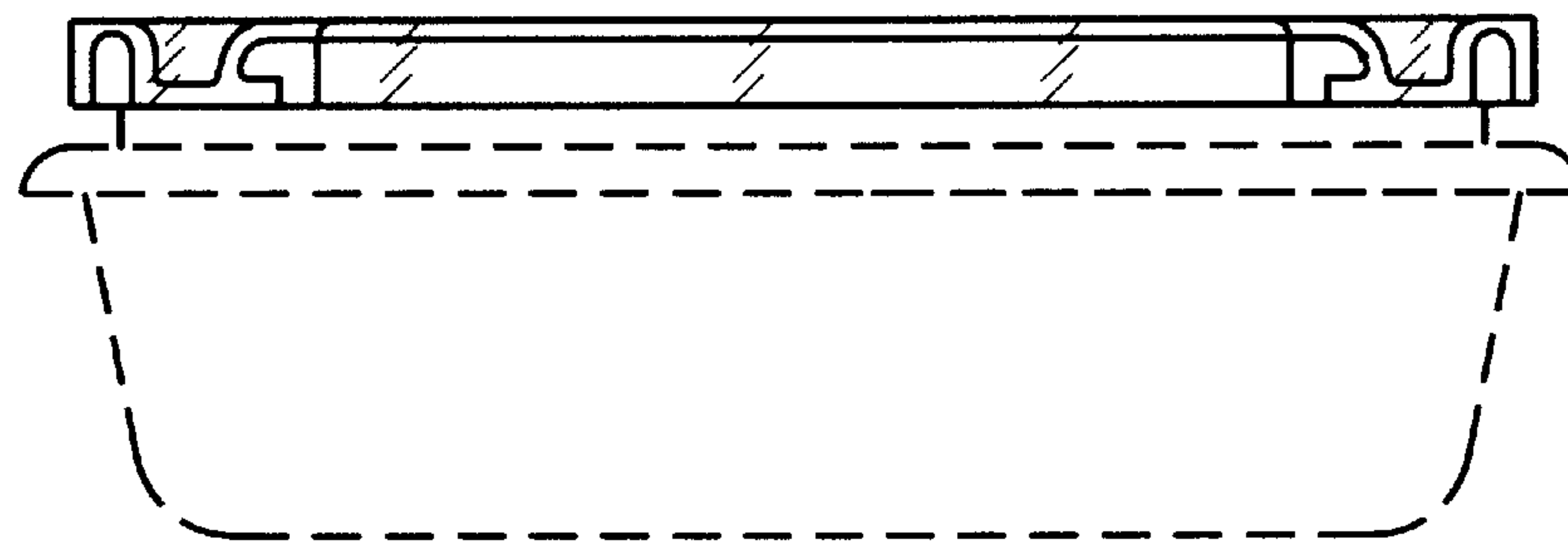

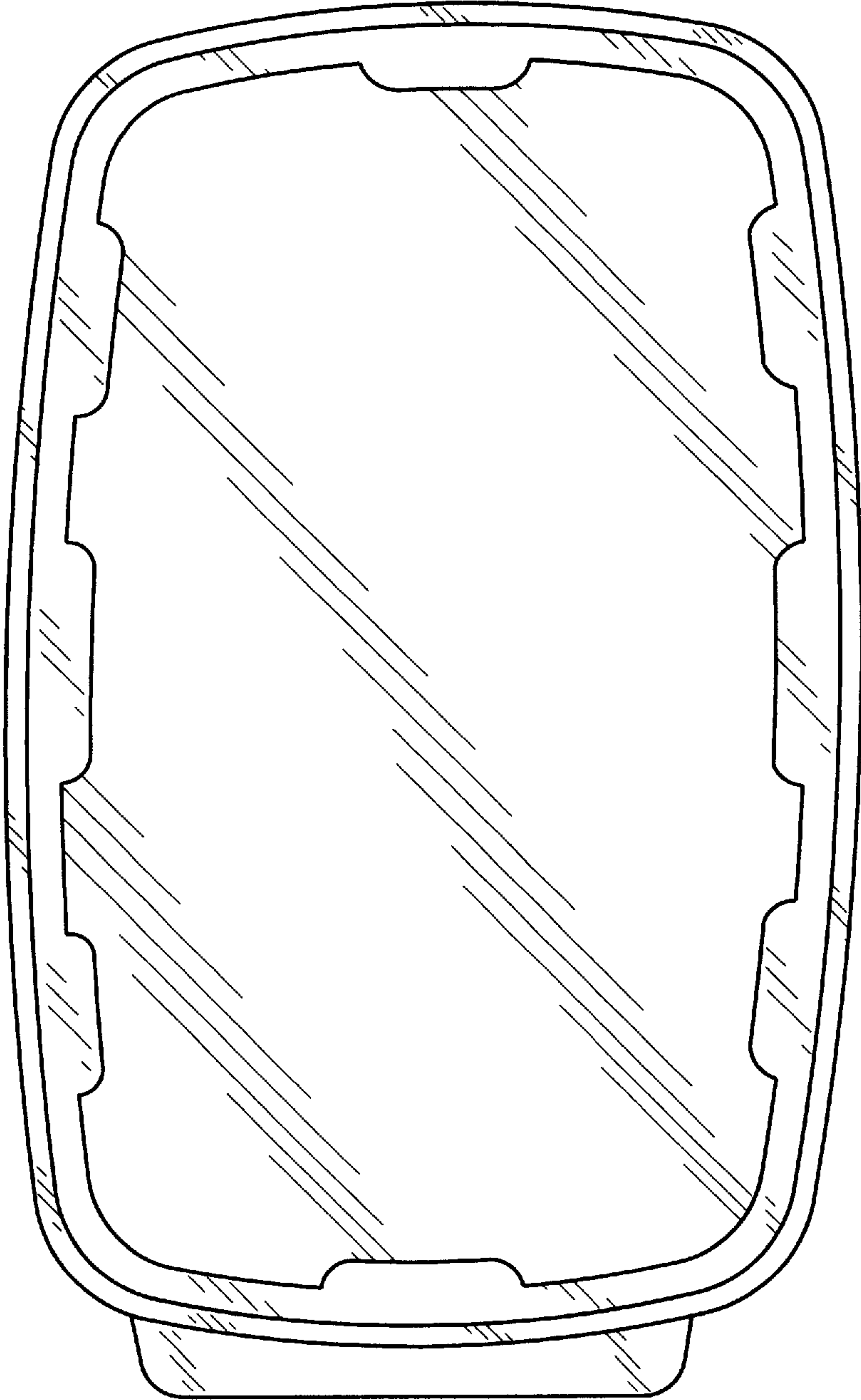
