The ornamental design for a knife handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the knife handle.

FIG. 2 is a top view of the knife handle; the bottom view being a mirror image thereof;

FIG. 3 is a left side view of the knife handle.

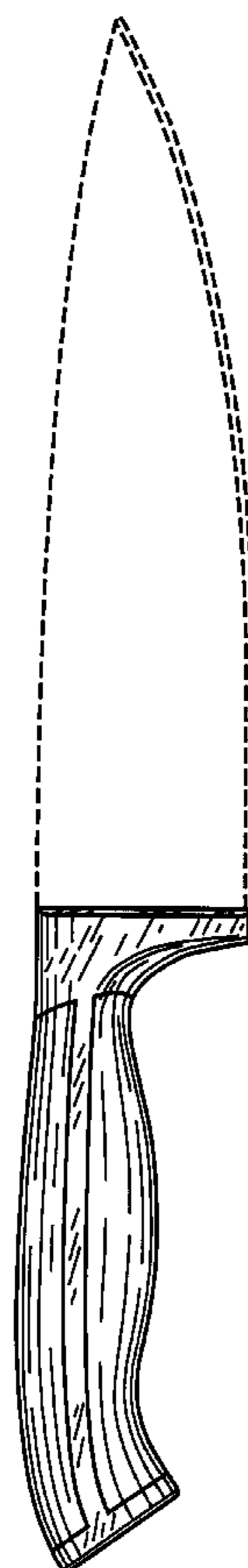
FIG. 4 is a right side view of the knife handle.

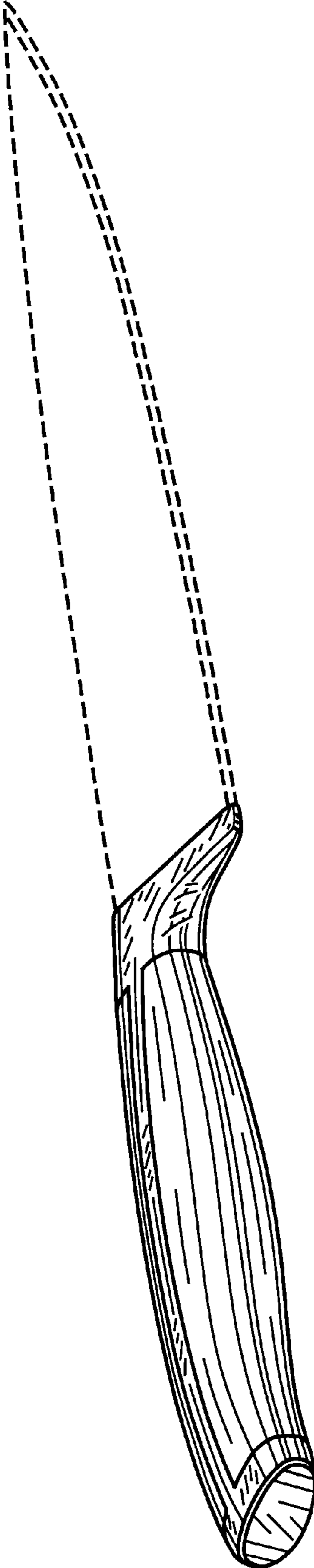

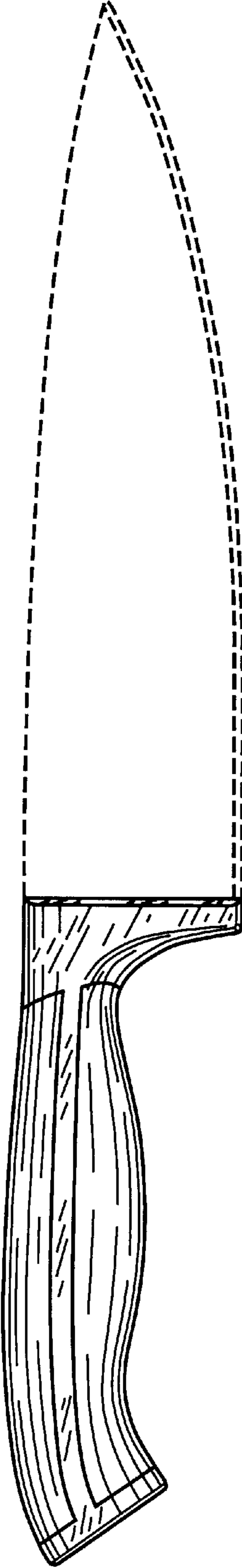

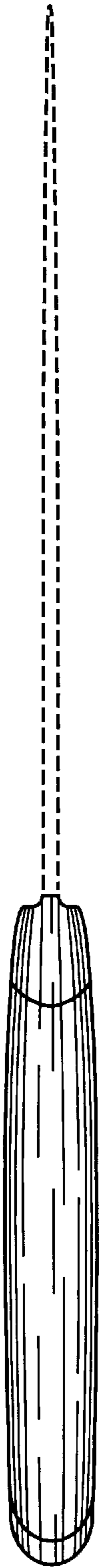

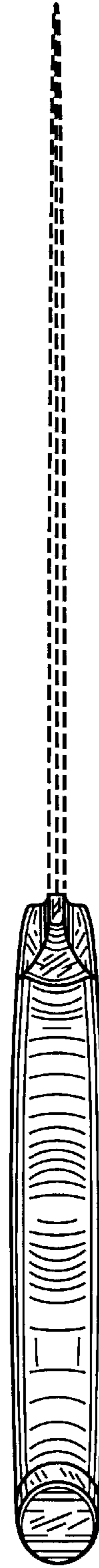

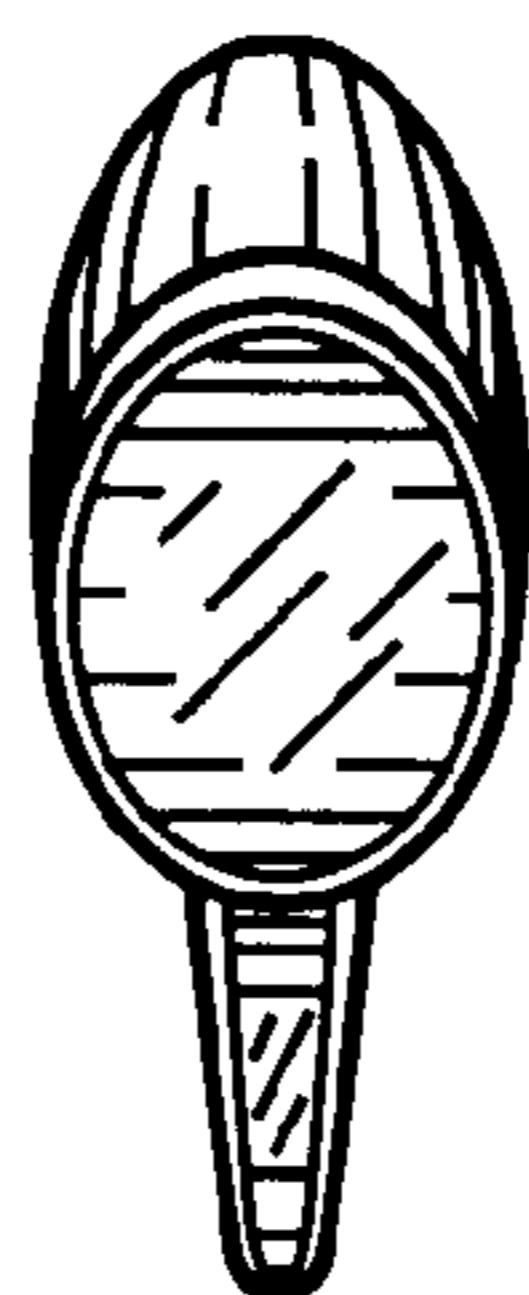
