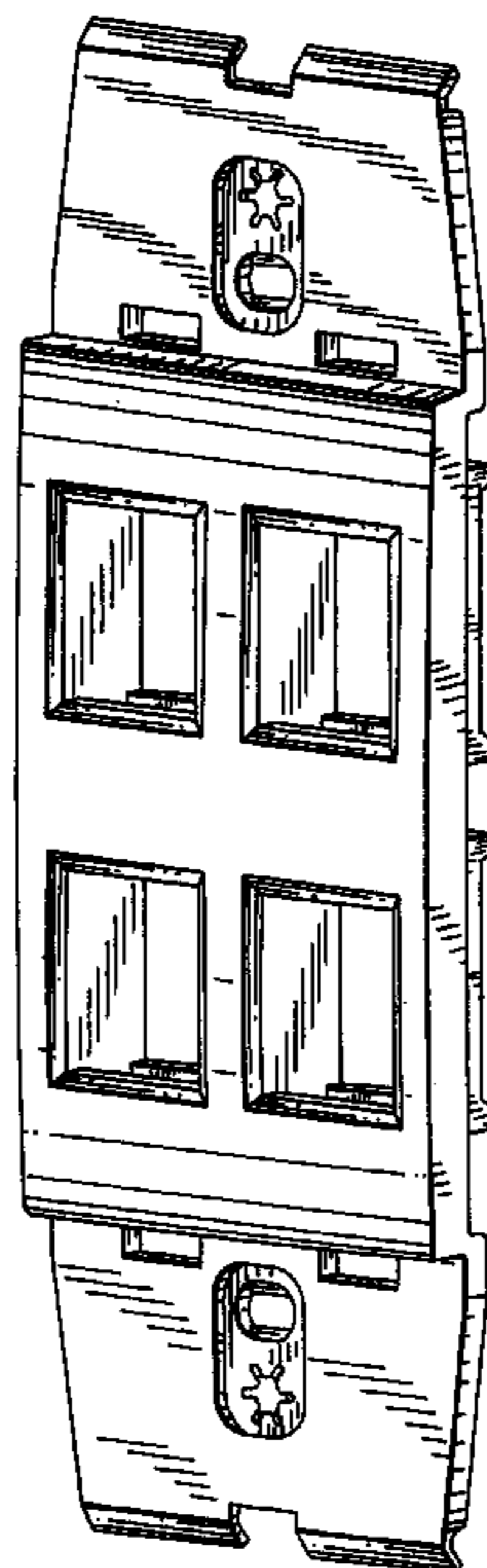
(57) **CLAIM**

FIG. 1 is a front perspective view illustrating a design for a four port wall plate insert;

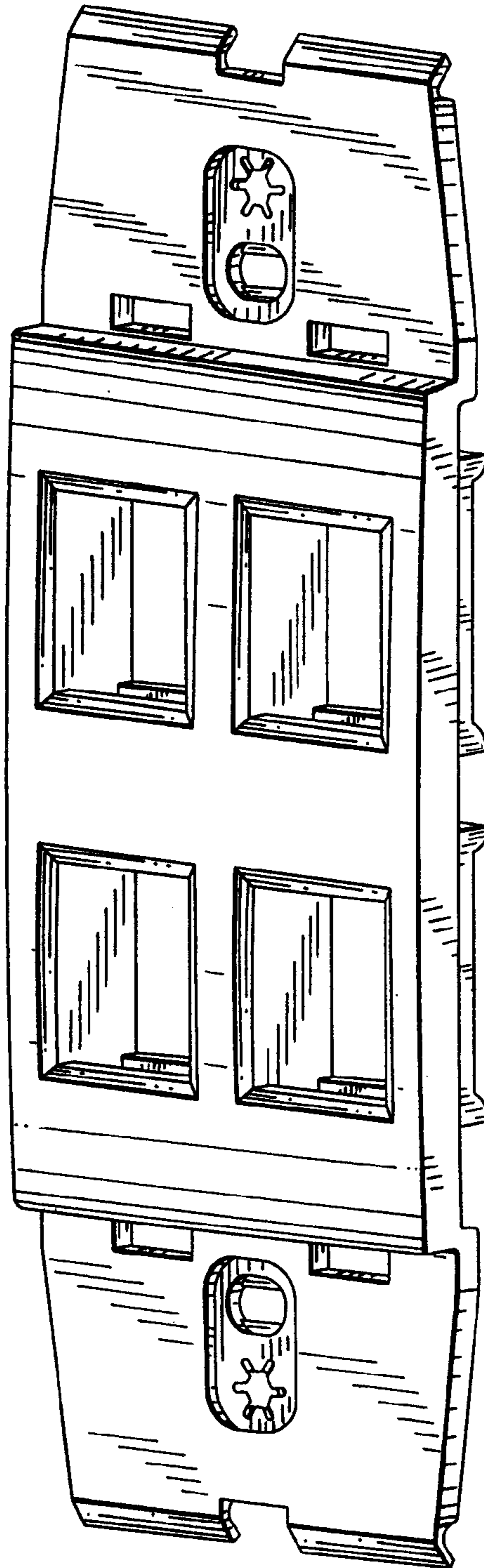

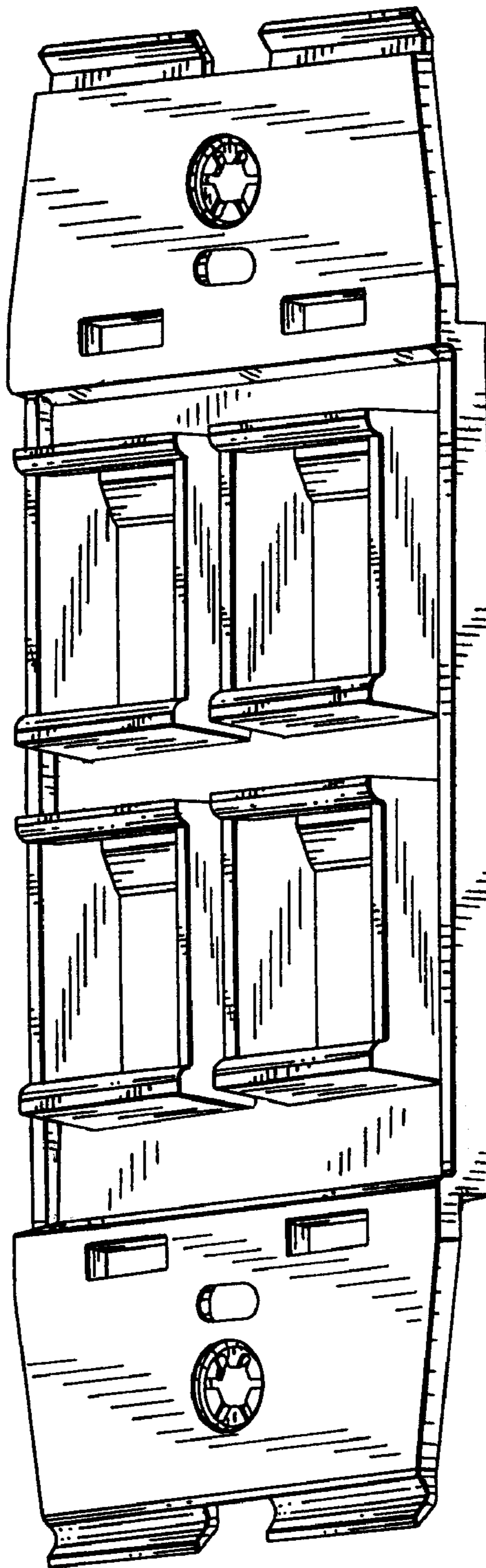

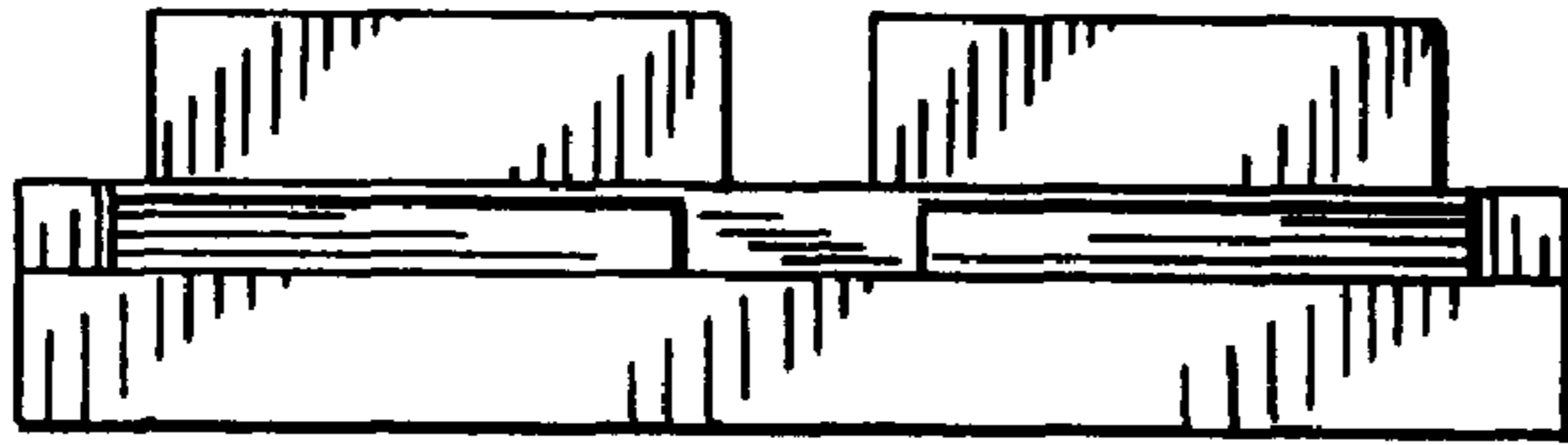

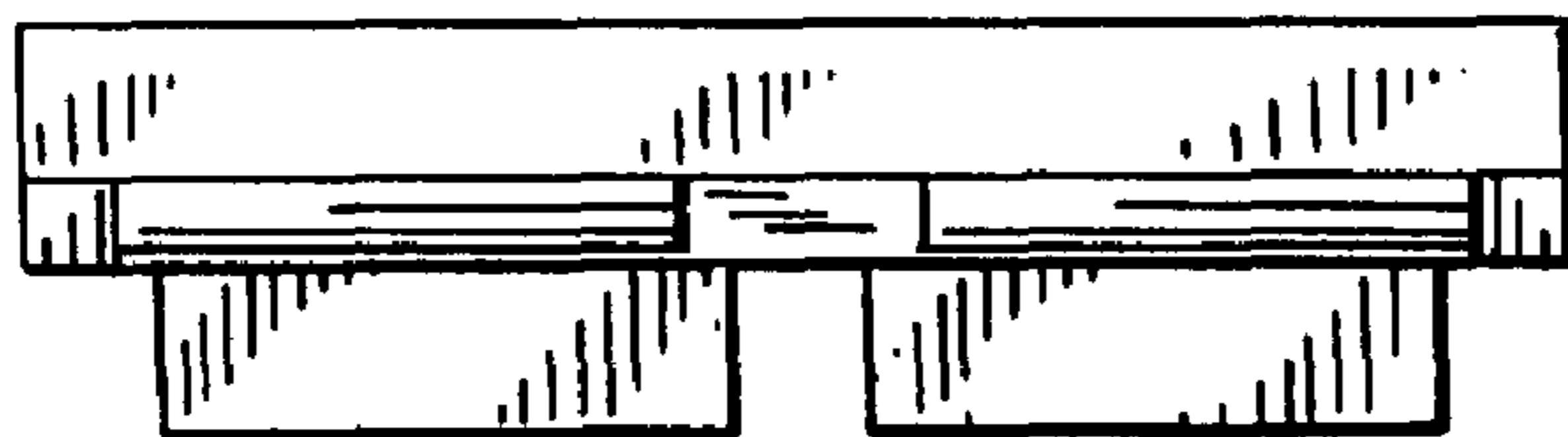

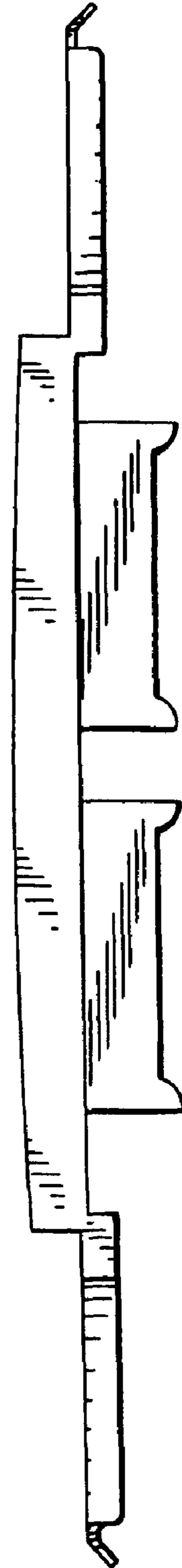
