FIG. 4 is a front view thereof;

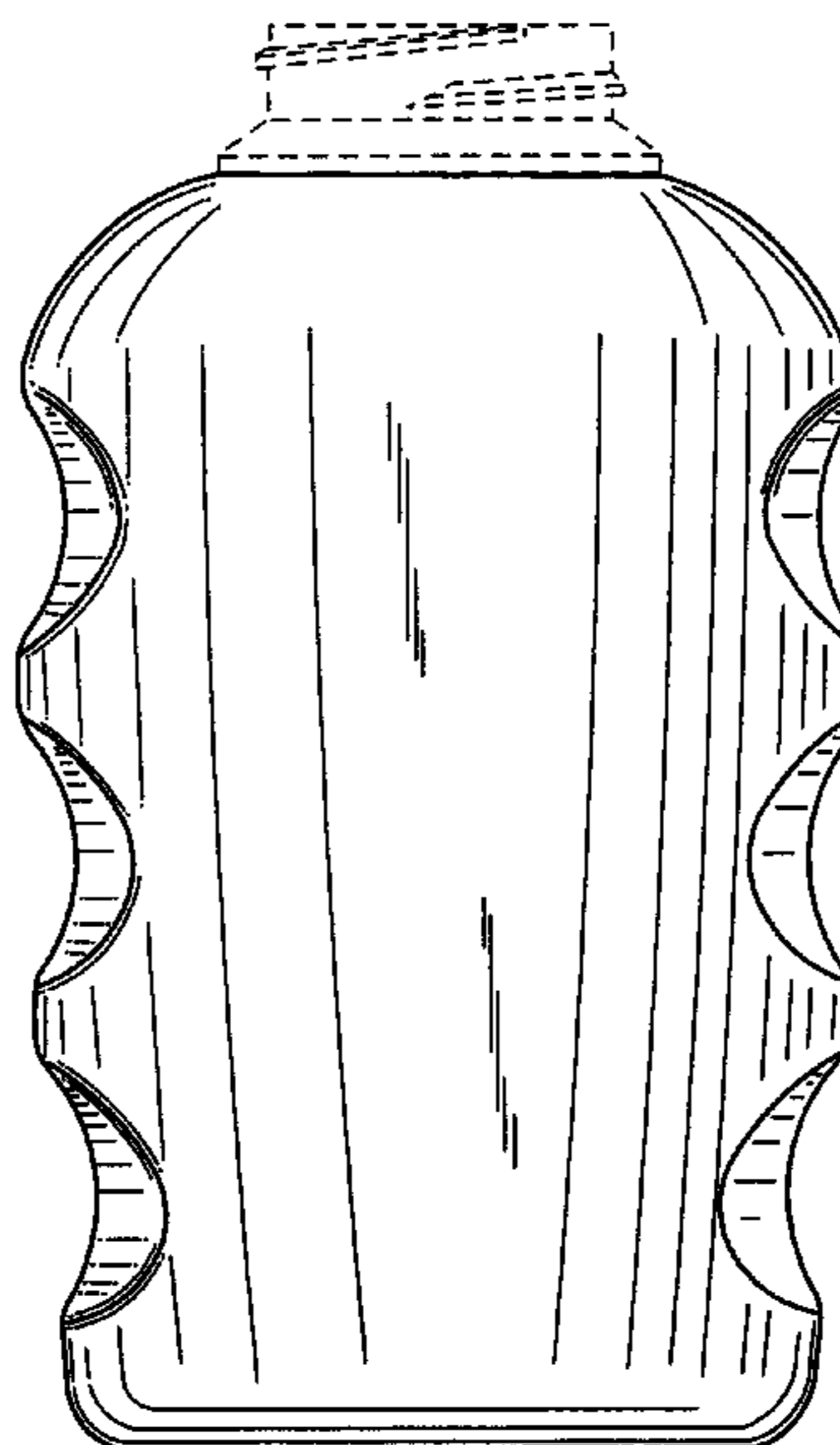
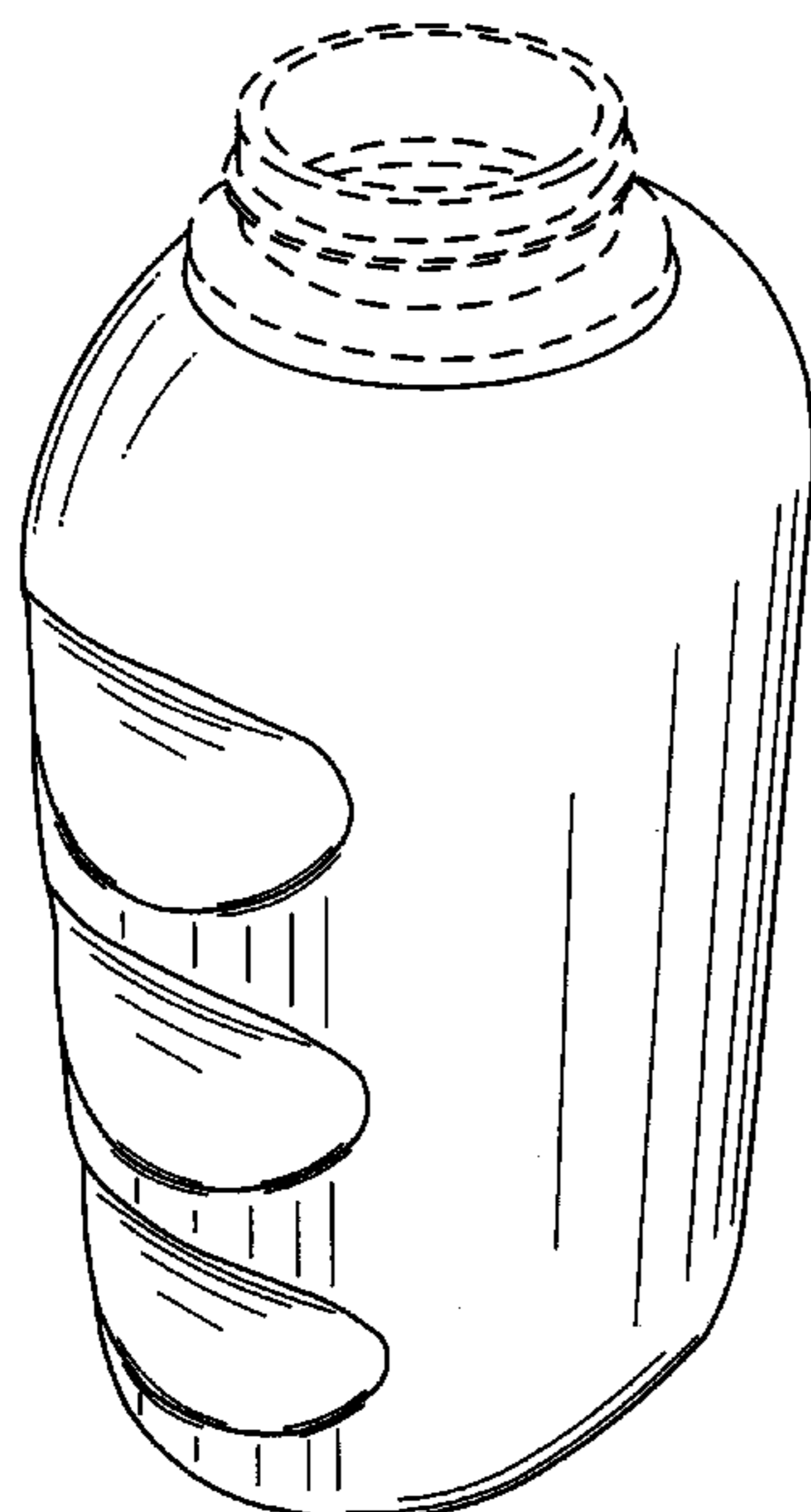
FIG. 5 is a rear view thereof;

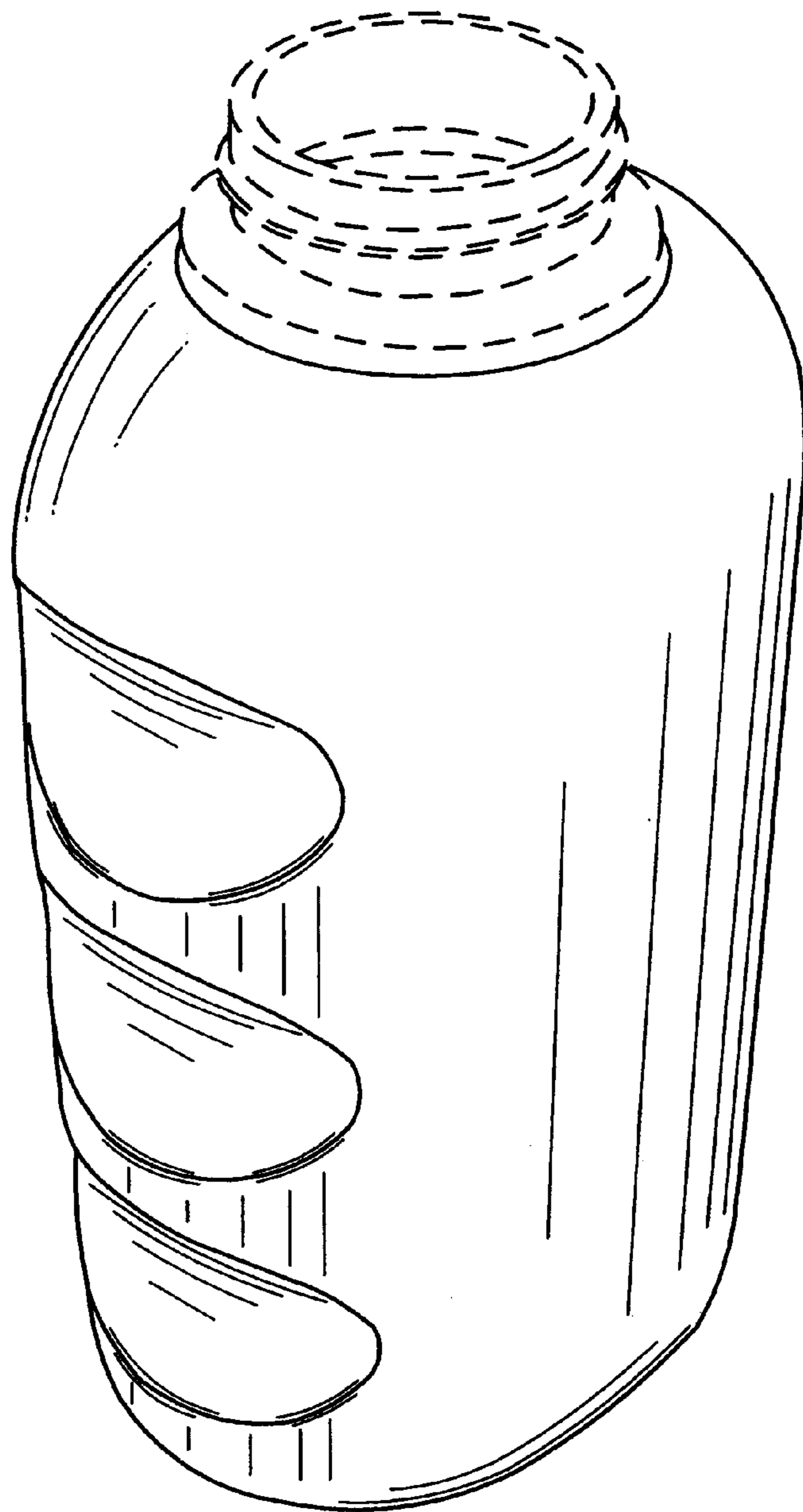
FIG. 6 is a top view thereof; and,

FIG. 7 is a bottom view thereof.

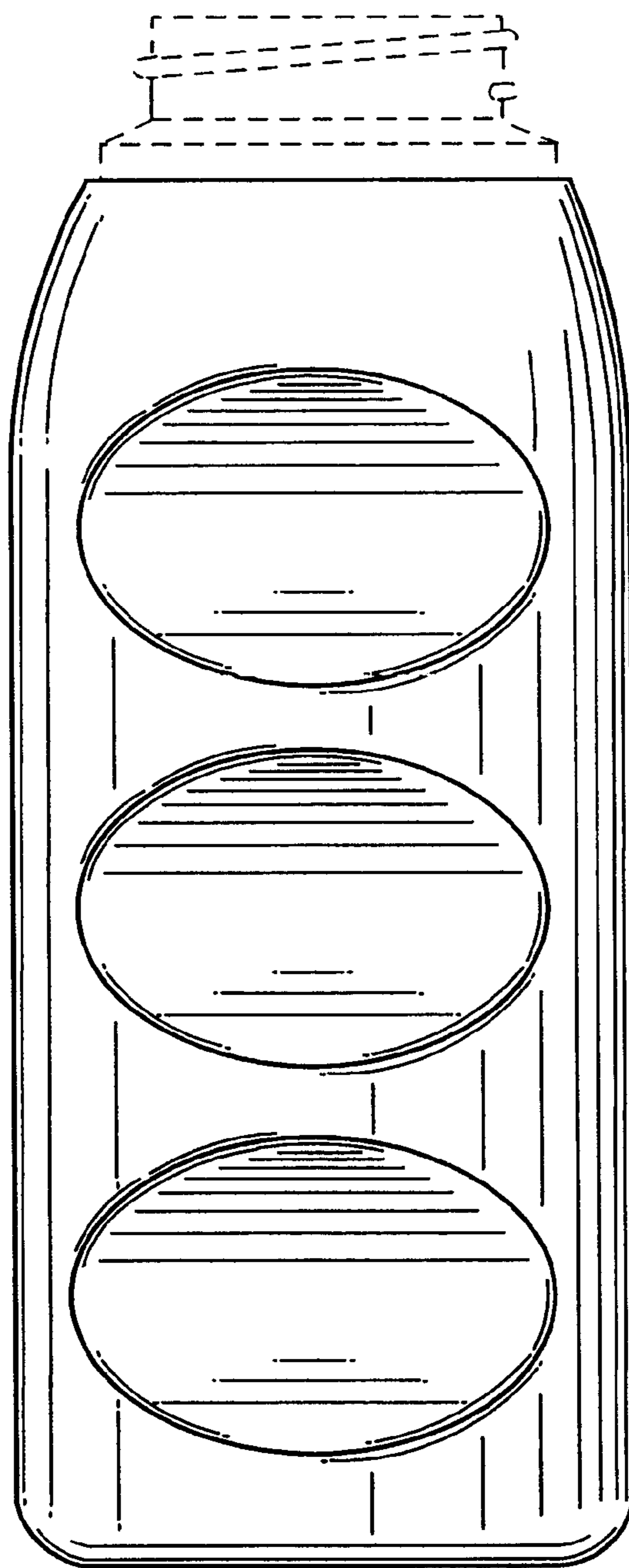
The broken line showing of the bottle neck is for illustrative purposes only and forms no part of the claimed design.

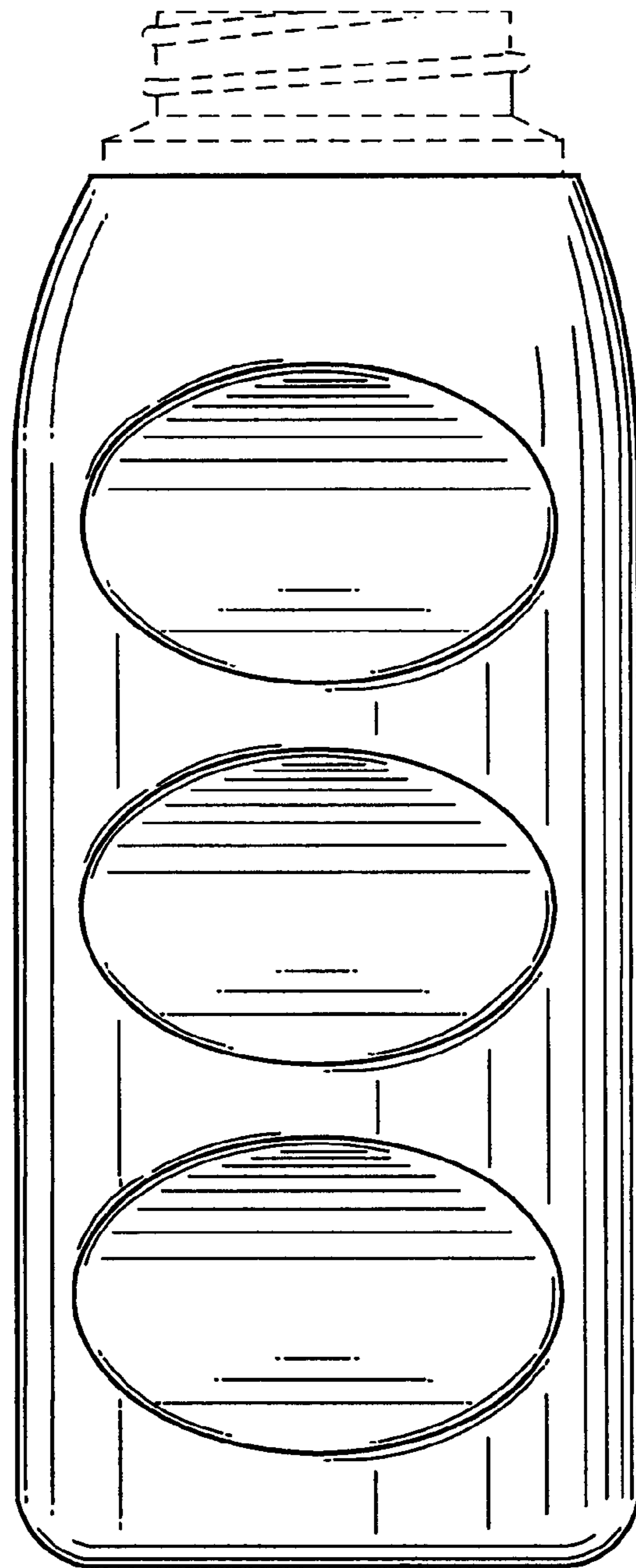




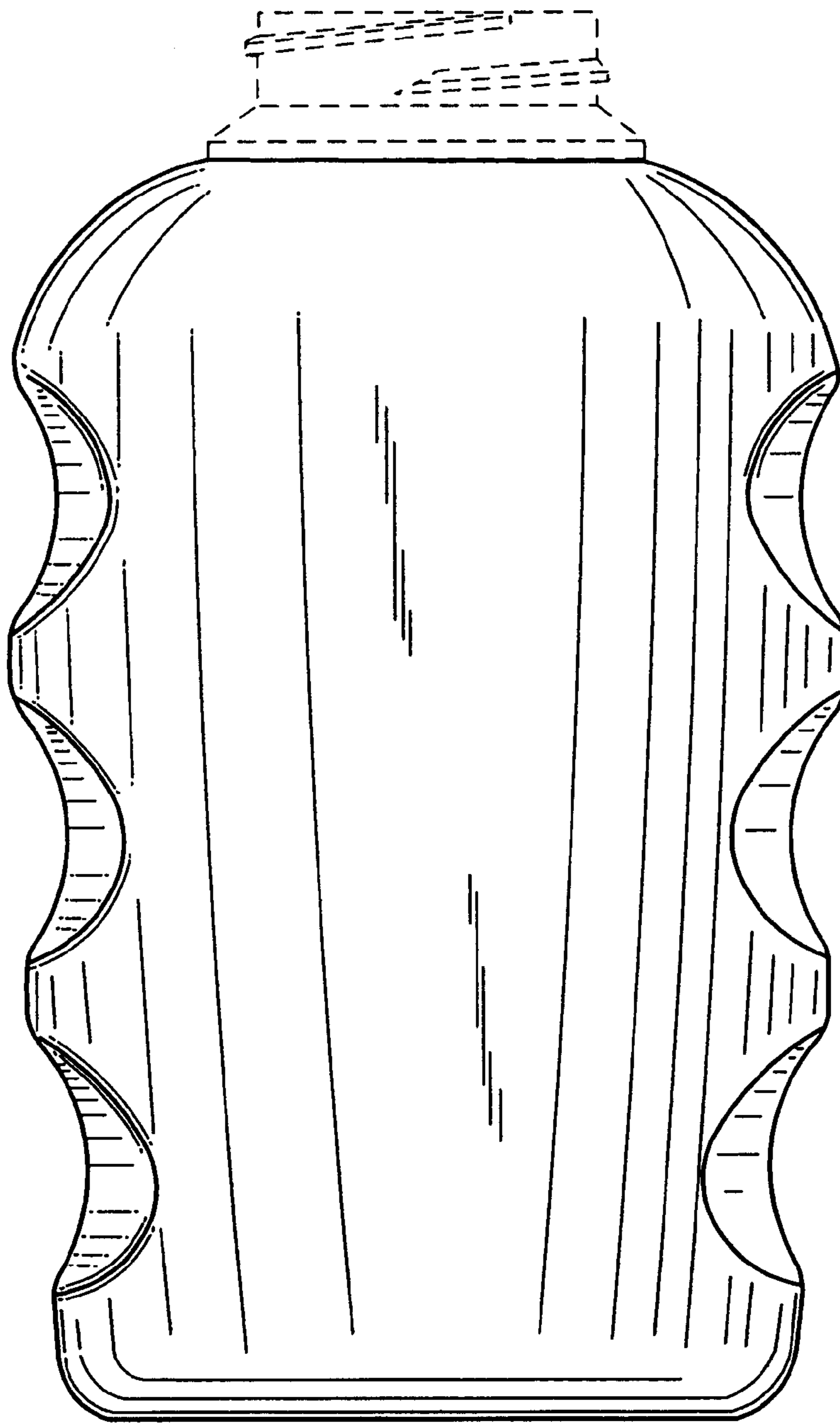

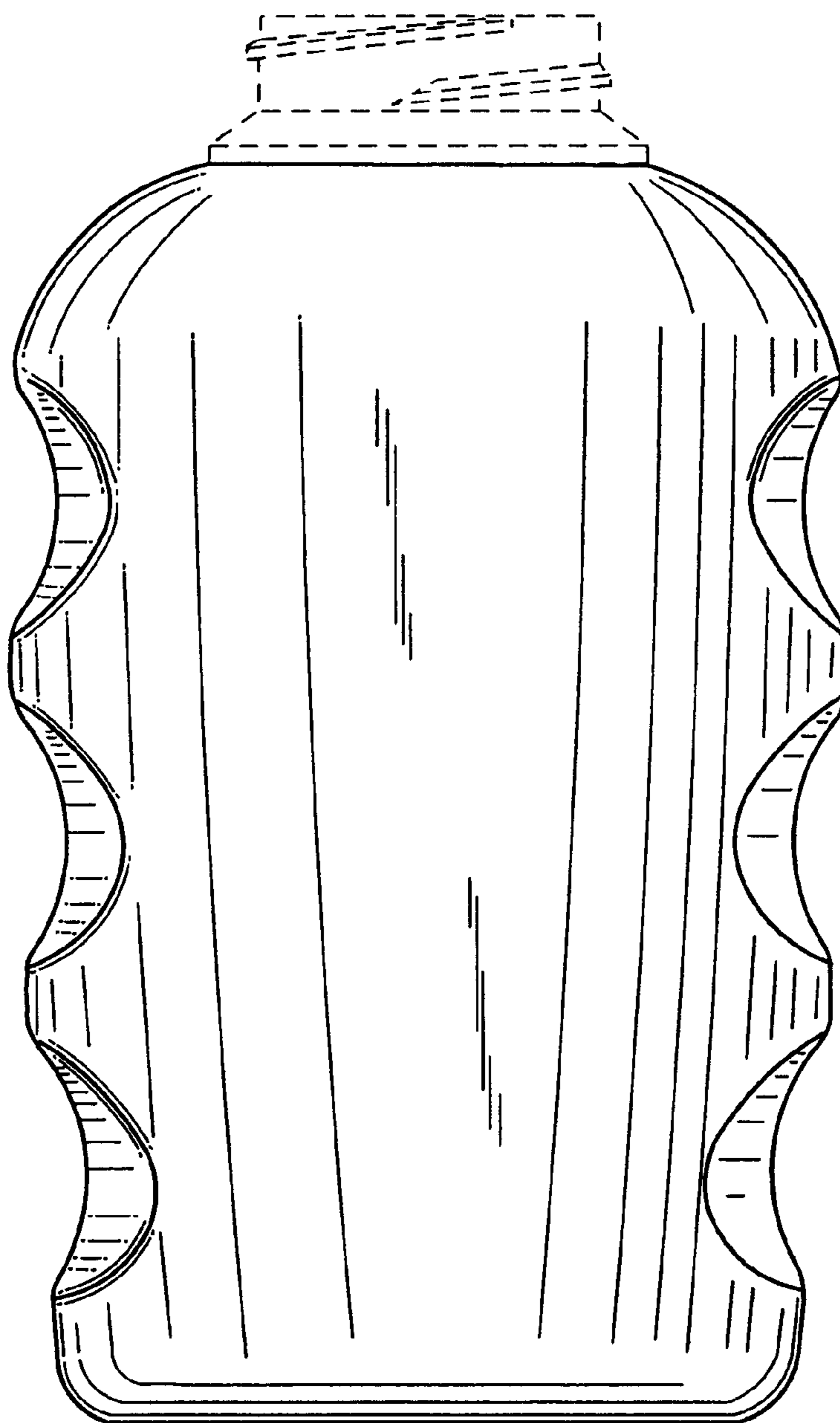

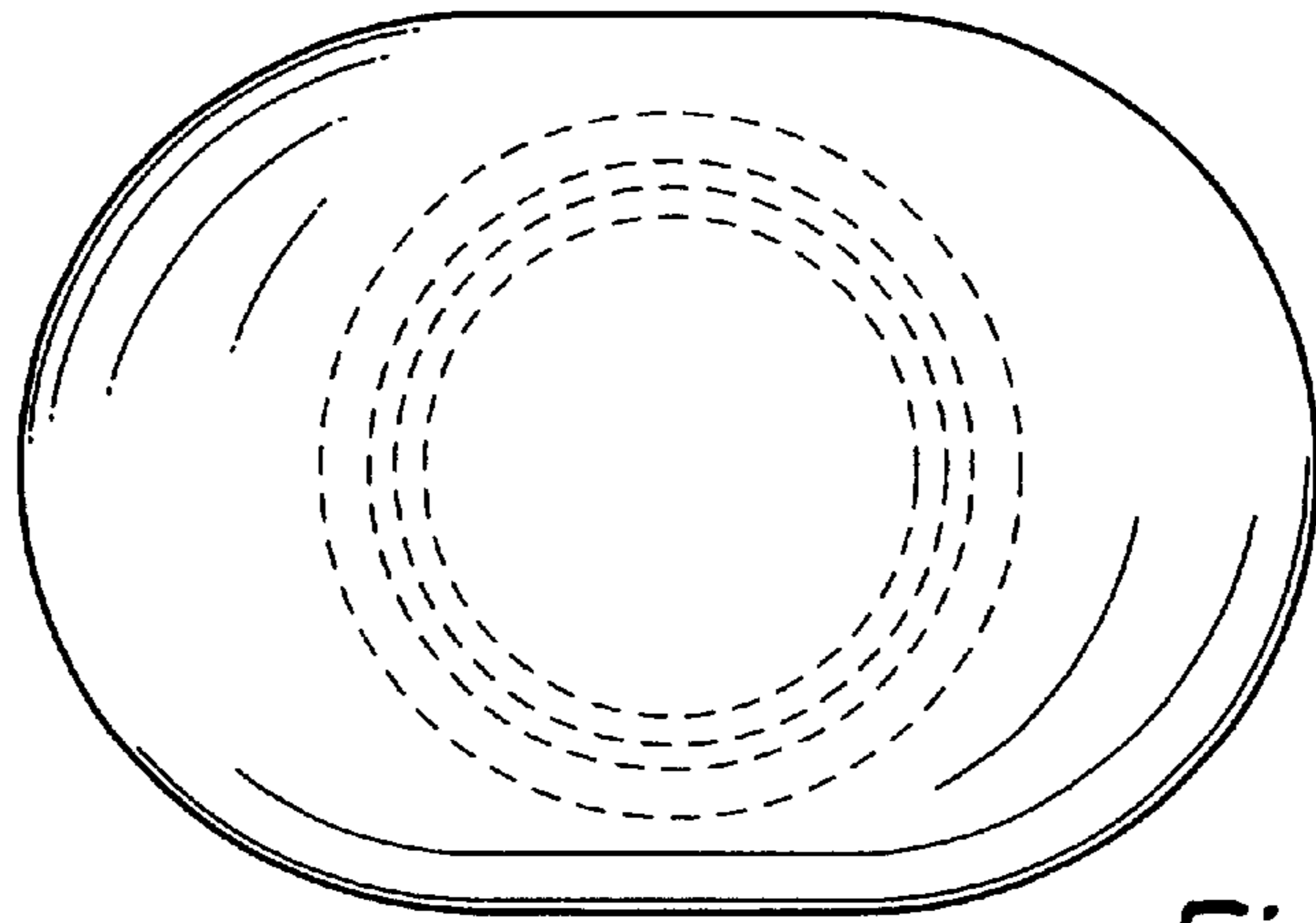

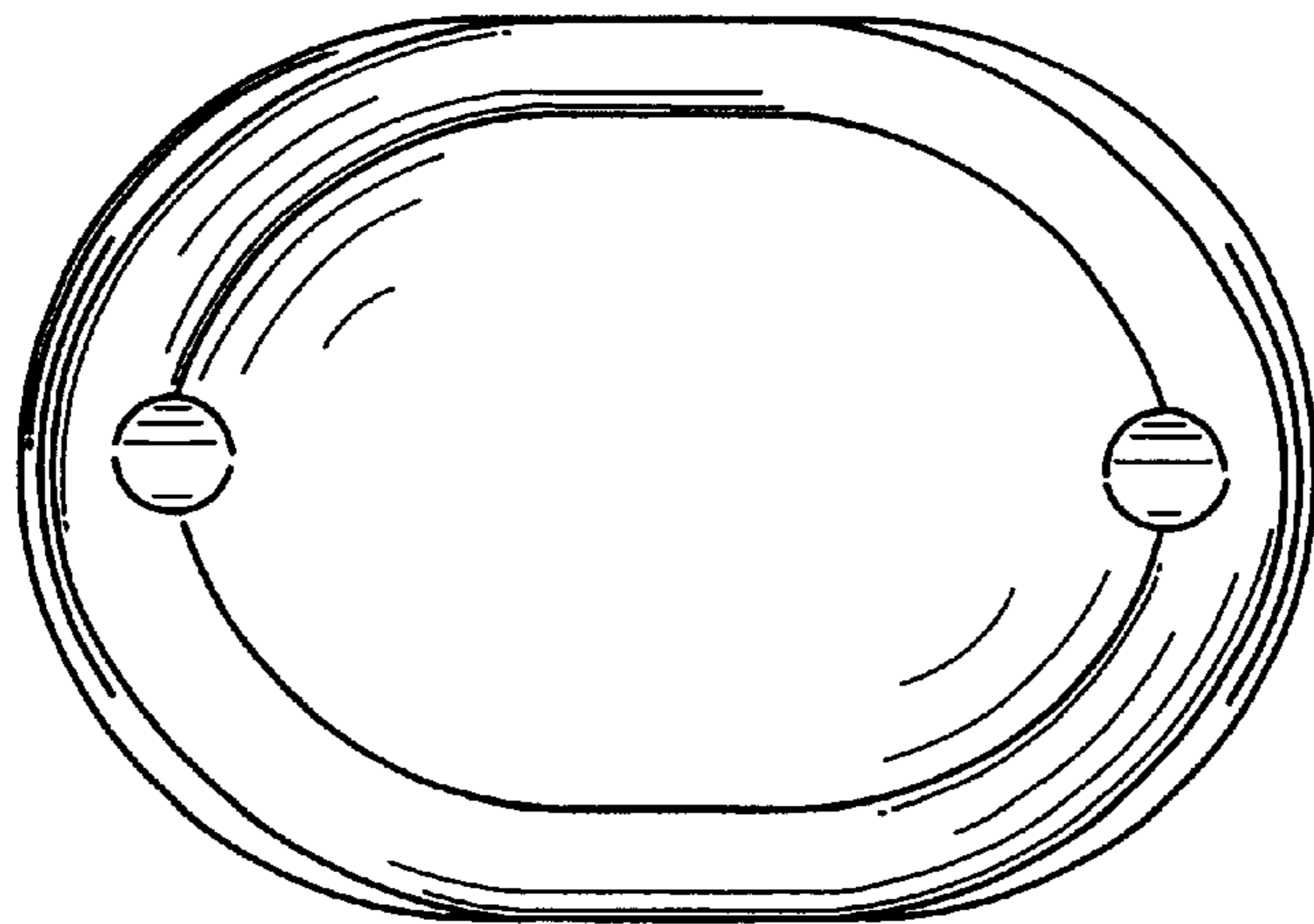
