(57) **CLAIM**

The ornamental design for a fluid product dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the top and front of a fluid product dispenser according to a first embodiment showing our new design;

FIG. 4 is a right side elevational view thereof;

FIG. 12 is a right side elevational view thereof;

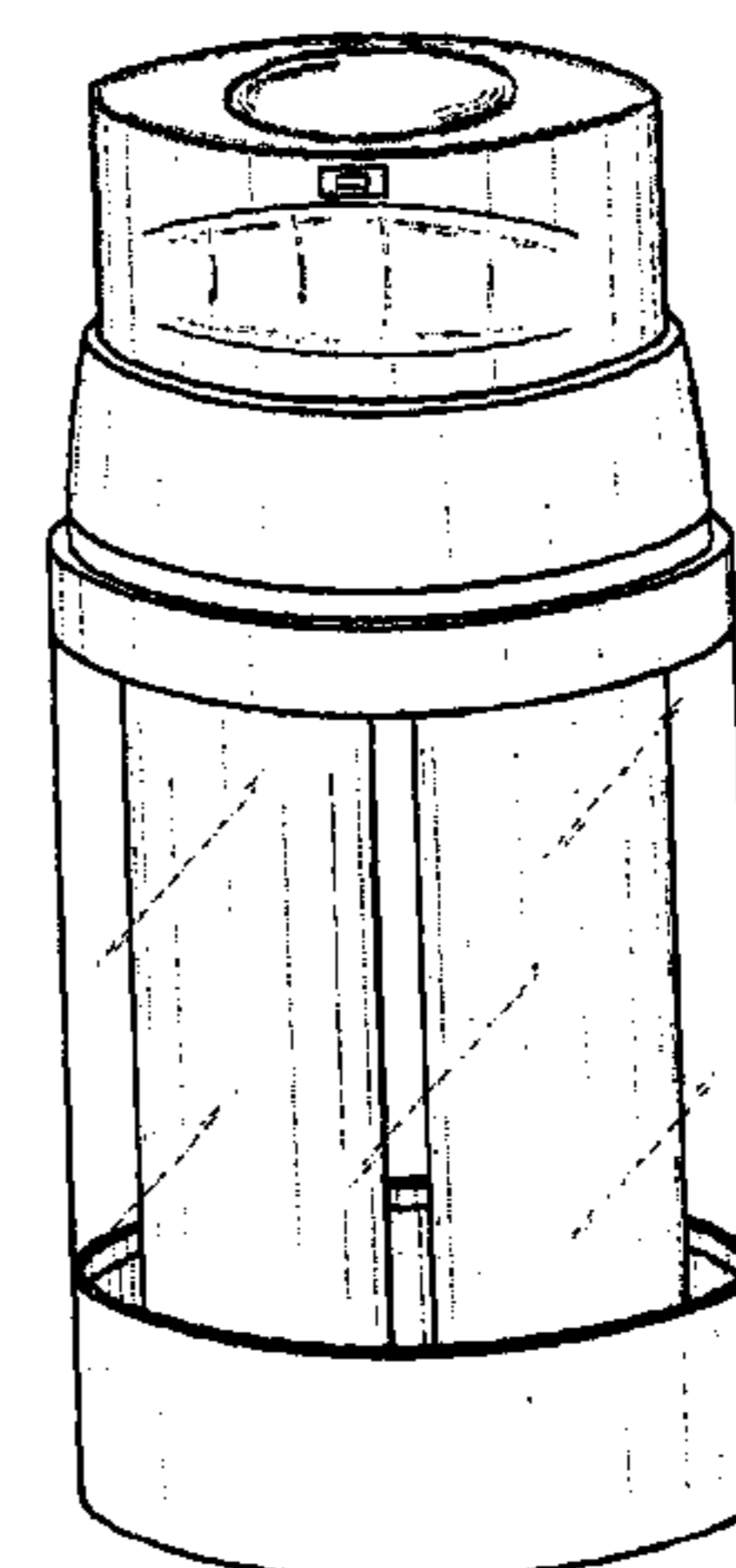
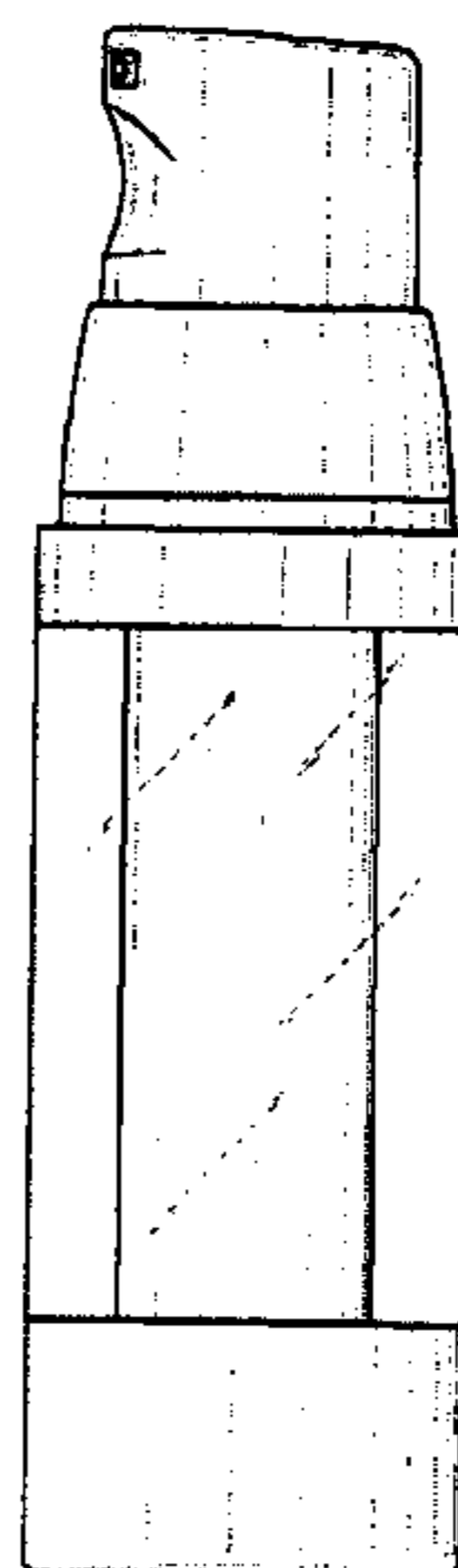
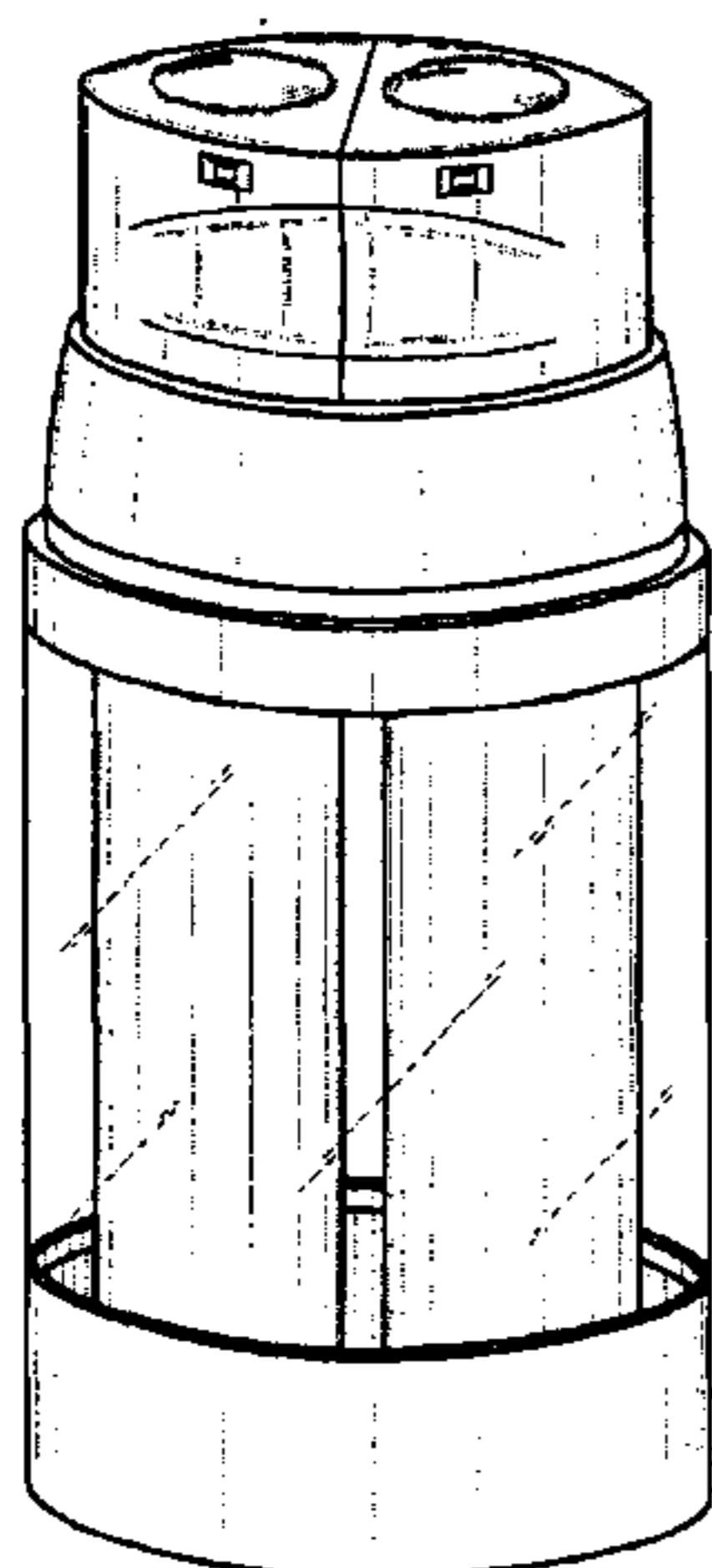
FIG. 13 is a left side elevational view thereof;

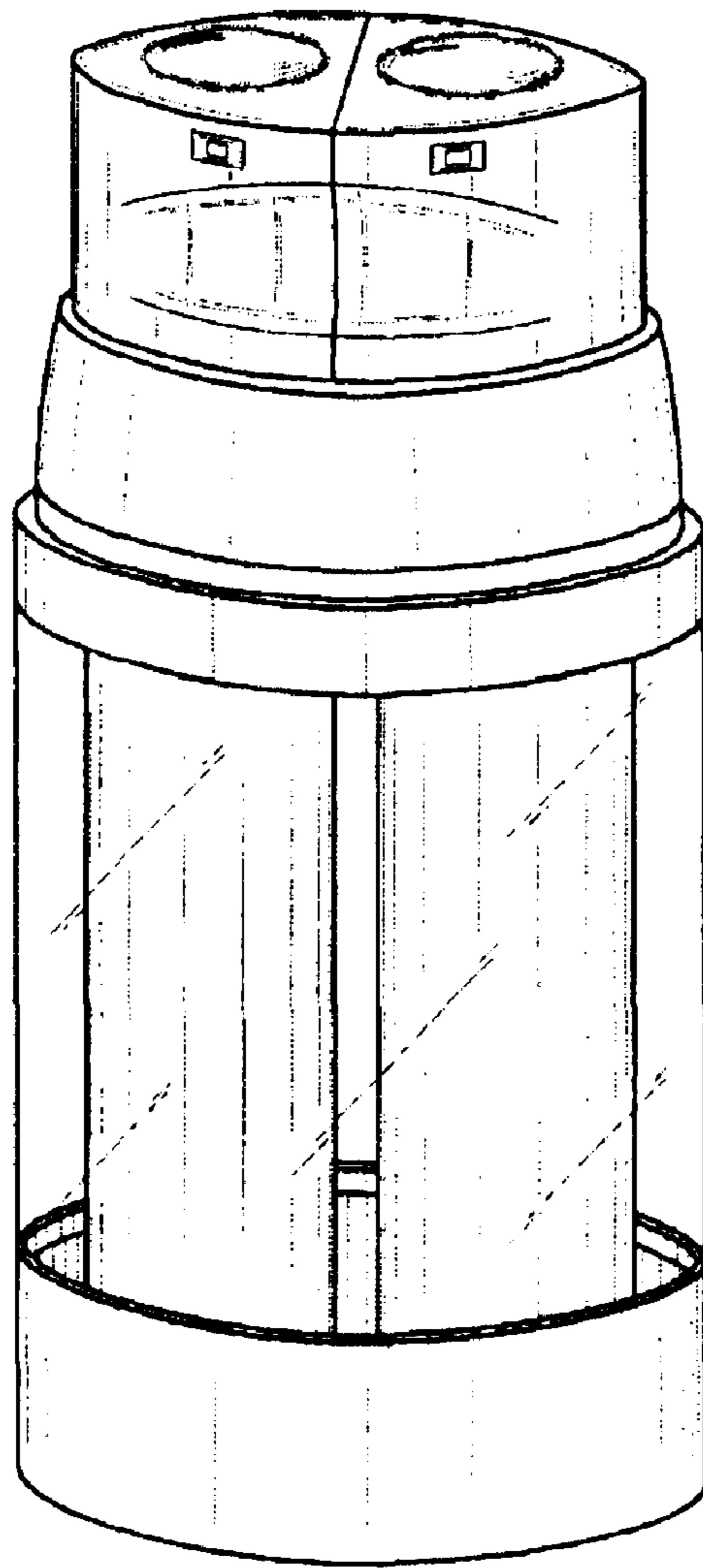

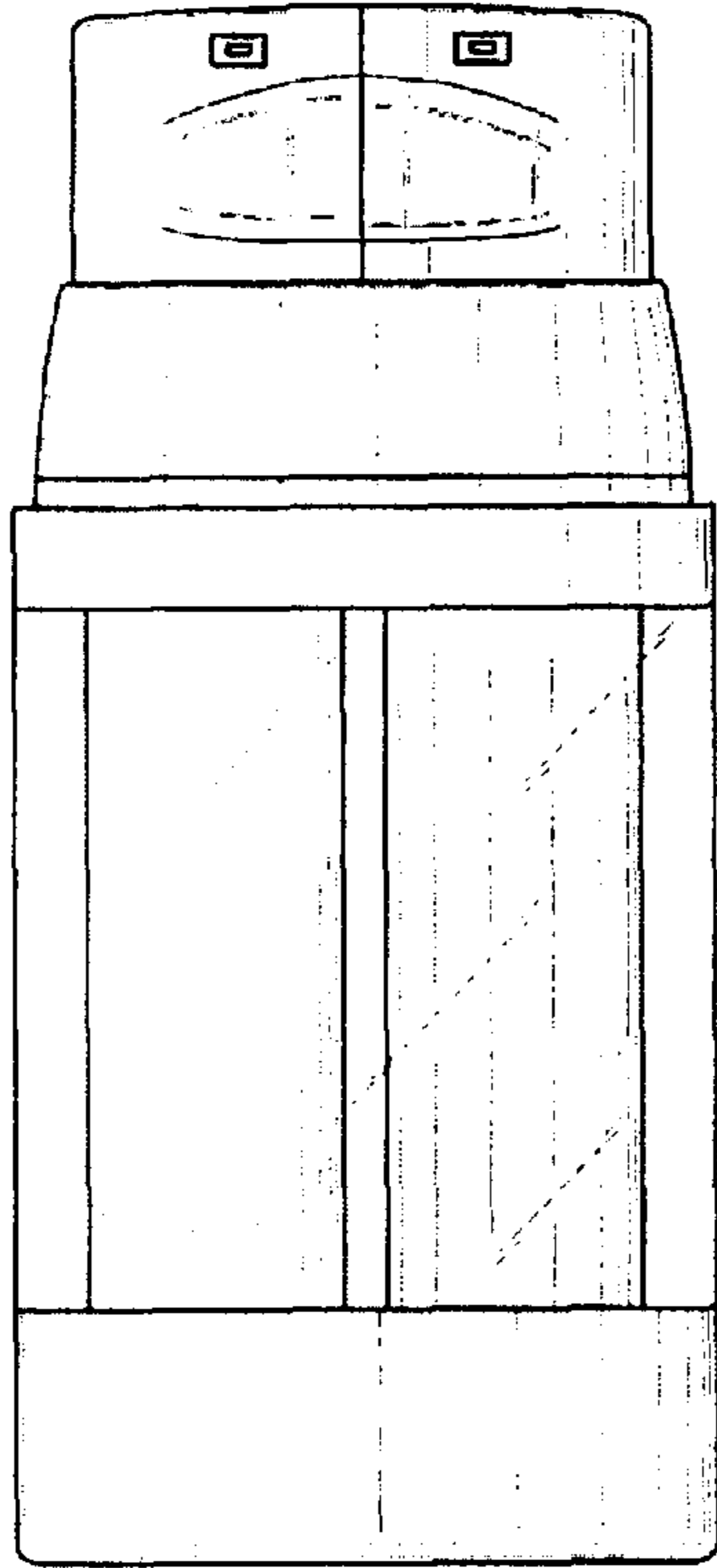

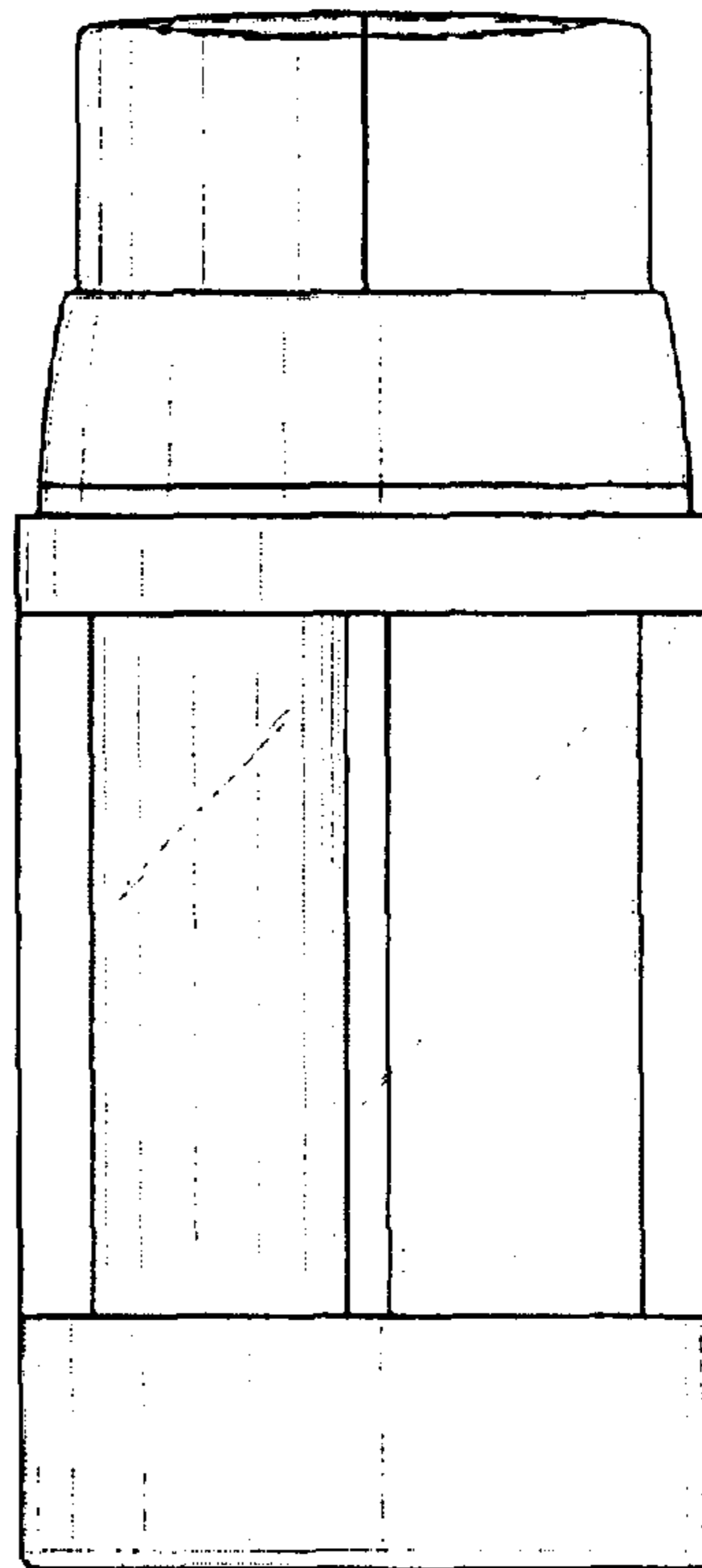

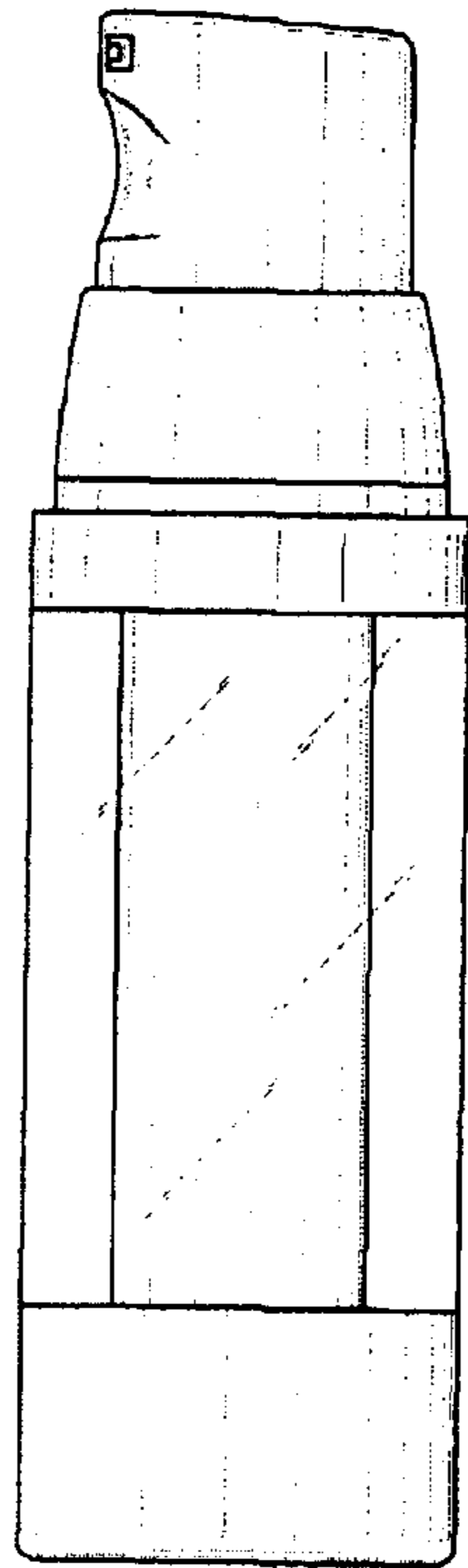

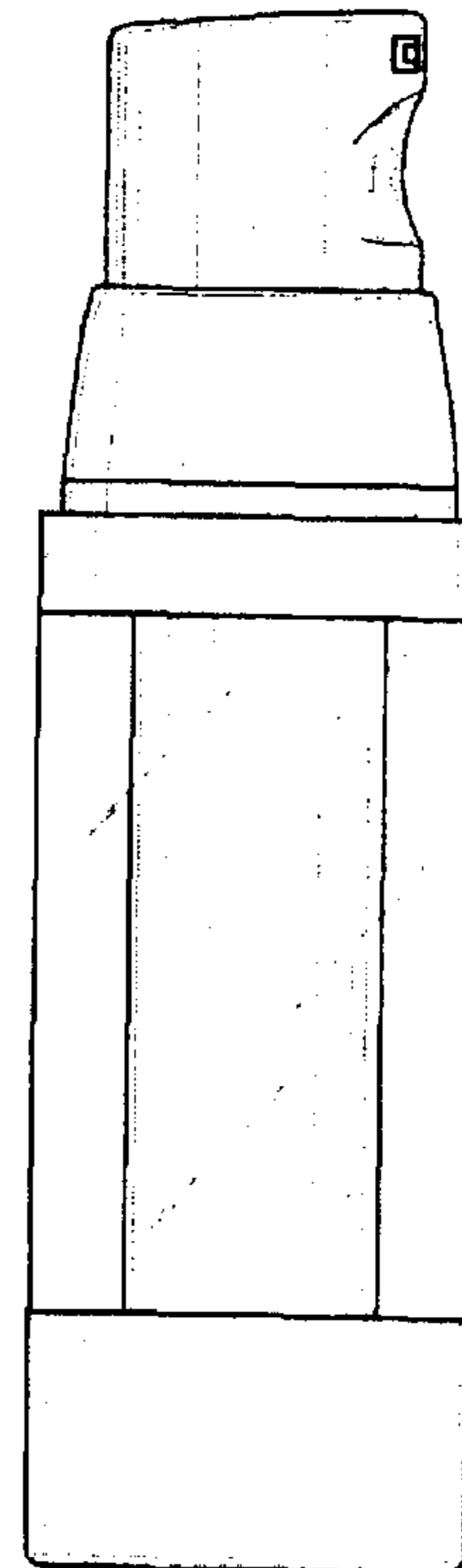

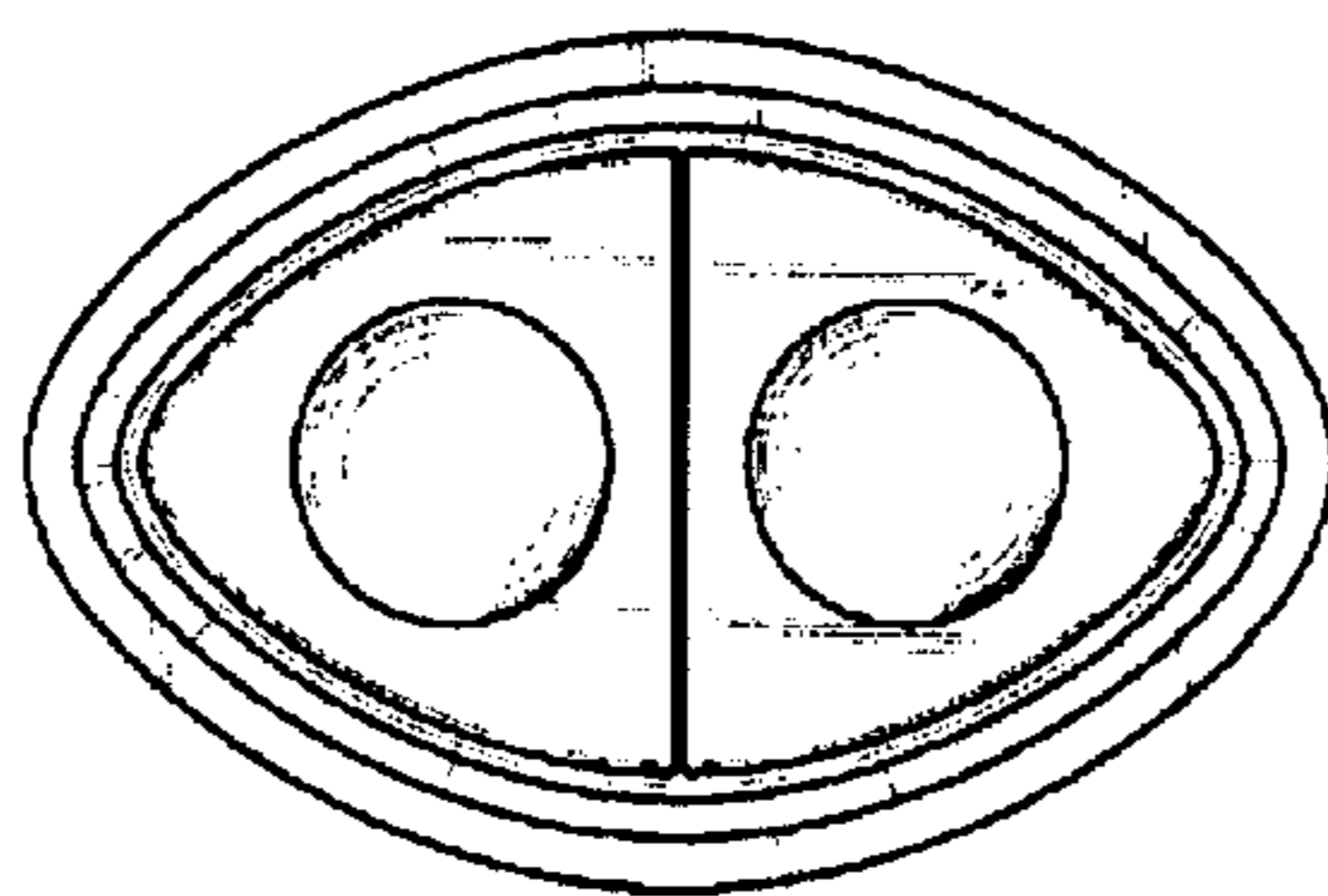

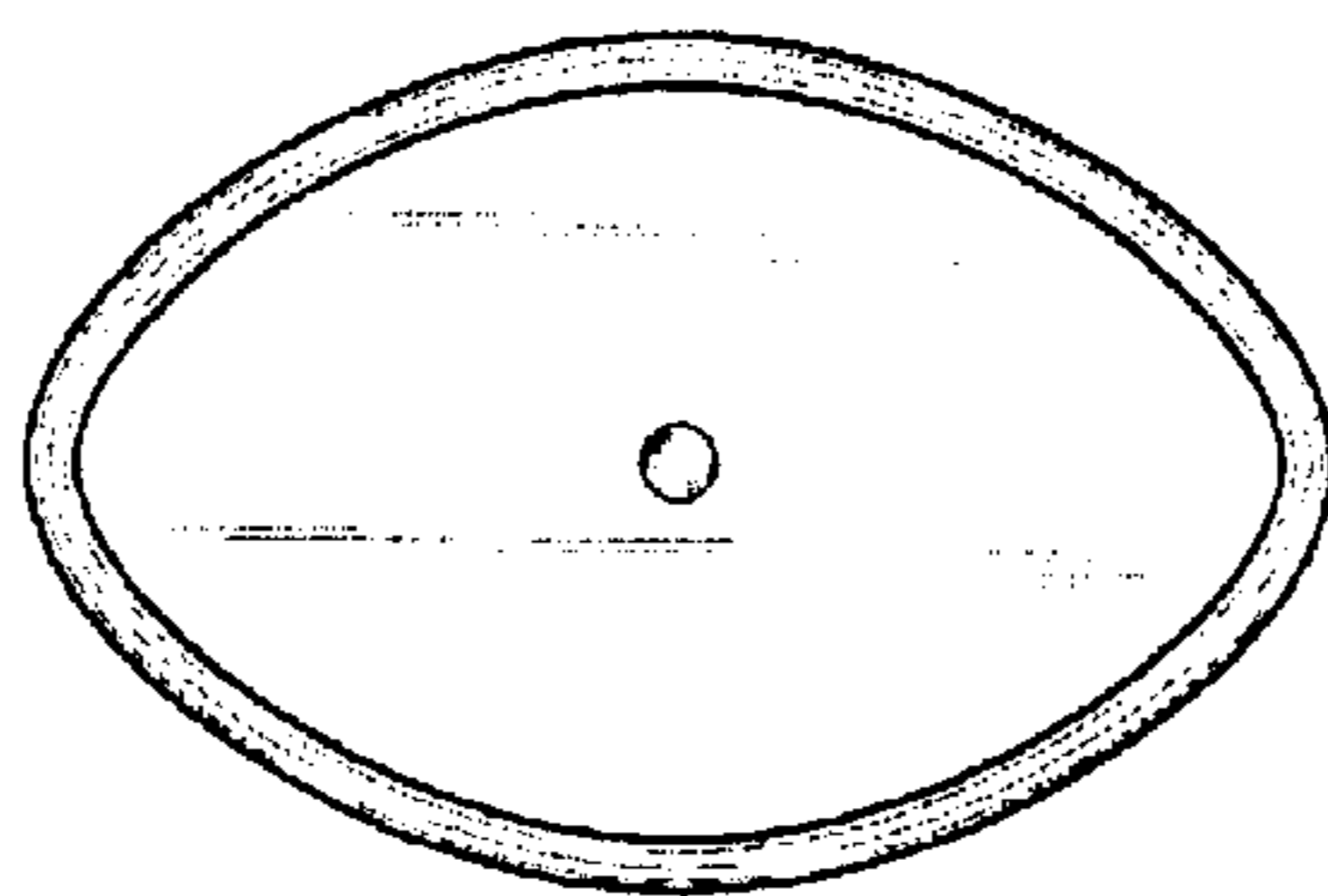

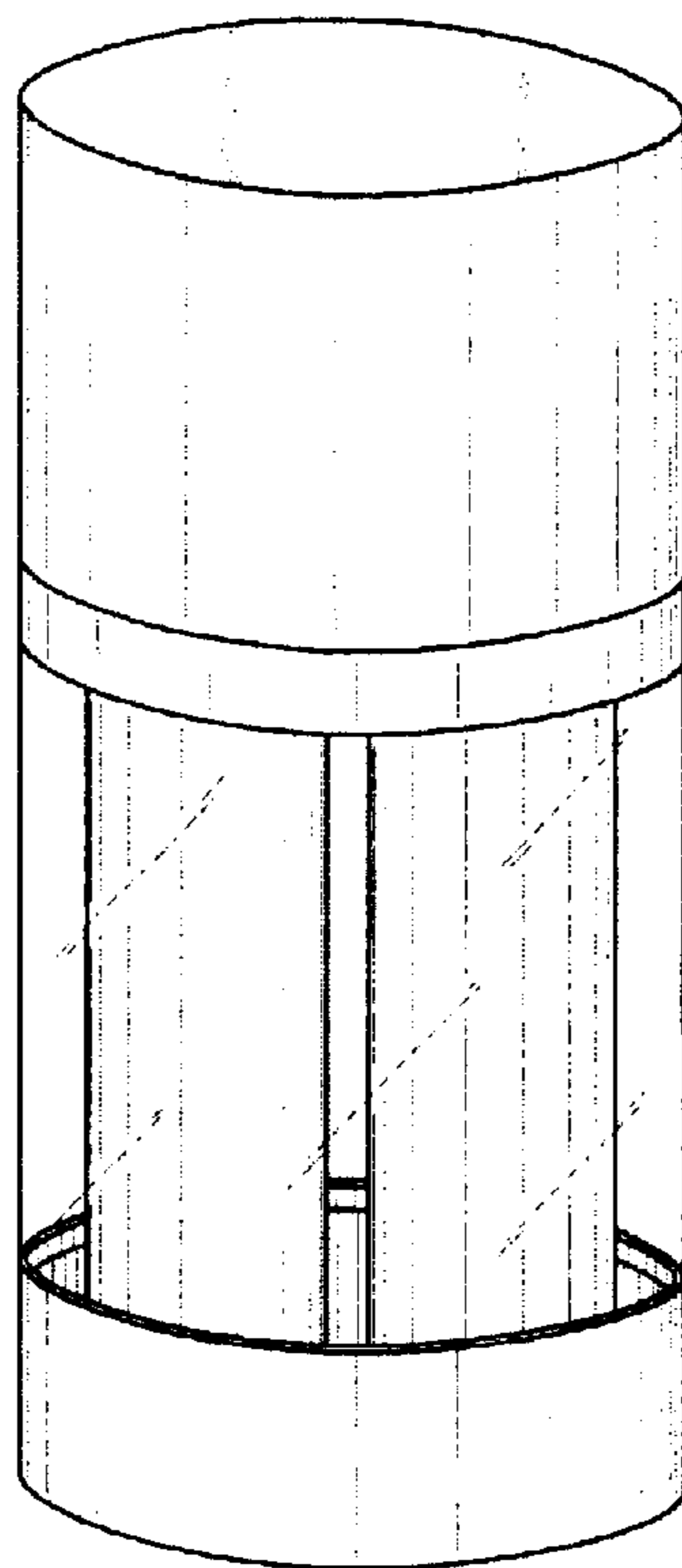

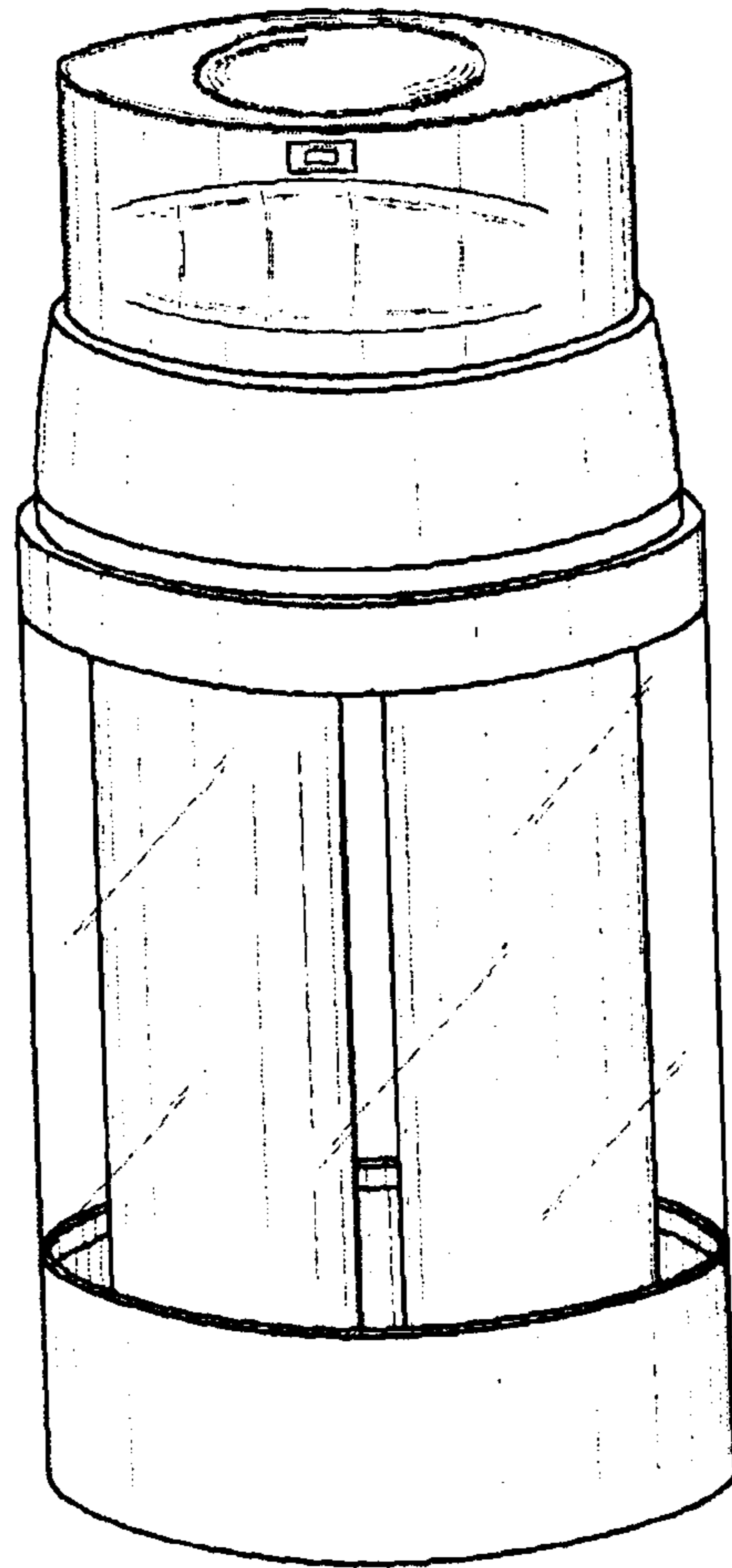

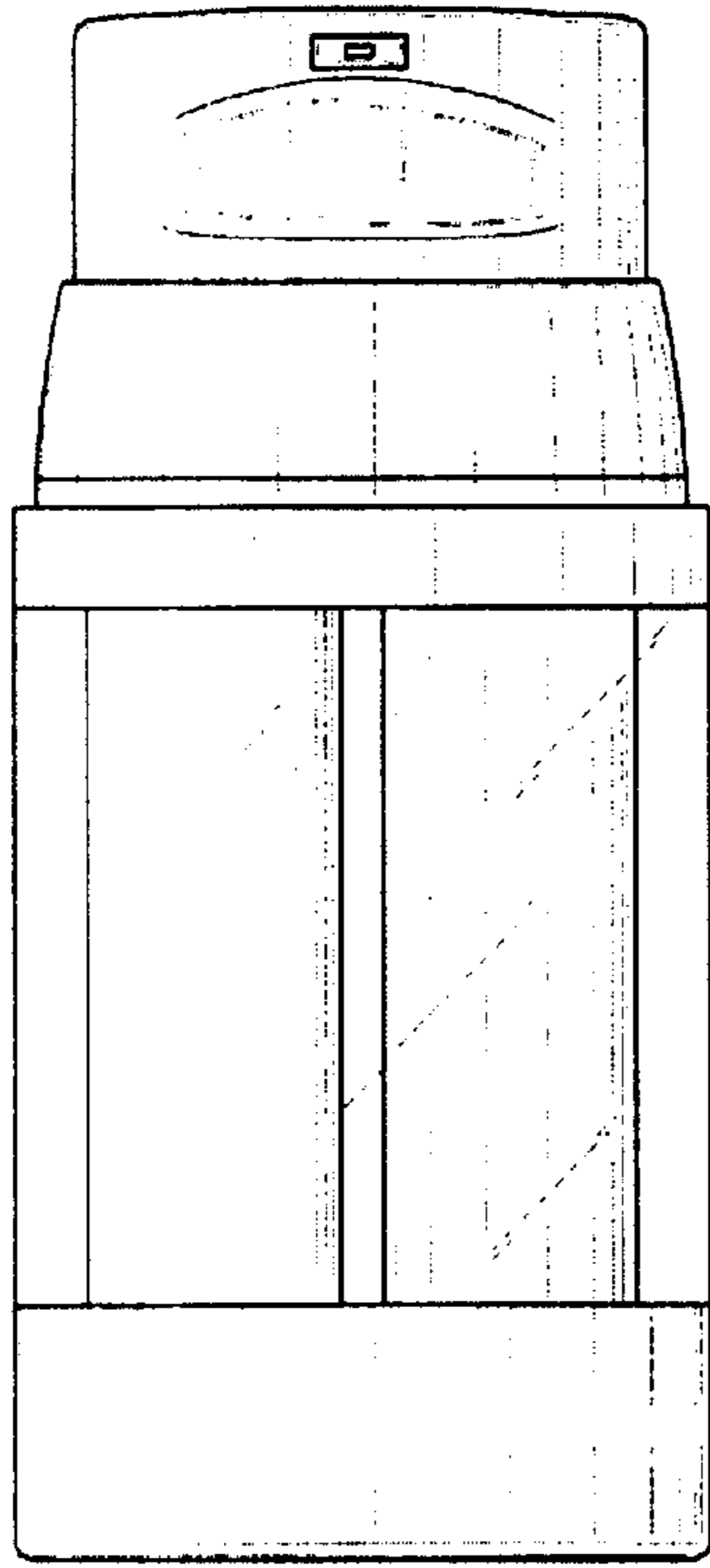

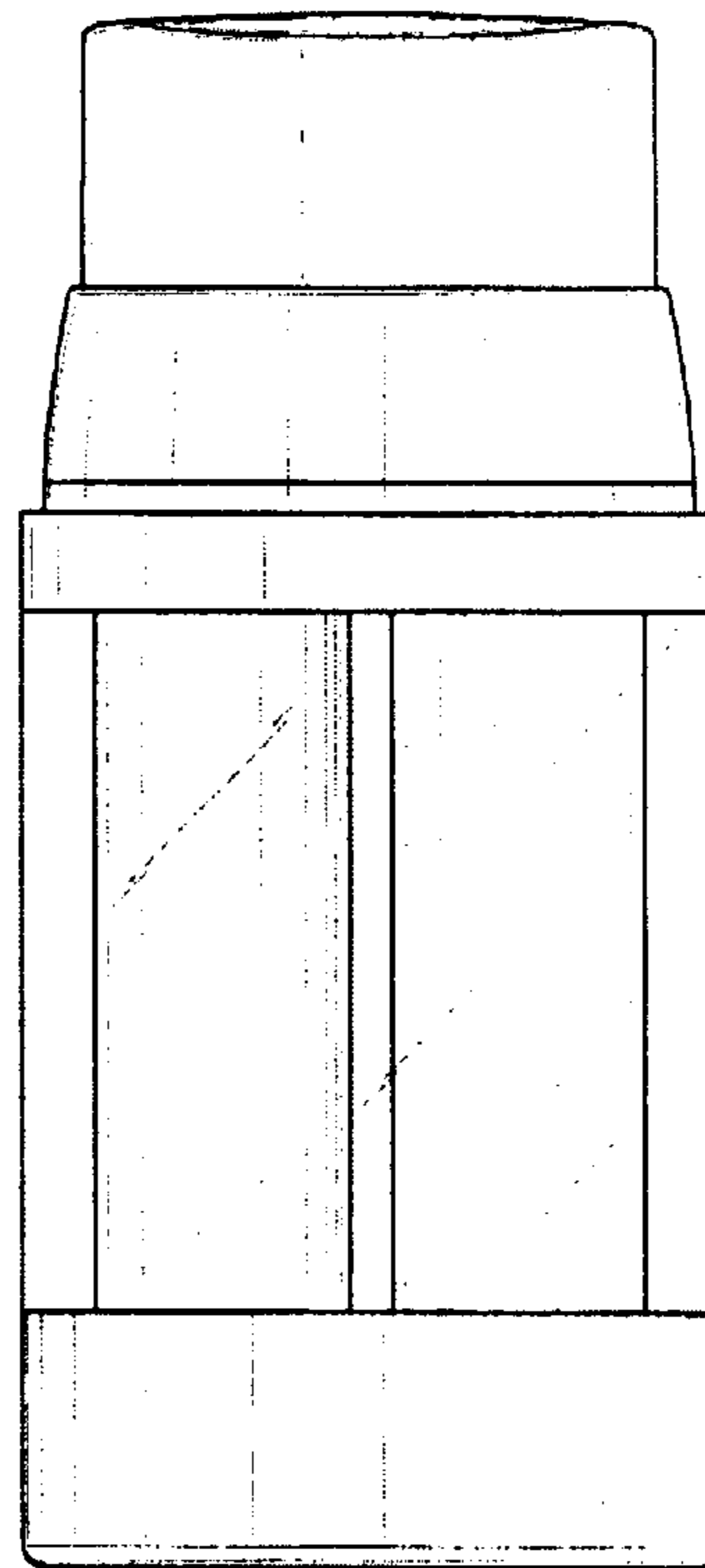

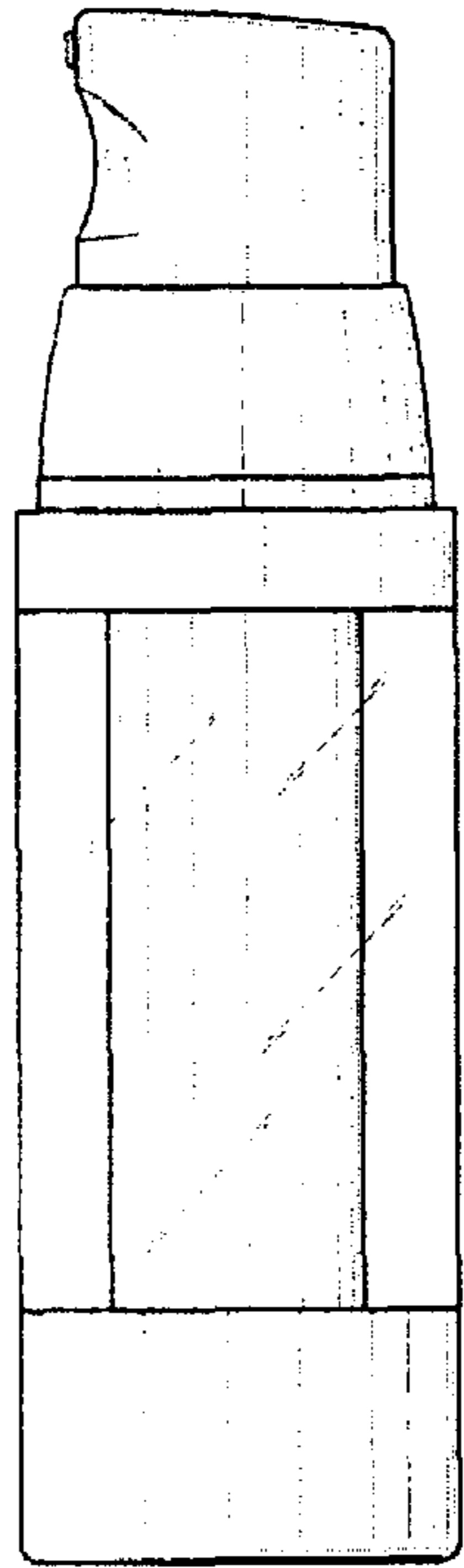

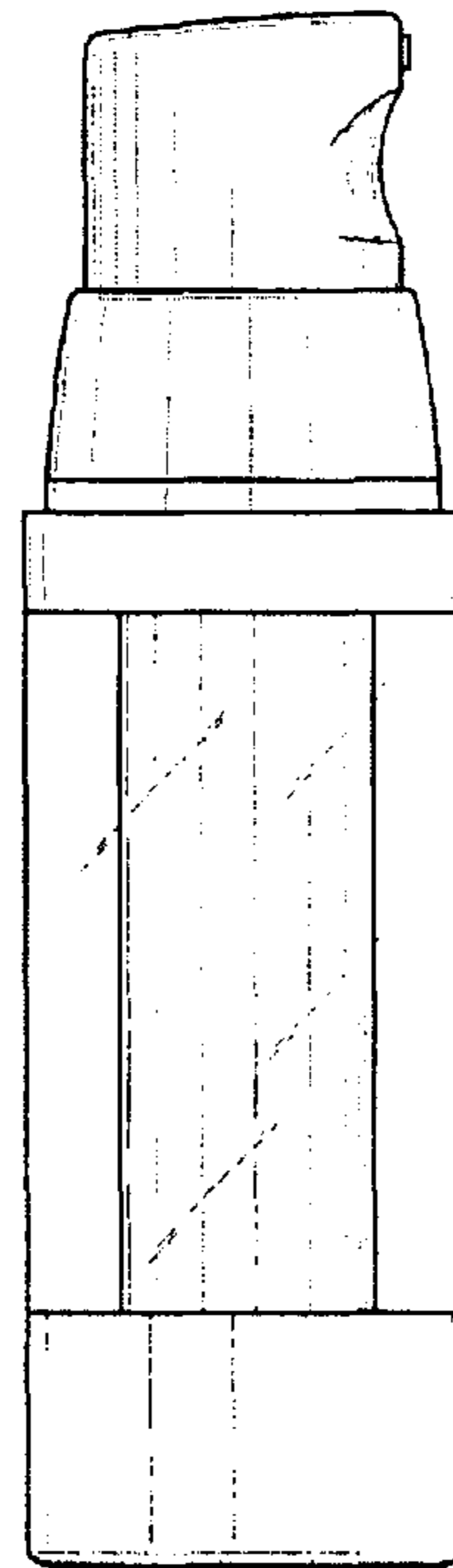

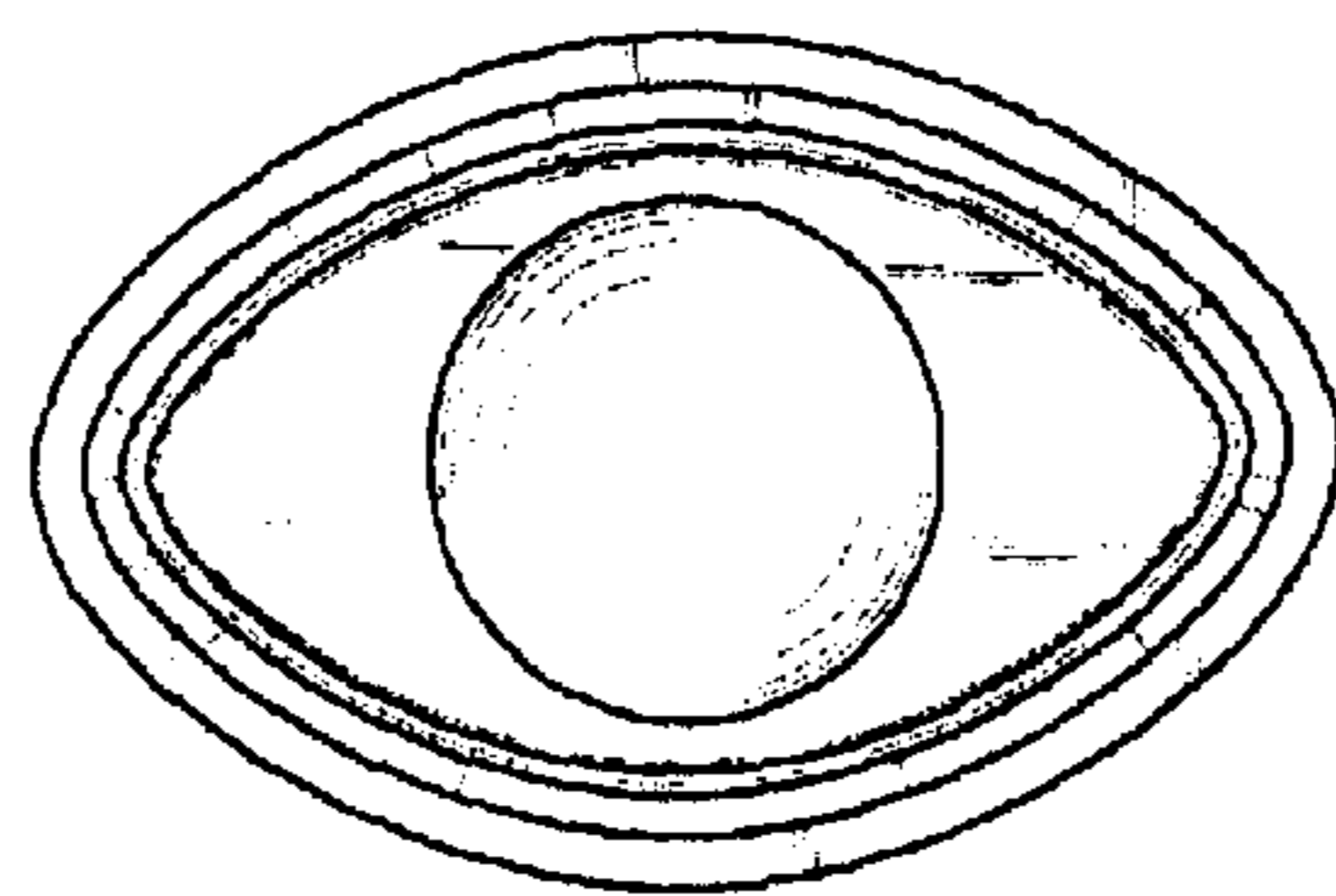

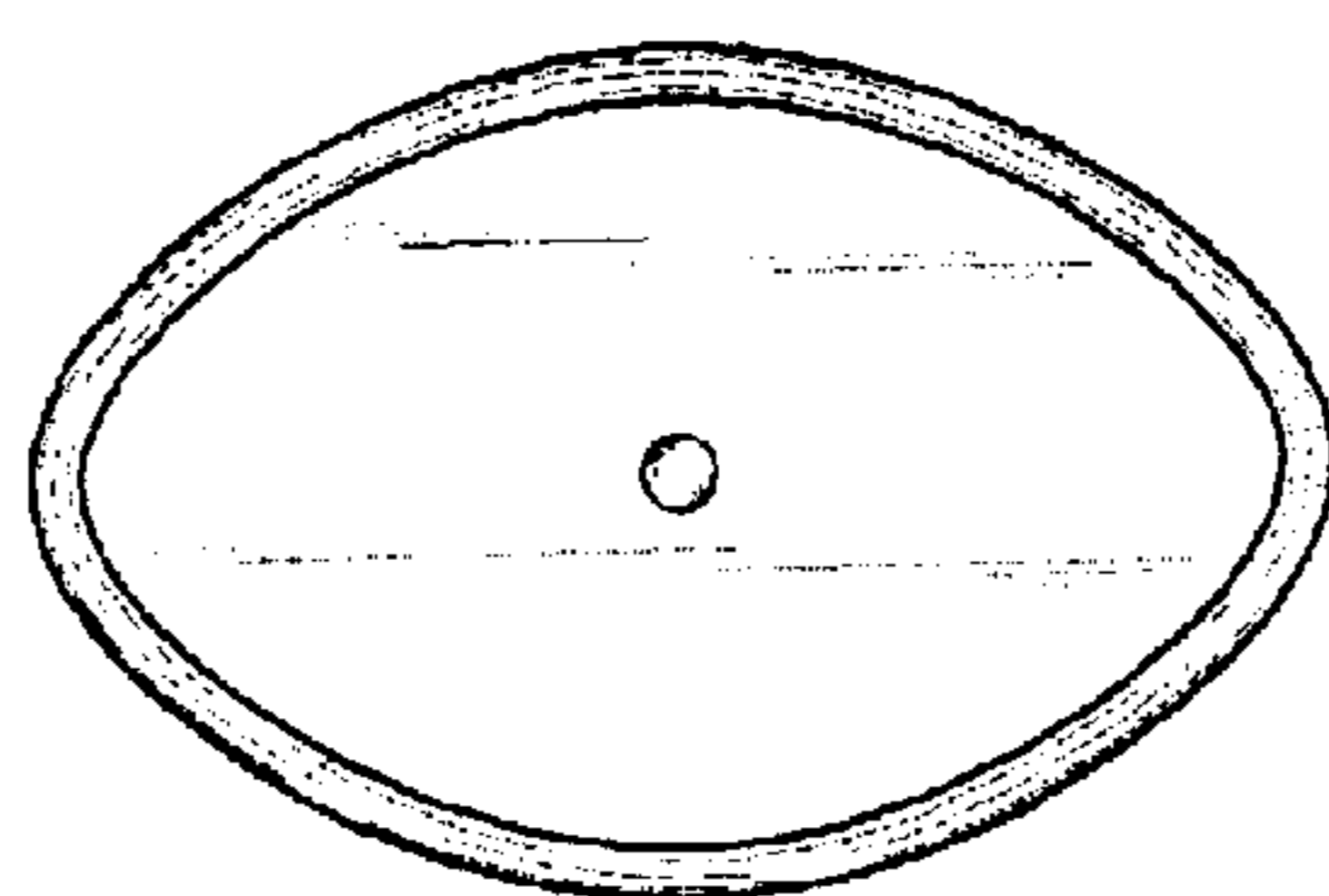

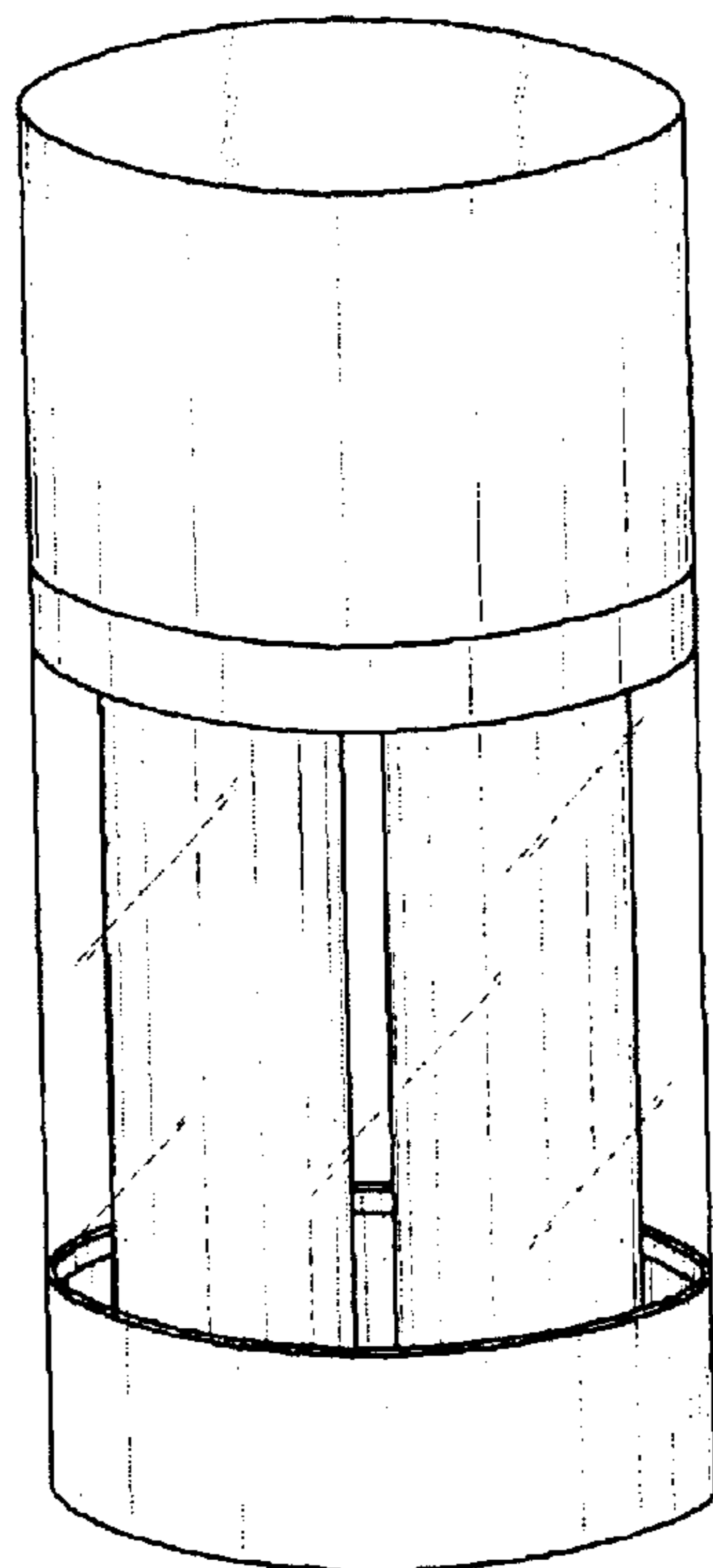
