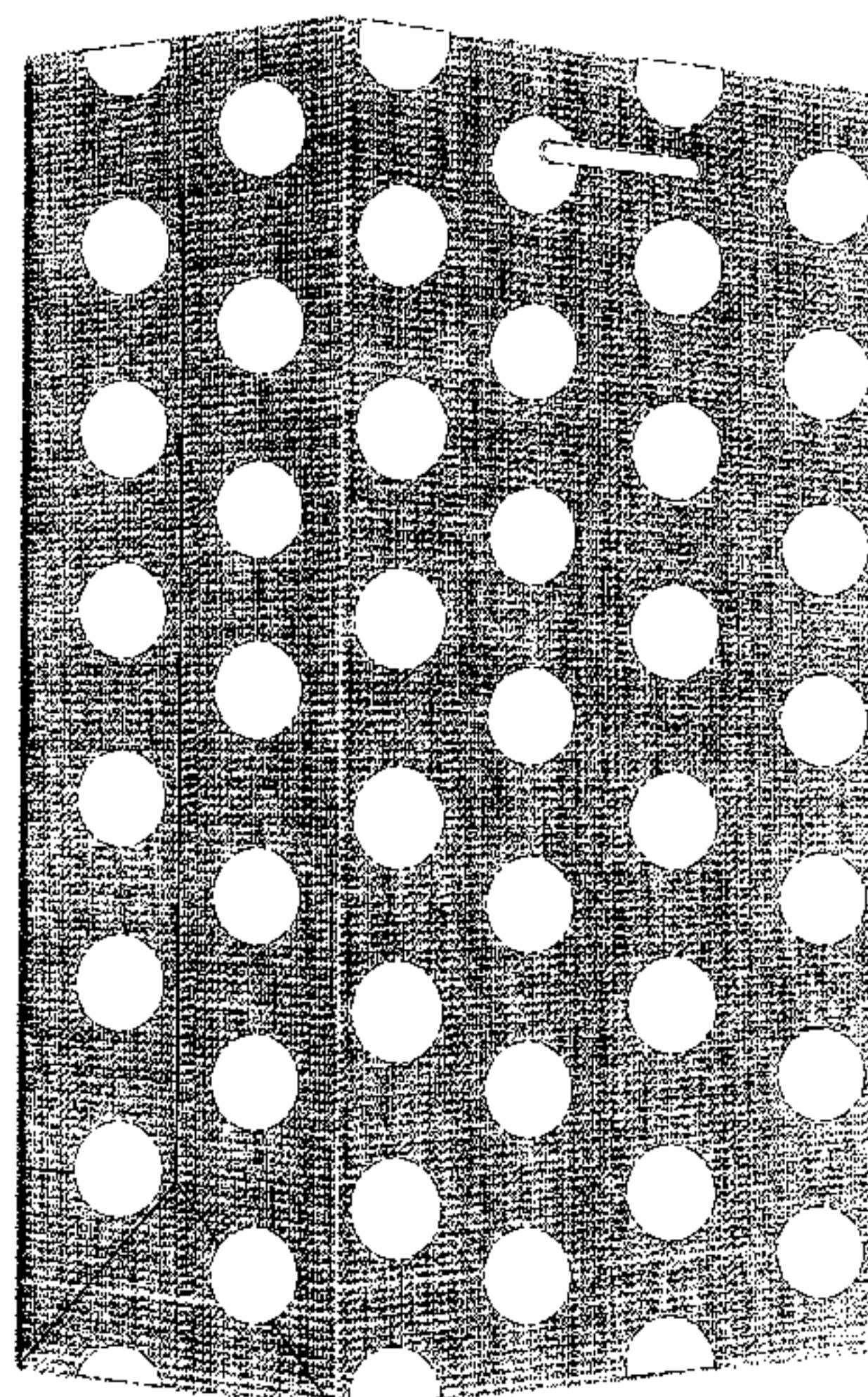

The ornamental design for a gift bag, as shown and described.

DESCRIPTION

FIG. 1 is a left front perspective view of a gift bag showing my new design;
 FIG. 2 is a front elevational view of the gift bag shown in FIG. 1;
 FIG. 3 is a rear elevational view of the gift bag shown in FIG. 1;
 FIG. 4 is a right side elevational view of the gift bag shown in FIG. 1;
 FIG. 5 is a left side elevational view of the gift bag shown in FIG. 1;
 FIG. 6 is a top plan view of the gift bag shown in FIG. 1; and,
 FIG. 7 is a bottom plan view of the gift bag shown in FIG. 1.
 The broken line showing of the flexible handles, eyelets, and the circular features is included for the purpose of illustrating environment and forms no part of the claimed design.

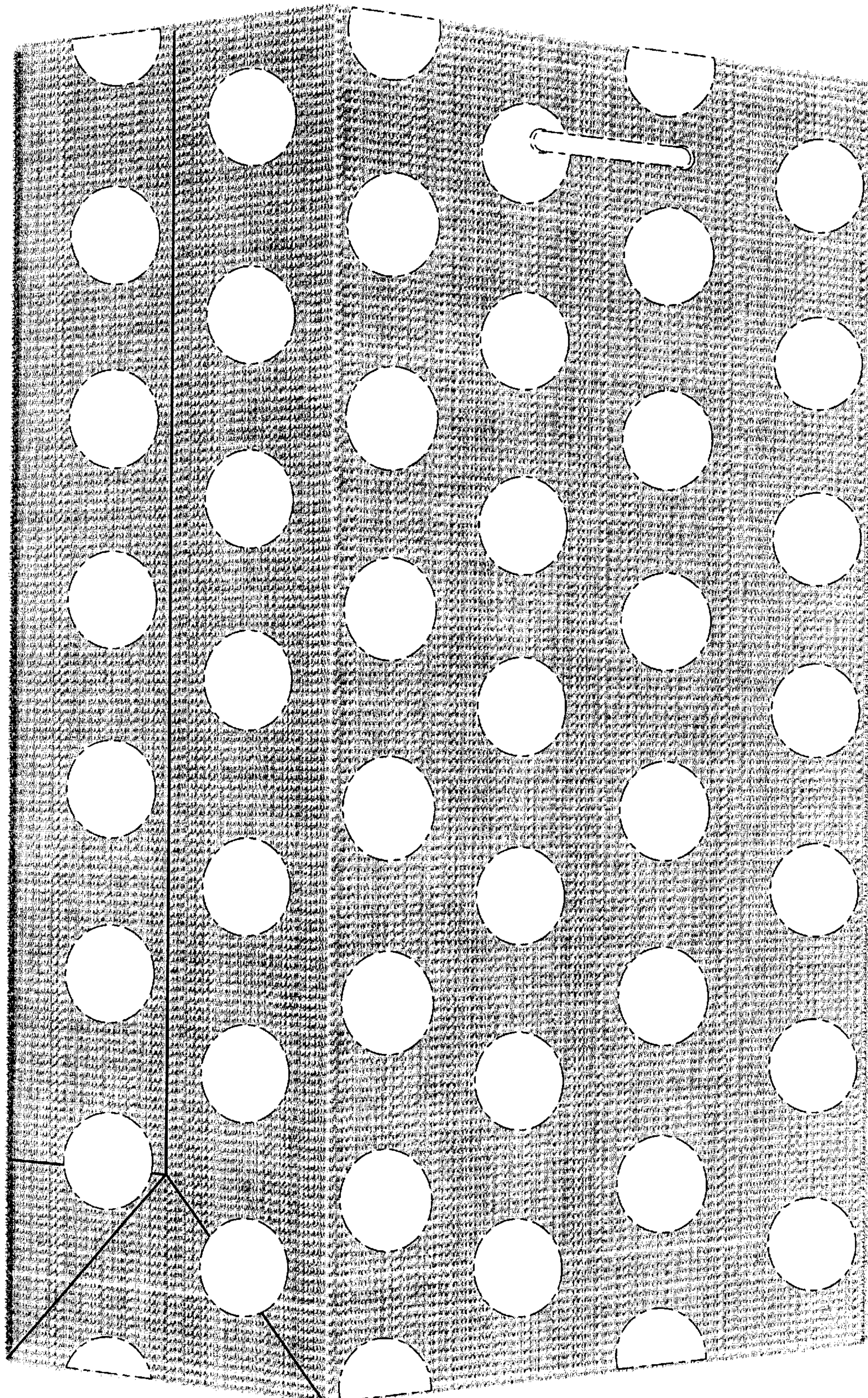

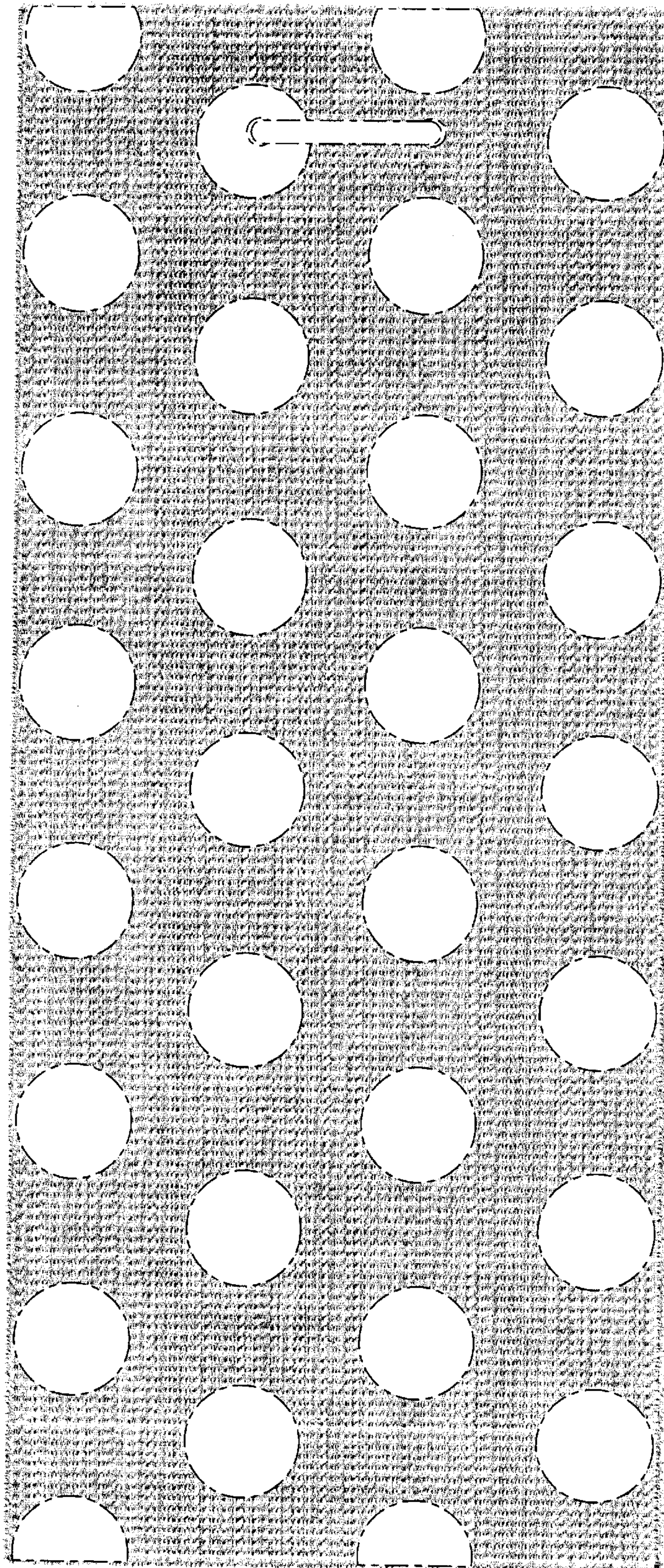

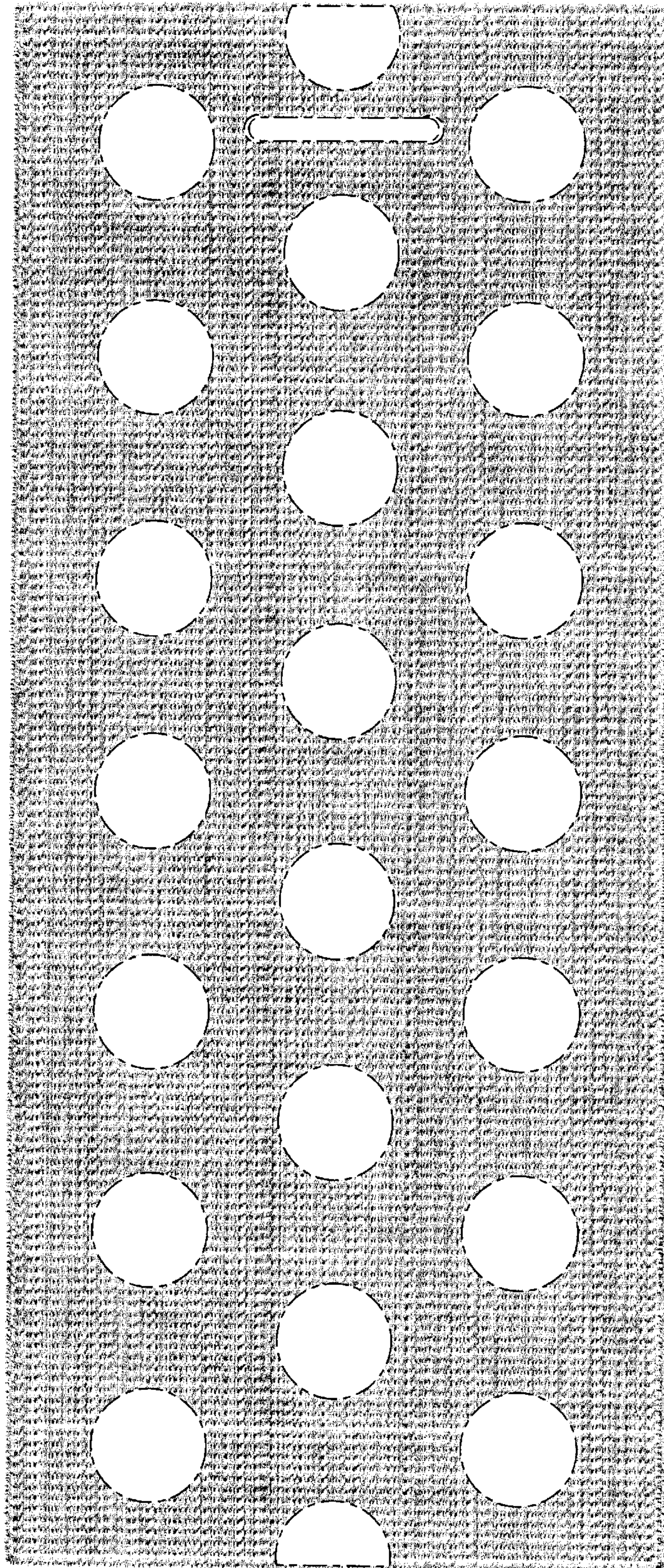

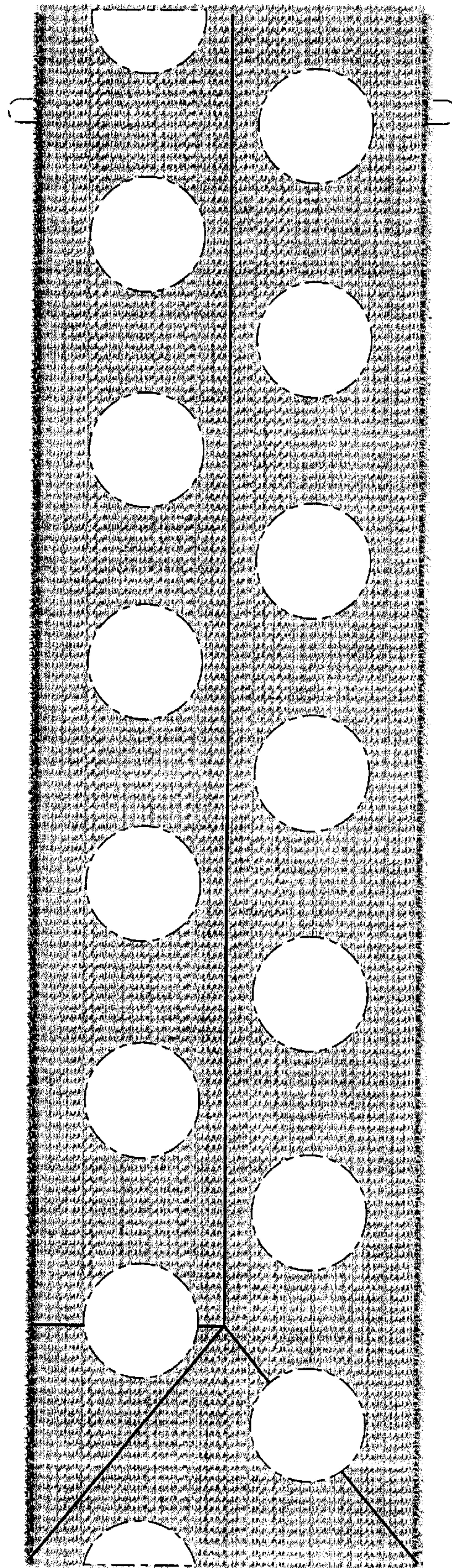

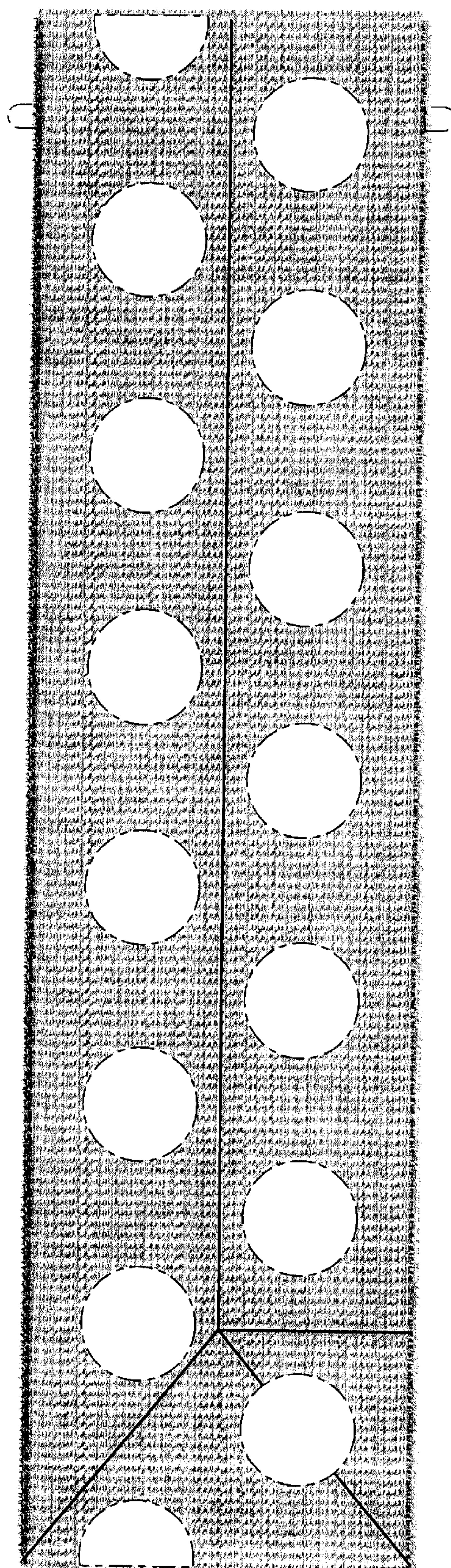

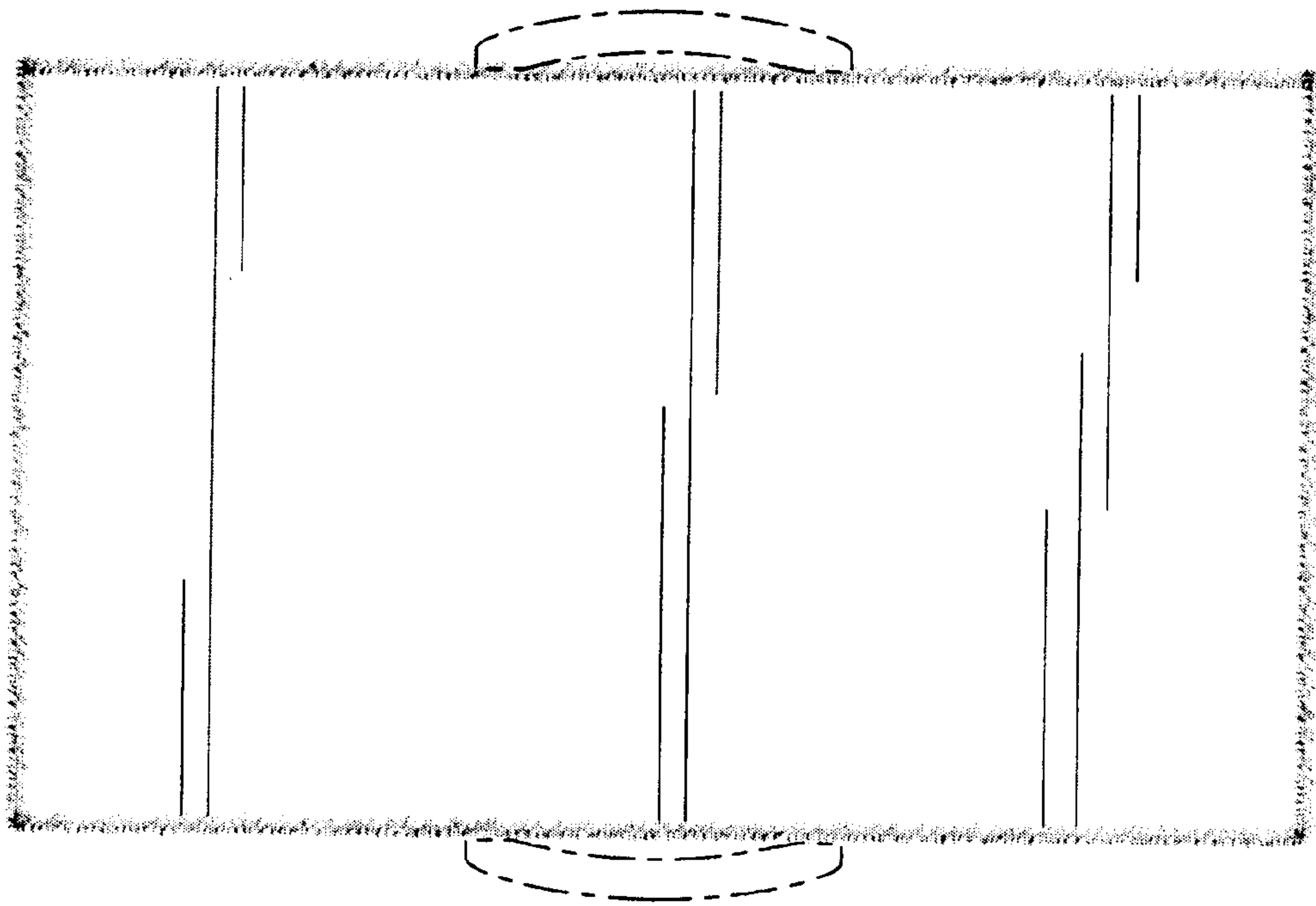

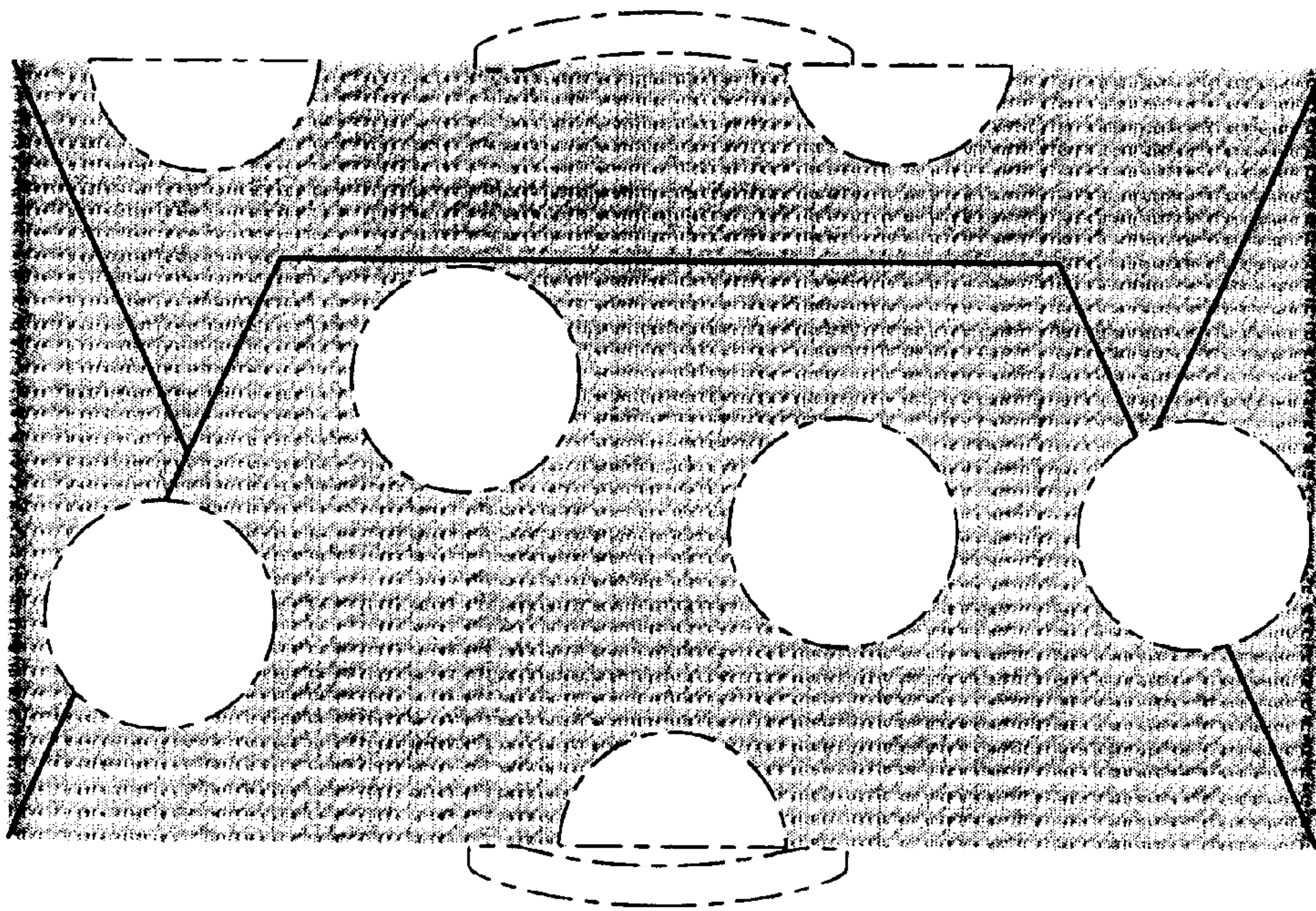
