DESCRIPTION

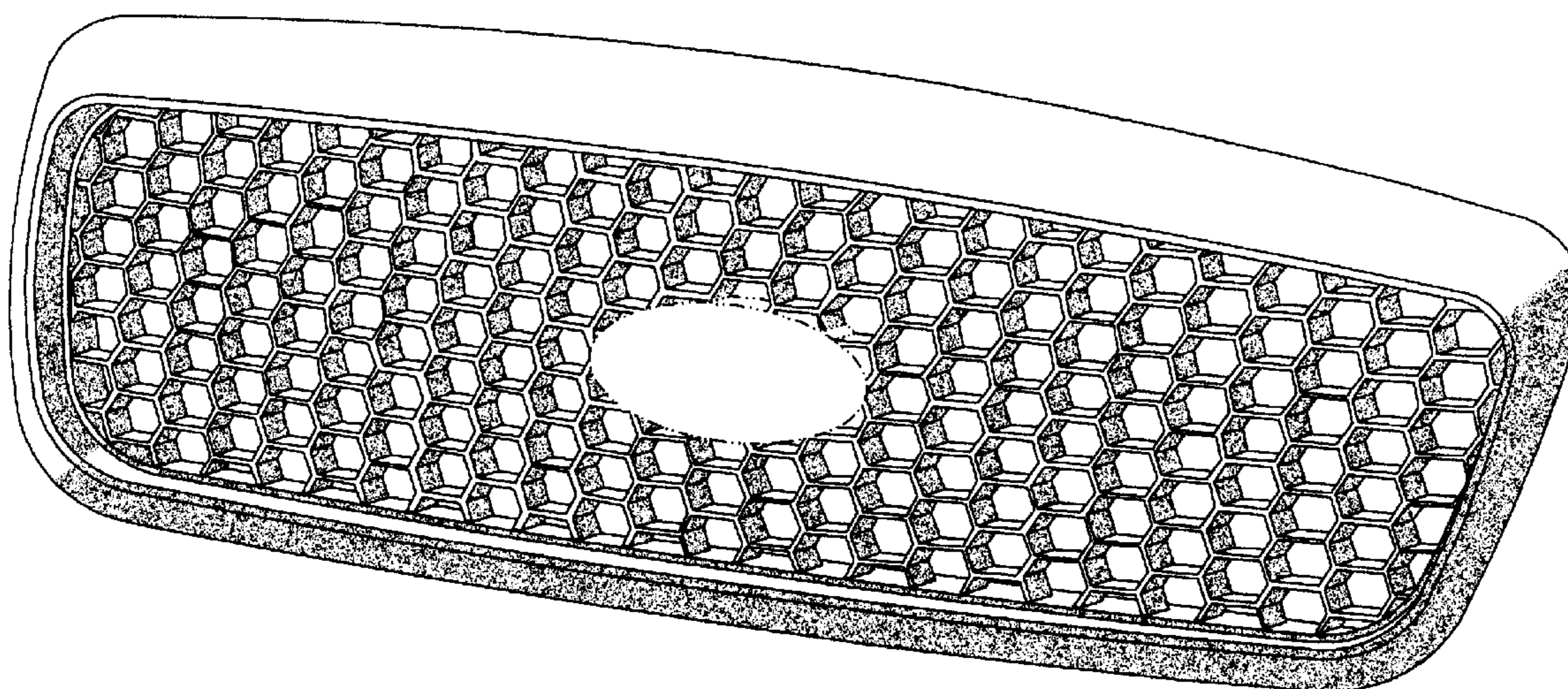
FIG. 1 is a front perspective view of the automobile grille; FIG. 2 is a front view of the automobile grille.

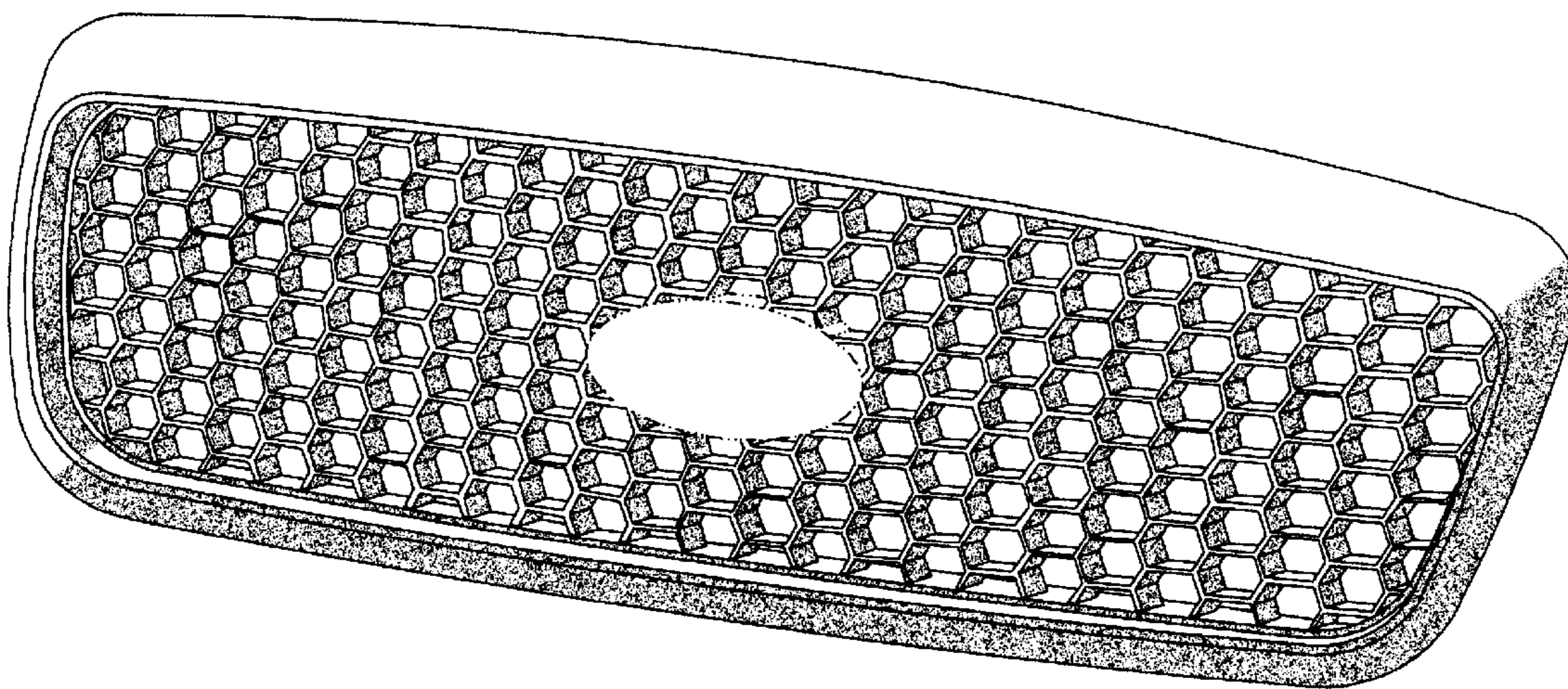

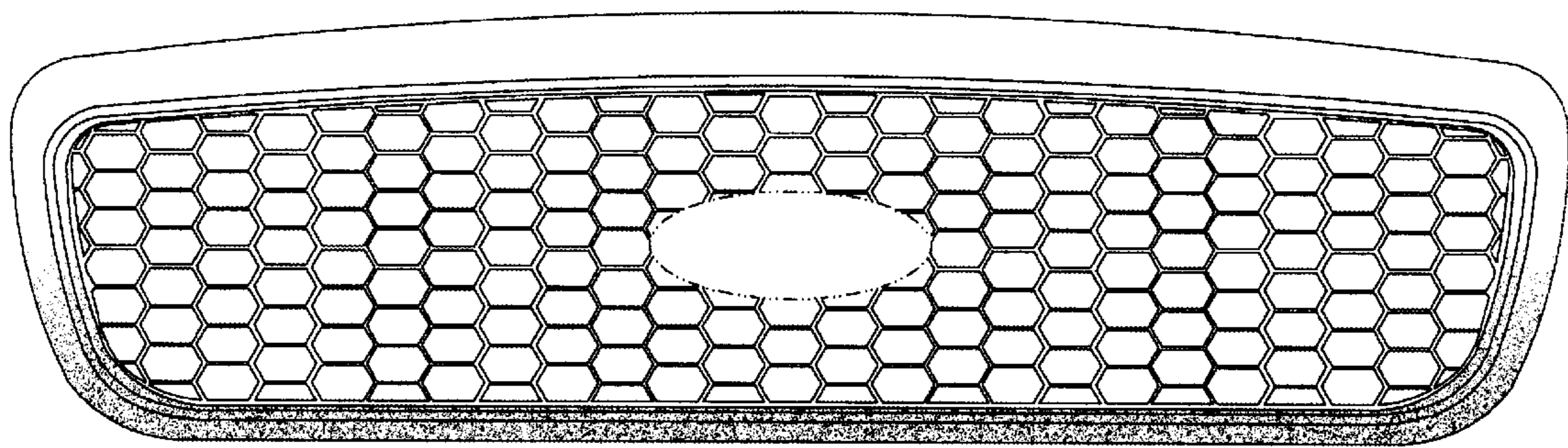

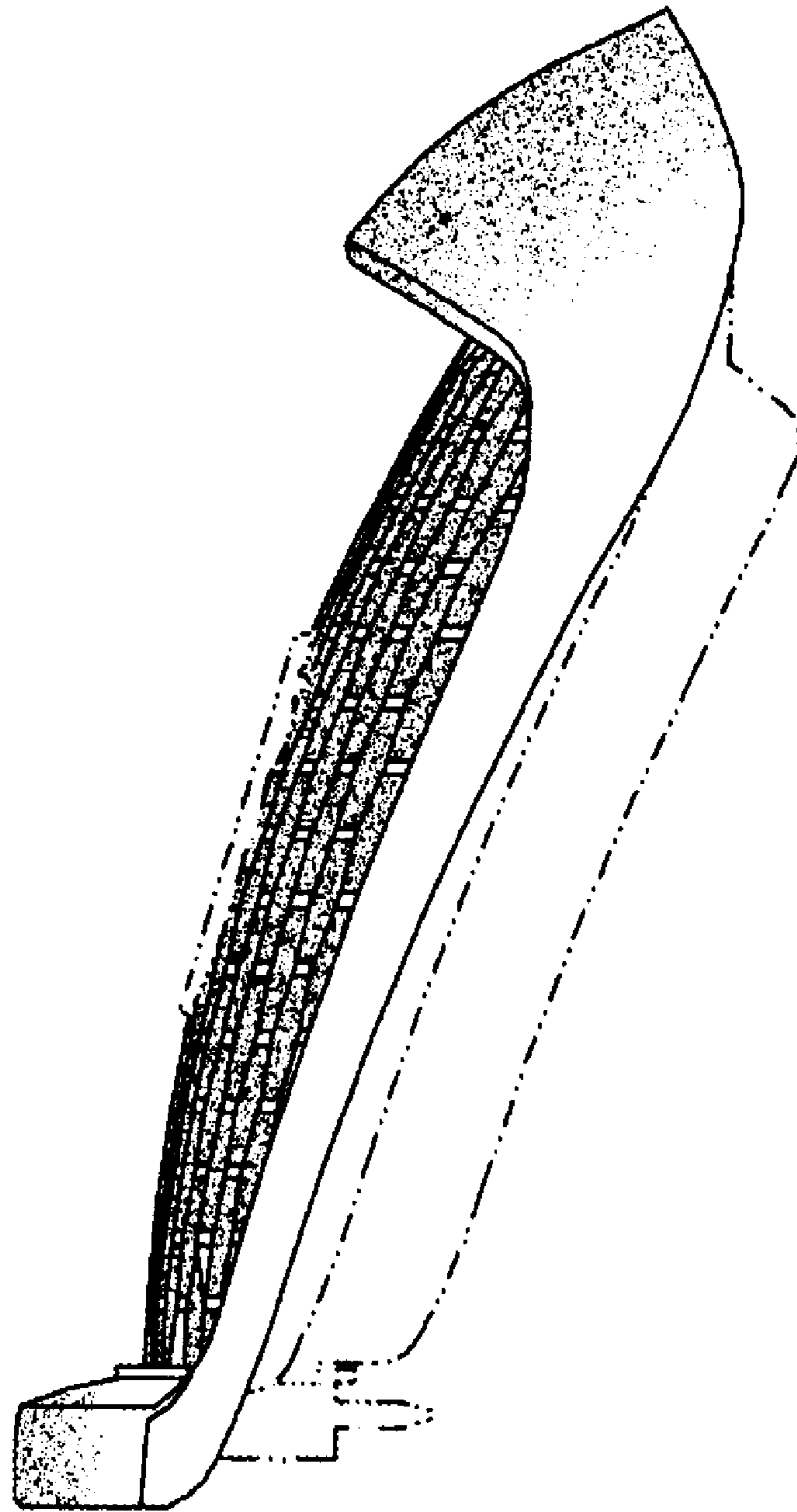

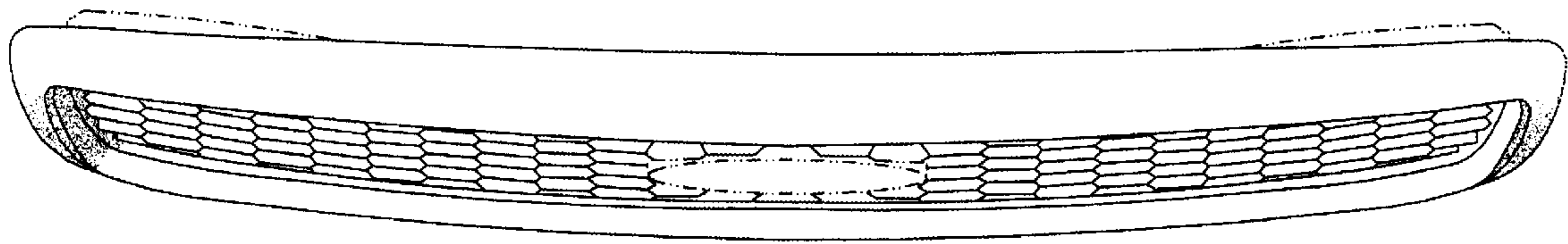
