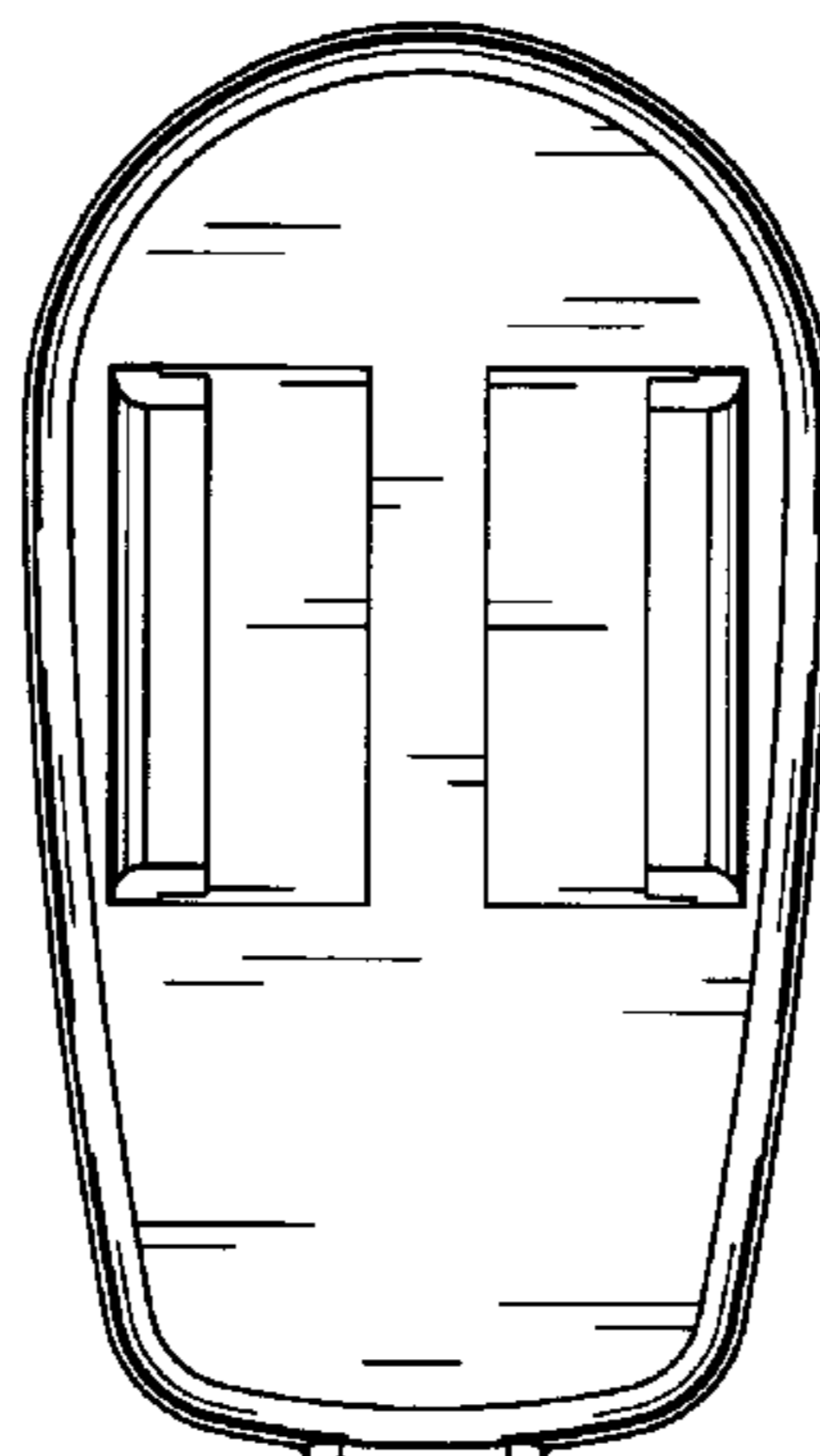
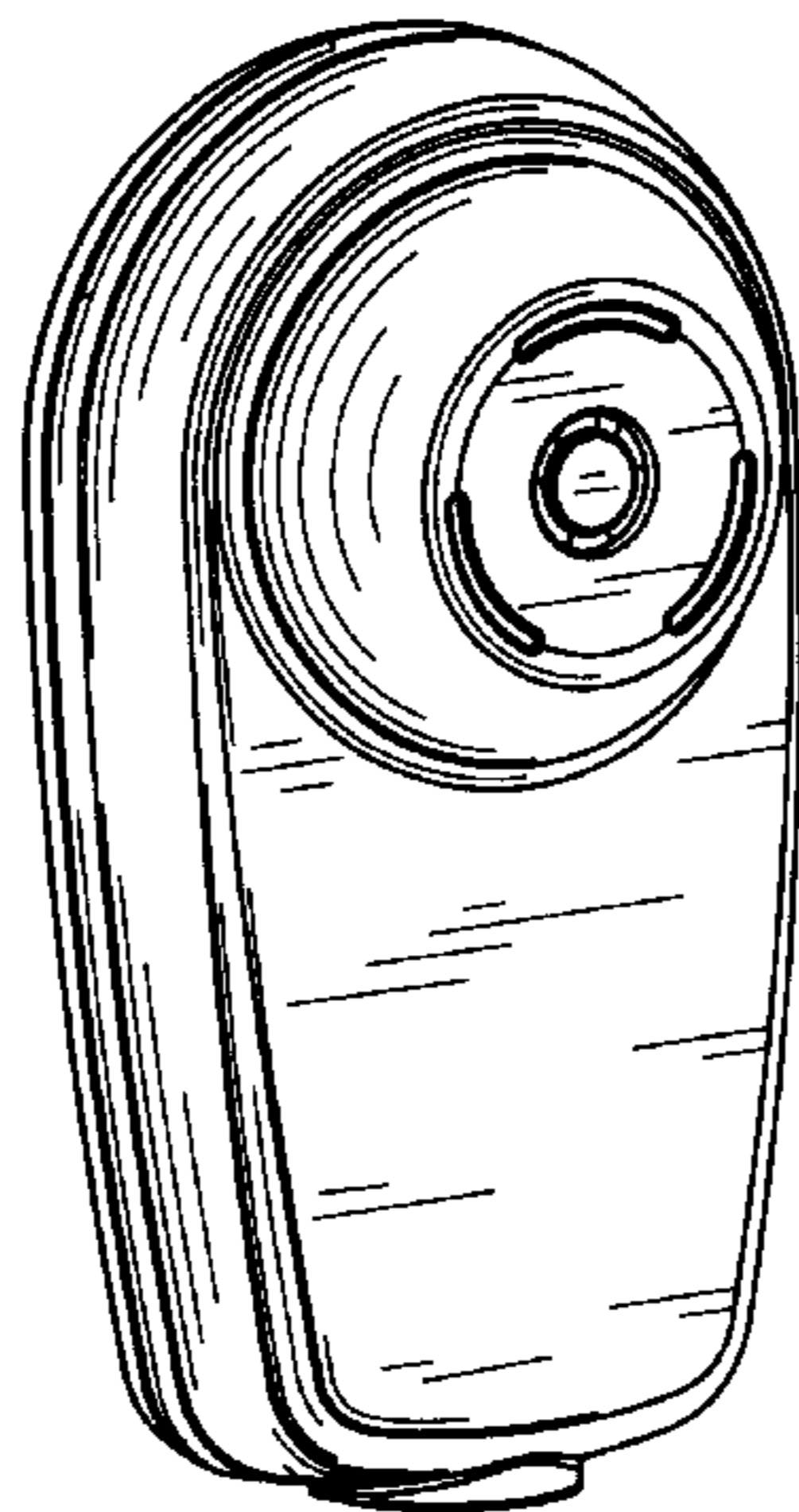

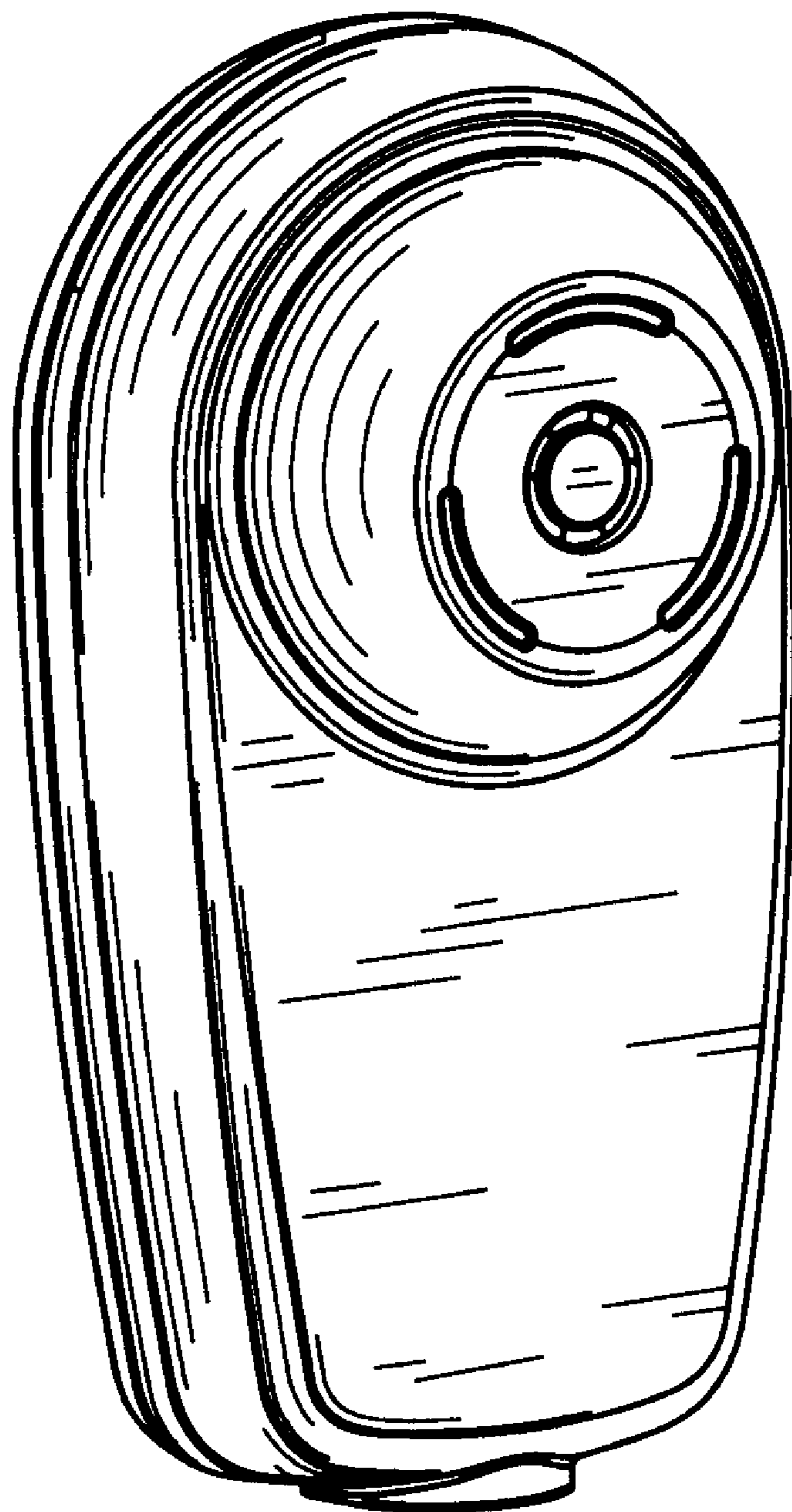
The ornamental design of the microphone, as shown.

**DESCRIPTION**

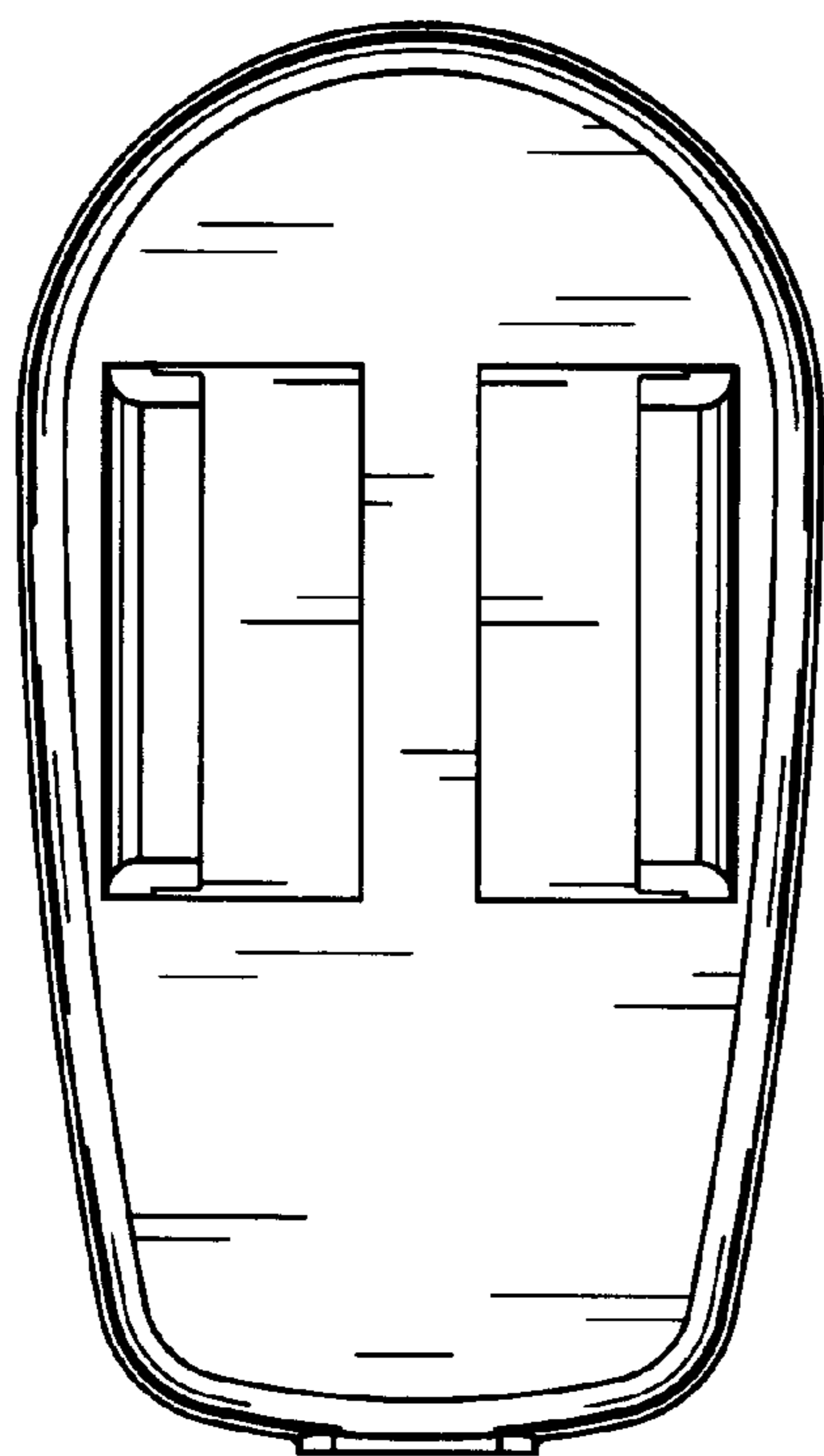
FIG. 1 is a perspective view of the microphone;

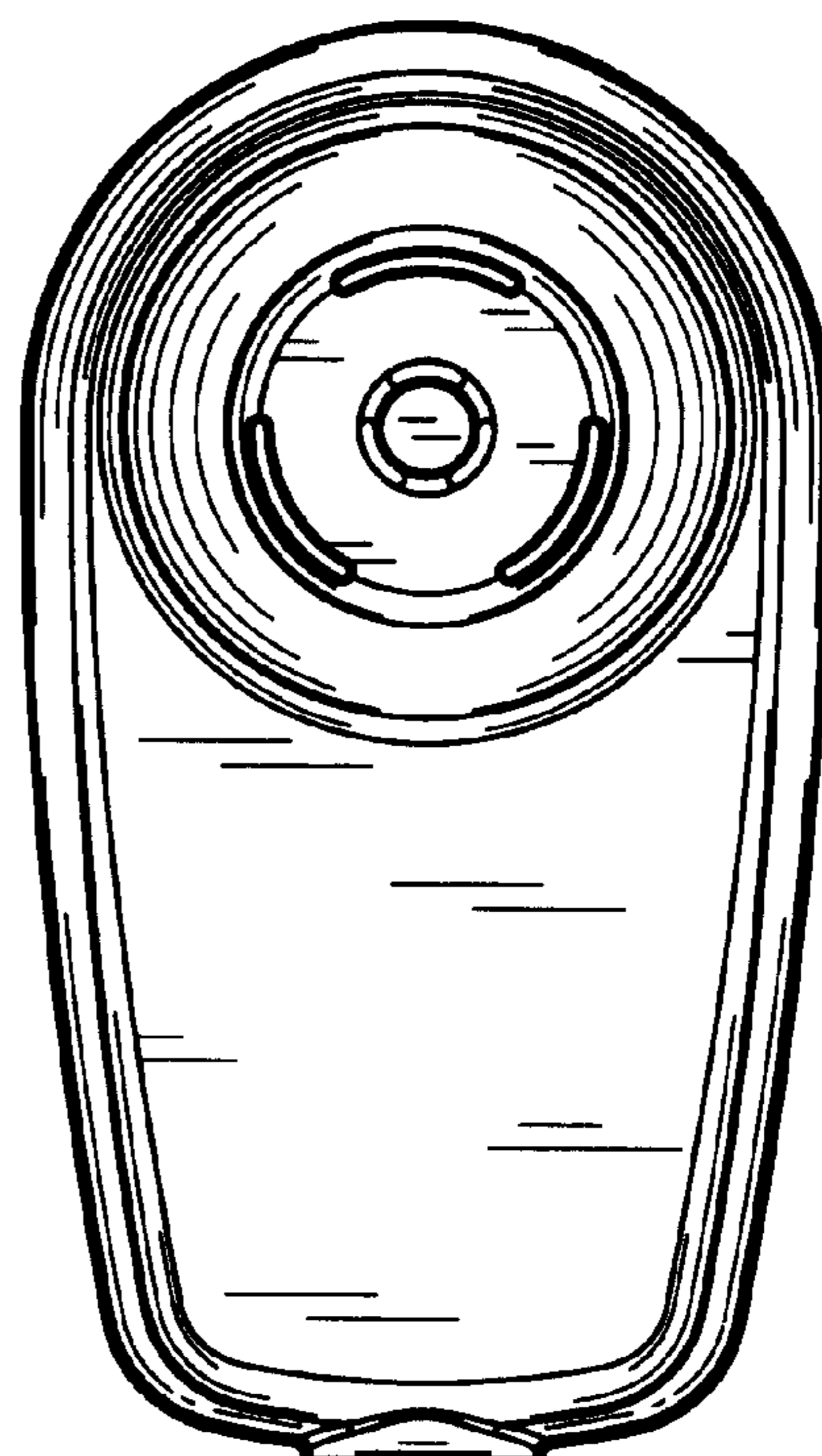




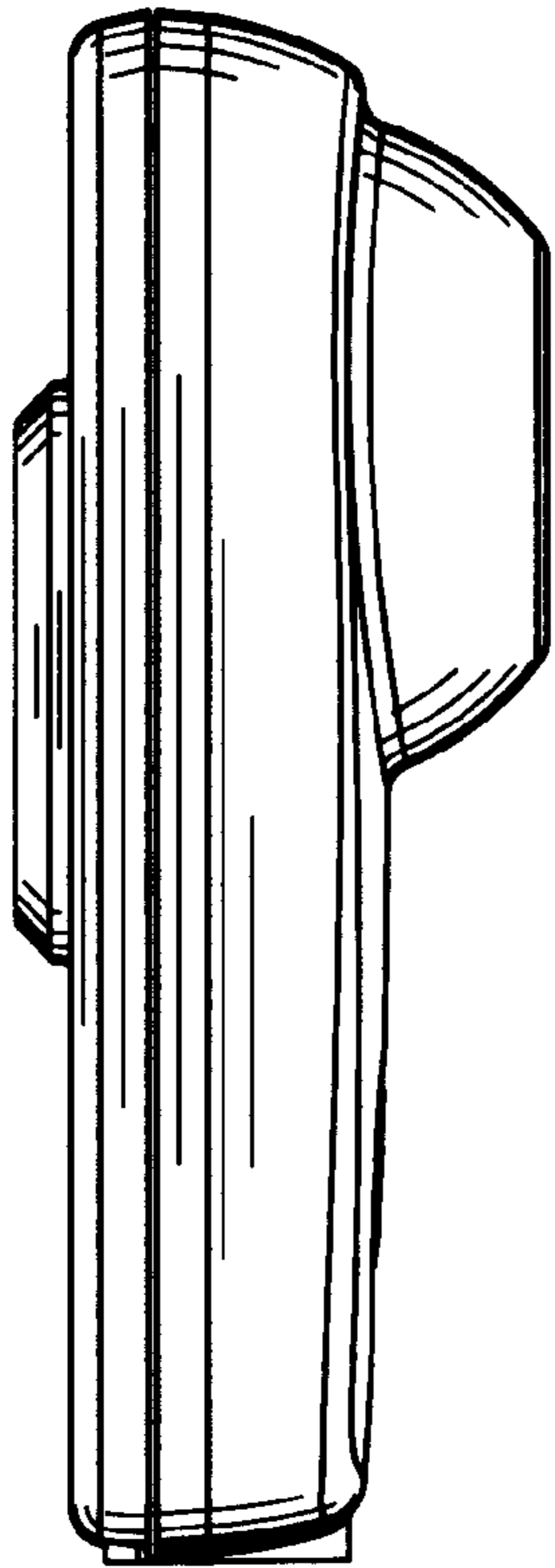

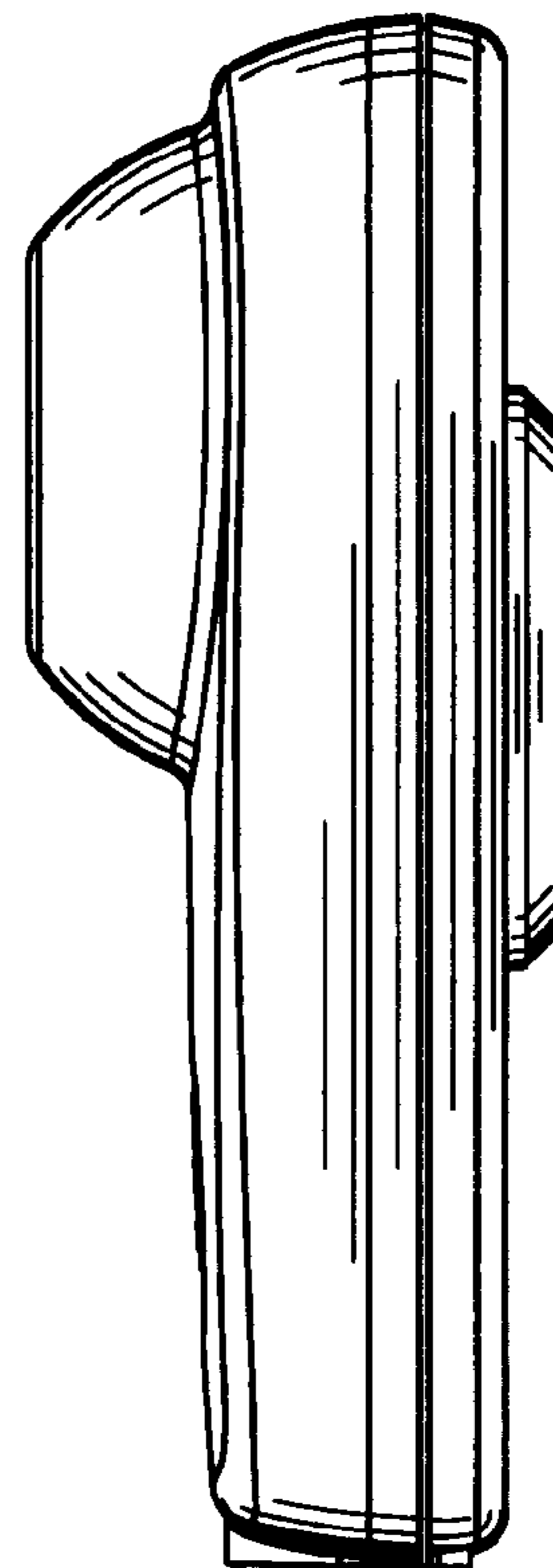

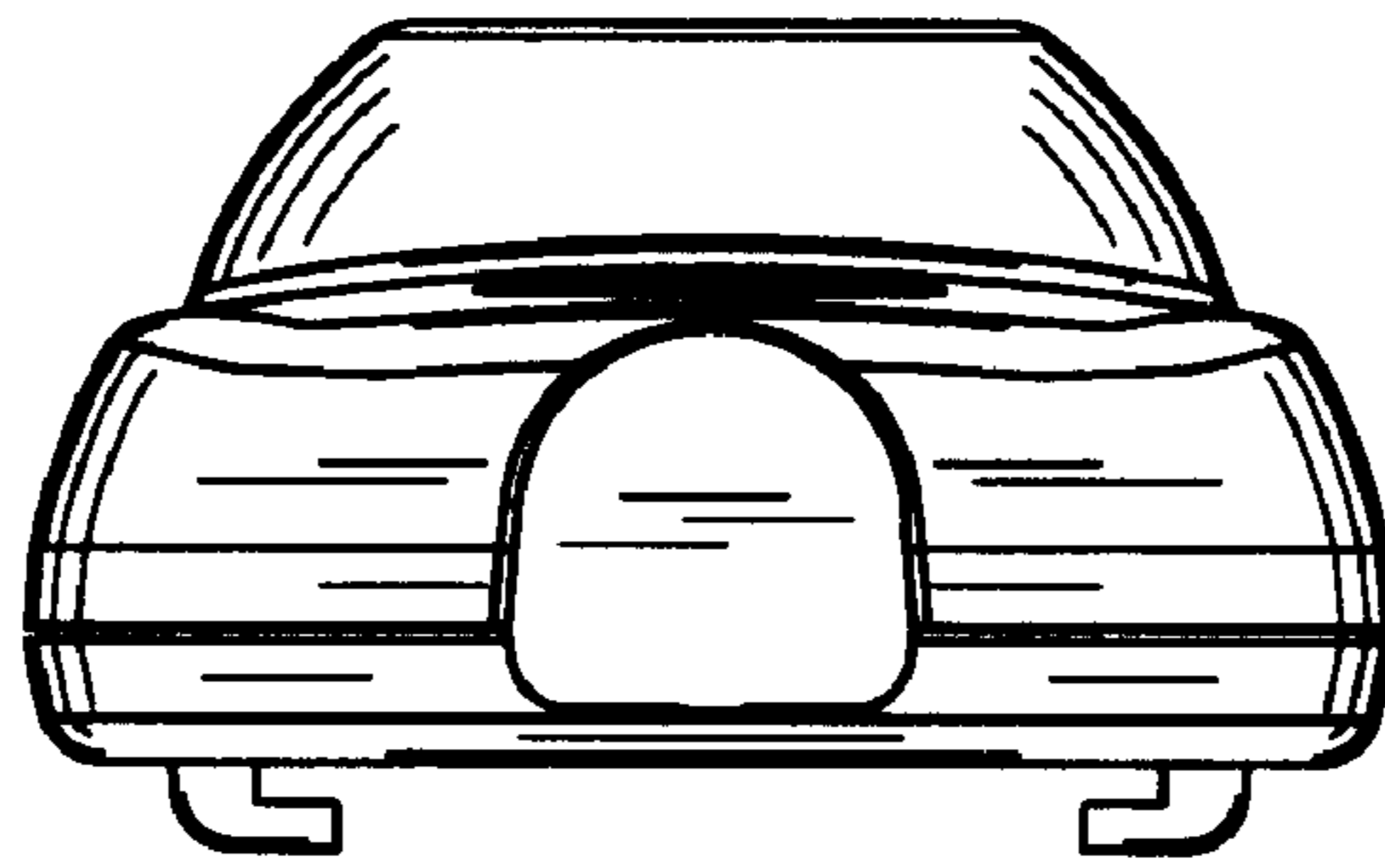

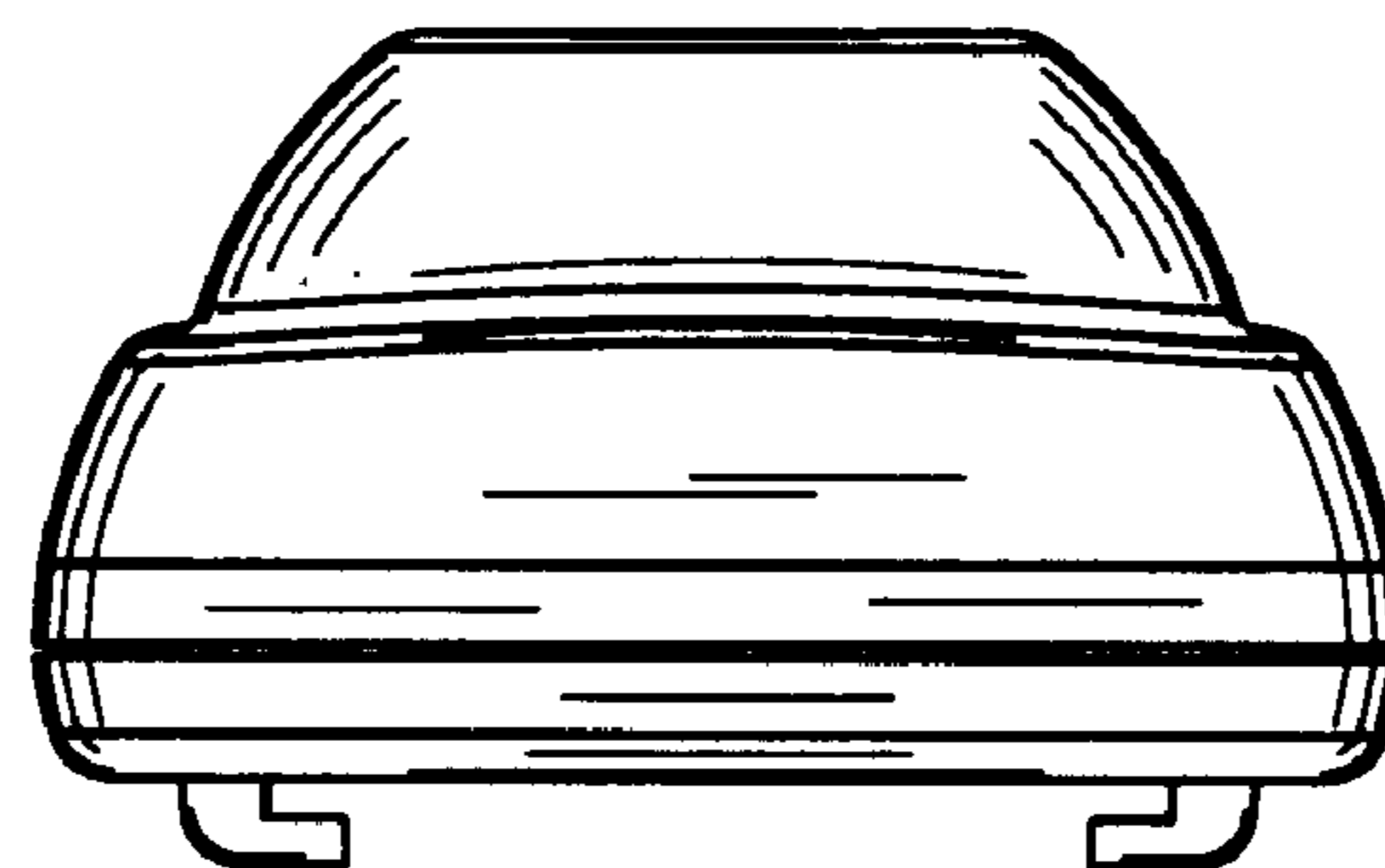
