(57) **CLAIM**

The ornamental design for a shock-absorbing coated solid and quiet paddle, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the shock-absorbing coated solid and quiet paddle, the undisclosed rear being identical;

FIG. 2 is a side elevational view of the shock-absorbing coated solid and quiet paddle thereof, the undisclosed opposite side being identical;

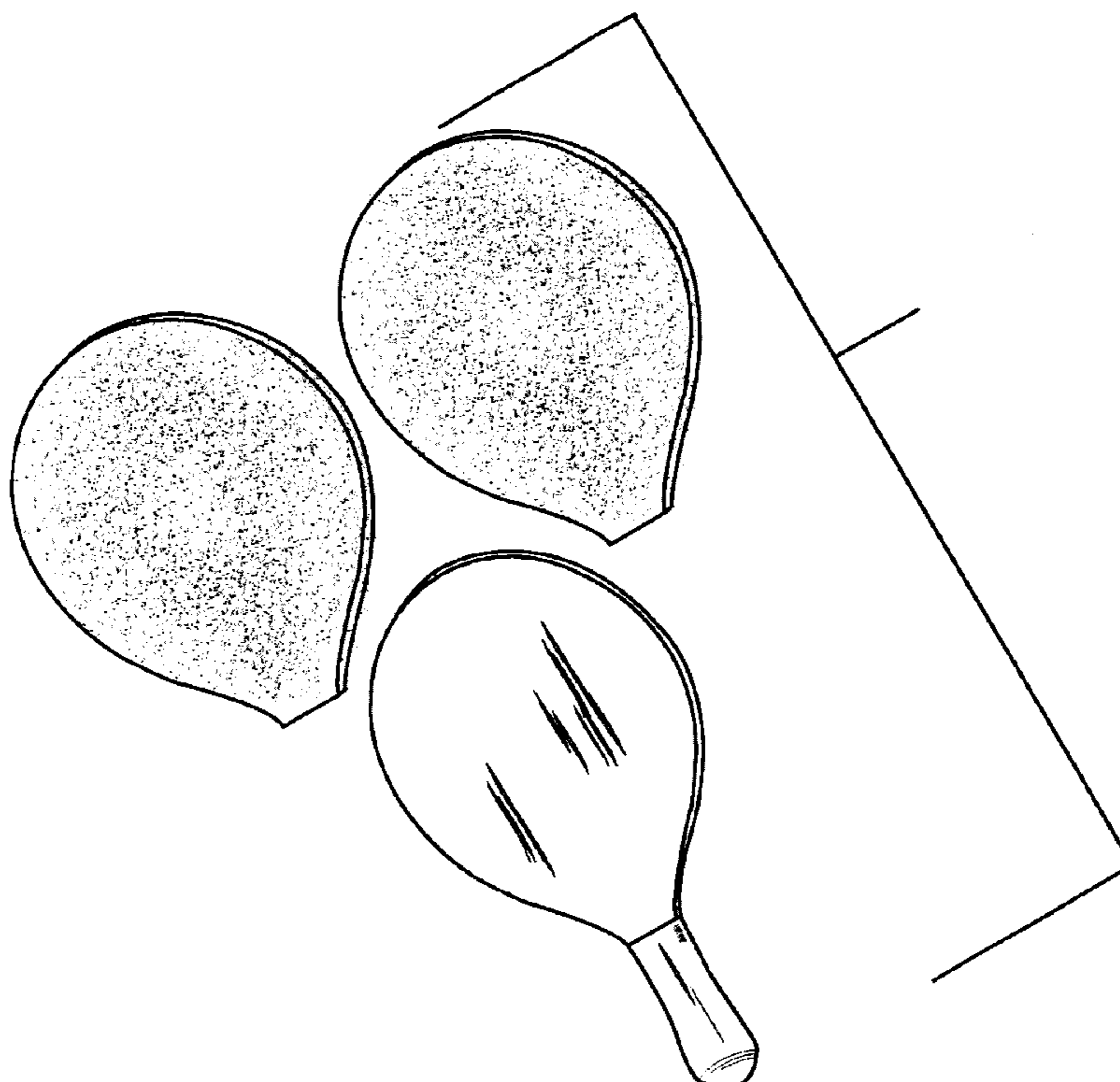
FIG. 3 is a bottom view of the shock-absorbing coated solid and quiet paddle thereof;

FIG. 4 is a top view of the shock-absorbing coated solid and quiet paddle thereof;

FIG. 5 is a reduced perspective view of the shock-absorbing coated solid and quiet paddle thereof, the broken line showing is included for the purpose of illustrating and forms no part of the claimed design; and,

FIG. 6 is an exploded view of the shock-absorbing coated solid and quiet paddle of FIG. 1.

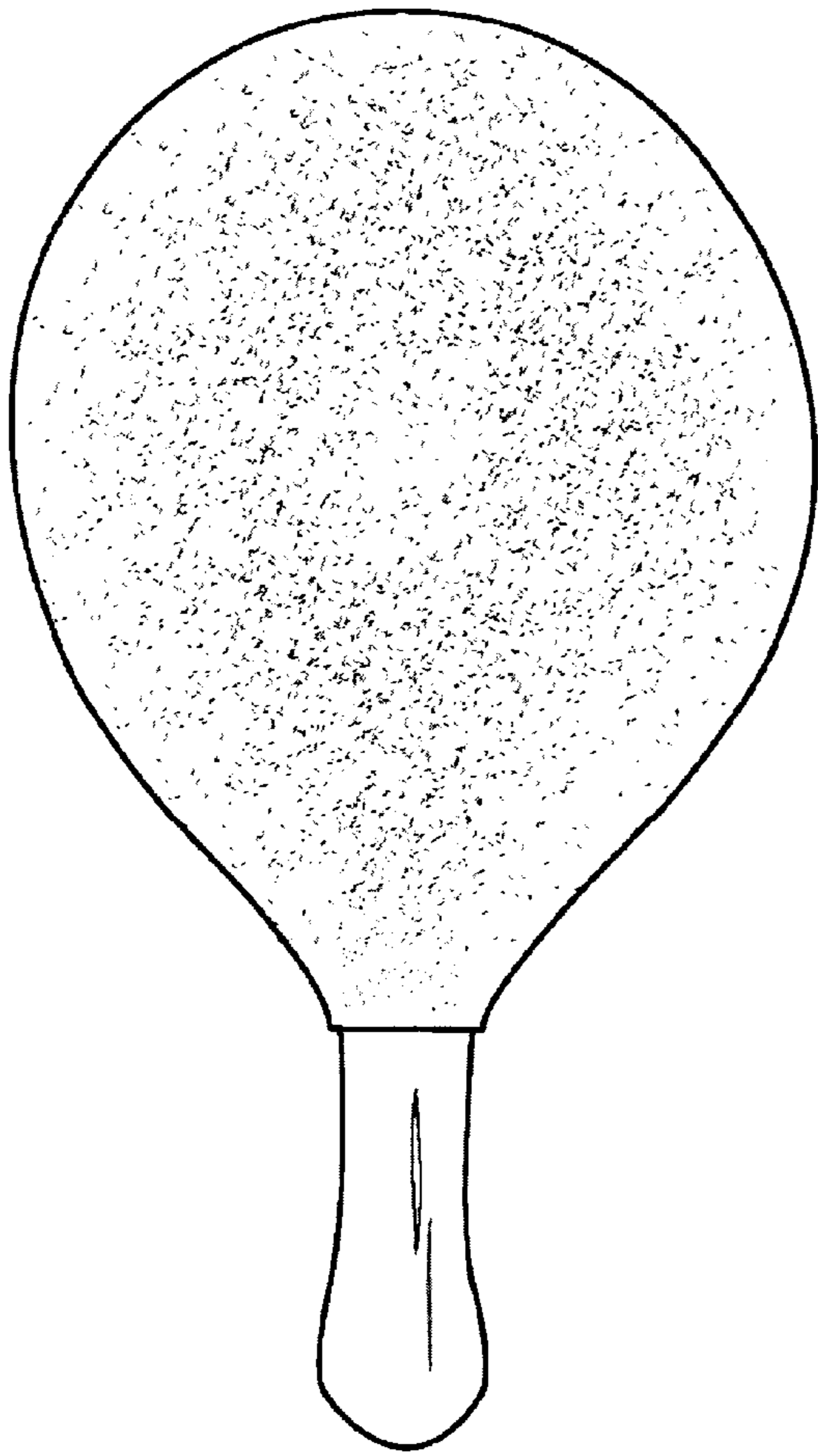

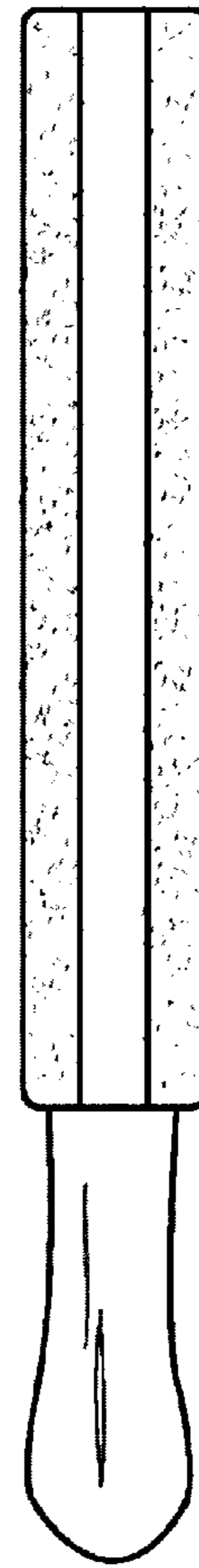

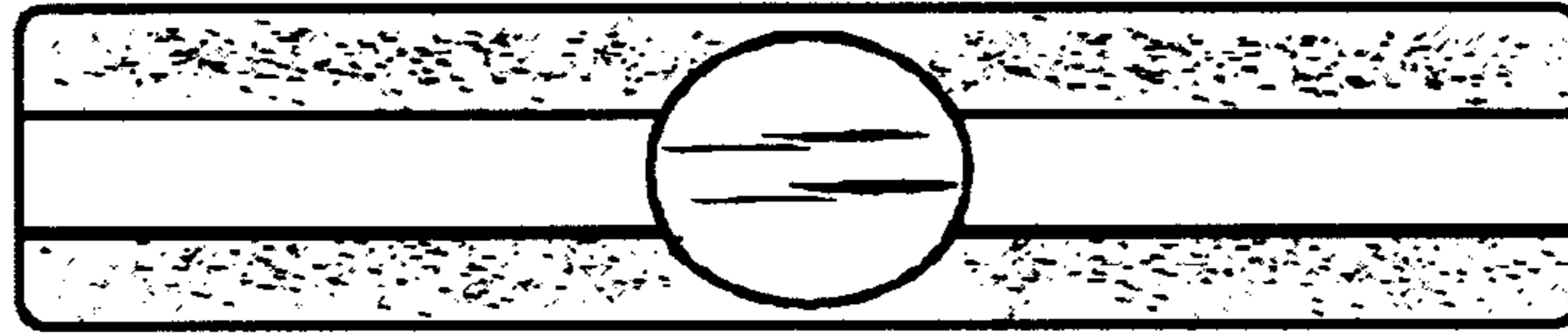

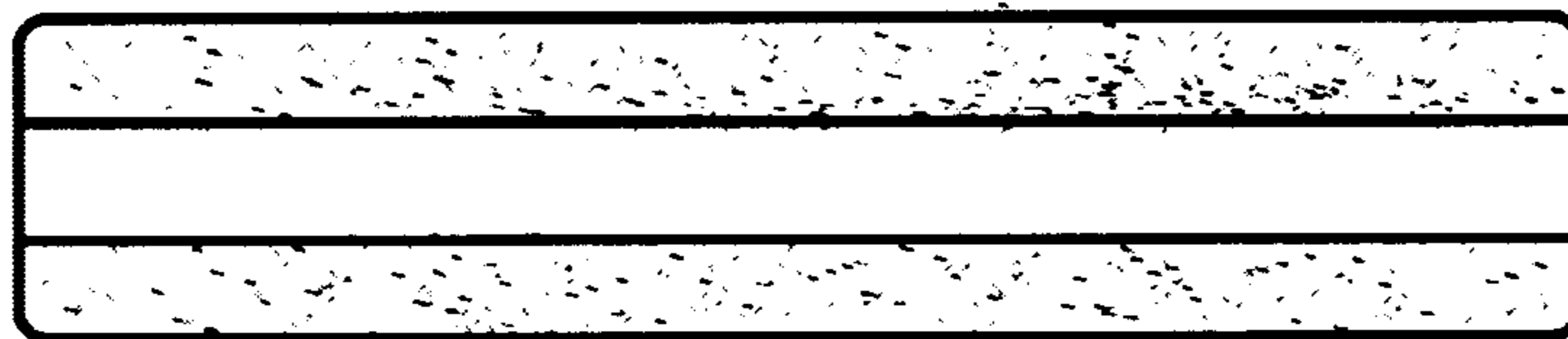

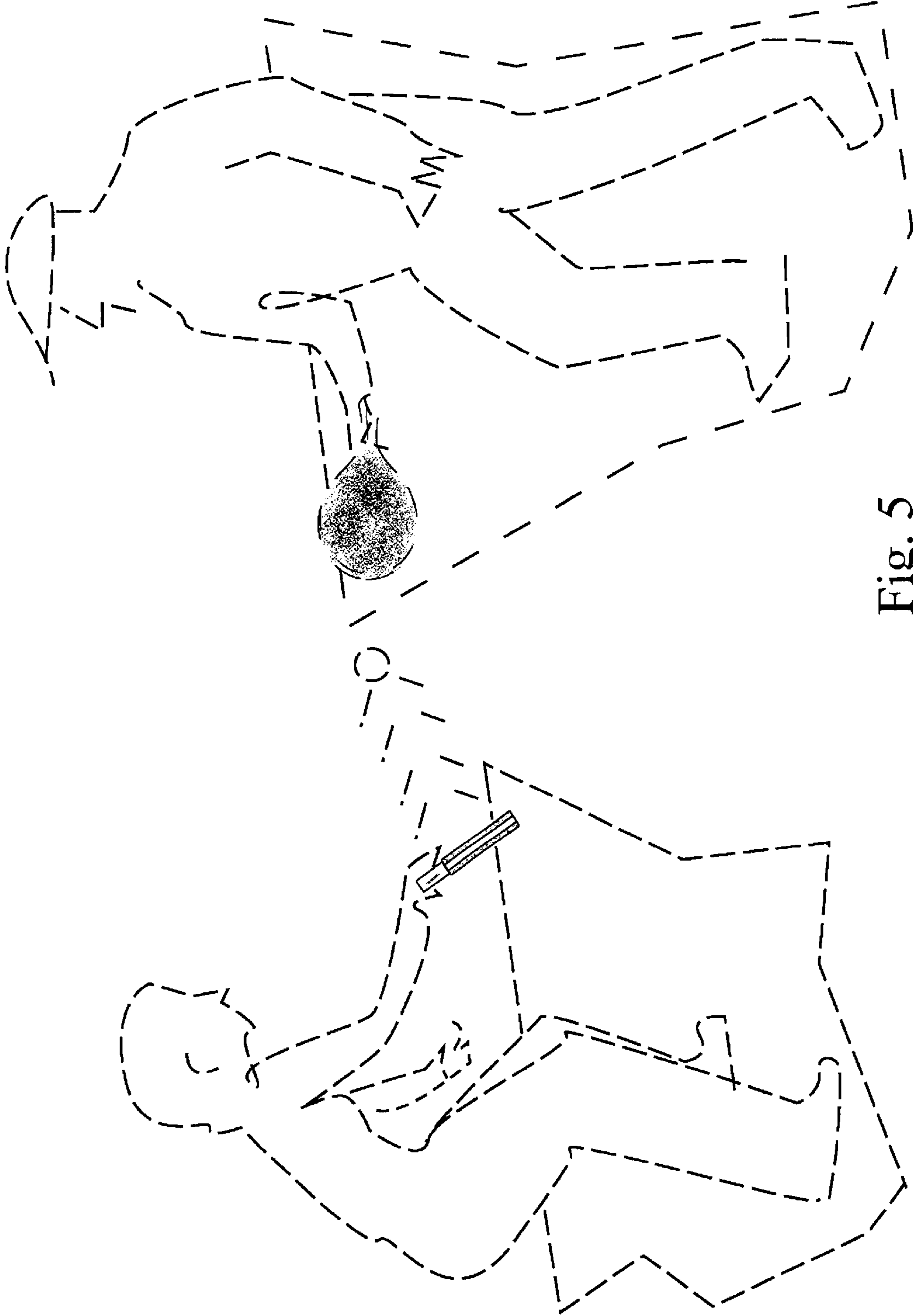

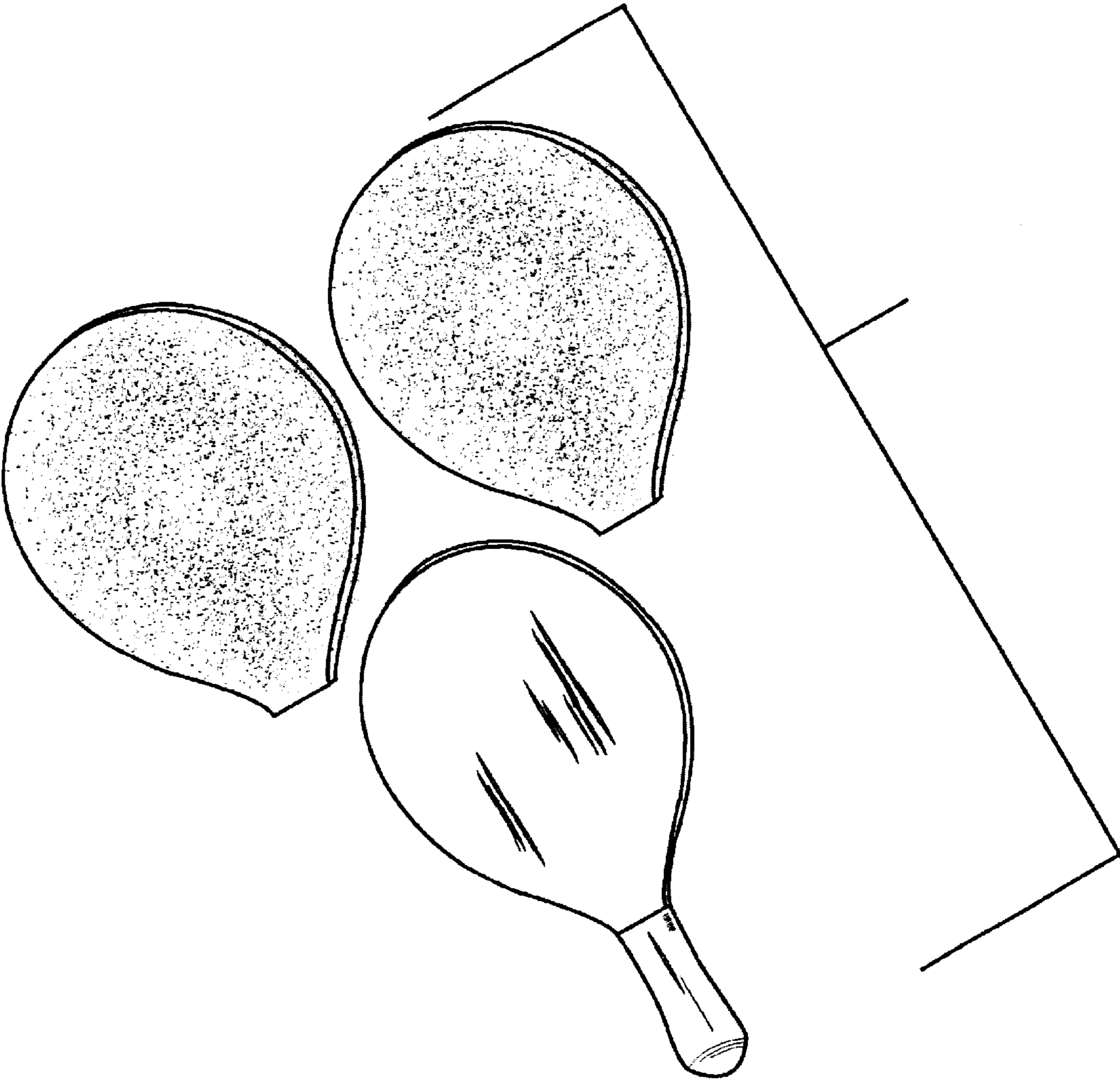
