The ornamental design for an aquatic float, as shown and described.

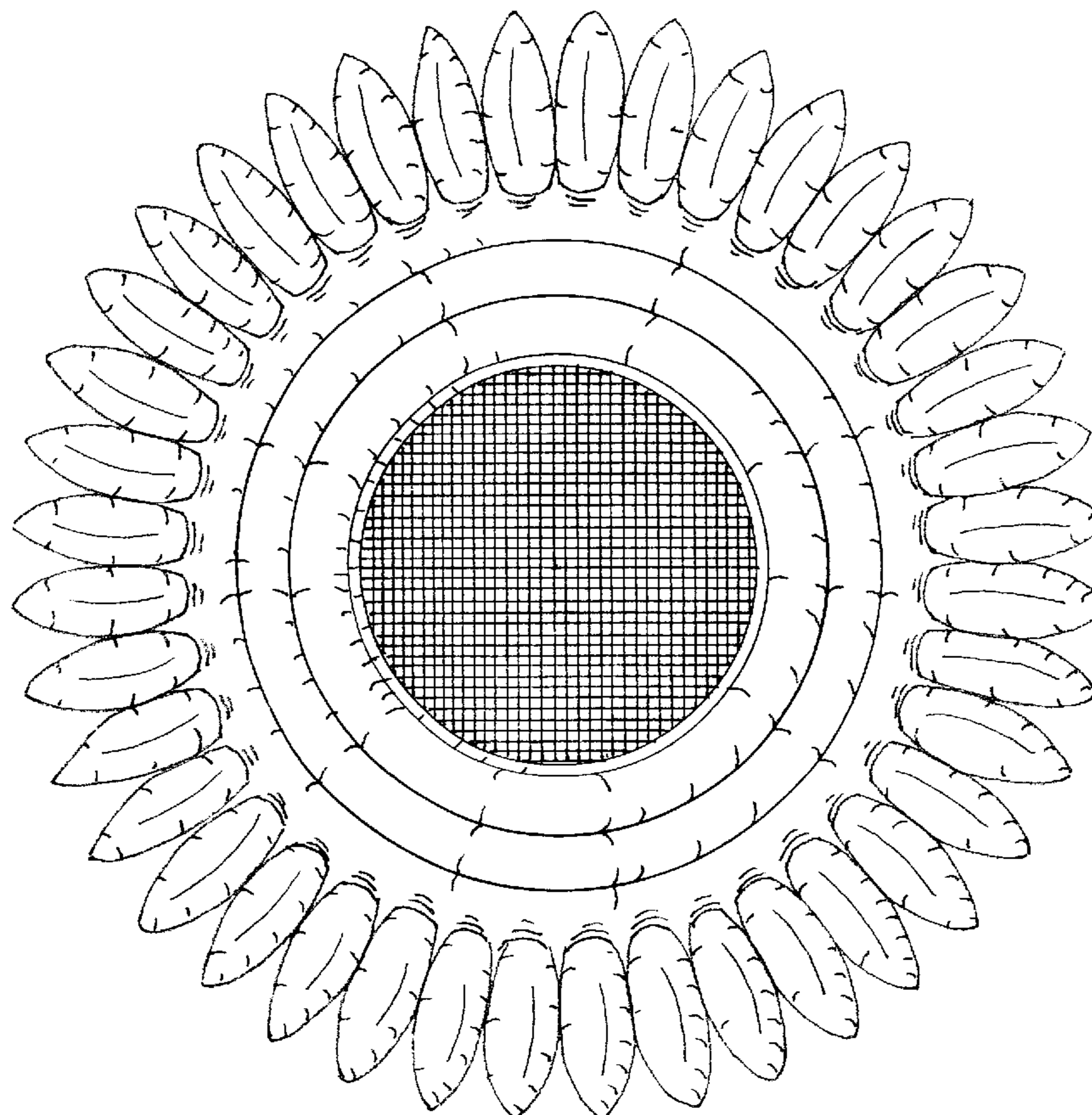
DESCRIPTION

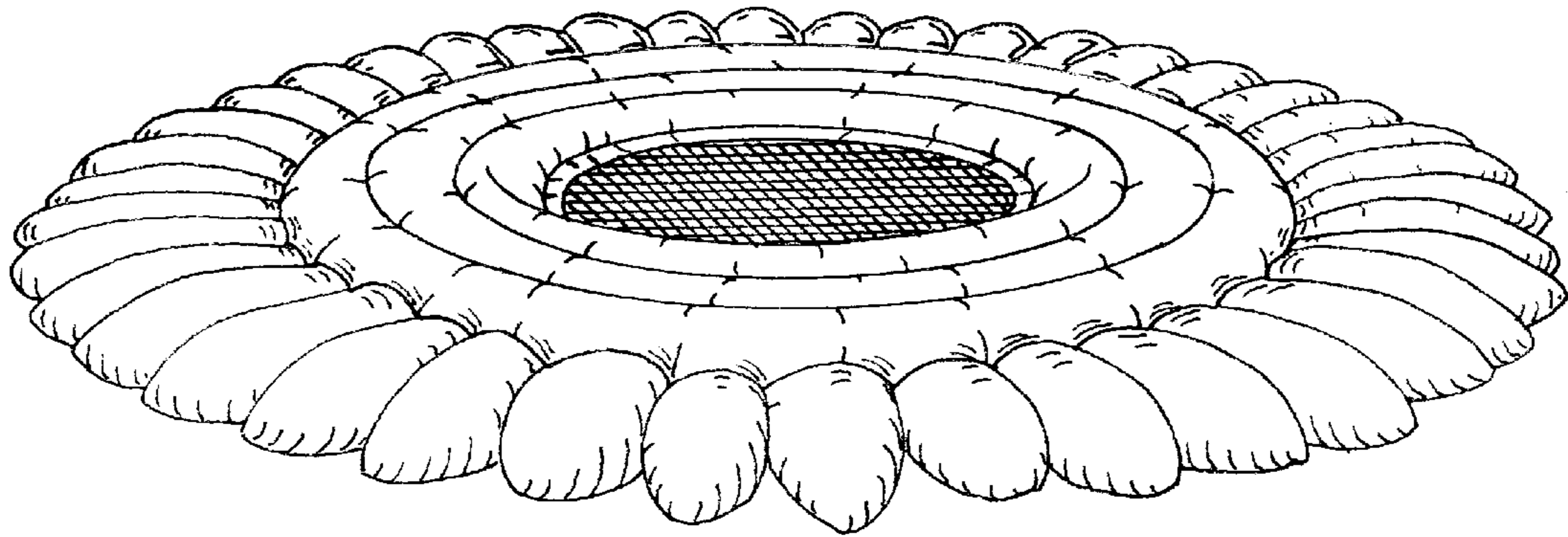

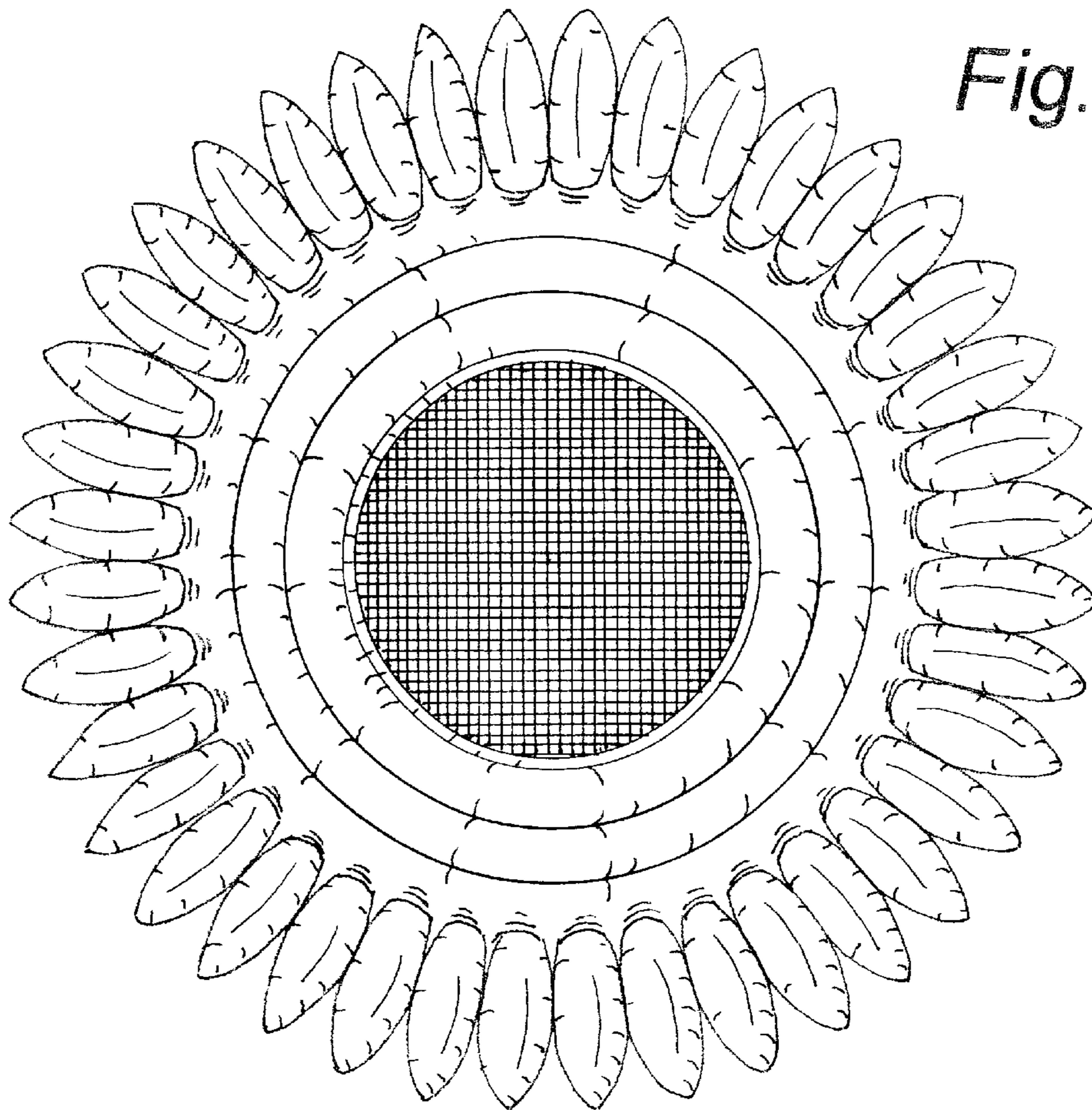
