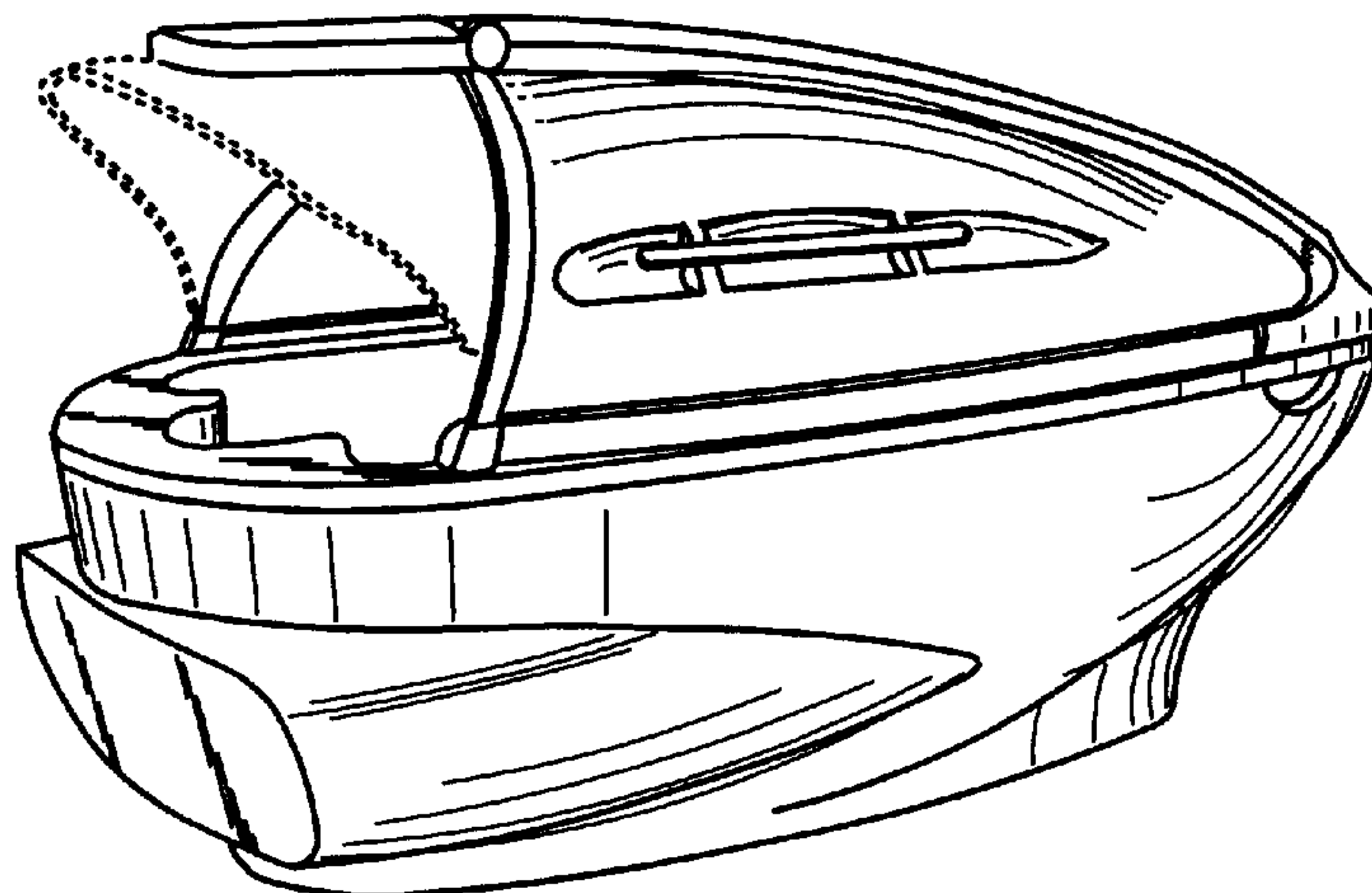
(57) **CLAIM**

and described.

DESCRIPTION

FIG. 1 is a rear and right side perspective view of a wellness
spa capsule embodying our new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevated view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof; and,
FIG. 7 is a bottom plan view thereof.

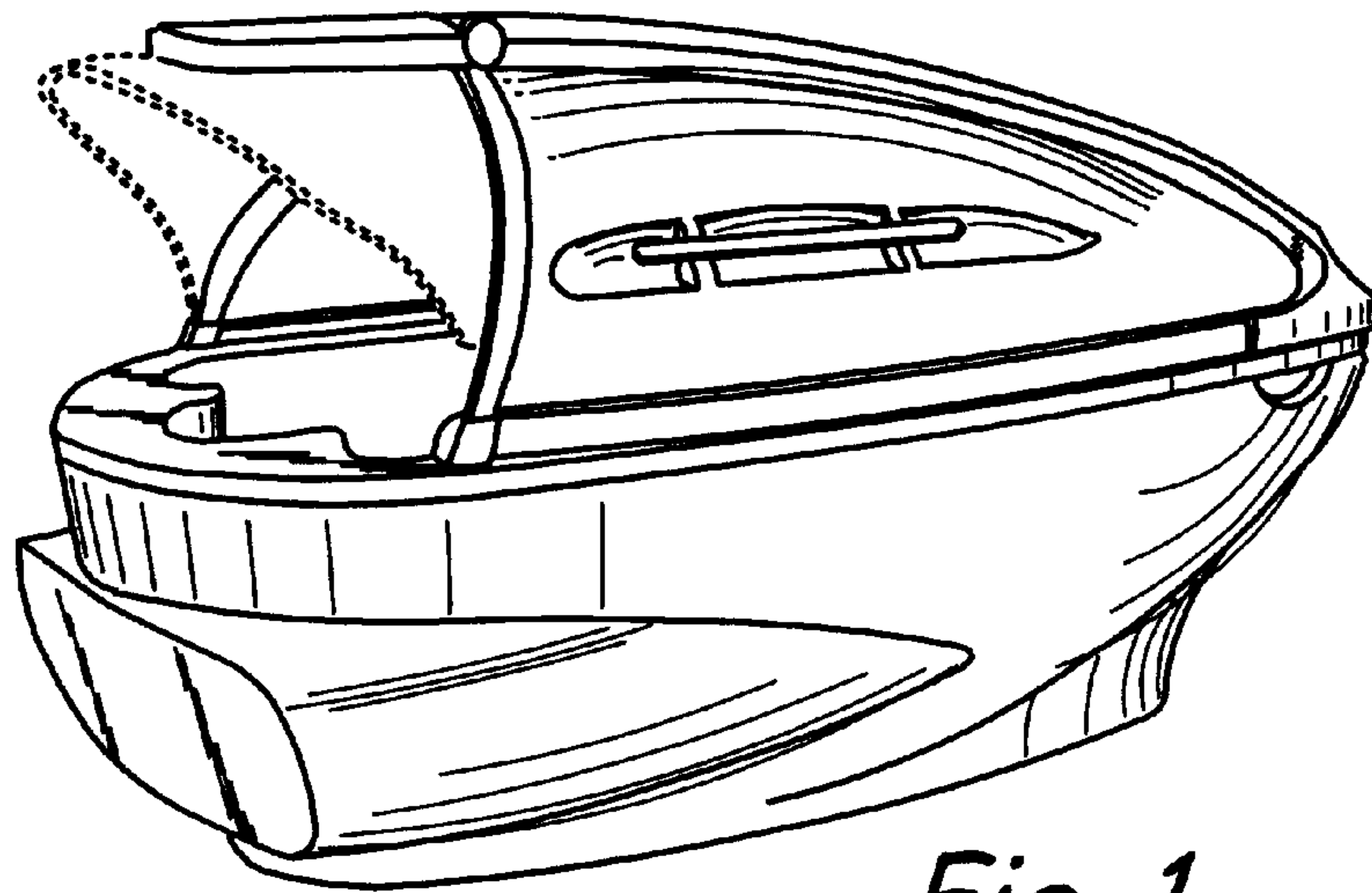

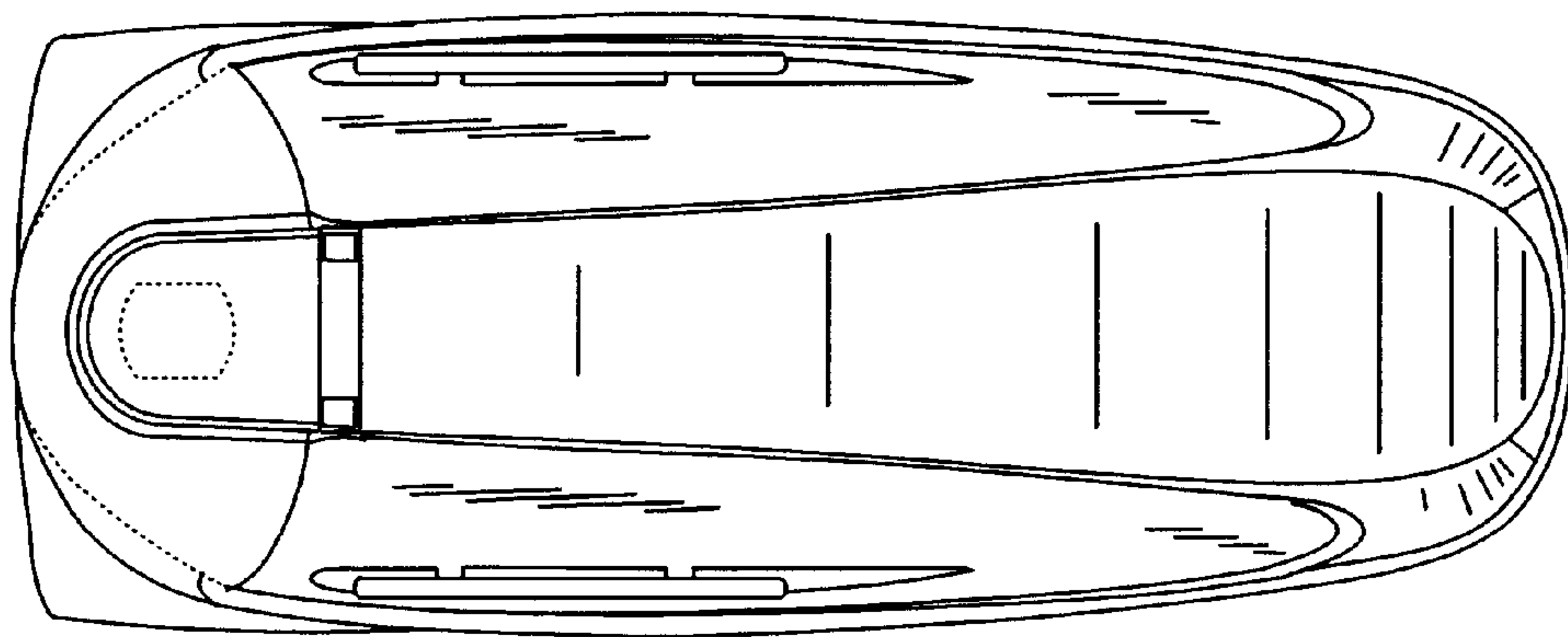

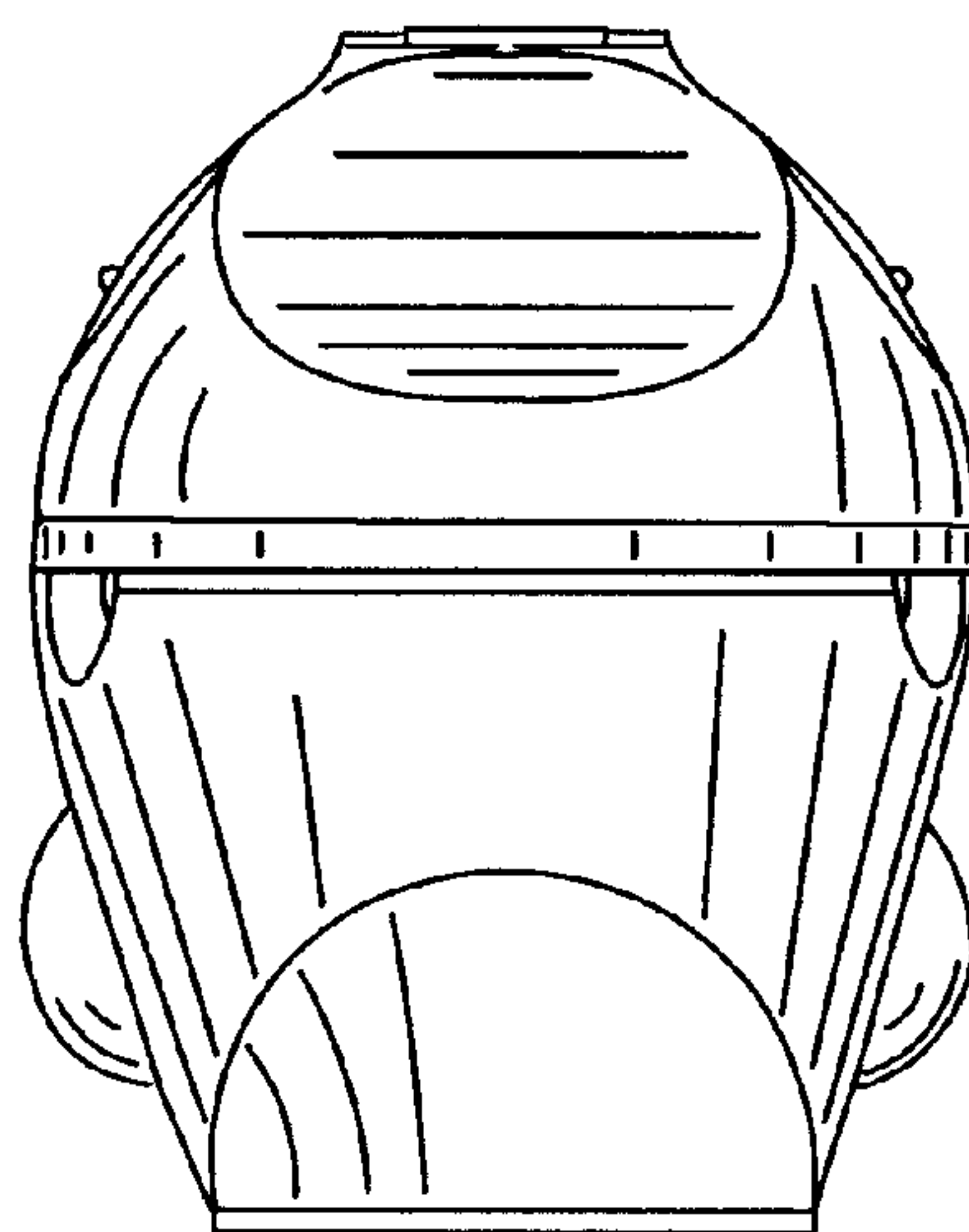

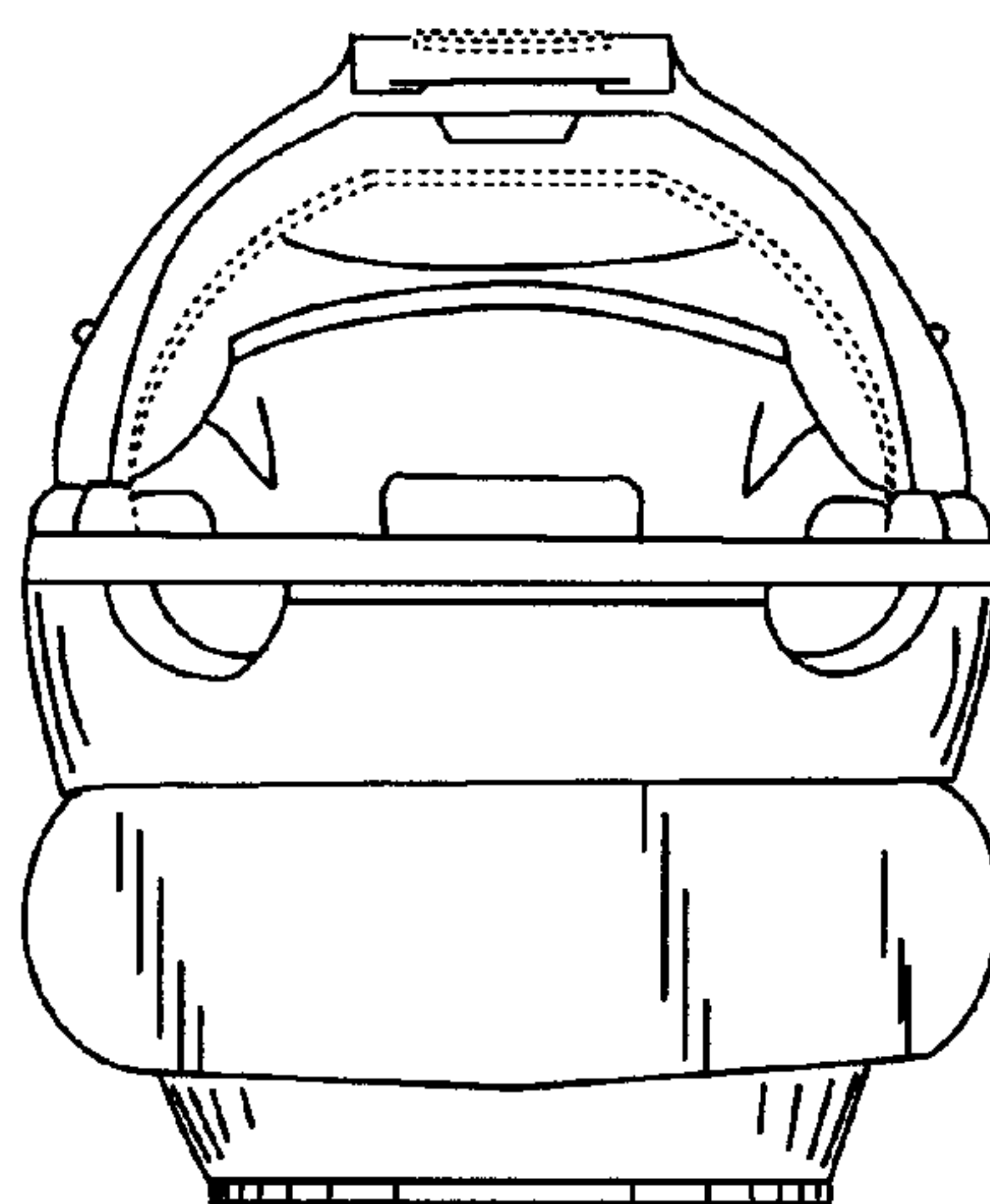

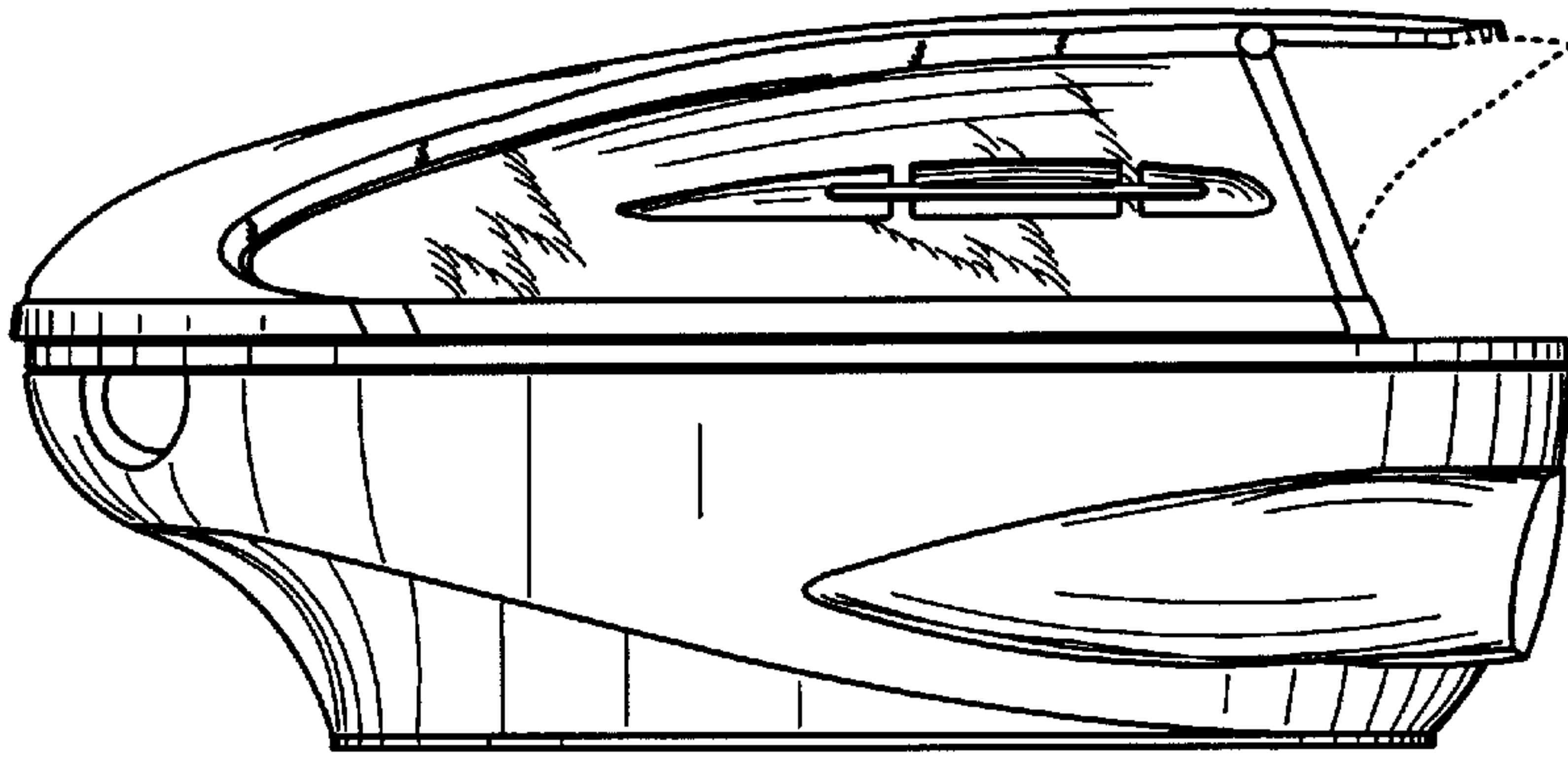

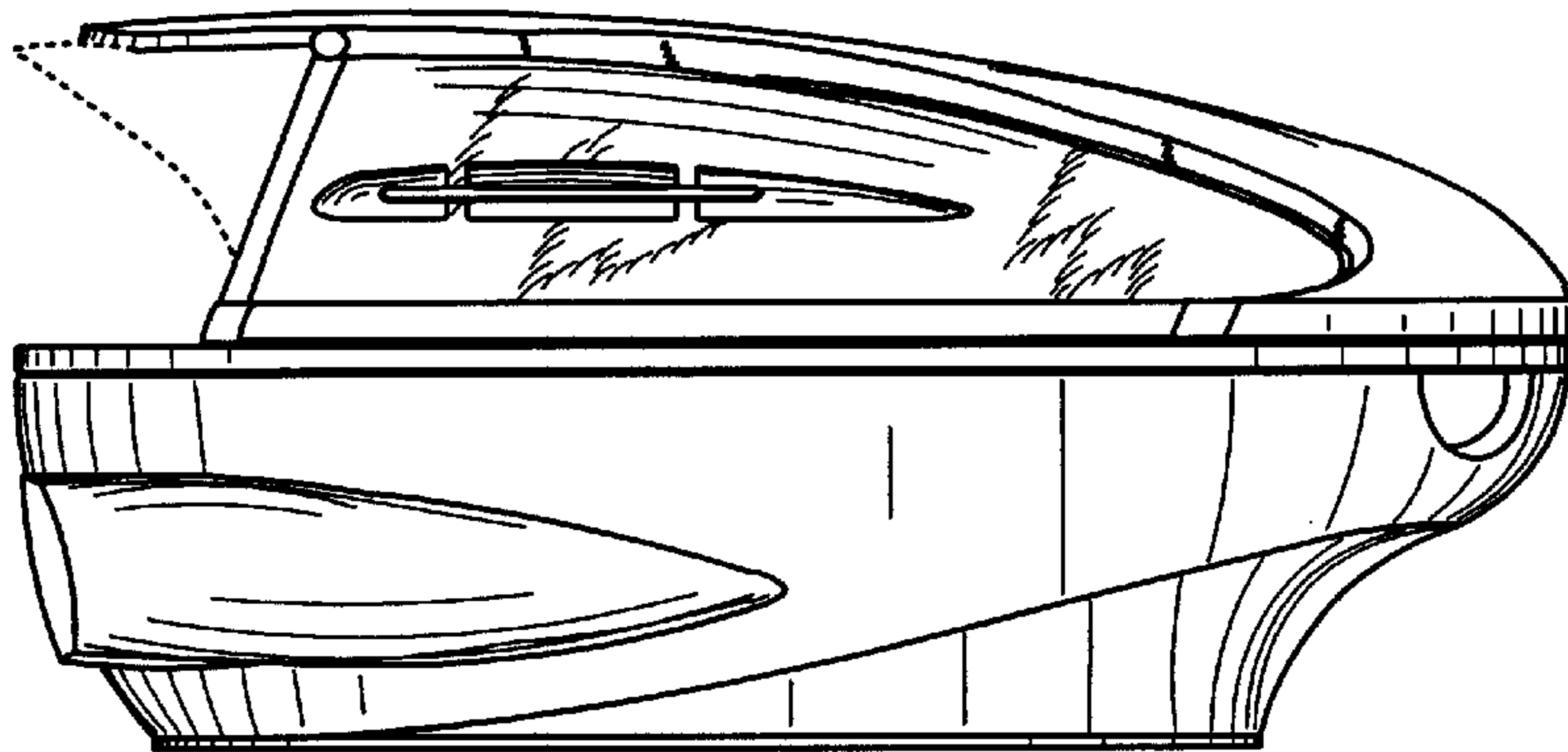

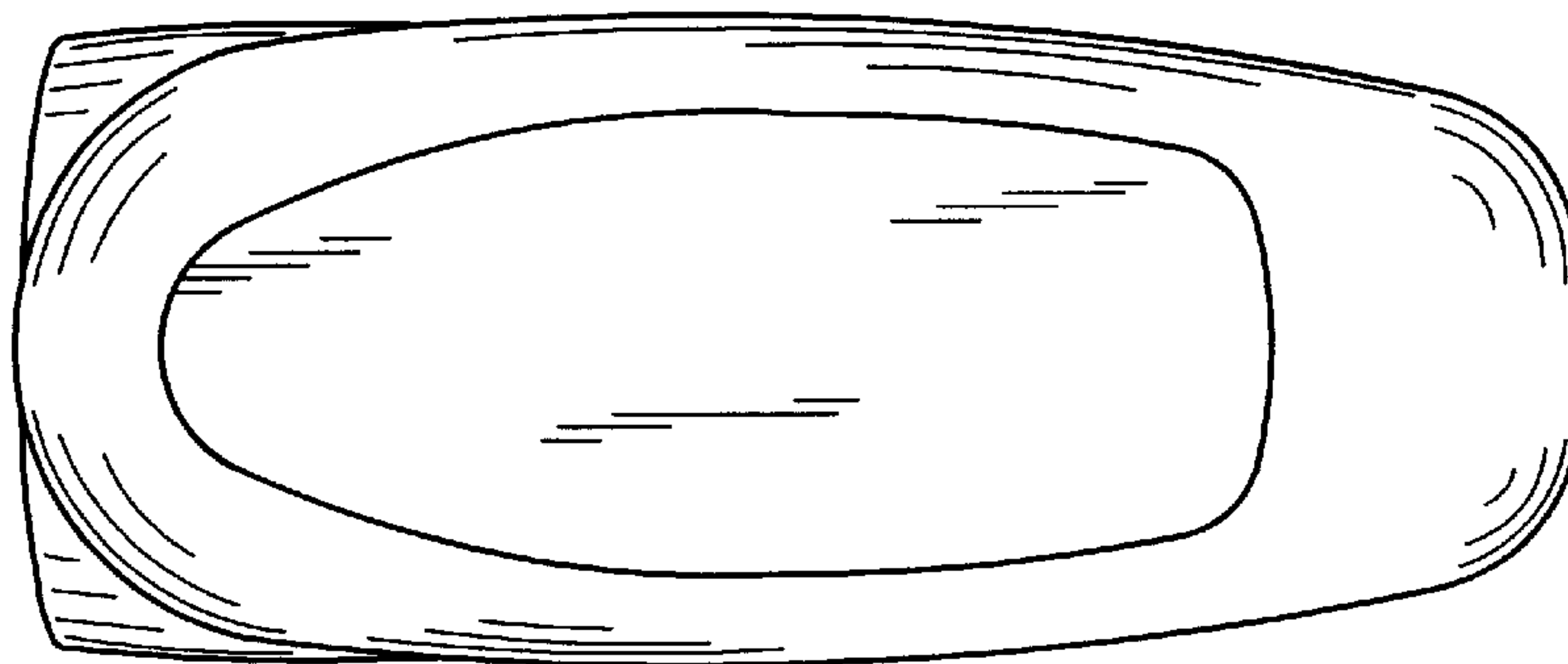
