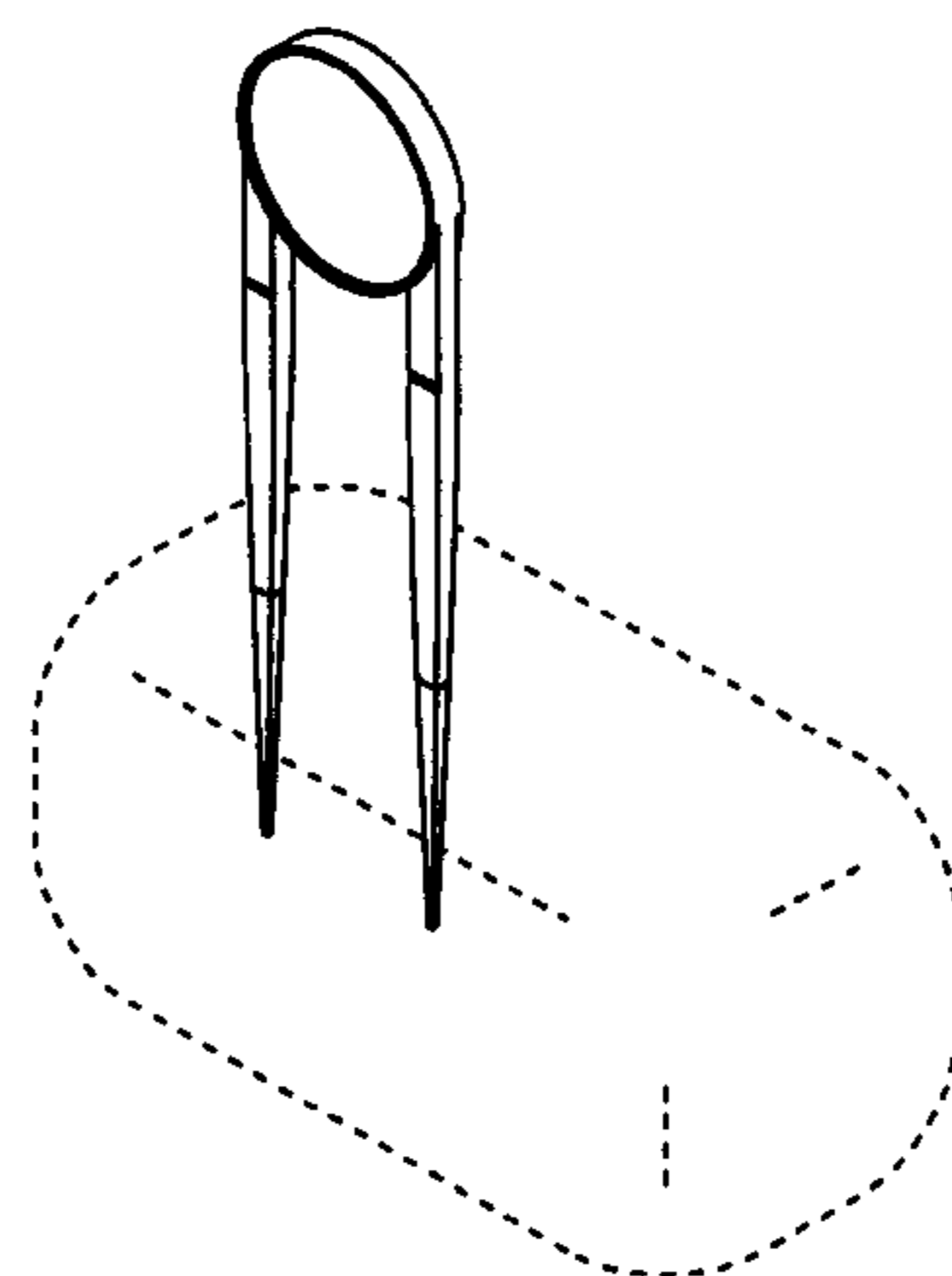
(57) **CLAIM**

The ornamental design for fork, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of the fork;
 FIG. 2 is a back elevation view of the fork of FIG. 1;
 FIG. 3 is a left side elevation view of the fork of FIG. 1;
 FIG. 4 is a right side elevation view of the fork of FIG. 1;
 FIG. 5 is a top plan view of the fork of FIG. 1;
 FIG. 6 is a bottom plan view of the fork of FIG. 1;
 FIG. 7 is a perspective view of the fork of FIG. 1;
 FIG. 8 is an enlarged partial cross-sectional view taken along line 8—8 of the fork in FIG. 1; and,
 FIG. 9 is an enlarged partial perspective view of a fork tine in FIG. 1, shown separately for completeness of illustration. The broken lines in FIG. 7 are for illustrative purposes only and form no part of the claimed design.

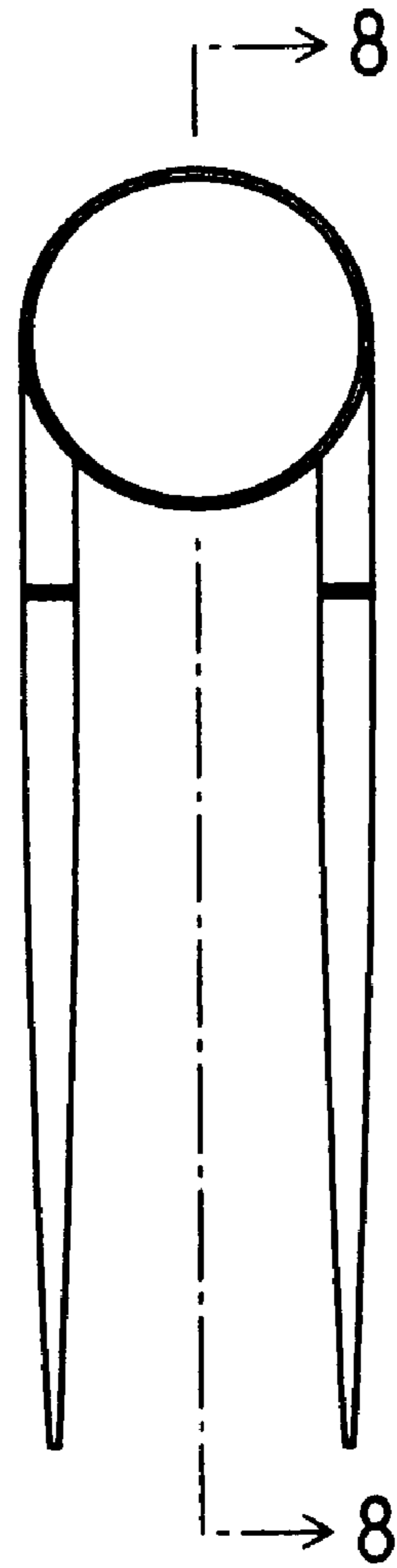

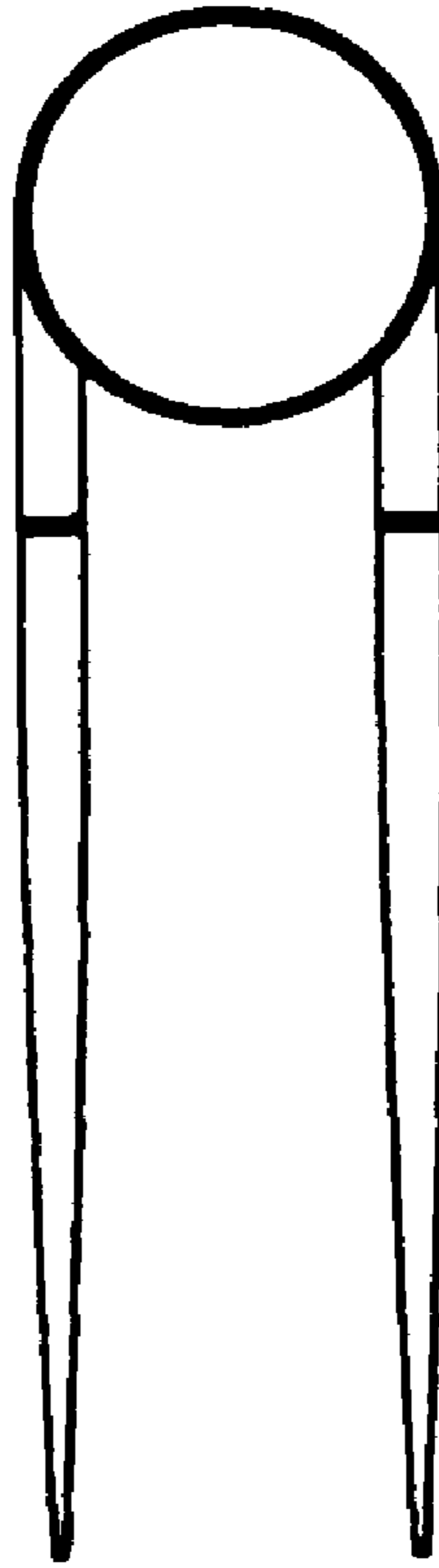

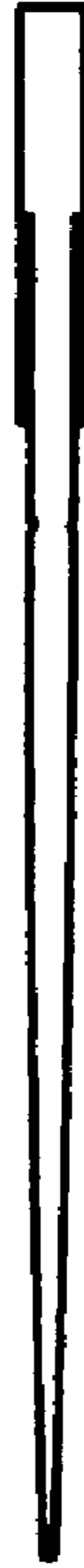

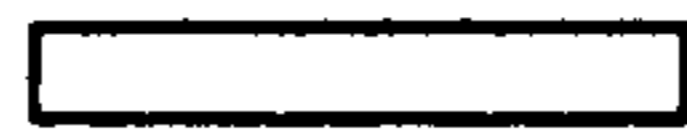

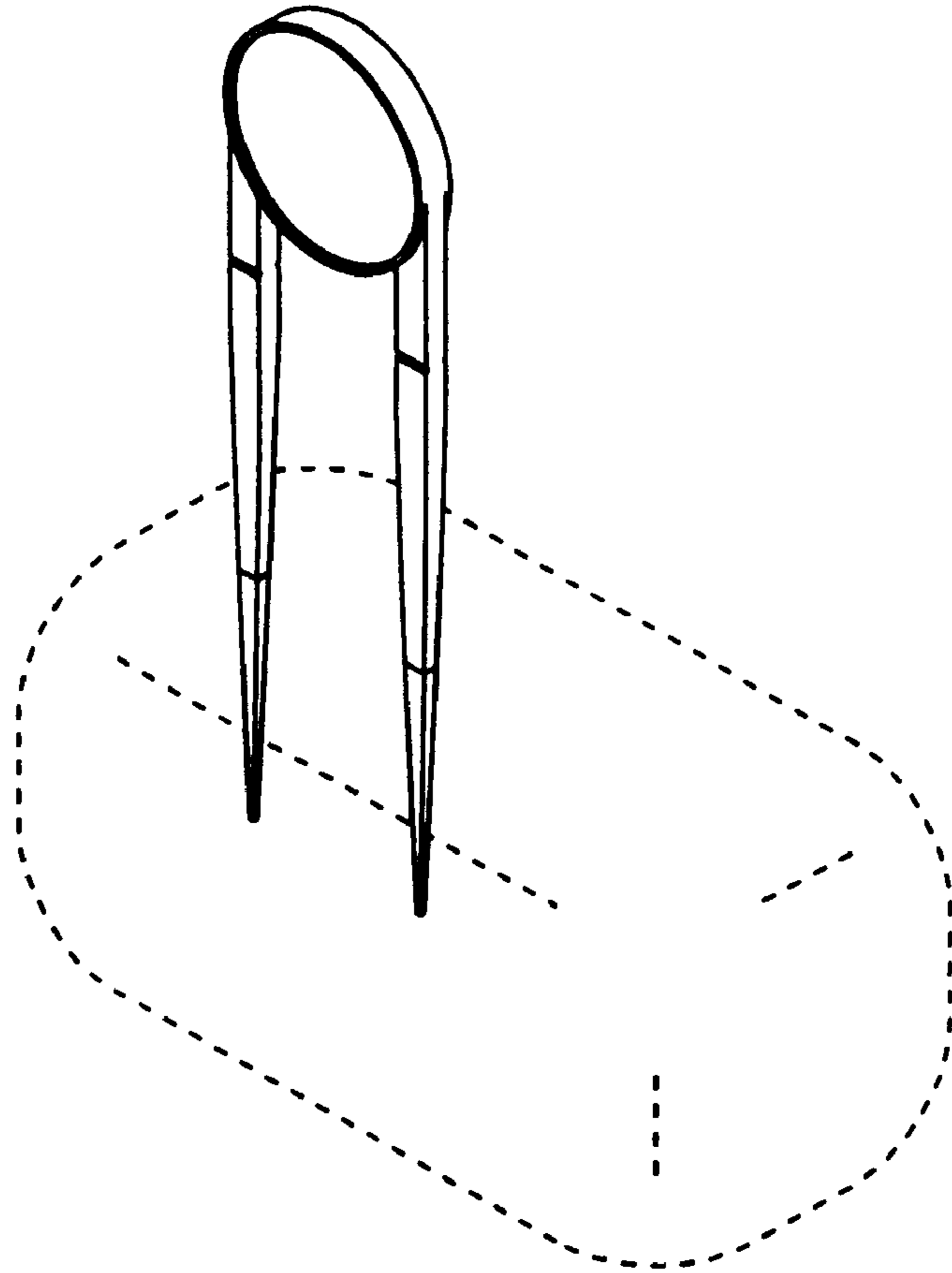

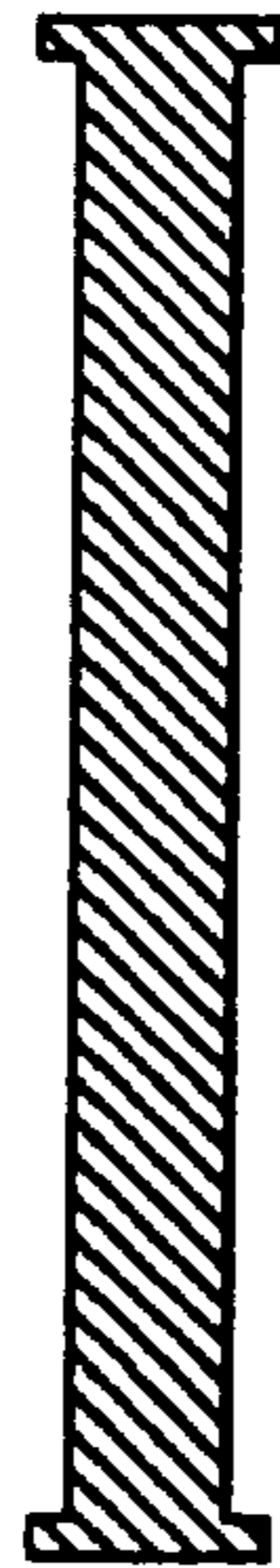
