(57) **CLAIM**

The ornamental design for a tool handle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of a tool handle showing my new design;
FIG. 2 is a rear perspective view of the first embodiment of the tool handle;
FIG. 3 is a front elevation view of the first embodiment of the tool handle;
FIG. 4 is a rear elevation view of the first embodiment of the tool handle;
FIG. 5 is a right side elevation view of the first embodiment of the tool handle;

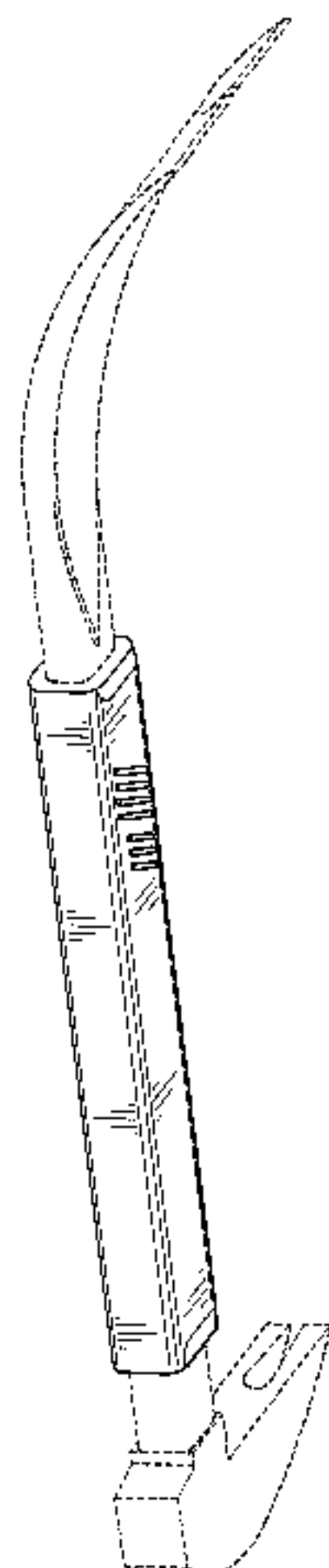


FIG. 6 is a left side elevation view of the first embodiment of the tool handle;

FIG. 7 is a top plan view of the first embodiment of the tool handle, the tool ends being omitted;

FIG. 8 is a bottom plan view of the first embodiment of the tool handle, the tool ends being omitted;

FIG. 9 is a front perspective view of an alternative embodiment of the tool handle of FIG. 1;

FIG. 10 is a rear perspective view of the tool handle of FIG. 9;

FIG. 11 is a front elevation view of the tool handle of FIG. 9, the rear elevation view being a mirror image thereof;

FIG. 12 is a right side elevation view of the tool handle of FIG. 9, the left side elevation view being a mirror image thereof;

FIG. 14 is a bottom plan view of the tool handle of FIG. 9, the tool ends being omitted.

FIG. 15 is a front perspective view of a second embodiment of the tool handle;

FIG. 16 is a rear perspective view of the second embodiment of the tool handle;

FIG. 17 is a front elevation view of the second embodiment of the tool handle;

FIG. 18 is a rear elevation view of the second embodiment of the tool handle;

FIG. 19 is a right side elevation view of the second embodiment of the tool handle;

FIG. 20 is a left side elevation view of the second embodiment of the tool handle;

FIG. 21 is a top plan view of the second embodiment of the tool handle, the tool ends being omitted;

FIG. 22 is a bottom plan view of the second embodiment of the tool handle, the tool ends being omitted;

FIG. 23 is a front perspective view of an alternative embodiment of the tool handle of FIG. 15;

FIG. 24 is a rear perspective view of the tool handle of FIG. 23;

FIG. 25 is a front elevation view of the tool handle of FIG. 23, the rear elevation view being a mirror image thereof;

FIG. 26 is a right side elevation view of the tool handle of FIG. 23, the left side elevation view being a mirror image thereof;

FIG. 27 is a top plan view of the tool handle of FIG. 23, the tool ends being omitted; and,

FIG. 28 is a bottom plan view of the tool handle of FIG. 23, the tool ends being omitted.

The broken line showings of the tool ends of the tools are for illustrative purposes only and form no part of the claimed design.

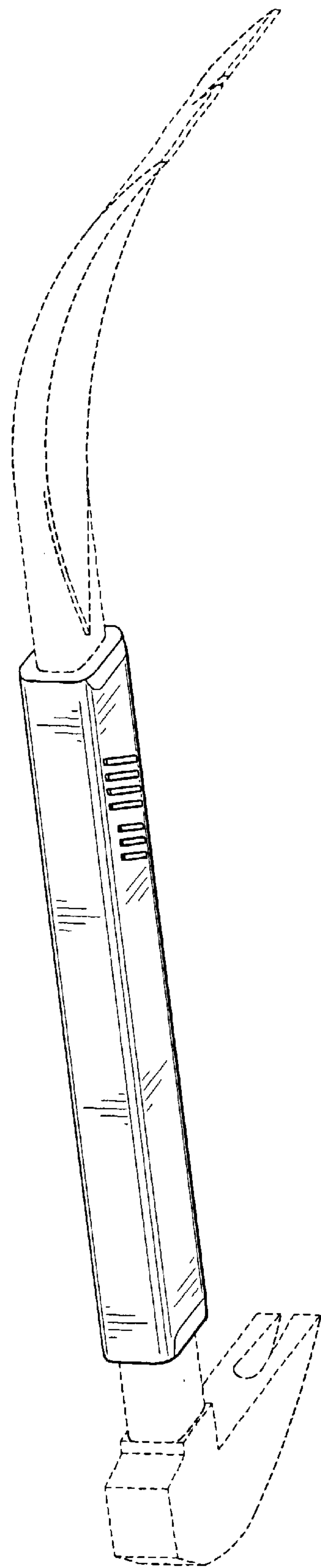

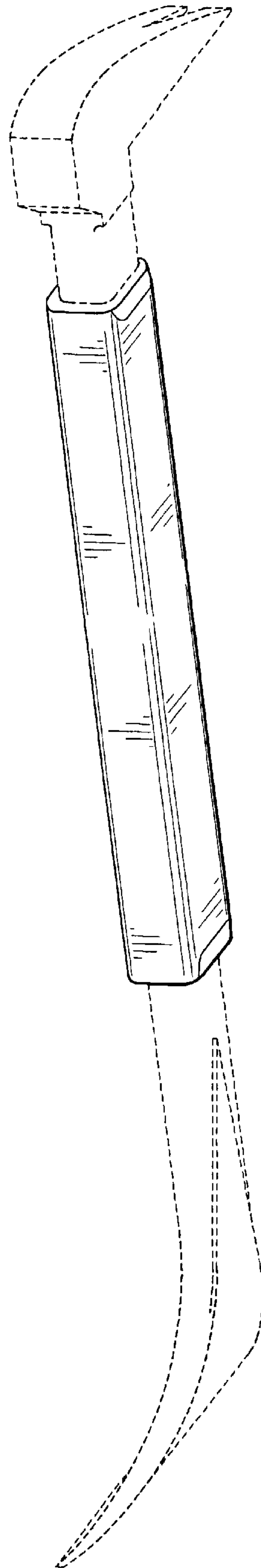

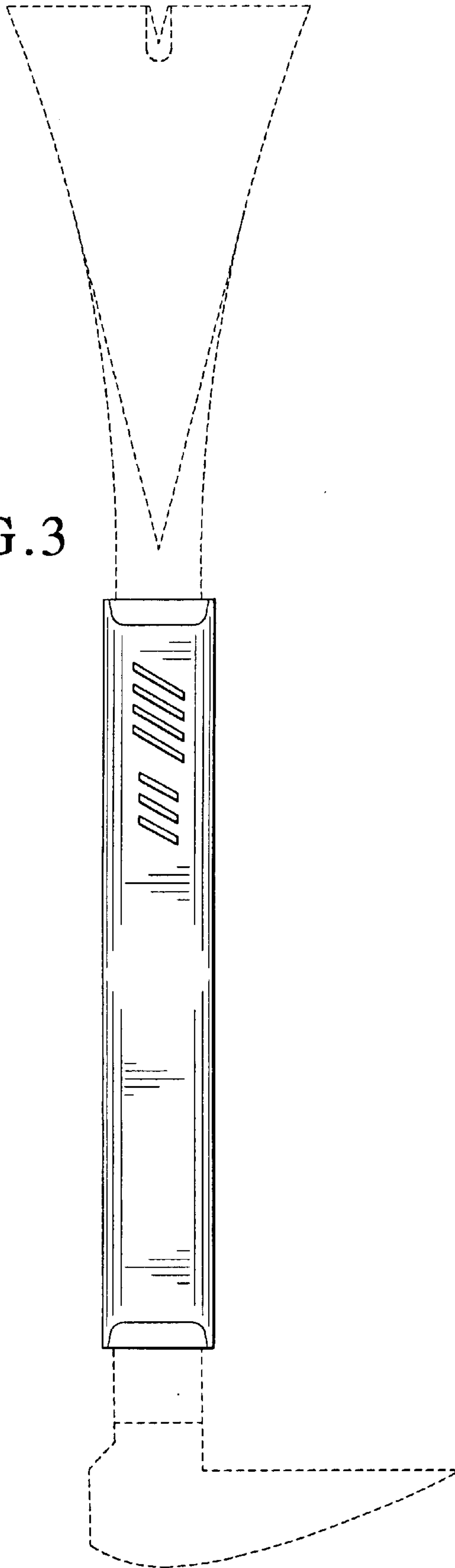

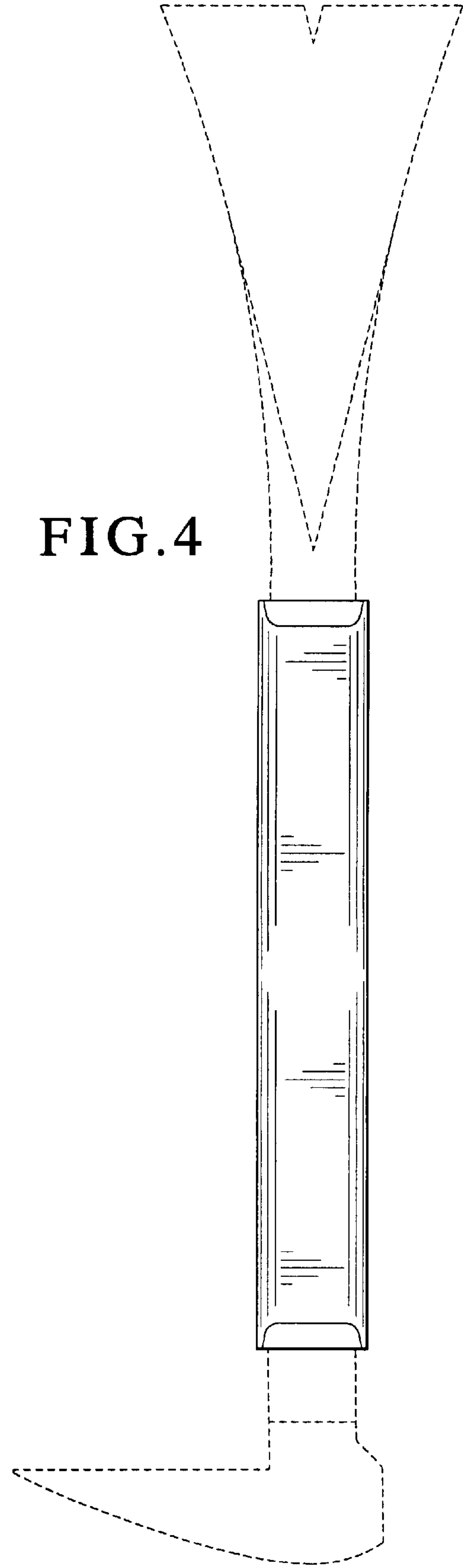

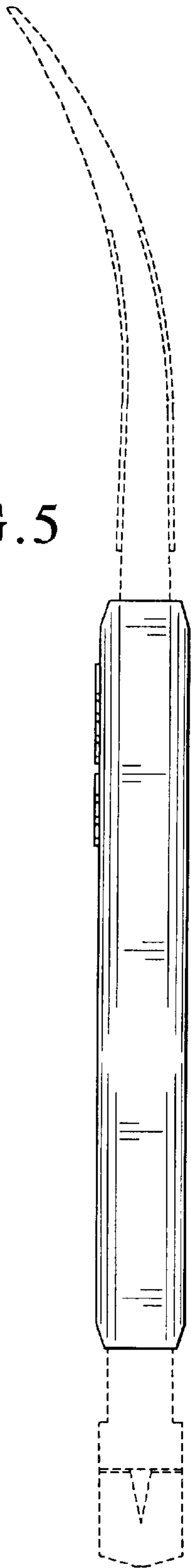

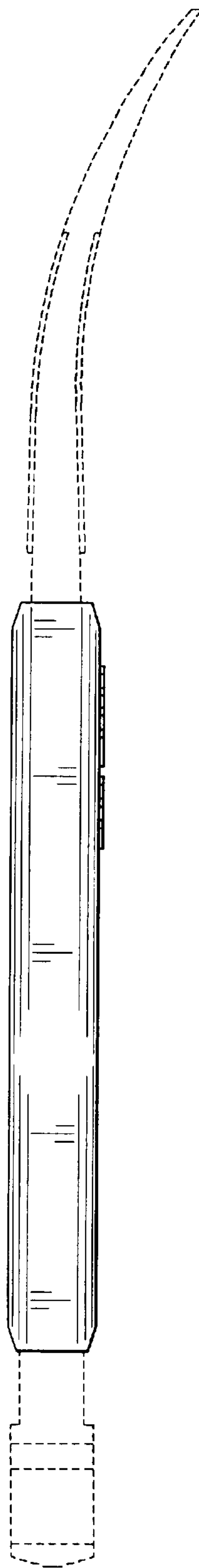

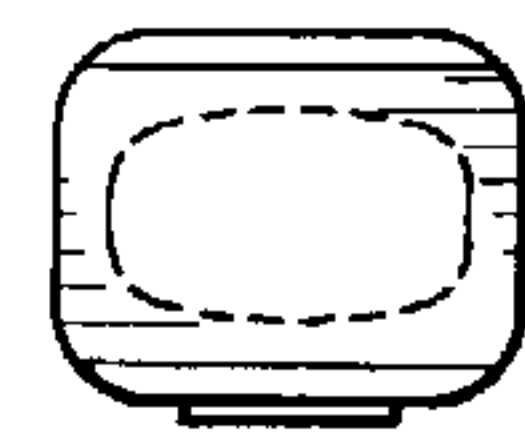
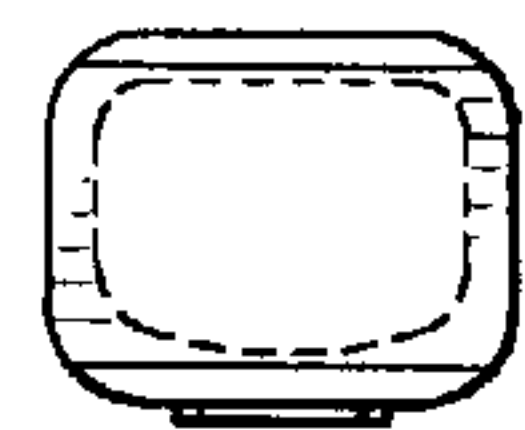

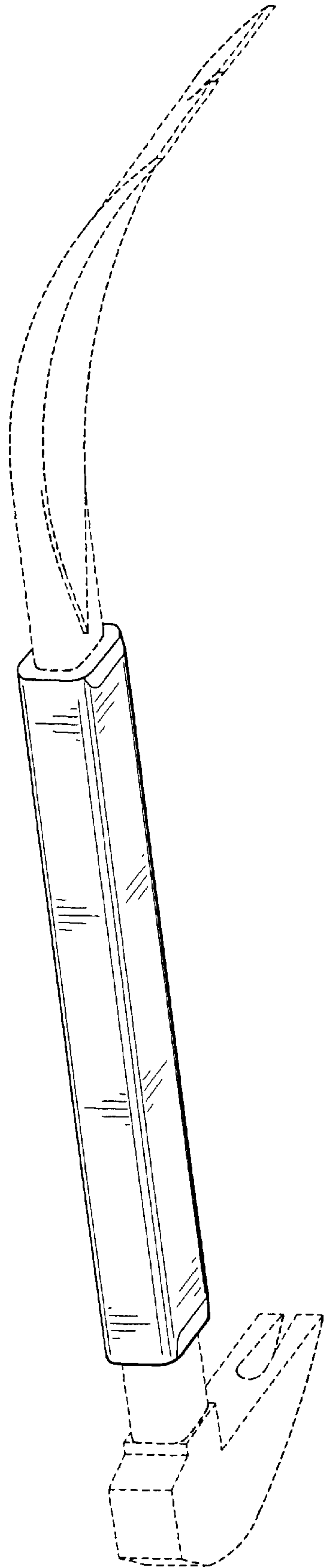

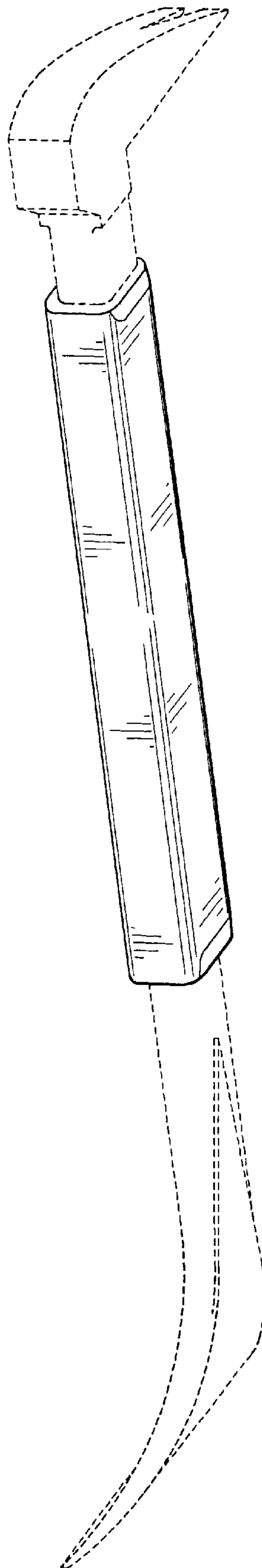

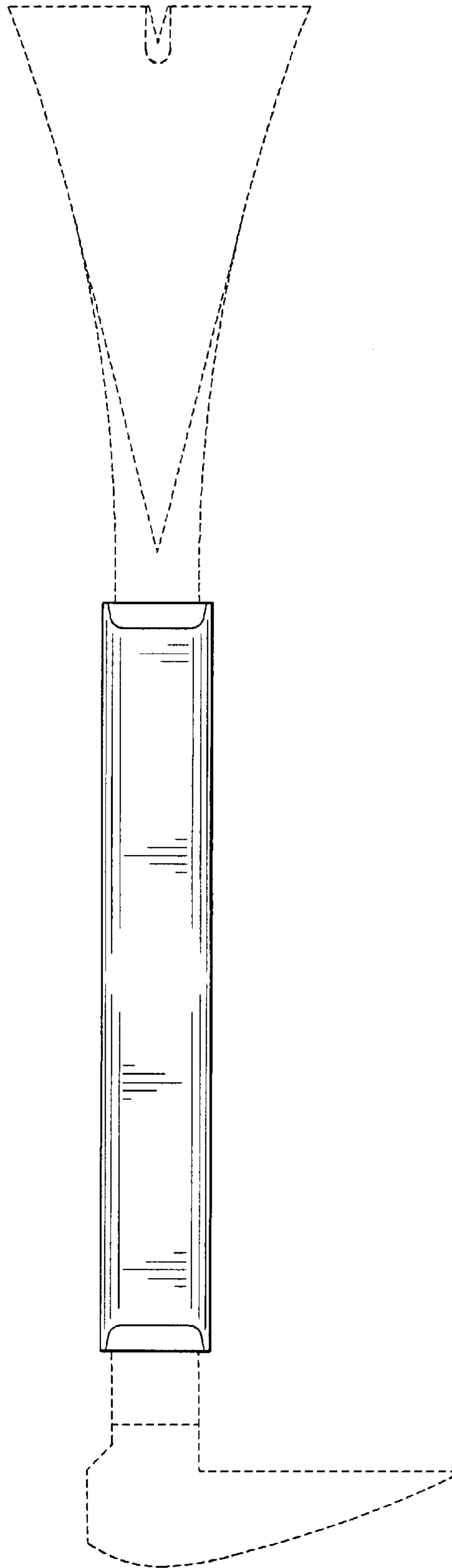

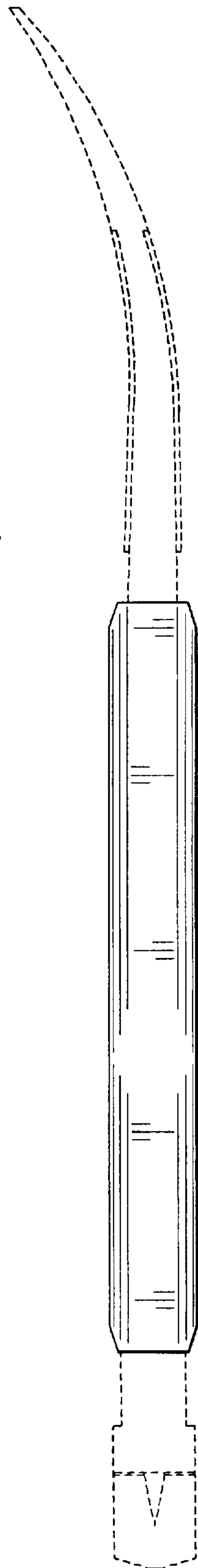

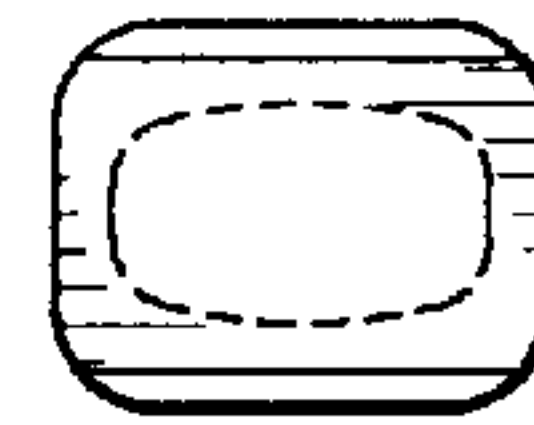
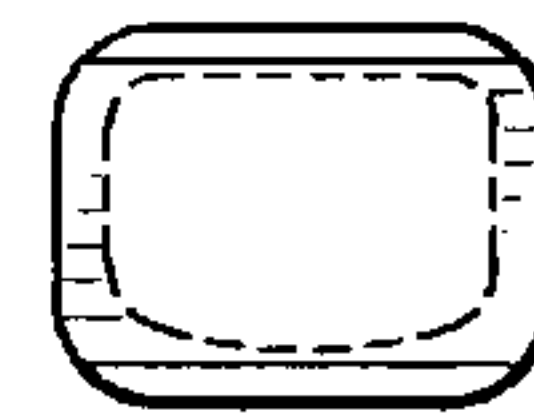

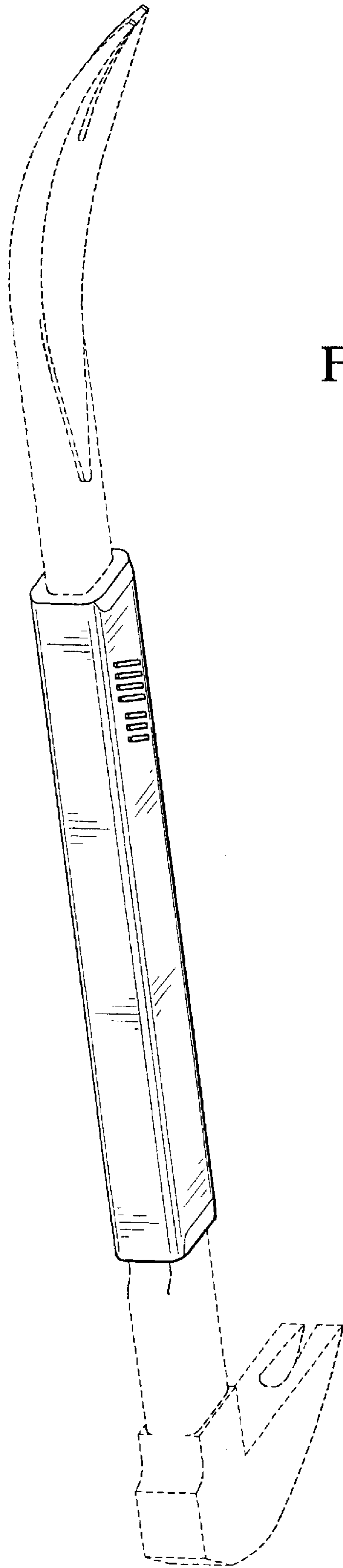

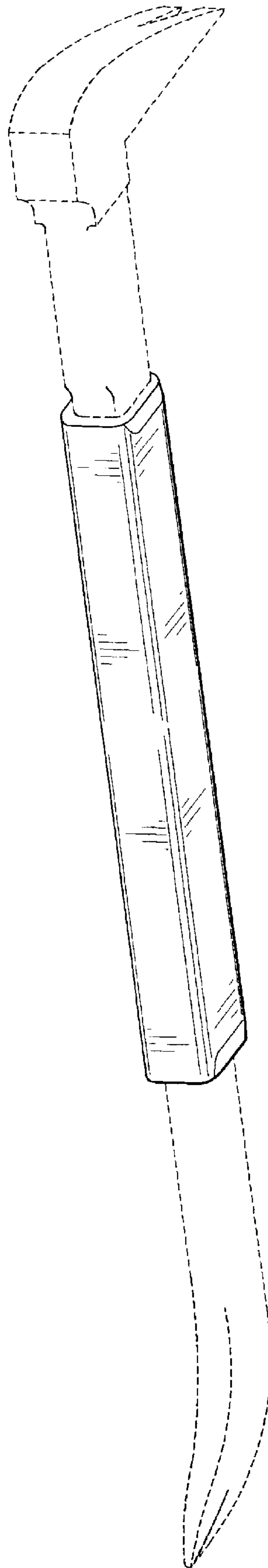

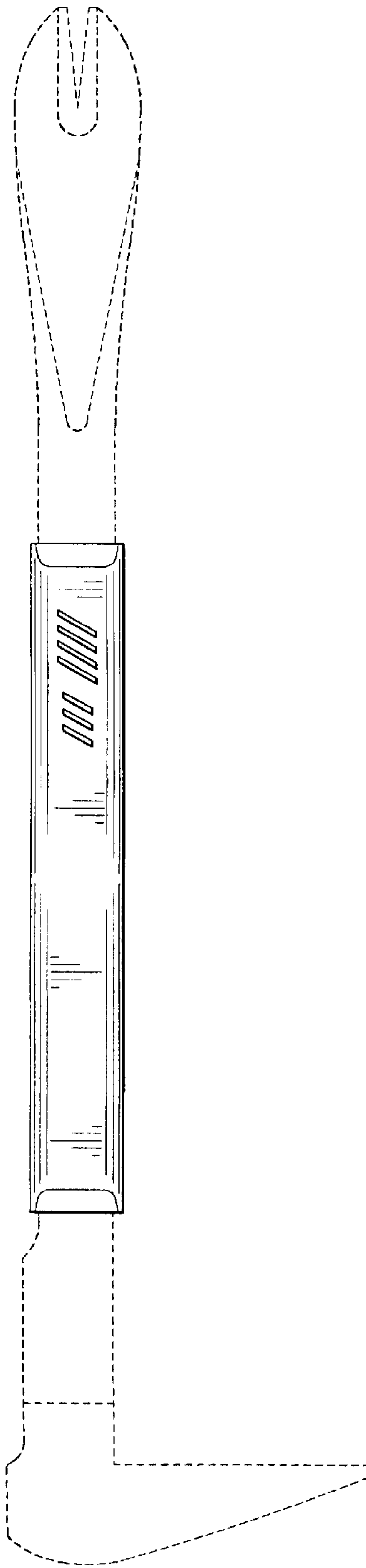

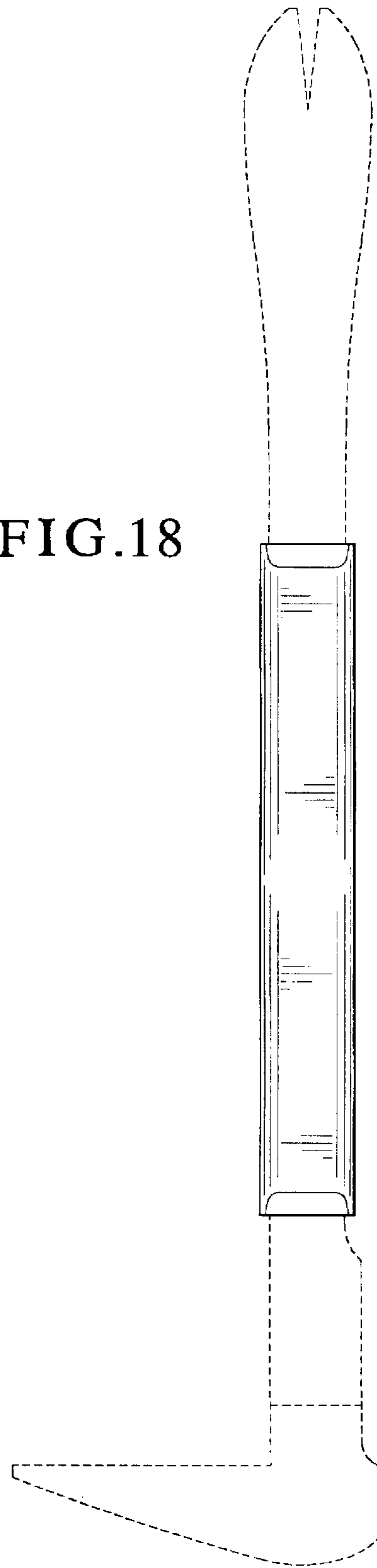

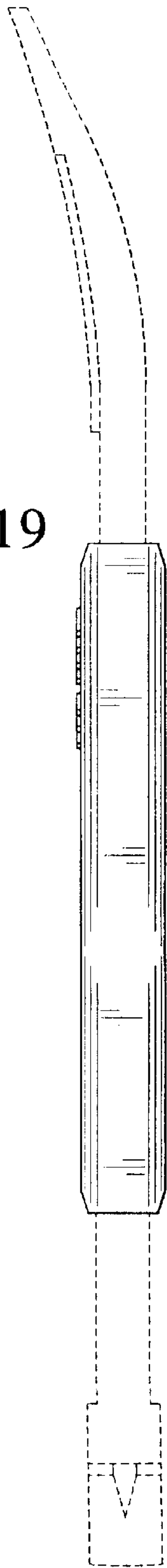

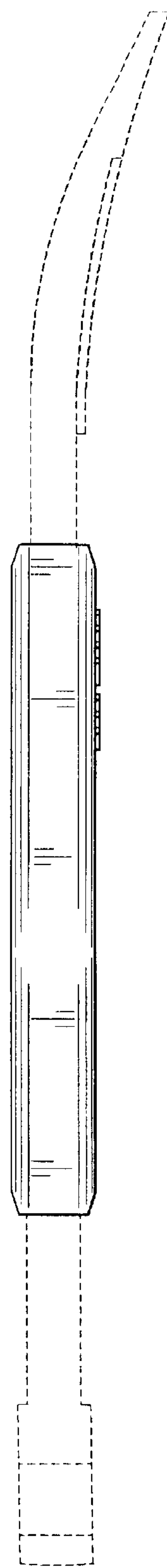

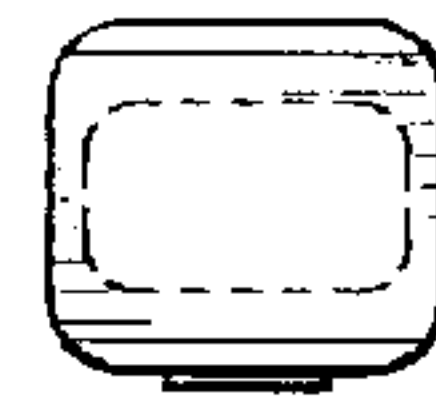
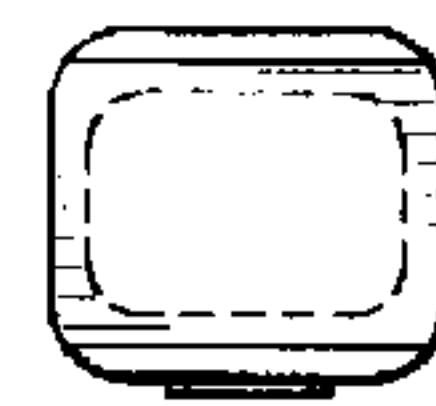

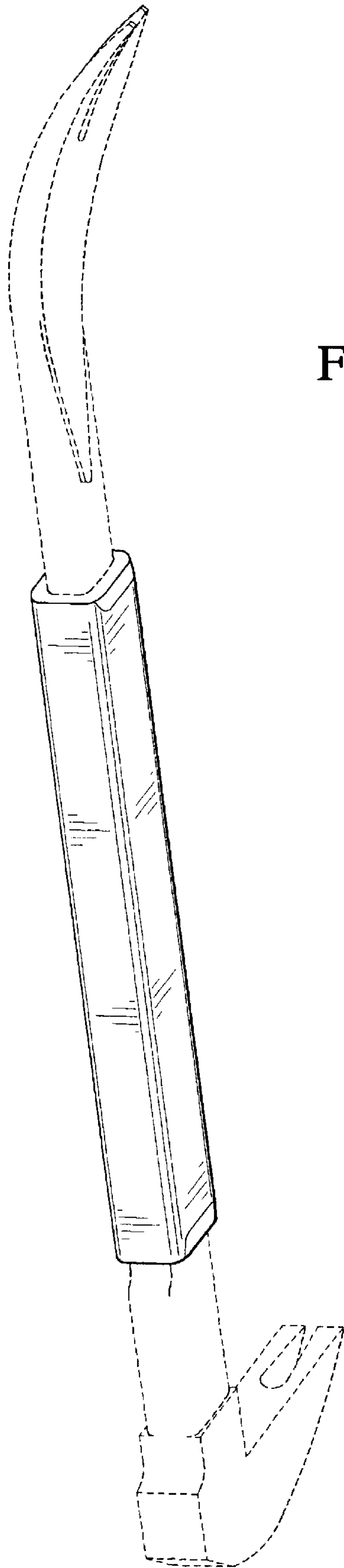

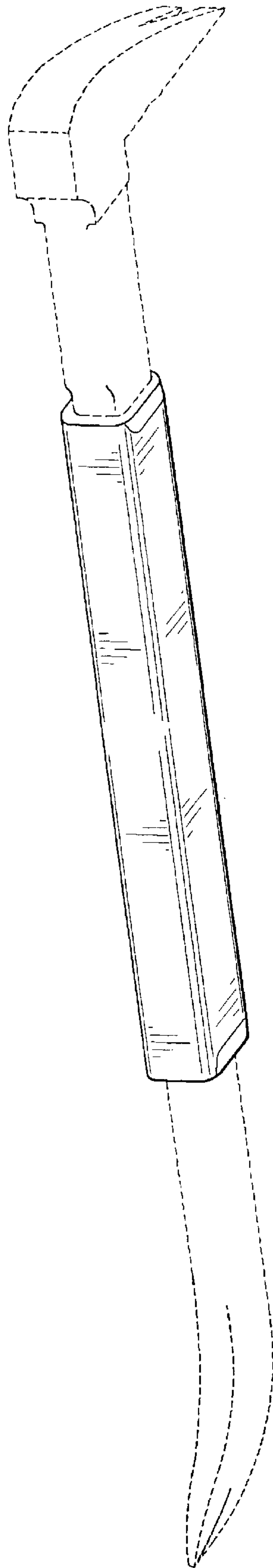

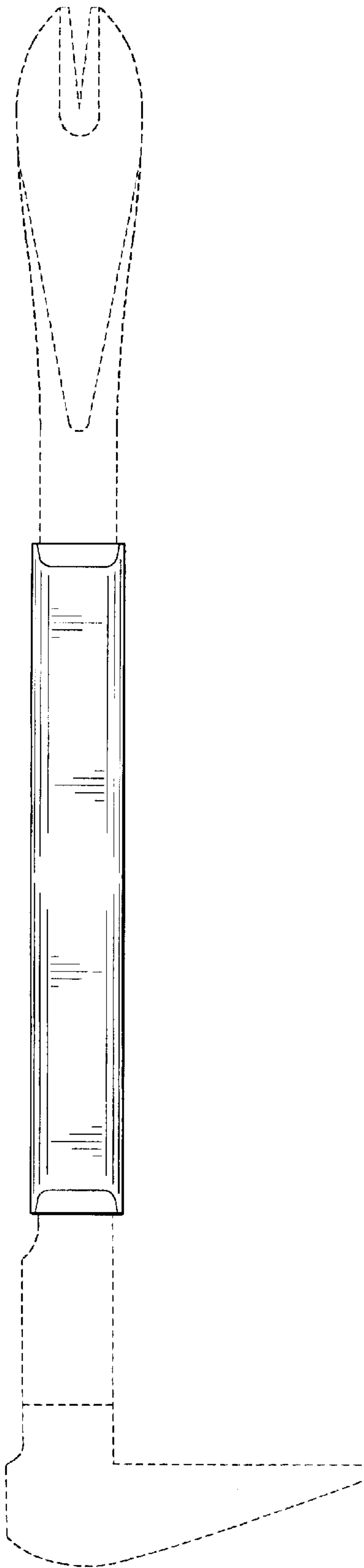

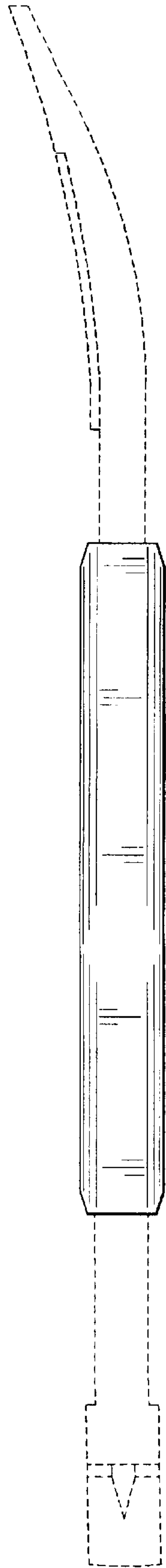

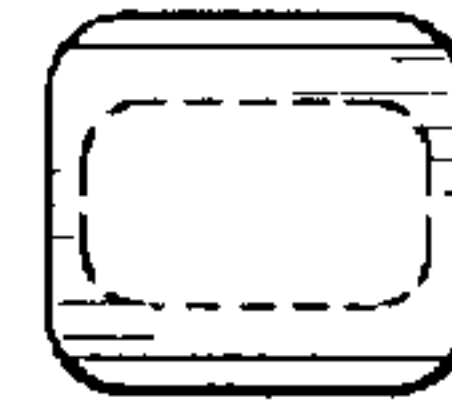
