FIG. 1 is front view of an open star jewelry item in accordance with the invention, the back side being a mirror image thereof;

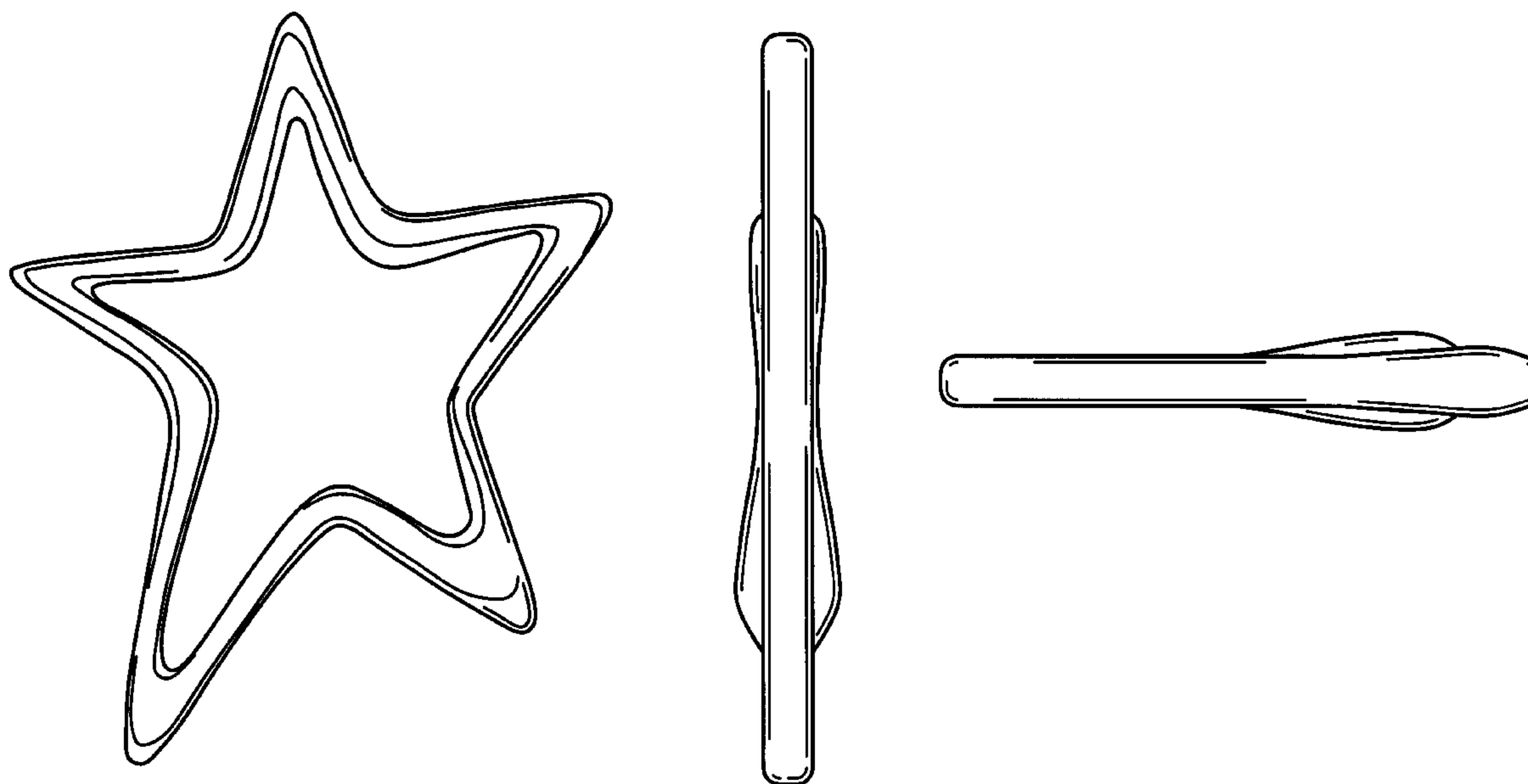
FIG. 2 is a left side view thereof;

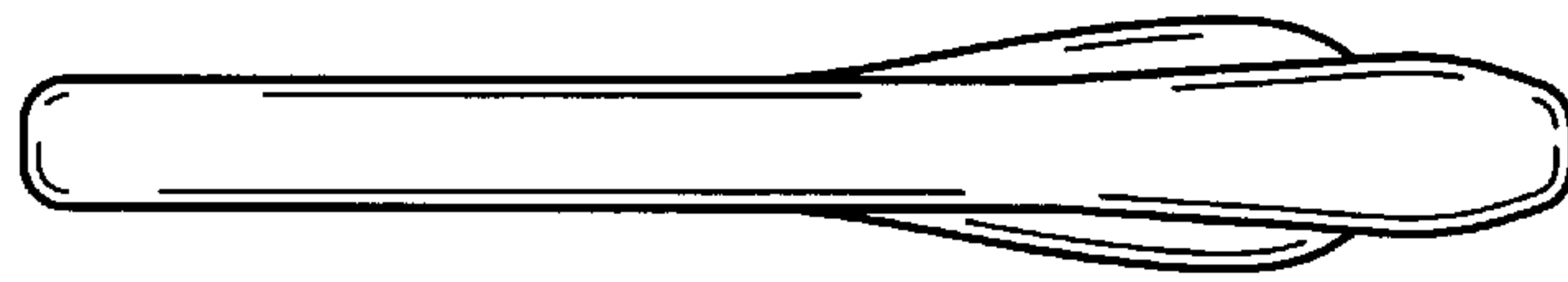

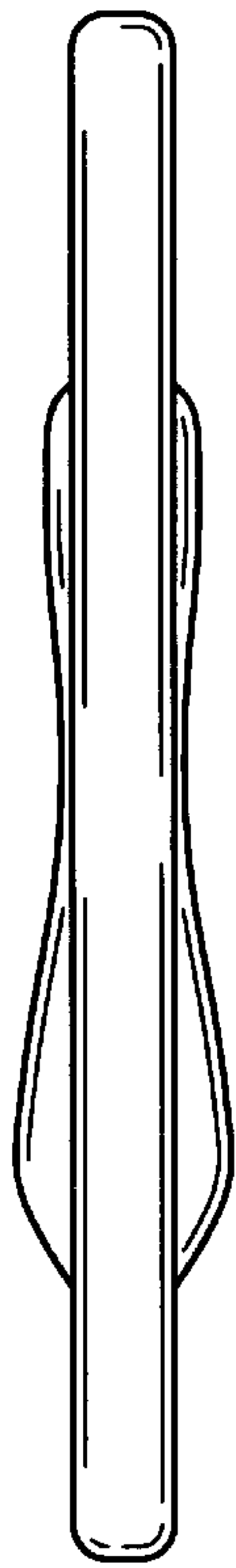

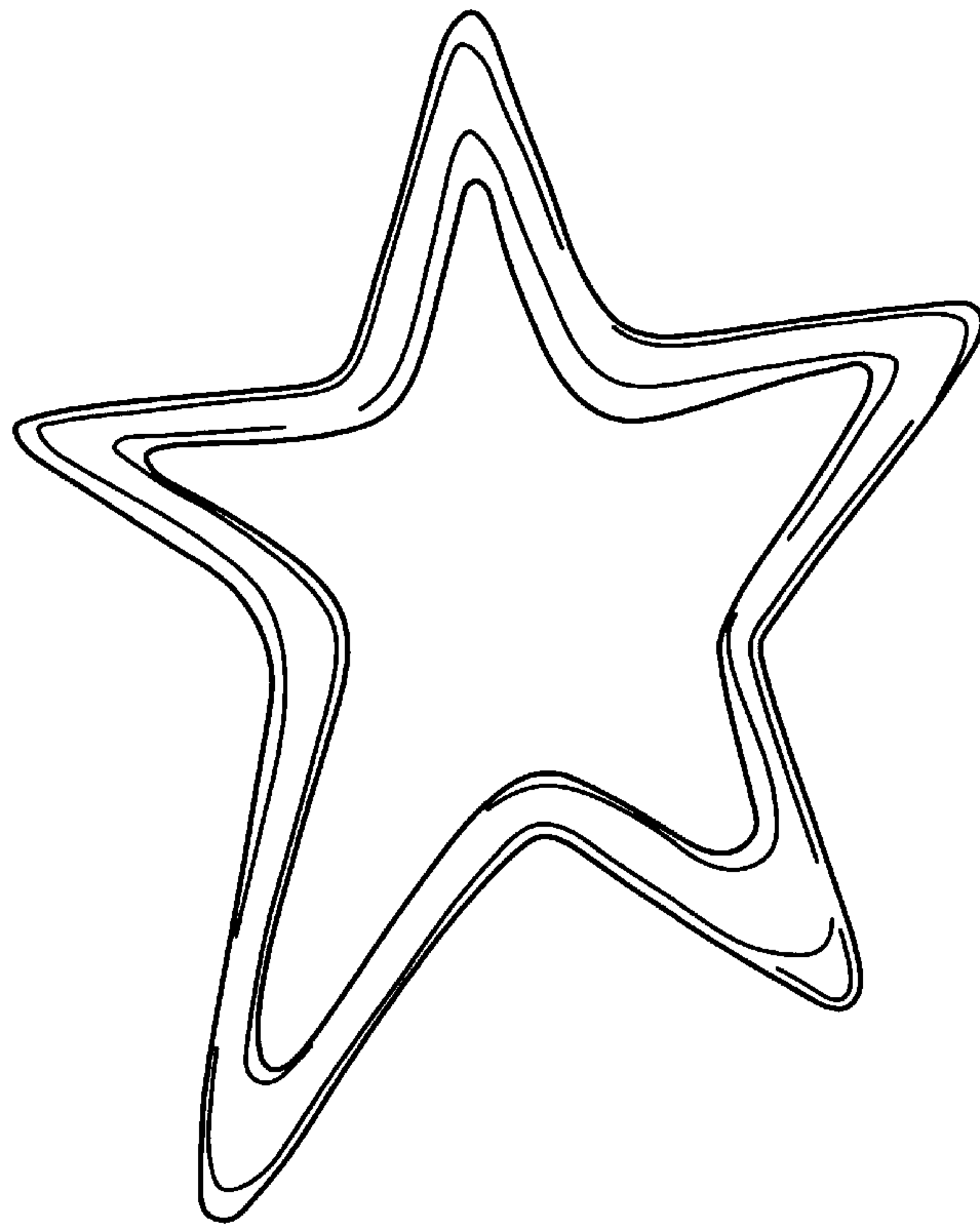

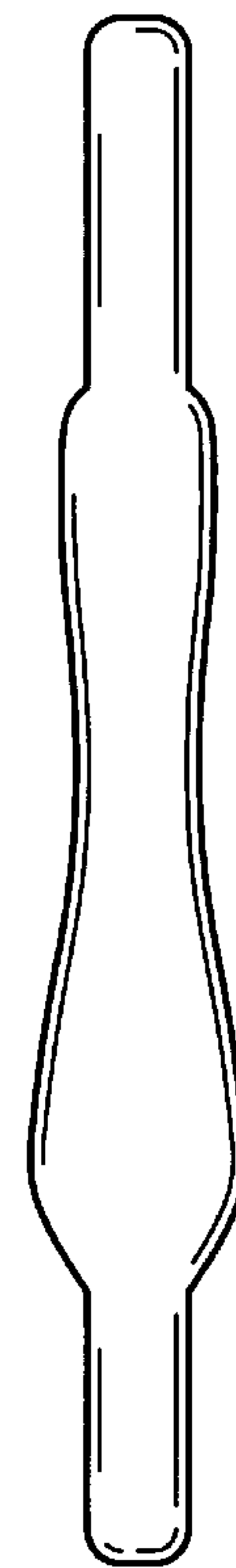

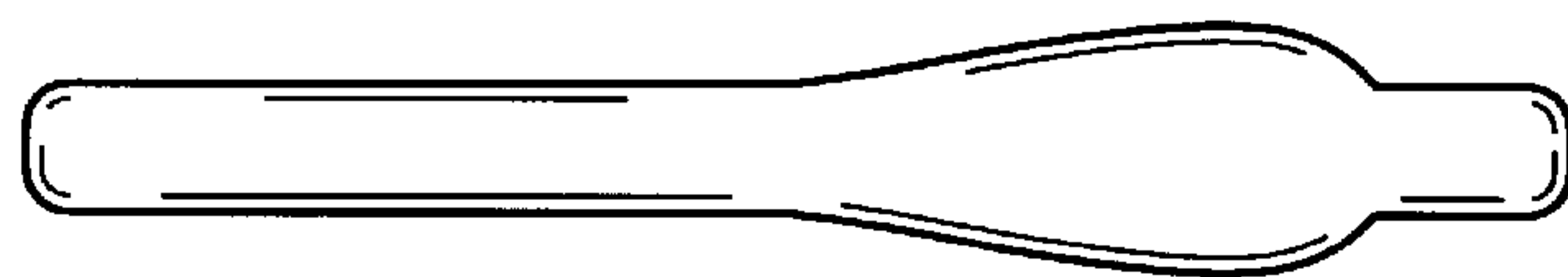
